The Bilderberg Group

Secret Societies and globalist organizations are always a hazard to the world. The explanation for that is that extreme secrecy, evil policies, and a lust for the sake of dominating all mankind is entrenched in their modus operandi. The Bilderberg Group is one such entity. **When I was thinking about what my new expose would be, the Bilderberg Group kept popping in my mind so relentlessly, that I finally decided to give a revelation of God's truth on them.** The time is now to represent accurately and expose that group's diabolism. The Bilderberg Group was created as apart of a goal to institute an united Europe as a foundation (among other purposes). **Dr. Joseph Retinger (who died in 1960), Prince Bernhard of the Netherlands along with others promoted that idea. As many realize Joseph Rettinger was pro-Jesuit and was one of the architects of the European Common Market. He was also an intellectual advocate of European integration. European economic and political integration is a brainchild of the global elite. Even in 1946, he told the Royal Institute of International Affairs (or the British version of the CFR) said Europe.** Even in Alden Hatch's biography of Bernhard, the Bilderberg Group gave a huge influence to the development of the European Union, but their ultimate goal is to have an one-world government. Some of its founders are Dr. Joseph H. Retinger, German-born Prince Bernhard, Colin Gubbin (former director of the British SOE, Special Operations Executive), General Walter Bedell Smith, etc. According to Robert Howard, the Bilderberg Group was David Rockefeller's brainchild. Pilgrims David Rockefeller and Sir Denis Healey were crucial in the Bilderbergers though. Yet, I personally believe that the Bilderberg Group was the creation of Rettinger (**who had Vatican and Jesuit ties**) and Prince Bernhard. Their first meeting was in the Hotel de Bilderberg in Oosterbeek, Holland from May 29-31, 1954. In the 1954 meeting, C.D. Jackson (Vice President of Time magazine, delegate to the U.N., and spokesman for the U.S. delegation led by David Rockefeller) said that by their 2nd meeting, Senator Joseph McCarthy would be gone from the American scene. **See, McCarthy was anti-Communist and was occasionally eccentric at times. He was unfortunately Jesuit-trained trained and agitated by Jesuit Edmund Walsh. He was really gunning for the communists infiltrating high-levels of the U.S. government and died in 1957. McCarthy didn't fully know that the Communists and the cartel-capitalists were funded by the same people. The vast majority of its members are from North America and Western Europe.**

In the 1962 and 1973 meetings, Prince Bernhard (who is the husband of Queen Juliana of the Netherlands) chaired them. The Queen of the Netherlands was one of the richest women in the world at the time because of her partnership with Victor Rothschild in the Royal Shell Oil Company [which once owned 5% of the stock in 1978, which was worth \$425 million and also he holds stock in Exxon]. In 1976, 15 representatives from the Soviet Union attended the meeting in the Arizona desert. Some claim that the Bilderbergers planned to end Communism in the Soviet Union during that meeting. **Even Dan Quayle (a lackey for the elite) in 1990 was at a Bilderberg gala in Long Island, New York.** In 1995, he thanked Illuminatus Lawrence Rockefeller for his connections to make his success. Baden Baden, Germany [in the Black Forest] in 1991 was another famous Bilderberg Group meeting. There, they discussed plans for a common European currency, European central banking, they talked about Mid-East issues, and they discussed about developments of the Soviet Union. That's similar to the European Union. John Reed, U.S. Republican Senator from Rhode Island John Chafee, and even Douglas Wilder (the first black governor in American history, a Freemason, and a Boule member) attended the 1991 gathering. Also, David Rockefeller said this in Germany in 1991:

"We are grateful to the Washington Post, the New York Times, Time magazine, and other great publications (more)...But the world is now more sophisticated and prepared to march toward a world government. The supranational sovereignty of an intellectual elite and world bankers is surely preferable to the national auto-denomination practiced in past centuries."

In 1992, the Bilderbergers advocated an UN army to, by force, impose its will on any nation. That's nuts since the U.N. is already a corrupt group as it is today. Henry Kissinger advocated using the U.N. to restore order in L.A. during the '92 meeting. All of the resort areas and hotels are cleared of visitors and residents before the Bilderberger ascend these soldiers, armed guards, the Secret Service, and state and local police guard the area. All bugging devices are scanned in all conference and meeting rooms. The Bilderbergers try to keep what goes on in their meetings secret from the public. The media never report the Bilderberg Group greatly. Why? They don't want us to know their paymasters since many media bigwigs are apart of the Bilderberg Group. The late Peter Jennings, Bill Moyers, George Stephanopolis, and Paul Gigot are or were in it. Bilderberg policy is carried out by the Bilderberg Steering Committee (made up of 24 Europeans and 15 Americans) and by the Advisory Committee, which makes a smaller group within the organization.

*Only a brief press conference is held to show some of the topics discussed after the meeting. According to Fritz Springmeier, the executive committee of the Bilderbergers is the 9th Degree of the Illuminati. 1 Simdwater, The Hague, the Netherlands is the address of the permanent Bilderberg Secretariat. 345 E. 46th Street, NYC is the address of the American version of it (i.e. the palace of the Trilateral Commission and the Carnegie Endowment for International Peace). One of the more recent events, they discussed about the Iraq War in their May/June 2002 meeting as found in this source:

“The Issue of America going to war in Iraq has been delayed, with the White House agreeing to wait at least until next year, instead of late summer or early fall, but many issues simmer at this year’s secret Bilderberg meeting.” (“Bilderberg Meets” by Jim Tucker-American Free Press-June 1, 2002)

Further in Tucker’s “Bilderberg Batters Bush; but unity remains on N.W.O.” on June 9, 2002 at the American Free Press had Rumsfeld saying no immediate war, but didn’t say there aren’t any “plans for future wars.” So, they indeed set consensus policies. The Bilderberg Group is a miscreant-networking group who’s an enemy of man and most importantly an enemy of Almighty God, who created the universe (because of their extreme secrecy and their globalist agenda). The website of www.bilderberg.org, Jim Tucker, American Free Press, and others have been some of the foremost in exposing the Bilderberg Group.



Bilderberg Gatherings from 2004 to 2007

The June 3-4, 2004 Bilderberg assemblage was held in Stresa, Italy. It was its 50th anniversary and their 52nd meeting. Folks came not only from Europe and America, but also from Turkey, Canada, Cyprus, and other areas. The American delegation had 33 members among the 127 **known** attendees. Full of luminaries of the globalists were present like:

Jim Tucker wrote this about Stresa:

“...At this year's secret Bilderberg meeting, some of the world's most powerful elite focused on U.S. taxes and foreign giveaways, as well as the increasingly violent Iraq occupation and the role the United Nations should play in all future similar outbreaks of violence. Prior to the

meeting, a Bilderberg memo promised that its members would deal mainly with European-American relations and in that context, with U.S politics, Iraq, the Middle East, European geopolitics, NATO, China, energy and economic problems. During the conference, Britain came in for harsh criticism for supporting the invasion of Iraq. It was also lambasted for failing to embrace the euro, despite Prime Minister Tony Blair's promise to do so at a Bilderberg meeting some years ago in the Scottish resort of Turnberry. **Bilderberg members also expressed frustration with the rising clamor in Britain to quit the European Union.** As expected, the United States was heavily criticized for the fact that its foreign aid was a smaller percentage of gross domestic product than that of other nations. That marked the third straight meeting at which Bilderbergers' decades of almost total congeniality was marred by hostility among the Americans, Britons and continental Europeans... Bilderbergers, however, remain united in their long-term goal to strengthen the role the UN plays in regulating global relations...European Bilderbergers also protested the fact that the Pentagon was considering reducing troop levels in Germany and tried hard to convince their American counterparts to resist the move. They argued it would "undermine unity" and, irrespective of the military implications, the German economy benefited annually from the millions of dollars spent by U.S. servicemen there.

Resistance in Britain to the euro, and to membership in the European Union, caused much concern and was deemed an obstacle to the solidification of the super state. It was noted that many Europeans were unaware of the European Parliament elections scheduled for June 10 and should there be a low turnout, EU opposition groups could attribute it to a protest boycott of the elections. Four former Conservative members of Parliament have endorsed the United Kingdom Independence Party, which demands British withdrawal from the European Union. And, if allowed to vote in a referendum, it has been reported that Britons would reject membership in the European Union by strong proportions. A YouGov survey, taken at the end of May, showed 48 percent would vote to get out of the European Union and 36 percent would vote to stay in. As it stands, Europeans can only select members for the European Parliament but not the EU Commission, the bureaucratic powerhouse of the union. Bilderberg participants ended their secret sessions on an upbeat note with a ferry ride to a luxury island on Lake Maggiore, where John Elkman, the latest vice president of the Fiat motor company, will marry his new bride in September...." (From www.bilderberg.org/2004.htm "Investigation Reveals: Bilderbergers Want Taxes Up, War in Iraq Over" By James P. Tucker Jr.)

Tucker also mentions that the Bilderberg Group wanted to expand the FTAA to include the whole Western Hemisphere except for Cuba until Castro is gone. They also want the FTAA to evolve into the American Union similar to the European Union [a fulfillment of Bible prophecy describing the kingdom of the Antichrist. The prophecy in the book of Revelation says that 10 Kings under the Antichrist will rule the world]. The Bilderbergers planned more in 2004 as well. They desire an Asian-Pacific Union to be the 3rd great super state and the U.S. and other financial organs to fund them. Indeed, a planned Asian Union might come in 2015. Some of the Bilderbergers seek a global tax worldwide either by a tax on oil or on global financial transactions. The 2004 gathering also wanted to raise the U.S. tax rate (they view it low) and increase U.S. foreign aid to underdeveloped countries. Well, this is gross for taxes should involve individual nations and we're shouldn't submit to a global tax since that's theft not to mention it's unconstitutional and against our national sovereignty.

For Iraq, many of them argued that the U.S. shouldn't invade Iraq without the U.N. European Bilderbergers don't want U.S. troop levels in Germany to decrease to promote "unity" and the German economy benefited yearly by U.S. servicemen. Prince Bernhard of the Netherlands died in 2004 at 93. Jim Tucker of American Free Press was arrested for showing us this exact information for being a good journalist. Texe Marrs mentions even more of the agenda by the Bilderbergers in their 2004 meeting. They according to Marrs are to pass U.S.A. hate crimes to end free speech with them globally, new Big Brother policies to prohibit anti-N.W.O. dissidents to express themselves in the Net and other places, and force Taiwan (a real Nationalist country) to lose its sovereignty to China by 2012. They want this, so China can join the Asian Union. Jocelyn Gecker, who is an Associated

Press Writer, (whose words are found in the link of www.usatoday.com/money/topstories/2009-03-01-2589509399_x.htm) wrote that: "...Thailand - **Southeast Asian leaders** vowed Sunday to push ahead with ambitious plans to become a **European Union-style economic community by 2015** despite roadblocks posed by the global financial crisis and Myanmar's dismal human rights record...The summit was the first since **the group signed a landmark charter in December that makes ASEAN a legal entity, like the EU**, and moves it a step closer to its goal of integration..." Marris talked about the Middle East plans and sending medical care benefits to fund millions of illegal immigrants. The 2005 Bilderberg conference may take place in Munich, Germany according to Bilderberg expert James P. Tucker Jr. It will take place after Bush and Condoleezza Rice came into Europe for a visit. Rumsfeld persuaded Europeans to even train and finance thousands of new Iraqi police. Barry Carmish called Naton Sharansky as a KGB informer. Topics that you can expect to be discussed in the 2005 meeting are about "democracy" in Iraq, Saudi Arabia, the Middle East (they could allow Israel and Palestine to be in the EU??), the development of NATO, the evil EU Constitution, etc. Like always, many leaders of all major international institutions like the World Bank, the IMF, the U.N., and the E.U. visited there. **The Bilderberg Group meet in Ottawa, Canada in 2006. Alex Jones was detained for 15 hours while trying to investigating the happenings in that location. Regardless of what you think about Alex Jones (and I don't agree with him on every issue), it is wrong for the immigration Canadian services to aggressively detain Alex Jones and get rid of his computers (plus other supplies) without a legitimate reason. Many of the people there knew of Alex Jones and his work.** The pro-Bilderberg Group folks called Alex Jones a liar for distorting the real agenda behind the Bilderberg Group, which is false. In truth, The real agenda of the Bilderberg Group has always been globalization, promoting a global tax, and forming an American Union (just like the CFR wants). **Many of them want a global government as said by David Rockefeller. Many members of royalty, politics, heads of the corporate world, and media big wigs came there.** The Bilderberg Group is one of the most powerful groups on Earth. Kanata is a suburb of Ottawa.](#) The 2007 Bilderberg Group was held in Istanbul, Turkey. Jim Tucker is an expert on the meeting. He has even be almost arrested by the members there. Jim also was shot at. Turkey is a nation with strong pro-Big Brother laws.

Hundreds of people were at Chantilly, Virginia protesting that nefarious organization. The reason is that the Bilderberg Group is made up of 120+ individuals dictating a lot of the policies in the global realm without our input or permission. **It has strong secrecy with intelligence agencies plus security preventing people from even going into Bilderberg's meetings. Many of the Bilderberg's members have said derogatory comments and endorsed wicked policies for the globe.** The Bilderberg Group was created in 1954 by Prince Bernard and pro-Jesuit Joseph Rettinger. The Bilderbergers were crucial in the creation of the European Union since some of its founders wanted the EU like Rettinger. Some believe they gave the green light for the Iraq War back in 2002. Famous members of this enclave include Bill Clinton, Donald Rumsfeld, former British Prime Minister Tony Blair, and others. The Bilderbergers will meet this year in Vouliagmeni, Greece on May 14-17, 2009.

Vouliagmeni is 20 miles outside of Athens and the Nafsika Astir palace hotels are meet behind guards at the Westin Nafsika. According to James P. Tucker Jr., the Bilderberg agenda in that will meeting will deal the handling of the global economic crisis (Tucker believes that the Bilderbergers are manipulating the economic crisis for their selfish interests). Of course, the Bilderbergers bash any pro-American fair trade endeavors as equated to "protectionism." The Bilderbergers are internationalists, they view themselves as citizens of the world, and their leaders especially scorn strong nationalism. These are the reasons that they love free trade, whose dogma carried out into the extreme is essential for the plan of world government. According to Jim Tucker, the Bilderbergers don't want the United States and other countries to impose tariffs. Tariffs can equalize competition in trade. The Bilderbergers would enjoy the shipping of U.S. manufacturing jobs over seas, while cheap labor is exploited in the Third World. Jim Tucker said that the Bilderbergers want to continue importing products made by slave labor in China and Africa, underselling domestic products. **The Bilderberg Group is a secret elitist group that meet each spring at posh resorts.** They are protected by armed guards, uniformed police, and the world's intelligence community. Their deliberations are kept secret. They were invented by the pro-Jesuit Joseph Rettinger and Prince Bernard of the Netherlands among others. **The Bilderbergers have been exposed greatly in recent years, especially since 2006.** **The Bilderberg Group have members in the Barack Obama administration.** They support the European Union and the regionalism of the North American continent (that can lead into the creation of the North American Union). An Asian Union is growing as well. Some want a real Asian Union by the year of 2015. Bilderbergers have used the man made global warming myth to promote the Kyoto treaty as well (like the U.N.). Tucker is the author of Jim Tucker's Bilderberg Diary: One Man's 25-Year Battle to Shine the Light on the World Shadow Government. Tucker is a key expert on the cosmology and history of the Bilderberg Group. So, these groups are being exposed daily.

Bilderberg updates in 2009 are coming in. The comedian Charlie Skelton was arrested for just taking a photo of the sea view near the Bilderberg Hotel in Greece. Greek police that were armed tried to force Charlie Skelton to delete images from his camera. He refused, so he was detained by the police for a temporary period of time. Skelton was comical about it, then he seriously criticized the media for not covering the policies of the Bilderbergers in an elaborate

type of way. The Hotel was the Astir Palace near Athens. This is the Bilderberger's 57th annual meeting. There is a Dutch Prime Minister being grilled over the Bilderberg Group as well. A Dutch Member of Parliament has formally petitioned Prime Minister Jan-Peter Balkenende and his European Affairs Minister Frans Timmermans concerning their involvement with the Bilderberg Group, citing an article released by Prison Planet last week. "In his [web log on May 13](#), Member of Parliament of the Socialist Party, Harry van Bommel, refers to, and footnotes, (Paul Joseph) Watson's article on information confided to Bilderberg researcher Daniel Estulin concerning the agenda of the secretive meeting," writes Jurriaan Maessen. The secretive nature of the Bilderberg Groups is easily proven by even mainstream sources of information. Prime Minister Baleknende went into last year's Bilderberg Group meeting in Chantilly, Virginia. This was before he went with then President George W. Bush and Queen Beatrix (plus her son William-Alexander. Queen Beatrix is a regular attendee of the Group). **Eustlin believes that the 2009 Bilderberg agenda deals with our economic future as in his own words as: "...Either a prolonged, agonizing depression that dooms the world to decades of stagnation, decline and poverty ... or an intense-but-shorter depression that paves the way for a new sustainable economic world order, with less sovereignty but more efficiency..."** According to Estulin, "One of their concerns is addressing and neutralizing the anti-Lisbon treaty movement called "Libertas" led by Declan Ganley. One of the Bilderberger planned moves is to use a whispering campaign in the US media suggesting that Ganley is being funded by arms dealers in the US linked to the US military." van Bommel is in his written request wants to find out on the Dutch cabinet's position on Bilderberg and their stance on the purported plans to discredit Ganley. van Bammel feels that the European Union wants to use slander against Declan Ganley in order to promote the anti-liberty Lisbon Treaty (which can further strengthen the European Union). Ganley is a leader in the anti-Lisbon movement called "Libertas." van Bommel wants to see if the Bilderbergers are promoting the Lisbon Treaty. Time will tell if the **Dutch Prime Minister will answer van Bommel's** questions. [Blair brazenly lied in front of Parliament again in October 2006](#) when, in response to a question regarding Bilderberg by MP Norman Baker, he stated, "I have not attended any such meetings," despite the fact that [he attended the 1993 Bilderberg meeting in Greece](#). van Bammel's inquiries are legitimate since it's about time that political leaders are trying to get answers about the Bilderberg Group indeed.



The Modern World

In the 21st century, the economic crisis is still here. Instead of allowing bad corporations to fail, the government is using their power to control as much industries as possible in order to centralize wealth into central banks. **Barack Obama believes that tax increases for those making \$250,000 or above is fine, but there are problems with this plan. One issue is that the top 5% have wide differences of income. A person making \$250,000 is hardly rich, but upper middle class. Also, it's very unfair to tax a \$250,000 income earner to a person making over 100 million dollars. After federal, state, and local taxes, a person could earn about \$160,000 per year if they are lucky. In big cities like New York City, that is just upper middle class not super rich at all. Therefore, this tax plan will tax a huge part of the middle class in order to bailout the super rich. According to Paul Craig Roberts: "...In America, the truly rich are those in the top 0.5% of the income distribution. These are the people with yachts, private airplanes, and who are still rich after they lose half their wealth in a stock market collapse caused by government policy that accommodated financial gangsters...The real rich are few in number and seldom present any opposition to government. Recently, the New York Times reported (March 23, 2009) that the 400 richest Americans' "share of the nation's total wealth has nearly doubled to more than 22 percent." The average income of the 400 richest Americans is \$263 million annually. That is 1,052 times the income of the "rich" \$250,000 income..."** Constant overspending that can inflate the dollar is a prescription for economic complications as well. A real tax policy would be tax cuts across the board and cutting spending on areas of foreign affairs (and enact other reasonable policies. These policies are reforming our trade policy to be more fair, ending foreign military bases, get rid of corporate loopholes, create more funds to help the poor & middle class, develop specific incentives for economic growth, and getting rid of the FED). In other words, a multi-faceted approach in acquiring economic solutions is better than doing nothing or using unnecessary spending. **Bilderberger Treasury Secretary Timothy Geithner wants to decide on his own which companies are 'systemically' important to our country and worthy of taxpayer investment, and which are not. This bailout law isn't about real economic growth among the**

people directly. It's about the state and central banks to centralize power and forcing banks to accept more TARP money even if they don't need it (or want it). The bailout money (in large quantities) were sent into Big Banks not directly into the American people or homeowners. 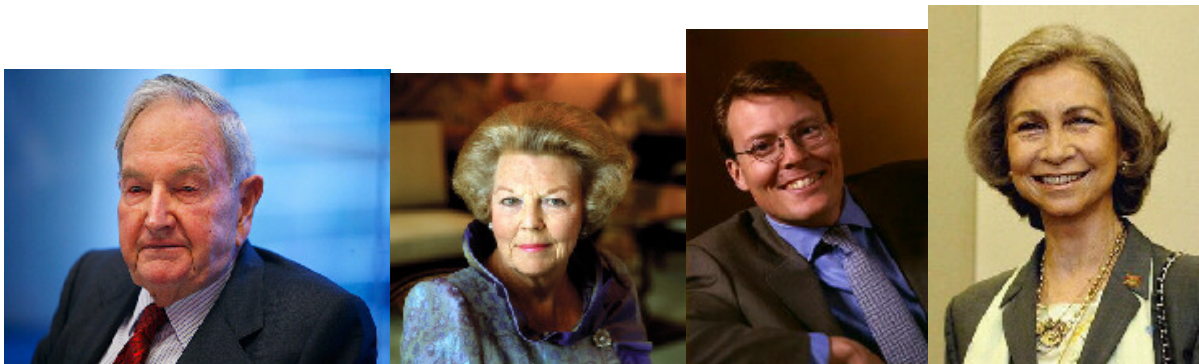

Or maybe it's the beginning of a realisation that the world will no longer be the same and we are going to do something about it..." **The Eu Observer article said that: "...A meeting in June in Europe of the Bilderberg Group- an informal club of leading politicians, businessmen and thinkers chaired by Mr. Davignon- could also 'improve understanding' on future action, in the same way it helped create the Euro in the 1990s, he said..."** There is even a 1955 Bilderberg Group conference that was held in Germany, which discuss the agenda to create an European Union and a single EU currency (This was decades before they were introduced). Leaked papers from the meeting which took place from September 23-25 1955 at the Grand Hotel Sonnenbichl in Garmisch-Partenkirchen, West Germany, were released by the Wikileaks website yesterday. The summary report of the 1955 meeting talks of the "Pressing need to bring the German people, together with the other peoples of Europe, into a common market." The document also outlines the plan, "To arrive in the shortest possible time at the highest degree of integration, beginning with a common European market." There is an early European group promoting a single market called the European Economic Community, which was formed in 1957. The EEC was duly created via the Treaty of Rome, which was signed on 25 March 1957. Its nations originally comprised of Belgium, France, Germany, Italy, Luxembourg, and the Netherlands. The EEC became the European Community and

then the European Union by 1993. “**A European speaker expressed concern about the need to achieve a common currency, and indicated that in his view this necessarily implied the creation of a central political authority,**” states the summary document. The document desired an unification of Europe, which is a Vatican brainchild. James P. Tucker Jr. wrote about how other Bilderbergers desire a global currency system in September 28, 2009. Tucker writes that former German deputy finance minister Heiner Flassbeck co-authored a report calling for a global currency. He worked with then U.S. Deputy Treasury Secretary Lawrence Summers in 1997-98 to contain the Asian financial crisis. Summers is a longtime Bilderberg luminary and has been photographed by AFP at annual secret Bilderberg confabs. Appendix A: The Pilgrims Society

This refers to their influence literally being global. Also, there are the images of an eagle and a lion. This of course refers to the logos of America and Great Britain. The Pilgrim Society was never discussed in the mainstream media presently at all and rarely discussed in the alternative media until 2006 or 2007. The real Pilgrims were religious people coming from Europe into Europe in order

to acquire religious freedom. Therefore, the Pilgrims Society mocks many of the legitimate reasons the Pilgrims came into America in order to form the new world order (by leaving the old world). To Fritz Springmeier's credit, he was one of the few men that exposed the Pilgrims Society back in the 1990's. Now, the Pilgrims are learned about with more accurate and they are greatly understood during 2009. It's even rare to find a membership list of the Pilgrims until recently. Before discussing its members, it's time to learn about its origin. Now, before the Pilgrim Society was formed, there was the Round Table Group. This was formulated by Freemason Cecil Rhodes to create the new world order under British rule. **In 1891, Rhodes organized a secret society with members in a "Circle of Initiates" and an outer circle known as the "Association of Helpers" later organized as the Round Table organization.** The Rothschild Family, Milner, and other leaders funded and were apart of the Round Table. They were key in imperialism and Rhodes' allies were involved in South Africa to oppress Africans (and the Boers, which they subjected to immoral rule). The British general Field Marshall Earl Roberts of the Boer War was a founder of The Pilgrims. Lord Kitchener was the British commander for South Africa---and became a member of The Pilgrims. According to www.boer.co.za, under Lord Kitchener there were 116,572 Boers in concentration camps during 1899-1902; and 27,927 died of starvation, of which 22,074 were children under age 16. The war was over control of the mineral wealth. Lord Alfred Milner, British High Commissioner for South Africa--- later Viscount Milner, was an associate of the Rothschilds and the Royal Family. Milner funded the Russian Communist Revolution from 1916 to 1917. The Pilgrims helped to form the Soviet Union and economically aided China as well. **After Rhodes died, according to Georgetown University Professor Carroll Quigley, the offshoots of the Rhodes Round Table was the RIIA in Great Britain and the CFR in America. In 1928, the Council on Foreign Relations was dominated by the associates of the Morgan bank. Closely allied with this Morgan influence were a small group of Wall Street lawyers whose chief figures were Elihu Root, John W. Davis, the Dulles Brothers, John J. McCloy, etc.** The London chapter of the Pilgrim Society was established in July 11, 1902 (This invention was held in the British Carlton Hotel. Those in attendance were Lindsay Russell, General Lord Roberts, General Joseph Wheeler, and Sir Harry Britain). William MacDonald Sinclair, was elected chairman of the executive committee in the early 20th century. The New York chapter of the group was formed in January 13, 1903. The people around Lord Alfred Milner and the then deceased Cecil John Rhodes created the Pilgrim Society. They wanted to strengthen ties between Great Britain and the United States of America. Most of the American members of the Pilgrims are top level bankers and elitists from the East Coast of America. Most people that are invited to join this powerful organization are in their 40's and 50's. Famous members are Chief Justices, Attorneys, bankers, and other prominent people in America. There are dining meetings where political subjects are discussed. Pilgrim member Francis F. Randolph was the Russell Trust Association's Treasurer for years. The Russell Trust Association is the corporate name of the Skulls and Bones secret society. Now, the Skulls and Bones is one entry level point into more powerful groups and Secret Societies like the CFR, the Bilderbergers, Freemasonry, or even the Pilgrims. The Skulls and Bones plus related group back in the 19th century were conduits in funding the British Empire (including the Opium Trade). That is why Russell and Company was granted opium trading concession in China by the BEIA or the British East India Company. **There is a Skulls and Bones and Scroll and Key link to the Pilgrims Society. A great example of the cooperation between the London and American Pilgrims is the London Bush House, which was ordered to be built in 1919 by Pilgrim Irving T. Bush, a N.Y. businessman. The Pilgrims are very famous for being involved in the Jekyll Island meeting in 1910 (the Pilgrims' names are Vanderlip, Strong, Warburg, Davison, Norton, and Aldrich) that lead into the creation of the Federal Reserve Act of 1913. **Also, Alfred L. Aiken (who was the financial advisor to Senator Nelson Aldrich), Edward B. Vreeland (who was Aldrich's associate was a Pilgrim. He Aldrich's associate in Congress), Otto Kahn, and Jacob Schiff were all members of the Pilgrim Society. The Pilgrim Society is very powerful organization (which is more stronger than the CFR) that is related to the Anglo-American establishment. President Woodrow Wilson signed the bill into law and later regreted the Federal Reserve ultimately.** Afterwards, Pilgrims were Presidents of the New York Federal Reserve Bank from 1914 to 1979. Thomas Watson of IBM was a Pilgrim that was key in aiding Nazi Germany in giving them electronic counting machines. Pilgrims were involved in the Nuremberg trials (like the Freemasons were). The power of the Pilgrims is expressed by this interesting quotation:

"There are several curious things about these Pilgrims functions. In the first place there is present at these dinners an array of notables such as it would be difficult to bring together under one roof for any other purpose and by any other society... Among the guests were John D. Rockefeller and J.P. Morgan, Thomas W. Lamont and other members of the House of Morgan... We are entitled to know what the Pilgrim Society is, what it stands for, and who these powerful Pilgrims are that can call out the great to hear a British Ambassador expound to Americans the virtues of a united democratic front."

- John T. Whiteford asking very reasonable questions in his 1940 pamphlet 'Sir Uncle Sam: Knight of the British Empire'.

The Pilgrims Society also meet in prestigious hotels like the Victoria, the Waldorf Astoria, the Carlton Ritz, and the Savoy. One Pilgrim named Francis Beverly Biddle was one of the four primary judges at the Nuremberg trials. He represented America. In 1973, Pilgrim Edward W. Simon was chairman of the President's Oil Policy Committee from February to December of 1973 (oil crisis started in October in the midst of the Yom Kippur war). He also was an administrator of the Federal Energy Office since December 1973 and was charged with the responsibility of minimizing the effects of the energy crisis and preventing future crises (decided the oil prices and the distribution).



Referring to the power of the organization, in a speech at the House of Commons on August 20, 1941, Winston Churchill (a member) said, "No one could stop it. Let

it roll on in full flood, inexorable, irresistible.” *On page 223 of his unauthorized Nixon biography, Allen wrote---*“...Bobst is listed as a member of the highly secret Pilgrim Society, which is even closer to the inner circle of the conspiracy than the CFR...” Bobst was a Knight of Malta and was a leading member of Big Pharma (as the then head of Warner-Lambert pharmaceutical company). On page 27 of the article, Gary Allen commented that: “David Sarnoff is a member of the super-secret Pilgrim Society, whose official logo is entwined American and British flags. This group, which is dedicated to merging Britain and America, has a number of internationalist members like Paley, Sarnoff, and John Schiff whose ancestors were not British.” David Sarnoff was once the chairman of RCA or the Radio Corporation of America and NBC. One leading member of the Pilgrim Society in Great Britain is the Duke of Westminster named Gerald Cavendish Grosvenor. Grosvenor is one of the Royals that owns over 300 acres of the property in downtown London, Canada, Australia, Hawaii, and other places. That is why it’s common to witness Barons, Viscounts, Earls, Marquises, and Dukes as members of the Pilgrims Society. The Pilgrims are Vatican allies. Not to mention that certain people refuse to expose real Vatican elites found in the Constantinian Order, the Order of St. Gregory, the Knights of Malta, the Order of St. Francis, Opus Dei, etc. Knights of Malta Myron Taylor and J. Peter Grace are Pilgrims. The banks that the Pilgrim Society have influence from range from Chase Manhattan US/UK, Citibank, JP Morgan Chase, the Bank of England, etc.

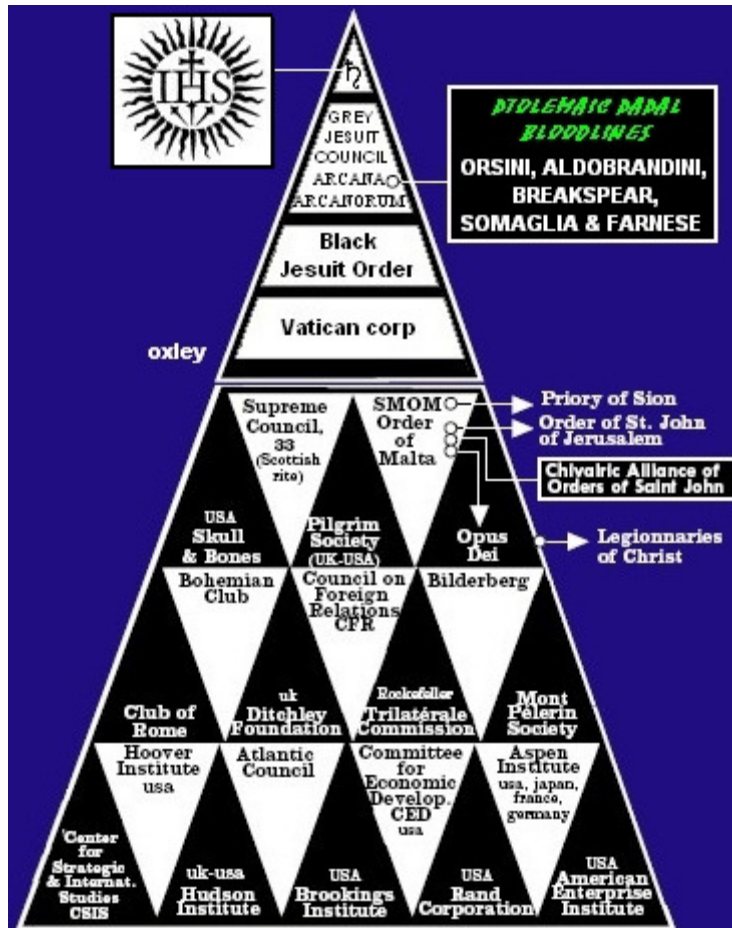


Appendix B: A Secret History among the Nazis & the E.U.

These top Nazi industrialists were ordered by SS Obergruppenfuhrer Dr Scheid to set up front companies abroad and pose as democrats in order to achieve economic penetration and lay the foundations for the re-emergence of the Nazi party. "The Third Reich was defeated militarily, but powerful Nazi-era bankers, industrialists and civil servants, reborn as democrats, soon prospered in the new West Germany. There they worked for a new cause: European economic and political integration," writes Lebor. [Wealthy Nazi bankers like Alfried Krupp and Friedrich Flick used front companies like the BMW, Siemens, and Volkswagen to try \(or Krupp Industries\) to build a new pan-European business empire.](#) [Historian Dr. Michael Pinto-Duschinsky is an adviser to Jewish former slave labourers.](#) He said that: "For many leading industrial figures close to the Nazi regime, Europe became a cover for pursuing German national interests after the defeat of Hitler....The continuity of the economy of Germany and the economies of post-war Europe is striking. *Some of the leading figures in the Nazi economy became leading builders of the European Union.*" [Banking leader Hermann Abs joined the board of Deutsche Bank during the rise of the Nazis.](#) He sat on the supervisory board of I.G. Farben (IG Farben is the company that made the Zyklon

B gas that murdered concentration camp victims). Abs was even apart of the Marshall Aid allocation funds that economically aided the Germany industry. He managed Germany's economic recovery by 1948. Abs was apart of the European League for Economic Co-operation, an elite intellectual pressure group set up in 1946. This League wanted a common market, which was a precursor of the European Union. Many of the Nazis' organization promoted similar common market systems as the Nazis ([according to Rodney Atkinson's "Europe's Full Circle"](#)). Nazism and the EU have many similarities. The Bilderbergers (their founders include pro-Jesuit Joseph Rettinger and accused Nazi Prince Bernhard of the Netherlands) even wanted an unified European currency (in a common market) according to documents from 1955 (as proven by the Bilderbergers' own leaked documents). Other top Nazis who called for the creation of a pan-European federal economic superstate include Ribbentrop, Quisling and [Seyss-Inquart](#), who spoke of "The new Europe of solidarity and co-operation among all its people... will find...rapidly increasing prosperity once national economic boundaries are removed." So, the European Union was dreamed way before 1993. The EU today has embraced totalitarianism. Some Euro MPs want to ban certain blogs on the Internet. Under the 1999 ruling of the [European Court Of Justice \(case 274/99\)](#), it is illegal to criticize the EU and the EU is on a [mission](#) to outlaw any national political parties that do not pander to the European federal superstate agenda. 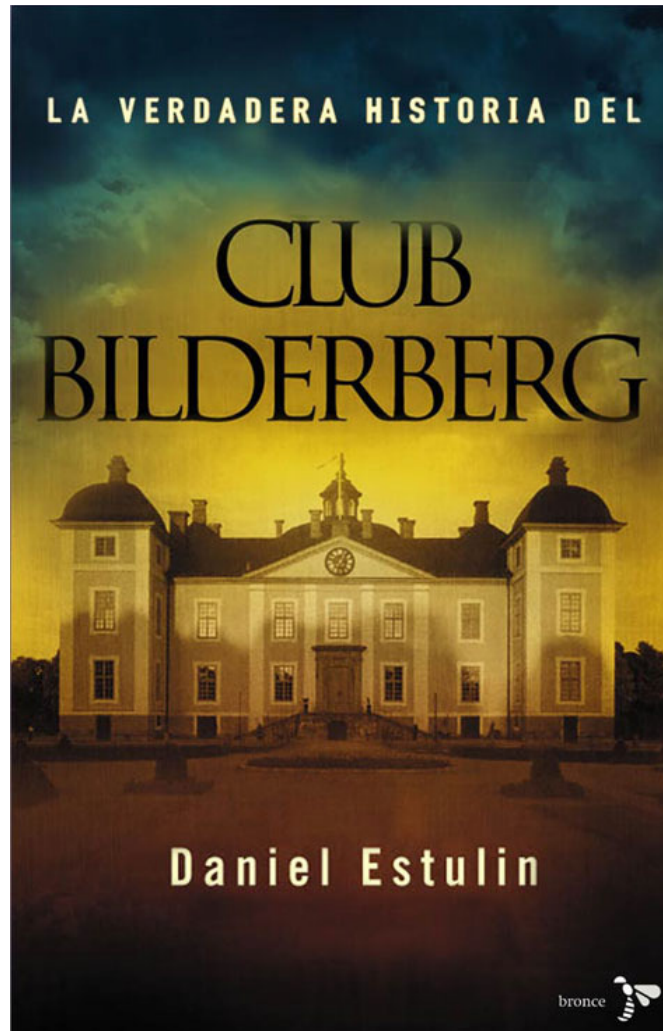


This is Craig Oxley's Chart of world Power.

Eustlin is the famous researcher of the Bilderberg Group. He recently gave an interview with the Corbett Report in early November of 2009. He revealed the behind the scenes details of last week's G20 Finance Minister's meeting in St. Andrews, Scotland. Some of the details of this occurrence have come out from actual G20 documents. Eustlin says that his sources were able to sneak out of the meetings these documents despite the security measures he calls unprecedented even by Bilderberg standards (as the Bilderbergers are protected by the Secret Service, CIA, MI6, MI5, the Mossad, the BND, etc.). The documents contain valuable information about the conference. They are found at BilderbergBook.com and have been [mirrored on The Corbett Report homepage](#). This information were smuggled out at great personal risk. People are disseminating this information widely and they should be since people have the right to know the truth. Eustlin found out that the meeting about the next step in globalization. The elite according to him wants to create the African Union. The African Union agenda is really similar to the EU, which is about the ceding of national sovereignty to unaccountable regional governments. The list have the names of: leading Bilderbergers such as U.S. Treasury Secretary Timothy Geithner, Federal Reserve Chairman Ben Bernanke, World Bank President Bob Zoellick, Turkish Finance Minister Ali Babacan and British Finance Minister Alistair Darling and many others. The Trilateral Commission was also represented at the conference by Japanese members Yoshihiko Noda and Masaaki Shirakawa. Estulin in his interview talked about the G20's debate on dumping the U.S. dollar. "The American and the British delegations tried to persuade the Russian and the Chinese delegates to devalue the dollar and create a basket of currencies or another world currency to take the place of the dollar," he said. "Luckily, both the Russians and the Chinese told the Americans and the British to go pound sand. They were not willing to do this." This proves that some Western financial oligarchs want to dump the dollar in order to promote another global currency (under a new financial system as promoted by Henry Kissinger and George Soros. The new financial order these men promote are unaccountable and unelected. Herman Van Rompuy is the new EU President

The European Union has decided on its new President. His name is Herman Van Rompuy. He's a member of the Bilderberg Group. The Bilderberg Group promotes globalization and the new world order of course with member David Rockefeller desiring the new world order by his own words. Rompuy is of the establishment by being in the seat of Prime Minister of Belgium. The decision to make Rompuy the new President of the EU was made in a dinner meeting in Brussels by the leaders of the 27 EU member states. The new positions include; President of the European Council and Foreign Affairs Chief and comes into effects on December 1, 2009. **Van Rompuy will take his post as the first president of Europe on January 1, 2010. The permanent EU President seat was created by the Lisbon Treaty. He was educated at the Jesuit Sint-Jan Berchmans College in central Brussels, then studied philosophy and economics at the Catholic University of Leuven. At the meeting Van Rompuy gave a speech about the implementation of new taxes on shopping items (value added tax), airline travel (aviation tax) and petrol stations (fuel duty tax) that will go directly to Brussels as an "EU tax."



He said: "The possibilities of financial levies at European level must be seriously examined and for the first time the large countries in the union are open to that," credit to the newspaper De Tijd. The EU and the Bilderbergers love global carbon taxes and as many taxes as possible in society. The Bilderbergers was created by Vatican agents and Western elitists. Belgium expelled the Jesuits in 1818 and when the Jesuits were expelled from Germany in 1872, they came into Belgium. Further, the Order was expelled from all public and private schools in Belgium in September, 1826 according to Eric Jon Phelps. The new EU President according to Daniel Taylor said that he wants global governance, because of the world financial crisis. He admitted that he was n't there only as a Prime Minsiter of Greece, but a representative of the Socialist International. **He supports global taxes, an international carbon tax, green bonds or transaction taxes, and in his words: "...transforming foreign debt into equal funds to be used by poor countries for climate change adaptation..."** He attended the Bilderberg Group's conferences in the years of 1995, 1998, 2000, 2004, and 2005. He is one of numerous world leaders desiring world governance as an excuse to promote climate change hysteria. This is extreme, because carbon dioxide is a natural chemical that plants breathes. Papandreou authored an article for TheNation titled '[The Challenge of Global Governance](#)' in which he openly stated: "While I am pleasantly surprised that socialism is back in vogue, I am also mindful that it must be reinvented, too...we are calling for greater financial transparency, more robust regulation, the closing of tax havens, and the creation of a World Finance Organization to enforce global standards..." **So, it's there. Even the nation of Spain is suffering, because the green initiatives in the antion have according to some decreased Spain's standard of living. "Bilderberg-controlled news outlets in Europe and the Western Hemisphere are conditioning the public to accept two of the super-secret elite's major goals in advance of its meeting June 4-7 in Sitges, Spain: a U.S. attack on Iran and a financial bailout of Greece and other European Union (EU) countries," [writes Tucker](#). It isn't a secret that the agenda for global government is real (and out of the open) along with the Bilderbergers grooming politicians to have high powered positions within the new world order hierarchy. The most interesting aspect to come out of this year's conference in Sitges Spain is the question of who will be attending. David Cameron has a new coalition government in the UK. It opposes the Bilderberg's European project in rhetoric, but they have appointed pro-Euro politicians to influential posts. There is a possible attendance of Cameron and Nick Clegg to the Bilderberg group. Some UK Labour Party members may be invited to the group. Gordon Brown resigned in the UK (and the Bilderberg could recruit people like possible future Prime Ministers like David Milliband).

Bill Gates was in the Bilderberg 2010 conference. Microsoft founder Gates funds & bankrolls sterilization vaccine programs. Gates is to have given a speech on global warming agenda and "the needs of the poorest." He was forced to admit to journalists that he will give a speech at the globalist confab. He admitted this information to

journalists from 20 Minutos, which is a free Spanish newspaper. This newspaper is published only in numerous Spanish cities plus others globally. According to the report, Gates told reporters, "I'm one of those who will be present." Bill Gates promotes eugenics like programs. The Rockefeller Foundation praised Hitler's sterilization program in Nazi Germany. A joint World Health Organization-Rockefeller inoculation program against tetanus came about in Nicaragua, Mexico and the Philippines. In the early 1990's was in fact a covert trial on using vaccines to medically abort women's babies. "Comite Pro Vida de Mexico, a Roman Catholic lay organization, became suspicious of the motives behind the WHO program and decided to test numerous vials of the vaccine and found them to contain human Chorionic Gonadotrophin, or hCG," writes historian F. William Engdahl in his article, [Bill Gates And Neo-Eugenics: Vaccines To Reduce Population](#). Other reports show that the vaccines were laced with hCG hormones came from the Philippines and Nicaragua. This can cause pregnancy problems when the natural hormone hCG merges with a tetanus toxoid carrier. He wants to use sterilization against men to make him infertile for six months. This is wild stuff. "The foundation has funded a new "sweat-triggered vaccine delivery" program based on nanoparticles penetrating human skin. The technology is described as a way to "...develop nanoparticles that penetrate the skin through hair follicles and burst upon contact with human sweat to release vaccines," [writes health researcher Mike Adams](#). Gates might support a carbon tax. The carbon tax agenda is wrong since it won't radically stop pollution. Also, it will enforce a consumption tax that can reduce the standard of living of people (especially in a global depression). The Bilderberg act undemocratic in their hierarchy when they propose these policies. Some Bilderbergers view people with income as a threat to the plans of globalism or world government. The Bilderberg's history has a long journey. It was created in the Netherlands in 1954. They met each year with over 125 people per year. Their members are made up of the political, financial, military, academic and media elite worldwide (primarily from North America, Western Europe, and Japan). Researchers have found that CEOs or Chairman of some of the largest corporations on Earth (like from Royal Dutch Shell, British Petroleum, and Total SA) are members of the Bilderberg Group. European monarchs, international bankers, and David Rockefeller (including major politicians, President, Prime Ministers, and central bankers of the world) are in the club. Joseph Retinger was one of the architects of the European Common Market and a leading intellectual supporter of European integration. He wanted a federal union for European countries to relinquish part of their sovereignty (among European nations) in 1946. The CFR and the Rockefellers funded Retinger's efforts to institute the European integration agenda. The CFR has been heavily founded by the Carnegie Corporation, Ford Foundation, and the Rockefeller Foundation. The Bilderbergers are heavily influenced by the Vatican and the Pilgrim Society. Tons of people already know that the European Union is pro-Papacy since the Papacy have agents in the European Union. This global think tank wants to link the governments and economics of North and Europe. The Bilderbergers desired the EU for a long time. Newly released documents from the 1955 Bilderberg meeting show that a main topic of discussion was "European Unity," and that "The discussion affirmed complete support for the idea of integration and unification from the representatives of all the six nations of the Coal and Steel Community present at the conference." Further, "A European speaker expressed concern about the need to achieve a common currency, and indicated that in his view this necessarily implied the creation of a central political authority." Interestingly, "A United States participant confirmed that the United States had not weakened in its enthusiastic support for the idea of integration, although there was considerable diffidence in America as to how this enthusiasm should be manifested. Another United States participant urged his European friends to go ahead with the unification of Europe with less emphasis upon ideological considerations and, above all, to be practical and work fast." Thus, at the 1955 Bilderberg Group meeting, they set as a primary agenda, the creation of a European common market.

Reports from the Bilderberg meetings in Canada in '06 and in Turkey in '07 predicted a global housing crash and forecast a prolonged financial meltdown as a result. Exposures of the Bilderbergers have proven that Bilderberger member plan events or plan strategies about events going on in the present and the future. The

first Bilderberg meeting took place at Prince Bernhard's Bilderberg Hotel in Oosterbeek, Holland in 1954. Hugh Gaitskell is in the far corner of the room looking rather skeptical and you can just see him scratching his chin (in an old picture of the meeting). Chairman Prince Bernhard was a leader of the Bilderbergers for a long time. Prince Bernhard was Chair of the group until 1976 when he was forced to resign because of the Lockheed bribery scandal. There has been documented evidence that the Bilderberg Group was instrumental in European integration (like the euro and of course the E.U.).



The Bilderberg will take place in Switzerland in its 2011 meeting. Switzerland has been a neutral country where money laundering has taken place. **It's an internationalist nation. Swiss bank accounts are there and there can be used anonymously sometimes to hire a hit man to murder someone. Some rich elitists are immune from austerity measures or even some taxation from various nations, because they hide their wealth.** Queen Beatrix and her husband from the Netherlands are regular visitors to the Bilderberg meeting regularly. Over 100 people are in the Bilderberg Group per year. The 2010 Bilderberg Group took place near Athens Greece. There were demonstrators at the place from the political left and right. They shouted outside of the Astir Palace hotel. Other regular attendees at the group include Henry Kissinger, Wall Street Journal Editor Paul Gito, and others. Some sources from

there show that its meetings have a globalist agenda and question the essence of national sovereignty as regressive. According to some (like Joël van der Reijden) , the Bilderbergers are dealing with Turkey to prepare for it for EU membership, while Cerle is dealing with covert action and national security issues. **The 2011 Bilderberg Group meeting will be held in St. Moritz, Switzerland in the Grand Hotel Kempinski.** This will be shown from June 9-12. The location will be close from Davos. Davos is of course, the site of the regular meeting of high priced meeting of thousands of banks, political leaders, and other notables. This meeting is called the World Economic Forum, which deals with the promotion of globalization in the world. The Grand Hotel Kempinski is a luxurious 5 star hotel at the Mauritius spring. This is the actual root of St. Moritz itself. The hotel has a direct access to St. Mortiz spa. The sports center and local swimming lakes are easily walking distance. The Hotel is huge with 184 rooms and suits, 46 resort rooms, 5 deluxe suits, 11 spa suits, 1 Presidential suit (**that is 320 square meters in area**), a fitness center, a casino, 5 modern daylight conference rooms for a total of 300 persons. European news outlets and some U.S. independent media will report on the Bilderbergers. Yet, the Washington Post, the New York Times, The Los Angeles Times, and other major news chains will not report on the Bilderbergers that much since their top representatives are actual Bilderberg participants themselves. The Bilderberg itself is governed by a Steering Committee. It designates a Chairman. Members are elected for a term of 4 years and they can be reelected. There are no other members of the Bilderberg conference.

The Bilderberg insider Henry Kissinger is calling for an U.S. ground invasion of Libya. America now is embroiled in at least 3 major conflicts. We have to take care of our services, our debt (the Standard and Poor said that America will soon lose its triple A credit rating since America's inability to reduce the budget deficit. Although, human lives are more important than austerity), and Kissinger wants the U.S. to have a ground invasion of Libya. He also wants to keep the war continuing for at least another year. Kissinger spoke of these words in at least 3 different globalist confabs. Jim Tucker (who is a veteran Bilderberg Group expose and journalist) said that Kissinger gave almost the exact same speech at 3 different conferences over the past 2 weeks. First, it was in an April 8-10 get together at the George Washington University's Elliot School of International Affairs, then at an Aspen Institute session on "Values and Diplomacy" at the National Cathedral, and in the Bretton Woods II conference in New Hampshire. Tucker has made routinely accurate information from the globalists' secret meetings for years. "Kissinger, visibly depressed, gave a rationale for the war on Libya that the TC (Trilateral Commission) and its brother group, Bilderberg, want to keep rolling, according to an inside source who has proved reliable for years. Both groups want the war extended through 2012 to generate turmoil throughout the Middle East and pressure the United States into attacking Iran on behalf of Israel. Which would also produce huge war profits," [writes Tucker](#). President Barack Obama now wants to oversee unmanned drones to intensify the air bombardment. Some like Kissinger want an U.S. ground invasion. Right now, the intervention in Libya is costing Americans \$608 million. The war in Libya is complex and arming the rebels could make a stalemate continue. The globalists have international agenda dealing with manipulating nation-states. In America, some say that they can't afford to pay the police or firefighters. "In all three speeches, Kissinger played the reluctant damsel who was firmly convinced that the United States must put boots on the ground in Libya—among all the wars that the U.S. is already involved in," reports Tucker. Tucker said that Kissinger is worried about the selling of the invasion of Libya. The reason is that it's been found that some of the Libyan rebels have had links with Al-Qaeda terrorists. NATO is stilling using the rebels to fight against Gaddafi. Some reactionaries want to use Libya as an excuse to promote an U.S.-led attack on Iran. The new Bilderberg Meeting in 2011 will happen in the resort city of St. Moritz, which is in southeastern Switzerland from June 9-12. Some expect the luxurious 5-star Grand Hotel of Kempinski to house the people. This may be one of the most important Bilderberg

meetings in recent years. Indeed, when attempting to book a room for the period in question via the hotel website, a message pops up saying the hotel is closed, all but confirming it as the location for Bilderberg 2011. However, Bilderberg have been known to change their plans at the last minute in a bait and switch to throw journalists off the scent. Tucker, who has been hunting Bilderberg for no less than 36 years, [has released his Bilderberg itinerary](#) for the 2011 meeting.

Recently, a well known Swiss politician wants Kissinger to be arrested at the Bilderberger meeting for obvious reasons. Kissinger has been involved in nefarious acts and his critics expose his war crime activities for decades in the world. Henry Kissinger has been accused of being complicit in war crimes in Indochina (or Vietnam now), Bangladesh, Chile, Cyprus, and East Timor. Many activists have tried to arrest him over the years under the Geneva Convention Act. This person is a figure from Switzerland's largest political party. Kissinger might come into the 2011 Bilderberg conference. It is set to happen in Thursday at the Hotel Survretta House in St. Moritz. He is Dominique Baettig (from the Swiss People's Party). He wrote a letter to the General Prosecutor of the Swiss Federation in desiring the arrest of Kissinger if he comes into Switzerland. Baetting is equivalent to an U.S. Congressman. The man represents the Canton of Jura on the National Council of Switzerland. The Swiss People's Party is the largest of such party in the Federal Assembly. The assembly is made up of 58 members of the National Council and 6 of the Council of States. He wants George W. Bush and French President Nicolas Sarkozy to be apprehended for arrest, but it's unlikely that they will come into the Bilderberg Group. Jim Tucker is one of the great researchers of the Bilderberg Group since 1975. He writes for the American Free Press. He is the author of his book entitled, "Bilderberg Diary" that talks about his car chase experiences, his hotel room bugged, uses of aliases, and other situations in his investigation of the Bilderberg Group. Jim Tucker made numerous predictions that were correct. His predictions have been validated from his research and sources that he was able to smuggle out of past conferences. Even the 1955 Bilderberg confence as documents leaked was devoted to the creation of an European Union and a single European currency. Two years later the Treaty of Rome, now officially regarded as the birth of the European Union, was signed into existence by, among others, [Bilderberg attendee](#) Paul-Henri Spaak. Back in March 2009, former EU commissioner and current Bilderberg Steering Committee Chairman Etienne Davignon admitted to the EU Observer that the Bilderberg has been instrumental in creating the Euro currency in the 1990's. Some of his predictions coming true are the following:

-Jim Tucker made the successful 2002 prediction (based on Bilderberg intel that the Iraq War would be launched in March of 2003).

-Jim Tucker made the 2009 prediction that the Bilderberg would use the financial crisis to work behind the scenes on the construction of a closer American governmental integration. This is confirmed by the newly shown Canadian diplomatic cables detailing about how lawmakers have been quietly working on just such an integration for years. Just last year, former NATO Secretary-General and two-time Bilderberg attendee [Willy Claes admitted](#) that Bilderberg attendees are expected to use reports from Bilderberg meetings to set policies in their respective countries.



One Harvard professor said that the globalists are panic-stricken about Greece debt default threat to their single currency agenda. There is a top Bilderberg member. He said that the globalists are panic stricken about a potential euro zone crisis caused by a Greek debt default. This could precipitate the collapse of the Euro and also derail the wider agenda for multi-regional currency unions and eventually a global currency system. Jim Tucker said that the new Bilderberg meeting will deal with the euro at the globalist confab in San Moritz, Switzerland. Tucker said that the Bilderbergers are afraid that the Euro will go down or disappear. Tucker explained how several European countries' intention to abandon nuclear power after the Fukushima disaster could cause a crisis for the single currency. Sitges, Spain was the location of the last Bilderberg conference. In there, the Euro was in free fall. This occurred after the austerity riots in Greece. The globalist back then panicked that the single currency could face a total collapse. The Euro has made significant gains against the crumbling U.S. dollar over the past year. Yet, some financial analysts are still predicting that the single currency faces a massive crisis. This could threaten its very existence. Last month, representatives of the European Commission held an emergency crisis meeting. This existed after the reports of Greece considering exiting the euro zone and creating its own currency. Some fear that the European Central Bank could be bankrupt if the ECB are exposed to European economies (or if Greece defaults on its debt, which is very possible). According to ratings agency Moody's, "Greece is 50% likely to default on or restructure its debts in the next five years." Bilderberger and Harvard Professor Kenneth Rogoff said that the elitists are concerned that an euro zone collapse would derail the wider agenda for the multi-regional currencies like the Amero. He wrote these words in the Financial Times, which is regularly represented at Bilderberg, but it refuses to report on the meeting. "The euro experiment has also brought us to a crossroads in the whole international monetary system," writes Rogoff. "Will our grandchildren inherit a world with a huge number of national currencies, or a very small number of multi-country currencies?" The Bilderberg was instrumental in promoting the Euro as it was a Bilderberg brainchild (as Bilderberger chairman Etienne Davignon admitted last year that the single currency was formulated by the Bilderberg in the 1990's). A BBC investigative team was allowed to access Bilderberg files which confirmed that the EU and the Euro were the brainchild of the Bilderberg. Also, the EU was a Vatican/Jesuit

brainchild as well. Tucker believed that the globalists want to keep the recession going until at least 2012 plus keep gas prices high. They have resolved to level the globe economically, not by rising up poorer countries to western standards but lowering the standard of living in richer nations. Tucker exposed the fact that the Bilderbergers are furious that more and more resistance is increasing via a number of demonstrations plus independent journalists showing a spotlight on their meetings. This is a feeling that transpired during the last 2 conferences. An astounding exchange between two Bilderberg members overheard by London Guardian journalist Charlie Skelton revealed that the elitists saw people with income as “a threat” to their agenda, as they decried the fact that protesters could actually afford to travel to the different countries in which they meet every year. Tucker admitted that his source said that the Bilderbergers want world depopulation since they feel that the world to them is overcrowded (so they are using wars to depopulate the human population. The elite’s own documents from NSM 200, the PNAC document, and onward call for depopulation via various means all of the time).

New updates and events transpire all of the time as it pertains to this present 2011 Bilderberg meeting. Swiss MP Dominique Baettig and members of the Swiss National Council are calling for the arrest of conference participants who are internationally wanted for war crimes. These people include: George W. Bush, Henry Kissinger, Dick Cheney, and Richard Perle. These people have done a lot of crimes including lies about war, violating national & international laws, the promotion of torture, invasion of sovereign nations without a Congressional declaration, etc. Aaron Dykes and Paul Joseph Watson found out about the names of (from inside sources) that 5 influential people who are not named on the official attendee are in attendance at the Bilderberg conference in 2011. Their names are Anders Rasmussen (the current Secretary General of NATO), Angela Merkel (the German Chancellor), Jose Luis Zapatero (the Spanish Prime Minister), Bill Gates (former Microsoft CEO and the head of the Gates Foundation), and Robert Gates (he is serving the U.S. Secretary of Defense). Aaron has shown information about how Robert Gates’ attendance is a violation of the Logan Act. Tucker has gotten memos from the Bilderberger’s place.



This 2011 Bilderberg Group meeting is expected to have the most attention ever from the public. People and the media are noticing the Bilderberg conference. The issues that they will probably discuss are the economy, globalization, etc. Will Hutton called the group the "high priests of globalization." They don't conduct their issues or discussions in an open forum. The elite have promoted fascism for a long time. The Industrialist Thomas W. Lamont (a chairman of the Pilgrims from 1939 to 1945) supported Mussolini including other Wall Street bankers. The ruling class or the elite hate fights against monopolies, land reorganization to benefit the common people, higher wages, Social Security (this is why the McCormack-Dickstein Committee exposed how fascists wanted to rule America by breaking down American social policies. These fascists had links to the American Liberty crowd during WWII), true labor rights, and a fair work week. Hitler, Franco, and even Japan for a while had been aided by Western Wall Street or Western banking interests.

In the new Bilderberg meeting in 2011, there will be people there like David Rockefeller, Queen Beatrix, Josef Ackermann, and others. The Bilderberg Group has been accused of proposing policies and discussing international issues. The Logan Act makes it crime for any U.S. citizen to negotiate with a foreign nation on the USA's behalf.

There are more stories about the Bilderberg meeting in 2011 showing now. 3 European protesters told Luke Rudkowski about their experience in St. Moritz near the Bilderberg meeting. They put up a banner opposing the new world order in the side road with a profane word on it. Later, Swiss Security rips down the anti-Bilderberg banner and stole the camera. The Europeans are in a US Americans Wake Up video. The video shows the words Bilderberg go home painted on the ground in St. Moritz. The 3 young men said that the security people were clashing them. Jim Tucker said that his insider sources shown the the banker David Rockefeller was spotted in the resort in St. Moritz, Switzerland. Tucker said that the Bilderbergers approve the evil NATO action against Libya (to have big bloody war in the region). He said that high oil prices and huge prices in the pump will be used to gain support for more military action in the Middle East. The U.S. is continuing the secret campaign of air strikes in Yemen. This is intensifying the tensions in the region. Jim Tucker mentioned that the alternative media's exposing

the Bilderbergers' agenda is angering the Bilderbergers. He said the elite attempted to get media magnate Rupert Murdoch to convince The Guardian in the United Kingdom and the Irish Times to scale back their reportage on the Bilderbergers, but he was unable to do so. Tucker's sources also said the Bilderbergers are stunned the presence of demonstrators and alternative media. People spotted in St. Moritz have been the leading neocon and former assistant Secretary of Defense, Richard Perle, and possibly Microsoft founder Bill Gates. Danish politician and current NATO boss Anders Fogh Rasmussen was also spotted. The presence of Rasmussen at the meeting lends credence to Tucker's assertion that NATO's campaign against Libya figures prominently on the globalist agenda.

*The Bilderberg Group has been exposed in a lot of times. The corporate foundations of Rockefeller, Carnegie, and Ford have had a huge influence in the Bilderberg Group and the European integration agenda as well. Professor of Education Robert F. Arnove even exposed these foundations in his book entitled, "Philanthropy and Cultural Imperialism." He believed that these groups are corrosive to a democratic society, because on many occasions these entitled harbor unregulated and unaccountable amount of wealth plus power. These groups buy talent and prevent radical, structural changes in society. Internationalists work with these foundations and have fought against the rights and interests of minorities, the working people, and Third World human beings. These groups promote globalism just like the Bilderberg Group does as well. It isn't a secret that these Foundations have huge influence over education and universities globally not just in the Western Hemisphere. They are the ideological and political descendants of the old American robber baron industrialists that desired economic monopolies. Their drive for economic monopolies was so bad and so brazen that the government had to put restrictions on them. Today, there is sophisticated actions like social engineering, big banks working with elite families, etc. in order control society (in a feudal Empire as predicted by Professor Carroll Quigley from the Jesuit Georgetown University. He was Bill Clinton's mentor). They constrain true knowledge and try to recruit other human beings. Interlocking groups and organizations readily act in uniform in promoting Western political hegemony in the world.



China, The Bilderbergers, Rick Perry, and Economic Information

The Bilderberg Group is a complex organization. China is having a mention according to sources from investigative journalist Daniel Estulin. China is having a huge importance in global affairs since it may exceed the economy of America by 2016 as American hegemony in the world is rapidly decreasing. Also, Pakistan is firmly having a close knit role with China. Pakistan is having controversy with America over Western bombings in Pakistan (in fighting al-Qaeda). China and Pakistan are working together strategically and economically. China is working in Africa that has China competing with Africa in control of African resources, etc. The 2011 Bilderberg meeting will have attendees from China for the first time ever. They are Huang Yiping, a prominent economics professor at Peking University (China's Harvard), and Fu Ying, China's Vice Minister of Foreign Affairs. More and more of the elite want Asian nations to be involved in their network. Japan is a part of the Trilateral Commission for decades under the inspiration of David Rockefeller and

Zbigniew Brzezinski. The Trilateral Commission eventually expanded the Japanese section of the group into a 'Pacific Asian Group' in 2000 to include not only Japan, but South Korea, Australia, New Zealand, Indonesia, Malaysia, the Philippines, Singapore, and Thailand. The G20 is now having China and India to work it in economic affairs too. China and India has been invited to join the Trilateral Commission too in 2009. The elite wants China to be integrated into their world order while China has been a wildcard in its policies for a long time. The elite believe in global governance literally. They even admit that they hate nationalism and want globalization. As Denis Healey, a 30-year member of the Steering Committee, himself pointedly explained:

“...To say we were striving for a one-world government is exaggerated, but not wholly unfair. Those of us in Bilderberg felt we couldn't go on forever fighting one another for nothing and killing people and rendering millions homeless. So we felt that a single community throughout the world would be a good thing... Bilderberg is a way of bringing together politicians, industrialists, financiers and journalists. Politics should involve people who aren't politicians. We make a point of getting along younger politicians who are obviously rising, to bring them together with financiers and industrialists who offer them wise words. It increases the chance of having a sensible global policy...”

So, there is no question that globalists want their Utopia of global government totally, yet it has been called globalization or global governance.

The Bilderberg Rick Perry may run for President in 2012. He could be a front runner in the Presidential race for the Republicans. He may challenge President Barack Obama for his Presidential spot. Perry is a shady character using social conservative views as a tool to get votes obviously. His associates said that he will test the prospects in the early caucus and primary states of Iowa, New Hampshire, Nevada, and South Carolina. The Texas Governor of Rick Perry is a protégé of Karl Rove. Perry is good as claiming to be a populist, but he is similar to George W. Bush. He talks about Tea Party rhetoric and speaks of secession, shooting coyotes, and tries to get support from Christian evangelicals. Covertly, Perry sold out Texas to foreign companies via its highways to foreign companies. Perry for a longtime has been a supporter of the NAFTA Superhighway and related infrastructure projects according to AFP's Jim Tucker. The Bilderberg Group members support globalization in America indeed. The North American integration agenda is about globalization seeing an unified North American continent economically and politically. He agreed with Mexican President Vicente Fox's efforts to make Texas a sanctuary state for illegal immigrants. Many sincere people agree and disagree with

this policy. He supported the Rockefeller foundation supported HPV vaccination campaign in Texas. Now, we know that HPV vaccinations have caused deaths worldwide. Rick Perry attended the Bilderberg group meeting in Istanbul, Turkey. This violated the Logan Act. The Logan Act is a real US. federal law. It forbids unauthorized citizens from negotiating with foreign governments. His actions are that of a globalist that is opposite of the Tea Party populist motif or any lover of freedom. The globalists love Perry since he can use rhetoric to galvanize people while stab them in the back. The Bilderbergers have been influential in grooming leaders. One example is that Bill Clinton was a little known Governor of Arkansas before he attended a Bilderberg meeting in 1991. He became elected President a year later. . Similarly, British Prime Minister Tony Blair attended Bilderberg before his election in 1997. According to Euro Weekly News, Maria Dolores De Cospedal's attendance at Bilderberg 2011 in St. Moritz Switzerland also "augurs a victory in Spain's next general election" for her Partido Popular party. Even Barack Obama had a secret meeting with Hillary Clinton in June of 2008 in Northern Virginia. This was in the time that the Bilderberg meeting was taking place in Chantilly, Virginia. James A. Johnson chose Joe Biden as the running mate to Barack Obama. Johnson is a Bilderberger. John Edwards made a speech in the Bilderberg meeting in Italy of 2004 since he impressed Henry Kissinger and David Rockefeller. The Bilderberg Group influence and house U.S. Presidents, potential vice Presidents, and other puppets (who are under the multi-generational globalists, central banking moguls, and CEO's of the world strongest corporations. These people attend the Bilderberg Group's conference each year).



Le Cercle and the Eurasian agenda of Brzezinski are akin. Other such Le Cercle people are Freeman, Amirahmadi, Japaridze, Shackley, and Spencer. Brzezinski wrote his 1997 book entitled, "The Grand Chessboards: American Primacy and Its Geostrategic Imperatives." Zbigniew Brzezinski wanted the book to promote the West to control the Middle space or Eurasia. This is a long term goal of groups like Le Cercle. Other such members include David Rockefeller, Henry Kissinger, and former Cercle chairman Brian Crozier. Some have accused Soros' Open Society, the Eurasia Society, and Albright's National Democratic Institute of

running the Ukrainian Orange Revolution in late 2004. This was promoted in order to push Russian influence further back east. Even in November of 2004, the National Democratic Institute and George Soros were accused of doing the same revolutionary promotion in Georgia including in 2010 at Kyrgyzstan. So, it seems that in the war on terror, Brzezinski and his Le Cercle allies are using his Grand chessboard strategy. This strategy wants the West, especially America, to control Eurasia since it accounts for 60 percent of the world's GNP and $\frac{3}{4}$ of the world's known energy resources according to Brzezinski. He wrote about the need for America to have positive relations with China, Japan, and even Iran in some degree to control Eurasian resources. Now, we live in the war on terror era. Even Le Cercle member Chas Freeman praised Mao, China's handling of the Tiananmen Square protests, and he criticized Taiwan. Brzezinski is of the Euro-Vatican faction of the globalists that seeks no major war with Iran, but wants a new world order using stealth (or by a gradual approach via playing both sides against each other, etc). While, the Anglo-neo-con faction of the new world order want to have globalization by conflict as soon as possible via force.

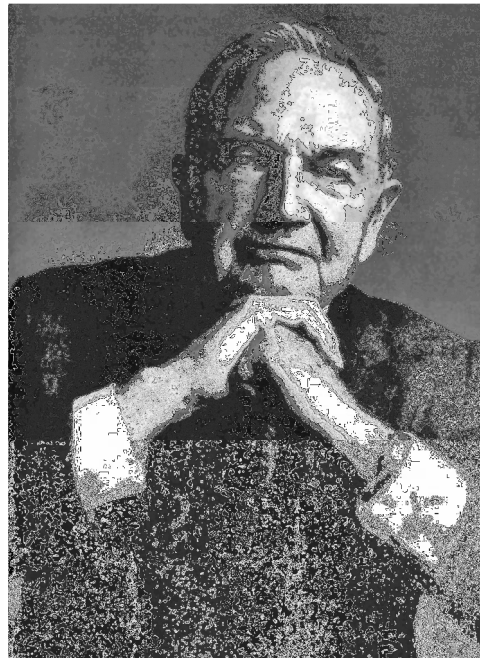
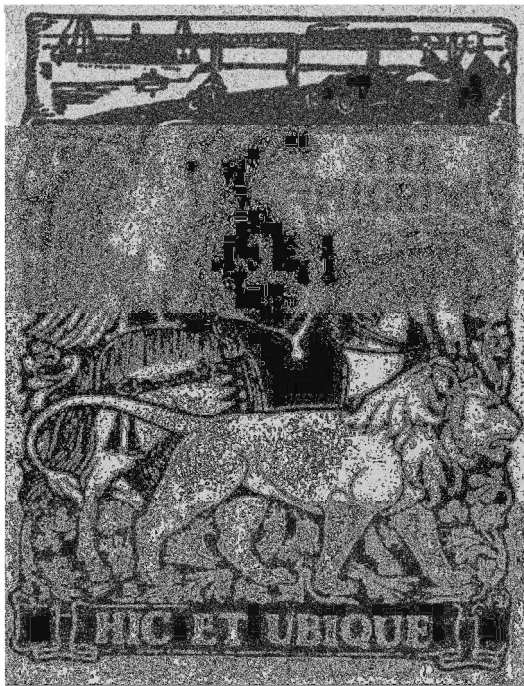

Buckley, Jr., CFR and Yale Skull and Bonesman alleged conservative, called the movement "Anarcho-Totalitarianism." Koch used money to fund the Cato Institute or the first American libertarian think tank back in 1977. The Koch Family funds the Rockefeller-aided Heritage Foundation. The Heritage foundation is linked the Sun Myung Moon. David Koch is on the board of Trustees of the Rockefeller University and he's a part of the New Age globalist Aspen Institute. Maurice Strong used to head the Aspen Institute. He supports the Agenda 21 movement and believes in environmental sustainability. David Koch believes in embryonic stem cell research. CFR members were in the CNP originally like its early members. Nelson Bunker Hunt was in the CNP and the JBS. Some eugenicists, the Knights of Malta, and others are in the CNP's highest ranking members. Some of them promote the cultic Dominionist/Reconstructionist movement. Oil baron and CNP member Nelson Bunker Hunt was a former member of the racist pro-eugenics group called the International Association for the Advancement of Ethnology and Eugenics. The group was heavily involved in the promotion of eugenics and segregation. So, it's that much of the Tea Party has been infiltrated by the elite. We have the right to expose the truth and be real. Some regulation is fine and some isn't. Some forms of taxation are fine and some aren't. Just because the government may intervene in a certain circumstance, doesn't mean that this is a representation of Communism or socialism at all.

The stock market experienced a roller coaster wide of ups and downs by hundreds of points. This drop was the highest in August 8, 2011 when the Dow fell by 624 points. The U.S. Treasury bonds in that time was downgraded from AAA to AA+ by Standard and Poor's. The roller coaster ride in the stock market began in Monday in August 2, 2011. This time was the day after the last minute U.S. debt ceiling deal. This deal was supposed to stop any downgrade of credit, but it occurred anyway 5 days later. This volatility is strange and unprecedented. There have been daily reversals of stock levels that people question why it's occurring in the first place. The plunge in 1/8/2011 was the 6 largest stock market crash ever and the worst since 2008. This could be similar to the fear that swept financial markets after the collapse of U.S. investment bank Lehman Brothers in September 2008. The banks stopped lending each other money. The banks' cash deposits at the central bank doubled within days. There is the changing of the market. Some researchers have questioned the validity of the downgrade that could be another Lehman brothers. Dean Baker is the co-director of the Center for Economic and Policy Research. He said that the S&P's decision was at first based on a 2 trillion dollar error in accounting. This error was later corrected and still the S&P continued with the downgrade, which was strange despite the evidence. Even Paul Krugman from the NY Times is skeptical about the downgrade. He wrote that the S and P speculated on the \$4 trillion as the agreed deficit reduction in over a decade. To him, an extra trillion in debt adds only a fraction of a percent of GDP to future interests' costs. He believes that the S&P is making up their claims on the financial people like they didn't getting the mortgage debacle right. Jane Hamsher believes that the S&P has a political agenda to promote the view that America is at risk of default on its debt based on the arbitrary limit to debt to GDP ratio. Jane wrote that: "...There is no sound basis for that limit, or for S&P's insistence on at least a \$4 trillion down payment on debt reduction, any more than there is for the crackpot notion that a non-crazy US can be forced to default on its debt...It's time the media and Congress started asking Standard and Poors what their political agenda is and whom it serves..." According to Jason Schwarz, there is word that S&P CEO Deven Sharma took control of the ratings agency and personally pushed for an U.S. downgrade. He went ahead with the unethical downgrade even when the S&P debt calculations were off by 2 trillion dollars. He is the person that was a key contributor the 2009 Bilderberger summer. Many people in the Bilderberg Group want to end the dollar as the global reserve currency. Even in his own writings, S&P CEO Sharma considers America a problem in today's world. He wants globalization and America to be torn asunder. Schwarz called Michel Barnier (or the head of the European Regulation) as a suspect in the market manipulations. Barnier triggered an alarming 513-point drop in the Dow on August 4, when he blocked the plan of Hans Hoogervorst, newly appointed Chairman of the International Accounting Standards Board, to save Europe by adopting a new rule called IFRS 9. The rule would have eliminated mark-to-market accounting of sovereign debt from European bank balance sheets. The banning of the mark to market system has caused economic recovery. Barnier went into Bilderberg conferences. Daniel Estulin (or a Bilderberg researcher) believes that this Bilderberg group wants to bring together financial institutions which are most powerful ones on Earth. He said that the Bilderbergers use financial power, develop acquisitions, and mergers in order to make one centralized financial order in the world (that's privately owned). Nation states are submerged in this international, private banking system. George Ball back in the 1968 Bilderberg meeting in Canada said that: "...Where does one find a legitimate base for the power of corporate management to make decisions that can profoundly affect the economic life of nations to whose governments they have only limited responsibility?" This is why the elite oppose productive, non-inflationary credit created by the state as found in the U.S. Constitution. The elite acquiring assets have prevented the government from issuing their own currencies plus credit. Money that's loaned instead of being created causes debts to grow. The European Central Bank tried to save the Eurozone from collapse by buying up Spanish and Italian bonds (as high as 32 billion dollars worth of bonds). Even the Securities Exchange Commission said on August 8 that they are investigating the downgrade (to see if insider

trading came about). Some speculate if FED Chairman Bernanke will promote another round of quantitative easing or QE3. This market action does deserve investigation indeed.

Updates for the Pilgrim Society in 2011, Etc.

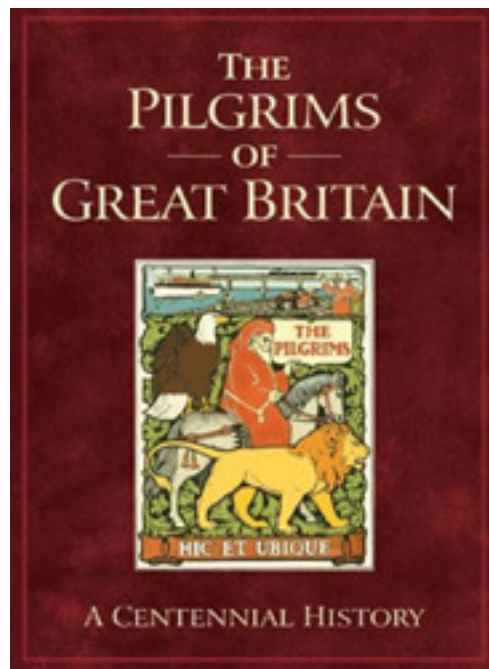

This has been confirmed by Charles Savoie in his research as well. **Charles Savoie (he, Fritz Springmeier and Joël van der Reijden were among the first people to expose the Pilgrim Society in a high level among independent researchers. 20 Years ago, very few people even knew about the Pilgrim Society)** is right that we shouldn't allow the establishment to radically deplete our silver reserve in America at all. Charles is correct that human beings have the right to own precious metals and someone shouldn't immorally steal these items from any human being. Historically, the international bankers have had a strong prejudice against silver or any independent economic policies that would benefit the common man. Yet, Charles needs to know that legitimate social programs to help the poor and others suffering in society is neither a sin nor a vice period. For example, the Great Depression was so horrid in its composition that stock speculation had to be curtailed, construction projects for the unemployed had to exist, child labor has to be abolished, homeless people had to be supported, the elderly had to get real services to prevent them from literally dying, and a minimum wage created wasn't evil.

The Black Nobility bloodlines and the Crown never gave up their goals of controlling us in Americans and nations in the world. The Pilgrims were created in 1902 as a means to covertly used political and economic means to unite Brittan and America into a way to establish the new world Empire. Cecil Rhodes proposed covert control over America. Rhodes in his own words:

“...“What an awful thought it is that if we had not lost America, or if even now we could arrange with the present members of the United States Assembly and our House of Commons, the peace of the world is secured for all eternity. We could hold federal parliament five years at Washington and five at London. The only thing feasible to carry this idea out is **A SECRET ONE (SOCIETY) GRADUALLY ABSORBING THE WEALTH OF THE WORLD TO BE DEVOTED TO SUCH AN OBJECT.** There is Hirsch

with twenty millions, very soon to cross the unknown border, and struggling in the dark to know what to do with his money; and so one might go on ad infinitum.” (“Cecil John Rhodes,” *The American Monthly Review of Reviews*, New York, May 1902, pages 556-557)

One founder of the Pilgrim Society of America in 1903 was banker and financier Morris K. Jesup. He headed the New York Chamber of Commerce at the time. The Chamber opposed silver money. The Pilgrim Society evolved from the Rhodes Scholar. Rhodes Scholar came from the Freemason and Jesuit-influenced Cecil Rhodes. He was funded by the Rothschilds and the Crown in South African diamond cartelization. This cartelization leads to the De Beers conglomerate. It was the Pilgrim Society member Vanderlip that was in the Jekyll Island, Georgia meeting that the Morgan-Rockefeller (or Pilgrim Society network) interests that developed the plans for the Federal Reserve System in the first place. Clarence Douglas Dillon was the son of Clarence Dillon. Clarence Douglas Dillon was a Pilgrim Society member like his father. Dillon handled more money than J.P. Morgan did in his career according to pg. 187 as found in “*The Mirrors of Wall Street*” from 1933 as published by Putnam’s Sons. Dillon once chaired the Rockefeller Foundation. He ruled over the recall of 90% of silver coinage to be sent into Treasury Department vaults to be melted and donated to his friends in the Silver User Association. This association is represented by Pilgrim members like Leland Ira Doan of Dow Chemical, Birny Mason Jr. of Union Carbide, Philip D. Reed and Walter Hoving of Tiffany & Company, and others. A certain percentage of CFR members and executives are Pilgrims.



Tobie Roosevelt was a Pilgrim Society member. She passed away in 1988. She was the widow of Franklin Roosevelt Jr. She headed the Gibraltar American Council (a British front) and ran with the Duke of York plus Prince Andrews. Both the Duke of York and Prince Andrews are Pilgrims and Royal Family members. Another powerful Pilgrim in our age is Weatherstone. He was knight by Queen Elizabeth II or the Royal Patron of the Pilgrim Society. Sir Dennis Weatherstone from 1995 to 2001 was on the board of the Banking supervision of the gold price depression the Bank of England. Pilgrims have infiltrated the religious world too. The Pilgrim Bishop Henry C. Potter was the bishop of New York from 1887 and 1908. He was one of the primary founders of the Pilgrims in America. Historically, Canterbury Cathedral in London and the Cathedral Church of St. John the Divine in New York has been both staffed by Pilgrim Society members. The Episcopal Church and some Presbyterians have Pilgrims (even though real Presbyterian Christians have existed in history before). Catholics have been in the Pilgrims as well like the Knights of Malta Myron C. Taylor, Joseph Kennedy, Dean Rusk, Elmer Bobst, J. Peter Grace, Alexander Haig, Lord Lothian, and Lord Mowbray. The Catholic family in England (or the Dukes of Norfolk) had been representatives to the Vatican and this family has been occasional visitors of the Pilgrim gatherings. Diplomatically, the Vatican and the Anglo-American establishment worked together in order to focus on the same goal (globalization and the new world order). One huge globalist and the long time associate of David Rockefeller today is John C. Whitehead (he's the Director of Rockefeller University). The late Eagleburger (who passed away recently) was in 1965 a special assistant to Pilgrim Society member Dean Acheson. Acheson was the Secretary of State in 1949 to 1953. Some folks believed that he was involved in starting up the Korean War. Of course, Acheson was a Scroll and Key member from Yale. Acheson wrote "Present At The Creation" (1969), a reference to the creation of NATO (North Atlantic Treaty Organization). On page 510 Acheson said---"I performed the duty of every Secretary of State by addressing a gala and distinguished company of the London branch of the Society of Pilgrims." So, many American heads of state consort with the British redcoats elites in London. Eagleburger was in the National Security Council back in 1966 and was an assistant to Henry Kissinger in 1968. Eagleburger was decorated a Knight of the British Empire in 1994 by Queen Elizabeth II.

The Prussian monarchy was created in 1701. King Frederick I was its first king. The rulers of many German states before that time were call electors. He called himself a king in Prussia. Pope Benedict XIV (1740-1758) was the first Pope to recognize the title of King of Prussia and the title was recognized officially by all the other nations in 1772. The Jesuits infiltrated Prussia for centuries. Sophia of Hanover was the consort of the King of Prussia from 1701 to 1705. One successor of the throne was Frederick William. In 1714, Sophia Charlotte of Hanover's eldest brother (or George Lewis) would succeed the throne of Great Britain as King George I. King Frederick William was the father of Frederick II (or Frederick the Great). Frederick William used eugenics philosophies (long before Galton and Sanger) to birth a group of giants as his regiment. These people were called the Potsdam Grenadiers. Hitler believed in a super race centuries later. Hitler is wrong since there is no such thing as a superior race. Later, Frederick the Great want to

revive the German Empire. King Frederick from 1740-1748 wanted to control Austria since he felt that the young Empress Maria Theresa was lacking political experience. Most of the nations of Europe took the side of the Young Queen and Prussia won war or the Austrian Succession with difficulty. It spread into colonial areas and thousands of people died from the war. After 8 years of bitter conflict, a truce was finally signed in 1748. Under the Treaty of Aix-la-Chapelle, Prussia was allowed to hold on to the conquered territory of Silesia. Empress Maria Theresa was still determined to get back Silesia and this led to the second worldwide conflict called the Seven Years' War. The Seven Years' War spread into America as the French-Indian War. The conflict ended with the signing of the Treaty of Paris in 1763. Prussia was allowed to hold Silesia. France was ejected from the New World and the Louisiana Territory handed over to Spain.



This conflict set the stage for the American Revolution because the British colonists were forbidden to settle west of the Allegheny Mountains. Soon, the Jesuits were banned by the Pope (since the Jesuits were involved in conflicts in Europe via wars, assassinations, and other conflicts). Pope Clement XIV banned them “permanently and perpetually.” This was his Bull of Suppression that extended into Austria, France, Spain, Portugal, and Italy. The Pope died in mysterious circumstances. We have a very good idea on the party who killed him. Ironically, the so-called Protestant Frederick housed the Jesuits after they were expelled from European nations (including Catherine II of Russia). Many European leaders want to revive the unholy Roman Empire from Charlemagne onward to even now with the European Union. Even Hitler wanted Germania to be a world capital. Pepin of France gave the Pope the Papal States in 755, his son Charlemagne was crowned by the Pope as the unholy Roman Emperor back in December 25, 800. This was the First Reich. The 2nd Reich came from 1871 to 1918, which was a more tolerable era. Bismarck did do some actions that were right. Bismarck and the Reichstag back then opposed the Jesuits and emancipated 550,000 German

Jewish people in 1871. These were righteous actions. Emancipation in this instance means giving folks voting rights basically. So, Prussia did have a strong Protestant heritage that fought back against Papal influences. Kaiser Wilhelm opposed the Boer War. The Boer war was about British imperialists killing innocent Protestant South African Boers. Deaths came about in the conflict. Concentration camps were used against the Boers by wicked imperialists. The men involved in these massacres were British, Jesuit-inspired Masons like Cecil Rhodes, Alfred Milner, and the Prince of Wales (who would later be King Edward VII). The Roundtable types stole the gold in Transvaal and this money was used to fund acts in the 20th century as beyond. Kaiser Wilhelm opposed the Boer War. The Third Reich (heavily headed by the Roman Catholics Hitler, Himmler, Mueller, Thyssen, etc.) of course was the Hitler dictatorship from 1933 to 1945.



In the past, very few human beings knew about the Pilgrim Society. People knew more about the CFR in the 1960's than the Pilgrim Society. The Pilgrims have had influenced in the Presidency since the times of Theodore Roosevelt. One famous Pilgrim was William Sterlin Odgen of Chase Manhattan bank. He was the director of the silver user GAF Corporation, he founded the Institute of International Finance in D.C. during 1984 (it calls itself the global association of financial institutions). The members in the Institute were strongly opposed to a precious metals monetary system. The exposure of the Pilgrim Society is here and it's found in other places in the world as well. David Rockefeller has been even less humble (but perhaps more honest) in his assertion of his family's and his own personal role in shaping the world. In his 2002 book, *Memoirs*, David Rockefeller wrote:

“...For more than a century ideological extremists at either end of the political spectrum have seized upon well-publicized incidents such as my

encounter with Castro to attack the Rockefeller family for the inordinate influence they claim we wield over American political and economic institutions. Some even believe we are part of a secret cabal working against the best interests of the United States, characterizing my family and me as 'internationalists' and of conspiring **with others around the world to build a more integrated global political and economic structure--one world, if you will. If that's the charge, I stand guilty, and I am proud of it...**"

On the event of David Rockefeller's 90th birthday, James Wolfensohn, speaking at the Council on Foreign Relations, stated:

"...[T]he person who had perhaps the greatest influence on my life professionally in this country, and I'm very happy to say personally there afterwards, is David Rockefeller, who first met me at the Harvard Business School in 1957 or '58... [At the beginning of the 20th century] as we looked at the world, a family, the Rockefeller family, decided that the issues were not just national for the United States, were not just related to the rich countries. And where, extraordinarily and amazingly, David's grandfather set up the Rockefeller Foundation, the purpose of which was to take a global view.

... So the Rockefeller family, in this last 100 years, has contributed in a way that is quite extraordinary to the development in that period and has given ample focus to the issues of development with which I have been associated. In fact, it's fair to say that there has been no other single family influence greater than the Rockefeller's in the whole issue of globalization and in the whole issue of addressing the questions which, in some ways, are still before us today. And for that David, we're deeply grateful to you and for your own contribution in carrying these forward in the way that you did..." (James D. Wolfensohn, Council on Foreign Relations Special Symposium in honor of David Rockefeller's 90th Birthday, The Council on Foreign Relations, 23 May 2005)

*The Le Cercle group wants to struggle to have influence in the Eurasian continent or region of the world. Le Cerle's meetings are very mysterious. Some allies of Le Cerle are Saudi oil man Chas W. Freeman, Jr. former Georgian national security chief Tedo Japridze, CIA officer Theodore Shackley, and American-Iranian Council founding President Dr. Hooshang Amirahmadi. The Le Cercle has been nicknamed the Atlantic Circle. Tax filings show that Cercle meeting occur one or twice a year, mostly at the Watergate Hotel in D.C. According to Fritz Springmeier, Lord Carrington is one of the most powerful men on Earth. Pilgrim Society member John M. Wallace was the head of Chase National Bank's London offices, while also vice President of Equitable Trust Company. The Pilgrims tend to support the U.N., NATO, the neoliberal World Bank, the IMF, the OECD, and the Atlantic Institute of International Affairs.



The Bilderberg Group in 2012 and Beyond

The Bilderberger Group meeting in 2012 is having more media coverage. Ironically, the mainstream media is nowhere in sight in reporting this very important news story. The Bilderberg Group has representatives of many of the major corporate & media organizations in the world there. They are having a meeting in a hotel in Chantilly, Virginia, but the mainstream media isn't reporting on one of the most important stories going on in

the world today. So, the Bilderberg has a huge relevance in our day and age. The Bilderberger policy debate will occur by many technological giants. Their names include the following people:

Eric Schmidt, Executive Chairman of Google

Craig J. Mundie, Chief Research and Strategy Officer at Microsoft Corporation, and

Reid Hoffman, Co-founder and Executive Chairman of LinkedIn.

The Bilderberg Group and other organizations have their origin from the Nobility bloodlines in Europe. The Pilgrim Society members are in the leadership positions of the Bilderbergers. Chantilly, Virginia is the location where the elite will meet for their annual Bilderberg conclave. The Charles Scribner's Son publishing company carried a book called "The Thousand Year Conspiracy." This book believed that a Prusso-Teutonic clique wanted to rule the world using various nefarious means. Hitler's Nazi Empire according to Paul Winkler represented a part of this plan by the elite to take over the world. The truth is that many factions desire the Utopian vision of a new world order to span the entire globe. The Bilderberger Group (in 2013 and Beyond)

The Bilderberg Group meeting in 2013 came about. **For record, I disagree strong with the new North Carolina Voter ID Law and I disagree with stop and frisk over inside of New York City (the recent judge's decision as it relates to stop and frisk is a historic step in the right direction). We know the place where it was held. The Observer said that the dates of the conference are from June 8-9, but it is expected for the attendees will leave on the morning of the 9th as routine. In 2010, former NATO Secretary-General and Bilderberg member Willy Claes admitted that the attendees are mandated to implement decisions that are formulated during the annual conference of power brokers. In 2009, Bilderberg chairman Étienne Davignon even bragged about how the Euro single currency was the brainchild of the Bilderberg Group. In February of 2013, the Italian lawyer Alfonso Luigi Marra requested that the Public Prosecutor of Rome investigate the Bilderberg Group for criminal activity. He wanted to question the elitist organization's 2011 meeting in Switzerland led to the selection of Mario Monti as Prime Minister of Italy. Even as recently as a few months ago, Honorary President of the Supreme Court of Italy and former Senior Investigative Judge Ferdinando Imposimato accused the Bilderberg Group of being behind terrorist attacks in Europe.

Hundreds of thousands of human beings came to the Watford as a means to protest the Bilderberg Group meeting. The Bilderberg should be exposed for what it is. There is Google's annual Zeitgeist conference. This conference has been based at the Grove since 2007. It comes days before the Bilderberg Group meeting. Google is shown as a way for the elite to control the global political and technological landscape. Paul Joseph Watson said that hotel managers and others in the Grove told him that this is Google's agenda. The London Independent describes the centers around Google Zeitgeist as a cuddlier version of the Bilderberg. Numerous activities reveal about them.

Now, the Bilderberg Group want to use Google to present themselves as liberal, feel good, and advancing philanthropic actions. There are the forums of Google Zeitgeist and TED. We know that some in the Arab Spring used Google as a means to be involved in the Arab Spring. In Tunisia and Egypt, some of them or members of the Arab Spring attended the Zeitgeist conference at the Grove. Google employee Wael Ghonim used the social media services as a means to be involved in the revolution of Egypt. **Some folks in the Arab Spring were real. Others were backed by Westerners as a means to allow the Muslim Brotherhood to rule Egypt under the guise of color revolutions. Google influences American and British governments. Eric Schmidt was a campaign advisor and a major donor to Barack Obama's Presidential campaigns. Eric was offered reportedly the post of Treasury Secretary within the Obama administration.** In the UK, Google representatives met no less than 23 times with the Conservative Party officials since the general election of 2010. David Cameron addressed the inaugural 2006 Zeitgeist conference before going on to become Prime Minister four years later. British Chancellor George Osborne paid a visit to Zeitgeist just weeks before he also attended Bilderberg 2011 in St. Moritz, Switzerland. **The Zeitgeist meeting and the Bilderberg meetings have merged their ties. The London Telegraph compared the power of the Google confab to the World Economic Forum in Davos. Each meeting has folks of global significance to talk and network.** The Bilderberg Group groomed ex-U.S. President Bill Clinton. Clinton has given speeches at Zeitgeist including his fellow Bilderberg attendee Prince Charles. Another Telegraph report called Zeitgeist as, "one of the most high-powered gatherings of business leaders, thinkers and those that are considered to generally shape the global future." Google databases are known to track cars and various forms of communications globally. Google Glass can track human beings as well. The Grove Hotel during WW2 was a secret wartime HQ for London, Midland, and Scottish Railway. It was named Project X. **Eric Schmidt said that he wants Google to answer questions, and know where human beings are. He said that: "...We know everything you're doing and the government can track you." "We will know your position down to the foot and down to the inch over time...Your car will drive itself, it's a bug that cars were invented before computers...you're never lonely...you're never bored...you're never out of ideas."** In numerous speeches, including those made at Google Zeitgeist, Schmidt has outlined his vision for a collectivist, permanently networked world in which individuality and privacy are ostracized and those who refuse to sign up to the new religion of transhumanism are shunned as sub-human savages. Many Bilderberg members share that vision of Google's Eric Schmidt. A source says that the 4 or 5 big conferences of Google will happen at the Grove in May, June, and July. The Google Zeitgeist will come in the 227 room hotel. Some will get in London hotels, because of the large guests and administrative staff. According to various sources, the Bilderberg 2013 meeting will deal with Iran's nuclear program, the Syrian war, the threat of a global pandemic, ways to control the revolution of 3D printing, them losing control over information dissemination, smart cities to spy on human beings, ways to control what can be published on

the Internet, bailouts to build the euro, etc. The agenda of the Bilderberg Group is exemplified by the comments of Bilderberg member Henry Kissinger. Wikileaks found out the quotation from the luminary Kissinger. These players are particularly fond of the global conference circuit – from the annual bash at in Davos of the

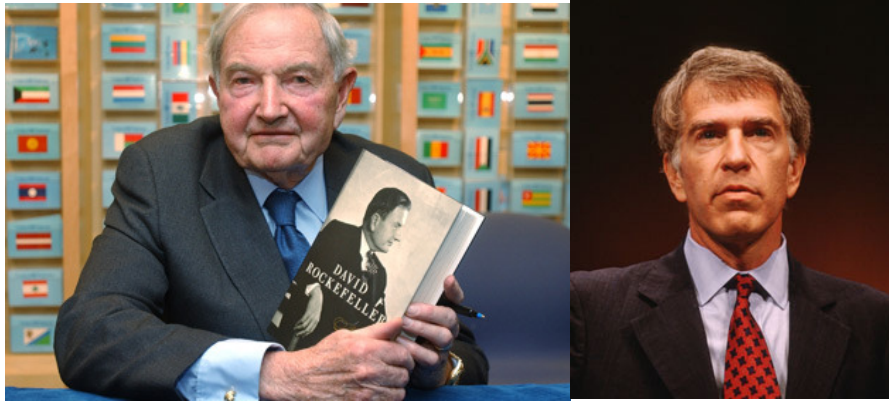

There are many major figures in the Bilderberg Group. The Bilderberg's Steering Committee has at least a dozen prominent Americans. David Rockefeller is a member of the Advisory Group. David Rockefeller attended the recent 2013 meeting. We know about David Rockefeller's agenda. He wanted a one world system by his own words in his Memoirs back many years ago. In her book "Web of Debt," Ellen Brown quoted economist/geopolitical analyst Hans Schicht saying: "What has been good for Rockefeller, has been a curse for the United States. Its citizens, government and country indebted to the hilt, enslaved to his banks." "The country's industrial force lost to overseas in consequence of strong dollar policies (pursued for bankers not the country)." Now, it seems that the elite are shifting their power base into younger human beings.

Roger Altman is a famous member of the Bilderbergers. Roger is a former Lehman Brothers partner. He left before its dissolution. He was Clinton's Deputy Treasury Secretary. He is a Bilderberg Steering Committee member. He is the founder and executive chairman of Evercore Partners. It's a prominent predatory investment banking advisory firm. It specializes in mergers, acquisition, divestitures, restructurings, financings and other strategic transactions. It operates the old-fashioned way. It recommends leveraged buyouts, asset-stripping targeted companies, and leaving thousands of employees high and dry on their own.

Bilderberger Jeff Bezos is Amazon's founder and CEO. Amazon is the world's largest online retailer. Earlier, he worked on Wall Street and for a New York based hedge fund. As of March 2013, Forbes estimated his net worth at \$25.2 billion.

Bilderberger Martin Feldstein is a Harvard University Professor of Economics. From 1982 to 1984, he was Reagan's Council of Economic Advisors chairman and chief economic advisor. He was the National Bureau of Economic Research (NBER) President emeritus. It is an elitist organization. Many of its members have been conservative Nobel economics laureates. Others served as White House chairmen of the Council of Economic Advisors. It ignores the protracted Main Street Depression, but it claims to announce when recessions begin to end. In 2006, Feldstein was on Bush's Intelligence Advisory Board. In 2009, he served Obama in a similar capacity. Martin is also affiliated with the following groups of the

Council on Foreign Relations, Trilateral Commission, and American Enterprise Group among others. He has been a board member of several major corporations.



The controversial Timothy Geithner is a member of the Bilderbergers as well.

Neo-con Robert Zoellick is a prominent neocon. He was a Project for a New American Century member. He advocated post-9/11 wars. He is a member of the Bilderberg Group as well. Paul Wolfowitz succeeded Wolfensohn as World Bank president. Zoellick succeeded him. He served from 2007 to 2012. He formerly was a Goldman Sachs managing director, as well as Deputy Secretary of State and US Trade Representative under GW Bush. Under Reagan, he held various Treasury positions. He was Counselor to James Baker, Executive Secretary of the Department, and Deputy Assistant Secretary for Financial Institutions Policy. He was GHW Bush's Under Secretary of State for Economic and Agricultural Affairs. He also served as Department Counselor. In 1991 and 1992, he was Bush's G7 summit representative. He 1992, he served as White House deputy chief of staff. From 1993 – 1997, he was Fannie Mae executive vice president. He bears much responsibility for helping to inflate the housing bubble.

Bilderberger James Wolfensohn was once World Bank President. He is a Bilderberger. The World Bank harms nations financially under the guise of structural adjustment harshness. The World Bank prioritizes privatization of state enterprises, mass layoffs, deregulation, deep social spending cuts, wage freezes or cuts, corporate-friendly tax cuts, unrestricted Western corporate market access, trade unionism crushed or marginalized, and stiff repression targeting non-believers. In 2005, Wolfensohn founded Wolfensohn & Company. It's a global emerging markets private equity firm. It advises governments and large corporations doing business in emerging market economies. Since 2006, Wolfensohn's also been Citigroup International Advisory Board chairman. In 2009, he became a China Investment Corporation International Advisory Council member. In October 2010, he regained his Australian citizenship.

Other notable Bilderberg attendees include IMF head Christine Lagarde, European President Jose Manuel Barroso, former appointed Italian Prime Minister Mario (three-card) Monti, Britain's Chancellor of the Exchequer George Osborne, Goldman Sachs International chairman Peter Sutherland, as well as numerous other politicians, corporate bosses, investment firm heads, journalist insiders and others.



A Recap of the Federal Reserve

Folks know all about the Federal Reserve. Human beings from across the political spectrum have exposed the errors from the Federal Reserve. I would continue to clarify that I oppose the Federal Reserve completely and I want alternatives to occur as a means to grow our economy systems in the world. We know that the Federal Reserve has been involved in many controversial actions since its inception. It is no secret that corporate interests and the Pilgrim Society (with folks like Paul Warburg, Senator Nelson Aldrich, Henry P. Davidson, Benjamin Strong, and Franklin Vanderlip) influenced the development of the Federal Reserve. Massive industrial consolidation by a few oligarchic elites was the rule of the day, as J.P. Morgan expanded total control over railroad and banking interests, and John D. Rockefeller took control of the oil market, and expanded into banking (in the late 19th century and to the early 20th century). At the end of November 1910, Senator Nelson W. Aldrich and Assistant Secretary of the U.S. Treasury Department A. Piatt Andrew, and five of the country's leading financiers (Frank Vanderlip, Henry P. Davison, Charles D. Norton, Benjamin Strong, and Paul Warburg) arrived at the Jekyll Island Club to discuss monetary policy and the banking system, an event that led to the creation of the current, privately owned Federal Reserve. This nefarious meeting without massive public input at all has been documented in many books from Bill Still's research, to the Creature from Jekyll Island book made by E. Edward Griffin.

The Federal Reserve Act formed the modern Federal Reserve in December of 1913. The FED is the modern central banking system in the United States. It can handle interest rates, certain prices, and other functions of the economy. It is made up of the Board of Governors, the Federal Open Market Committee, 12 regional Federal Reserve Bank, etc. found in various cities of America. It acts as a central banking entity. According to the Board of Governors, the Federal Reserve System "...is considered an independent central bank because its monetary policy decisions do not have to be approved by the President or anyone else in the executive or

legislative branches of government, it does not receive funding appropriated by the Congress, and the terms of the members of the Board of Governors span multiple presidential and congressional terms..." This is from the horse's mouth. The [U.S. Supreme Court ruled](#) in 1928: "...Instrumentalities like the national banks or the Federal Reserve banks, in which there are private interests, are not departments of the government. They are private corporations in which the government has an interest..." So, the Federal Reserve readily serve the interests of private interests and not the people totally, especially the poor. The long-time Chairman of the House Banking and Currency Committee (Charles McFadden) said on June 10, 1932: "...Some people think that the Federal Reserve Banks are United States Government institutions. They are private monopolies" The Fed itself [admitted](#) (via Bloomberg): "...While the Fed's Washington-based Board of Governors is a federal agency subject to the Freedom of Information Act and other government rules, the New York Fed and other regional banks maintain they are separate institutions, owned by their member banks, and not subject to federal restrictions..." For that reason, the New York Fed alleged in the lawsuit brought by Bloomberg to force the Fed to reveal some information about its loans – [Bloomberg LP v. Board of Governors of the Federal Reserve System](#), 08-CV-9595, U.S. District Court, Southern District of New York (Manhattan) – that it was not subject to Federal Freedom of Information Act. That is why the senior counsel of the Federal Reserve admitted in a court hearing in the Bloomberg lawsuit that the FED banks are independent corporations and not agencies. So, select private interests control the FED. Even the Bank of International Settlements or the BIS is owned by 55 central banks. Private Banks own the FED and other central banks own the BIS. The FED having excess reserves and the fractional banking system are some of the many errors of the Federal Reserve.

The Federal Reserve has even bailed out foreign banks, which is immoral and disgraceful to say the least when we still have record poverty in the world. The Federal Reserve has shown policies as a means to benefit the corporate not the interest of the rest of the people. A 2010 Fed audit also revealed that [of the \\$1.25 trillion of mortgage-backed securities the central bank purchased after the housing bubble popped](#), some \$442.7 billion - more than 35% - were bought from foreign banks. If central banks have cause huge errors and Wall Street still have record profits, then what are the alternatives? There are many. There is the cooperative commonwealth movement that can decentralize power more to the communities of America. Some have advanced state banks or decentralize banks (sending debt free money to the populace. Debt free money is one alternative to fractional banking) that can give great credit to the communities of American society more directly. The state bank of North Dakota has been highly successful in the world. There are the actions of a guaranteed annual income and other anti-poverty measures that can help humanity too. Some want Congress and the people (not the Federal Reserve) to have a more direct role in the economic system of America.

Inside of Detroit, the government still chooses the big banks over the American people once again. Ellen Brown have made mentioned of this reality as well. She writes about the derivative financial scheme acting like a risky casino. Congress has been manipulated by the masterminds of Wall Street to preserve it or derivatives at all costs. The government was wrong to excessively bailout out Wall Street mega banks, but the government refuses to bailout out Detroit in a hypocritical fashion. So, Detroit is set to pay an estimated \$250 million to terminate

a soured derivatives transaction from 2005. The banks' 25 percent hit is nothing compared with the city's suggested 90 percent cut to the pensions' unfunded liability — which will result in benefit cuts that would be disastrous in both human and political terms and that the State of Michigan must prevent from happening. There are still activists in Detroit trying to protect pensions, trying to protect municipalities from Wall Street, and trying to revoke the obscene privileges of banks that allow them to prosper on the failings of others. Numerous top independent economists and financial experts believe that we have to break up the big banks as a means to save the economy. Ellen Brown, Richard C. Cook, Stephen Zarlenga, Bill Still, and other economic populists want unique solutions to solve our economic ills. The government should not throw trillions at the big banks to artificially make them appear profitable. We have to choose to favor the interests of Main Street. The central banks' central bank — the Bank for International Settlements — [warned in 2008](#) that bailouts of the big banks would create sovereign debt crises, which could bankrupt nations. This is what is happening. Much of the bailout money has been used to subsidize the bonuses of corporations. A large percentage of the bailouts have gone into foreign banks. A huge portion of the money from quantitative easing came into foreign banks as well. The FED bailed out Gaddafi's Bank of Libya, hedge fund billionaires, and big companies, but not much of the common people in the States. We have a merge of state and corporate power. Economist Dean Baker says that the real purpose of bank rescue plans was "A massive redistribution of wealth to the bank shareholders and their top executives." The new threat of a stop and frisk program is being developed in Detroit. Emergency Manager Kevyn Orr is directing its establishment. According to the *Detroit News*, Orr has authorized the Detroit Police Department (DPD) to hire consultants from the Manhattan Institute for Policy Research, a right-wing think tank, and the Bratton Group, the law enforcement consulting firm, both based in New York, to reorganize the Detroit police and implement stop-and-frisk. The slashing of public services and the savaging of retired workers' conditions has harmed Detroit. The same program (of stop and frisk like policies) is being used in numerous cities across the country, based on the reactionary *Terry v. Ohio* ruling by the US Supreme Court in 1968 allowing wide latitude for the stopping and patting down of individuals on the basis of police "suspicion." So, we have fights in our time and we will continue to fight for racial justice, economic justice, and for human rights indeed.

The city of Detroit is still suffering. Wall Street has harmed Detroit too. There have been corporate interests that have caused the dissolution of Detroit. Also, there have been black bourgeoisie scapegoats following orders as well like Kevyn Orr. Detroit has been disenfranchised, because they power is heavily controlled by managers. There has been a recent unannounced cut off of electricity. This was done by Chief Compliance Officer Gary Brown. This happened in September 11th where many frightened human beings were stuck in elevators in 90 degree plus heat. One has been injured after the horrendous incident. He tried to justify the sick action via his sick words: "...We did start calling our customers prior to taking them down and asking them to turn off air conditioners, but they weren't responding as fast as we would like them to so we had to send them a strong message by turning the power off..." The oligarchy has arbitrary power in Detroit. We know that Judge Rhodes will decide if the imposition of an unelected dictatorship in Detroit represents a constitutional crisis or not. Brown follows the orders from EFM Kevyn Orr, who follows orders from Wall Street interests. Orr was a bankruptcy lawyer. Now, he is trying to strip Detroit of its assets and privatize its services for the benefit of Wall Street banks. The blackout in Detroit exposes its faulty infrastructure and it was an exercise of arbitrary power that allowed human rights to be further violated. The Judge will decide on whether Detroit should handle its own affairs. The threat of privatization is ever real in the world. We are still fighting for self-determination and real Power in the world. Brown resigned from his \$75,000 a year City Council position to sign on as Orr's lieutenant for [\\$225,000](#) — and, of course, an inside track in the corporate looting that will accompany Detroit's fiscal dissolution. Wall Street wants Detroit to suffer austerity and mega thefts of its resources. The

establishment hates Detroit as evident on the sick comment made by five time mayor Tom Menino saying that he will blow up Detroit and start over. If a person other him say similar comments in public about a mostly white city or mostly white area in America, he would be criticized by the media and even investigated by the DHS for possible terrorism charges. Yet, saying that garbage to Detroit (which is 85 percent black) is fair game to these elitist racists. Even the White House insults black Americans with the bootstraps line all of the time. Detroit needs democratic freedom from unelected bureaucrats. The confiscation of property is real there. "This [Emergency Financial Manager] law has been applied in cities and school districts where the majority population is African American, and I find this to be racist in both its aims, and its application," Bill Hickey, a 50-year resident of the city, told the judge. Indeed, more than half of Michigan's Black population has been disenfranchised, a shocking state of affairs that is generally treated as a non-event – or, maybe, in the popular consciousness, it is the world as it should be. It is a matter of the human rights of folks living in Detroit. Last November, a large majority of Detroiters and 53 percent of Michigan voters rejected the Emergency Manager legislation, but Republican governor Rick Snyder rammed it through the legislature, anyway. We know that a new survey says that 75 percent of Detroit residents do not want any cuts in public employee's pensions and 78 percent oppose selling any precious works at the Detroit Institute of Art. The bankruptcy was imposed on them by the powers that be. The reality is that we should be political independents. Republicans and Democrats have advanced austerity, imperialism, bigotry, anti-poor moves, and other moves against self-determination for over 100 years. We need to support the interests of the poor and all oppressed human beings of the world. The reactionary elitism among both parties has been wrong and immoral. Even the current White House executes some of the same policies as the Bush/Cheney regime from the war on terror to the Wall Street bailouts. The Bush tax cuts are extended. There was a shutdown of Senator Leahy's "Truth Finding Commission" that was designed to investigate Bush Cheney crimes. So, we know the truth. The truth is that political independence is what we need. We need to fight this class struggle, we need racial justice, we need economic justice, and we need social justice as well. We need to be comprehensive in our outlook and actions indeed.



It has been five years after the U.S. bank Lehman Brothers gave out years ago on September 15, 2008. This was the start of the growth of the global financial crisis. It allowed in motion a series of processes that brought to the surface the essential economic and political relations of world capitalism. The financial crisis has grown since the beginning of it. The measures of the governments and financial authorities like using ultra cheap money to finance speculation allowed the crisis to start in the first place. Since the events of 2008, some 8.8 million jobs were wiped out in America and \$19.6 trillion in household wealth was lost. The harshness of the crisis can be evaluated in the extent of the emergency facilities (provided by the US. Federal Reserve). Altogether some \$17.7 trillion was made available, with the top eight

borrowers, including Citigroup, Morgan Stanley and Merrill Lynch, receiving around \$11.5 trillion. This was not a liquidity crisis, but one of insolvency. The Federal Reserve rescued the major banks. They later used the program of quantitative easing. There has been much current round the clock money printing campaign in the realm of \$85 billion a month into financial markets (to fund the same speculation that led to the crisis of 2008). According to the Wall Street journal, total corporate bond debt has grown to nearly \$6 trillion, up by 57 percent since 2007. Junk bonds, which made up 17 percent of the corporate bonds sold in the US before the crash, now constitute 25 percent. The stock market grew into new heights. This is while the American economy is growing a little more than 2 percent, which is well below necessary to accommodate the growth of the labor force and ensuring the continuation of mass unemployment. In the UK and the Eurozone, the gross domestic product has not recovered to the level reached in 2007. There is the view that emerging markets can be able to decouple from the advanced economies and provide a new basis for global economic growth has been shattered. In fact, the economies now may cause a new financial meltdown. The cheap money that can into the economies and inflated a series of speculative bubbles is withdrawn as the FED begins to wind down its asset purchasing program.

When the crisis erupted, there were various claims that would necessarily lead to a reform of the banking system and the breakup of the financial giants that dominate it. Five years on, the American banking and financial system is more concentrated than before the crisis. The same is true of Europe, Britain, Australia, and other economies. Despite the criminal nature of the financial actions that contributed to the crash, not a single leading executive has been prosecuted let alone jailed. As U.S. Attorney General Eric Holder explained, the Obama administration refuses to prosecute the major banks or their top officials for fear of setting off a crisis with global consequences. The U.S. "recovery" heavily relates to the redistribution of wealth up the income scale. We know that between 2009 and 2012, during the so-called "recovery," total US income rose by 6 percent, with 95 percent going to the top 1 per cent. Real incomes for the majority of the population have fallen. The labour share of national income has fallen from 62 percent before the eruption of the financial crisis to around 59 percent today. With US gross domestic product at about \$15 trillion, this means that some \$450 billion has been gouged out of the working class to finance the further enrichment of the financial aristocracy. We see the truth since the crash of 2008 in the midst of wide social inequality. The financial and corporate elites want to harm and manipulate all of the social gains made by the working class including the rest of the people. We know that the counterrevolution has not ceased even after the end of the Reagan Revolution. The financial criminals and the imperialists use their influence to advance parasitism, criminality, and other evils. War is openly being used as a means to secure strategic political and economic objectives. That is criminal as the Nazis did this back in the day and they were tried in the Nuremberg trials. We know that war and social counterrevolution can never be executed in legitimate, peaceful method. They are done via police state methods, spying, and creating illegal laws. The ruling class readily provokes social upheavals as a means to harm revolutionary aspirations (and create reactionary policies). The ruling class wants the status quo not a radical ending of poverty. We see authoritarian rule in the world via slick, sophisticated means. We know that the cartel capitalism system has failed, which has resulted in war, dictatorship, and mass unemployment. We need revolutionary changes where solutions are created to benefit all of the people not just a select few.

The goal of the banking elite is clear. As Georgetown University history professor Carroll Quigley wrote:

"...[T]he powers of financial capitalism had another far-reaching aim, nothing less than to create a world system of financial control in private hands able to dominate the political system of each country and the economy of the world as a whole. This system was to be controlled in a feudalist fashion by the central banks of the world acting in concert, by secret agreements arrived at in frequent private meetings and conferences. The apex of the system was to be the Bank for International Settlements in Basle, Switzerland, a private bank owned and controlled by the world's central banks which were themselves private

corporations..." (Carroll Quigley, *Tragedy and Hope: A History of the World in Our Time*, New York: Macmillan Company, 1966, 324)

*Also, many Federal Reserve leaders have historically have been Bilderberg Group members.



A Summary of Important Political History

It is easy to see that the Democratic establishment has moved into more reactionary territory as time went on. Many Democrats from yesteryear would be called a radical today by the Tea Party types. Even FDR (despite his imperfections) said that he welcomed the hatred of the reactionaries. Head Start, food stamps, work/study, Medicare, and Medicaid came about because of the War on Poverty ethos from the 1960's. We see that members from both the Republicans and the Democrats have been hostile to a genuine, real social safety net system. Many Democrats presented themselves as the lesser of 2 evils when they have been the more effective evil in getting their agenda done in the 21st century. Now, both parties are pro-war. Paranoia about terrorism has been part of the nomenclature among political elites for over 10 years now. In fact, most of the United States' twentieth century wars were initiated by mostly Democrats not Republicans. Republicans initiated the war on terror in the 21st century though. The first significant presidential act of Roosevelt's successor, Harry Truman, was to order two atomic bombs dropped on the Japanese cities of Hiroshima and Nagasaki in August 1945, killing estimated 200,000 Japanese. Even Henry Wallace had to disagree with some of Truman's reactionary agenda in terms of foreign policies. Henry Wallace said the following words in December 29, 1947:

"...Peace and abundance mean so much to me that I have said at a dozen press conferences and in many speeches when asked about a third party, "if the Democratic party continues to be a party of war and depression, **I will see to it that the people have a chance to vote for peace and prosperity.**" To those who have come to me asking the conditions of my adherence to the present Democratic administration, I have said, "let the administration repudiate universal military training and rid itself of the Wall Street-military team that is leading us toward war. I have insisted that the Democratic administration curb the ever-growing power and profits and monopoly and take concrete steps to preserve the living standards of the American people. I have demanded that the

Democratic administration cease its attacks on the civil liberties of Americans. **In speeches in the North and in the South at non-segregated meetings I have stated the simple truth that segregation and discrimination of any kind or character have no place in America...**

Truman went on to launch the Korean War in 1950. As early as 1951, a Gallup poll showed 66 percent of Americans wanted U.S. troops to pull out of the Korean War. In 1952, 51 percent agreed that it was a "mistake" to intervene in Korea at all. There was no massive movement to oppose the War. Four million Korean civilians out of the Five million human beings died from the Korean War. Campaigning for election in 1964, Democratic candidate Lyndon B. Johnson pledged, "We are not about to send American boys 9,000 or 10,000 miles away from home to do what Asian boys ought to be doing for themselves..." As we know months later, Johnson escalated U.S. troop involvement in the Vietnam War. Even the AFL-CIO convention in 1965 supported the Johnson administration in using the military as a means to fight Vietnam. It was only in 1970 that AFL-CIO's vice President Walter Reuther said to Nixon that, "We must mobilize for peace rather than wider theaters of war." This came in the midst of a very strong anti-war movement and the continued bloodshed in the Vietnam War. When Bill Clinton was elected in 1992, it marked the modern shift of the Democratic Party into neoliberal status. Bill Clinton used the military to advance U.S. interests as he said that he would do. He intervened in Haiti. He allowed the U.S. support NATO in its war against Yugoslavia in 1999. NATO committed war crimes in Belgrade and other locations in that region of the world. He bombed Sudan and Afghanistan too. He bombed Iraq during his no fly zone exercises. Clinton supported cruel sanctions against Iraq where over million Iraqis died from 1991 to 2003. Even Clinton's Secretary of State Madeleine Albright told 60 Minutes journalist Leslie Stahl that the sanctions against even innocent Iraqis were worth it. The New Deal Coalition came in the 1930's since the Great Depression was harsh that revolutionary fervor was in the air. That is why Roosevelt made concessions by allowing once the Wagner Act or the National Labor Relations Act to come about. It made it illegal for employers to refuse to bargain with union. He passed the Social Security Act as it gave the poorest families and the elderly some standard of living. Much of the New Deal coalition included real folks and evil Dixiecrats too. So, the establishment allowed concessions to happen as a means to prevent real revolution (and concede that the worst aspects of capitalism harmed the poor). When the reactionary Richard Nixon was President in 1968, he had to deal with social activist movements of all kinds. Nixon hated the war on poverty programs, so he continued with his own policies. In the mid 1970's, the growth of neoliberalism came about. Neoliberalism allowed the business elite to use policies to lower the working class living standards, while increasing corporate profits (which leads into an increase of economic inequality). Real wages were falling in 1974 and more automation came about as predicted by the late Dr. Martin Luther King, Jr. The corporate tax rate fell from 1969 to 1981. Reagan cut heavily many social safety net programs like AFDC or the Aid to Families with Dependent Children.

Bill Clinton (an ally of the DLC) supported NAFTA, and wanted to end welfare as we know it. In 1994, he transformed AFDC into a temporary program requiring all able-bodied recipients to go to work after two years. In 1996, facing reelection, Clinton signed the Republican-sponsored Personal Responsibility and Work Opportunity Act, extinguishing the hallmark of the New Deal by relieving the government of any responsibility to care for the poor, limiting poor women and children to a five-year lifetime limit. Yet, he is called the golden Savior of all Creation by his adherents. So, Clinton had his reactionary side just the overt reactionary agenda of the Bush administration from 2001. The Clinton Anti-Terrorism and Effective Death Penalty Act made it more palatable for the more repressive Patriot Act to come about, which was passed after September 11, 2001. Any form of inequality from economic to social is always evil, justifiable, and morally repugnant period. So, history is filled with social changes. Today, neoliberal is still an ideological cancer plaguing both parties. We can see the drone attacks, the Simpson-Bowles agenda, and the NSA scandal to witness examples of that. So, it is our job to fight for justice and truth irrespective of times changing.



Updates on the Syrian Civil War in 2013

The United Nations is saying that the US backed opposition groups not the Syrian regime has used poisonous gas in Syria. There has been a series of interviews about this issue. UN investigator Carla del Ponte spoke in these multiple interviews. Carla del Ponte said that sarin gas used in Syria was fired by the U.S. backed opposition not the regime of President Bashar al-Assad. Her account explodes the lies on which Washington (and its European allies) have based their campaign for more military intervention in Syria. Some neo-cons in the United States and its allies want to attack Syria under certain circumstances. They use Assad's chemical weapons as a justification to get this goal accomplished. The rebels having sarin is ironic since these same rebels are armed by U.S.-allied Middle Eastern nations under CIA supervision. Del Ponte's statements relate to the events of the blatantly or flagrantly illegal Israeli air strikes on Syria. These airstrikes have been endorsed by President Obama. These recent events critically escalate the US-instigated and supported sectarian war for regime change in Syria. Some view these incidents as a prelude to a potential strikes on Iran. Del Ponte is a former Swiss attorney general who served on the Western backed international courts on Yugoslavia and Rwanda. Right now, she sits on an UN commission of inquiry on Syria. She gave an interview with Italian-Swiss broadcaster RSI on Sunday. She said the following words:

"...According to the testimonies we have gathered, the rebels have used chemical weapons, making use of sarin gas." She explained, "Our investigators have been in neighboring countries interviewing victims, doctors, and field hospitals, and, according to their report of last week which I have seen, there are strong, concrete suspicions but not yet incontrovertible proof of the use of sarin gas, from the way the victims were treated. This was on the part of the opposition, the rebels, not by the government authorities." She added, "This is not surprising, since the opponents [i.e., the anti-Assad opposition] have been infiltrated by foreign fighters." In a video interview on the BBC yesterday, del Ponte said, "We collected some witness testimony that made it appear that some chemical weapons were used, in particular, nerve gas. What appeared to our investigation was that was used by the opponents, by the rebels. We have no, no indication at all that the government, the authorities of the Syrian government, had used chemical weapons."

This makes the Western claim that the Syrian government is using chemical weapons as wrong. The U.S. military could step up intervention in Syria. The Assad regime charged that the opposition had fired a rocket with a chemical warhead at Khan al-Asal near Aleppo. It killed 26 people including 16 Syrian soldiers according to opposition sources. The opposition claimed that the Assad regime had fired the chemical rockets. This is implausible since the rocket was aimed at pro-Assad forces. The U.S. political and media establishment took opposition allegations as good by default. President Barack Obama said in August of 2012 that the use of chemical weapons by the Syrian government would be a red line prompting U.S. military intervention (from giving opposition forces arms to a military strike). On April 26, the White House endorsed this campaign in a letter to Congress, declaring: "The US intelligence community assesses with some degree of varying confidence that the Syrian regime has used chemical weapons on a small scale in Syria." The statement is false. Witness testimony gathered by the U.N. has documented that the statement is false as well. The use of sarin apparently by the U.S. backed Sunni Islamist opposition is tied to Al-Qaeda. They or the rebels carry out terrorism in Syria against Christians, Shias, and even Sunni human beings. The U.S. Council on Foreign Relations said that sarin is very complex and dangerous to make. They believe that it could be made by a trained chemist with publicly available chemicals. The rebels have been controversial regardless if they gotten the sarin from foreign backers (and synthesized it themselves under outside supervision) or stole it from Syrian stockpiles. Even the mainstream media is having trouble to spin the chemical weapons story in a way to get the majority of the American people to support some military attack in Syria. Time and again—in the Houla massacre of May 2012 and the murder of journalist Gilles Jacquier in January 2012—the media blamed atrocities perpetrated by the opposition on the Assad regime, then dropped the issue when it emerged that the opposition was responsible. Even the US government's announcement last December that Al-Qaeda-linked opposition forces had carried out hundreds of terror bombings in Syria did not dim media support for the war. Most of the mainstream Western media will bury the del Ponte interview. The West wants more intervention in Syria. This is similar to the lies about weapons of mass destruction or WMDs used to justify the war against Iraq. The West is showing propaganda about chemical weapons as a means to justify agitation against Syria. The Washington Post is showing the same claim of Assad using chemical weapons against civilians. A preemptive strike against Syria would be against international law just like the Iraq War was ten years ago. The Iraq War was destructive killing millions and costing trillions of dollars. NY Times executive editor Bill Keller in his article entitled, "Syria Is Not Iraq" wants the rebels to be funded. He wants immediate military action in Syria. On the other hand, there is no evidence that Assad used chemical weapons. We need a peaceful resolution to this Syrian civil war not war mongering.

The American killed fighting for Syrian rebels had an Al-Qaeda flag. The terrorist makeup of the Syria opposition has been underscored by the mainstream media all of the time. An American woman and 2 other westerners were killed fighting on the side of the FSA rebels in Syria. They were found with the Al-Nusra flag or the Al-Qaeda group that killed U.S. troops in Iraq and has become the primary fighting force in the country. "TV footage showed a bullet-riddled car and three bodies laid out. It also showed weapons, a computer, a hand-drawn map of a government military facility and a flag belonging to the al Qaeda-affiliated al-Nusra Front," reports the CNN. The American woman was later identified as 33 year old Nicole Lynn Mansfield, from Michigan. The Al-Nusra connection again underscores the point that while Britain and France plan to arm rebels after an EU ban was lifted, opposition militants fighting in Syria are becoming increasingly extremist, radicalized and dominated by foreign jihadists. Jabhat al-Nusra is the now leading front force in Syria. They are commanding other rebel groups as FSA rebels defect to the terrorist group in droves. Soon after the State Department declared Jabhat al-Nusra a terrorist organization, 29 different FSA rebel outfits pledged allegiance to the Al-Qaeda group. In April, the leader of Al-Nusra formally pledged allegiance to Al-Qaeda. NATO have shown their best efforts to try to portray the FSA and Jabhat al-Nusra as separate entities, but the so-called moderate FSA rebels are now mimicking Al-Nusra's behavior (like in a recent video which showed an FSA fighter cutting out the heart of a Syrian soldier and biting into it). The FSA wants to see the Al-Qaeda flag fly over the White House once they are successful in the region. They made songs that glorify the CIA asset Osama bin Laden and the 9/11 attacks and even naming their units the "Bin Laden brigade." FSA rebels have ransacked Christian churches and burning U.S. including Israeli flag in public in more than one occasion. This is not about the

morality of burning flags, but the West being hypocrites (in claiming to love America but agree with rebels burning their own flags).

The reality that the Syrian opposition is now replete with bloodthirsty terrorists has turned public opinion squarely against arming the rebels, but NATO powers and the United States are still seriously considering supplying heavy weaponry in light of Russia's decision to green light the delivery of six S-300 air defense systems to Syria under a 2010 contract. The last American found to be fighting on the same side as FSA rebels was U.S. Army veteran Eric Harroun. He joined up with Al-Nusra in Syria. He was arrested by FBI agents on his return to the U.S. and charged with using a rocket propelled grenade launcher on behalf of an Al-Qaeda affiliated group. Harroun's father claimed that his son has been working for the CIA. The CIA is known to fund terrorists for decades across the Earth. In March, the New York Times reported that the CIA has been conducting, "a secret airlift of arms and equipment for the uprising against President Bashar al-Assad," since early 2012. Matthew Vandyke fought alongside al-Qaeda terrorists in both Libya and Syria. He gave lectures in D.C. back in March. He originally wanted to join the CIA and later called himself a freedom fighter. "Why westerners were fighting the Syrian government alongside Al Qaeda "rebels" is not known. What is known is that tomorrow front pages across the nation will be blasting "American woman killed in Syria" and the ensuing thirst for revenge will be just the missing link needed by the administration, in lieu of having found no weapons of mass destruction, to escalate the conflict even further," writes Zero Hedge. Turkey supports the Syrian rebels as well. Turkey has a neoliberal privatization agenda especially when it is found in Istanbul. Turkey's own citizens have protested Turkey backing NATO backed terrorists in Syria and other issues. Prime Minister Recep Tayyip Erdogan of Turkey wants more influence in the Middle East and the EU in exchange for their support of terrorists in the Middle East. Back then, Erdogan was having almost daily talks with President Obama while he was being wooed into the scheme. Turkish police have used water in attacking the Turkish protesters wanting real changes in Turkey. Webster Tarpley is right to mention that the West has exploited the Arab Spring as a means to destabilize the nation states of the Middle East.

Senator John McCain went into Syria to meet with the Syrian rebels. This is ironic for many reasons. One is that the U.S. government claims to fight terrorism. Yet, they are funding the rebels, who have terrorists among many of their ranks indeed. Not to mention that numerous individuals are in Guantanamo Bay for just associating with terrorists. Numerous FSA rebels in Syria have admittedly said that they were led and have allegiance to Al-Qaeda terrorists. The Republican Senator John McCain wants U.S. military aid to the Syrian opposition. He made a surprise visit to Syria and met with the rebels. This comes when Russia and the U.S. are trying to set up a peace conference. This comes when the EU wants to scrap the arms embargo of the Syrian opposition. This will give Britain and France the means to send heavy weaponry to the rebels when the Syrian Army troops are scoring major victories. Many of the former Guantanamo Bay detainees (as found in a list) are in there, because some of them are merely associating with terrorists. John McCain did just this action when he meet up with FSA militants. These militants begged him to pressure President Barack Obama to send weapons and launching air strikes against the Assad government. NATO tries to differentiate between FSA rebels and the Jabhat al-Nusra terrorists in Syria. Yet, some of them are one and the same. Some Jabhat al-Nusra members are commanding FSA rebels. There are facts that prove that many sections of the FSA rebels are terrorists. John McCain is associating with many terrorists members. FSA rebels have defected to Jabhat al-Nusra in drove. Jabhat al-Nusra is in the leading front line fighting force in Syria. They command other rebel groups. They have killed U.S. troops in Iraq. After the State Department declared Jabhat al-Nusra a terrorist organization, 29 different FSA rebel outfits pledged allegiance to the Al-Qaeda groups. FSA rebels have vowed to fight the U.S. after they finish with Bashar al-Assad. They burn American flags. Some of them are filmed singing songs to glorify the CIA asset Osama bin Laden and the evil 9/11 attacks.



Some of the FSA rebels have cannibalized human beings. Some of them have murdered Christians, Sunnis, Shia, and other dissidents in Syria. FSA rebels have forced children to behead human beings and create other atrocities. They have killed journalists in targeted killings like Maya Nasser and Yara Abbas. FSA rebels are pictured wearing the black flag of Al-Qaeda and wearing uniforms with Al-Qaeda insignia on. The UN human rights investigator Carla del Ponte said that FSA rebels have used chemical weapons. They are being funded by the Saudis and the Qataris. John McCain is the man supporting the terrorists in Libya that murdered innocent human beings before. When the No Fly Zone resolution over Libya was first passed in the UN, it was designed to enable 'rebel' forces in Libya to "protect the civilian population" from air and armor attacks from the Libyan Army. What ensued almost immediately after the resolution passed was nothing of the sort: the UK and France – under US direction – took it upon themselves, in almost 10,000 airstrike sorties within six months, to not only destroy all of Libya's meager air-force and armor, but destroy the vast majority of the infrastructure Gaddafi had built. This ran alongside a targeted assassination campaign against Gaddafi himself to bring about the desired regime change, which just by chance, also happens to be completely against international law. He or John McCain wants conflict with Iran, but loves to ally with terrorist allied human beings in Syria. The secular Syrian government is targeted for regime change (and Jabhat al-Nusra wants an extremist fundamentalist state filled with sharia law). The CIA has used an arms trafficking operation from Saudi Arabia and Qatar to Syria according to numerous sources. Saudi Arabia is hypocritical to claim to want freedom in Syria, but they have some of the most authoritarian, anti-freedom policies in the world. The neo-conservatives want Western involvement in a war with not only Syria, but with Iran as well. The Syrians should have freedom, but not at the hands of theocratic terrorists. There should be an independent peace conference and discussions as a means to end the Syrian civil war (and make solutions that will benefit all of the Syrian people not a select few or U.S./NATO interests).

The West want regime change in Syria as a way for them to get the region's oil reserves in a strategic power grab. The EU embargo was lifted as result from the campaign from the UK and France on May 28. This will cause more atrocities in Syria via jihadists as terror squads (on the behalf of London, Washington, and Paris). In the UK, reactionaries are exploiting these events as a means to create even harsher repressive policies domestically. Prime Minister David Cameron has created an anti-terror task force as a means to propose measures to tackle "political extremism." This force includes the Metropolitan police commissioner, Sir Bernard Hogan-Howe, and the Director General of MI5 Andrew Parker. The government of the UK now is trying to reintroduce legislation that makes telecom companies

to record the time, duration, originator, and recipient of all emails, phone calls, messages on social media, webmail and Internet voice calls made in the UK. The murder of Lee Rigby has been exploited as a means for the enemy to continue their imperialist and colonialist adventures overseas. Political life in Britain and globally has been harmed by laws that violate human civil liberties. The leaders of financial power want to get the oil, gas, and mineral resources of the Earth via wars. Now, we are paying trillions of dollars for these evil wars and they cost our social programs at home. The ruling class is just as much responsible for the murder of the soldier as the real murderers are. They are the ones who orchestrate terrorism globally.

The U.S. is using the accusation that Assad is using chemical weapons as a means to send weapons to the rebels. The truth is that the Al-Qaeda back rebels are found to have chemical weapons. The White House claimed that Syria has crossed the red line. Secretary of State John Kerry loves this action. This imperialism is done under the guise of humanitarian intervention. The West accused the Syrian President of killing his own people. *"Following a deliberative review, our intelligence community assesses that the Assad regime has used chemical weapons, including the nerve agent sarin, on a small scale against the opposition multiple times in the last year," White House Deputy National Security Adviser Ben Rhodes said in a statement. "Our intelligence community has high confidence in that assessment given multiple, independent streams of information." The President believes that President Bashar Al Assad has used chemical weapons allegedly in Syria. This is very similar to the WMD saga of Iraq. Iraq was attacked on the false basis that it has WMDs extensively. The West believes that the Syrian government executed premeditated mass murder, so intervention must occur. The rebels want the U.S. to have a no fly zone. The United States wants to aid the rebels more. The military rebels have been decimated by the Syrian government forces.* These defeated opposition rebel forces –largely composed of the Al Qaeda affiliated Al Nusra– are supported by Turkey, Israel, Qatar and Saudi Arabia. The US, NATO, and Israeli funded rebels have lost the ground war. The Western military alliance has funded the Al Nusra Front Fighters. A no fly zone could be risky since Syria's air defense system has the Russian S-300 SMA system. We know that the U.S. supported Al Qaeda rebels have used chemical weapons (in their atrocities in Syria).

Confirmed by various sources including CNN, the Western military alliance has not only made chemical weapons available to the Al Nusra Front, it has also sent in military contractors and Special Forces to train the rebels. The rebels have been trained in Jordan and Turkey. Many defense contractors are training Syrian rebels to handle stockpiles of chemical weapons. The Gulf Arab states are aiding the rebels as well. Some like those in the Syrian Foreign Ministry believe that the U.S. is wrong to frame the Syrian regime as having used or prepared for chemical warfare. While President Obama accuses Bashar Al Assad, the US-NATO military alliance is channeling chemical weapons to Al Nusra, a terrorist organization on the State Department list of terrorist organizations. Even the United Nations Independent Mission confirms that rebel forces are in possession of sarin nerve gas. The Turkish state media agency Zaman said that the Turkish General Directorate of Security named Genel Müdürlüğü sad that the Al Nusra terrorist cell has chemical weapons. The West is supporting Al Qaeda. The State Department called Al Nusra a terrorist organization. They have killed innocent Syrians in Damascus, Aleppo, Hamah, Dara, Homs, Idlib, and Dayr al-Zawr. The head of the FSA Supreme Military Council Brigadier General Salem Idriss is a liason with Al Nusra military commanders. Both Democrats and Republicans believe in this war mongering. Bill Clinton agreed with John McCain in having militarism in Syria. Most Americans do not want an American troop intervention inside of Syria. Much of the anti-war movement is silent on this issue since a Democratic President is in the White House. We know the truth. The truth is that pseudo-liberals want to transform the Middle East into a place filled with pro-Western puppet states. It is the threat of imperialism and a malleable world which is a true threat to all freedom loving peoples of the world. We have the right to disagree with this evil and advocate for justice and a peaceful resolution to the civil war in Syria. The Western elite is trying to force or pressure President Barack Obama to attack Syria (after the liberation of Qusayr on June 6, 2013. The anti-Assad death squads were defeated there) plainly speaking. He or Obama has hesitations about a massive military involvement in Syria. We know that illegal phone taps are bad, but the WWII scenario as advocated by reactionary neocons is worse.



The Evil Drone Attacks

There have been lawless drone killings for years now. Two UN reports outline this problem. A sixteen year old named **Malala Yousafzai** is an activist for women's education, a blogger, and a Sakharov Prize winner. She is a Pakistan National Youth Peace Prize recipient. She was a 2013 Nobel Prize nominee. Desmond Tutu nominated her for the International Children's Peace Prize. On October 16, Canada said it plans to grant her honorary citizenship. Obama invited her to the White House. She ironically said that, "Drone attacks are fueling terrorism." "Innocent victims are killed in these acts, and they lead to resentment among the Pakistani people." She is correct. Predator drones kill many human beings. There are remote warrior teams that operate computer keyboards and multiple monitors. In other words, the imperialists murder by remote control. They target faceless victims. They kill indiscriminately. They do so unaccountably. We know that drones are instruments of state terror. Studies document how mostly innocent civilians are killed by them. They were in the wrong place at the wrong time. There is the joint Stanford University International Human rights and Conflict Resolution Clinic (SU)/New York University School of Law Global Justice Clinic (NYU) report. It entitled, "Living Under Drones." The dominate Washington narrative claims that drone strikes are precise and effective. Targeted killings "minimi(ze) downsides or collateral impacts," it says. Doing so makes America safer, it alleges. These views are false since drone attacks kill indiscriminately. Mostly noncombatant civilians are affected. "Living Under Drones" exposes what Washington won't say. The White House claims that drones haven't caused a huge number of civilian casualties. It claimed that they're targeted or focused at people who are on a list of active terrorists trying to go in and harm Americans. Hard evidence proves otherwise. According to the SU/NYC study:

"US drone strike policies cause considerable and under-accounted-for harm to the daily lives of ordinary civilians, beyond death and physical injury." "Drones hover twenty-four hours a day over communities in northwest Pakistan, striking homes, vehicles, and public spaces without warning." "Their presence terrorizes men, women, and children, giving rise to anxiety and psychological trauma among civilian communities."

Official statements about drone killings keeping America safe are false. Evidence from the SU/NYU study show that at most only 2 percent of victims are high value combatants. Others are mostly innocent civilians. Drone killings fuel resentment. They facilitate anti-American recruitment. Most Pakistanis call America the enemy. Other affected countries view America in the same context.

Professor Christof Heyns co-directs the University of Pretoria's Institute for International and Comparative Law. He serves as UN Special Rapporteur on Extrajudicial, Summary or Arbitrary Executions. He has his September 13 dated UN report. It is entitled, "Extrajudicial, summary or arbitrary executions." It omits offender country names. He clearly holds Washington responsible. "The expansive use of armed drones by the first states to acquire them, if not challenged, can do structural damage to the cornerstones of international security and set precedents that undermine the protection of life across the globe in the longer term," he said. The report mentions the following:

"...The use of drones by states to exercise essentially a global policing function to counter potential threats presents a danger to the protection of life, because the tools of domestic policing (such as capture) are not available, and the more permissive targeting framework of the laws of war is often used instead."

On October 25, General Assembly member states will discuss Heyns' report. It calls for obeying international law. According to Heyns, he wants nation to follow international law. Countries may not consent "to the violation of their obligations under international humanitarian law or international human rights law." Reprieve is an UK based human rights group. Its legal director Kat Craig said that the report exposes the evil drone war that is harming innocent civilians. This action is a threat to international security as a whole. The CIA must be held into account of this. Reprieve has clients like young Pakistani children who saw their grandmother killed in front of them. The CIA is made up of terrorists. Ben Emmerson is UN Special Rapporteur on Human Rights and Counterterrorism. His September 18-dated UN report is titled "Promotion and protection of human rights and fundamental freedoms while countering terrorism." The UN investigators identified dozens of U.S. drone strikes causing civilians deaths and inquire. Doing so clearly violates international law. There should be justice on this issue. There are such incidents in Afghanistan, Yemen, Iraq, Libya, Somalia, Pakistan and Gaza. "While the fact that civilians have been killed or injured does not necessarily point to a violation of international humanitarian law, it undoubtedly raises issues of accountability and transparency," he said. Former UN Special Rapporteur on Extrajudicial, Summary, or Arbitrary Executions Philip Alston calls targeted killings "intentional, premeditated, and deliberate use of lethal force (against individuals) not in the physical custody of the perpetrator."

*The White House has no moral right to assassinate anyone in the world even American citizens at any time. Francis Boyle calls drone attacks "murders, assassinations, and extrajudicial executions." According to Marjorie Cohn: Unlawful drone strikes "not only undermine the rule of law, (they) prevent the United States from reasonably objecting when other countries (target their own) kill lists." What more proof do we need? There has been a lack of transparency on the total CIA drone situation. The kill lists are highly evil. So, we know that the war on terror is evil and has been evil for over a decade.




Conclusion

You cannot be a racist without power. You cannot be a sexist without power. Even men who beat their wives get this power from the society which allows it, condones it, encourages it. One cannot be against racism, one cannot be against sexism, unless one is against capitalism.”

Yet, there can be no denial of mainstream capitalism contributing to the reality that the wealthiest 1 percent now control 39 percent of the world’s wealth, and their share is likely to grow in the coming years, according to a new report. Such murders are even glamorized in TV programs and movies. The movie *Waterloo Bridge* outlines the murderous nature of mainstream capitalism. We know that the

imperialist wars in the 21st century are a continuation of capitalism. The Iraqi War killed over 4,000 human beings from America. It has murdered 1.3 million Iraqi deaths. More Iraq and Afghanistan U.S. veterans have committed suicide than were killed in battle. In fact, 30 U.S. veterans attempt suicide every day and 18 die from it. In World War I, about 15 million human beings were murdered and 45 million human beings were murdered in World War II. Both wars have capitalist companies funding both sides (as Hitler was brought into power by German capitalists such as Thyssen, Krupp, and Siemens including other American capitalists) and stirring the directions of the war in various directions. In our time, we have White House leaders justifying murdering U.S. citizens via drone strikes. We have the mine disaster killing 13 miners in West Virginia including the miners killed by neoliberal forces in South Africa. We see a lack of healthcare, economic treason, and food exploitation by the elite. If we are awake, then we know that the murder of workers by extreme policies is an abomination. The new genocide is done in the West with the tactics of austerity, militaristic imperialism, and capitalist genocide. We know that every 2 minutes, a baby is born into poverty. Every 15 minutes in America a baby is born to a mother who received late or no prenatal care. One out of every 4 American veterans is now homeless. 22,000 Americans will die needlessly because of private, over expensive capitalist healthcare insurance companies. We have a modern capitalist police state in America with the stop and frisk program in NYC, with the SWAT Team harming communities nationwide, with the unjust laws violating fundamental human civil liberties, with warrantless wiretapping, and with other nefarious evils spreading in the world. We are in a global class war where the elite are murdering human beings, violating laws, stealing pensions, and receiving record bailouts.

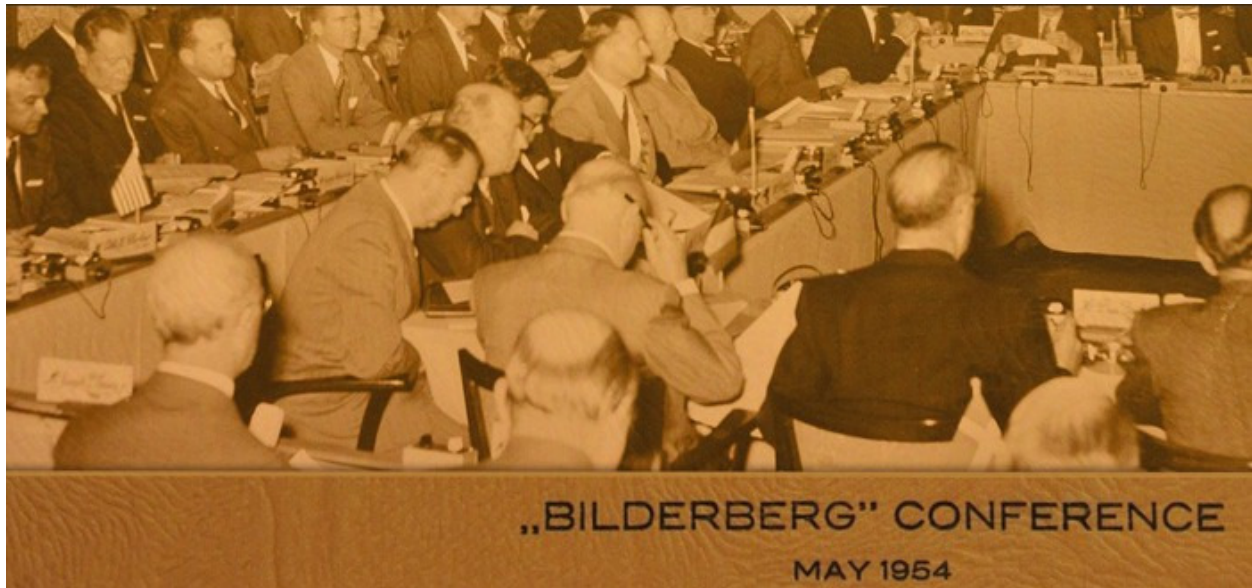

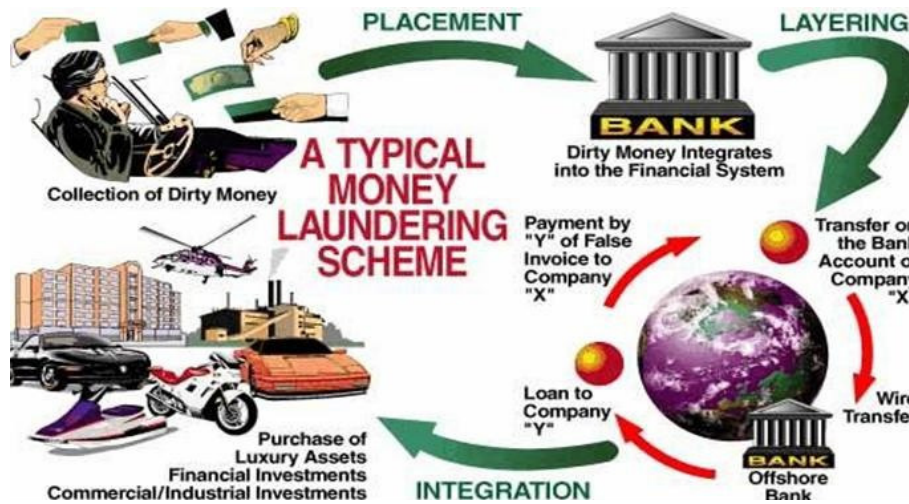
The Bilderberg Group in 2014 and Beyond

We know fully that the Bilderberg Group meeting in 2014 (in Copenhagen) has been filled with war criminals, Big Oil leaders, banksters, and neo-liberal advocates. **The Bilderberg Group** is a private organization. It is not public at all. It is exclusive. European royalty readily are in its membership. Its members are part of other elite transnational groups and forums too. There are the interconnections between the elite communities and networks. The authors named Ian Richardson, Andrew Kakabadse, and Nada Nakabadse wrote the new book on the Bilderberg Group entitled, "Bilderberg People: Elite Power and Consensus in World Affairs." Even a scholar like Ian Richardson has admitted that elite conclaves of the Bilderberg Group and the Trilateral Commission are linked to the structure of transnational interlocking corporate power. Richardson has interviewed two professors, the governor of a central bank, an EU Commissioner, the CEO of a television network, and other human beings. Many in mainstream academic are members or have ties to these transnational elite organizations. That is precisely why academia is not reporting on these groups in a thoughtfully critical fashion. It is obvious that Bilderberg members want a more globalized world order. Similarly, Bilderberg regular Denis Healey (who was also on Bilderberg's Steering Committee), admitted recently:

"To say we were striving for a one-world government is exaggerated, but not wholly unfair. Those of us in Bilderberg felt we couldn't go on forever fighting one another for nothing and killing people and rendering millions homeless. So we felt that a single community throughout the world would be a good thing."

You have the words from the people in that group. Also, we should oppose the terrorism from the FBI, the CIA, and NATO (which have use tactics to harm legitimate revolutionary movements

worldwide. These intelligence and political organizations are terrorist organizations point blank period). The 2014 Bilderberg meeting occurred in the Copenhagen Marriot HOTEL In Denmark. The conference included also members from military intelligence, politicians, finance, academia, and neocon think tanks. While Bilderberg claims its annual conference is “to foster dialogue between Europe and North America”, the worldwide monetary system as well as the US-NATO global war agenda are slated to be discussed behind closed doors. Bilderberg expert Daniel Estulin said that the Bilderberg Group talked about the 2008 economic crisis before. Estulin correctly predicted the housing crash and the 2008 financial meltdown, because of his sources in Bilderberg told him what the elite were planning. This was based on their 2006 meeting in Canada and the 2007 conference in Turkey. We know that many too big to fail banks like Goldman Sachs has too much power in the world. Goldman Sachs will be represented by: Peter D. Sutherland, Chairman of Goldman Sachs International, and Robert B. Zoellick, Chairman of the Board of International Advisors of The Goldman Sachs Group. Their presence is by no means accidental. Both Sutherland and Zoellick “in their previous lives” before joining Goldman played key roles in strategic trade negotiations including NAFTA and the WTO. The Transatlantic Trade and Investment Partnership (TTIP) is on the Bilderberg agenda and Goldman Sachs is intent upon playing a leading role. “Too big to jail” HSBC will also have representatives, the Group Chairman of HSBC Holdings, Douglas J. Flint, and his senior advisor Sherard Cowper-Coles. These mega banks have a longstanding record of financial fraud. Goldman Sachs has been caught in being involved in financial manipulation since the 19th century. NATO Secretary General Anders Fog Rasmussen will be in the Bilderberg Group meeting too.



As for “too big to jail” HSBC, on December 10, 2013 the US Justice Department “announced a settlement with the British-based HSBC bank regarding charges of money laundering Mexican drug funds that allows the bank to admit to wrongdoing and pay a fine without being criminally charged.” In 2012 the US Justice Department issued a statement saying that after an exhaustive investigation, they “concluded that the burden of proof to bring a criminal case (against Goldman) could not be met based on the law and facts as they exist at this time.” Robert Rubin and Lawrence Summers were involved with supporting the policies (like neoliberal policies) that contributed to the recession. Robert Rubin was involved in abolishing the Glass-Steagall Act, which paved the way to the Wall Street CASINO and led to the 2008 collapse. Lawrence Summers advocated IMF policies in developing nations, whose structural adjustment program policies resulted in mass poverty. So, for 4 days, instrumental people (some of whom are involved in economic disastrous policies,

imperialism, and maintaining oppressive surveillance policies) will meet in secret. The mainstream media is not totally covering the Bilderberg Group because of obvious reasons.

- Council of Foreign Relations member and Former Secretary of the Treasury USA member Robert E. Rubin

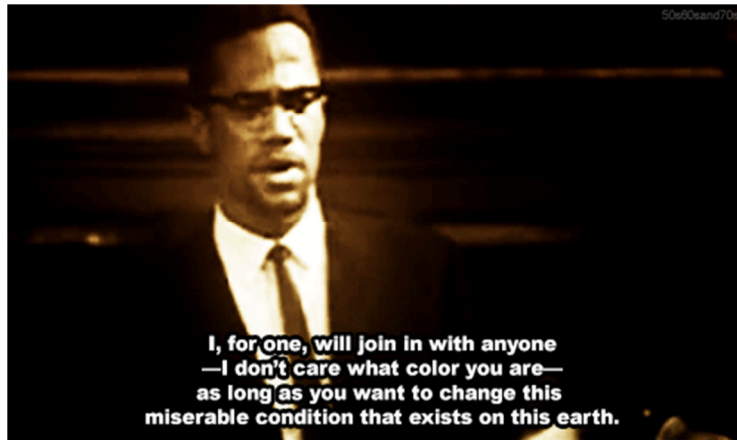

A Reminder

Both parties are responsible for the damage done to the economy. Both parties in their leadership follow orders from the one percent. Bill Clinton was a centrist and he used triangulation. A centrist is a person who have done both some legitimate things politically and made errors including compromises as well. That sums up the Clinton legacy. He ended welfare as we know it, which I disagree with. He allowed policies to grow the prison industrial complex (with his love of the War on Drugs and strict three strike laws. The reality was that Clinton played his role in helping to create a low-wage, low-benefit economy. The number of working poor increased under his watch.

According to a 1999 report compiled in part by the National League of Cities and the National School Boards Association, "The number of children in working poor families leaped by one-third from 1989 to 1997, despite a booming economy and a twenty-five-year low in the nation's unemployment rate." Clinton had a reactionary foreign policy too. So, people know the truth. Clinton, the one-time anti—Vietnam War so-called "protester", CONTINUED Bush's 1992 invasion of Somalia, invaded Haiti in 1994, bombed Serbia in 1995 and 1999, he bombed Sudan and Afghanistan in 1997, and William Jefferson Clinton bombed Iraq almost continuously throughout his administration. To force North Korea into negotiations, Clinton threatened in 1994 a war that could have provoked a nuclear conflict. He enforced the murderous sanctions of Iraq that killed over one million Iraqi civilians. Bill Clinton's Presidency was better than other Presidencies like Harding, Coolidge, Andrew Johnson, and Reagan, but he followed Republican-lite policies as a means to preserve his political power.



We also have to understand real history too, so we can be mentally, socially, politically, and economically liberated. We know that the CIA, under the guidance of the counter-intelligence chief James Angleton ran extensive, illegal domestic operations against anti-Vietnam War protesters. Many CIA-linked people are part of the reactionary American Security Council. Since the end of WWII, we have seen an increase of private think tanks and social clubs. These organizations have been funded by a small group of multinationals, foundations, and banks. We should never omit the Le Cercle group too. That group is tied to the Opus Dei, the Knights of Malta, and the CIA. Le Cercle has supported covert operations too. The Anglo-American Pilgrim Society has a great membership and it is older than the CFR, the Royal Institute of International Affairs, the Bilderberg Group, the Trilateral Commissions and other private groups too. Some very powerful people in the world include David Rockefeller, Henry Kissinger, Lord Jacob Rothschild, Otto von Habsburg, and others. We see many factions of the Western political structure. Some of them are the liberal establishment (tied to the State Department), the conservative establishment (linked to the CIA and the Pentagon), the Vatican-PanEuropa network (that is self explanatory. Group like the Jesuits, Opus Dei, and the Knights of Malta are in this network), and the Zionist establishment (which is tied to the U.S. Israeli lobby, Israel, and communities worldwide). The establishment in its many forms are in a class warfare. The establishment is hostile to genuine grassroots movement for social change where labor unions and the rights of the poor and middle class are defended. These organizations (like the neoliberal Bilderberg Group) pretty much want privatization, deregulation, and more political including economic integration in the world as the true "solution" for humanity.

We know that real solutions don't reside in oligarchy, but in the empowerment of the masses of the people.



When I have researched Republican and Democratic Presidents in the past decades, I see the same pattern. They are funded by the same corporate interests. They are part of the same engine of oppression against our community. Many of them advance blatantly reactionary policies. Carter and Reagan radically deregulated industries. Clinton and Bush Jr. advanced the blatantly racist War on Drugs, mass incarceration, and bad trade deals for years. Truman advanced aggressive Cold War policies too (he consented to the dropping of two nuclear bombs on Hiroshima and Nagasaki in August 1945—incinerating hundreds of thousands instantly and subjecting millions more to cancer—even generals winced like Dwight D. Eisenhower). There is nothing radically left wing about these Presidents. The Democrats in their leadership have been just as much involved in war mongering as the Republicans. That is why many Democrats voted for the Iraq War just like the Republicans. By the 1960's, the ruling class had no choice, but to give concessions to the masses of the people. The Civil Rights Act, the Voting Rights Act, Medicare, Medicaid, and other legitimate laws were created by the blood, sweat, and tears of real activists (among many colors including black people) who refuse to capitulate to injustice. All people deserve justice. The 1960's was a changing time. It was the time of the zenith of liberal reformism in American society. After King's assassination, the government abandoned broad bases reforms and choose more moderate and reactionary policies (since the days of Nixon onward. Nixon supported the racist Southern Strategy, etc.). The ruling class allows a privileged upper middle class layer to persist while the masses of the people suffer in poverty. Our condition has not radically improved either since the late 1970's.

That is why revolutionary solutions (that involves the fighting of economic inequality and the unification of the working class via a real program) are needed to help us as a community. We should constantly learn new, interesting information. At the end of the day, humanity needs jobs, education, adequate housing, AFFORDABLE HEALTH CARE, and other rights that all human beings deserve. There must be a revolutionary transformation of the social order where democratic rights are maintained and the neo-feudal ideology of austerity is purely repudiated. Also, I still believe in revolutionary solutions. There must be active political involvement in the world as a means for us to transform it and make it better for humanity. Our people will have to continue to struggle for justice excluding accommodation to the status quo. We need an end to imperialism and the blatantly destructive War on Drugs. I will always agree with workers' rights, with environmental justice, with racial justice, with human rights, with universal health care, and with economic justice (as the late Dr. Martin Luther King Jr. accurately said, we need a radical redistribution of economic and political power to address the needs of the poor & all oppressed peoples. I will never bow down to crony capitalism. I am opposed to monopoly capitalism for capitalism is not God. I will believe in social democratic power & that people power is important too).



The CIA and Torture

It is obvious the U.S. has done torture policies. This torture did not just exist since 9/11. The CIA has done torture for decades in nations globally. Operation Phoenix dealt with explicit torture and assassinations during the Vietnam War. So, America hypocritically lectures other nations on human rights abuses, but America must bring its own house in order. It is as simple as that. The Senate report on the CIA torture program documents the evil of torture. The unclassified executive summary of the Senate Intelligence Committee's report shows the brutal program of torture, and abuse. The U.S. government's crimes are very intensive. The 500 page report of CIA torture under the Bush administration was released on Tuesday morning. Senate floor remarks were made by committee chairman Dianne Feinstein. It is a summary of a larger, still classified 6,700 page document, which was compiled by Senate staff from 6 million pages of documents. The report was completed in 2012. The CIA, with the collaboration of even the Obama administration, has sought to obstruct its release at one time. The reported said that the CIA used not only waterboarding. Prisoners were thrown against walls. Prisoners were secured in Mylar tape. Some detainees were slapped and punched. Other detainees were in mock burials where they were kept in small boxes in which they were unable to move for hours at a time. One prisoner, Gul Rahman, was forced to take "ice water baths" and was then "held partially nude and chained to a concrete floor" until he died of hypothermia. One of the officers responsible for Rahman's death was then given a "cash award" of \$2,500 by the CIA for his "constantly superior work." According to the report summary, "CIA officers also threatened at least three detainees with harm to their families—to include threats to harm the children of a detainee, threats to sexually abuse the mother of a detainee, and a threat to 'cut [a detainee's] mother's throat.'" Further, "[o]ne interrogator told another detainee that he would never go to court, because 'we can never let the world know what I have done to you,'" and another interrogator "engaged in 'Russian Roulette' with a detainee." A CIA employee noted that prisoners in the COBALT detention facility (described by the chief of interrogations as "the dungeon") "literally looked like a dog that had been kenneled," and that when the doors to their cells were opened, "they cowered." That is why some prisoners attempted suicide and mutilation.

The report summary details how the CIA hired two doctors, James Mitchell and Bruce Jessen (identified in the report by the pseudonyms, Grayson Swigert and Hammond Dunbar), and to develop a method of torture whereby prisoners could be reduced to a state of physical and mental devastation. The doctors based their recommendations on the theory of “‘learned helplessness,’ in which individuals might become passive and depressed in response to adverse or uncontrollable events.” At least 26 prisoners are acknowledged to have been held without any basis whatsoever. The report summary enumerates dozens of occasions when high-ranking CIA officials lied to Congress and the public. In the course of a single hearing to the Senate Intelligence Committee on April 12, 2007, then-CIA Director Michael Hayden lied about a total of 17 subjects related to the torture programs. The Bush administration officials, especially Cheney and George W. Bush, have defended the perverted program. The CIA officials involved in the programs should be prosecuted as these actions violate national and international law. This torture is a sign that we in America must get our own house in order and promote human dignity for real.



The Issue of Russia

Russian politics and its relationship to the Western elite is complex. To get a better picture of it all, it is important to understand the end of the Cold War. The Soviet Union was in the decline, because of human rights issues, the over extension of resources in their fight against Afghanistan, and collapse of political plus economic infrastructure. The Soviet Union was spending from 15 to as high as 27 percent of its GDP (not the annual budget) on the military. Even today in America, the U.S. only spends about 5.5 to 5 percent of its GDP on its military. Many Russian oligarchs were in touch with British aristocratic economists and MI6 assets before Yeltsin was President of Russia. These oligarchs wanted to promote a neoliberal path for Russia. During the late 1980's, Gorbachev ruled the Soviet Union. He knew that the Soviet Union was about to end, so he made concessions with the Western establishment. Soon, a crisis occurred in Russia and Yeltsin along with the oligarchs took over. Yeltsin and the Western oligarchs have links to Western financial elites. The West wanted to use Yeltsin as a means for the Western establishment to transform Russia not into a real progressive, social democracy, but a client state filled with neoliberal policies. Throughout the 1990's, the Russian economy became devastated. Yeltsin became more and more corrupt. The Russian oligarchs are linked to Western banks and some Israeli plus some Jewish bankers too (not all Jewish people. Many Jewish people and many non-Jewish people want justice and freedom for all people, so I want to make that clear). They control much of Russia's wealth. The Russian mafia grows their power during the 1990's as well. The Neo-cons James Woolsey and Le Cerle member Fritz Ermath are accused of using Russian oligarch Boris Berezovsky to manipulate Russian politics and siphon off IMF aid to the country. Others named in the IMF and related financial scandals are the oligarchs Mikhail Khodorkovsky, Vladimir Gazinsky and Roman Abramovich. Yeltsin and his family members are accused of looting funds meant for the development of Russia. The West wanted to pacify Russia.



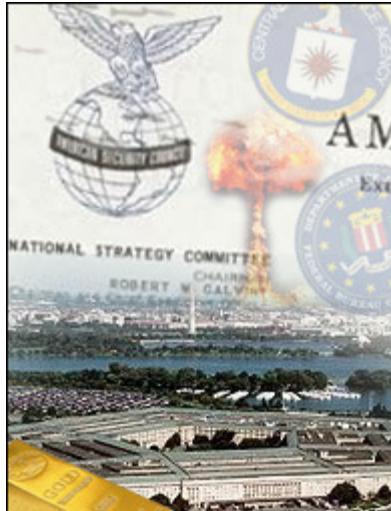

WHO ARE THE TERRORISTS?



In 1999, things changed. Former KGB/FSB chief Vladimir Putin comes into power and people accuse him of being involved in the Russian apartment bombings of September 1999. Russians re-invade Chechnya, because they want its territories. Chechnya is heavily Muslim. Putin also uses a program to retake the possessions of the oligarchs Boris Berezovsky and Mikhail Khodorkovsky. Berezovsky soon flees Russia and is given asylum in England. Khodorkovsky teams up with Henry Kissinger, Jacob Rothschild, Zbigniew Brzezinski and George Soros, but is later imprisoned by Putin. So, the West wants to limit the growth of Russia and China for the sake of the West wanting hegemony over the resources of Central Asia and the Middle East. Even Zbigniew Brzezinski admitted this plan in his 1997 book entitled, "The Grand Chessboard." Samuel Huntington's "The Clash of Civilizations and the Remaking of the World Order" from 1996 talks about similar subjects. Vladimir Putin's legacy has not yet been totally written. He has worked to develop the Russian military. Its economy has been harmed via Western sanctions. He has supported Crimean self-determination, which is great, but his problem is that some of his domestic policies are overtly anti-democratic. Russia's S-400 anti-aircraft system is a powerful weapon too. Now, Russia and the West are dealing with Ukraine. Ukraine is having its civil war. The West wants the Ukraine to join with the European Union while Russia wants Ukraine to be more in line with the Russian orbit of influence. So, Ukraine should not be some puppet Western/EU/IMF client state. We know the evils that NATO has done too. Ukraine should be independent and truly free. Future and time will tell what will happen.



The American Security Council

One of the most reactionary organizations in the West is called the American Security Council. It was created in 1954, which was during the early era of the Cold War. Its members include generals, intelligence officers, businessmen, and scholars on its various boards. Many of their early members were supporters of the anti-civil liberty advocate Senator Joseph McCarthy. They have irrationally harsh anti-“communosocialist” opinions. They were antagonistic towards the State Department. In essence, the establishment rights (made up of the old right, new right, and the religious right) teamed up to fight communism for decades. The old right historically formed groups like the American Legion, the American Liberty League, the National Association of Manufacturers, the Crusaders, and the American First Committee. These groups were anti-interventionists, but some of their members early on expressed indifference towards European and Japanese fascism. Then, WWII occurred where the establishment decided to overtly fight Nazi Germany. After WWII, the interventionist new right was born. An old right figure would be someone like Senator Robert Taft. Yet, all of these factions of the establishment right hated and opposed the New Deal. The New Deal has some flaws. Yet, the New Deal was right to limit work hours and abolishing child labor. The late Jerry Falwell was in the religious right. Falwell was a close ally of the American Security Council. Falwell was part of the ASC’s “Peace Through Strength” campaign in 1983.

There is a lot more information on the American Security Council. The American Security Council wanted to fight communism. It has been reported that the ASC had information on 6 million human beings. They profiled Americans because of political beliefs, which is by definition anti-democratic. One famous person in the ASC was retired Rear Admiral Chester C. Ward. He supported massive defense spending as in a BOOK (published by him and the Dame of Malta Phyllis Schlafly) in their book “The Gravediggers.” In 1974, both of them published the best-seller “Kissinger on the Couch” criticizing Kissinger’s policy of détente and claimed that he was an instrument of the Soviets. The ASC’s book was very similar to the John Birch Society’s books. Some directors of the Citizens Committee for a Free Cuba or CCFC were ASC board members Edward Teller and Claire Boothe Luce. It is well known that the conservatives of the American Security Council and other related groups were against President John F. Kennedy’s Limited Test Ban Treaty and Kissinger’s proposals of détente including the Strategic Arms Reduction Talks. The ASC believed in the paranoid fiction that diplomatic efforts for détente was part of a Soviet run, grand “communosocialist” conspiracy

created to rule America. Even General Douglas MacArthur pushed for the use of nuclear weapons against North Korea and China. Even Truman thought that he went too far. Members like Colonel Raymond Sleeper (part of an ASC national strategy committee member) wanted to attack the Soviet Union if they refuse to comply with the West. General Curtis LeMay was a wicked man. He not only ran the fire bombings of Japanese cities killing more than 2 million people in the process (which tons of civilians died). He also wanted a massive bombing campaign in North Vietnam and he wanted to attack Cuba, which JFK rejected outright. He was so extreme that he called the resolution of the Cuban Missile Crisis as the "greatest defeat in our history." His protégés were Power and ASC strategy board member Joints Chief General Lyman Lemnitzer. The Western reactionaries readily support the torture, murder, and oppression of labor union leaders, human rights activists, communists, socialists, etc. if the leaders of those nations are in league with Western interests. The ASC continued domestic spying actions even after the Frank Church Committee's findings of government corruption. The ASC loved the views of Richard Nixon, Barry Goldwater, and Ronald Reagan. Today, the ASC is focused on anti-terrorism not anti-communism as we live in a new generation. The ASC is allied with the neoconservative movement. At the end of the day, we don't need to worship neoconservatism. We need to fight for our liberties, labor unions have the right to organize, and social services should help humanity.



Appendix A: The Mid Term Elections of 2014

The midterm elections are coming up in America. This election represents the divisions in American society over political issues. The Obama administration has been around for six years. There are millions of dollars are being poured into the campaigns of the two big business, capitalist parties. Total spending will make 2014 the most expensive non-Presidential election year in U.S. year. Some predict that voter turnout will be in new lows, even for American elections, which routinely attract less than 50 percent of the electorate. There is disillusionment among some in the American political system. The total political system has shifted further to the right. Both parties since 2008 have used policies that have harmed the poor and working class. Global capitalism has been exposed now like in no other time in history. We live in a heavily commercialized world where marketplace transactions are one of the most dominant forms of social interaction. Some people want material gain alone instead of loving each other. There

*The combined net worth of Congress is about 2 billion dollars up from 150 million dollars from 2012 ACCORDING to CQ's Roll Call's annual tally. The median net worth of the members of Congress is over \$450,000. The midterm elections are the most expensive non-Presidential election in U.S. history. Ironically, voter turnout is expected to be in record lows. The public at large has expressed great disapproval of both the Democrats and the Republicans. Both of these parties are running on right wing platforms. We see the huge, widening chasm between political institutions and both parties form the broad mass of the people. The financial oligarchy controls economic life in the West heavily. The extremely rich control a huge part of the social and economic components of mainstream United States society. The release of the report follows the announcement earlier this year by the Center for Responsive Politics, using a different method for estimating the average wealth of US lawmakers, that 2012 marked the first time a typical member of Congress was worth over a million dollars. We see that even the Democrats, who posture themselves as for the "middle class" were on average richer than their Republican counterparts. Congressional multimillionaires include House Rep. Darrell Issa (a Republican from California), the Republican Michael McCaul of Texas, Democratic House member John Delaney, and others. Each of these people works with major committees or they are funded by the military industrial complex and other corporate entities like Credit Suisse and JPMorgan Chase.

The House and Senate leaders are readily multi-millionaires. Democratic Senate Majority Leader Harry Reid is worth about \$2.8 million, while Republican Senate Minority Leader Mitch McConnell is worth \$11.97 million. Republican House Speaker John Boehner has a net worth of \$2.32 million, and outgoing House Majority Leader Eric Cantor \$9 million. Democratic House Minority Leader Nancy Pelosi has a net worth of \$29 million, making her the 14th-wealthiest member of Congress. The net worth of a typical U.S. household was \$56,335 in 2013, which is down from 36 percent since 2003 according to a study published earlier this year by the Russell SAGE Foundation. This means that a typical member of Congress is 20 times wealthier than a typical American. We see much corruption, bribery, fraud, and other insider dealings in the government. That is why candidates either seek wealthy donors to fund their campaigns or agree with oligarchical policies. The Democrats try to get support from the middle class, the working class, and sections of big business. The Republicans gain support from small businesspeople and small farmers including most of corporate America. We see for the past 50 years, the deindustrialization, the financialization of the economy, the growth of social inequality, and other issues. The only solution is a broad based ending of the current system to be replaced with a fair system where the working class has democratic control of the economy, where people have real rights, and justice is established.



The Mid Term Election Results (Republicans win mostly)

Many in the corporate media (the CIA's Operation Mockingbird has infiltrated the corporate media for decades) have said the GOP will take control over the Senate for months. So, this reality is not shocking or surprising to me. The Republicans have shown who they are. They want more corporate tax cuts, many of them want more policies against workers' rights, a lot of them want more austerity, some love the TPP, and many of them want the growth of the Empire (via imperialist policies which has killed so many people in the world including Africans. The GOP has both houses of Congress. Some of them have been funded by the Koch Brothers and the interests of the 1%. We know how reactionary, retrograde, and extremist the GOP is. Now, they have no excuses to put it bluntly. I will never be a Republican too (and many closet Republicans are in the world too. I have exposed not only the Koch Brothers, but the Bilderberger participant George Soros before too. I know about Left Gatekeepers for years as written about by Charles Shaw. The Left Gatekeepers are funded by big corporate foundations like many reactionary Republicans are). Yet, we should never lose hope. We should fight for solutions and CONTINUE to work in our communities regardless of the composition of Congress. 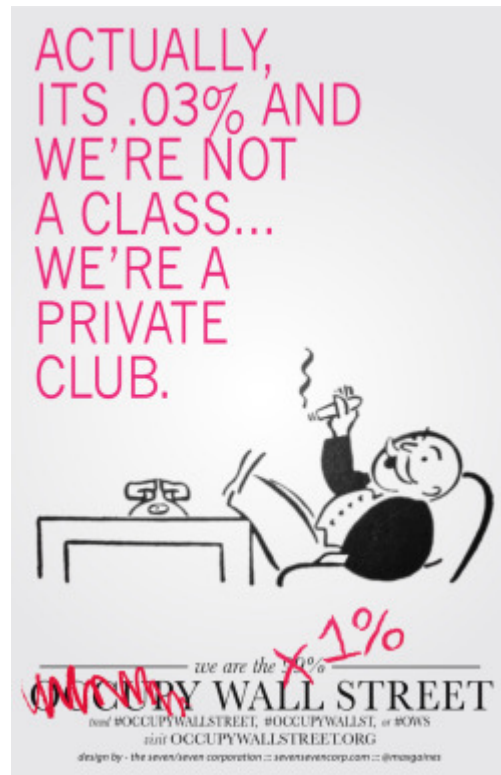
movement (outside of the two party system) that can address the needs of the masses of the people. We should have justice period.



Rahm Emanuel is a neoliberal politician. He is the representative of the centrist, neoliberal 21st century Democrat. Before Emanuel, the Daley family had a 43 year dynasty as being mayors of Chicago. Richard Daley Sr. was part of a white racist Irish gang called the Hamburg Athletic Club. This group were one of the many racist instigators of the Chicago race riot of 1919 (also called the Red Summer riot) where innocent black people were assaulted and killed by racist mobs. The Hamburg Athletic Club members were instigators in the attacks of black people. Daley Sr. also opposed Dr. Martin Luther King Jr.'s efforts in Chicago in 1966. Daley Sr. also supported the police assaulting protesters during the 1968 Democratic Convention in Chicago. Many of the black people prosecuted during his tenure as mayor were tortured by the Chicago police. CPD Lt. Detective Jon Burge tortured more than 200 criminal suspects in Chicago from 1972 to 1991 in order to force confessions. This was a grave injustice. Many innocent black people and others were railroaded into prison. This history must be known, so we can realize the total truth concretely.

Rahm Emanuel has Wall Street ties. He is known for his usage of massive profanity. He once cursed at Sister Karen Lewis. Rahm is an acolyte of Bill Clinton and he agreed to support NAFTA. One of the mayor's closest friends is Bruce Rauner, a billionaire investor. Many of these recommendations should have been implemented by the mayor long before it was released, because many of them are common sense actions that can be executed immediately when he was first inaugurated as Mayor of the city of Chicago. He promotes this Road Map in the midst of him trying to be reelected.

Rahm is aided by corporate interests. Emanuel not only shut down over 50 schools in Chicago and he lay off teachers. He has attempted to cut pensions too. These actions only harm the city not help.
