Surprising Revelations a Swiss banker, interviewed by the Russian weekly "NoviDen" in Moscú the May 30, 2011.



CEO of Deutsche Bank and Bilderberg, <u>Josef Ackermann</u>, an example of the worst excesses of the <u>Bilderberg Club</u>.

**Q:** Can you tell us something about your participation in the Swiss banking business? **A:** I have worked for Swiss banks for many years. I was appointed as one of the best directors of one of the largest Swiss banks. During my work I participated in the payment in cash to a person who killed the president of a foreign country.

I was at the meeting where it was decided to give the cash to the murderer. This gave me headaches and remorse. It was the only case and went from bad to worse. The payment order

was handwritten by a foreign service giving the order to pay a certain amount to a person to kill the leader of a foreign country. And it was not the only case. We have received several handwritten from foreign secret services giving the order to disburse cash in secret accounts to fund revolutions or death of people cards.

I can confirm what <u>John Perkins</u> has written in his book " <u>Confessions of an Economic Hit Man</u>". Actually there is only one system and Swiss banks are involved in such cases.

**Q:** Perkins book has been translated and is available in Russian. Can you say which bank is and who was responsible? **A:** It was one of the *three major Swiss banks* at the time and was the president of a Third World country. But I will not give out many details because I would easily find if I say the president's name and the name of the bank. I risk my life.

**Q:** Could you name another person's bank or not ?, **R:** No, I can not, but I can assure you that this happened. There were several people in the meeting room. The person responsible for the cash came to us and asked if he was allowed to pay such a large amount of cash that person and a director explained the case and all the others said they could.

**Q:** Has it happened often? Does this type of fund was used to bribe? **A:** Yes. This was a special fund managed in a special place on the bench they were all coded letters and went abroad. The most important letters were handwritten.

We had to decipher them and was ordered to pay a certain amount of cash in the account of the murderer, revolutions, strikes were financed funding, all political parties are financed. I know some people who are Bilderbergers participated in such orders. I mean I gave the order to **kill**.

**Q:** Can you tell us what year or decade this happen? **A:** Prefer not give the exact year but it was in the 80s.

**Q:** You had a problem with this job? **A:** Yes, a very big problem. I could not sleep for days and after a while I left the bank. If I give a lot of details I will leave footprints. Several secret services abroad, mainly English speaking, gave orders to fund illegal acts, including the killing of people through Swiss banks.

We had to pay and instruct foreign powers to murder people who did not follow the orders of Bilderberg or the IMF or the World Bank, for example.

**P:** It is a startling revelation what you are doing. Why do you feel the need to say this now? **A:** Because Bilderberg meeting in Switzerland. Because the world situation is getting worse. And because the largest banks in Switzerland are involved in unethical activities. Most of these operations are out of balance. It is a multiple of what is officially declared. It not audited and passed without any taxes. The figures in question have a lot of zeros. They are large amounts.

**Q:** So billions? **A:** It is much more, are trillions completely unchecked, illegal and outside the tax system. Basically it is a robbery everyone. I mean the ordinary people who pay taxes and obey the laws. What is happening here is completely against our Swiss values, like neutrality, honesty and good faith.

In the meetings that I attended I was completely against our democratic principles. You see, most of the directors of Swiss banks are not from here, are foreigners, mostly Anglo-American or British, do not respect our neutrality, do not respect our values, are against our direct democracy, just use Swiss banks for their illegal means. They use large amounts of <a href="money-created-from nothing">money created from nothing</a> and destroy our society and destroy the people and the world only by greed.

They seek power and destroy whole countries, like Greece, Spain, Portugal or Ireland and Switzerland will be one of the last in line.

They will use China as slave labor. And a person like Josef Ackermann, who is Swiss, is the most important man in a German bank and uses his power for greed without regard to ordinary people.

He has very few legal cases in Germany and now also in the United States. It is a Bilderberger and do not care about Switzerland or any other country.

**Q:** Are you saying that some of these people you mention will be at the next Bilderberg meeting in June in St. Moritz? **A:** Yes.

**Q:** So they are in a position of power? **A:** Yes. They have a huge amount of money available and is used to destroy entire countries. Destroy our industry to bring it to China. On the other hand, they opened the gates of Europe to all Chinese products. The working population of Europe is gaining less. The real goal is to destroy Europe.

**Q:** Do you think that the Bilderberg meeting in St. Moritz has symbolic value? Because of what happened in 2009 in Greece and 2010 in Spain. Does this mean that Switzerland can expect something bad? **A:** Yes. Switzerland is one of the countries most important to them, because there is so much capital here. They meet there, because, apart from anything else they want to destroy all the values that Switzerland stands for.

You see it is an obstacle for them not to be in the EU or the euro, without being totally controlled by Brussels and so on. As for the values'm not talking about the big Swiss banks, because they are not Swiss, most of them are run by Americans. I'm talking about the true spirit of Switzerland that ordinary people appreciates and supports. Of course it has a symbolic value, as you said, with regard to Greece and Spain. It aims to be a sort of exclusive club of the elite that has all the power and everyone is impoverished and going down.

**Q:** Do you think the goal of Bilderberg is to create a kind of global dictatorship controlled by large global corporations, where there is no more sovereign states? **A:** Yes, Switzerland is the only place left in your path with a direct democracy. They use blackmail of "too big to fail," as in

the case of UBS to put our country with a large debt, as it did with many other countries. At the end maybe they want to do with Switzerland, which they did with Iceland, with all banks and the country bankrupt.

**P:** And also bring to the EU? (Switzerland) **A:** Of course. The EU is under the tight control of Bilderberg.

**Q:** What do you think could stop this plan? **A:** Well, that's why I talk to you. His truth. The truth is the only way. Put a light on this situation exposes. They do not like being in the spotlight. We have to create transparency in the banking sector and at all levels of society.

**Q:** What you are saying is that there is a right way for the Swiss banking business and there are a few banks that are misusing the financial system for their illegal activities. **A:** Yes. The big banks are training their staff with the Anglo values. They are training them to be greedy and ruthless. And greed is destroying Switzerland and everybody else.

As a country we have the majority of banks operating more successfully in the world, if you look at the small and medium banks. They are just *great* they operate globally and are a problem. They are not Swiss (banks) and are not considered as such.

**Q:** Do you think it's good that people are exposing Bilderberg and showing who they really are? **A:** I think the case of <u>Strauss-Kahn</u> is a good opportunity for us, because it shows that these people are corrupt, they have a mind sick, are full of vices and vices they are kept secret. Some of them rape women as Strauss-Kahn, others are sado or pedophiles and many are in Satanism.

When you go to some banks you see these satanic symbols, such as the Rothschild Bank in Zurich. They have to follow orders or be exposed, will be destroyed or even killed. The reputation of Strauss-Kahn has not only been murdered in the media, he could be killed literally.

**Q:** Since Ackermann is on the steering committee of Bilderberg, do you think he's a great decision maker? **A:** Yes. But there are many others, like Lagarde, in my opinion, it will probably be the next head of the IMF, also a member of Bilderberg, then Sarkozy and Obama. They have a new plan to <u>censor the Internet</u>, because the Internet is still free. They want to control it and use terrorism or whatever the excuse. They can even plan something horrible to have an excuse.

**Q:** So that's your fear? **A:** It is not just a fear, I'm sure. As I said, they gave orders to kill, so they are capable of terrible things. If they feel they are losing control, including lifting now in Greece and Spain, and perhaps Italy will be next, then they can do another Gladio. I was close to the Gladio network.

As you know instigating terrorism with American money to control the political system in Italy

and other European countries. Regarding the murder of Aldo Moro, the payment was made through the same system that I told you about.

**Q:** Was Ackermann part of this payment in a Swiss bank? **A:** (S mi) ... you're the journalist. Look at your career and how quickly rose to the top.

**Q:** How do you think we could stop them? **A:** Well, there are many good books that explain the background and connect the dots, as mentioned by Perkins. These people have really come down to the men who were paid to kill.

Some of them obtained the money through Swiss banks. But not only have this system set up throughout the world. You have to expose them in public because they are willing to do anything to maintain control.

**Q:** What through exposure we can stop them? **A:** Yes, telling the truth. We face very cruel criminals, also big war criminals. They are ready and able to kill millions of people just to maintain power and control.

**Q:** Can you explain from your point of view, why the media in the West is more or less completely silent about Bilderberg? **A:** Because there is no agreement between them and <u>are the owners of the media</u>. They do not talk about it. They buy them. Some of the leading figures in the media are also invited to the meetings, but told not to report what they see or hear.

**Q:** In the structure of Bilderberg, is there an inner circle knows the plans and then there is the majority who just follow orders? **A:** Yes. You have the inner circle where Satanists are then are naive or less informed people. Some people in the outer circle even think that they are doing good.

**Q:** According to the documents presented and their own statements, Bilderberg decided in 1955 to create the EU and the euro, so now do and decide important things. **A:** Yes, you know that Bilderberg was founded by <a href="Prince Bernhard">Prince Bernhard</a>, one former member of the SS and the Nazi party and also worked for <a href="IG Farben">IG Farben</a>, the subsidiary that made the <a href="Zyklon B">Zyklon B</a>. the other was the head of Occidental Petroleum, had a close relationship with the communists in the Sowjetunion (Soviet Union).

They worked on both sides, but in reality these people are fascists who want to control everything and everyone who gets in his way will be removed.

**Q:** Is the payment system you explained outside normal operations, is secret and is compartmentalized? **A:** In normal Swiss bank employees do not know is happening. It's like a secret department within the bank itself. As I said these operations are out of balance, unsupervised. Some are located in the same building, others are out. They have their own security and a special area where only certain authorized people can enter.

**Q:** How do you keep these operations outside the international system <u>SWIFT</u>? **A:** Well, some of the listings <u>Clearstream</u> from the beginning. It just included fake names to mislead the entire list is false. You see I also make mistakes. The first list was true and you can trace a lot of things. You see, there are people around who discover irregularities and say. Then, of course, there are lawsuits and these people are forced to shut up. The best way to stop them is <u>to tell the truth</u>, put a spotlight on them. If we stop we not end up like slaves.\_
