El Sistema Financiero Mundial y Sus Núcleos De Poder El Grupo Bilderberg

The Bilderberg group was officially born in May 1954, the date on which took place in the Dutch town of Oosterbeek first Conference of this organization with the participation of hundreds of prominent figures from the economic, political, academic and media world. Host this inaugural session in the halls of the hotel Bilderberg, whence the name of the group, was Prince Bernhard of the Netherlands, a closely related to high financial circles and Western political character.

Since cast to walk, the message released by the mentors of the *Bilderberg Group* (*The Group*) was the characteristic of this type of body: it was, according to the official statement, an entity designed to strengthen Atlantic unity, curb expansionism Soviet and promote cooperation and economic development of the countries of the western area.

All this was just a euphemistic way of describing, well known under the content of their meeting real objectives of the organization. And, despite the secrecy in which they develop, they have never lacked the telltale leaks on this subject. In follow-up meetings and adventures of this brotherhood emeritus worth mentioning the work has long been conducting the US newspaper *the Spotlight*, whose valuable information have been essential to know that these objectives are summarized in one, which is the progressive removal of national sovereignty and transfer to institutions and supranational oligarchy. But before going further agree scrutinize the origins of this entity, which appears as gray eminence and instigator character of little public resonance, but of enormous weight in the most discreet and elite circles of power.

This is **Joseph Retinger**, a subject to whom the surrender Bernhard of the Netherlands own funeral tribute with these words:

"History knows many notables on which aroused during his lifetime the limelight. They were admired and celebrated by all, and no one ignored his name There are, however, other men whose influence is even greater, affecting with his personality in time in which they lived, but they are not known, nevertheless, rather than by a very narrow circle of initiates. Joseph Retinger was one of these. "
(Bulletin # 5 Europeen du Centre de Culture).

Joseph Retinger was born in Krakow in 1887 within a prestigious Jewish family of Austrian origin. At age 18 he went to Paris, where he received his doctorate in Letters and filed his first contacts in the high western social spheres. Then he would begin his eventful and turbulent existence, characterized by multiple changes of residence and constant displacement, as well as its presence in the majority of political and diplomatic scenarios where European conflicts of the first half of this century were ventilated.

A frantic activity, in short, keeping a curious parallel to the adventures of the famous itinerant agents Enlightenment Freemasonry. After studying at the *School of Political Sciences* Paris moved to Munich, where he took a course in psychology. Later, in 1914, he went to London to join the *London School of Economics*, center where he established close contacts with the British Fabian circles bonded around this influential institution.

After starting in the Swedish Freemasonry, he moved to the United States, a country that would expand their relations senior and star in countless adventures. Finally, once the 2nd World War, Joseph Retinger fully committed himself to the task of building the foundations of the European movement. In May 1946, along with **Paul von Zeeland**, creates the *European League for Economic Cooperation*, an agency in the that, contrary to what might be inferred by name, were actively involved several prominent members of the US oligarchic nomenclature as

- John McCloy (CFR, Bilderberg, Chase Manhattan Bank)
- Averell Harriman (CFR, Bilderberg, Pilgrims, The Order)
- George Franklin (CFR, Bilderberg, Trilateral)

- M. Leffingwelle (partner of Morgan Banking)
- Nelson and David Rockefeller, etc.

The May 7, 1948 saw the light further elaboration of Retinger, the *Congress of Europe*, an entity in which several related organizations now joined, and from which emerge a year later the *Council of Europe*. Equally noteworthy is the decisive role Retinger in the delivery of the *European Movement*, an institution whose main objective is the <u>establishment of a supranational European government</u>, and whose general secretariat occupy its founder for several years.

It should go without saying that this kind of organisms are nothing but fumes high plutocratic-oligarchic spheres, so not surprisingly the content of a confidential report by one of them, the European Commission, under President **Jacques Delors**, report according to which fifteen multinational famous "single market" will split Europe:

The task developed by <u>Retinger</u> in the crystallization of the pro-European framework would be reviewed by the Bulletin No. 5 of the Centre for European Culture with these words:

"Without it, the European League for Economic Cooperation, the European Movement and our Centre for European Culture would not have never seen the light. The Congress of Europe in The Hague was his work, and the Council of Europe its outcome. Later it was he who she conceived and gave birth to the Bilderberg Group, dedicated to the understanding and the Atlantic union."

As indicated the quoted bulletin, the *Bilderberg Group* (The Group) was, indeed, one of the major projects implemented by **Joseph Retinger**, who served as Permanent Secretary of that body until his death in 1960. It should be clear, however, that the birth of the *Bilderberg Group* was conceived following the norm in these cases, just as has happened with all parallel entities described along these pages, and in which behind the technocrat operator it has always been a plutocrat sponsor.

No economic suffrage <u>house Rothschild</u> never have taken shape plans **Cecil Rhodes** and the <u>Round Table</u>, nor would have become reality *London School of Economics* without the funds provided for its creation by Huntington Trust and Banking Rothschild.

Just as the *Council on Foreign Relations* and its main architect, the sinister "Colonel" House, were sponsored Banking Morgan, or trades Brzezinski and trilateralist project had as its patron David Rockefeller, so the work Retinger for delivery of the Bilderberg Group responded to the strategic initiative and the funding from the plutocrat shift, then **Victor Rothschild**.

And in the shadow of every business on this scale, and beyond their immediate promoters, always behind an oligarchic incitement and a powerful financial platform. Until 1976, the *Bilderberg Group* was chaired by Prince Bernhard of the Netherlands. The bonds of the Dutch royal house (holding one of the largest fortunes in the world) with high finance are old and well known, making it unnecessary to detail here. Following the scandal of bribes from the Lockheed Company, in which he was involved as the main implicated Prince Bernhard, he left the presidency of the group and was replaced by <u>Douglas Home</u>, British Foreign Secretary, who remained in office until 1980.

A Home happened <u>Walter Scheel</u>, Foreign Minister and later President of the Federal Republic of Germany, which assumed leadership until 1985, when he was relieved by the British <u>Eric Roll</u>, president of SGWarburg banking group. The latter gave way in 1989 to the current president, **Peter Rupert**, better known as *Lord Carrington*, former Secretary General of NATO, former minister of several British governments and prominent member of the Fabian Society and the Royal Institute of International Affairs. Among the most prominent members of the European section of the Bilderberg Group is usual simultaneous membership in the <u>Trilateral Commission</u>, membership which extends to the <u>Council on Foreign Relations</u> in the case of the most prominent members of the American section of the Group.

The latter may be mentioned a short list of names that are active in the three agencies, such as:

- David Rockefeller
- George Bush
- Zbigniew Brzezinski
- Robert McNamara
- Henry Kissinger
- Caspar Weinberger
- Bill Clinton,

... None of which needs no introduction,

- George Ball, associate professor of banking Lehmann Brother
- Cyrus Sulzberger, columnist for the New York Times
- Heddy Donovan, editor of Time magazine

As regards the internal structure of the Bilderberg Group, it is structured according to the characteristic pattern of concentric circles, which is the organization adopted by both the oligarchic-globalization network as a whole, for each of the entities integrated therein. In the case of the Bilderberg Group, the outermost circle is represented by those attending regular conferences organized by the agency members, some of which are permanent members, and other occasional guests or pending recruitment.

The first inner circle is the *Steering Committee*, composed of 39 permanent members of the Group. A restricted clique latter is, in turn, the *second inner circle and tighter*. This is the <u>Bilderberg Advisory</u> Committee, whose members are all American members of the *Council on Foreign Relations*.

Not surprisingly Colonel **Curtis B.Dall**, ex-son of President Franklin D. Roosevelt and character well introduced in the US financial and political means, defined as the Bilderberg Group,

"The World Cup finals US Council for Foreign Affairs and the Royal Institute of British international affairs".

The objectives of the *Bilderberg Group*, nothing difficult to assume the other hand, have been exposed more than once with clarity on discrete conclaves celebrating this body amid imposing security measures. While it is true that little has served so far the secrecy surrounding such meetings, on which rarely have missed leaks, and even internal accusations that allowed to know much of their conclusions.

Proof of this are the statements made in the preambles of the Bilderberg Conference 1991 by <u>Charles Muller</u>, a senior official of the entity, who complained that "every year, someone who represents an organization or willing to oppose our newspaper goals just somehow infiltrating "(the newspaper referring Muller is none other than *the Spotlight*). Despite being, as already pointed above, the outermost circle of this entity, matters discussed at the regular summits offers a clear idea of your goals. Thus, in the Conference in June 1991 in the German town of Baden-Baden, the most conspicuous militants celebrated the development of Gulf War, whose outcome was so recent, as "an important step to bring Americans of nationalism".

On this particular spoke <u>Henry Kissinger</u>, one of the speakers, noting "advancing years" I had expected that the US intervention in the conflict had been agreed at the UN before the endorsement of the US Congress, unique empowered to declare war as required by the Constitution of the country, adding that organ,

"If Americans can be persuaded to transfer the war to the UN decisions, nationalism narrow gauge of France, Britain or any other country will disappear."

Kissinger's joy and their illustrious brothers was fully justified when you consider that the UN is but one of their puppet organizations. The culmination of this quick review will be good a few words on one of the "hobbies" favorite of the Bilderbergers. This is what, in the jargon of the organization, is known as "war games", a significant understatement by certain practices already been developing for some time before the designated *Council on Foreign Relations*.

Basically, the so-called war games involve role play of extreme crisis on foreign policy issues, to be provided every possible contingency that might pose an obstacle to the desired outcome. The reflection seminars or forums where they operate these "games" are usually held in remote locations under the auspices of academic institutions such as *Averell Harriman Institute*, the *Council on International Studies Yale* or the *Academy for Educational Development*, all they linked to society the Order of the which will be discussed later.

Participants in these seminars are usually experts recruited in high scientific and academic sphere and linked to key foreign policy figures in their respective countries. Alongside the "war games" "political games" are developed, both complementing each other. Actually, the war game starts when they occur or are placed in a critical political game events, such as coups, serious social unrest, assassinations, invasions, etc.

And while war games are designed to be provided all possible eventualities and the most appropriate solutions to each of them, it sometimes happens that the actual event (either spontaneous and provoked) develops differently than expected in the "game", in which case it becomes necessary to intervene directly if necessary, to correct deviations and redirect the process towards the right outcome.
