FOREWORD By MYRON C. FAGAN

For this issue we have departed from our usual format of unmasking and reviewing the various phases and techniques of the Great Conspiracy, in order to bring to your attention a recent event of great significance. That event was an address delivered by Holyoke (Mass.) paper industrialist George B Fowler before the American Institute in Milton, Mass., on March 7, 1960. It has great significance for every Civic organization in America — that is, for those Civic organizations that are truly concerned about the welfare of their communities and for the nation as a whole . . . it has great significance, and sets a perfect example, for every Community leader — that is, for every such leader who places country above self-interest. The following paragraphs will clarify what I mean.

In mid-1945, the late Senator Arthur H. Vandenberg came into possession of films (microfilms) and records of the secret meetings at Yalta — not the meetings that were "reported" by the Press, but the really secret meetings attended by only Franklin Roosevelt, Alger Hiss, Stalin and Molotov — the meetings that "delivered" the Balkans, Eastern Europe and China to "good old Uncle Joe". Those films and records revealed a story of rampant treason in our State Department, in the Treasury Department, in practically ALL of our Government Agencies, and in the White House, such as has never been equalled in the annals of any nation on the face of the earth.

Just how those films and records fell into Vandenberg's possession has no relevancy to this story — but what followed is *highly* relevant.

(Note:—The play "THIEVES' PARADISE" reveals how and why those shocking films and records were made — and how they were smuggled out of Yalta and into Washington . . . printed copies of the play are available at \$1.00 per copy. Ed.)

Senator Vandenberg had been sincere — naive, but sincere — in his bi-partisan support of the Roosevelt administration during the war. He had accepted Roosevelt's ideas in good faith, but when those films and records revealed his (Roosevelt's) treacheries and betrayals at Yalta — revealed, too, that our entire government was thickly infiltrated with Communists — Vandenberg felt that he was greatly to blame, that it had been his bi-partizanship that had in-

the free hand that enabled him to betray our nation. And he decided to undo that wrong the only way he knew how — by revealing the whole story to the American people. He called in the Press and submitted his "story" (the films and records). Now, those "gentlemen" of the Press knew that that entire evidence was bona fide — just as they knew that the so-called "Yalta Papers" they finally published had been deleted, distorted and watered down — but when Vandenberg offered them the true and unabridged Yalta story as revealed in those films and recordings they recoiled from it as if it were a case of smallpox . . . that's how controlled our Press was — and IS!

The Senator then turned to the Radio Networks — and received exactly the same kind of a reception. Of course, we now know that, with very few exceptions, the men who own and/or control ALL the Networks are functionaries of the Internationalist-Communist Conspiracy, but, at that, they had a more plausible excuse: they pointed out that any attempt to "tarnish" the halo of God-Man Roosevelt would be regarded as rank heresy by all the powers-that-be (at that time) in Washington — and the FCC was one of those powers!

Thereupon Vandenberg Int upon the idea of telling the "story" in a film — and in Hollywood he realized what a complete strangle-hold the Reds had on ALL our communications media. The Hollywood Moguls were even more brazen than the Press and Radio. Those who didn't jeer, resented the idea of a film that would "smear" the "greatest humanitarian the world has even known". When Vandenberg observed to Harry M. Warner that his "Mission To Moscow" had glorified Communism and betrayed America wherever that film had been shown, Warner flippantly repeated his famous retort to a similar charge by Representative Dies: "Don't worry about the Communists," retorted Warner, "they're fine; just you keep worrying about the Nazis and the Fascists".

After his humiliating turndown in Hollywood, Vandenberg turned to Broadway (the Legitimate Theatre) True, a play wouldn't have the nation-wide spread of a film showing simultaneously in hundreds of theatres, but the reviews were bound to mention the treason charges against Roosevelt, Hiss, Hopkins, etc., etc. That would force all of the Press. Magazines and Radio to "front-page" the event — anyway so Vandenberg believed. In addition, all those named as traitors in the play would be forced to enter libel suits — such suits would undoubtedly bring out the entire truth. On the other hand, if they would not sue it would be an open admission

of guilt — and then it would be up to the American people AND CONGRESS to bring them to trial via impeachment proceedings and other available legal machineries.

But Broadway was just as fully in the grip of the Great Conspiracy as Hollywood, as Radio, as the Press — if not even more so. The Producer who refused to play the RED game couldn't get a theatre — Actors, Directors, Scenic Artists who wouldn't play along with the Reds couldn't get jobs.

However, Vandenberg's "Mission to Broadway" was not altogether fruitless. His "story" was written into a play - in fact, two plays: "THIEVES' PARADISE" and "RED RAINBOW". And despite all the frantic efforts of the MASTERMINDS of the Great Conspiracy to prevent it, both were produced. The production of "THIEVES' PARADISE" in Hollywood (in 1947) directly forced the Congressional investigation that unmasked to all of the American people the Red Conspiracy in Hollywood. In addition, "RED RAINBOW" inspired the Senator McCarthy investigations that revealed the Communist infiltrations — and treason — in the State Department, the Treasury Department, the Defense Plants, the Armed Forces -- and in the White House. Also, "THIEVES' PARA-DISE" was directly responsible for Sen. McCarran's and Representative Usher L. Burdick's investigations that revealed that the "United Nations" is the Great Conspiracy's "Trojan Horse" within the United States — and serving, among other conspiratorial functions, as a sanctuary for Russian spies and saboteurs and for American traitors.

Now, all of the above may seem like an overlong preface to establish a point — but that point is the key to our entire problem of how to deal with the Great Conspiracy. It establishes that the one overwhelming fear of the Masterminds of the Conspiracy is the wrath of the people. Thus, I wanted to set forth the lengths to which they will go to keep the truth from getting through to the people — to establish their almost complete control of our Press, Radio, TV and other mass communications media — to establish that that is why the vast majority of the American people get only the information that the "Masterminds" want them to get.

However, there is one medium which could do an excellent job of transmitting the truth to the people, and it is a medium that the "Masterminds" could not control — except by the collaboration of our sanctimonious "Community Big Shots". . . the following will explain that statement:

In every community in our nation we have a variety of Clubs

and Civic organizations, such as Chambers of Commerce, Economic Clubs, the Lions, Kiwanis, Rotary, Women's Clubs, etc., etc. All of them are (ostensibly) devoted to keeping their members abreast of events and conditions through the Speakers they engage for their weekly luncheon and/or dinner meetings. In combination, they could go far to offset the "brainwashing" by the controlled Press, Radio, TV, etc. But in recent years even that "communications medium" has been shut off. To emphasize the statement I will quote from our October 1958 "News-Bulletin":

"I have spent the past several weeks in New York, Chicago, Detroit, etc., talking with civic leaders, with Industrialists, with members of Congress and heads of Patriotic organizations. And in those conversations I have learned more and more . . . the reasons for the bewilderment and confusion of the mass of the American people . . . the reasons for their believing and accepting what the ENEMY wants them to believe and to accept.

"The first reason that comes to mind, of course, is the 'brainwashing by the Enemy-controlled Press, Radio and TV . . . but there is a far deeper reason — and that is the suppressing and muzzling of those who could, at least partly, offset that 'brainwashing. And virtually all who are responsible for that suppression are men and women who proclaim 'Americanism' the loudest. I refer to the officials of Service Clubs, Civic Groups, Women's Clubs, etc., who choose the Speakers for their various meetings. Today — and for the past several years — every Speaker who forcefully exposes the various phases of the Great Conspiracy, speakers such as John T. Flynn, Dan Smoot, even Dean Manion, are branded as being 'controversial' and are barred by a great majority of all Clubs and Civic organizations. Now, I won't say that these officials are pro-Communist. In their own minds they probably believe that they are as loyal to America as you and I. Nevertheless they bar such Speakers — and thus definitely collaborate in the plot to keep the American people from learning the truth. Their excuse is FEAR — fear of jeopardizing their positions. To clarify what I mean I will quote the President of perhaps the most prominent Service (Economic) Club in the mid-west — he said:

 Immediately, the Anti-Defamation League, various other Jewish organizations, and even the 'Christian and Jewish Brotherhood' descended on me, all screaming demands that I cancel Mr. — the papers made snide remarks — some of our own members protested — I was forced to cancel that speaker.'

"And that is not a unique case. I've had many similar statements from others. Thus, the people are 'brainwashed' by the Press, Radio and TV on the one hand — and shut off from the word-of-mouth true story on the other hand."

But there is one kind of speaker whom no Community Club official could very well bar; or dare to dictate and/or censor his subject — and that is the Big Man in that community. By that, I mean a Banker, a Judge, an Industrialist, any highly respected personality in his community, such as Mr. George B. Fowler is in the Holyoke-Springfield area — or, I should say, in the state of Massachusetts.

Briefly, Mr. Fowler is Treasurer and Chief Executive of the century-old Holyoke Paper Company, one of the most successful and highly regarded establishments in the entire paper industry. As an individual American his reputation for integrity is second to none. But what is more important to this subject, George B. Fowler is one of relatively rare American industrialists and business men who know just how dangerous is the situation confronting our country under the tricky surface compounded of propaganda, ballyhoo, wishful thinking, complacency and government-disseminated misinformation. Indeed, his grasp of all the phases of the Great Conspiracy amazes even me, with all of my accumulated knowledge. What is more, Mr. Fowler has for many years been engaged in a prodigious effort to acquaint as many people as he could reach with truthful, factual information regarding problems now literally threatening the continued free and sovereign existence of the United States.

I strongly urge you to read his findings slowly — digest them — and, if you can, follow his example and relay his invaluable information to friends and acquaintances concerned about their own future and especially that of their children as free Americans.

And I strongly urge all the Big Men in our various communities to do what Mr. Fowler has done—and is doing. They are the voices of authority in their communities — they will be heard where others are silenced — and they will be believed. They can go far to save our country.

And now I have the honor — and pleasure — to give you Mr. George B. Fowler.

MR. FOWLER'S ADDRESS:

My subject concerns the World Revolution — more particularly as reflected in current political and economic movements, and pending financial chaos in the United States — above all, however, it does concern the World Revolution, which is the crux of a struggle and a crisis in our time that goes beyond any previous experience of mankind. Some comments, therefore, are in order which are directed specifically to that revolution — and especially to the thinking of those who lend themselves in furtherance thereof.

There is a hard core minority composed (to be sure) of Communists (trained revolutionaries). They and their party are more entrenched and more generally active than ever before. Cooperating for their purposes, however, are many who will prove to be primarily responsible for such success as may be achieved (and, as things now stand, that ultimate success seems to be almost inevitable). You can call them Socialists, One Worlders, Internationalists, dupes, social do-gooders, visionaries, intellectuals, or what have you — any such terms are probably correct. They are not necessarily Communists — but they help the course of revolution in terms of Communist objectives by virtue of their unwillingness to act in defense of their native land, their civilization, their freedom, or their future. There is something in the thinking of such people that is responsible for their apparently wholesale defection from the ranks of citizenship in support of America — which is a characteristic that has been clearly illustrated and emphasized again and again by events within our own borders. Even more clearly have similar events been dramatized by disclosures outside our borders. More about this will be discussed in just a moment. We notice a cloak of respectability almost universally associated today with open treason — treason so flagrant as to spell inevitable and irrevocable national disaster. Attention is called to a very significant article appearing in the February issue of AMERICAN MERCURY* titled "The Story of International Development" by Harold Lord Varney This is a must reading for all who are concerned with the events of our time - as it is a clear description of a major program of suicide which we have embraced that invites disaster by giving away American production and know-how. Attention is also called to the international Exchange Agreement of November 21, 1959

(between the United States government and the USSR) that provides (in the guise of exchange) for the importation from Russia of cells or groups of students, graduates, post-graduates, researchers, instructors, professors, and the like - with their families and retinues — at American taxpayers expense — thoroughly indoctrinated and trusted Communists here to observe, study, and analyze our society, our manners, our culture, our institutions, our scientific and technical know-how in every conceivable field — this is a giveaway of American security — CLOSER-UP* of January 15, 1960 is urgent reading on this subject. The personnel mentioned above are described as agents trained to become "administrators" and "commissars" of a world government — specifically designated for governmental positions in the United States when total world government has arrived (by 1973 at the latest). Attention is also called to action at the top level of government as illustrated by recommendation of the President (backed by the Secretary of State and the Attorney General) for abolition of the Connally Reservation socalled (which, alone, stands between our independence and practical slavery). In programs that are so numerous as to leave one in extreme confusion who is not a student of such things, we find proposals being made and steps taken to consummate the decisive take-over in favor of a planned world governmental authority. This is well expressed by ECONOMIC COUNCIL LETTER No. 472 of February 1, 1960:*

"The ultimate design is to integrate all national governmental operations into a world operation under UN control, while at the same time integrating all local governmental activities and all private agencies firmly under the Federal Government".

It is probably an accurate statement — that the next Presidential election will mark a "break-through" as decisive as that accomplished in 1932. We are being trained for alliance with (and, I believe, submission to) Communism. We are the targets of a psychological warfare beyond any previous human experience. It is in the field of victory over our minds that the downfall of our civilization will be sealed. Therefore, it behooves us to examine this warfare as a background for any subsequent events, as it will be decisive for future generations. We must study the thinking of the enemy — (some of us may be surprised to find that similar or identical thinking today governs many of our own people).

So I shall begin by presenting the dominating ideas of the movement for a new world order — they are the classic foundation of

Communism. They should be memorized, studied, and discussed. A tremendous insight into human conduct and actions will be so gained.

- 1) Denial of religion and denial of God God, religion, moral precepts in terms of right and wrong all of these must go if Communism (and a World Order based upon materialistic ideas) is to prevail;
- 2) Dialectical or evolutionary materialism that everything in existence came about as a result of ceaseless motion among the forces of nature—that "conflict in nature" is the source of all creation that out of fierce, writhing forces in the elements we have obtained all that now is —stars, solar system, planets, animals, and the intelligence of man.
- 3) Human beings are only graduate beasts. This is fundamental. It explains the completely reckless disregard for human life which is the most striking single characteristic of Materialism in action.
- 4) The end justifies the means there is no such thing as innate right or wrong. The dialectical Materialists look upon distinction of right and wrong, ethics and morals as superficial and fraudulent.
- 5) The law of economic determination that "the qualities of human intelligence, personality, emotional and religious life merely reflect economic environment".

The following quotation is interesting in connection with these principles of Communism and is taken directly from the Staff Consultation of the Committee on Un-American Activities in Washington, D. C. on May 29, 1957 with Dr. Frederick Charles Schwarz of Australia.

- 1) Mr. Weil:— "I would like to ask one question of you as a psychiatrist as well as an analyst of the Communist ideology. There comes a point when all this re-evaluation and re-definition has progressed to a point where it is no longer reconcilable with reality, and even the Communists themselves must recognize this. Have they not reached that point?"
- 2) Dr. Schwarz:— "I do not believe they have reached it. They have reached the point of insanity".
- 3) Mr. Weil:— "You think Krushchev still believes in the classic theories as you expounded them?"
- 4) Dr. Schwarz:— "I believe that paranoia is at the heart of Communism and that their theoretical concepts are far more convincing to them than the evidence of the facts. I do not think that they are just hypocrites; they have merged the techniques

of hypocrisy with the virtues of sincerity, creating a very powerful instrument".

- 5) Mr. Weil:—"Mass paranoia itself is a term which can be quite deceptive".
- 6) Dr. Schwarz. "It is a powerful instrument".

Now see what happens when these ideas become accepted as principles of life, conduct, and thinking. I will illustrate how people become easy victims of an ideological virus that emerges as the secret (and decisive) weapon of Communism. W. Cleon Skousen, a well-known attorney and professional law enforcement administrator (formerly associated with the F. B. I.), to whom I am indebted for much of this information, made the following significant remarks in discussing the famous Gouzenko case:

"Prominent citizens and officials were promptly arrested and investigated by the Royal Canadian Commission - what the Commission wanted to know was why these high Canadian officials would turn against the interests of their native land. They asked these people if they had been bribed, and one of them replied, 'If they had offered me money, I would have been insulted'. . . . When the Commission inquired into the backgrounds of these people, they found they were casualties in the ideological war which is being waged between the Materialists and their opponents in the free world — these people had been raised in freedom — yet, when asked why they had collaborated with the Soviet agents, one of them made a typical reply: 'I thought I was helping humanity'. How were these men and women converted by Communist agents to believe that if they collaborated they would be helping humanity? . . . Suppose you were a scientist and one of these agents came to you. How would you react? Supposing he said: 'My friend, you know there is no divine intelligence guiding the human race; you know there is no Providential destiny for humanity; you know that if superior intelligences like yourself do not help us gain control of the human race, it will destroy itself. Can you imagine yourself giving this reply. I do not believe that there is any God or divine intelligence guiding the human race. Therefore, I suppose I should feel it my duty as one of the superior intelligences of my generation — and for the sake of humanity - to collaborate with your movement which is destined to take over and save the race for itself."

This was not only typical of the statements which many of the Soviet-converted Canadians admitted making — but they verified

their complete devotion to such ideas by deliberately engaging in subversive activities against their own country.

Therefore, we must conclude that these people were home grown Materialists. As Igor Gouzenko pointed out—"there is a defect in your culture when your own people can grow up in your midst without gaining an appreciation of the difference between freedom and slavery, between idealism and atheism, between faith and doubt, or between order and chaos".

Somehow we failed to provide these people with the necessary ammunition to protect them in that critical moment when they were contacted by the agents of a foreign ideology. And we should be quick to recognize that if our culture and system of education is producing Materialists, then this is the greatest secret weapon the Communists possess!

The greatest mistake that is being made in the free world today is the fact that we are mixing iron and clay. We are (supposedly) fighting for freedom but allowing some of our boys and girls to believe in things which turn out to be basic Communistic concepts (and increasing numbers of adults are accepting these concepts also). Materialism is not Americanism, but Communism. Every time we train a boy or girl to believe that the universe is the product of accumulated accident, that human beings are only graduate beasts, that there are no such things as innate right or wrong, or that deep spiritual convictions are old-fashioned and unnecessary, then we have caused a casualty among our own ranks in the field of ideological warfare. Without his ever knowing it, a young American is thereby trained to be a potential Red ally. This is, indeed, the great secret weapon of Communism. I recommend a book on this subject by Mr. Skousen: "THE NAKED COMMUNIST", published by the Ensign Publishing Company, Salt Lake City, Utah — also available from — The Bookmailer, Inc., Box 101 Murray Hill Station, New York 16, N. Y.

Those of us who do believe in God, who respect Him and seek to know His way (and follow it) find it difficult (if not impossible) understand the minds of those who are separated, adrift, without anchor or foundation, (though they may mouth pious platitudes and wear the aspect of sincerity and truth). As explained by Nietzsche (himself an Atheist and a Materialist) they (spiritually speaking) "wander through an endless nothingness". So the idea of a global revolution comes to them like a shining and guiding light. They seem to become part of a crusade — part of the stream of history — part of a program to regenerate mankind. Their lives are

given a purpose — and they dedicate their all to that purpose — with fanaticism that blots out any analysis of their information sources — the realistic consequences of the new and global political and social order — the qualifications of the executors thereof (individually or collectively) to assume the role of gods (much less to exercise the ensuing brutal power required to keep the human race forever in bondage). Here is the explanation that sheds light on the great problems of these times, the meaning of Communism, the meaning of the World Conspiracy, the meaning of World Government, the meaning of planned and wholesale treason at the top level of government in the United States.

Let me add that in this matter of treason you are exposed to great danger — for the culprits, having gained the upper hand, will exact upon you the punishment which they themselves deserve. The present drive for surrender of our sovereignty by elimination of the Connally Amendment and proposed Mental Health bills, Civil Rights bills, and others should be a warning of this. "Where there is no vision, the people perish".

In this war we are approaching the climax. I propose to discuss briefly certain movements that have assumed national proportions with national objectives in relation to the global plan. First, however, I shall mention specifically the ultimate goal and for this purpose refer to an article appearing a few months ago in HUMAN EVENTS — "Congress and the country face a situation unprecedented in the history of our Constitutional Government. A brother of the President acts as a decisive go-between. Milton Eisenhower led the President to launch his experiment in personal diplomacy. His international attitude was recorded in a pamphlet on UNESCO. 'Educators have a great role to play in helping to build up the outlooks and attitudes which would favor the establishment of a world government'". Few people are willing to recognize (much less grasp the implications of) the realities now shaping our lives namely, a complex, powerful, smooth-operating conspiracy that reaches into every facet of our activities for the purposes of a world government. It is specifically directed to the destruction of the United States as a sovereign nation; and its absorption in an organization controlled by aliens under which the American people will have lost their freedom and independence forever in a Sovietized America. The speed of progress toward fulfillment has been so great in the last 30 years as to exceed in its effect the combined efforts directed to the same goal during previous centuries. So complete and rapid and successful has been its evolution during this time as to now bring final victory within sight — almost within immediate grasp! This consummation of disaster for the human race is reflected in a comment already quoted here — namely, that a "break-through" can be expected in the next 2 years equal to what occurred in 1932. However, my purpose at this point is to discuss certain political, economic, and financial aspects of this revolution. Therefore, your attention is directed specifically to these phases which are classified as follows:—

- 1) The pincers movement for strangling America in furtherance of World Government: A) Metropolitan Government; . . . B) Urban Renewal; . . . C) Inflation.
- 2) Its definitions: . . . A) Its purpose (from the Enemy viewpoint); . . . B) Its present development; . . . C) Its relation to government spending; . . . D) Its relation to gold (and the gold standard).
- 3) Taxes: The word throughout is camouflaged CONFISCATION!... Confiscation of our political rights . . . Confiscation of our economic rights the right to hold private property . . . Confiscation of the value of our money . . . Confiscation of our gold . . . Confiscation of what money we have left through the progressive income tax . . . and, finally, Confiscation of our sovereignty and our nation.

Dan Smoot has expressed it this way! (we are caught in) "a pincers movement which can destroy the whole fabric of government and social organization in the United States, eliminate the sovereign states as meaningful political entities, and divide the nation into Metropolitan regions (or Soviets) managed by appointed experts, who will be answerable primarily to the supreme Soviet in Washington, which will provide most of the tax money".

The lower jaw has two prongs: . . . A) Metropolitan government — the political phase; . . . B) Urban Renewal — the economic phase . . . and at the top is World Government.

For full comprehension of both Metropolitan (Metro) government and Urban Renewal, it is important to understand precisely the meaning of "Soviet". "Soviet" refers to political government under a governing council in association with a Commissar, or manager, or executive authority. Here seems to be the system planned for the United States: It envisions town satellites (village Soviets) controlled by a local city manager and a village council (political parties are prohibited in the election thereof). Then a county Soviet (Metro) with its County manager and its non-par-

tisan council (County Commissioners). Next the Regional Soviet (a State might be divided into 4 regions) with its Commissar and Council. Then the District Soviet (a world map shows 12 such districts covering the entire United States — although I have here copy of a map from the August 1958 issue of HARPER'S MAGAZINE showing 15 great super-regions which "are rapidly changing the human geography of the entire country").

Over these districts will come the Union Central Executive Committee (whose seat probably will be moved from Washington to Chicago) — and over all will be the Supreme Soviet of the World.

What a set-up for world-dictatorship — and the destruction of freedom! 1) Now as to Metropolitan Government — the political phase — the first prong of the lower jaw, I quote from the Newsletter CLOSER-UP of August 8, 1958 as follows:—

"The UN Charter has superseded the Federal Constitution, but State Constitutions cannot yet be ignored. The executive went as far as it dared at Little Rock; any more flagrant move would be called dictatorship. The Supreme Court has reached an impasse — until the temper of people has cooled. World Government moves from the top must be slowed, lest the people rebel. But moves from the bottom, grass-roots level, can be speeded up. Hence the rush to destroy State Sovereignties at the local level. Super-Metro is the Planners' ace-in-the-hole. Beware of every out-of-town planner who comes to your community".

Merging is the basic pattern of Metro . . . A) Metro is NOT "home rule" . . . B) Metro does NOT reduce taxes . . . C) Local spending increases . . . D) Its Charter (as illustrated in Florida) establishes a "Metro" Court — staffed by appointed judges — thereby placing in jeopardy the Constitutional rights of all citizens . . . E) Metro has the power to control business franchises . . . F) Metro has the power to abolish elective offices . . . G) Political parties are to be abolished . . . H) The "Metro" Manager is all-powerful — need not be a resident . . . I) Finally (if we can understand it) here is the definition of "Metro" as issued by Rollins College, Fla.

"The Metropolitan region is a design for human living which provides for the continuity of man's total experience within its area".

2) Urban Renewal — the economic phase — is the second prong of the lower jaw. It is a program of legalized thievery for the confiscation of private property by trickery.

Again quoting from Mr. Smoot — well-known commentator, news analyst, and former F. B. I. official:—

"Urban Renewal is NOT slum clearance. It is a federally financed program of city planning which requires city governments to seize homes and other private property from some citizens and resell them, at below cost, to real estate promoters and other private citizens for developments that the city planners consider desirable.

"Under the ancient right of eminent domain, city governments do not have the power thus to confiscate private real estate. Laws giving cities such power would (before 1954) be unconstitutional. But in 1954 the Supreme Court said that Congress and State legislatures can do anything they like to the private property of private citizens if they claim it for the public good. Since that court decision, Urban Renewal has become a major national movement with frightful implications and dangers."

This confiscation of private property is no casual matter, but a majority of people don't understand this, and remain apathetic — mass protests are not heard, and the steamroller moves along. However — look at it through enemy eyes:— A) Theory of the Communists may be summed up in a single venture:

"Abolition of private property"—that's Marx and Engels; . . . B) "As long as Capitalism remains we cannot have peace — a funeral requiem will be sung over the Soviet Republic or over world capitalism" — That's Lenin speaking — significant because there can be no Capitalism without private property; . . . C)"History is on our side — we'll bury you" — that's Khrushchev; . . . D) "War to the hilt between Communism and Capitalism is inevitable" — Manuilsky, one time presiding officer of the U. N. Security Council.

We are engaged in that war today — the hottest war in history. How many know that the Steel Companies, by accepting the equivalent of a government-dictated agreement, may have saved all Industry — that a Bill was already prepared directing the President to seize and operate all plants considered "necessary to the National Defense and Economy" that had been closed by a labor strike — providing further that all profits accruing under government management would be paid to the U. S. Treasury — and that further legislation was planned to write seizure power into the Taft-Hartley Act — providing government seizure in case of a lengthy strike if the President decided that such company or industry was "necessary to the National Defense and Economy."

What (other than may apply peculiarly to the human element in the Supreme Court itself) can account for the strange Court decisions that generally have paralyzed our defenses against the Communist take-over? The fact is that since 1945 the Supreme Court has predicated its infamous decisions on The United Nations Charter, the Universal Declaration of Human Rights, and the Genocide Treaty — and every article of these instruments affects, conveys, paraphrases, alters, abridges, amends, and alienates every article or amendment of the Constitution which guarantees without exception every basic right to the Federal government, to the States, and to the people.

In other words, the Constitution has been superseded — (in practical language and effect — liquidated) — Here is the crux of the situation. What are we going to do about it? That is the \$64 question — but, in any event, I can promise no help from the President.

The following is part of a Fourth Quarter Report of the "Intelligence Agency SPX Associates" of East Stanwood, Washington:

"In charts of the Communist Global Conquest (with specific reference to the area of multiple surrender to the enemy) his performance pattern (persistently maintained and marked by recent expansion) has revealed these solidly documented facts:

- "1.) The current occupant of the White House has done nothing and will do nothing by word or deed, seriously to damage or arrest the progress of the Communist Global Conquest".
- "2.) Conversely, by his decisions and actions (or refrainments) he has done much to help it, directly or indirectly, at critical times and places".

This "Report" is supported by a listing of 21 massive citations of high treason — unprecedented for callousness, effrontery, and grandeur of scale. In other words, the President of the United States is working for the enemy (he is working, and has been for at least 14 years, and will certainly continue — with probable increased effectiveness). SPX — Soviet Principle of Warfare No. 10 — (the use of paralysis to conquer without a fight) is thereby made decisive, to wit: "The ultimate objective in warfare is NÓW destruction of the will to resist in ADVANCE of perceptible hostilities". — Soviet Revision of Clausewitz's U.O.

4. INFLATION:

This is a tremendous and complex subject, and almost everyone has his own idea about it. So it should be approached with caution, especially because of dilemmas, misunderstandings, pitfalls arising from difficulties in precision of language, etc. Actually, there are 8 different types of inflation, each of which can have several causes. The steel strike recently stirred the American people deeply because they sensed its impact on the national economy — to bring prices up and lower the value of the dollar (from which no one has anything to gain). This is one kind of inflation—wage inflation—that is deadly serious. But I am directing your attention to another kind of inflation—fiat money, or so-called legal tender PAP-ER inflation—that is the primary responsibility of the government and can be measured in terms of government deficit spending. As we stand today it far overshadows every other kind (probably all others put together). This puts the matter bluntly and places the blame where it belongs. Our common enemy well knows the meaning of inflation and has so expressed himself;

- 1. From Lenin "To create revolutions, wreck the currency".
- 2. From Major Angas of Saxtons River, Vermont (an internationally recognized authority:— A) "Russia's declared objective—inflation in the United States—B) America is now entering the last stage of wild inflation—the Wreckage Stage—when the patient becomes a nervous wreck, who eventually collapses."
- 3. From the Los Angeles "Herald and Express", September 15, 1959: "Anyone should know what printing press money means. It means the end of the dollar"; . . .
- 4. From "The Wall Street Journal": "Time has caught up with a prodigal country. For more than a decade we have spent money like the proverbial drunken sailor. We have poured out billions for farmers, veterans rewards, housing luxuries, any sort of welfare that came to mind. We have poured billions all over the globe with blatant disregard of the deficit people high in government and some economists cheered the action".
- 5. From the American Economic Foundation: "When the Federal Government needs money, it can put its I.O.U.'s into the banking system and cause the banks to CREATE brand new unearned money paper money that is counterfeit money without foundation other than obligations of the government taking on value only by taking away part of the value of existing money. It is money taken away from the people, because when it is spent, the value of the people's money goes

down by approximately the same amount".

- 6. Dan Smoot comments as follows: "By the Act of 1934, which abolished the gold standard, Roosevelt by one stroke confiscated 40% of the savings and investments of every person in the land. Between then and 1939, he further cheapened the dollar by adding \$39 billion to the national debt. Comparing the purchasing power of the American dollar in 1958 with the same purchasing power in 1933, you will find that the American dollar has depreciated by about 75% in 25 years. The Roosevelt economists developed theories and arguments showing that 'inflation was good for our economy at about 3% per year.' Economic ruin is now a dreadful eventuality which every American under the age of 60 can anticipate in his lifetime!"
- 7. Paul Bakewell, Jr. well known attorney of St. Louis has written a book titled "Inflation In the United States". Concerning this volume, Mr. Towner Phelan, Vice President of the St. Louis Union Trust Company, has the following to say:—
 - "Mr. Bakewell shows with irrefutable logic that the substitution of managed money for gold coin, and for managed money paper convertible to gold coin on demand, makes possible an almost unlimited inflation, and that this is mainly responsible for the economic situation which has developed in the United States since 1933. Under the gold standard, people control their government because, when they lose faith in government spending and fiscal policies, they can demand gold coin and thereby bring sufficient pressure to bear on the government to force a reversal of unsound policies. But with irredeemable paper currency such as we now have under managed money, there can be no effective control of political spending, and no control can be exercised over inflation spirals so long as the government finds inflation the path of least resistance politically".
- Mr. Bakewell himself remarks:—"Ours is a fiat money system." "The government can cause a colossal inflation. There is no instance in history where a government which has caused a colossal inflation has ever corrected it and restored sound money. Every government in history which has caused such an inflation has been overthrown".

The conspirators managing our crisis know this — and are prepared, to wit: A world currency (backed by gold) — along with a world government, a world law (not American law), a world police force, a world economy, a world religion, a world culture, a world society, and a world race. I do not know where your place might be, but will say this — that liquidation will be the alternative to

adaptation. Just think of it — all this — the resources, the finances, the manpower of the world — in the hands of a few (and their designated successors) for untold and unknown time. Is it worth the sacrifice of your country?

5. TAXES—

One of the steps taken with the advent of the New Deal (pursuant to a revolution of retrogression and darkness) is briefly but succinctly set forth by Garet Garrett in his book "The People's Pottage" (published by The Caxton Printers, Ltd., Caldwell, Idaho), as follows:—

"A scheme of taxation, class subsidies, and Federal grants-in-aid calculated in fact to reduce millions of citizens to subservience, bring forty-eight States to the status of provinces, and create in the executive principle a Supreme Government"

My previous discussion gives some indication of the tremendous successes toward these objectives.

Karl Marx in "The Communist Manifesto" published in 1848 listed the steeply graduated income tax system as one of the 10 main weapons of Communism. Now (quoting from Dan Smoot) see what happened - "The Federal income tax law of 1914 gave the government unlimited access to wealth and, in addition, power for the first time to levy taxes not for revenue only, but for social purposes. Many Americans now know that the progressive income tax system (the kind we have) was designed by Communists as a means of destroying private capitalism, arbitrarily confiscating the wealth of the citizens and overturning the existing basis of society. Americans were sold on the scheme because it appealed to their greed. Here was a way to soak the rich - something which appeals to almost everyone who is not rich - and those who are not rich outnumber those who are. But several things should be noticed about that system. It does soak the rich, and everyone else — particularly those who have a hard time making ends meet. It has enabled the Federal Government to grow into such a Frankenstein of power and complexity, that controls and safeguards and economy are quite impossible. Americans making less than \$5,000 per year are taxed billions per year to subsidize Communist and Socialist rulers abroad, to provide foreign aid and contracts to big industries, to subsidize air-lines, to pay lush subsidies to big farming syndicates, to pay the salaries of millions of well-paid government employees whose activities are so vast and extensive that no one on earth knows how to effect economies or savings. It should be obvious that the only thing we can do to keep this monster from consuming us is to eliminate it. It is beyond all possibility to reform."

I intend to show that it can be eliminated — and how to do it. Legislation is pending — but favorable action can come only by popular support — only the people can assure their self-defense and survival! Action we must have — words, explanations, conferences, letters, petitions — all are of no use without passage of the necessary corrective legislation. Well does the enemy know it — Heavens: — He's entrenched in the halls of Congress itself!

In the Congressional Record (85th Congress — Tuesday, February 18, 1958), the following remarks were made by Congressman Ralph W. Gwinn of New York (in recording the testimony of Willis E. Stone).

"Mr. Speaker: Last session I introduced a proposed amendment to the Constitution — House Joint Resolution 355 — designed to get the Federal Government out of business in competition with its citizens. It provides that the United States Government shall not engage in any business, professional, commerical, financial, or industrial enterprise except as specified in the Constitution.

"If this language were adopted as an amendment to the Constitution, the savings from it would, it is claimed, make possible the repeal of the individual income tax. The claim may seem fantastic. But I can find no one in Government who can dispute it. Congress certainly cannot dispute it".

Mr. Gwinn refers to the Proposed 23rd Amendment, which summarizes years of research by Willis E. Stone of the National Committee For Economic freedom of Los Angeles. It has been demonstrated that a reduction in the cost of government must be associated with any program for cutting taxes, and that the most promising area for such reduction is that of Federal corporations, everyone of which is illegal, existing without any pretense of constitutional authority. They absorb about half of our tax dollars, and have already taken over 40% of the land area, and 20% of the industrial capacity of the Nation. These enterprises are costing the American taxpayers a loss in excess of \$28 1/2 billion per year. If they were returned to the people, this loss would be transformed into a minimum gain of \$1 billion, and it would not be necessary for any citizen of the United States to pay any personal income tax (or any tax on estates, gifts, or inheritances). Benefits to the people would be tremendous (including 15% to 20% more money to spend for things, or services, or savings). We could balance the budget; the national debt itself could be paid off in some 25 years; and the government would be restored to a solvent position. At the state level, tremendous amounts of property would go back on the local,

county, and state tax rolls. (For example, Federal agencies own 45% of the land area of the State of California), These are some of the enormous benefits that can come to the American people . . . Here are the provisions of pending House Joint Resolution 23.

- Section 1. The Government of the United States shall not engage in any business, professional, commercial, financial, or industrial enterprise except as specified in the Constitution.
- Section 2. The Constitution or laws of any State, or the laws of the United States shall not be subject to the terms of any foreign or domestic agreement which would abrogate this amendment.
- Section 3. The activities of the United States Government which violate the intent and purposes of this amendment shall, within a period of three years from the date of ratification of this amendment, be liquidated and the properties and facilities affected shall be sold.
- Section 4. Three years after the ratification of this amendment, the sixteenth article of amendments to the Constitution of the United States shall stand repealed and thereafter Congress shall not levy taxes on personal incomes, estates, and/or gifts.

More than 6.000 organizations have adopted resolutions in support of it... At least ten States are cosidering it with a view to enactment of identical resolutions (some have already acted favorably). . . These resolutions must be identical in all the States for purposes of a constitutional amendment.

Frankly. I have never heard a valid argument against this amendment. Under the circumstances, the following comments seem to be in order:—

- 1. Compromise is obviously impossible it is unnecessary—in the circumstances of our time, it spells disaster!
- 2. The graduated or progressive personal income tax must be eliminated.
- 3. No issue of national defense is involved the Defense Department is maintaining over 19,000 business, commercial, and industrial establishments in direct competition with private enterprise which are absorbing directly or indirectly for their development and maintenance over 1/2 of the total Defense Department appropriation.

- 4. This is no issue of policy that involves laissez-faire there is no room for surrender in war!
- 5. No substitute tax is necessary to make up for the personal income tax lost to the government through getting the government out of competition with private enterprise, a greater amount will be saved by that government.

So there you have the story of what is happening to our country. Clearly something must be done — and a beginning made —

- 1) We must get back to the Constitution. . . . 2) We must put our financial house in order A) Get back to the gold standard to American currency backed by gold and B) Return to our people the constitutional right to own gold
- 3) We must abolish the personal income tax. Settle the money question and you will go a long way toward settlement of all our problems. Failure to settle it means failure to survive as a free nation.

Are you equal to the challenge? Your country, your future, and your freedom are at stake. Barry Goldwater recently summarized the case when he said:—"The American people have never failed when freedom has been challenged. And what hangs in the balance today? Not just this or that political party, not just this or that system of government, or economic system or social organization—what is at stake in the mid-years of this century, what we will nobly preserve or meanly lose, are the dearest persuasions of 6,000 years of history. What is at stake is love, honor, justice, truth and man's understanding of his relationship to Almighty God. These are the component parts of freedom."

Supplement A

The speed and importance of certain current events impel me to urge attention to immediate critical aspects of the movement for world government.

- 1. The Humphrey and McDowell pending amendments probably to be killed due to quick and effective protests of citizens. These amendments would give specific overriding authority to the World Court in precedence over our independence and sovereignty.
- 2. The treasonable Clark Concurrent Resolution 83 design-

ed to peacefully transform our nation into a Socialist Republic within a Socialist world government by changes in the U. N. Charter for the promotion of World Peace Through World Law so-called,

N. has proved to be a complete failure, and is totally ignored as a peace agency by every nation save the United States — for such reasons the one-worlders are resolved that they are going to make the U. N. work, even if every last vestige of American freedom and American honor must be sacrificed — even if the whole world is plunged into another Dark Age to make it work".
