FOREWORD - by MYRON C. FAGAN

Originally, we had scheduled this (March) "News-Bulletin" to be an up-to-date revelation of "HOW HOLLYWOOD AND TV ARE BRAINWASHING OUR PEOPLE"—and the good Lord knows it is high time for such a revelation, because even at its worst in the years gone by Hollywood and TV were never as seething and crawling with Reds as they are today—never have both industries been as brazen with filth and outright treasonous propoganda as they are today.

But from the very day that our last issue (No. 102) came off the press we have been deluged by requests for clarification of various of the statements in that issue—particularly that warning that our 1964 Presidential election could be, and might be, cancelled by Lyndon B. Johnson. People ask: "How could he do that? . . . What kind of powers can he use to accomplish it?" . . . And they point out that under our Constitution he has no such powers. Which, of course, is true—as far as our Constitution is concerned . . . the President's power to cancel an election is definitely outside of the Constitution, but, tragically, our Congress has provided such powers, as you shall see.

The urgent requests for that information and for clarification of other points reached such a volume that, after discussing it with the author of the No. 102 "News-Bulletin", we decided to use this issue to complete that Report.

As I pointed out in "News-Bulletin" No. 102, because of the nature of that "Report," the name "John Hancock" was a pseudonym in order to protect a veteran journalist of 40 years who has spent most of the last 15 years analyzing the international Communist Conspiracy. The use of the pseudonym for this "Report" is governed by the same reason.

A nationally-recognized authority on communism, he "John Hancock" was perhaps the first to recognize the deviation in the party line from Trotsky's violent overthrow to Khrushchev's takeover by infiltration into the governments of the world.

He maintains there is no split in the Communist Party, but that the pretended "split" between Russia and China simply is subterfuge to confuse patriotic peoples and to insure the success of the infiltration movement until communism dominates the world.

In spite of the fact many commentators still refer to communism as an ideology, he also was among the first to insist communism is not an ideology, but a criminal conspiracy in which any means justifies the end, a fact which explains many of the seeming acts of contradictions on the part of the Communist Party which simply are not contradictions. Instead, they are carefully-calculated moves to create confusion.

His Report in this issue will cover nine salient points which are dovetailed to advance the conspiracy regardless of whatever label the conspiracy happens to carry at the time.

Covered are the maneuvers on disarmament, gun registration, racial hatreds and demonstrations, aid to the Reds, the war on poverty, our appeasement policy, a background on President Johnson, brainwashing by newspapers, movie and the TV industries, and how "The Dallas Story" fits into the entire picture.

THE FINAL STAGES OF THE CONSPIRACY

PSYCHOPOLITICS is the art and science of asserting and maintaining dominion over thoughts and loyalties of individuals, officers, bureaus and masses and the effecting of the conquest of enemy nations through "*mental healing*" . . . *This definition comes right out of Moscow.*

In the training of psychopolitical operatives by the international criminal conspiracy, the main objective is to develop the technique of the operatives to bring about a mass state of mind in which the masses of the world believe that the opposite of truth actually is the truth. This is the only way an international criminal conspiracy can fool and dupe men of freedom.

It makes little difference whether the psychopolitical method is employed by the international communist conspiracy, the socialists, the one-world government advocates, those who believe in the world rule by law, the United Nations, the liberals, The Council on Foreign Relations, The Metro Club, better known as the 1313 Club, or those who profess to be promulgating rule by democracy.

These are merely different labels which apply to the one conspiracy to present the image of separate and disconnected groups. However, they all describe the same group which is dedicated to the same goal . . . world control of all peoples by an atheistic rule which snipes at free men behind the fraudulent labels of humanists, democracy and liberalism.

This is why I have no use for political labels because the "*label*" is one of the most devastating tools in the hands of the criminal conspirators the world over, including many who at this moment are in ruling positions in America.

That this group of international criminals are succeeding is evi-

denced daily by the acceptance of historical frauds as truth; by the belief that black is white; by the acceptance on the part of the majority of the "big lie" technique which not only perpetuates the greatest historical fraud known to man, but also keeps the blindfold over the eyes of the majority and prevents the majority from seeing the truth.

However, the greatest harm is in the fact that it permits the criminal conspiracy within the United States and in other lands to continue its conquest of the world population under the guise of humanitarianism by duping otherwise good Americans to the cause of the conspiracy.

Slightly more than 60 days have passed since I issued the warning that 1964 could see America's first cancellation of a presidential election under the guise of "*the interest of national safety.*" It was published by the Cinema Educational Guild this past February.

Since then and up to the time of this writing just prior to the end of March, I have hoped and prayed I could be wrong. I had hoped that somewhere along the line I had mis-interpreted the news of the day and the aims of the powers-that-be.

However, the events of the last 60-some days not only have failed to prove me wrong, but have strengthened the belief that we are in the final stages of the complete and final takeover of all free peoples of the world. What develops will substantiate this statement.

This is being written during the period known religiously as the era of resurrection when Christ arose from the tomb and proved conclusively that life is eternal, everlasting and immortal. However, more important than this, Christ proved this eternal life is ours, too, each of us, and does not apply only to Himself.

The significance of this fact is this:

All of us are experiencing an eternal life which cannot be ended. Only our stay on this level of existence can be terminated, but not our life. It continues eternally and the "big lie" cannot disprove this.

However, belief in just the opposite is the one main weapon which the psychopoliticians of the international criminal conspiracy are using not only to recruit fools to become psychopoliticians, but also as the one weapon to whip the masses into submission and to help them make the "big lie" technique succeed. How else could intelligent Americans be duped into believing only a fraction of the "big lie" and become brainwashed?

Psychopolitical teachings of the conspiracy foster the fraud that man "*is a stimulus-response animal; even his ethics and morals*

depend upon his stimulus-response machinery". This is why the stupid fools who control this international conspiracy can advocate the following:

"The end thoroughly justifies the means. The degradation of popu- laces is less inhuman than their destruction by atomic fission, for the animal who lives only once, any life is sweeter than death."

At this point it is fairly obvious to you that the international criminal conspiracy considers only two alternatives for mankind—either total control by a few—or death by destruction.

The conspiracy ignores completely a third alternative—the teach- ings of the Greatest Teacher of all times—the Master of all men— whose resurrection we celebrated last month. Remember, it was Christ who said:

"I have come that you may have life and have life more abundant- ly . . . "He who shall live and believe in me shall not die."

This is so because man is not the animal the conspirators would like us to believe. Man is the son of God—a spiritual being!

This is the path which will lead us out of the wilderness of con- fusion which we are experiencing today. And, in spite of all the hopelessness which the news of the day gives us, this is the path which will lead us to our resurrection and enable us to destroy this criminal conspiracy. It might take years, but our success is inevitable.

In spite of all the gloom which this report will raise while it unfolds, this is the path which will lead us to the light of under- standing and help us to see through the conspiracy's brainwashing methods. It will—if we keep in mind Christ's teachings of:

"No man of this world shall have dominion over you. Only the Father which is in Heaven." . . . This is so because man is not an animal—he is the son of God!

I have resorted to this lengthy introduction to this month's report because it is vital to your understanding of how to interpret the news of the day and see through the fraud which our officials are selling us as the truth.

Before you proceed into the portion of this report which deals with what has happened during the past 60 days and what you can expect in the next six months, study this introduction. Absorb it until its meaning becomes part of you. Then you will find it easier to digest what is to follow.

One more point must be cleared up before moving to the cur-

rent events of the day. It has a direct bearing on the psychopolitical war which has been waged against free men for the past 50 years.

Although it began early in the 20th century, you experienced a recent application of this great historical fraud when the liberal element in America headed by Chief Justice Earl Warren and his ilk, including the "Voice of America" broadcasts, attempted to brand all of Dallas, Tex., guilty of the assassination of President Kennedy.

That this line was picked up by the international criminal conspiracy need not be repeated here because our American liberals are part and parcel of the total conspiracy. The line, however, was carried around the world by the stooges of the conspiracy . . . Had it succeeded, it would have placed a blanket of blame on all patriotic Americans in every city of the United States . . . All that was necessary was to have the "Dallas Guilt" accepted and it would have spread to include every patriot in every section of America.

It would have been the one fatal bullet fired into all patriotic causes and give the conspiracy complete and free reign to destroy all opposition and guarantee the successful takeover of America!

This is the primary reason why President Kennedy was assassinated by his own conspirators who sacrificed his earthly life in the hope that his elimination also would eliminate all opposition to the conspiracy.

But for the grace of God, it would have succeeded. However, the plan failed and patriotic Americans were given another opportunity to regroup their forces in the all-out fight against the conspiracy.

Now, was this a stroke of chance?—or is there a precedent for such action?

What we are being taught as history tells us there is a precedent! Honest historians and educators, who have not sold their souls to the devil psychopolitician, will verify this:

While Kaiser Wilhelm was covered with the blame for starting World War I, in reality it was the international communist conspiracy which forced such conditions to prevail which made war a natural outcome, with the Kaiser being blamed entirely.

In 1939 while Hitler was given the total blame for launching the greatest destructive war in history, the mechinations of the war actually were precipitated by international conspirators mostly from the United States, England and France in conjunction with Russia.

Both wars were started for the same reason: complete and total control of the world population by the conspiracy!

In 1914, the main objective was the same as 1939—to set up a

world organization which would pose as a peace organization, but actually camouflage the one instrument for mind control. Today you know the first organization as the "United Nations" and its arm of destruction as the "United Nations Educational, Scientific and Cultural Organization" (UNESCO), a vital part of the conspiracy which controls all of our schools.

During the reign of the Kaiser, the world control unit was to be the "League of Nations." When it failed, the instrument of mind control was placed in safe keeping in Geneva to be resurrected in its complete form as the damnable UNESCO in 1945 (See *News-Bulletin No. 86.*)

Bringing this to light in no way is to be construed that I am in sympathy with Hitler's Nazi Socialist Party, but the conspirators will attempt to make it read that way. The above has nothing to do with political ideology, but only with historical truth. I in no way at any time approved of Hitler or his methods. My only allegiance lies in maintaining historical truth and in a government ideology such as the Republic of the United States in which each person is free to live and think as he pleases as long as he denies no one the same equal rights. This is the teaching of Jesus Christ.

And no one should assume I am blaming minorities for bringing about the two wars and for perpetuating the great historical fraud. I am blaming the total international criminal conspiracy by whatever label it chooses to wear. It matters little to me who belongs to the conspiracy. What matters only is what the conspiracy is doing and how we loyal Americans can stop them.

Now, in addition to setting up a worldwide organization, the conspiracy also succeeded in forcing Germany to pay reparations to some minorities at the same time Germany was deprived of its rightful property. This, naturally, served to drive the "guilt" in deeper.

The second war also made it possible for the conspirators to divide Germany, *a needless concession to Russia at the time*, to create a focal point for international crises and to hold the threat of nuclear war over the world. And in blaming Japan along with Germany in World War II, the Japanese bastion against communism in the Far East was destroyed to make possible the communization of China, placing 600 million Chinese under communism. This also provided a second focal point for continued crises and a perpetual threat of a terminal nuclear war in Formosa.

And it is from these two avenues that almost all of the international crises stem. This is vital to correctly analyze the work of the conspiracy.

Knowing this, now, it is clear what the liberals had in mind when they attempted to place the blame of Kennedy's assassination on patriotic Americans, when, in reality, the liberal conspirators ordered Kennedy to his own execution on Friday, Nov. 22, 1963.

Before going into the attempted Dallas Fraud more deeply, a look back during the past 60 days will give us an insight into the workings of the conspiracy and how the brainwashing is moving into the final stages—*mostly as a result of the murder of the chief spokesman for the international criminal conspiracy in America, John F. Kennedy.*

If you recall, the February report said more and more crises would be created worldwide to keep you confused; more political and racial hatreds would be stirred up to force the registration of all guns in the United States. This is exactly what has happened on all fronts.

In addition to fanning the winds of hatred to bring about the registration of fire arms which will lead to the cancellation of the 1964 presidential election, two very significant moves were made in March to speed up the final control of America.

The first is the proposal to give every American an adequate income whether he works or is unemployed.

The second is the resurrection of the one-world government idea by the World Federalists after a lapse of 16 years when it was exposed as an attempt at treason against the United States. (*See News-Bulletins Nos. 92 and 93*)

And the most significant factor of these two moves is the fact that both are being promulgated by the "*Fund for the Republic*" out of Santa Barbara, California—also known as the "*Center for the Study of Democratic Institutions.*"

This is the same organization, sponsored by the Ford Foundation and headed by McNamara before he became Secretary of Defense, which has advocated the elimination of our Congress in 1963 through the hypocritical mouths of Senators Joe Clark of Pennsylvania and J. William Fulbright of Tennessee.

If you have wondered why McNamara aids and abets the communist cause, you need wonder no longer!

But before analyzing these two moves and how they dovetail in with President Johnson's alleged war on poverty, study these developments of the past two days:

CIVIL RIGHTS—To begin with, this title is as false as the pro-

posal itself. Nowhere in the entire proposal on rights is there any measure of protection of rights for the majority of Americans, the Americans who have made this the greatest country in the world. It is, in reality, a denial of all rights rightfully ours under the Constitution of the United States—and is another attempt to eliminate our Congress.

If it is adopted as presented by Kennedy, and now urged by Johnson, it will create agencies which will usurp the powers of Congress in such matters as conducting investigations and then levying penalties. Under our constitution, only Congress has this power.

The main purpose of the alleged Civil Rights Bill is to create federal control over most every facet of our private lives by denying the majority its basic rights and placing control in federal agencies.

Since February, look at what has happened and what the conspiracy-controlled leaders have promised for us in the months to come.

Jacksonville, Fla., has witnessed four days of rioting which are only a sample of what's ahead. Three were killed and damage was estimated in the millions. How in the world can any minority claim it has the right to kill and destroy property of others?

Racial strife was registered in Atlanta, Los Angeles, Glenwood, Miss., Phoenix and Tallahassee, just to mention a few.

What is important on this crises-producing front is the remarks made by three conspiracy-controlled leaders.

Martin Luther King, who poses as a man of God, but preaches hatred and violence, said: "*Racial demonstrations will reach record proportions this year . . . demonstrations on the size and level never seen before. Beginning next month (April), demonstrations will begin in Alabama and fan out to engulf the nation.*"

Malcolm X, in a New York Times story in which he urged negroes to form rifle and shotgun clubs "*because they are legal and we believe in obeying the law,*" and added this ominous warning: "*Negroes are ready to act in self defense against white brutality. The time has come for the negro to fight back.*"

And a negro youth leader whose name escapes me at the moment, told a nationwide TV audience: "*Some of our people will not accept non-violence. We are being prepared even if the Civil Rights bill is passed. Its enactment and enforcement will cause civil war in the south and racial battles in the north.*"

The significance of these statements is clear. The conspiracy will

resort to mob rule to a far greater degree than ever before to take by force, if necessary, your rights and mine. At the same time, it cares little for the welfare of the Negro minority.

All three are giving the conspiracy added reasons to enact a gun-registration law—*which is the real purpose behind the creation of racial strife in America!* All three are playing their part in the blueprint for a takeover as described about five years ago in the communist mouthpiece, *"The Minority of One,"* a newspaper allegedly published in New Jersey.

In this article, the takeover blueprint was described in three steps. The first was parades and picketing to draw attention and publicity to the cause of the conspiracy, but in the *"image"* of helping the minority to a better way of life.

The second was sit-ins and any other form of *"ins"* the diabolical minds of the conspirators could dream up. You have witnessed many of these already under the hypocritical guise of non-violence.

The article, however, admitted neither method would work, so a third and final alternative had to be employed. This third and most frightful to any law-abiding American is this:

"Boldly march in and takeover all means of communications, government offices and businesses and industries which are essential to the operation of the government."

Now, to make this final step work, the paper's editor added, *"riots, fires and strife of all sorts must be created to keep the police, firemen and any other enforcement body busy while the takeover is being carried out."*

This is one of the reasons I can say we are in the final stages of the takeover. The conspirators have said so themselves, by words and action. They are following their well-laid plans on schedule.

We already have moved through the first two stages. The third and final is in preparation now on all fronts.

All that is needed now is to pull the loose strings together to form the rope which will hang us all if we don't fight back. Here is how it is being done:

GUN REGISTRATION—Sen. Tom Dodd is intensifying his hearings on the necessity of arms registration. The disarmament conference in Geneva is doing the same on a wider scale. More stringent moves to bring this about will unfold as more racial and political hatred develops on our national front.

Internationally, more crises will develop to give the impression the world is on the verge of a nuclear war, just as Kennedy did in 1962 over the Cuban farce. That scare, too, was another fraud.

Richard M. Nixon, who supposedly is traveling worldwide for a softdrink firm, in reality is making the tour of world capitals in the interest of "*World Rule by Law*," a diabolical instrument which ties in with the World Federalists' attempt to establish a one-world government.

Nixon is listed in the congressional record as the top leader in America for the "*World Rule by Law*" group. This is why he took the position with the New York law firm which also operates out of Paris and Washington, D.C. Paris already has been picked as the sight of the first international headquarters of "*World Rule by Law*."

The World Federalists, who operate out of Santa Barbara's Fund for the Republic headquarters, are a part of this "*World Rule By Law*"—and both factions also are a part of the disarmament conspiracy which is dedicated to the need for arms registration.

WHEAT SALES—While Americans are being told wheat sales to Russia is an humanitarian gesture to help starving Russians, this also is one of the strings helping to form the hangman's rope. Representative Bill Stinson, of Seattle, told the House of Representatives in a recent speech that Russia is using our wheat not only for nuclear bombs, but also for all kinds of weapons of destruction.

Stinson used the statistics of the Russian government to prove to his fellow representatives that Russia has enough foodstuffs of its own to feed its people. He disclosed that our wheat is being used to produce 800,000 tons of alcohol from which the Russians will make atom bombs, poison gas, TNT, hand grenades, nitroglycerine and other explosives, as well as rocket propulsion fuel.

This, mind you, while our conspirators in the nation's capital tell us we must not only disarm our country, but ourselves as well!

WAR ON POVERTY—In a recent proposal, Johnson advocated the drafting of 17-year-olds into glorified Civilian Conservation Corps to alleviate the job shortage. Here again is another hidden attempt to enforce federal regimentation and control over the most vital sector of our manpower, *a factor which is necessary before any conspiracy to takeover America is successful!*

In conjunction with this hypocritical war on poverty, the "*Fund for the Republic*" advocates pay for everyone whether he works or not. This, too, is needed to complete the hangman's rope because when you have this kind of a situation, you not only have commun-

ism, you also have complete and total control over every man, woman and child in America. *You obey or your subsistence is cut off!*

Now, how does the conspiracy, the "Fund for the Republic," say this can be accomplished?

By the following proposals . . . *Check them closely:*

1. *Massive program to build up the educational system:* Mind you, this in spite of the fact you will be paid for not working! Why study? In reality, this is another sneaky attempt to place all educational institutions, private and public, under the control of the communist-dominated UNESCO. Federal Aid to Education failed to do this, so this trick now is being proposed. Again, *total mind control is necessary to make the conspiracy work!*

2. *Massive public works programs:* Here is the group's hypocritical way of saying *slave labor!* Can you begin to imagine what will happen to your income when you relinquish all control to bargain for what you believe your services are worth? Of course you can. In time you will be forced to work for starvation wages to prevent you from financing a revolt.

This is guaranteed by the UNITED NATIONS "*Bill of Human Rights*" which states: "*Everyone shall be entitled to an economic status as prescribed by law.*"

See the connection? With World Rule by Law Controlling us all, we would be entitled to whatever wages the conspirators felt like doling out, *just as they do in all communist countries.*

3. *Program of low-cost housing:* This is the way you say Americans will live in communes, if you are a conspirator. You know what happens in communal living? Family living is destroyed. We are well on this road now as it is!

4. *Rehabilitation of obsolete military bases!* See how they say "*concentration camps*" to make you go into slavery willingly.

5. *Government license to regulate industry!* Who could be fooled into believing this is humanitarian? What else is it but complete and final control of all income-producing avenues to prevent any possibilities of a revolt being financed?

6. *A major revision in the tax structure:* And how else would the conspirators be able to gain control of the entire wealth of Americans? Under this plan, you would be taxed out of house and home. This measure also would make it virtually impossible for any successful revolt to be staged once the conspirators were able to pull

all of the above-mentioned strings together. All of us would be powerless to resist.

If all of the other plans failed, this last one alone could bring about the downfall of the American Republic before most of the sleepy Americans knew what had happened.

Now, just one more string before moving into the portion of this report which will help you to understand why all this is happening:

APPEASEMENT BY AMERICA—This is perhaps the most important step our conspirators must follow. It is important because this is the only way the international conspiracy can engulf America without a fight.

America must follow an appeasement policy if the conspiracy is to be successful. We have had an appeasement policy for a long time now, but not as openly advocated. However, the signing of the nuclear test ban has made this legal in the eyes of the conspirators, just as I had pointed out in the February report: *Now they can conspire "by law!"*

Now Johnson and Sen. Fulbright can boldly state so in public, but they still do so in a hypocritical vein by the use of semantics.

Johnson said just before the end of March we must follow "*reasoned agreement instead of ready aggression*" in dealing with our global problems. This is pure and simple appeasement of the enemy.

Fulbright, who perhaps is the most dangerous traitor in the U.S. Senate, said we must "*abandon old myths and face up to the new realities of our time.*" Another description of appeasement.

This man who has defamed the Senate of the United States by advocating its elimination, called for a prompt revision of the Panama Canal treaty and a new attitude toward Cuba, adding that "*Castro is a nuisance, but not a grave threat to the United States.*"

His declaration to destroy the United States followed those of Johnson by several days, just long enough for the American public to be conditioned to such remarks, but not soon enough to disclose the connection between the two remarks and the other incidents which indicate our freedom is in great peril if we remain apathetic.

Fulbright, who originally drafted the policy of appeasement we have been following for almost six years, must echo Johnson's policy of appeasement. How else can the conspiracy hide such U. S. failures in our foreign policy as Katanga, Laos, Viet Nam, Cuba and Panama? . . . How else can the State Department dismiss the fact that there are 847 *security risks*, the polite way to call a man a

traitor and a conspirator, busy in our state department to make sure we continue to suffer failures and setbacks in our foreign affairs? . . . And how else can America succeed in beating down the forces of freedom in Cuba, Katanga, Laos, Viet Nam and other places while helping communists to enslave the world?

Appeasement, my fellow Americans, is just another word which means neutrality towards the advance of communism. And neutrality is another way of saying *surrender* to this same sinister force.

This is what our leaders are asking us to accept today—the same leaders who swore solemn oaths to protect and uphold the Constitution of the United States, who now are leading us to submission to communism.

And this is the reason why we face the possibility of an electionless 1964. The conspiracy cannot take the chance of having the rank and file of American voters upset the conspiracy's applecart at this late stage of the game. They might not get another opportunity.

This is why, too, in the state of California, a determined effort is being made to keep the Rumford initiative off the June primary ballot.

As you know, this initiative is to repeal the Rumford act passed by the California legislature last year which takes away control of property from the property holder.

Harold Stassen, who aspires to be a Republican president of the United States, visited the Golden State recently and urged Gov. Brown to delay the initiative until November. The Democrat-controlled assembly also is attempting to do the same thing.

The motive is obvious. The June primary must be held to give the conspiracy additional time to pull together all the strings. But the November general elections can be cancelled by President Johnson if the takeover schedule isn't interrupted by that time. Johnson has the power in the "*Executive Decrees*" issued to Roosevelt during World War II, but which still have not been cancelled. This decree gives the President the right to usurp the power of Congress just by "*recognizing*" a national state of emergency. The weapon at his disposal is the innocent-sounding phrase "*in the interest of national safety.*"

Another indication of what you can expect in November is in the proposal still before the damnable and hypocritical organization called the "*United Nations.*" If adopted, the General Assembly will not be convened until "*after the November election date in America.*"

Here the implication also is clear. Should the conspiracy advance as scheduled in America, the organization then will be convened, not as the "*United Nations*," but as the UNITED NATION to enforce the one-world rule which is being set up now in Paris by Nixon and the World Federalists. This is one of the reasons France announced its recognition of Red China and why more and more of the conspirators in America are openly advocating the United States do likewise.

Why is all this possible in the greatest country in the world?

A look into the background of the man who now is President of the United States can supply some of the answers.

As you will recall, I stated in the February report that Johnson is attempting to present a "*father*" image to beguile you into trusting whatever he does. This theme already has been picked up by most of the nationally-syndicated columnists. More will follow later.

What is Johnson really like?

In an article published in a San Antonio, Tex. newspaper, "*The Texas Argus*", the editor recalls, in asking why Johnson has betrayed the trust of Texans, that when Johnson ran for his first public office in Texas, he had to have a co-signer to borrow \$75 from a bank . . . *Today, Johnson is regarded in some financial circles as one of the wealthiest men in Texas.*

The editor, Clyde Wantland, adds that "*as fellow Texans, we would be proud to brag about you and we would like to point with pride to your fantastic accomplishments, but we can't do this because of the sordid facts revealed in the scrutiny of your record.*"

One of the issues which Mr. Wantland points out is the "*infamous ballot box 13*," a political maneuver, *to say the least*, which started Johnson on the way to the White House.

It happened in 1948 after Johnson had completed his fifth term as congressman and contested the then governor of Texas, Coke R. Stevenson, to the senatorial seat.

Briefly, here is what happened, according to the Argus story:

According to the election tabulations, Gov. Stevenson had won the runoff election against Johnson by 213 votes after enjoying a 71,460 vote majority in the preliminary election.

In spite of this, Johnson went on the air and told the "*PROGRESSIVE PEOPLE OF TEXAS*" that he had won. (*There's that word, progressive, again!*)

Meanwhile, Luis Salas, presiding judge of ballot box 13, which embraces Alice, the county seat of Jim Wells County, reported that while he had been given only 600 ballots, box 13 showed a count of 768 for Johnson and 60 for Gov. Stevenson. He also said he did not have anything to do with the final tabulation, which was 238 ballots in excess of the number of official ballots he started with.

Johnson forces then impounded the box and held it safely in a bank vault. Stevenson attempted to have the box released for a recount, but Johnson obtained a court order in the District Court of Jim Wells County. In a subsequent hearing in the chambers of Judge Roy Archer on Sept. 10, 1948, the day the order was obtained, the injunction was issued without notice to enjoin Stevenson from obtaining possession of box 13 or forcing a new count.

This did not stop Gov. Stevenson, and when he was about to be successful in removing the injunction because of irregularities involved, Johnson obtained a Supreme Court Order, signed by Justice Hugo L. Black on Sept. 29, 1948, upholding the District Court's order.

As a result of this, Stevenson, in spite of the fact he originally held a 213-vote edge on Johnson, lost to Johnson by the slim margin of 87 votes.

The conclusion appears obvious. The excess of 238 ballots in Box 13 proved to be the deciding factor. And the irony of the entire case is noted in the fact that later, after Stevenson's defeat was ordered by the Supreme Court, Stevenson did get control of Ballot Box 13. But by this time, it was stuffed full of old newspapers and rubbish . . . *The original ballots, 600 or 738 as claimed, never were found!*

And from this came all the rest, including the fostering of such individuals as Bobby Baker, who started as a Senate page boy and became a millionaire with the help and influence of Johnson.

How is all this possible in a country which is supposed to have a free press?

The answer is obvious. A free press does not exist. Publishers who belong to the World Federalists are part of the conspiracy. Those who do not belong are powerless to expose the conspiracy because they fear government reprisals in the form of income tax investigations. It is as simple as this!

The press of the United States came under the complete domination of the government under President Kennedy. Today, the focal points of control lie in the New York Times, the Washington Post

and the Los Angeles Times. This is why stories can be front-paged and carry the central theme of the conspiracy on a moment's notice—or be dropped from the pages with the suddenness of one pushing a single control button.

The radio and TV industries have been controlled for many years. This is why smut and filth rivals hate and racial issues as the main course of entertainment or enlightenment on both outlets.

Fear dominates the airways today. It virtually is impossible to watch TV for several hours in the course of any day without getting a double dose of fear—fear of minorities—fear of majorities—fear of worldwide destruction by a nuclear war. Hate and distrust rival fear for prominence in an industry which is supposed to be dedicated to the American Way of Life. Under the guise of news coverage, the advocates of hate are given free reign on TV. Drama, which is supposed to be uplifting, highlights hate and fear—and pits one minority against the other to split up the majority into groups and factions who then become easy victims for the conspirators.

The movie industry, under the leadership of the late Eric Johnson, set the pace for the moral decline which America is experiencing today. Say what the conspirators will, this they cannot deny.

While major movies become filthier than any stag movie ever was, anonymous spokesmen for the industry hide behind the hypocritical statement that this is what the public wants.

They ignore completely the public's wish by producing only filthy movies, then have the brazen nerve to say, in effect, to the public:

“Whether you know it or not, this is really what you want because you want to see life in its rawest form but do not have the nerve to live that way. By seeing these movies you experience it vicariously and still maintain your morality.”

For the first time in the history of the “*great movie fraud*,” (the *Academy Awards*), all five top contenders for the best actress award have depicted roles on the screen in which morality has no consideration whatsoever. But, as the anonymous Movie spokesman will insist: *“this is what you want, although you are not aware of it.”*

The Academy Awards will have been made while this report is in the process of reaching you. However, morality cannot escape the mortal blow, because two of the actresses played roles of girls

who cared little for decency—one depicted a prostitute, another was an immoral wife, the fifth enacted the role of a landlady who was interested in collecting more than just the rent due.

The reasoning behind this is simple: No matter what happens, movie houses across the country can play up the fact that it pays to be indecent and immoral. *Didn't the Oscar Awards prove this?*

Then to add insult to injury, pictures such as "*Dr. Strangelove*" and "*Seven Days in May*" are produced to defame the military—and add another cause for disarmament and the conspiracy to be successful.

So much for the "*great movie industry of Hollywood*" which makes it possible for every girl to live a life of prostitution vicariously. This is real living, movie moguls will tell you!

The newspaper industry gave one of its greatest demonstrations of being centralized with its handling of the Kennedy assassination, the apprehension of Lee Oswald, the shooting of Oswald—and then the subsequent trial of Jack Rubenstein, the murderer of Oswald.

A research of newspapers during the past four months on the handling of these four incidents will disclose even to the most obstinate American that news is MANUFACTURED before it is managed.

Who the spokesman for this manufactured news is matters little because there are so many of them. What matters, however, is the motive behind the maneuvers.

In the first incident, news was manufactured and managed to prevent the general public from recognizing that Kennedy was ordered killed by his fellow conspirators. It is a known fact that among the communists, a live prisoner is worthless to the Reds until he becomes a dead martyr. And Kennedy certainly was a prisoner of the Reds who was stopped from carrying out his part in the international criminal conspiracy by determined efforts from conservative elements spearheaded by the Cinema Educational Guild.

The apprehension and shooting of Oswald was presented in such a manner as to confuse the average newspaper reader, again to hide the true fact that the assassination of Oswald also was just as much of a "*must*" as was the shooting of Kennedy and it, too, was ordered by the conspirators.

This is an old conspirators' trick. By creating an incident on top

of an incident, facts can be so muddled that it takes a near genius to keep them straight.

Oswald was murdered for another reason, too. He had to be prevented from talking in order to give the conspirators free reign to make any public statement they wished regarding the assassinations of the president and the assassin. This is actually what happened.

Now comes the murder trial of the murderer. Justifications become the rule of the day, not only to free the murderer, but also to legalize murder through the use of psychiatry, a pseudo-science at its best. Psychiatry cannot be recognized as a true science because psychiatry cannot establish a definite order of treatment or its application.

And to keep the entire nation from seeing the entire picture, never at any time is all the news transmitted to all of the nation at the same time. Parts of the nation are given some of the news the other parts are denied, and vice versa. This is similar to giving you a jig-saw picture to complete while the key pieces are retained by the conspirators.

As an example of this method, a research of the two major newspapers in Dallas will disclose important facts about the killing of President Kennedy which were withheld from other parts of the country. Insofar as the conspiracy is concerned, it mattered little whether the people of Dallas are convinced of the true facts. If they try to inform others, the conspirators can dismiss this simply as fantastic reasoning on the part of "*extremists who were responsible for the assassination in the first place.*"

This is the first principle in establishing a perfect crime. Immediately blame someone else and then continue to fabricate stories and evidence which upholds your accusation.

What are some of the facts published in Dallas which were kept in total or in part from the rest of the nation?

A week's research in Dallas produced the following:

- 1) Jack Rubenstein, alias Jack Ruby, went out of his way to set up an air-tight alibi for the time when Kennedy would be shot . . .
- 2) Dallas police reported that Ruby was sane and rational before and after his shooting of Oswald and was in complete command of his senses at all times . . .
- 3) Ruby was connected with the Chicago underworld and union racketeers while he was a resident of Chicago and after he moved to Dallas . . .
- 4) Ruby at one time was a neighbor of Oswald . . .
- 5) Ruby also used the gymnasium facilities of the YMCA in which Oswald lived for a short time before he made

his numerous moves . . . 6) A memory expert who performed in Ruby's club, told Dallas police Oswald was a customer of the club about nine days prior to the shooting of Kennedy, Nov. 22, 1963. *Oswald participated in his act* . . . 7) Oswald, who was supposed to be financially broke, made a trip to Mexico, received a large sum of money and purchased a car just prior to the assassination of Kennedy . . . 8) The FBI knew Oswald was a "*potential killer*"; knew he worked in Dallas; knew he would be working near a vantage point along the parade route,—and knew he was a member of the communist criminal conspiracy. However, neither the Dallas police nor the Secret Service were told of this. *This is one thing Bobby Kennedy should be made to explain to the public!* . . . 9) "*The Worker*," official newspaper of the Communist Party, in its November 26, 1963 edition, advocated the creation of an "*Extraordinary Commission*" to investigate the shooting of Kennedy—*and that this group be headed by Chief Justice Earl Warren!* Four days later, Nov. 30, 1963, President Johnson did just that! . . . 10) Gov. John Connally of Texas wanted to call off the trip by Kennedy. He made a special trip to Washington to accomplish this, but on his return, told his associates the trip would proceed as scheduled.

Ten vital points—and when they are analyzed and compared to the publicity newspapers and magazines across the nation carried, you begin to wonder if you are talking about newspapers in the United States or those of Russia.

Briefly, nationally-circulated stories stated:

1) Ruby was a fanatic fan of the President, which is why he was supposed to have shot Oswald. In reality, at the time of the parade, Ruby made it his business to be seen prominently in a Dallas news paper office working on an ad for his club—*of all things!* . . . 2) Accounts on Ruby said he was incoherent and could not remember what he had done at the time of the shooting. All he could remember was that his beloved (?) President was shot and he had to do something. Dallas police say the opposite . . . 3) Ruby was painted as a friendly cooperative and law-abiding citizen of Dallas who knew all of the police intimately. *Dallas papers recalled his underworld connections!* . . . 4, 5 and 6) Stories maintained Ruby never had seen Oswald until he walked into the Dallas Police Station and shot him. Dallas newspapers not only have Ruby as Oswald's former neighbor and a frequenter to the YMCA where Oswald lived, but also had Oswald as one of Ruby's patrons at his club . . . 7) Oswald's trip to Mexico was mentioned in most stories, but his financial matters and the car he received so mysteriously were played down, buried, or omitted from most stories . . . 8) Most newspapers carried the accounts of the FBI being unaware of Oswald's whereabouts at the

time, but Dallas papers contradicted this . . . 9) Few, if any, newspapers carried the account of the communist newspaper, "The Worker", advocating the investigative committee with Earl Warren as head . . . 10) Gov. Connally's attempt to have the trip cancelled was carried only in the Dallas papers.

Whatever you do, do not expect the Warren commission to include any of these 10 points in its report. These, coupled with the shameful attempt by psychiatrists to justify and legalize murder could be a dead giveaway as to the real reason Kennedy was murdered.

What happens now?

One of two things will develop: If no protests are made, the Ruby appeal will be placed on the Supreme Court Calendar and his death sentence will be commuted, or . . .

If you raise an issue, Ruby will be eliminated by the simple expedient of having him commit "suicide."

This already has been planted into your minds by Melvin M. Belli, who disgraced the law profession with his behavior and utterings, and by leading syndicated writers. This gives the conspirators a clear path to do away with Ruby and then claim a "suicide." After all, haven't they already told you it will happen? And, in all probability, this could develop even before this report reaches you.

What can you do about all this?

Fall back to last month's observance of the Resurrection of Christ. Renew in your mind His wonderful teachings:

"Believe in me; whosoever believes in me shall do great things. These things I do even ye shall do in greater measure."

This is the one weapon which the conspiracy lacks and this one hope of resurrection can, if applied to the utmost, overcome all of the combined weapons of the conspiracy.

Know that "one with God is a majority." His Infinite Power of resurrection can lead you to the promised land. He will not fail you.

When this is completed, these five things you must do. You have little time in which to do them:

1. Flood your congressmen and senators, especially the liberal ones, with letters demanding they stop this suicidal game of appeasement. Demand they brace up and stop the conspiracy and all aid to communists.

2. Demand an investigation of the State Department and the "United Nations" with the aim in mind that we eliminate this "Trojan Horse" from our shores once and for all.

3. Demand that every communist agent in the State Department be ousted immediately and all tried for treason against the United States for the attempted takeover of the United States.

4. Demand that the damnable UNESCO rule be ended in our schools and that progressive education be replaced by the traditional system which DID teach our children the three Rs: read, write and reason, not to mention spelling.

5. Most important of all . . . take the emphasis off the presidential election and place it where it belongs . . . on the election of congressmen and senators to bolster the one defense you have against America being seduced by the international criminal conspiracy.

The Congress of the United States is your bulwark against tyranny. Lose this group and you lose your freedom. Elect a strong American Congress and you place the conspirators on the run.

The "invisible government" can control the President of the United States and force him to make whatever appointments it wishes. However, you control the selection of honest and patriotic senators and representatives. I cannot emphasize this too strongly.

Let the conspirators have the presidency, if we must. As long as you get out and work for patriotic senators and congressmen who will help you to achieve the five objectives above, we can then stop the present policy of appeasement; we can get rid of the treacherous and fake "United Nations," one-world government, world rule by law, socialism and communism; we can force the State Department to get rid of the agents of the conspiracy who are leading America to its down fall today.

Do all of these five "very important steps" and you will begin to change the tide and once again direct our progress towards restoring America to the concept which our revolutionary founders gave us; a *Republic form of government under the Constitution of the United States*.

Your alternative is not so pleasant. Do nothing and you have only a matter of months to wait until the last vestige of your freedom disappears.
