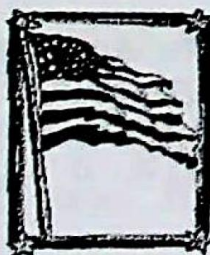

YOU CAN SAVE OUR COUNTRY!!!

This is **BY FAR**, the most important 'BULLETIN' we have ever issued to you and to all our loyal patriotic co-workers. Therefore, I appeal to you to read every word of it very carefully, *study* it, *digest* it—and then **PLEASE** give it your immediate and **UTMOST** attention! ! !

But some very capable and wonderful patriots were victims of their threats of death—as you shall see.

PATRIOTS DIE UNTIMELY DEATHS

From the time that Woodrow Wilson put over his illegal "Finance" Act, many individual American patriots worked mightily to undo all the CFR plots. And many of them died strange and unexplained deaths.

The following is a quote from an ECONOMIC COUNCIL LETTER:

"Any fool can commit a murder. It takes an artist to commit a natural death"—Whittaker Chambers.

In Newton, Massachusetts, on May 9, 1970, a 30-year State

Representative, flushed with his success at getting a Bill introduced in the Legislature to *outlaw war*, and the rosy prospects of a brilliant career, returned from dinner with his young bride, Anita, after saying good night to their closest friends and confidant, the Reverend John M. Wells, pastor of the First Parish Church. Young Mrs. Shea went to the bathroom, while her husband went directly to their bedroom to undress for bed.

She walked into the bedroom to recall to her husband a delightful part of the conversation that they had had on the success of his Bill. "Jimmy," she called. But in the darkened bedroom, Mrs. H. James Shea, Jr. heard several shots. Switching on the lights, she discovered a .38 caliber pistol, not of his own ownership, clutched in her husband's hand and aimed at his head. The authorities called it suicide, but Anita Shea knew her husband had no reason to want to die. And Pastor John Wells knew it. But there was no effort made to find out who the *real* owner of the gun was—and why Shea could possibly have wanted to die.

The Bill which Shea had sponsored meant:

1) That Massachusetts servicemen can decline combat duties in foreign countries unless military action had been authorized by a Declaration of War by the Congress of the United States.

The Massachusetts Attorney General was required to represent such servicemen in Court.

The central point of Shea's Bill, which was actually authored by the Reverend Wells, was that without a Declaration of War by the Congress of the U.S., no United Nations War, such as Vietnam, could happen again.

It had been necessary to invent "*incidents*" to get the U.S. into World War I and II, but since that time we have fought so-called "*Police Actions*" and "*Treaty Obligations*" by Presidential Executive Orders. The American boys buried in Korea are buried under a UN flag, and the United States is in Southeast Asia under the UN regional arrangement: (SEATO) the "Southeast Asia Treaty Organization." We have been brought into these wars in order to destroy the National Sovereignty of the United States while protecting money interests of certain financiers operating in those areas.

Young Shea was a friend of the American people, a devoted patriot of his country, and thus a determined foe of the "*clique*" who must have wars to realize their plans for world domination.

Shea's Bill was filed in the Supreme Court by the State of

Massachusetts on July 22, 1970. May his country remember him, and carry on his fight to end all "created" wars.

ANOTHER MYSTERIOUS DEATH

Late in 1969, Justice of the Peace, Martin U. Mahoney, of Credit River Township, Minnesota, went to bed, looking happily forward to answering a summons for the following day (August 22, 1969) to the Minnesota Supreme Court.

Judge Mahoney was a simple, folksy man who often held court in his barn, sitting on a milkstool. But he was an expert in country law which he knew to be more powerful in most respects than the Supreme Court of the United States. He was not a man of formal education, but he was an expert on Constitutional Law. A year before, he had dared to declare that Federal Reserve money (*for which no reasonable consideration existed, since no gold backs Federal Reserve Notes*) is no lawful tender. It is merely "created" out of nothing.

Mahoney felt that he could thwart the Supreme Court's efforts to uphold the international bankers' means of controlling the U.S. and the whole world through central banks such as the "Federal Reserve." He believed in the world's greatest document which says: "*No state shall make anything but gold and silver as tender in paying of debts,*" and "*The Congress shall have the power to coin money, regulate the value thereof, and of foreign coin, and fix the standards of weights and measures.*"

His was the first courageous legal voice in the United States to challenge the privately owned, privately operated, and secretly controlled corporation which had brought panics, inflation and deaths to millions of Americans.

Justice Mahoney looked at the Minnesota Supreme Court summons. They had charged him with "*intentionally and deliberately violating a high court order,*" because he had made a decision against the "Federal Reserve."

Judge Mahoney, 52 years old, and greatly loved in his community knew Constitutional Law as well as he knew his Bible, and he was positive he would win, he told his wife when they retired.

In the middle of the night there were noises at the Mahoney

Farm, but perhaps it was the farm animals or a foraging raccoon which had disturbed the dogs.

The next morning, as the papers reported "*Justice Mahoney woke up dead.*"

The coroner performed an autopsy because of the "*unusual circumstances at the death scene and the controversy he was involved in at the time.*" The coroner stated that it was an acute heart attack, but hinted that it may have been artificially induced.

The following memorandum to Mahoney was delivered at his funeral: "*A carpenter and a farmer, he was reviled like another carpenter a long time ago, for he had confronted the money changers in their temples and it shook his faith, but not his courage.*"

JACK KENNEDY WAS ANOTHER "TARGET"

President John Fitzgerald Kennedy had been told several times about the international conspiracy to control the world. He had been told when he went to Congress by one of his father's friends, sitting in Joseph Kennedy's office at 230 Park Avenue in New York City. The man who told him rode to Washington with him, and filled him in on all the details. Jack replied, "*I appreciate this knowledge but I want to be a Congressman. What you say is probably true, but if I get involved now, my career will be busted. Wait.*"

He was reminded again while he was a Senator. "*Not now,*" he told the wise old friend of his father. "*Wait until I am President and I'll be powerful enough to do something.*"

Perhaps I shouldn't include President Kennedy with his socialist record in these pages. But the friend, who knew his father when the older Kennedy found out who was behind the "*invisible government,*" asked that specific proof be shown his son. This friend had reason to believe that President Kennedy discovered the awesome truth he was warned about, and made secret plans to wrest the country from their control.

The truth is, that Jack Kennedy's death was arranged by a group of at least 50 conspirators, and 21 persons directly involved in his death have died mysteriously, one by one. Endless magazines, reports, computer studies, etc. have shown that bullets from several different guns in different locations entered Kennedy's body, the fatal one from other than Oswald's gun, and that the Warren Commission was a Johnson-Fortas-One World scheme to shield the truth

from the American people. "*Pardon Me But . . .*" a monthly publication has done a complete analysis of the Kennedy murder conspiracy, as has Richard E. Sprague in "*Computers and Automation*," May 1970. Bernard Fensterwald, Jr., a lawyer who heads the "*Committee to Investigate Assassinations*," 927 15th Street, Washington, D.C., has massive information on the Kennedy assassination, including a bibliography carrying many books which show that Kennedy was assassinated by conspirators.

Penn Jones, Jr., Editor of the "*Medlothian Mirror*," Medlothian, Texas, maintains a list of witnesses who "*knew too much and who have died unexplainable deaths*." There have been more than 50 deaths among this group, he maintains, since November 1963, and states that the chance that the number of deaths in such a group from natural causes is much less than one out of a million.

Did Kennedy realize too late that he was being used by an international group of "*Controllers*" who sought to destroy his country? Did he plan to put the finger on the individuals in the United States who were at the head of it—even though he knew he might die for it?

"When they will want to get me, they'll get me, and nothing can stop them," he said just before Dallas. Kennedy is said to have talked of his death before going to Dallas. Did he have a premonition of it, or did someone warn him?

HOW JOE McCARTHY DIED

Death came to Joe McCarthy, U.S. Senator and heroic foe of Communism, in Bethesda Hospital in Maryland on the night of May 2, 1957. Ironically, "*Bethesda*" means "*house of mercy*" in Aramaic, the language of Jesus. But other patriots had been shown no mercy here, and neither was Joe McCarthy.

It was to Bethesda that the *martyred* body of Jack Kennedy (*or was it the body of officer J. D. Tippit, the slain police officer?*) was taken for autopsy, the record of which was carefully burned. The hospital officially reported McCarthy's death as due to "*acute liver failure*." He did *not* die of cirrhosis of the liver, nor of drinking too much, nor of the other diseases caused by intemperance as was suggested in the snide comments of the left-wing press. Joe McCarthy was murdered by his enemies.

According to Medford Evans, in *"The Assassination of Joe McCarthy,"* published by WESTERN ISLANDS: "What I should insist on at once is that McCarthy's health was such in the Spring of 1957 as to make it incredible that he should die so swiftly of natural causes, and that McCarthy far from being out of the fight against Communism simply because the Senate had condemned him (though he felt that condemnation keenly) was now striking nearer to the heart of the Communist strategy than he had ever done before." Just weeks before his death he delivered a speech to show that American Foreign Policy was controlled by a conspiracy.

McCarthy died supposedly of acute or toxic liver failure, not infectious hepatitis. Liver failure of this kind come from poisoning by chemicals which had been developed for that purpose and used by the conspirators to attack the vital organs of their (victim) enemies.

But as Dr. Evans points out in his brilliant and convincing book, these poisons could also include snake bite, chloroform, or mercury, but McCarthy, more conveniently, was poisoned by carbon tetrachloride.

The *"New York Times"* reported the death as *"mysterious."* This (hepatitis) is an internal ailment, but the reports from the hospital were that he was being treated in the neurology ward." Next day (May 4) the *"Times"* reported: "The origin of the ailment was not known, and no autopsy was planned . . . WHY WAS McCARTHY MURDERED?"

He was *"the protagonist in a tragic struggle against what he identified as "Communism on behalf"—as he stated in his initial philippic at Wheeling, Virginia "of Christianity."*

Joseph Kennedy, a deep personal friend of Joe McCarthy, who once said: *"I love him like a son,"* was reportedly heart broken over the Senator's untimely death, as were all American patriots.

McCarthy had a star-studded stable of known enemies. First and foremost, Dwight D. Eisenhower, then Henry Cabot Lodge, David Lilienthal, Lewis L. Strauss; Senator Arthur Watkins, Stuart Symington, Herbert Lehman, Lyndon B. Johnson, and other left-wing Congressmen; the controlled Press and TV, spies in the State Department and all other Zionist—Communist-one-worlders in the invisible government. A startling array of enemies, but the finger of death was laid on McCarthy by one at the top of the conspiracy to control the world.

"It is important to recognize that Joe McCarthy was a good man," says Dr. Evans, "kind, generous, never vindictive, always

courageous, sincerely patriotic, always loyal to his friends, forgiving to his enemies. It is important to realize this fact in order to do justice to the memory of the man, but also to approach some kind of understanding of what it must mean that the leadership of our Country—decided not merely to reject him, but turned upon him like a wolfpack, encircled him and brought him down.”

“The comparison, however, is unfair to the wolves, who simply live by instinct. Many, if not all, of those who destroyed McCarthy knew he was a good man. Indeed, that was the reason he was destroyed—he was too fearless to be intimidated, too innocent to be corrupt, and his salvos were dangerously on target.”

All patriots agree with Dr. Evans that the assault on the United States and the American way of life could not have advanced as far as it has, if Joe McCarthy had not been assassinated, figuratively in the Senate, and literally at the Bethesda death house 2 1/2 years later.

SEN. McCARRAN'S UNTIMELY DEATH!

Senator Patrick McCarran, who preceded his beloved young friend Joseph McCarthy in death by three years, was, next to McCarthy, the man most hated by those who plot to destroy the United States. Perhaps no other Senator authored as much legislation for the protection of his country, and for the benefit of her people. His enemies remember him best for the despised Internal Security Act of 1951, and the Immigration and Nationality Act of 1952. One of his most patriotic accomplishments was his expose of the communist conspiracy through his investigation of the Institute of Pacific Relations, the organization responsible for convincing the West that Mao was a harmless “agrarian reformer,” and the sell-out of China to the Reds. Among those on the Board of Trustees of the IPR were Owen Lattimore, Alger Hiss, David Lilienthal, F.A.O. Schwartz, William S. Lockwood (Woodrow Wilson School), Lewis Straus, Alfred Esberg, Pearl S. Buck, Lauchlin Currie, Philip E. Lilienthal, and Dean Rusk.

McCarran brought in the highest members of Government on whom he had sufficient evidence to suspect as being members of the Communist Party. McCarran once questioned Felix Frankfurter in the Senate Judiciary Hearing on his nomination to the Supreme Court. He asked Frankfurter if he were a communist and Frank-

furter did not give a direct answer. McCarran found such persons intolerable in places of authority in government.

He fought to prevent Roosevelt's Supreme Court "packing" law from being passed. He fought for economic stability, to save the country's mining industry, and to build up small business.

He gave no right to any man to deviate from the rigid measuring rod of this oath: "*To support and defend the Constitution of the United States against all enemies, foreign and domestic.*" He believed in the Constitution of the United States to the last comma, and he knew it word for word, sentence by sentence, article by article.

Pat McCarran saw all the dangers of opening our gates to the hordes of enemies who want to come to America to destroy her.

"If we espouse the principles of the Constitution of the United States, we will not support those who would come here to destroy this government."

"Few understood his deep-seated fear of "*conquest by immigration,*" which has been the principal factor in subverting the United States to Communism, and which is the first step in the plan of the Conspirators' one-world clique to control the world. His last speaking engagement was to help alert the country to the dangers of the "destroyers from within, of the dangers of not checking carefully the political background of each person admitted to the United States, and of checking the loyalty of each person admitted to any public office, or the Government, especially those in the Courts."

These brilliant addresses were shaking the complacent, and waking up the sleeping. In each of them, as in the last, he read these lines from Oliver Goldsmith, which was his philosophy:

*"Ill fares the land, to hastening ill a pray,
where wealth accumulates and men decay;
Princes and lords may flourish or may fade,
A breath can make them as a breath has made;
But a bold peasantry, their country's pride,
When once destroyed can never be supplied."*

At this banquet, on the night of September 28, 1954, the audience cheered. They had been following the spy hearings of McCarran and the Internal Security Committee. McCarran and McCarthy were naming names. They were beginning to break apart the conspiracy.

A poison was slipped into his glass—a poison which caused great internal distress and killed McCarran immediately.

Another patriot, also a friend of McCarthy and McCarran, Senator Robert Taft probably was martyred by the same conspiratorial tyrants.

Senator Robert Taft represented the heart and soul of America as the Republican Senate Leader for many years. He was famous for the TAFT-HARTLEY BILL which was against "closed shop" or making a man join a union in order to be permitted to work. He bitterly opposed Roosevelt's machinations to plunge the United States into a global war. Often he accused the President of lying to the American people, of doing what he chose to do without the consent of Congress. Labeled an Isolationist by pro-Roosevelt-Zionist-communist propagandists, he, nevertheless, was fearless in standing up for the right of the people to have their will carried out by their elected representatives.

Taft understood that the lend-lease was merely an excuse to create an incident for an undeclared war by Roosevelt. He opened it and all other war-making legislation proposed by Roosevelt: (1) more aid to allies (2) military airplane appropriations (3) conscription Bill (4) lend-lease Bill (5) Armed Ship Bill to deliver goods to allies (6) entry into belligerent zones (7) seizure of ships of countries occupied by the Germans.

The New Deal administration, operating from the White House through the Department of Justice, caused twenty-eight Americans residing in different parts of the Country to be indicted, arrested and taken from their homes to Washington, D.C. for trial in a foreign jurisdiction. Entrapment schemes were set up by having a reporter on the Zionist left wing "Washington Post" write letters to each of those persons.

These were called Mass Sedition Trials, one of the most infamous cases of tyrannical government and they were perpetrated and sponsored by some of the country's leading Reds. All indictees in the New Deal Sedition Case were without exception fighters against communism. Typical of the indictees was a man of 83. He lost the mailing permit for his weekly paper and lived with his aged wife, keeping a goat and a few chickens. He was held in jail until he died with 40 cents in his pocket. His body was shipped home naked in a pine box, and his wife did not have enough money to pay the express charges.

Taft so custigated the Justice Department, Roosevelt and the pro-communist newspapers, that communists and Zionist controllers who sought to destroy free speech of honest Americans never forgave Taft. Taft put his finger on the whole one-world-Zionist-Communist conspiracy in the United States, and he knew the

names of all those behind them—see (The Sedition Case, 1970,) by SONS OF LIBERTY.

But Taft was too powerful to be touched *yet!*

Taft called the attention of Congress and the United States to the Yalta betrayal. He saw that the Nuremberg Trials were conducted to destroy the West and benefit Russia and he condemned it to the world.

He was furious when Truman recalled (*fired*) MacArthur. He knew that the free world was being sold into slavery.

Taft ran in the primaries for the Presidential nomination in 1952. He had become so well-known in America, so recognized as Mr. Republican and what American wanted (*and desperately needed*), he was persuaded to run for President. Republicans at the convention, however, had been bombarded with anti-Taft material and personal pressures and bribes were the order of the day upon the delegates at the Convention.

The entire story of the treacheries and bribes were related in full depth upon my return to Los Angeles from that Convention in Chicago.

However, Senator Taft accepted all those treacheries, bribes and his loss graciously and plunged in to help Eisenhower. But he was appalled at Eisenhower's left-wing appointments, his calling off of internal security measures, his attitudes on Korea and foreign policy matters. Taft once blew up at the White House over the fat budget Eisenhower proposed to Congress, but his greatest concern was the expansion of communist influence in the government and Eisenhower's lenient, if not accommodating, attitude toward it.

Many saw Taft rising in stature. He, no doubt, would be the next President because Eisenhower was already fumbling the ball, and the Republicans realized they had been betrayed.

Taft noticed one day a strange canister, the type used to hold cobalt-90, but this canister seemed to be a dispenser of some sort. It was directly under the large easy chair he used, and he asked about it. Someone in his office thought it was an air purifier. Several days later the mysterious canister disappeared. Not long afterwards, on the morning of July 31, Taft died of cancer of the left hip.

MYSTERIOUS DEATHS CONTINUE

Another great American patriot, E. E. Cox, Congressman from Georgia, introduced a Resolution in the House of Representatives on August 1, 1951, asking for a Committee to conduct a thorough investigation of the tax-exempt foundations. He named the Rockefeller Foundation, the Guggenheim Foundation, the Rosenwald Foundation, and the Carnegied Corporation, among others who were disloyal to their country. Cox was villified and threatened. Because he criticized the Rosenwald Fund for making grants to known communists, he was called anti-semitic, because he mentioned foundation support of Langston Hughes, a Negro communist, Cox was accused of being a racist.

But Cox's Resolution was adopted in 1952, and the Cox Committee was set up to investigate tax-exempt funds. However, Cox died suddenly and a pathetic whitewash of his investigation was filed by his Committee.

If, during the Taft period, there was a Senator more vocal against Communism and Roosevelt's World War II than Taft, it was Vandenberg who said of the war: "*We are now living by Executive Decree.*"

In 1941, he stated: "If American cracks up, you can put your finger on this precise moment: it was at that moment that the Senate passed the Lend-Lease Bill. We have tossed *Washington's Farewell Address* to the discard. We have thrown ourselves into the power politics and power wars of Europe, Asia and Africa. I do not believe we are rich enough to underwrite the wars of the world."

He stated that a super-state would never work, that we must remain totally sovereign, make our own decisions, be faithful to American interests.

Roosevelt and then Truman began to "court" Vandenberg — he was finally made the first delegate to the U.N. He was constantly flattered by the Internationalists, who tried to seduce him by offering him speaking engagements, titles, favors. But finally he saw them for what they were.

One of the acts which Senator Vandenberg promoted was the Connally Amendment which required that the UN Charter could not impose anything on the United States without a vote of the

House of Congress. He said: "I will regret to the day I die having ratified the United Nations Treaty."

At the end he saw all of the Internationalist network — UN, NATO, etc., work as a mere excuse to further Communist Conspiracy.

He was one of the most formidable enemies of the avaricious gang at the International Monetary Conference. He pointed out that the so-called American plan was not framed by us but by the International Bankers. He feared above all that they might propose an International Bank, but his death prevented him from fighting to keep the International Bankers from carrying out their plan.

Senator Vandenberg's son verified this story by his father's carefully kept diary.

Senator Vandenberg had told several other Senators (including Joe McCarthy) and Representatives of this terrible conspiracy and on April 18, 1951, he "died" of "cancer."

John T. Flynn wrote in the "LATTIMORE STORY": "The final effort of Acheson, Lattimore and Jessup to deliver China and Korea into the arms of the Communist world came on February 9, 1952. That conference was held in the White House but was not made public until the Fall of 1952 by Governor Stassen. To this conference with Truman, Jessup, and Acheson, the Secretary of State made the mistake of inviting Vandenberg. At that White House meeting Acheson and Jessup proposed that the supplies that had been loaded at San Francisco for Chiang Kai-Shek's Nationalist government — under congressional authorization — should be halted as a dramatic gesture revealing our abandonment of the Chinese Nationalist government and as a move toward peace. Part of the plan was actually to blockade Nationalist China. Forty-Five ships were on their way to China belatedly carrying arms and supplies. It was proposed that the ships be halted and if done with appropriate publicity, this action would be notice to the world that we were out of the Pacific Struggle. Senator Vandenberg protested vigorously against this plan and warned President Truman that if it were attempted he would recruit a majority of the Senate to stop it. This daring secret cabal to turn Eastern Asia over to the Reds — although plotted in February 1950 — was never revealed until Governor Stassen testified before the McCarran Committee (Fall 1951).

Senator Vandenberg died of cancer — or a broken heart — but it is fairly certain that both were induced by the enemy.

On a visit to Arlington National Cemetery, according to Cornell Simpson in his book, *THE DEATH of JAMES FORRESTAL (Western Islands 1966)*, John F. Kennedy sat down at the lonely gravesite of the nation's first Secretary of Defense, which he had sought out, and said: "*It is so peaceful here, I almost think I could stay here forever.*"

How strangely prophetic! Here, in the dust, lay a man who, like Jack Kennedy, was an Irish Catholic who had risen to high places in Washington. Like Kennedy he had been groomed for the "Invisible Government" to run the world. But unlike Kennedy, he realized it early in the game and broke away from them. Like Joe McCarthy and Pat McCarran in background and ideals, Forrestal loved his country with great undying passion and was willing to make any sacrifice to save her.

It had not begun that way with Forrestal, at least not to the World Control System of the

Forrestal was a brilliant, power-driven businessman who had jumped from the bottom of Bernard Barach's firm Dillon-Read (one of the big eight World-Control Rothschild satellites that rule the monies of the world) to the President at 46 and a millionaire.

Barach spoke to Roosevelt, feeling that Forrestal the Irish financial wizard would be important in getting Wall Street support for bringing the United States into World War II. And Forrestal, not realizing that he was being groomed to be a push button for those who run the government behind the scenes, but seeking to serve his country, gave up his stock, his wealthy living and his \$200,000 a year salary to accept a \$12,500 post as one of Roosevelt's many assistants.

Forrestal went to this job, because he honestly believed just as Barach and Roosevelt told him, he would be serving his country where it needed him most.

Six weeks later, at the urging of Barach, Forrestal became Roosevelt's Undersecretary of the Navy.

Forrestal then organized, from scratch, the Navy's vast wartime procurement system, in addition to coordinating the greatest Navy in the history of man. On the death of the Secretary of the Navy in April 1944, on the eve of D Day, Forrestal became the head of the navy.

Throughout the war, Forrestal was a brilliant organizer, an unfatigable worker. He remained Secretary of the Navy until the

powerful new position of Secretary of Defense was created to unite and reorganize the feuding branches of the Armed Services.

Plans were under way for a World Seat of Government in Palestine, but James Forrestal, far more patriotic than they had dreamed, began to be troublesome to those who had put him in this sensitive place.

In his new job, he had written in one of his original diaries:

"26th of November 1947. Lunch today with Senator McGrath. Prior to it I had him read the secret report on Palestine by the CIA. I said to McGrath that I thought the Palestine question was one of the most important in our foreign policy, and that if we were talking about lifting foreign affairs out of domestic politics, there was nothing more important to lift out than Palestine, with all its domestic ramifications."

"I learned from McGrath that Jewish sources were responsible for a substantial part of the contribution to the Democratic National Committee and many of these contributions were made with a distinct idea on the part of the givers that they will have an opportunity to express their views and have them seriously considered on such questions as the present Palestine question."

"3 December 1947. Lunch today with Jimmy Byrnes. We talked Palestine."

In this entry Byrnes told how Sam Roseman and David K. Niles had caused Truman to come all out for the Zionist plan to take over Palestine and how Rabbi Abba Hillet Silver was managing to influence the Republican party by putting money only behind those candidates, including the Presidential Nominee who would come out for a political uprising to take Palestine way from its citizens.

"I said that I thought it was most disastrous and regrettable fact that the foreign policy of this country was determined by the contributions a particular bloc of special interest might make to the party funds."

"3 February 1948. Visit today came from Franklin D. Roosevelt, Jr. who came in with a strong advocacy of the Jews taking over Palestine, that we should support the United Nations' decision and in general, a broad, across-the-board statement of the Zionist position."

"I pointed out that I would be derelict in my duty if I did not point out what I thought would be the consequence of any parti-

cular policy which would endanger the security of this Country. I said I was forced to repeat to him what I had said to Senator McGrath in response to the latter's observation that our failure to go along with the Zionists might lose the States of New York, Pennsylvania and California — that I thought it was about time that somebody should pay some consideration to whether we might not lose the United States."

Then came the mighty Bernard Barach, took the man whom he had helped to install in government aside and warned him: "*Jimmy, you are pushing a dangerous policy with the Palestine question. Your career is in danger. I am telling you, you must lay off criticizing the Zionist plans for Palestine. Not only is your career in danger, but you are courting personal dangers.*"

"But, Bernie, my Country is in danger and I cannot quit."

"There are other grounds to fight on. You must forsake this one. Fight Communism, but keep out of this."

Forrestal could find no threat from his mentor; he took it as a friendly warning, even though he knew that Barach was speaking as the dean of Zionism and world control.

Forrestal had already fought many battles on many fronts:

He had fought a tremendous battle against the State Department and the Communists in the State Department to keep our loyal Ally, Chiang Kai Shek, a power in China. Their program was the same as Soviet Russia's: to destroy Chiang and hand China to Mao Tze Tung and his Yeman Reds. He fought General George C. Marshalls plan to infiltrate Chiang's government with communists, at Stalins request in order to have a coalition government.

Forrestal flew to Peking and consulted with the military. He flew to Tokyo to consult with Douglas MacArthur. Here he found a kindred spirit. General MacArthur exposed the plan of the Com-muzionists to take control of China.

Forrestal never stopped trying to save China, even after Marshall turned it over to Mao. He tried to reactivate the "Flying Tigers" to give Chiang air support from American volunteers. He even set up his own private espionage network in Red China, hiring loyal Chinese Agents to infiltrate the homeland. He spent a small fortune of his personal money to keep the truth coming to the U.S.

FORRESTAL SAVES ITALY

The United States State Department in 1949 was still doing its best to make Italy go Communist, as it had since the time of Roosevelt in 1944. We had tried to give Russia one-third of the Italian Navy. The Russian Delegation in Italy had been sent unlimited funds from the U.S. Treasury and his assistant Harry Dexter (White) to build up the Italian Communist Party.

In 1944 Marshall Pietro Badoglio had set up a coalition government with the Communist and Socialist Parties. The Under Secretary of State Dean Acheson and his pro-Communist legal counsel to the Department, Benjamin Cohen, wanted to give Russia Italy's Tripolitania (Libya) plus the Dodeccanese Islands and their Italian Naval Bases plus the right to fortify and occupy the Dardanelles.

Just before Italy's post-war election in 1948 Forrestal learned that the Communists had started to spend 30 million which Roosevelt had let them steal in Italian Lire when he sanctioned their murder of Mussolini and millions in U.S. taxpayers dollars given directly to the Soviet Union.

Forrestal arranged with Judge Edmund L. Palmiera, a prominent Attorney and Monsignor Maurice S. Sheehy to go there as his personal representatives with a million dollars of his own money to get out the vote and protect Italian voters from Communist goon squads.

Forrestal's campaign consisted of getting American-Italians to write their relatives in Italy urging them to vote against the Communist Party. The other was done through the Catholic Church's organizing workers at the polls, discussing the vote from the pulpit, even providing armed guards, in some cases at polling places. Through the Church Forrestal's money provided for buses to go to by-ways to bring in the poor, the ill and the infirm. Forrestal hired Italy's free lance news-papermen and paid them three times what the Communists paid them to write stories for the anti-communist candidates. The Church was accused of refusing to give help to Jews fleeing Germany, phony documents bringing vile accusations against the Pope were circulated. The clergy was stoned and some killed for preaching against the Communists.

But Christians fought valiantly, and special prayers were sent up daily. At election time an unprecedented 90% of all eligible had voted. God, Italy and Forrestal had won.

Forrestal had discovered that there was a great conspiracy than Communism itself. Communism was merely its weapon.

Forrestal fought the Marshall plan of Alger Hiss and Clark Eichelberger to communize Europe. Instead he sought to give U.S. taxpayers' dollars only to those few countries who made a stand against Communism.

He fought and helped put an end to the Morgenthau Plan which was, as he put it, "mass murder of the Germans, their enslavement and industrial devastation of the Country."

While Eisenhower was fraternizing with Red Army Commanders and holding back our troops to let the Russians grab Berlin and Eastern Europe, Forrestal demanded a showdown of communists pouring in for the seduction of Germany. He saved France from Communism with his own funds and brilliant planning after a long and bitter strike.

Forrestal was a great friend of Joe McCarthy, of Vandenberg, of McCarran, of General Patton, of Robert Taft. He was therefore not only hated by his enemies, but the enemies of his friends. These enemies included: George C. Marshall, Dean Acheson, Harry Truman, Harry Hopkins, Bernard Baruch, C. Douglas Dillon, Henry Morgan then, David E. Lillienthal, David Niles, Michael Greenberg, Owen Lattimore, Phillip Nash, Clark Eichelberger, J. Robert Oppenheimer.

At the time of his murder, Jim Forrestal was writing a political book, the greatest expose of all times. He had recorded all his notes for the book in his diaries, and one or two intimate friends knew that when he left the Department as he had planned to do, he would destroy the enemy with one quick blow.

Then men who ran Truman knew that Forrestal must be discredited and killed rapidly, or their vast empire might crumble when the truth became known. When the diary was rewritten only the parts were ever reprinted. But there are two men on the side of good who live, and know the awesome truths it contains.

Jim Forrestal was buried with the honor that Kings and Presidents receive. Muffled drums and the slowly booming 19 gun salute accompanied the long funeral cortege; there was the saddled riderless horse on a lead run, the flag-draped casket and the caisson pulled by six-matched gray horses, flanked by resplendent honor guards of all the services while he lay in state. Thousands of prominent people, including the President, royalty and Ambassadors the world over mourned him.

Forrestal had been murdered the day he was to leave the hos-

pital. He had been gagged and bound and thrown from the 16th floor of Bethesda — the “house of mercy,” where patriots receive no mercy. He had been the right of seeing his family or even his priest just prior to his death. But government officials including President Truman had the free run of his bedroom at Bethesda and visited him frequently.

MURDERS IN THE LIBERAL YEARS

Murders that happened during the Roosevelt-Truman-Kennedy and Johnson years with such frequency that no one questioned heart attacks just before an investigation, suicide that were impossible, unexplained falls of anti-communists from open windows, “instant cancer after cancer casts were negative, poisonings at dinner speaking engagements, deaths when a person was leaving the hospital after minor surgery.

GENERAL KRIVITSKY NOT A SUICIDE

“If they try to prove that I took my own life,” General Walter Krivitsky warned friend many times before, *“don’t believe it.”*

On February 10, 1941, the day that he was due to testify before a New York legislative committee investigating communist infiltration in the State’s educational system, Krivitsky was found in a Hotel Bellevue room in Washington, D.C. with his brains blown out.

Kenneth Goff, former communist said that after Walter Krivitsky followed him to the stand to testify against the communists before the House Un-American Activities Sub-Committee, said: *“This is my obituary.”*

The walls of Krivitsky’s hotel room were thin and both adjoining rooms were occupied, yet no one heard a shot. “Krivitsky’s *suicide gun*” was not equipped with a silencer so Krivitsky could not have died by suicide, since any shot in the hotel would have been heard by many witnesses. Krivitsky was also planning another appearance before the House Committee on Un-American Activities; the British

government was arranging for him to make a second trip to London to testify, and he was about to expose a top level spy ring in the United States, of which Alger Hiss was a part.

Krivitsky, after breaking with the world communists, and fleeing to the United States, publicly named a long list of Moscow's enemies who had died peculiar deaths and declared that he had positive proof that these men had been murdered by the government.

A favorite technique, he said, employed by communists, is to use medical men for the actual killing so that the death may be described in natural causes. The communists, Krivitsky related, have developed a complete series of chemicals which produce symptoms of liver, heart, kidney failure, cancer, leukemia or one of the blood cell diseases.

Thomas J. Walsh, a prominent attorney was designated to serve as Attorney General in a deal with Roosevelt by the Democratic Party before his election. Walsh was a conservative Democrat and the Party insisted that he go in with Roosevelt. Roosevelt discussed his appointment and insisted that Walsh accept Communist-lover Zioniet Felix Frankfurter as his Solicitor General. Walsh refused and a violent argument ensued. Roosevelt left the room where they had met, and the matter was dropped.

However, when Walsh was on the train speeding to Washington to be sworn in, he had a sudden occlusion of the bowels and died in pain on the bathroom floor of his Pullman.

I could name many other great patriots who devoted their careers and their lives to their fight to awaken the American people to the desperate need of their joining them in the fight and using their influence with the men they elected into Congress for the kind of action that would save our Country. You probably know all of them by name, but I won't burden you with recitals of how all of them were murdered.

I am positive that if all those men had had the kind of nationwide support that we (CEG) had when we organized groups in all Communities which enable us to force Congress to torpedo the RED CONSPIRACY in HOLLYWOOD, then the "UNITED WORLD FEDERALISTS" plot, and all the other horrifying plots of the CFR-UN, our Country would now be free of the CFR, the "United Nations" and the entire GREAT CONSPIRACY.
