FOREWORD

This News-Bulletin was written prior to the assassination of President Kennedy. Our first thought was that we should not publish it at this time. However, after thinking it over, we realized that this would be unfair to everybody concerned. Mr. Kennedy made his own record of his own free will—we are equally free to praise or condemn those things that he did. Further, the new administration will necessarily, in part, at least, be a continuation of much of the Kennedy administration.

While listening to the fulsome paeans of eulogistic praise being accorded to John F. Kennedy we sometimes wondered if they were talking about John F. Kennedy, 35th President of the United States. He was recorded as being so tremendously popular when, in fact, he was elected by a *minority* of the votes cast in 1960. And since then, his popularity, as recorded by the various polls, has always been low for a President. His famed Inaugural Address was constantly eulogistically referred to by the Lippmans, the Marquis Childs, the Alsops, etc. . . .—but too many other columnists and writers have shown the utter falseness contained in that document. And we cannot help remembering that Cuba is still a Communist nation and that many, many Cuban patriots died in that abortive attempt to free Cuba — *an action for which John F. Kennedy was wholly responsible!* We keep remembering that phony confrontation with Khrushchev, just before the 1962 elections, which finalized into absolutely nothing. We keep remembering the assassinations, three weeks earlier, of the Diem brothers in Viet Nam, for which John F. Kennedy must bear the direct responsibility. And we keep remembering the treatment that was so brutally accorded Madam Nhu by Kennedy and his administration. And we remember our prediction that he would not fulfill his term of office! While we regret the assassination, as does every decent American, we also remember the biblical injunction: "Those that live by the sword . . ."

All thru those tragic days of November 22 to November 25, we sympathized with his family, his wife, his children, his brothers and sisters and his parents—until we were shocked by the "*Eternal Light*" to burn forever at his graveside! There is an "*Eternal Light*" at the Arc de Triumph in Paris — for those who died for France. There is an "*Eternal Light*" burning at the Tomb of the Unknowns in Arlington — for those who died for America. Is there an "*Eternal Light*" for Washington, or for Lincoln? Two of our truly great Presidents. Is there even an "*Eternal Light*" for Franklin Roose-

velt? Because, even tho we detested him and everything he did and stood for, we cannot forget that he was a tremendously popular President — as evidenced by the votes cast for him, the tremendous majorities — who holds a unique position in our history, as the one, and only, four-time President. Are we now to have an “*Eternal Light*” burning at the grave of every President? And thus make a mockery of the one at the Tomb of the Unknowns?

Finally, one more reason why we decided to publish this News-Bulletin as planned. The Kennedy boys are two of the most ruthless, brutal and arrogant politicians to ever take office. They have subverted much of the press to their own ends. They admit to, almost boast of, controlling and managing the press for their benefit. They admit to deliberate lies in this management of the press. Because of these things, we think it important that this information, as covered in this News-Bulletin, be issued so that the American Public has the facts laid before it . . . Because if ever the need existed for our people and our Legislators to understand enough about the tactics to avoid falling into propaganda booby traps, this is the time.

We cannot close this “Foreward” without further emphasizing the continued use of the “*Big Lie*” technique. Until Lee Oswald was captured and his Communist background discovered, the Radio and TV commentators, various public officials such as Earl Warren and others, used the dreadful assassination as a means of an attack on the “*Right Wing*.” It was the “*Right Wing*” that was held responsible — it was the “*Right Wing*” that was accused of incurring all the hatreds. Even after it was discovered that the murderer was a Communist, the unrelenting attack on the “*Right Wing*” continued. Warren, speaking at the Capitol Rotunda, used it as an excuse for a continued attack. Warren, whose court was solely responsible for the continued freedom of all the Communists by their continual striking down of all State and Federal statutes against the Communists and seditious acts. Perhaps if Mr. Warren had not been so zealous in protecting the “*rights*” of traitors and had thought more of the rights of the vast majority of the Americans, this Communist, and all the rest, would have been rounded up, and the assassination would not have taken place. Mr. Johnson, in his speech to the joint Houses of Congress, continued the attack. Jesse Unruh, a California politician, expressed the pious wish that he “*hoped that this would not result in a ‘witch hunt’ against the Communists.*” What will it take to awaken these men to the very real internal and external dangers posed by Communism? ? ? ?

Those of you who have attended debates between the Right and the Left and various Left Wing meetings will be fully aware that it is always the Left which resorts to either verbal or physical "hate" actions and violence. Where is the violence of the organized "Right Wing"? ? ? ?

The above forthright Foreword, written by Bruce Fagan, while I was hospitalized and undergoing major surgery, will be amplified in our "Year-End Report." In that document I will review all the events that followed the horrifying assassination of President Kennedy — events that clearly and starkly reveal how the "Masterminds" sacrilegiously immediately sought to use that foul assassination to achieve their objective of brainwashing and seducing the American people into a "voluntary" surrender of our Freedoms and the sovereignty of our nation. It was as if they felt that this was their golden opportunity — that during this period, when all of the people were in a state of numbness and shock, they could at least railroad Congress into passing legislation that would draw us closer to the brink of the abyss they plan for us. Their theory was that by (virtually) canonizing Kennedy they would mesmerize the people into at least not opposing such legislation — if proposed as "memorials" for the assassinated "hero." The modus operandi was to be very simple — it all was to be accomplished via tributes to "the memory of John F. Kennedy," whom that assassin's bullets seemingly transformed from a ruthless political charlatan into a veritable saint. For examples: No sooner was Johnson sworn-in to the Presidency, than he proclaimed that Congress must immediately pass the full Kennedy "Civil Rights" Bill — to serve as a "Memorial for John F. Kennedy." . . . he also demanded that Congress give immediate approval of Kennedy's Eleven Billion Dollar Tax Cut — "as a Memorial for John F. Kennedy." In short, every objective of the "Masterminds" was to be railroaded into "Law" as a "Memorial for John F. Kennedy."

Indeed, as Bruce Fagan expressed it: if ever the need existed for our people and our LOYAL Legislators to understand enough about the tactics to avoid falling into propaganda booby-traps, this is the time. MCF.

SOME GOOD OMENS

Within one week after we placed our "News-Bulletin" No. 99 ("HOW THEY BRAINWASH") into circulation we began to receive a flood of letters, which finally became a deluge such as we have seldom experienced. All types of letters. Some from individuals who for some time had been fully aware of the "brainwashing" processes revealed in our "News-Bulletins"—they expressed deep appreciation for the *documentary* evidence the "Bulletin" provided and thus *confirmed* their awareness.

Others stated that they had been *vaguely* aware of the general plot to keep the American people unaware of the Conspiracy to destroy the United States as a sovereign nation and to transform us into an enslaved unit of an Internationalist One-World Government—but the indignant and angry denials issued by men in high offices, *men supposedly of high honor and integrity*, men such as Kuchel, Eisenhower, Dulles, Rusk, State Department and Pentagon top officials, etc., etc., made them somewhat dubious about *our* warnings . . . these correspondents, too, express great appreciation for the documentary evidence in "News-Bulletin" No. 99—which removed at least some of the vagueness from their awareness.

Others, on the other hand, express shock and horror that the newspapers and magazines, in which they had such implicit faith, are deliberate collaborators in the plot to keep the American people "brainwashed" and unaware.

Still others are horribly shocked by the realization that all other mass communications media, particularly Radio, TV and Hollywood films, are deliberate collaborators in the "brainwashing" plot. Many have been puzzled by the "Liberal" views expressed in various TV shows and by various "commentators," but the propoganda has always been so craftily camouflaged that it simply left them bewildered and "brainwashed."

The good omens to be found in all of the above is that, in the main, all of them have become so alerted that now they all want to join in the fight—and they seek further information on how to add their strength to it.

However, with all of their new awareness, many of these people seek information of the *specific* acts of treason and betrayals by our (*Khrushchev described*) "LEADERS" in Washington. All those acts

can be fully described and completely documented, but I would need a several hundred page volume to do it. Actually, in various of our "News-Bulletins" and "SPECIALS," I fully described all of those acts time after time after time. I fully described Franklin Roosevelt's betrayals at Yalta, Teheran, etc., etc. . . . In our several "Eisenhower Myth" volumes I clearly revealed how that phony "military genius" had maneuvered all of the Allied Armies in order to clear the road for the Russians to "liberate" all of the Balkan states—I revealed his deliberate delivery of Berlin to Moscow (*publicly confirmed by General Gavin as late as November 11, of this year.*) — and how he isolated West Berlin from entry and/or exit for the Allied Forces I revealed how China was delivered to Mousey Dung, etc., etc. I revealed the Hiss-Molotov secret agreement to place all UN military activities under the supreme control of Moscow. Time after time, I NAMED the seven Moscow Reds who *consecutively* occupied that post from 1945 to this very hour. In short, I provided incontrovertible proof of all the treason, betrayals and chicaneries of all the men in the White House, in the State Department, in the Pentagon—and *all other Federal Agencies.*

My revealments should long ago have aroused the entire nation to the same kind of action that France took with Laval and Petain — and Norway took with Quisling — but *our* traitors are very crafty. The moment they were caught red-handed, they immediately created a new crisis that took everybody's mind off the previous act of treason—and *the Press and our other Mass Communications Media promptly took all possible measures to make us FORGET!*

Not only that, but, in each and every case, they used the new crisis to promptly transform the guilty traitor into a public HERO.

To emphasize that point, I will cite three such incidents—all of which the vast majority of the American people have forgotten, one that most can only vaguely recall *because the Press and our other media have made us FORGET!!!*

I will take Franklin Roosevelt for my first citation (*although Woodrow Wilson belongs in the same category.*)

It certainly is no secret any longer that Roosevelt was one of the most vicious opportunists and foulest traitors we ever had in the White House. There is no need to enumerate all of the Rooseveltian collaborations with Stalin and the Communist conspiracy, but I will emphasize one foul deed, *perhaps the foulest of all*, to stress my point.

No. 1) *As we know, and as was known in Washington at the time, Roosevelt deliberately baited and encouraged the Japanese to launch that "Pearl Harbor" attack. He had to have that "attack" to serve as the "excuse" for dragging us into World War Two. Promptly, that vicious fiend launched his pious "Day of Infamy" speech before a joint session of Congress—and demanded a Declaration of War against the treacherous Japanese and Hitler—and he emerged a HERO of the American people . . . and the Press and all of our Mass Communications Media, who knew at least most of the truth about that "Pearl Harbor" attack, promptly broke into a rash of eulogies for the man—and for his speech—that transformed that evil traitor into a "GOD MAN" who could do no wrong!*

No. 2) Eisenhower: In our "*Eisenhower Myth*," and various other "*News-Bulletins*" I revealed all of that man's background of infamy and his collaboration with Stalin and Roosevelt in the delivery of the Balkan States, of Eastern Europe and Berlin to Moscow. I *documented* all my charges with verbatim quotations from the memoirs of Viscount Alanbrooke, Britain's World War II Chief of the Imperial Staff, from Statements issued by Winston Churchill, from statements issued by our most valiant General, George Patton, from statements issued by various Generals serving with Ike in World War II. All the statements revealed that Eisenhower fully cooperated with Stalin in Moscow's "*grab*" of the Balkans and Berlin. But Eisenhower was the chosen tool of the Masterminds of the Internationalist-Communist Conspiracy to destroy our national sovereignty . . . and the Press and all of our Mass Communications Media continuously eulogized and glorified him—they concealed all his evil—and finally transformed him into a GOD MAN!

No. 3) Truman: The least important man of the three, went to Potsdam, where he fraternized with "*good old Joe*,"—where he confirmed Moscow's "*conquests*" of the Balkans and Eastern Europe—where he confirmed Eisenhower's agreement to give Russia control of the road into and out of West Berlin. He came back to Washington to be "*eulogized*" by the Press for his "*masterly*" handling of that "*Summit Meeting*." He and George Marshall delivered China to Mousey Dung—and both were eulogized for their betrayal of Chiang Kai Shek—and for their support of the "*Agrarian Reformers*." Nor was Truman criticized for "*firing*" General MacArthur for insisting on winning the Korean War!

To the vast majority of the American people all those incidents are the vaguest of memories . . . because our Press and other Media have consistently been "*brainwashing*" us into FORGETTING them!

BUT HERE IS ONE YOU CAN'T FORGET!

The one I mean is the Kennedy incident. You cannot forget it because it is still too fresh in our minds — regardless of all the “brainwashings.”

I won't go into all of the lying, cheating, and political trickeries and gangsterisms prior to October 1962. In our 1961 “*Year-End Report*” we clearly reported that Russia was in the throes of transforming Cuba into a Nu-Clear menace to the United States. We revealed that they had already mounted Missiles in various parts of Cuba, most of them already trained on all of our important cities on the Atlantic Seaboard. That “*Year-End Report*” was issued in December 1961. In January 1962 several members of Congress questioned the State Department, the Pentagon and, of course, Kennedy about those charges. Kennedy contemptuously declared our charge to be a (*Rightest-Extremist*) falsehood. In our following “*News-Bulletins*,” we named all of the locations of those Nuclear Missiles—we named and located all the caves and inlets where the Russians were frantically installing more Missiles and Submarines with Nuclear weapons. Again Kennedy and (*on his orders*) the CIA denied our “*allegations*.” However, along in March or April, Senator Keating of New York was provided with documentary evidence of the same type from other reliable sources. He promptly (*publicly*) revealed that information—and Kennedy, still deliberately lying in his throat, proclaimed that Keating was completely wrong. But as Keating continued to proclaim his warnings, and others, particularly a few publications in Florida, confirmed his findings, Kennedy, to offset those charges, and *still lying in his throat*, announced that CIA, State Department and Pentagon investigations did reveal that Russia had been shipping arms into Cuba “*but that they were all DEFENSIVE weapons and threatened no danger for America.*”

But even as reports from extremely reliable sources bluntly contradicted that lie—even as films of the Nuclear emplacements were smuggled out of Cuba, Kennedy continued to pooh-pooh all the evidence and all the films *and the (managed) Press, Radio and TV fully supported him* — as did the Pentagon, State Department and CIA And, late in September, Mister Kennedy blithely set off on a politicking tour. A Congressional election was in the offing—and he had to make sure that the people would elect his chosen candidates. But everywhere he went his speeches were broken into by blunt questions about Cuba. By late October he realized that those questions were sure-fire harbingers of defeat for

the Democratic candidates. Panicked, he quickly resorted to another lie (*the easiest thing he can do*): On the excuse that he had been stricken by a "cold," he flew back to Washington, and, on October 22, without even a remote indication of a "cold," he piously proclaimed that he had "*just been informed*" that the Russian weaponry in Cuba were NOT just "*defensive*." And then he came forth with his "*brave confrontation*" of Khrushchev And he emerged from that "*confrontation*" as a great American HERO!

Forgotten were his lying denials of our (CEG) and Senator Keating's *documented* proof of the Russian Nuclear weaponry in Cuba—forgotten were his lies that the 25 to 50 thousand Russian troops in Cuba were "*Just a few technicians*"—forgotten were his (*and Bobby's*) collaborations with the NAACP, the ADL, with all pro-Communist plottings in the U.S. and all of Latin America that "*confrontation*"(?) made the vast majority of all of the American people forget all about all those treacheries and treasonous lies—and accept him as a great young HERO!

But WHO made us FORGET? WHO kept dinning into our ears and pouring into our minds the "HEROISM" of our "great" President? WHO kept telling us how that brave young HERO not only made Khrushchev cringe with fear, but forced him to hurriedly (and faithfully) agree to promptly remove all Russian troops and weaponry from Cuba—ALL TO BE DONE UNDER ON-SITE INSPECTION BY OUR (U.S.) OFFICIAL MILITARY EXPERTS? WHO kept eulogizing and glorifying this obvious political charlatan—WHO continued to lie, deceive and betray all of the American people?—NONE OTHER THAN OUR GREAT AMERICAN FREE PRESS and all of our other Mass Communications Media! ! !

Now, even in the midst of all the adulation for our "HERO," it became commonly known that the two Ks were exchanging secret letters—*the contents of which were never revealed!* But we do know that "*in return*" for Khrushchev's "*promises*" to remove all Russian troops from Cuba and denude the island of all Nuclear weaponry, our "HERO" faithfully pledged our country not to disturb Castro's dictatorship of Cuba — that we herewith were nullifying our sacrosanct "MONROE DOCTRINE" — that he would permit no attacks and/or invasions against Castro and Cuba from U.S. soil—*or from any other sources!* We know how our (*traitor*) HERO has been (faithfully) fulfilling that pledge — his bloody betrayal of the "*Bay of Pigs*" invasion is all the horrifying proof we need!

Yet, with all that proof, our Press and other Mass Communication Media continue to camouflage and shield all of his lies, all his betrayals, all his chicaneries—and continue to HEROIZE him!

Now let's go a step further: in that "*confrontation*" Khrushchev

"*faithfully*" agreed to on-site inspection (*by our military observers*) of the removal of the Nuclear weaponry and withdrawal of Russian troops and technicians. Khrushchev *rushed* Gromyko and Mikoyan to Cuba to make sure that Castro would not interfere with such inspection. But apparently (?) Castro strenuously objected . . . so our brave young HERO magnanimously took Khrushchev "*off the hook*" — he (*the HERO*) turned the whole matter over to the sacrosanct UN to see that the orders were carried out. And that man of "*great integrity*," U Thant, the self-acknowledged Burmese Marxist and devoted friend of Moscow, flew to Havana — to "*personally*" supervise the "*on-site inspections*" . . . but all his inspections consisted of were kindly pats on the heads of Castro and the Russians, with the assurances that *his* UN would not permit the nasty Americans to participate in the "*inspections*," or annoy dear "*Doctor*" Castro in any other way — and then U Thant flew back to UN headquarters — *and that was that!*

But to "*satisfy*" the American people — *and to ease our alarms* — our HERO issued a public statement that Khrushchev was "*faithfully*" fulfilling his promises. At the same time, we were treated to front-page pictures of Russian ships leaving various Cuban harbors with huge crates loaded on their decks—crates which, *so we were told*, contained Missiles and other Nuclear weapons. But all those crates were heavily encased in canvas and tarpaulins. For all anybody could tell, those crates were empty, or contained bags of sugar, of rocks, of sand, etc., etc. And on each occasion, when one of our naval vessels stopped a Russian ship to enable a boarding group to look under the coverings they were met with snarling "*nyets*," backed up by machine guns . . . and, on orders from Kennedy (to "*avoid incidents that might anger Castro or Khrushchev*"), those ships were allowed to proceed without inspections.

In the following days, we also were told, *by Kennedy*, that Khrushchev was withdrawing Russian troops and technicians at the rate of 2,000 men a day—and, *again*, we were treated with front-page pictures of the withdrawals . . . *BUT we were NOT told that those withdrawals were, at the same time, being replaced by twice as many Russians and Chinese Reds!*

All of the above only scratches the surface of the complete picture of Cuba as a Moscow Nuclear menace just 90 miles away from all of our vulnerable cities. I have in my possession *documentary* proof that, *as of today*, there are between forty and fifty thousand Russians and Chinese Reds in Cuba—I have the names and the locations of the Caves in Cuba containing Nuclear Missiles trained on the U.S. — I have the names and the locations of the inlets and harbors containing Russian submarines equipped with Nuclear

weapons — *I have documentary evidence of Kennedy-Castro backstage dealings which opened our doors to more than 4,000 RED AGENTS.*

I will publish all that information in one of our forth-coming "SPECIAL BULLETINS," but my chief objective in this issue is to show just how our Mass Communications Media, *particularly the Press*, are being used (*managed*) not only to keep us unaware of our dangers, but to keep us brainwashed in a feeling of security.

I have a vital reason for making that my chief objective, to wit: even our most alerted people simply cannot understand how our Press could have become so completely entrapped and controlled—many of them just cannot believe that all those thousands of Publishers and Editors, who prate about the "Freedom of the Press" and the integrity of their publications, can knowingly and deliberately falsify all the information they provide for their readers — they KNOW that many of those publishers and editors are, *in their hearts*, loyal Americans. And they just cannot believe that such men can be FORCED to slant the truth and to falsify the treason that is being perpetrated — they point to the indisputable fact that under our Constitution nobody can tamper with the "Freedom of our Press," or our "Freedom of Speech."

And, of course, they are right — our Constitution DOES guarantee all those rights. So, now I must clarify how all those Constitutional rights have been destroyed — how *honest* journalists are being FORCED to lie, deceive and betray — how they are left with a choice between bastardizing their publications into *brainwashing* the people — or suffer economic destruction.

A VITAL REMINDER

It was in 1947, when I first unmasked the Communist Conspiracy in Hollywood, and named the 100 top Stars, Producers, Writers and

Directors who were promoting and supporting the Conspiracy, that I first became aware that the Press had become one of the chief tools of the Conspirators for the "brainwashing" of the people. I revealed all that I had learned (*up to that time*) in my first book on the subject: "RED TREASON IN HOLLYWOOD."

And as I became more and more aware of the techniques that were being employed to tighten the enslavement of the Press, I revealed my findings in various of our "News-Bulletins." But at that time it was all so new, so fantastic, so utterly unbelievable, that hardly anybody took my information seriously. It was only after Kennedy brazenly proclaimed that the Federal Government would hereafter "manage" all "News" that the people were at long last shocked into the realization that we no longer have a "Freedom of the Press" that perhaps my warnings had not been as fantastic as they sounded at the time.

For the best reminder of those warnings I shall now repeat a few sections from our December 1954 "News-Bulletin" in which I made my most earnest effort to awaken the people — and, if possible, reach the consciences of the more loyal journalists.

"Freedom of speech is a principal pillar of all free governments; when this support is taken away, the constitution of a free society is dissolved, and tyranny is erected on its ruins."

"WE ARE FAILING OUR FATHERS!"

●

"In 1775 our Founding Fathers fought to give us the Freedoms which have made us the greatest nation within the known history of the world. But now, at the very peak of our greatness, we are failing our Founding Fathers — we are permitting the transformation of those very Freedoms into weapons for our destruction.

"We know the enemy . . . we see him transforming our Freedoms we know what he is planning, yet, like a too-full-fed pigeon, we sit still and browsily blink as he steals closer and closer — to knock us off with that "stick" that he has fashioned out of our Freedoms.

"ARE ALL MEN EQUAL?"

"Recently, Gerald W. Johnson, historian, wrote an article for which he used the above question as a heading. He based his article on the following statement by Thomas Jefferson in a letter he wrote to John Adams on October 28, 1813 'There is a natural aristocracy among men. The grounds for this are virtue and talents'

"'No one can understand American democracy,' Johnson philosophized, 'until he can understand how those words could have been written by a man who held it a self-evident truth 'that all men are created equal.' The explanation is that Jefferson knew that virtue and talents are acquired characteristics. All men are indeed created equal, but the acquirement of virtue and talents renders some superior to the rest, and it is to these superior men that the administration of education, justice, and public affairs should be intrusted.

"'The man who believes that he was born superior to others is an anti-democratic fool; but the man who does not believe that diligence, intelligence and integrity can make him superior to some others is equally a fool. As an American he is also anti-democratic, for America's representative democracy is based on the ability and the will of the people to choose natural aristocrats for their leaders.

"'Sometimes they fail. Sometimes they choose pseudo-aristocrats, virtuous men without talent, or talented men without virtue; and the failure costs the people dearly. But they have picked the combination, virtue-plus-talent, often enough to keep their Constitution working for 165 years. This is conclusive proof that most of the time they possess that vision without which the people perish.'

"Mr. Johnson's analysis is well taken until we reach his final observation—and there his error lies in one word: he should have said possessed instead of possess.

"Vision, as the word is implied by Mr. Johnson, is nothing more nor less than public opinion. It is public opinion that decides who is to be the President of our Country it is public opinion that endorses or rejects all those who seek public office. Public opinion is the yardstick by which ALL of us are measured. It is public opinion that gives us the vision to appraise the merits and demerits of those who seek to be our leaders.

"Public opinion is formulated and moulded for us by our various public communications systems, principally the Press, Radio, Television and the Motion Picture. That is why 'Freedom of the Press' (freedom of speech) has been the most cherished of all our Freedoms. It has been the watchdog of all our Freedoms. It gave us the vision to choose the 'natural aristocrat' and

to reject the 'pseudo-aristocrat.' It was the foundation on which we built our great Land of Liberty. A people can be as free only as its Press is free. Our Founding Fathers knew that and surrounded our Press with every possible safeguard against government control or interference. They made it so free that today it is even free to commit treason!

"There are various forms of treason. Hiss committed treason . . . the Rosenbergs who betrayed our Atom Bomb committed treason . . . Franklin D. Roosevelt betrayed us at Yalta and committed treason . . . all who helped to infiltrate Reds into our Government Agencies committed treason . . . all the One-Worlders who are seeking to transform the U.N. into a One-World Government are committing treason.

"By that token, our Press, Radio, TV and Motion Picture Screen are committing treason . . . they have been committing treason for at least the past half-century. During that period of time they have been creating the kind of 'public opinion' that blurs our VISION into rejecting our 'natural aristocrats' and into accepting the 'pseudo-aristocrats.' They revile and vilify the patriot and glorify the traitor McCarthy was the villain — George Catlett Marshall was the hero. They have transformed our precious 'Freedom of the Press' into a weapon that is blinding us into our self-destruction. By that token their degree of treason is greater, far greater, than that of a Hiss or a Harry Dexter White.

Here, however, in all fairness, I must emphasize that not all the men and women in our Press and other Communications systems are deliberate traitors. I will even say that the great majority of them acquiesce (by their silence) to the treason being committed through fear of economic disaster. In short, our Press is a captive of the Enemy and our 'Freedom of the Press' has become the chains of our gradual enslavement.

"In my book, 'Red Treason on Broadway,' I revealed with full details this evil Conspiracy that has enslaved our Press and made a mockery of our Freedom of speech. I named names and provided documentary evidence. I exposed the various forms of threats, coercion and blackmail that forces newspaper publishers and editors to slant the news and conform their editorial policies to the requirements of the Enemy. The method was always the same — 'obey, or we will pull out all your advertisers!' I cited specific cases. And I NAMED the 'Anti-Defamation League' as the Cabal that has the power to thus ruin any publisher who might dare to refuse to obey its dictates.

"PROOF

●

"Nothing so confirms a charge as the silence of the accused. The 'Anti-Defamation League' did not sue me for libel — they did not even try to

refute or deny my charges. The reason is very simple: they know that I have DOCUMENTARY evidence for every one of my charges—they knew that a lawsuit would crack the entire conspiracy wide-open.

"However, what I have stated in the preceding pages is by no means a secret in newspaperdom — and recently there have been signs of a brewing rebellion against this ADL enslavement . . . faint signs, as yet, but positive ones — as evidenced by the following Editorial in the Tulsa Tribune:

"STRANGE REPORTING

" 'Is there something funny going on in American journalism?

" 'In the (Aug. 20, 1954) U. S. News and World Report there is a fascinating interview with Rep. Martin Dies, who headed the House Committee on Un-American Activities from 1938 to 1945. It is entitled, 'They Tried to Get Me, Too.'

" 'Congressman Dies relates how he was attacked for his 'methods' by the 'liberal' orators, statesmen, columnists and reporters. He tells how Mrs. Roosevelt entertained Joe Lash and other officers of the Red-tinged American Youth Congress at the White House while they were under investigation by his committee and how she tried to get Lash into naval intelligence.

" 'Dies recounts the effort President Roosevelt made to call him off the Communist investigations. He describes the wild-swinging attack from the CIO, led by John L. Lewis. He tells how popular press reports were designated to smother his investigation with ridicule, as in the case of the famous Shirley Temple incident.

" 'Although subsequent history proved how right Dies and his committee were in their charges that high places in the administration had been infiltrated by Communists and although the committee named names that were later identified with high treachery it was impossible to get heads of the great government bureaus to act against these people.

" 'And always there was criticism of his 'methods'. All the politicians and writers who sought to destroy Dies painstakingly pointed out that they approved of his patriotic object but they didn't like those 'methods'. The same cry, says Dies, has been raised against every man in Congress who ever conducted a serious investigation into Communist subversion.

" 'But it's not the history that worries us. Here's what does.

" 'The Dies interview took up 14 pages in the magazine. At one point on the 12th page he was asked if he had any advice to give Joe McCarthy.

Dies replied that on some occasions he felt McCarthy had rushed into trouble he could have avoided and that he disagreed with McCarthy's claim that Federal officials should in all cases reveal secret information to Congressional investigators.

" 'These admonitions occupied just six paragraphs out of the 149 paragraphs in the interview.

" 'Yet the United Press account of the interview spent all six of its own paragraphs describing how Dies felt that McCarthy had made mistakes. A reader of the U.P. report would gain the impression that Dies had joined the mob attacking McCarthy's methods.

" 'And the Associated Press story of the same interview spent 10 of its 13 paragraphs on Dies' two points of criticism of McCarthy. Again a reader would assume that Martin Dies disapproved of McCarthy.

" 'Nowhere in either story was there a word about Dies' sensational disclosures of Communist coddling in Washington during the time he headed the committee, not a line indicating how Dies was drawing a parallel between the abuse he took and the abuse McCarthy is taking.

" 'What is going on in American journalism?

" 'Why, when Cardinal Spellman made a long speech generally supporting McCarthy, did the New York papers haul out one sentence of mild criticism, leave out the rest of the speech, and made it appear that the Cardinal had joined McCarthy's critics?

" 'Why are millions of Americans who watched the McCarthy hearings on television shocked to find that reported versions in their newspapers were so much at variance with what they had actually seen?

" 'The press and the wire services that feed it are on trial. It is the right of an editorial writer to fulminate as he pleases. But when news stories and particularly wire service stories, which are supposed to be balanced and factual, begin to reflect the hysterical polemics of the American Newspaper Guild every newspaper in the land may be heading for trouble.' "

A CALL TO ARMS

●

"There is far more in that editorial than meets the eye: Richard Lloyd Jones, the man who wrote it, has the answers to all the questions he raised. He knows that the Chairman of the Board of Directors of the Associated Press is Eugene Meyer, owner of the notoriously pro-Red-Washington 'Post' and who is high in the top brass of the 'Anti-Defamation League' and the

Internationalists . . . he knows that the Scripps-Howard organization, who control United Press, are in the financial clutch of the Internationalists. All our other Publishers and Editors know it. All of them know all there is to know about the ADL's enslavement of the Press. Most of them bitterly resent that enslavement. But they all go on taking their orders . . . they go on slanting the news and their editorials . . . they go on creating 'public opinion' to belittle and smear our 'natural aristocrats' and to glorify the 'pseudo-aristocrats.' In other words, they go on deluding the American people into giving the leadership of our nation into the hands of those who are determined to transform the United States into an enslaved unit of a Communist One-World Government. Their excuse is the fear of the ADL's power to destroy their advertising revenue. But that fear is a false fear—the threat of the ADL has been tested and found to be more bugaboo than real! The Editor of the Tulsa Tribune knows that. He knows that if all publishers and editors who can still feel a flicker of self-respect and loyalty to country would take concerted action they can smash that bugaboo as easily as a cat can destroy a rat . . . that the smashing of that bugaboo would restore the 'Freedom of the Press' . . . that a Free and fearless Press would smash the entire Conspiracy to destroy America. That editorial is a 'call to arms' to all those publishers and editors!"

HOW IT CAN BE DONE

In "Red Treason on Broadway" — and again in our July (1954) "News-Bulletin" — I established that the Enemy early realized that control of the Press was a MUST if their conspiracy to destroy the United States as a sovereign nation was to succeed. I pinpointed their various steps to achieve that control. Actually, it required only four major steps to accomplish it.

1) Outright purchase of influential newspapers and magazines in various parts of the country by "Syndicates" financed by such Internationalist Bankers as Lehman Brothers, the Warburgs, Kuhn-Loeb, the Rockefellers, etc., and organized into "chains" whose "Editorials" and "News" would be controlled by the Masterminds of the Great Conspiracy (*the "Council on Foreign Relations"*); 2) Financing individual publishers who were willing to repay with editorial treason; 3) To get control of the working press, such as the reporters, critics, sub-editors, etc., they created the "American Newspaper Guild." That "guild" is more than a mere Union for "collective bargaining" purposes; it serves as a SANCTUARY for the Reds and "Liberals" in journalism — no publisher can fire even the known Reds without the consent of that "Union" unless he is

willing to face a complete shutdown. That "Union" is also the spawning ground for brilliant writers without scruple who can be groomed for high places in the profession — such columnists as Elmer Davis, the Alsop boys, Drew Pearson, Walter Lippman, etc., etc., — all crafty word carpenters who can idealize Marxism, who can create mental pictures of horns and forked tails for a Joe McCarthy, a Martin Dies, a Bill Jenner — and a halo for a Franklin Roosevelt, a George Marshall, an Eisenhower, for all other traitors . . . writers who can make TREASON spell HUMANITARIANISM.

Even so, just those three steps could never have spelled CONTROL, because there were thousands of publishers that could not be reached through any of those steps. It was their fourth step that did the trick. That was the control of advertising by the "Anti-Defamation League" — as described in "Red Treason on Broadway."

NOTE: "RED TREASON ON BROADWAY" is now out of print, but the entire ADL story is contained in my latest book "DOCUMENTATIONS OF THE REDS IN HOLLYWOOD AND TV" (\$2.00 per copy. MCF)

Under the guise of decency and "humanitarianism," the ADL, created in 1913, bent all efforts, from its very inception, to gaining control of the advertising budgets of Department Stores and all types of advertisers — and, *with the help of the CFR*, they succeeded. They did it so quietly and smoothly that nobody so much as sensed their objective. They did not accomplish it overnight, but by 1930 they had acquired a truly frightening power. By 1940 not a newspaper or magazine publisher dared to oppose their wishes. Governors, Senators, Congressmen, Mayors, Judges, all jump at their command. Throughout their formative years their entire camouflage was that their only objective was to prevent the spreading of anti-semitism. But as they grew in power they became bolder and bolder — they began to scorn explanations and qualifications for their acts — their slogan became: obey or be destroyed!

And now I will reveal what seems to have been a well kept secret: the entire power of the ADL lies in the "fear" they have generated. Put to test, the threat with which they have enslaved the press is as empty as a kid's toy pistol. Any publisher can call their bluff *and make them run for cover* — as I proved with the following citation in "Red Treason on Broadway":

"ANY NEWSPAPER CAN LICK ADL

"As a matter of proven fact, any one newspaper with good old-fashioned American backbone can successfully defy the ADL and make them crawl. It has been done—by the publisher of one of the most important newspapers in the middle-West. His paper had never directly tangled with the 'Anti-Defamation League,' but, early in 1951, he opposed certain national legislation backed by them. One fine day, an ADL Committee called on this publisher. They placed a list of the city's largest advertisers on his desk and wrathfully told him that if he did not agree by noon of the next day to change his paper's editorial policy all the merchants on that list would withdraw their advertising at the end of the week. The publisher looked over the list and told the Committee they didn't have to wait until the next day for his decision—he'd give it to them right then and there: the decision was NO! 'And,' the publisher quietly added, 'the first advertiser who will withdraw his advertising will, on the following day, find his regular space devoted to a full explanation to the public why the ad was withdrawn—and that it would continue every day with every ad withdrawn.' The dismayed ADLers looked at each other; then, with a sickly smirk, the Chairman asked the publisher to 'forget all about it.'"

"(NOTE:—The newspaper referred to in the above is located in Tulsa, Oklahoma. There is no need to more specifically identify the publisher—except by the statement that he is a MAN who treasures the ethics of his profession, the 'Freedom of the Press' and loyalty to country far above all the advertising dollars in the world. Ed.)"

"THEY ALWAYS CRAWL

"The Tulsa Case is not the only one that proves my contention. In New York we have another publisher who refuses to swoon at the mere mention of the ADL. His newspaper has the largest circulation in New York City—which means, in the United States. Several years ago he published several editorials that aroused the ire of the self-imposed Censors of the Press. They promptly sent a Committee to inform him of their displeasure. As in Tulsa, they laid down their ultimatum—as in Tulsa, the New York publisher dared them to go through with their threat—and, as in Tulsa, the Committee meekly tucked its collective tail between its collective hind legs and humbly asked the publisher to 'forget it.'

"Newspaper publishers like those two are almost an extinct breed, but

there are a few left—and whenever the ADL bumps into one of them they hurriedly slink away, with a plea to 'forget it.' And, make no mistake about it, it is a plea—because they know that if the publisher were to front page the story—and name the merchants—it would spell ruin for those merchants, and thus transform their one and only weapon into a boomerang for their own destruction. That is not a guess . . . it happened!

"James Ewing is the editor of the Monroe (Louisiana) 'News-Star.' Jim is another one of that nearly extinct breed. But he is even more militant than the two previously mentioned—he views pressures to suppress the truth in print as blackmail. Thus, when the ADL decided to 'pressure' him into changing his editorial policy, they smashed headlong into disaster—Jim Ewing refused to 'forget it.' The story he published did not name the ADL's merchant stooges—but it carried a promise that he would publish names if any member of that Cabal so much as came near him again. And the reaction of the townspeople was that it would be highly advisable for such named merchants, when and if named, to 'close up shop' forthwith. That was enough! The terrified merchants promptly closed their doors to the ADL . . . Today there is no ADLism, no Communism, no One-Worldism, no Un-Americanism of any kind in that community . . . all because ONE man had the intestinal fortitude to fight for his AMERICAN birthright."

"Those three incidents, but especially the last one, prove beyond a doubt that a courageous AMERICAN press can quickly restore the Freedom of the Press and cure our Country of the ADL cancer, the Reds, and of all the enemy within, by simply turning a full spotlight on their activities. The important point is that it must be done NOW — before it is too late! The timid and enslaved, but otherwise loyal, journalist must be given a shot of courage in his spine — the disloyal one must be driven out! There is one sure way to accomplish both of those 'musts.'

"The strength of a newspaper lies in its readers, not in its advertising columns. A newspaper's crusades against crooked politicians, racketeering, gangsterism, and all other evils in the community, are always based upon its power to arouse the anger of the people. That same 'anger' can just as easily make or break a newspaper publisher. In the following pages I will present proof that 'the Voice of the People' can dictate the editorial policy of the press even more effectively than all the evil powers of the ADL.

"LOYALTY PAYS OFF

"The Los Angeles Herald-Express is the most highly respected and highly regarded newspaper on the Pacific Coast. It was not always so. For many

years the 'Times' was the top newspaper in Los Angeles. Founded by General Harrison Otis, it was lustily American throughout his administration. Then it passed into the hands of his son-in-law, Harry Chandler, and from him to its present owner, Norman Chandler. The character of the paper slowly but surely changed. It became more 'liberal.' It lent a ready ear to the 'Anti-Defamation League.' Hesitant to risk an all-out 'Internationalist' policy in its own columns, it finally set up a tabloid, the 'Mirror,' which, to put it mildly, is as Left as Dorothy Schiff's New York 'Post.'

"Conversely, the editorial policy of the 'Herald-Express' became more and more AMERICAN. It helped to unmask 'Unesco' — and spearheaded the campaign to have it hurled out of the Los Angeles schools . . . it led in the fight to smash the treason plot of the 'United World Federalists' . . . it fearlessly reveals the chicaneries and planned treacheries of the 'United Nations' and the Internationalists. And, to my knowledge, it has always rejected all the pressures of the 'Anti-Defamation League.'

"Today it is the 'Herald-Express' that has the full trust and regard of the true Americans in Southern California, whereas the 'Times' is 'suspect.' Which indicates that the American people are slowly but surely waking up."

NOTE: All of the above citations from our News-Bulletin No. 40, published in December 1954, accurately described the perfidiousness of our Press until that time. It also emphasized the journalistic honesty of the "Los Angeles Herald-Express". I will now cite two incidents to show the desperation of our plight — and the desperate measures of the ENEMY to destroy the loyalty of the few honest journalists. M C F

HERALD-EXPRESS MUZZLED

In November 1961 we (CEG) devoted our issue of that month to a complete unmasking of "UNESCO." We revealed that outfit's plot to completely control all of the educational systems in the United States — and thus *brainwash all our children into complete acceptance of Communism and "One-World Government."* The title of that News-Bulletin No. 86, was "UNESCO: No. 1 ENEMY OF AMERICAN YOUTH"

Simultaneously, we issued a condensed version of that News-Bulletin in a six-page pamphlet ("*Tract*"), which quickly went into wide circulation (*millions of copies*) throughout the nation.

That *News-Bulletin No. 86* is truly one of the most sensational, if not THE most sensational, of all the publications we ever issued. It revealed the names of all the officers and directors of UNESCO, *practically all of them Russians and Communists of all degrees* — it revealed both NEA and the National PTA as its chief tools and collaborators — it revealed how our State Department *officially* supports it — and collaborates with it . . . it *PANICKED* the *Conspirators!*

The research to acquire all the information for that document was probably the toughest assignment we had ever faced, and I want to take this opportunity to give full credit to certain individuals on the L. A. "*Herald-Express*" who devoted many precious days to aid in that research . . . But now for the first incident I promised:

Immediately after we (CEG) issued our (UNESCO) No. 86 "*News-Bulletin*," the Editor of the Los Angeles "*Herald-Express*" assigned one of his top Feature writers to write a series of (*not less than five*) articles further unmasking "UNESCO" — *in line with our News-Bulletin.*

Immediately after I received that information, I (CEG) issued a "*SPECIAL BULLETIN*" to alert all of the American people to this most amazing *and gratifying* loyalty of the Los Angeles "*Herald-Express*" — and urged everybody to render all possible support to this newspaper. The response to that "*SPECIAL BULLETIN*" was truly amazing — and provided prima facie evidence of the loyalty of the American people when and if properly alerted. Directly from the office of the "*Herald-Express*," I was informed that it was *deluged* by many thousands of *paid* subscriptions from all over the country. Simultaneously, the New York headquarters of the Hearst Syndicate was flooded with letters from all over the country, urging Wm. Randolph Hearst, Jr., Editor-in-Chief of the Hearst chain of newspapers, to transform the Editorial policies of all the Hearst newspapers to conform with that of the Los Angeles "*Herald-Express*."

Now, you would think that that was all that should have been necessary to convince Mr. Hearst that that was a mandate from all of the American people to make the Hearst newspapers the true "*VOICE*" of the American people. But, amazingly — *and shamefully* — it accomplished the very reverse, to wit:

On the very morning after the "*Herald-Express*" published its first "UNESCO" story, a long-distance telephone call from the

New York headquarters ordered the immediate cancellation of the "UNESCO" series — together with a peremptory order that under no circumstances was there ever to be any derogatory mention of UNESCO in the columns of the L. A. "Herald-Express" — and, *we must assume*, in any of the Hearst publications . . . *talk about "managed" news !!!*

But, as Al Jolson used to say: . . . *Wait, you ain't heard nothin' yet!*

During the past ten or more years, we had four major newspapers in Los Angeles; to wit: The L. A. "Examiner" (a morning newspaper) and the L. A. "Herald-Express" (an evening newspaper), both owned by the Hearst Syndicate — and the L. A. "Times" (a morning newspaper) and the "Mirror" (an evening Tabloid), both owned by the Chandlers.

Throughout those years there was keen rivalry between the Hearsts and the Chandlers. The Hearst papers leaned to Conservatism — the Chandlers leaned (*heavily*) to "Liberalism." The Hearst papers published the Westbrook Pegler and George Sokolsky type of Columnist — the Chandlers favored the Walter Lippman, Alsops, Drew Pearson type.

However, in the late 1950s increased costs in operation and reductions in revenues forced the Hearsts and the Chandlers to more or less bury their rivalries. The "Mirror" was a financial flop from its outset, and the "Examiner" was drifting more and more into the "red."

Anyway, with that as the (*proclaimed*) main reason, and for other unknown reasons, the Hearsts and the Chandlers "agreed" that Los Angeles could not support four major newspapers, and they decided to "merge" the "Times" and "Mirror" into one morning newspaper — and the "Examiner" and the "Herald-Express" into an evening newspaper, to be known as the "Herald-Examiner."

Those "mergers" went into effect December 1961, and, beginning on January 11, 1962, Los Angeles was reduced to two major newspapers.

This new arrangement created a great problem for the ADL. The previous rivalry between the Hearsts and the Chandlers had played right into their hands. The ADL's (*previously mentioned*) control of advertising budgets had enabled them to control the editorial policies of all the newspapers by threats of reduced ad-

vertising volumes unless their demands were met. But with only one morning newspaper and one evening newspaper that blackmailing technique lost all of its potency — no Department Store would dare to confine (*or even reduce*) its advertising to just one newspaper — it would mean ruin for them.

However, those “*mergers*” also played (*temporary*) havoc with the “*brainwashing*” operations of the “*Masterminds*” in Washington. Not that either publication even remotely indicated objection to “*management*” of news — and they faithfully continued to slant their editorial matter to the complete satisfaction of the “*Masters.*”

It was the sudden “*economy mindedness*” of the publishers that threatened to disrupt the “*brainwashing*” process in the Southern California area.

You see, the “*Liberal*” columnists are the most effective instruments in the entire “*brainwashing*” technique. And let there be no delusions about their effectiveness. The Walter Lippmans, the Marquis Childs, the Alsops, the Eric Sevareids, etc., etc., unquestionably are the smoothest and most (*fiendishly*) clever word carpenters in journalism. Even Drew Pearson, and the others of *his* ilk, with all their crassness, have a distinct place and value in the “*brainwashing*” operation. But it is the smooth and well-turned phraseology of the first mentioned columnists that entraps the unwary reader — it is *their* verbiage that has transformed “*patriotism*” and “*loyalty to country*” into “*dirty words,*” the mildest of which are “*Extremists . . . Rightists . . . Fanatics . . . witch hunters . . . Racists,*” etc., etc. . . . it is *their* verbiage that mentally envisions, for the naive and the unwary, all the trappings of hell (*the horns, the forked tail and the clovenfoot*) for a Joe McCarthy, a Martin Dies, a General Walker, a Robert Welch, any (*determinedly*) dedicated American patriot. In short, I repeat, the “*Liberal*” columnists are the most effective instruments in the entire “*brainwashing*” arsenal. Thus, when several of their most important ones disappeared from the Southern California scene as a result of the mergers of the Los Angeles newspapers, it quite naturally “*shook-up*” the “*Masterminds*” — it threatened to disrupt their entire “*brainwashing*” operation. The malodorous “*Washington Post*”, which syndicates virtually all of the “*Liberal*” columnists, urged the L.A. “*TIMES*” to provide a “*home*” for the columnists previously published in the “*MIRROR*”. They made a similar appeal to the publishers of the L. A. “*HERALD-EXAMINER*”. But both the Hearsts and the Chandlers turned deaf ears to that appeal — the costs of the white space, labor and fees for those columns were some of the items that forced the mergers of their publications, and they were not of a mind to load those costs on the

surviving newspapers and thus (*at least*) partially defeat their (*economy*) objectives.

However, the "*Masterminds*" just could not permit the people in Los Angeles, and, by that token, in all of Southern California, to be deprived of the "*sage*" opinions of their self-declared "*pundits*" — opinions which not only bolstered, but *anchored* the "*managed news*" phase of the "*brainwashing*" operations in the minds of the naive and unwary. Indeed, without the Lippmans, Alsops, McGills, etc., to offset the continuing columns of the loyal American Henry J. Taylors and Fulton Lewis, Jrs., etc., even the most naive readers might begin to think — *and that must never be permitted!* So, not so surprisingly, one fine day, the Hearsts and the Chandlers were summoned to Washington and haled into the "*awesome*" presence of none other than the U. S. Attorney-General Bobby Kennedy — the man flippantly referred to as "*The Chipmunk*" by Westbrook Pegler — to be solemnly warned that the mergers of their newspapers made them liable to various horrendous Federal suits: "*restraint of trade*" — "*Conspiracy*," etc., etc., being the mildest of them. All such threats were so puerile, so utterly far-fetched, that they were worthy of nothing but raucous laughter — there is nothing in Federal or State statutes that can force a publisher to continue publishing, no matter what his reasons may be for discontinuance. I am sure that the Hearsts and the Chandlers were fully aware of the ridiculousness of Bobby's threats — but they didn't laugh. No doubt there were other threats and pressures. And both Hearst and Chandler were fully aware that the Kennedys stop at nothing, within or outside the laws, to achieve their objectives. So, before they left Washington, both publishers "*signed-up*" with the "*Washington Post*" for all the "*Liberal*" Columnists syndicated by that malodorous outfit — and acquiesced to all other demands of the powers-that-be in our Invisible Government— *for whom the Kennedys serve as faithful stooges.*

Now, that incident in Bobby Kennedy's office is not based on hearsay — it was revealed to me by top staff members of both the "*L. A. Times*" and the "*Herald-Examiner*."

And that is how our Press, willingly, or unwillingly, has been — *and still is* — brainwashing the American people.
