## HISTORY OF THE UN PLOT TO DESTROY U.S.

---

Shakespeare said: "*The Play is the thing wherein I will catch the conscience of the King.*"

I say: This "BULLETIN" will catch the conscience of the American people and prove to even our most gullible and uninformed ones that: "*IF THE U.S. IS TO LIVE, THE U.N. MUST DIE.*"

---

For the intelligence of newcomers to our publication—and because the objective of this "BULLETIN" is truly the salvation of our Country, and desperately needs the help of all loyal Americans, I earnestly hope there will be MANY millions of such newcomers—I believe that a brief background of our organization, and how and why it came into being, will be importantly revealing to them.

### THE ORIGINAL "JOB" OF "CEG:"

---

In the late months of 1945, in response to urgent appeals from Senator Vandenberg, Congressman Parnell Thomas, then Chairman of the "House Committee On Un-American Activities," and officials of the FBI, I organized a group of loyal Americans in Hollywood, among them Adolphe Menjou, Rupert Hughes and various Stars, to unmask Hollywood as one of the chief instruments of the "ILLUMINATI-CFR" Conspiracy to transform the U.S. into an enslaved unit of their then just-born "UNITED NATIONS" One-World Trap.

(Note:—If you are one of our "newcomers" and don't know who and what the "ILLUMINATI-CFR" is I urgently suggest that you get (from CEG) a Set of RECORDINGS entitled "THE ILLUMINATI-CFR CONSPIRACY," MCF.)

---

After many months of research, we acquired a mass of *Documentary* proof of ORGANIZED Communist activities by various of the Hollywood (*Moguls*) Producers and 300 Top Stars, Writers and Directors. We turned it all over to the FBI and the "House Committee On Un-American Activities." It resulted in an immediate

Congressional "Hearing" in Washington. That "Hearing" created a nation-wide sensation. The Press and Radio, although controlled by the CFR, did not DARE to HUSH-HUSH it. Ten of the top Conspirators (*Heads of the "Hollywood Red Conspiracy"*), commonly remembered as the "HOLLYWOOD TEN," were sent to prison, and practically all of the 300 Celebrities were driven off the Screen. . . . It also killed off attendance and closed many of the Movie Houses throughout the Country. . . . *Our entire Hollywood and TV Cancer could have been cured right then and there!*

But Congress did NOT, as they should have, declare the Communist activities of all the Celebrities to be CRIMINAL TREASON . . . and the Press went into deep silence after that "Hearing." The Reds waited two years—and then began to flock back into Hollywood. And the people, *as is tragically customary with them, "forgot" all about the revelations of the "Hearing"* and began to flock back into the theatres—which again were showing their New "Treason" Films. Again, we (CEG) launched a campaign against the renewed Conspiracy. It resulted in another Congressional "Hearing" in 1951—and, once again it resulted in a nation-wide Press sensation—and, once again, it drove all the Reds out of Hollywood.

But, *as before*, the CFR-controlled Communications Media again went into complete "slumber" about it, and as soon as the people again FORGOT, the Reds again came flocking back onto the Hollywood Lots. *And they have been here ever since—on the big Screens in the Theatres and on the little Screens of your TV Set right in your Living Room, both spewing Communist propaganda, both encouraging, urging and furthering all the Racial upheavals and rioting throughout the Land, both feeding filth, race-mixing and pronography into the easily impressionable minds of YOUR children! ! . . .*

Now, you might well ask: why, after we had twice driven that horrifying phase of the Great Conspiracy out of Hollywood, hasn't it been kept off the Screens? Actually, there are three answers for that question: (A) Despite efforts of several loyal American members, Congress, as a whole controlled by the CFR, never legislated that such acts are TREASON, *to be punished as such*; (B) The CFR-controlled Press has constantly been defending and shielding the perpetrators of that TREASON, employing the *Court-approved edicts* about the CONSTITUTIONAL rights of FREE SPEECH, (C) And, most importantly, thus deprived of all LEGAL MACHINERY to smash this brainwashing propaganda TREASON, we, the people, have never created a nation-wide "Vigilante" action to stop the traitors in the only sure-fire way that we had out-

lined in our "News-Bulletin" No. 125, entitled: "HOW TO GET THE REDS OUT OF ALL MASS COMMUNICATIONS MEDIA." *That method, if adopted by enough Americans, would have done the JOB, beyond any doubt! ! ! It still can do it! But that's another story.*

## THE NEW - AND PRESENT - JOB OF "CEG"

---

Before going into the matter of the "*present JOB of CEG*," I feel that it is necessary to establish the vast importance of "CEG" to the *entire* fight for the salvation of our Country:

When Menjou, Hughes and I announced our intention to bring about a Congressional investigation of the "RED CONSPIRACY IN HOLLYWOOD," the hierarchy (Moguls) of that Conspiracy did not take the "*threat*" very seriously, because they had quietly spread the word that any member of the Film Industry who would cooperate with such an investigation would be "*blacklisted*." In other words, it would mean the end of his and/or her career in the industry. But neither was that threat taken seriously by the loyal Stars and Celebrities—they theorized that such a "*blacklisting*" would mean the wreckage of the entire Industry (*as it eventually did*) and no man like a Louis B. Mayer, a Harry Warner, a Schenk, regardless of orders from their overlords in New York, would make that kind of a personal sacrifice. But, as we know, those Moguls *did* mean, and *did* carry out their threats—we know what happened to Menjou, to Bob Taylor, to Judy Garland, to Hughes, and to many others.

Anyway, after that first Congressional Investigation, the previously defiant CEG group, *without whose cooperation there never would have been such a "Hearing,"* realized that the Moguls had not been merely threatening, and that their careers *would* be the price of their continuing cooperation with the "*House Committee on Un-American Activities*," and they informed me — *that is, most of them did*—that they felt they had done their "*bit*" for Country and had decided that (*to placate the Moguls*) we should disband CEG and leave the fight to save the Country to the people as a whole.

But I did not agree. First of all, I knew that because I had been the leader in that plan to create that Congressional Investigation, the Moguls, even if they would relent the "*blacklisting*" of all the others, would never forgive me. In short, *my "crime"* had brought my career in both Hollywood and Broadway to its end. So, one

might say—and some did—that I had nothing to lose by continuing the battle against the Hollywood Reds.

However, *that was not* my reason for refusing to disband CEG. In our researches, I had found that the CFR had infiltrated their poisonous Conspiracy into *every* phase of the life of our Nation. I found that, in addition to Hollywood, they had achieved absolute control of ALL our Mass Communications Media (*Press, TV, Radio*)—of our Money System—of our Judiciary—and, *most important*, of both our Political Parties! Control of our Political Parties meant that every man we “*elected*” into the White House, whether a Democrat or a Republican, had to be an *obedient* member of the CFR—that all the men chosen for his Cabinet, for his White House Counselors, even for his Chiefs of the Armed Forces, had to be *obedient* members of the CFR . . . . In short, I had found that TREASON was rampant not only in our White House, but in every important Federal office in Washington—even in our Congress! ! ! And that the very life of our nation was at stake!

And I, and some of the more courageous loyal-to-Country Stars, Writers and Directors, decided that CEG would have to be kept alive to carry on the fight *for the salvation of our Country*.

But we know that to *successfully* alert and arouse the American people to the great menace of the Great Conspiracy to destroy our Country we would need the help of other loyal Americans *to spread the story into all Communities throughout the Land*. We could expose the various plots and schemes of the CFR Conspirators in “*News-Bulletins*” and “*Tracts*,” but, with all book-sellers and magazine distributors controlled by the ENEMY, we would need the help of loyal Americans all over the Country to circulate those “*News-Bulletins*” and “*Tracts*” to all their friends and neighbors in their communities. Thereupon we opened the memberships in the CINEMA EDUCATIONAL GUILD to *all* Americans. And, by the grace of God, we found many loyal-to-America men and women in various parts of the Country who agreed with us, who joined CEG, and through whose efforts we have been able to keep MANY of the American people sufficiently informed and alerted *through our*

"*News-Bulletins*" to help us torpedo many of the most dangerous plots of the CFR and the UN (*aided by our Traitors in Washington*) to destroy the Liberty and Freedom of the wonderful Land our Founding Fathers had handed down to us.

---

And now let me tell you the actual objective of this "BULLETIN," which I am directing to YOUR *special attention*, and to the attention of all the members and ALL co-workers of CEG—and, I hope, *FINALLY* to the attention of all the American people through your cooperation: That objective is to FORCE Congress to haul in the UN and its phony "Charter" for a thorough investigation which should automatically take the U.S. out of the UN. . . . and simultaneously uncover the TREASON of the CFR and all their stooges in our Federal Government.

---

SPECIAL NOTE:—You will find the reason for my absolute confidence that you can get EVERY one of your friends and neighbors to join us for that objective in our "September, 1970 SPECIAL BULLETIN." Read it again, then have your friends read it again. The "Revelation" it contains that unless we get the U.S. out of the UN, BUT QUICKLY, we, all of us, will soon be paying an INCOME TAX to the UN will cause EVERYBODY to join us in the project to get the U.S. out of the UN.

---

So now I repeat: If we can get all the loyal American people, or at least the majority of them, to combine for this objective we will accomplish it overnight, so to speak—I will show you why it should be a very easy job:

Every member in both Houses of Congress KNOWS that the UN is an absolutely illegal and phony organization . . . Every lawyer in the Land knows it. They know it, because under our Constitution the U.S. can enter into TREATIES only with other Sovereign Nations. There is absolutely nothing Sovereign about the UN—it is a ragtag assemblage of agents of various nations and Tribes, many of which are not even *classified* as Sovereign Nations. Therefore, our "Treaty" with the UN, to express it mildly, has been a spurious (*fake*) deal from the very outset. Nevertheless, with the help of the CFR Traitors in our Federal Government and in our Congress, the UN has arrogated to itself a phony Sovereignty, and, with the treasonous help of our Judiciary (*especially Warren*), has

set itself up as the "LAW OF OUR LAND." Thus, Congress can easily declare it spurious—and therefore null and void.

Now, it is a matter of common knowledge that every disaster our Nation has suffered since 1945 has been due to the machinations and treason of the UN—and the CFR! That includes the Korean War and the present Viet Nam "War," which have murdered and maimed many hundreds of thousands of our young sons—it includes all of the lawlessness and anarchy that has been tearing our Nation to shreds, *which could easily be controlled by proper action by our Congress*; yet no action has been, or is being, taken to put an end to all that. *Why?*

During the past years various individual Members of Congress, particularly the late James B. Utt, have stressed that fact. Each one of them has submitted BILLS to haul the UN in for proper investigations to prove that the UN is directly responsible for all that—and to get the U.S. out of the UN trap! But, on every occasion, all those BILLS have been smothered by the Emanuel Cellers, the Jake Javitses, the Fulbrights, etc., etc. Yet, there is *proof* that if the people had properly used their power they could have forced their Representatives and Senators to approve any one of these BILLS, and the UN (and the CFR) would have been unmasked and the entire GREAT CONSPIRACY would have been smashed. . . . Let me PROVE that to you—let me prove it by *showing* you how concerted action by the people has saved us from some of the most horrifying plots of the UN:

At the time when our Senate had decided to approve and sign the UN Charter, Senator Connally demanded (and succeeded) the insertion of an Amendment in the Charter that would prevent the UN from interfering with the internal affairs of our Country. That was a terrific, *actually an insurmountable*, obstacle to the UN-CFR plot for complete control of our nation. They promptly tried to put over their "GENOCIDE TREATY" to offset that "*Connally Amendment*"—and in 1950 Truman was all set to twist-arm our Senate into ratifying it.

Immediately we (CEG) issued a "SPECIAL BULLETIN" in which we revealed exactly how the proposed "GENOCIDE TREATY" would place (and enslave) all White Christian Americans under complete control of the UN's One-World Court. In addition, we issued a "*Tract*" which, contained a verbatim reprint of the "GENOCIDE TREATY," and which we urged ALL the American people to *sign* and send copies of it to all their Senators, together with personal letters warning them that if they would ratify the



"GENOCIDE TREATY" it would mean the end of their political careers.

*Now let me show you that we CAN depend upon the people to go into ACTION once they are fully awakened and aroused—and how that kind of ACTION can positively save our Country—that it is the ONLY kind of action to save our Country:*

When I first broached that project to prevent the Senate's ratification of the "GENOCIDE" PLOT, my closest (CEG) associates told me it would be a "Love's Labor Lost"—that the people had become so brainwashed by our treasonous Mass Communications Media, and mesmerized by our Traitors in Washington,—that it would be impossible to arouse them to do the job. Nevertheless, I had faith, and went ahead. I appealed to the American Legion, the VFW, the DAR, Womens' Clubs and other loyal American organizations and Patriotic Groups to join CEG in the project, and to circulate the "Special Bulletin" and "Tract" throughout the Country. To my great gratification, and to the surprise of my associates, all those groups *did* join in the project as soon as I made them realize how vital it was . . . in a matter of months, *indeed weeks*, every member of the Senate was inundated by avalanches of signed "Tracts" and personal letters from their constituents—and *despite all of Truman's arm-twisting, and despite all the powers of the CFR, the Senate adamantly refused to ratify the "Treaty."*

The CFR-UN seemingly dropped their scheme—but here let me tell you: this gang of Conspirators NEVER QUILTS. They *pretend* to quit, so as to make the people FORGET—then they launch the very same plot, either under another name, or under the very same name. I submit this very "GENOCIDE PLOT" as proof of that statement:

The CFR-UN can never achieve their One-World Conspiracy in so far as the U.S. is concerned unless and until they acquire absolute enslavement control of the American people by a (*supposed*) Law that will destroy all of our Constitutional protections . . . the "GENOCIDE TREATY" would be such a Law! So, when we torpedoed their first (*Truman*) attempt to get it ratified, they (*the UN*) waited for three years—*until* 1953. They figured that by that time the people would have forgotten all about it—in addition, in 1953 they (*the CFR*) had a wonderful new tool (*Eisenhower*) in the White House. Eisenhower was virtually a GOD with the American people. Who would dream of opposing an Eisenhower wish? So, in 1953, they (*CFR-UN*) ordered the GOD MAN to have the same old "GENOCIDE TREATY" ratified by the new Senate. . . .

We (CEG) were promptly informed about it—we promptly duplicated our action of 1950: we again flooded the nation with our "Special Bulletin" and "Tract," together with the same directives to the people. And the people responded, exactly as they did in 1950—and again all the Senators were terrified into refusing ratification for the "TREATY."

Do you think that was the end of the "GENOCIDE" Conspiracy? Oh, no!!! They (CFR-UN) waited another three years—and then ordered Eisenhower to try it again. Eisenhower obeyed them; but we (CEG) had again alerted the people to warn their Senators—the people did, and the Senators again obeyed *them, their constituents*, not Eisenhower.

But, wait: that still was not the end of that "GENOCIDE" plot.

As I have previously stated, the Conspirators cannot complete their "One-World" objective as long as the "Connally Amendment" remains an integral feature of the UN Charter—and only a "GENOCIDE TREATY," *completely independent of the CHARTER*, could remove the "AMENDMENT" as the great obstacle to their Conspiracy.

Eisenhower's second failure to achieve a ratification of the "GENOCIDE TREATY" put three strikes on that plot. The CFR-UN Masterminds decided to try a completely new twist to accomplish the same results: *they would have one of their Senate stooges submit a BILL to the "Senate Foreign Relations Committee" to repeal the "CONNALLY AMENDMENT."* Such a "REPEAL" would remove that obstacle, and enable the UN to employ certain provisions contained in the CHARTER to control the people fully as well as they could with a ratified "GENOCIDE TREATY."

Thus, in 1959, a BILL for the repeal of the "Connally Amendment" was prepared for submission by Senator Fulbright—and *Eisenhower and Nixon* were handed the job of forcing the Senate into voting it into LAW.

That was a very sensational event. I am sure that everyone who will read this "BULLETIN" can still remember how we (CEG) employed the same method of having the people inundate their Senators with signed "Tracts" and "personal letters" to kill that particular plot—it was all covered in our "News-Bulletins" of that period, so I won't go into the details in this issue.

The point I again wish to stress is that this gang of Conspirators

never quit . . . and that if the U.S. is to Live, the UN must Die!

After we torpedoed their "REPEAL THE CONNALLY AMENDMENT" scheme they again waited a few years—to give the people time to FORGET—then they had their new tool in the White House (Johnson) once again try to get the "GENOCIDE TREATY" ratified. Once again we (CEG) aroused the people to torpedo it. . . . Now, as you know (see our September 1970 SPECIAL BULLETIN") they have waited again, and Nixon is ready and all set to again try the same old "ratification" trick right after this November election!!!

---

In short, the CFR-UN will never give up. There is absolutely no way to torpedo this GREAT CONSPIRACY except by FORCING Congress to haul the UN in for an official investigation which will automatically unmask it for what it really is. . . . Simultaneously, we must FORCE Congress to thoroughly investigate the CFR, and thus reveal that many of the men we have been electing into the highest offices in Washington are members (or stooges) of the CFR, who use those high offices to betray and deliver our Country to enslavement in the UN One-World Dictatorship. . . . Those two INVESTIGATIONS are our only hope for the saving of our Country. But only a nation-wide demand by the people will get us those two Investigations. And that—getting that nation-wide demand—has been our great problem.

---

There is one distinct reason why the American people are apparently oblivious of the menace of the UN. That reason is that they just don't BELIEVE that the UN IS a Menace. Our job, yours and mine, is to awaken them out of that oblivion—an oblivion created and fostered by the CFR-controlled Mass Communications Media.

From its outset, the UN was "sold" to the vast majority of our people as a God's BLESSING. True, many of them were, at least partially, disillusioned when they were made aware of the treason in the "GENOCIDE" project—and then in the attempted repeal of the "CONNALLY AMENDMENT" Plot. They all joined in the project of torpedoing both those Plots. They then at least began to sense that the UN is our most deadly ENEMY—they actually were ready to support the James B. Utt BILL to get the U.S. out of the UN. But very quickly our traitorous Press, TV and Radio launched a brainwashing process to convince the people that the actual objectives of both the "GENOCIDE" project and the repeal

of the "CONNALLY AMENDMENT" were "humanitarian" for the "protection" of the "poor" Minority Groups. *And each time that brainwashing process was successful!!!* And the people stopped supporting the Utt BILL and the demands for the Congressional investigations that would have proved the utter falsity of that UN "humanitarianism." . . . And thus we (CEG) have our job to do all over again.

But that very "brainwashing" attempt to endow the UN with "humanitarianism" became our most effective weapon: we began to concentrate our "News-Bulletins" on a new theme—a theme that should be difficult for the CFR-UN to oppose: We began to stress that a Congressional investigation of the UN could prove to be just as important for the UN as for the Utts and those who are determined to get the U.S. out of the UN. I pointed out that at the very least the UN was "*under a cloud*," and that a Congressional Investigation would definitely clear the atmosphere—that it would establish the UN to be what its "friends" (the CFR) claimed it to be, or it would confirm that it (*the UN*) is what the Utt group of Congressmen (*and the CEG*) accused it of being: a "*housing*" for the *ILLUMINATI-CFR One-World Dictatorship!*

Naturally, the CFR-UN did not take "*kindly*" to that suggested solution—they were fully aware what a Congressional Investigation would reveal . . . and the Emanuel Cellers and the CFR stooges in Congress continued to oppose the Utt BILL.

Then, during the 1968 *election year*, we (CEG) used our "BULLETINS" and Special "*Tracts*" to urge the people to demand *pledges* from their Congressional candidates that they would support the Utt BILL and the Congressional Investigations that would prove the *guilt (or the innocence)* of the UN.

And that proved to be the most effective of all our strategies! It gave us the opening we need to establish *beyond all doubt* that the CFR-controlled men we have been electing into our highest offices in Washington have for years been deliberately, *and TREASONOUSLY*, collaborating with the UN plot to destroy our National Sovereignty; here is how that came about:

Our plan did not work out as well as we had hoped for in 1968. Either not enough voters carried out our directives, or the candidates "*double-talked*" their way out of pledging themselves to their constituents. But this year (1970) tells a different story:

Apparently, the voters, disappointed and shocked by Nixon's

betrayal of his campaign promises, and his determination to get the "GENOCIDE TREATY" ratified, applied greater pressure on their candidates—anyway, this year there were many candidates who responded to their constituents' demands. Of course, many of them dodged *direct* answers, but, amazingly, quite a number, particularly those who are CFR controlled, retorted with demands that the constituents who called for their pledges provide them with *concrete proof* that there had been treasonous collusions between the UN and any of our top Government officials and Federal Agencies.

That, as far as I am concerned, was, as the saying goes, exactly "*what the doctor ordered.*" In the following pages I will provide *documented* OFFICIAL EVIDENCE of that kind of collusion; all bearing the official signatures of our Federal officials; *all* so unmistakably acts of outright TREASON that when and if submitted to Congressional scrutiny they will *automatically* CONVICT both the UN and our Federal Officials and Agencies of outright collusion to destroy the Sovereignty and the SECURITY of our Nation.

---

### PRESENT UN CHARTER IS NOT THE ORIGINAL CHARTER.

---

Before reading further, get this fact firmly fixed in your mind: From the outset, the original Charter was *intended* to be a hoax. When the ILLUMINATI-CFR Masterminds appointed Alger Hiss and his co-authors to prepare the CHARTER, they instructed them to compose what would appear to be a most innocuous Document, devoid of all verbiage pointing to ulterior motives. They theorized that they could later insert various "PROVISIONS," "Resolutions" and "Orders" that would transform it into the TRAP they intended it to become. The "GENOCIDE TREATY" was one such addition they had in the back of their collective mind. Also "Unicef," "Unesco" and many others. Gradually they have inserted *thousands* of such "PROVISIONS," *which would have killed the entire PLOT had they been spelled out in the original "CHARTER!"* And, as we now know, and as men such as John T. Flynn, Senators Langer and Shipstead and other alerted American patriots had forewarned us, all those "PROVISIONS" and plots were, and are, aimed directly for the take-over of the U.S.

## THEIR FIRST DELIBERATE PLOT.

---

In 1947, at the very time that we (CEG) had brought about that first Congressional Investigation of the REDS IN HOLLYWOOD, and thus at least *crippled* that "instrument" for their "brainwashing" operations, the Masterminds (CFR) of the "One-World Conspiracy" set up what they called the "UNITED WORLD FEDERALISTS" (UWF). The job set for the UWF was to bribe and seduce our State Legislatures into SECRETLY passing "RESOLUTIONS" that would FORCE Congress into transforming the U.S. into a Unit of a "FEDERATED UN ONE-WORLD GOVERNMENT." By June 1949, they (*the UWF*) had successfully seduced 26 State Legislatures into passing such "RESOLUTIONS." *All they needed at that time was six more States and the U.S. would have ceased to be a free and independent Sovereign Nation!* And it was all accomplished so secretly that nobody knew anything about the plot except the CFR-UN Conspirators and the seduced State Legislators—*because not one of the CFR-controlled Mass Communications Media mentioned one word about it!* But it was then that we (CEG) learned about it from the then California State Senator, Jack B. Tenney. We (CEG) promptly launched a campaign, via "Tracts" and "NEWS-BULLETINS," and personal appearances before American Legion and VFW Posts, the DAR and every Civic group we could contact, to alert the people of California to create a demand that the (*secret*) UWF "RESOLUTION" be subjected to an *open-to-the-public* review by the entire Legislature. At first, the people we spoke to refused to believe us—they just couldn't believe that the HOLY "UNITED NATIONS" would collaborate in such a dastardly TREASON plot. . . . *exactly as the vast majority of the American people have through the years been refusing to believe that the HOLY UN could possibly be guilty of a plot to destroy the U.S.!* . . . However, we (CEG) persisted in our fight to unmask that UWF plot, and, despite every type of pressure, insults, smears and threats, we accomplished our objective. We succeeded in convincing the people in California—and that UWF RESOLUTION, masterminded by Alan Cranston (*a traitor who is now a U.S. Senator*), was reviewed by the California Legislature in April 1950, and proclaimed to be a Document of TREASON—and the UWF (*tool of the CFR-UN*) was unmasked as a Cabal of TREASON. Of course, the Legislature also rescinded that RESOLUTION. The Press was FORCED to report that review and that rescission! The Legislatures of the other States that had passed similar UWF "RESOLUTIONS," frightened by the rage of the people created by those nationwide Press reports, promptly follow-

ed the example set by California, and rescinded *their* RESOLUTIONS. . . . Naturally, that spelled the end for all the UWF plottings—but, actually it should have spelled the end for ALL the CFR-UN plottings. Why do I say that? The answer is simple: All those Legislatures, in their OFFICIAL rescissions of the UWF “RESOLUTIONS” had established that the UWF was actually a subsidiary of the CFR, and had been acting on behalf of the UN. Right then and there Congress and every State Legislature should have enacted Laws to deal with such obvious TREASON. Such Legislation would automatically have forced a “review”—and an end—of the UN! *But neither Congress nor the Legislatures enacted such Laws!* Why? Because, by then, the CFR had long been our INVISIBLE GOVERNMENT, and too many of our Congressmen and State Legislatures were—and still are—taking their orders from that INVISIBLE GOVERNMENT—and we, the people, had not organized a nation-wide public organization to deal with that kind of TREASON.

---

(Note:—The “concrete proof” of that UWF plot is available in the RECORDS of all the States that had first passed and then rescinded those UWF “RESOLUTIONS.” MCF)

---

Surely, that should be sufficient for any loyal-to-America member of Congress to support a thorough Investigation of the UN!

*But, as Al Jolson used to say, “Wait! You aint heard nothin’ yet! ! !”*

---

## SECOND “CONCRETE PROOF”! ! !

---

The wrecking of that UWF “RESOLUTION” plot was a terrific blow to the Masterminds of the GREAT CONSPIRACY. It had all been so perfectly planned—so perfectly executed, as far as it had gone. The CFR-controlled Mass Communications Media had been very obedient—not one word about the “RESOLUTIONS” had been mentioned—and all the CFR stooges in the 26 States had performed perfectly. Given another year, the CFR stooges in the Legislatures of another dozen States would have passed the very same “RESOLUTIONS”—and that would have been the end of the U.S. as a Free and Independent Nation! But, by the grace of God, we *did* succeed in awakening the people in California—their

action awakened all the people in the Land, and *that* was the end of that particular plot. But, as I always keep warning, these Conspirators (CFR-UN) never quit. They wait until the people *forget* and then launch the same scheme all over again—the “*GENOCIDE*” plot is a perfect example!!! But they don’t stay idle while they wait—they devise other schemes which, *they hope*, will lead to the final TAKE-OVER job. So, when their UWF plot was torpedoed, they concentrated on another scheme, which they called:

---

## “OPERATION AGGRESSI”

---

What the word “AGGRESSI” or (AGRESSI”) means has never been explained. It is not to be found in any dictionary, and its objective has never been fully, or even remotely, explained.

That “OPERATION AGGRESSI” was truly a scheme that was wilder and even more brazen than the UWF plot. . . . we covered it in “SPECIAL BULLETINS” and “TRACTS” at the time the UN launched it, but I will briefly review it at this point to serve as the “concrete proof” of treasonous collusion between the UN and our Federal Government officials demanded by the candidates for Congress and State Legislators during the 1970 political campaign:

---

## “INVASIONS” THEIR “TECHNIQUE.”

---

In 1951 strange forces flying the Flag (RAG) of the “UNITED NATIONS (*and calling themselves* “OPERATION AGGRESSI”) began to invade towns and small cities in the United States, particularly in California, Texas and New York. Those “*invading*” forces came in with flash and fanfare, and boldly proceeded to occupy the cities—and to jail all the public officials.

Briefly, as it later became evident, the following was the objective of that UN “AGGRESSI” scheme: With the treasonous collaboration of the White House, the State Department and the Pentagon, the UN “*borrowed*” American troops, dressed them in UN uniforms, and placed them under UN appointed Commanders and under the UN (rag) Flag, and launched a series of “*invasions*” into various small *cities* in California, Texas, New York, etc. Those UN “*invasion*” Commandoes entered those various cities, “*arrested*”



the Mayors, Chiefs of Police, all Civil Authorities, took possession of the various City Halls and Police Stations, hauled down the U.S. Flags and replaced them with their own UN "Flags," and proclaimed those "captured" cities to be "UN territory."

---

(Note:—Following are some of cities thus "invaded" and "captured": Compton, South Gate, Anaheim, Inglewood, Santa Ana, Downey, Paramount, Palm Springs, Culver City, all in California; Manassus, Texas; Watertown, New York.)

---

The idea behind the scheme was simple—if it had worked, to wit:

If the UN "invasions" had met with no-resistance in the smaller cities, they (*the UN*) would have advanced their "invasions" into larger cities, until, gradually, all of the U.S. would have become "UN territory," occupied by so-called UN troops "loaned" to the UN by our Federal Government. . . . It was a crazy, wild-eyed scheme, but, seemingly, there is nothing too crazy or too wild-eyed for the Conspirators—especially if the American people can be kept unaware of the overall plot—and we were kept unaware of the entire AGGRESSI plot because not one newspaper, not one Radio, not one TV Commentator mentioned one word about those "invasions" . . . . But the most amazing feature of it all was the mesmeric grip that just those two words, "UNITED NATIONS," had on the intelligence of the American people. At that time the UN was a "Holy of Holies"—it just could do no wrong. The people in those small cities that were "invaded" by the UN in 1951 knew that something was wrong when they saw their Mayors and Police Chiefs hurled into jail cells—they knew that something was VERY wrong when they saw the American Flag hauled down and replaced by the UN Rag—it puzzled and bewildered all those people—but it was the "HOLY UN" that was doing it—and the UN could do no wrong.

That "UN AGGRESSI INVASION PLOT" was torpedoed by a sheer accident—perhaps "an act of God" might be the better interpretation: In one of those small cities (*Santa Ana, California*) there was one man who rejected the UN mesmerism—he saw the "invading forces" capture the City Hall of his town—he saw his Mayor being dragged off to jail—he saw the American Flag hauled down! That was too much for him! He hurried home and called together all his friends and neighbors. They armed themselves with

rifles, shotguns, revolvers, etc. Then they descended upon their City Hall and ordered the Commander of the UN "invasion" force to surrender and "clear out—or else!" The UN Commander didn't stop to argue with that group of outraged Americans—he knew that if he would try to resist, it would result in the same kind of battle that took place in Lexington in 1776—that it would be "*the shot that would be heard around the world*"—that it would suddenly alert and arouse ALL of the American people—and that would have been the end of the "UNITED NATIONS." That UN Commander promptly hauled down his UN Rag—and the "invasion" was over.

---

But here is one vital point to prove beyond all doubt the collusion of our Federal Government officials with all those UN AGGRESSI "Invasions": *The Commander of the UN "army" of American soldiers, "loaned" to the UN by our Federal Government, was a U.S. Army General! !*

---

Immediately after that incident in Santa Ana, the UN, in order to keep the matter "*hushed-up*," ordered all its "Invasion" forces to vacate all their "*captured*" cities. And that was the end of that entire AGGRESSI plot. However, the story of those "Invasions" did leak out—for one day—the Press did not DARE to ignore it. When our then President, the pusillanimous Harry Truman, was asked to explain how American soldiers, *disguised in UN uniforms*, had dared to "*invade*" American cities, he said he knew nothing about it. *Of course, he deliberately lied!* The Secretary of Defense (*the Pentagon*) said *he knew nothing about it—of course, he deliberately lied!* When the question was put up to the UN, that outfit blandly stated that the whole thing had merely been a "*dress rehearsal*." A "*dress rehearsal*" for what, they were asked. The UN simply said: "*No Comment.*" . . . I will now STRESS a very important point for *all* of the American people:

Those UN "*invasions*" of our cities were acts of war exactly the same as Napoleon's invasion of Russia, the same as Hitler's invasion of Poland, the same as the invasions of Hungary and Czechoslovakia by Russia. By that token, it established that the UN is a foreign Enemy on our soil. Yet our Congress did not haul in the UN, or "*review*" the UN Charter for the authority for those "*invasions*"—the Legislatures of the various (Sovereign) "*invaded*" States did not take any actions against the UN.

Furthermore, the Man in the White House, the Secretary of State, the Secretary of Defense, all of whom had deliberately "loaned" our soldiers to the UN for those "invasions," were just as guilty of HIGH TREASON as Benedict Arnold, or Quisling, or Laval; yet Congress did not haul any of them in for their crimes, the penalty of which should have been DEATH. WHY? Because, except for one day of Press flurry about those "invasions," all our Mass Communications Media were *ordered* to go into deep silence about that entire act of Treason—the American people, while momentarily enraged, were quickly brainwashed into "forgetting" all about the matter of deliberately plotting to surrender the U.S. to the UN—and the UN has been permitted ever since then to continue their plottings to suck the U.S. and the American people into their ILLUMINATI-CFR ONE-WORLD TRAP!!!

Now, all that happened almost 20 years ago. To this very day there are naive Americans who continue to have full faith in the UN, and who, if they do recall those "Invasions," simply refuse to believe that any of the men in Washington whom we had elected to safeguard the safety and security of our Country could possibly have been guilty of collaborating in the plot. Well, to remove all doubts and questions about the accuracy of that revelation, the following is a verbatim reprint of the "Proclamations" posted in the City Halls of the AGGRESSI "captured" cities:

---

## **"UNITED NATIONS FORCES MILITARY GOVERNMENT OF AGGRESSI.**

### **PROCLAMATION NUMBER I.**

**"TO THE PEOPLE OF AGGRESSI:**

**"WHEREAS, in prosecuting the war against AGGRESSI, it has become necessary for the armed forces of the UNITED NATIONS under my command, to occupy this town, adjacent areas and OTHER PORTIONS OF AGGRESSI, and . . . WHEREAS, it is the policy of the armed forces of the UNITED NATIONS not to make war upon the civilian inhabitants of the occupied territory but to protect them in the peaceful exercise of their legitimate pursuits, insofar as the exigencies of war and their own behavior will permit, and . . . . WHEREAS, in order to preserve law and order and to provide for the safety and welfare both of the forces under my command and of yourselves, it is necessary to establish MILITARY GOVERNMENT in the occupied territory . . . . NOW, THEREFORE, I, JONES SMITHMAN, General United States Army Commanding United Nations Forces Oceania, and**

Military Governor of AGGRESSI, by virtue of the authority vested in me by the United Nations Security Council, do hereby proclaim as follows:

I) All powers of government and jurisdiction in the occupied territory and over the inhabitants thereof, and final administrative responsibility are vested in me as Commanding General of the Forces of Occupation and as Military Governor of UNITED NATIONS FORCES MILITARY GOVERNMENT OF AGGRESSI is hereby established to exercise these powers under my direction . . . . II) All persons in the occupied territory will obey promptly all orders given by me or under my authority and must not commit any act hostile to the forces under my command or helpful to the Aggressi forces; must not commit acts of violence or acts which may disturb public order in any way . . . . III) Your existing customs, religious beliefs and property rights will be fully respected and your existing laws will remain in force and effect except insofar as it may be necessary for me in the exercise of my powers and duties to change them by proclamation or order issued by me or under my direction . . . . IV) All Agressi civil and criminal courts and all universities, schools and educational establishments will be closed until further order of UNITED NATIONS Forces Military Governors of AGRESSI . . . . V) All administrative and police officials of towns, cities, counties and states and all other government and municipal functionaries and employees, and all officers and employees of state, municipal or other public services, except such officials and political leaders as are removed by, or under my direction, are required to continue in the performance of their duties subject to my direction or the direction of such of the officers of the armed forces of the UNITED NATIONS as may be deputed for the purpose . . . . VI) So long as you remain peaceable and comply with the orders of the forces of occupation, you will be subject to no greater interference than is made necessary by war conditions, and may go about your normal vocations without fear . . . . VII) Further proclamation, orders and regulations will be issued by me or under my authority from time to time. They will state what is further required of you, and what you are forbidden to do, and will be displayed in Court Houses, City Halls, or other public places . . . . VIII) In case of conflict or ambiguity between the English text of this proclamation or any other proclamation, order, or regulation issued under my authority, and any translations thereof, the English text is to prevail.

(Note:—The above "PROCLAMATION" was made available to the Press, but except for two or three small newspapers in the "invaded" cities, not one important Newspaper published it. MCF.)

## MORE "CONCRETE PROOF"!!!

---

First of all, REMEMBER: Throughout the years, since we torpedoed the UWF "RESOLUTIONS" plot to transform the U.S. into a unit of the UN One-World Dictatorship, we (CEG) have constantly been warning that this "ENEMY WITHIN" (*the UN and the CFR-controlled traitors in Washington*) will never quit until they have destroyed our beloved Country, or we, the American people, will destroy them.

Why do I say: "*until we, THE PEOPLE, will destroy them?*" Because the following will show that we can expect no *voluntary* Congressional action against the UN, or against the CFR:

Immediately after we got possession of the above AGGRESSIVE "PROCLAMATION" we sent photostatic copies to all members of both houses of Congress, with demands that Congress immediately start action to take the U.S. out of the UN—that impeachment proceedings be launched against Truman and the various heads of the Federal Agencies who had collaborated with that plot, and that all the military figures, such as General Smithman, be court-martialed. We received "*assurances*" from a few *shocked* (?) Congressmen that Congress would take all necessary steps to prevent any recurrences of such acts—and that the UN would be "*rigidly restricted*" to the provisions in the ORIGINAL Charter—but not one word about any INVESTIGATION of the UN!

And as an indication of how little we can depend upon the "*promises*" of Congress, immediately after their UWF and AGGRESSIVE plots were torpedoed, the UN launched their "GENOCIDE TREATY" plot, then their "Repeal the CONNALLY AMENDMENT" plot, and various other plots, and met with no Congressional opposition. As a matter of fact, the vast majority of the Senate stood ready and willing to ratify the "GENOCIDE TREATY" on a number of occasions—also to repeal the "CONNALLY AMENDMENT." The only thing that stopped them on each occasion was that deluge of letters from their constituents warning them that a vote in favor of either of those acts of treason would mean death to their political careers . . . . On the other hand, Congress directly collaborated with the UN with the following:

In September 1961 they (Congress) approved the "DEPARTMENT OF STATE PUBLICATION 7277" to not only disarm the

United States, but to transfer all of our Armed Forces and Armaments to the "United Nations" . . . . They enacted that (7277) into "Public Law 87-297" on September 26, 1961!

---

But every time the late James B. Utt, or any other Representative, submitted a BILL to take the U.S. out of the UN, it was promptly smothered and pigeon-holed. The same treatment was given to similar BILLS by Congressman John R. Rarick and other loyal Congressmen—and that has "happened" year after year after year!

Thus we know that the only way we can get favorable action FOR our Country from our Congress, or from practically *any* of the men we elect to safeguard the safety and security of our Nation, is by using the POWER of the people exactly as we have been using it to prevent the ratification of the "GENOCIDE TREATY" . . . . Call it coercion, call it threat, call it anything you wish — to save my Country, I, for one, will always gladly resort to it. And I am sure that every loyal American who can be made to realize the present true conditions in our Country will gladly do likewise . . . . and that brings me to the final main objective of this BULLETIN:

In virtually every BULLETIN we issued during the campaign months of 1968, and again in the campaign months of this (1970) year, we urged you, and all loyal American voters, to carefully research the backgrounds of the men (*especially the Congressional Candidates*) who would come to you for your vote—and to demand that, *in return for your vote*, he, the candidate, must pledge himself to fully support any BILL, *such as the Utt BILL*, that would call for the Investigation of the UN and its Charter . . . . I also urged the voters to inform the candidate that if he will (*if elected*) fail to fulfill his pledge, they would organize their friends and neighbors (*his constituents who had elected him*) to promptly start action to RECALL him . . . . As I previously stated, that "threat" may sound like "coercion," but some politicians, *particularly those who are CFR controlled*, can't understand any other kind of language—and, as I have stated, *we must use EVERY possible means for the salvation of our Country!*

---

Now, I firmly believe that it is not yet too late to save our Country—the PEOPLE can FORCE Congress to get the U.S. out of the UN—they can do it exactly the same way that they terrified those 73 Senators into defying Eisenhower and Nixon when

those two CFR stooges tried to repeal the "CONNALLY AMENDMENT" . . . . And I have complete faith in the vast majority of our people—I firmly believe that they will finally combine to save our Country in the manner I have outlined, *when and IF they are made aware of the need of such action* . . . . But that "IF" is our great obstacle: through the years, the American people have been so brainwashed by our traitorous Mass Communications Media that they (*the vast majority*) just don't know the truth about the GREAT CONSPIRACY. I am very sure that every loyal American who will read this "News-Bulletin" and the "Special September 1970 Bulletin" will immediately "come awake" and join us in the fight to force the Congressional action we MUST have to get the U.S. out of the UN—and to unmask the ILLUMINATI-CFR . . . . *the JOB is to get them "awake."*

So, now I come to *you*—to all loyal Americans—for *your* help to awaken them: In our "September 1970 Special Bulletin" I outlined in all details the kind of help we (CEG) need to accomplish our objectives. I won't repeat it in this "BULLETIN." I will simply earnestly request that you NOW read that "SPECIAL BULLETIN" again—DIGEST IT!
