You will find this DOCUMENT completely different from our usual "News-Bulletins" and similar publications. It has long been very clear that our beautiful America has fallen into the hands of crafty conspirators and Political Charlatans . . . WE NEED A NEW STRATEGY!

STRATEGY under great GENERALSHIP has always won all wars. If we are to win this WAR for the salvation of our once great Country we must develop a new STRATEGY under GREAT GENERALSHIP acceptable to ALL the people.

As we all know, we have one great "ENEMY WITHIN" — the "ILLUMINATI — CFR-UN". It is a very powerful ENEMY, but

actually they are in the MINORITY. The loyal Americans are a vast MAJORITY. Yet that MINORITY always wins out. They captured our Money System — they achieved control of both our Political Parties and our Mass Communications Media, through which they deceive and brainwash the Majority — they control our Congress and our Courts — *in short, they control our Country. 2) I know that many of those charges against various of those ORGANIZATIONS and LEADERS were instigated by the CFR and their tools in order to create suspicions, doubts and general dis-

harmony among the ORGANIZATIONS and their members—they (*the enemy*) know they would not be able to combat the united efforts of the hundreds of loyal - to - America Organizations.

Anyway, today there are hundreds of loyal - to - America Groups and Organizations all over the Country. All these GROUPS are striving to awaken in their own particular ways the people around them to the menace of the GREAT CONSPIRACY to destroy our Constitution and all of its original purposes—and thus finally destroy our Constitution and all of its original purposes—and thus destroy our Nation. *It is vital that all loyal Americans join one or more of those Organizations to save our Country!!!*

Now, on the surface it would seem that all those GROUPS are getting nowhere. Treason continues rampant in Washington from the White House down to the minor Federal Agencies. The same might well be said about Congress. Bills to take the US out of the UN have been submitted year after year by several different members of Congress, persistently by the late James B. Utt, Rarick and others—they have all been smothered and stifled by the CFR's tools in both Houses—but *that can be remedied if all of the American people are made aware of it!*

**“COMMITTEES WERE ALWAYS THE BULWARK OF
OUR NATION”**

Throughout the life of our Nation many “Committees” were organized by the people and appointed by the Legislature of the Colonies during the Revolutionary period before and after the Union was formed. Among them were “*The Sons of Liberty*”, “*Continental Association*”, “*Minute Men*”, “*Continental Congress*”, “*Committee of the Whole*”, “*Committee of Safety*”, “*Committee of Correspondence*”, *etc., etc.* These were formed in several States and many have been active from that time until the present.

Those Committees were formed to express the opinions of the various Communities and of the States on political and legislative questions and to facilitate the ideas between the Colonies and the States and to communicate reports on all other activities.

During the period before and after the Revolutionary War and the forming of the Union (*the United States*), those Committees expanded their activities to include Legislative, Judicial and Executive functions. They served a very real purpose by creating as well

as by directing public opinion as to legislative issues that affected all the people, and to legislation and legal information to the people which was of a public nature. And they (*collectively*) performed a very effective job—until the “ENEMY” achieved control of our Mass Communications Media and used them to deceive and brainwash the people into losing respect of and faith in all the patriotic Organizations and Committees. Nevertheless some of those Committees continued to function and new organizations came into being to carry on the fight for the *salvation of our Country*.

“COMMITTEE OF THE STATES”

This “Committee” was organized by Dr. Robert C. Olney, M.D. and Merritt Newby. It is a legislative and legal Committee with the intents and purposes designed to state the legislative and legal rights of the people as they pertain and relate to public legislation both in the Congress and the States’ Legislatures.

The “Target Legislation Program” of this Committee of the States is designed so that one or 100 can work; any political party, patriotic party, or other organization can work with the Congress and the States Legislatures as they may see fit. It is a question of whether or not YOU will go to the State Capitols and to the Halls of Congress and demand and compel them to put this “target” legislation into effect as soon as possible, by introducing the Bills that are necessary to put it into effect. This cannot wait for another presidential election. WE MUST BEGIN NOW! To date this Committee has made excellent progress in every State. “Target Legislation” is in the office of every Governor and many of the Senators and Representatives in every State and many of the members of the U.S. Congress. It is now up to YOU to take it up from there.

It is up to YOU to take this Legislative Program to the voters of your State, to the members of your State Legislature and to your Congressional delegation; to take this legislation before any organization to which you may belong and to your Political Party. It is up to YOU to see to it that your organization or Political Party adopts this legislation in their platform *now*; that they publish it in their letters, their bulletins and newspapers, in order to inform the people—and thus offset the deceit and brainwashings of the ENEMY’s captive Mass Communications Media.

It is not the intent and purpose of this ‘Committee of the States’ to form a new political Party. Their only intent is to insist that

Senators and Representatives, both National and State, carry out the wishes of We, the People. The Laws now on the books are the root and cause of all the chaos, and this "Committee" intends to see to it that the men elected to public offices uphold their oaths of office to defend the Constitution and to represent the people in accord with the Constitution of the United States of America . . . *and they intend to use the "Act of Repeal" to accomplish it!*

WHAT IS "REPEAL"?

In every perfect or competent government there must exist a general power to enact and repeal laws; and to create and change or discontinue the agents designated for the execution of those laws. Such a power is indispensable to the preservation of a perfect and competent government.

The power to enact and REPEAL laws has been vested by We, The People, in the State Legislatures. We, The People, and the States, have delegated such power to the Congress of the United States, being limited by the Constitution of the United States. It follows then that the State Legislatures are general legislative bodies and collectively are superior to the Congress as the Congress is a limited Legislative body. (THE STATE LEGISLATURES COLLECTIVELY HAVE THE POWER TO REPEAL ANY LAW OR TREATY OF THE FEDERAL GOVERNMENT.) But only We, the People, and the State Legislatures have the authority to repeal or alter any Articles or Amendment to the Constitution, as well as making additional amendments thereto. Of course, the Congress can repeal its own Laws and treaties; however, this in no way prohibits the power, jurisdiction or authority of We, The People, and the State Legislatures in the event such powers are exercised. As yet, the States have never exercised such powers. THE STATES HAVE YIELDED TO THE FEDERAL GOVERNMENT BY DEFAULT, BY NOT TAKING CONSTITUTIONAL LEGAL ACTION WHEN THEY HAVE THE POWER TO DO SO. The States have the power to PREVENT the Federal Government from encroachment and usurping rights and power not granted by the Constitution.

The word "REPEAL" means to abolish, to abrogate, to annul, to call back, to cancel, to dismiss, to give up, to recall, or rescind by a superior authority. "REPEAL" is to a law or Treaty as "amputation" is to the hand or the foot—in short, *completely removed*.

Only the Legislatures and the Congress have the right to enact a *repeal* law. No COURT has the power to repeal laws. The Court has a right to set aside laws on the ground that the law is unconstitutional and on other grounds if sustained; however, the Court cannot effect *repeal*.

The State Legislatures or the Congress do not give reasons for enacting a law of repeal and there is no law requiring grounds to be incorporated in a law of repeal. A law of repeal is not concerned as to whether a law is constitutional, whether or not the agent's acts were illegal or exceeded their authority when enacting any law. Repeal is the process to COMPLETELY REMOVE it from the "BOOKS" without any discussion.

A law of repeal of the Civil Rights Act of 1964 would read as the crux of the law: "*The Civil Rights Act of 1964 and all amendments thereto are hereby repealed.*" The crux of repealing the 18th Article of Amendment to the Constitution (*the Prohibition Law*) which was repealed by the 21st Article of Amendment to the Constitution of the United States, reads (Section One), "*The 18th Article of Amendment to the Constitution of the United States is hereby repealed.*" Thus, you can readily see there are no justiciable issues to be litigated in the Courts.

Any other law enacted having this language or similar language can be challenged in the courts. Every declaration or allegation must be sustained and can be carried to the United States Supreme Court and the Supreme Court will have final adjudication.

Note the language closely: "*Those purported treaties and agreements relating to the United Nations Organization, now generally referred to as the UNITED NATIONS, are beyond the authority granted to the agencies purporting to make these treaties and agreements, and are therefore null, void and of no effect within the jurisdiction of the state, and any attempt to enforce the provisions of any said treaties or agreements within this state is unlawful.*"

In this type Bill all of the declarations and allegations must be sustained and it can be challenged both in the State and Federal courts by citizens of the particular States and can be carried step by step to the U.S. Supreme Court. We well know what would happen if an Earl Warren and/or Hugo Black had an opportunity to decide the matter. This particular type of law is a law of interposition and nullification. The South has lost on this type of law since 1832. There is no sense in trying this type of Bill further. *REPEAL is the only way out!*

Laws or parts of laws are challenged in the Courts every day

and we well know the decisions of the Supreme Court as to some of these laws already. We can recall that the Supreme Court declared the N.R.A. Act unconstitutional over thirty years ago, but that did not remove it from the "BOOKS", IT WAS NOT REPEALED! Do you realize, or know, that if this Act were brought before the Court today that the Court has the power to reinstate this law and put it on the books? IF THE ACT HAD BEEN REPEALED, THEY WOULD NOT HAVE THIS POWER. Thus, the Court could declare today that the UNITED NATIONS is unconstitutional and, in another case two or three years later, reinstate on the books the UNITED NATIONS CHARTER. It may seem unbearable, but that is the fact and the law.

Who in his right mind, would want the Supreme Court to decide on whether or not the United Nations Charter in lieu of the Constitution of the United States. In a dissenting opinion about 15 years ago, the Court stated very clearly that the United Nations Charter was the Supreme Law of the Land. The only way to get rid of a bad law or treaty is to REPEAL IT IN ITS ENTIRETY and thus be through with it. "REPEAL" is a basic fundamental right. *Exercise it and save this Country!* Repeal the Federal Reserve Act . . . Repeal the 14th and 17th Amendments to the Constitution. Repeal all of the so-called Civil Rights Acts. As previously stated, "REPEAL" completely removes any law or treaty from the "BOOKS" and the matter is completely settled. Demand and compel BOTH the States and the Federal Government to repeal these laws and treaties. We, the People have that power. Let's use it both ways. The late Hon. James B. Utt had a Bill in the Congress for quite a number of years to repeal the United Nations Organization in its entirety. Further, the Legislature of the State of Georgia filed impeachment charges against the Supreme Court in the House of Representatives February 22, 1957. Thus, legislation is already in the Congress and now is the time for all of us to join hands and take action. Remember: the State Legislatures have the vested power of We, the People, and the battle must be carried to the Legislative chambers of every state capitol!

The campaign to "REPEAL" the UNITED NATIONS CHARTER and the FEDERAL RESERVE ACT are the paramount issues in our own times. *The "Committee of the States"* is now working to reach the rank and file of the American people whose interests are in preserving Constitutional Government and our American Heritage . . . *It is up to YOU and all of us to give them our full support! ! !*

All of the foregoing is a prelude to the great chief objective of this "News Bulletin". "TAXATION WITHOUT REPRESENTATION", as stressed by its title.

Throughout several of the past centuries, Taxes, like death, have been regarded by mankind as inevitable, but the fact that they have been so closely associated with death in men's minds comes fairly close to showing their true nature. Our Founding Fathers knew that "*the power to tax is the power to destroy*", and our Revolutionary War was actually fought over confiscation of property without representative consent of the victims — and confiscation of private property is what it is really all about.

True, every government must realize some revenue for its existence, but the fact that the United States functioned as a nation for 137 years without an income tax proves that this particular type of tax was unnecessary. In February of 1913 a new twist was added to the taxing power of government. The "*Income Tax Amendment*" was adopted which made income from whatever source derived, subject to taxation. The Conspirators of this gigantic swindle began their campaign with a very modest and practically imperceptible rate, but it has been gradually expanded until the American taxpayer is carrying an intolerable burden. Billions of our dollars each year are being looted from us while the wealth of our nation is being dissipated in all the corners of the earth on every cock-eyed scheme which the traitors in Washington can concoct. The average American taxpayer must now labor from January 1 until the middle of May just to earn the money the government robs from him through so-called Taxation. This means that he works two hours and 34 minutes of each day, or 13 hours of every 40 hour week just to satisfy the greed of the political conspirators on all levels of government. Sixty million Americans are now virtual vassals beset under the heavy yoke of our outrageous and *unconstitutional* tax dictatorship.

The Income Tax is not the end of the taxation list. We pay taxes on theatre tickets, on Movies, on cigarettes, travel tickets, excises and license fees, sales taxes, death and gift taxes, gasoline, etc., etc. In addition, we pay indirect taxes on everything we buy. Every item manufactured or grown in the United States is taxed dozens of times in the various stages of production. This added costs is passed on to the consumer. There are 150 different taxes on just a loaf of bread, 600 on a house, 100 on an egg, etc., etc.

Government gets more expensive each year, but its value to the citizen diminishes in immense proportion to its cost. In the 1960-69 period annual costs of the Federal government leaped from 136 Billion Dollars to approximately \$300 Billion.

Another indirect source of government robbery is the continued inflation which has now eroded over 50% of the value of our money. And this continues unabated until it has now reached over 50% of the value of our money. Several noted stock market analysts and Economists recently stated: "*A little 3 cent loss of purchasing power in six months will make the dollar totally worthless in just over 11 years if continued.*" And yet the spending and inflation continues. WHY? Despite the protests of citizens to reduce spending and balance budgets, our politicians, and that includes Nixon, continue their insane policy of spending more and more each year. *Whom are they representing?* Is certainly isn't in the best interests of either the nation or its productive citizens to continue such madness. They are obviously ignoring the best interests of our nation in subserviance to minority and pressure groups.

Taxation without representation was unquestionably the chief cause of the American Revolution. *The same cause exists today!* We are being taxed without representation because no politician has enough to do more than pay lip service to controlling inflation by contracting spending.

Many of us wonder just how we got into our present dilemma, and what we can do, if anything, to alter the present disastrous course our government is pursuing. Obviously, most of us are unaware of the fact that our present problems are the result of a carefully contrived plot to centralize world control in a few powerful and unconscionable hands. The financial collapse our nation has been astutely and unscrupulously worked out by this small group of robber barons who have enthroned themselves as the money manipulators of the world. They have been active in Europe for centuries, having established their firm control over England as early as 1694, even before they created the "ILLUMINATI", when the privately owned Bank of England was established. Their control was gradually extended to other nations, and as early as 1775 the money gang cast greedy eyes in the direction of the prosperous American Colonies. The British Parliament, obeying the orders of the Bank of England gang, passed legislation prohibiting the Colonies from issuing their own money. It then became necessary for the Colonists to borrow money from the International Bankers who controlled the Bank of England and pay them huge rates of interest. That resulted in bringing financial stagnation to the once prosperous Colonies. That was unquestionably the main reason for the American Revolution. When our Constitution was adopted the framers were well aware of the dangers of a privately owned money system and specifically established the Provision in Article 1, Section 8, that "*The Congress shall have all power to cover money and regulate the value thereof.*"

Although our Constitution provided for an honest money system, the robber gang succeeded in preventing its establishment. The first United States Bank was adopted in 1791. That "*U.S. Bank*" was predominately privately owned but was controlled by the International Bankers gang. Among its main banking functions was the act of issuing so-called money which the government borrowed at interest.

The Bankers were not always successful in their bid for control, but they never ceased in their efforts to gain control of our nation through the establishment of a central banking system. A series of U.S. Banks was adopted, and repealed, but with each defeat, the gang struck back with either a war, or a recession, or a depression, using each to convince the people that only through the establishment of a central bank under their control could such "*boom and bust*" cycles be ended. *The Money Bandits succeeded in the establishment of total financial control over our nation's assets when the Federal Reserve Banking Act, was adopted in December 1913 . . .* That was the coup d'etat of the Robber Bandits — which took them over 100 years to accomplish.

The U.S. Government, so-called "*The Richest Nation in the World*", now borrows money from this gang of robbers which issues "*Federal Reserve Notes*" in exchange for interest-bearing bonds. The cost of this type of "*money*" to the American people runs into the billions every year and has created a nation of debt-ridden people who are unable to save money enough for their own retirement.

When the Income Tax Amendment was passed it was designed to take from the have-nots (*the productive, hardworking white and blue collar classes*) and give special privilege to the "*haves — the rich and super-rich*. That is why we now see the spectacle of dozens of multi-millionaire families such as the Rockefellers, Fords, Carnegies, Kennedys, etc., etc., enjoying staggering incomes, virtually tax free. The rich and super-rich use such devices as FOUNDATIONS and other schemes to escape taxation and keep their fortunes intact. The tax was also so designed that Socialist cooperatives and Mutual Companies would be virtually exempt from taxes while ordinary business (*true free enterprise*) carries a load of over 50% corporate taxation.

When enough of the American people will become aware of the reasons behind this inequitable tax structure and unconstitutional money system, they will demand the removal of these joint evils. When these measures are wiped off of our legislative books, estate and gift taxes will also be eliminated, as well as all Income Taxes, Government will be reduced to its proper function, that of protecting citizens and their property. Government will be removed from the more than 700 unprofitable business ventures it is attempting

to run and the bulging bureaucracy will be cut down to proper size. The issuance of money will be geared to the protective needs of the nation instead of the whims of the Open Market Committee of the Federal Reserve Bank. Government will spend money into circulation instead of borrowing it from a privately-owned Bank at huge interest rates. Both WIN and NO-WIN wars will cease as the ability of the world empire builders who use this device to increase their global control will be removed. Our dollar will be stabilized and inflation will cease. A real golden age of prosperity will begin — *when and if the people come awake!!!*

If our political representatives (Congress) are not willing to vote for our future, they must be removed. Every Candidate for office must be forced to take a definitive stand on these two issues which are so vital to our survival: the 16th Amendment (*INCOME TAX*) and the Federal Reserve Bank (*private control of our money*). If they vote against We, the People, they must be removed. Our survival as a nation and as individuals depends on these two issues. Only when enough loyal and thinking Americans realize this can we rout out the political rats which have brought us to the brink of ruin. We must now elect men of stature who will vote our nation back into the proud position of being the economic and political leader of the world. Can we, *as citizens, ask for less* — and can our “representatives” do less?

FEDERAL RESERVE ACT OF 1913

The Federal Reserve Act of 1913 creating the Federal Reserve Banking System MUST be repealed! As I have repeatedly stressed,

this is another creation of the International Banker Brigands that takes each year from the taxpayers of the U.S. between 15 to 20 Billions of dollars of illegal and usurious interest on the taxpayers money. There is nothing complex about this monetary system; it is so fantastic, so unbelievable and so simple that it is difficult for the American people to understand and believe what actually happened in that year of 1913.

I have stressed again and again — so has Wickliffe Vennard, the late Congressman Jim Utt, McFadden and many others, that the Federal Reserve System is NOT an Agency of the government of the U.S., but is a private Bankers Corporation. No audit has ever been made of the Federal Reserve System by the Government of the U.S. The Class A stockholders are not known to the Government or to the people. Money is never lent to the Federal Government by the Federal Reserve System; **IT IS MERELY PRINTED OR CREATED BY BOOK ENTRY.** *As a matter of fact, THE FEDERAL GOVERNMENT IS THE SERVANT OF THE FEDERAL RESERVE SYSTEM!* The Federal Reserve System, despite all efforts of many Congressmen such as Utt, McFadden and many others has never been investigated. **WHY?** *Insist upon the answer from your Senators and Representatives! ! !*

UNTIL THE FEDERAL RESERVE ACT OF 1913 HAS BEEN REPEALED, THIS COUNTRY WILL NEVER HAVE A SOUND MONEY SYSTEM! ! ! The Congress will never have control of our Money System until the Federal Reserve Act is repealed!

TRUTH ABOUT THE ILLEGALITY OF THE 14th AMENDMENT

We often hear questions about the 14th Amendment, and many of us wonder why so many references are made to it, its ratification and why it was originally proposed.

The Civil Rights Act of 1866 was the forerunner of the 14th Amendment and both were for the purpose of inflicting punishment upon the South immediately after the Civil War. Today this same 14th Amendment and the current Civil Rights Act are inflicting punishment on **ALL THE STATES** by nullifying the Bill of Rights, federal usurpation over the States, changing the form of government by treaty law and perpetrating a **SECOND RECONSTRUCTION** of the entire United States.

THE 14th ARTICLE OF AMENDMENT TO THE CONSTITU-

TION WAS AND IS A FRAUDULENT AMENDMENT TO THE CONSTITUTION OF THE U.S. FROM THE BEGINNING. It should be declared *illegally ratified* and *unconstitutional* by the several states. It is only necessary for ONE State to take this action and the Supreme Court would *be forced* to rule on this issue which it has circumvented for more than ninety (90) years, one way or another. In the event of an adverse Decision, then it should be repealed exactly as the 18th Amendment was repealed.

The 14th Amendment was ILLEGALLY ratified by the following methods: 1) *The Joint Resolution proposing said Amendment was NOT submitted to, or adopted by, a Constitutional Congress . . .* 2) *The Joint Resolution was not submitted to the President for his approval . . .* 3) *The Resolution proposing the 14th Amendment failed to pass both Houses of Congress as provided for in the Constitution . . .* 4) *The 14th Amendment failed to be adopted by three-fourths of the States as required by the Constitution . . .* 5) *The joint Resolution of July 21, 1868, by the Congress, ordering Secretary of State Seward to declare the 14th Amendment ratified, was an illegal Act by Congress. It violated the 5th Article of the Constitution as the Congress has absolutely no power to amend the Constitution.*

The Supreme Court and the Congress have the 14th Amendment as an instrument of destruction to the following DECISIONS and LAWS:

1) *The Supreme Court cited the 14th Amendment to force the States to reapportion their Legislatures . . .* 2) *The Congress cited the 14th Amendment to justify passage of the 1964 Civil Rights Act. This action nullified the people's right under the Bill of Rights of the Constitution of the U.S. . . .* 3) *The Supreme Court has released criminals to prey upon society. Investigations and arrests by officers have been seriously endangered and hampered by citing the 14th Amendment . . .* The Congress cited the 14th Amendment to pass the Voting Rights Laws.

Check the DECISIONS of the Supreme Court and the Laws passed by the Congress for the past 20 years, note the citation of the 14th Amendment in relation to the United Nations Charter, Universal Declaration of Human Rights, Declaration of the Rights of the Child, the Genocide Treaty, Executive Orders of the President and the Declaration on the Elimination of all Forms of Racial Discrimination, *Legality in Viet Nam*, Open Housing and Open Immigration.

These protests are lawful and legal and are an excellent forerunner to the REPEAL Legislation. Confrontation is what we need to get results. The "SILENT MAJORITY" has been silent TOO LONG. We have seen the results of the protests of various groups and college students. Jesus Christ didn't tolerate usurpation and money leeches — *He took quick action!*

There are many who have refused to be treaded upon. One of the best known is Austin T. Felt of Chicago, Illinois, who has not paid his income tax for the 12th consecutive year. Threats of the school closing if this bond or that bond doesn't pass has failed to intimidate the citizens in many cases.

YES, THE TAXPAYERS REBELLION IS ON! Join, get others to organize with you. Call on us if you need assistance in any way. We will place you in touch with "*The American Challenge.*" *They have speakers and programs of action!*

There are some people who think that this battle can be won politically. That may be true to a degree, but it must amount to more than election campaign promises and the election of your candidates. You must contact the candidates and get WRITTEN COMMITMENTS and their PUBLIC ACKNOWLEDGMENTS of their support of those issues. Ask the political parties to put in their platforms "*WHAT AND HOW TO DO IT*" on all issues. LIP SERVICE is one thing. ACTION is another!

Examine carefully the platforms of the Republican and Democratic Parties back as many years as you can. The platforms contain provisions for sound money, Constitutional Government, *getting out*

of the United Nations, stop foreign giveaways, etc. Both Parties have had, since 1932, a plank in their platforms to restore Constitutional Money! When the people find out the truth and PURSUE IT, then the Parties and the lawmakers will take action. The candidates usually extoll the same promises, but they fail to tell you HOW THEY ARE GOING TO DO IT! THIS IS THE MOST IMPORTANT POINT, anything less is the usual pacifying, "anything to get elected mouthing."

You must contact all your public officials BEFORE election, and if they are not for "TARGET LEGISLATION" THAT WILL SAVE THIS COUNTRY, then let them know they do not have your financial support or your vote. This never fails to get results. If the present candidates and the present office holders are not satisfactory, start looking for others to run for their offices. Let it be KNOWN which candidates and office-holders are unsatisfactory for office or election, and PUBLICISE the reasons why.

After election, see to it that the candidates KEEP their promises and their commitments. This goes for your Governor, members of the State Legislatures and the Congress. From the ballot box to the halls of the Legislature and the Congress is where you must work constantly until these TAXES are REPEALED.

You can NOT afford to wait for the election of 1972 or any other election, because your candidate may not be elected or he may not even choose to run. Furthermore, there is time in between elections which will cause a delay of one to three years. You can NOT afford to wait on, state, local or county elections, because the present members of your State Legislature and the Congress continue to pass and repeal laws, election or not. You need to work in the Legislature and the Congress when in session, as well as in the campaigns. NEVER LET UP! Take your tax grievances to your lawmakers. *Demand that they uphold their oaths of office and their campaign promises!*

1913 - THE INFAMOUS YEAR

Most people are not aware that when the 16th Amendment to the Constitution (Income Tax) was ratified, it repealed all state laws as well as all provisions of the Northwest Ordinance and of the Constitution relating to federal income tax. The passing of the Federal Reserve Act of 1913 (*and subsequent acts thereto*) repealed, negated

and nullified all state laws relating to lawful and legal money. The reason is that the PEOPLE and the STATE LEGISLATURES VOTED ON THE 16th AMENDMENT and the CONGRESS ABDICATED AND VIOLATED ARTICLE 1, SECTION 8, PARAGRAPH 5, of the UNITED STATES CONSTITUTION. In addition, the Federal Reserve Act was illegally, unlawfully and unconstitutionally passed December 23, 1913. 1913 *was the infamous year!!!* The Congressmen (many of them) were at home during the Christmas holiday of that year.

Proper hearings were not held. Those that were held are questionable. There is NO provision in the Constitution which gives the power or authorizes the Congress to delegate power to ANY agency to issue, control and regulate the value of this nation's money — gold, silver or paper money. *The only solution is a tax revolt by every taxpayer in the U.S. and the final REPEAL of the Federal Reserve Act of 1913!*

YOU PAY THEIR SALARIES

The best spokesman and representative in your State Capitol and in Washington is YOU. Notify not only your Congressional delegation but every member of the Congress and keep in mind that your taxes pay all their salaries. If a member happens to be a Senator for New York, or a Representative from Florida and you are from California, let him know what you want just as you would your own state representatives and Congressional delegation. The reason: they all vote in the Congress on all taxes, too.

The COMMITTEE OF THE STATES and the AMERICAN CHALLENGE, in whose support I am writing this "BULLETIN", have subscribers and members, as do we (CEG) in Washington D.C., who check on all the laws. This is particularly true concerning taxes and legislation that is designed and intended to further put the United States under World Government, and the abolition and takeover of the State Governments. It is practically impossible to impress and to get action out of the Congress without a tornado spearheaded by a cyclone from the people at home. Let them KNOW THAT YOU KNOW, and that you want the Federal Reserve Act of 1913, the United Nations Charter, the Income Tax Amendment (16th Amendment) REPEALED. The problem and the weakness in today's tax protest is that the people are UNAWARE of the various tax laws on the books that are wasting billions of dollars for nothing. In addition, check for other similar tax laws and see for yourself what is happening with the money derived from the present tax laws. *Either investigate or be Taxed!!!*

Repeal taxes that are absolutely unnecessary. See that existing taxes are reduced whenever possible. Cut excessive spending and waste of the tax money in contracting for bids for buildings, road paving and surfacing, street repairs, purchasing of supplies and equipment, etc., etc., etc. ALL business of the city, county, state and national government MUST be INVESTIGATED by "We, the People." Quicker action and results will be obtained to the benefit of taxpayers pocket books.

Eliminate the property tax as a source of income! Replace it with a tax on the Radio and Television stations' use of broadcasting time on the air.
