## “DON'T TELL THE PEOPLE!”

---

History tells us that the one thing all political charlatans always dreaded the most was an informed people. “*Don't tell the People*” has always been the frantic cry of every Dictator. Even the Hitlers and the Stalins and the Khrushchevs, with all their ruthless Gestapo and Secret Police controls, always frenziedly decreed that “*the people*” must be kept uninformed — and brainwashed. And the first thing every Dictator did the moment he came into power was to seize absolute control of the Press and every other Mass Communications Medium.

The Founding Fathers of our nation knew full well the powers of the Press. They knew that all the Freedoms they had fought for, and won, would not be secure without a FREE and loyal Press to keep the people fully informed. So when they wrote our Constitution they inserted in it a provision that was to rigidly guarantee Freedom of the Press — Freedom of Expression — Freedom of all Mass Communications Media that might come into existence.

That provision served us well — as long as our Press remained in the hands of journalists who took pride in their profession, men who accepted their “*freedom of the press*” as a sacred obligation to *faithfully serve as guardians of the truth* for the nation and for all the people — *without fear or favor*.

But our Press and all of our Mass Communications Media are no longer in the hands of such men. The change began some 40 years ago — right after the Masterminds of the “*Internationalist Communist Conspiracy*” created the abominable “COUNCIL ON FOREIGN RELATIONS” (CFR).

In our “*News-Bulletins*” Nos. 87 and 88, entitled “OUR INVISIBLE GOVERNMENT” (*Parts One and Two*), I provided the complete background of the CFR and its various Fronts. The task assigned to that execrable cabal was the laying of the groundwork for the transformation of the United States into an enslaved unit in a “*One-World (UN) Government*.” I revealed all of the techniques they employed for the gradual furtherance of that objective. First they acquired control of the Democratic Party, then the Republican Party. Then, beginning with Franklin D. Roosevelt, they planted pledged stooges (*Truman, Eisenhower, Kennedy*) in the White House. In turn, those unprincipled political opportunists planted other CFR stooges in all of the highest offices in the State and Defense Departments, in the Treasury and Department of Justice, in ALL FEDERAL Agencies. And all these men, *if you can call them men*, many of them anchored in their jobs via that “*civil service*”



anachronism, have ever since been terming the foundations of our Constitution and our *Republican* form of government . . . and that brings us back to the Press.

## ALL MASS COMMUNICATIONS MEDIA CONTROLLED

It goes without saying that the Masterminds of the Great Conspiracy have always been fully aware that they could never entrap a fully alerted and informed American people in their One-World scheme. They knew that not even a "Saint Franklin" or a "God-Man Ike" could pied-piper us into the trap as long as a free and loyal Press would keep us fully informed. Even more important (*to them*), they knew that not even their most unscrupulous and most daring White House stooges would dare to perpetrate outright treacheries if there would be a possibility of having to face the wrath of an outraged people. Therefore, as far back as the turn of this century, the Masterminds set in motion plans to achieve complete control of our Press. But it was not until the CFR came into being that they made their real strides. Today, every newspaper chain, every Wire Service, virtually *every* Metropolitan newspaper and national magazine, is tightly controlled by the CFR . . . All TV and Radio Networks are under CFR control . . . Hollywood, and even Broadway, are under CFR control. A study of the rosters of the CFR and its Fronts reveals that all the chief figures of ALL of our Mass Communications Media are dedicated *and controlled* members of that poison-traitorous outfit . . . In "News-Bulletin" No. 87 I reveal in all details the techniques they employed, and still employ, to achieve that control.

Now, to stress that point, I will cite just two or three of the more horrendous treacheries which are directly responsible for our present chaos — and the chaos of the past quarter-century . . . *treacheries which positively would not have been perpetrated if all of the American people had been kept fully informed by a LOYAL Press!*

## TREACHERY IN THE WHITE HOUSE

On October 22 the "*Cuban Crisis*" burst upon an unsuspecting American people with all the shattering impact of the "*Pearl Harbor Story*" the day after the Jap "*sneak*" attack . . . *which also burst upon us out of the blue!*

It was Franklin D. Roosevelt, congenital liar and the most unconscionable political charlatan in the history of America, who told that "*Pearl Harbor Story*" to the American people. Those of us who are old enough to remember will never forget the "*crocodile tears*" hypocrisy that dripped with every word of that atrociously phony "*Japanese Day of Infamy*" speech he delivered to Congress on that 8th day of December 1941. But on that day we accepted that hypocrisy as "*anguish*" — and our hearts bled for the "*great humanitarian*" thus basely betrayed by the treacherous Japanese. What we didn't know was that it was a Roosevelt "*Day of Infamy*" even more than Japanese . . . what we didn't know was that for months before it happened Roosevelt had been scheming and conniving to create that "*Day of Infamy*" . . . we didn't know that long before the Japs struck, the FBI, the White House and the Top Brass in the State and Defense Departments were fully aware of all the (*Japs'*) preparation for the attack — *that they knew the day and the very hour set for it!* . . . we didn't know that, *on direct orders from that man in the White House*, our Army and Navy Chiefs in Pearl Harbor were kept totally ignorant of the impending attack — it was also on orders from that Judas that our warships were so huddled within the harbor as to make them perfect "*sitting ducks*" for the Japs — that all the planes on the Airfields were drained of gas so that the pilots couldn't take to the air to meet the attackers.

And because we didn't know all that, Roosevelt emerged from his "*Day of Infamy*" a God-Man. When he "*sorrowfully*" announced that he would have to break his oft-repeated campaign promises that he would "*never send your sons to fight on foreign soil*", the whole nation cheered him . . . when he gave Russia eleven billion dollars, we cheered him . . . when he went to Teheran and YALTA to secretly betray and deliver all of Eastern Europe to Stalin, we cheered him . . . when he knifed Chiang Kai Chek in the back, and thus delivered China to Communism, we cheered him. And we continued to cheer him as he committed act after act after act of treason, all of which are directly responsible for our present heritage of crises, of havoc, of a Communist menace that may yet destroy our whole world. Even today there are many naive Americans who continue to worship the memory of that monster.



Now, one might well ask: how could a whole nation of undoubtedly intelligent people have been so naive and so completely deluded? The answer is: the perfidy of our Press — and of all of our Mass Communications Media.

True, all those acts of treason were (*supposedly*) well-kept secrets. But, of necessity, Roosevelt had many collaborators in those acts of treason — some very stupid ones, such as George C. Marshall — some vain and boastful ones, such as Harry (*the Hop*) Hopkins. “*Slips*” were bound to be made. One such “*slip*” occurred when Hopkins boasted to some of his cronies that the Japanese code had been broken and that our “*Intelligence*” was thus enabled to decode every order issued by the Japanese War Department. That “*slip*” was made months before the Pearl Harbor attack — and became proof positive that Roosevelt knew, *in advance*, of the impending attack. Another “*slip*” was made by Marshall, our then Chief of Staff, when he stated that he “*couldn't remember where he was at the time of the attack.*” Still another “*slip*” was a revelation that, *on direct orders from Roosevelt*, the Pentagon overruled Admiral Kimmel's decision to keep the fleet scattered and on alert for a possible attack — he (Kimmel) was ORDERED to keep the entire fleet huddled, *and bottled-up*, within the harbor, which permitted no maneuverability for fight or for escape. It was on orders from the White House that every ship in that fleet was rendered into a helpless “*sitting duck*” for the Jap planes.

Today we know — some few knew even in those days — that Roosevelt had to have that Pearl Harbor “*sneak*” attack. He was committed to bring the U. S. into that war. He was pledged to Churchill to do it. *But, far more important, he was pledged to his masters, the “Council On Foreign Relations,” to do it!* He knew — they all knew — that the American people wanted no part of that war. He knew that it would require some horrifying act like that Pearl Harbor “*sneak*” attack to budge us from our determination for peace into a furious demand for war. He also knew that it would have to be a highly successful attack — so successful that even the mildest among us would be swept into a frenzy for vengeance. And so that monster, who time after time piously proclaimed “*Ah hate wah — Eleanoh hates wah*” didn't flinch from the total destruction of our Pacific Fleet, he didn't flinch from the cold-blooded murder of the thousands of our sons whose bodies still are lying under the waters of Pearl Harbor . . . *and he achieved his evil objective* — as with one voice the whole nation cried out for war.

That would not have happened *if we had had a truly free and loyal Press*. All the things that have been happening since would not have happened — *if we had a loyal Press*. There is absolutely



no doubt that if the Press had told the true story of that Pearl Harbor attack to all of the American people it would have been the end of Roosevelt in the White House — he would have been impeached, and, together with all of his accomplices, executed . . . and there wouldn't have been any Eleven Billion Dollar gifts to "good old Joe" . . . there wouldn't have been any deliveries of the Balkans and Eastern Europe to Communist enslavement . . . there wouldn't have been any Red China . . . there wouldn't have been any Korean War . . . there wouldn't have been any Berlin crises — or today's Cuban crisis . . . there wouldn't today be a "UNITED NATIONS" sanctuary for Communist spies, traitors and saboteurs — and for Communist plottings. In short, *there never would have been a Communist Menace* — we would today have a World of harmony and peace — *if we had had a loyal Press in 1941!*

That's what our perfidious Press has done to us . . . and let there be no delusions about it, the Press did, *and does*, know the full truth about "Pearl Harbor" — ditto *all* of our Mass Communications Media — for weeks before the "sneak attack" it was known in every press room in the nation that the Japanese code had been broken, yet not one newspaper, not one Radio commentator asked why Washington had failed to provide Kimmel and Short with the means of "reading" the Japanese instructions for the attack. Thus they led all of the American people to conclude that it was the Pearl Harbor commandants who had been "asleep at the switch," or worse. They all knew all about all of the chicaneries and treasonous plottings that led up to it. But all of them (*obediently*) kept it all hush-hush. Indeed, they aided and abetted the Conspiracy as a whole with a constant stream of honeyed words about "our great Ally" . . . Hollywood glorified that "Ally" (*and Communism*) with a stream of Films such as "Mission To Moscow," "North Star," "Song Of Russia," etc., etc. — *Films that created world-wide hatred for America!*

## CONCRETE PROOF

However, despite all of the brutal consequences, including "black-listing," that they knew would follow their "rebellion," there were a few members of the Fourth Estate who refused to be muzzled. One was John T. Flynn, a journalist of great repute and of unquestionable integrity. He needs no "introduction" to the American people. His "Truth About Pearl Harbor" came into print very shortly after the "sneak attack." Previously a John T. Flynn book achieved a vast nation-wide circulation. But for his "Pearl Harbor" story



he found all avenues of circulation, *except mail-order*, closed to him — for many years a noted national Radio News Commentator, he suddenly found all Air-lanes closed to him . . . Another “rebel,” John J. O’Donnell, a noted syndicated columnist, was muzzled by the head of his Syndicate — *but not before one of his columns revealed enough facts to force a Senate Committee investigation*; the full report of that Committee has never been released. There were a few other Washington-based press correspondents and Radio Commentators who tried to tell the “*Pearl Harbor Story*,” but all of them were either muzzled — or fired.

The crowning — and most horrifying — proof of the press “blackout” of the treason committed by Roosevelt is provided by the following incident during the Yalta Conference: *Newsweek* correspondent Edward Weintal, one of the press corps in attendance at the Conference, exclusively got the news that Roosevelt had “granted” the USSR three memberships in the UN — two of them phony — despite the furious objections of Winston Churchill. That “news” was “leaked” to Weintal by a member of the British delegation. Weintal promptly filed the “story” for transmission to “*Newsweek*.” A State Department official sternly censored the “story” in toto, on the ground that its publication would be “*unpatriotic and harmful to the national interest*.” . . . The State Department official who did the “censoring” and made that statement was ALGER HISS!

However, in combination, all those “rebels” provided sufficient concrete evidence of Roosevelt’s horrendous act of treason for impeachments proceedings — and execution. Unfortunately, all that evidence reached only an infinitesimal fraction of the American people. Even more unfortunate, many of those who did receive that “evidence” couldn’t, or wouldn’t, believe it — and those who did believe were too shocked and stunned (*and didn’t know how*) to demand action by Congress.

But the most damning indictment of all came (*in 1945*) from the late Senator Vandenberg. Throughout the war, Vandenberg, Republican leader in the Senate, had zealously fostered Senate bipartisan support for Roosevelt’s war policies. Then, early in that year (1945), from some mysterious source within Russia, he came into possession of a set of micro-films and recordings of certain secret meetings at Yalta attended only by Roosevelt, Hiss, Stalin and Molotov (*and their interpreters*). Those films and recordings revealed, *and clearly established*, Roosevelt’s dastardly agreement to deliver to Stalin all of the Balkan States, Eastern Europe and Berlin.

(Note:—Here is a very significant point: the “mysterious source” whence came those films and recordings was the Underground in Russia. But you will note that they did not entrust them to our State Department or the



Pentagon, or to any of our Federal Agencies. The reason they sent them to an individual was their mistrust of everybody in the Roosevelt Administration. They knew that any information they would provide our State Department or other Federal Agencies would promptly be relayed to Moscow. That happened time after time after time, and thus many Underground leaders were exposed — and, together with their families, promptly Butchered. The very same conditions applied in the Truman and Eisenhower Administration—**AND EVEN MORE SO IN THE PRESENT KENNEDY ADMINISTRATION, as will later be seen.)**

Horribly disillusioned, Vandenberg submitted the films and recordings to a gathering of all the Washington Press Correspondents. Heads of all the newspaper chains and Wire Services were present at the showing. Nobody questioned the authenticity of the films and/or the recordings. It was *prima facie* evidence that *nobody* could doubt. Yet, not one publication mentioned one word about it. Ditto the Radio — that medium's alibi to Vandenberg was that the FCC would revoke the license of any Network that would permit the revealment of those films and recordings.

In short, without going into the details, Vandenberg was turned down by every Mass Communications medium. In Hollywood he even met with insults from Harry Warner, the Schencks, Sam Goldwyn and other Moguls, who jeeringly told him “. . . *don't bother us about the Communists, they are fine people — just you keep on fighting the Nazis and the Fascists.*” His appeals to Broadway producers to tell the story in a play met with similar, although less insulting, refusals. Martin Dies, first Chairman of the “*House Committee on Un-American Activities,*” received similar treatment from the Hollywood Moguls.

(Note: It was at Senator Vandenberg's request that I wrote both “RED RAINBOW” and “THIEVES' PARADISE,” in which I revealed that entire plot—plus the “One-World” objective of the “UNITED NATIONS.” The frantic efforts of the Eisenhower Administration to prevent the staging of “THIEVES' PARADISE” in Washington (in 1956) were described in all details in our then current “News-Bulletin.” MCF)

Except for the tragic note for the American people, the revelation of those films and recordings was ironically amusing. Unquestionably, Roosevelt was Stalin's greatest benefactor. With his “*Recognition,*” Roosevelt undeniably saved Stalin in 1933. He again saved him in 1941, when Hitler attacked Russia. And throughout



the war, with Eisenhower's collaboration, Roosevelt enabled Stalin's armies to "capture" the Balkans, all of Eastern Europe and Berlin. Despite all that, when Roosevelt came to Yalta to help Stalin cement all his "conquests," that ever-ruthless Jesse James of the Urals secretly filmed and recorded the very meetings at which the "cementing" was accomplished. That — the recording of his treason and everlasting shame — was Stalin's thanks to Roosevelt for all of his benefactions.

The filming and recording of those meetings had one prime objective: to serve as a Sword of Damocles over Roosevelt's head should he ever try to renege any of the Yalta agreements — and, unquestionably, to blackmail him into further concessions.

Roosevelt was utterly unaware of those Films and Recordings until two days before his death. The revelation of their existence — *and that they were in Vandenberg's possession* — came to him while he was vacationing in Warm Springs. He was horribly shocked. He bitterly denounced the treachery of his "false friend" (Stalin) — hours later he pulled the trigger of the gun that so shattered his head that the most expert of plastic surgeons couldn't conceal the evidence of his suicide — and he went to his grave in a tightly-sealed casket without anybody, *not even Eleanor*, seeing his face . . . Talk about RETRIBUTION — the great "God-Man" was even denied the lying-in-state honors usually accorded to far lesser figures!



**Note:—To remove all doubts about the above: on the very day that Roosevelt got word that the (secret) Films and Recordings were in Senator Vandenberg's possession and that he was seeking ways to release "the story" to the American people, the Press throughout the nation quoted him (Roosevelt): "I have for some time had growing doubts about Stalin's honesty. . . . (and) regret that I ever trusted him."**

In the publication of his death, on the very next day, some newspapers gave "a stroke" as the cause of his sudden demise — others ascribed it to "a massive brain occlusion" — some vaguely hinted that he was assassinated by one Madame Schaumatoff, a Russian woman artist, who was there (ostensibly) to paint his portrait — a few other papers hinted that "he had died by his own hand." The question is: why all the mystery? MCF.)





## OFFICIAL "REQUIEM" FOR THE TRAITOR

---

In the foregoing I established beyond even a remote doubt the treason committed by Franklin D. Roosevelt. The following excerpt from the *Congressional Record* of September 22, 1950, reveals with equal clarity what an inveterate liar and unscrupulous political charlatan he was. This was contained in "an extension of remarks by Congressman Harold H. Velde on 'The Communist Threat to America' by Martin Dies, first chairman of the House Committee on Un-American Activities." According to this reference, on August 12, 1938, Roosevelt told Dies in a private conversation:

**"If you expose the Communists in the CIO, the CIO will turn against the Democratic Party. If we lose the CIO in some of the Eastern States we cannot win. . . . The Communists have just as much right in the CIO as anyone else."** Later Dies obtained the records of several thousand Communists, agents, stooges and sympathizers on the government payroll. Again Mr. Dies had a private conversation with FDR wherein FDR became angry and screamed at Dies: "I have never seen a man that had such exaggerated ideas about this thing . . . there is nothing wrong with the Communists in this country — some of the best friends I have got are Communists!"

Analysis of the "political opportunism" displayed in the above Roosevelt statements and the complete acceptance and furtherance of the Communists' tactics, strategy and objectives throughout the entire FDR Administration shows how and why Communism has become the great menace to the life of our nation — and of the whole world . . . One can also clearly see that Franklin D. Roosevelt was the most dedicated and most effective Communist Conspiracy functionary in America — *with Eleanor a very close second!*

## JFK ANOTHER FDR - ONLY WORSE!

---

On October 22 (1962) John F. Kennedy duplicated Roosevelt's "Japanese Day of Infamy" hoax.

Solemnly, in phony tones of horrified outrage, Kennedy proclaimed to a nation-wide TV audience that he had "just discovered" that the treacherous Khrushchev had transformed "Cuber" into a Moscow satellite — and was equipping it to become a "Nuclear" menace to the United States and the entire Western Hemisphere. He further "reported" that in an exchange of "diplomatic letters" Khrushchev



had blandly assured him that there were no Missiles and no Nuclear Bomb emplacements in Cuba — that the Russian chief delegate at the UN had impudently brushed off the pictures of the bomb sites in Cuba as fakes. He then castigated Khrushchev as an unmitigated liar and “*bravely*” proclaimed a tight blockade (“*quarantine*”) of Cuba, to be maintained until all the bomb sites would be dismantled *under “on site” supervision* — and all “*offensive*” nuclear weapons removed or destroyed.

Now, before going any further, let’s establish beyond the shadow of a doubt that Kennedy’s “*just discovered*” was an outright and deliberate falsehood.

In our last “*Year-End Report*” (January 1962) after I reviewed the Cuban Invasion (*Bay of Pigs*) betrayal, I made the following statement: “**Apologists for Kennedy stressed that the entire Castro treason plot was launched during the Eisenhower Administration. Which only means that both Eisenhower and Kennedy are equally guilty — that both were carrying out the directives of the Masterminds of the Great Conspiracy! . . . Which one of them will be responsible to the American people when one shocking day we will discover that Castro has nuclear missiles in Cuban underground sites ready for instant firing on our Country? . . . But perhaps by then it will be too late to put either one on trial for TREASON !!!**”

Thus, I knew as far back as the late months of 1961 that the Russians were pouring many shiploads of nuclear weapons into Cuba and were feverishly building Launching Pads and Platforms in various parts of the island . . . *as you read further, bear in mind that I stressed “UNDERGROUND SITES” in that statement.*

In addition, at the same time, and during the months that followed, other publications printed the same information . . . And here it is highly important to *stress* that that information came *not* from our State Department, *not* from the CIA, *not* from our Defense Department (*all traitor-infested*), but from highly reliable sources within Cuba — *sources that never once misled us!*

Obviously, if *we* knew all that for approximately a full year before Kennedy made his amazing “*discovery*,” he knew it too. As a matter of fact, by mid-year the whole thing was more or less an *open secret*. In August, even the Administration-slanted press openly stated that Moscow had already poured 150 shiploads of materiel into Cuba, but they stressed that most of the cargoes were “*food, oil and economy goods.*” But from our reliable sources inside Cuba came positive reports that SCORES of the ships unloaded nuclear missiles and fighter and bomber planes — *and thousand of Russian soldiers.* But, in response to direct and pointed questions, Kennedy scornfully dismissed those reports — and time after time blandly



assured the nation that all of the weaponry were "*defense weapons*," and the soldiers were "*technicians*" in army uniforms. And all the while Moscow continued to rush into Cuban harbors more and more shiploads of "*defense weapons*" and "*technicians*" — and the "*technicians*" continued to rush completion of the Launching Pads . . . . And all the while the American people were becoming more and more confused and bewildered by Kennedy's reiteration of his reprehensible falsehood, more and more frightened, more and more panicky, more and more angry — and furiously demanding ACTION!

In the midst of all that, our apparently unperturbed boy-president decided to go off on a politicking tour — you see, he would need more Democrats in the next Congress to pass the wild-eyed legislation he would require. Besides, if Nero could go off into the hills to play his fiddle while Rome was burning, why shouldn't the great KING Kennedy go off into the hinterlands to play politics — *and warn the people to vote Democratic or be deprived of Federal Patronage jobs?*

But, alack and alas, everywhere our "*hero*" went he found alarmings signs that all was not too well with *his* world. The crowds that greeted him, while not actually hostile, were far from wildly enthusiastic. Some almost jeeringly urged him to show less "*image*" and more courage — they asked him what he was going to do about Cuba, etc., etc. He began to realize that he was hurting rather than helping his chosen candidates—and that his Democratic Party was fast slipping down the drain. Then, on October 20, in Chicago, our young man got a jolt almost equal to the one that caused Roosevelt to seek surcease via a gun — one of his boys in Washington warned him that the *true story* of Cuba, together with aerial photographs showing almost completed Launching Pads all equipped with Missiles trained on many of our cities, had been "*leaked*" by someone in the Pentagon to a publication which the Kennedys had as yet been unable to muzzle — and that that publication was about to publish the entire story.

Of course, Kennedy immediately realized that the minute that story would be published it would spell finis for him — he wouldn't even dare to go back to the White House long enough to pick up his rocking chair. *He just had to beat that story to the public!* He promptly cancelled the rest of his politicking tour, giving as his excuse that he had been savagely attacked by a ferocious germ (cold), and dashed back to Washington. Two days later (Oct. 22), *with no sign of any "cold" apparent*, he appeared on TV and "*reported*" to the American people how he had "*discovered*" the "*clandestine treacheries being perpetrated in 'Cuber'.*" In that "*ora-*



tion" he warned Khrushchev that unless he (Khrushchev) would promptly dismantle the Launching Pads and remove all Nuclear weapons and planes from "Cuber" he (Kennedy) "*would employ all measures necessary to accomplish it.*"

That "*brave speech*" is still fresh in all our minds so there is no reason to waste any more of our present space on it, but a review of what followed is very necessary in order to show how we were . . .

---

## FLIMFLAMMED AGAIN

---

The one great puzzle of all time which I have never been able to solve is the short memory of the American people — why, time after time after time, they are so easily "*taken in*" by *obvious* political charlatans. Their so-called apathy, deplorable though it is, I can understand — for some thirty to forty years they have been so bewildered, bemused and bewitched by our prostitute press that they no longer can differentiate between what is good and what is bad for our nation. But when it comes to the DEEDS of the men who are the would-be destroyers of our nation, their short memories are inexplicable and unforgiveable. When we elect and re-elect and re-elect into office political charlatans who have been caught red-handed in their chicaneries, their lies, their cheating, their betrayals, we have none but ourselves to blame — and thus we provide the Internationalist-Communist Conspirators (CFR) the means and the weapons with which to destroy us. For one example, let's again cite Franklin D. Roosevelt:

From the very outset of his political career that man lied, deceived, cheated, betrayed. Every promise he made in his very first campaign for the Presidency was an outright lie, and, of course, never fulfilled. Yet, he was elected again and again and again. We KNEW he was lying, deceiving and betraying us, yet we kept entrusting the destiny of our nation into his traitorous hands to the very last day of his life . . . *And now we are making the very same tragic mistake with John Fitzgerald Kennedy — whose middle name, as well as his last, is a synonym for the most vicious kind of political crookedness. Want proof?*

In 1947, Jack Kennedy, then just a wild-Irish night club habitue, and a political nonentity, was told by his political mentors (*papa Joe and grandpappy Fitzgerald*) that in order to "*go places*" in politics he would have to create an "*image*" for himself — they also told him that *sensationalism* is the most effective stepladder to political "*fame.*" But they also warned him never to attack anybody who



could fight back. So, metaphorically speaking, like a buzzard on the wing, Jack began to circle around on a hunt for a defenseless victim, or, even better, for carrion that couldn't fight back at all. Soon he sighted a perfect quarry — the carcass of Franklin D. Roosevelt — and he boldly swooped down upon it with a speech (*in Salem, Massachusetts*) in which he unequivocally charged Roosevelt with all of the World War II betrayals, particularly emphasizing his delivery of China and the Kurile Islands to Stalin — he named, *and blasted*, George Catlett Marshall, Lattimore and all the other “China Hands” who collaborated in that treasonous delivery . . . *that was what he stressed, the treason committed by Roosevelt, in that maiden “image”-building speech.*

Then came 1960 — and a complete metamorphosis. In speech after speech he *rhapsodized* the memory of the man whom only 10 or 12 years earlier he had reviled. In 1949 Roosevelt (*in Kennedy's own words*) was a villainous traitor—in 1960 Kennedy eulogized him as a “saint” . . . “a noble-hearted humanitarian,” . . . “the greatest of all our Presidents.” And he *promised* that, if elected, he . . . “*would pick up where Roosevelt left off.*”

Right then and there the American people should have known what to expect from Jack Kennedy . . . just as the world should have known what to expect from Adolph Hitler after reading his “Mein Kampf”—what to expect from Lenin and Stalin after reading *their* books. Hitler, Lenin and Stalin fulfilled all the “*promises*” in their writings . . . and Kennedy has been faithfully fulfilling his promise to “*pick up where Roosevelt left off*” . . . Moreover, all the old “China Hands” he excoriated in 1949 for their parts in that (China) deed of treason are now (*since 1961*) his most trusted lieutenants.

During the campaign many people brushed off that “*promise*” as a case of pandering to the Black Widow of Hyde Park in order to get the support of the Roosevelt cult. That was partly true — *but only partly.* That “*promise*” was a public renewal of Kennedy's pledge to the CFR. Kennedy didn't have to worry about the support of the Roosevelt cult — because the Roosevelt cult is, *and always was*, part and parcel of the CFR.

Limitation of space does not permit a review of all the events in the two years of the Kennedy Administration that so starkly parallel Roosevelt's chicaneries and treasonous betrayals. But, to *stress* my warning about “*short memories,*” I will cite a few of “King” Kennedy's most reprehensible deeds, every one of which *cried* for impeachment.

No. 1) The “*Bay of Pigs*” treasonous betrayal: *That was a DE-*



*LIBERATE betrayal!* Not only was the faithfully promised air support withdrawn without notification to the Cuban invasion commanders, but full information about the planned invasion was provided to Castro — and thus the Cuban Freedom Fighters walked right into a perfect ambush — *an ambush virtually set up by the United States!* It does not matter who provided Castro with that information, whether it was the State Department or the CIA — it does not matter who masterminded the plot as a whole — what does matter is that it was a distinct case of rendering “*aid and comfort to the enemy,*” defined by our Constitution as an act of treason punishable by death. Kennedy publicly assumed personal responsibility for that act of treason. Impeachment proceedings and trial by the Senate should have followed automatically — that is the *sworn obligation* of all members of Congress! . . . Such a trial might well have unmasked ALL the Masterminds of the Great Conspiracy — it well might have smashed the entire Conspiracy.

In all of the public appraisals of that act of treason one very vital aftermath was completely overlooked: it served as a complete deterrent of all similar invasion — raids . . . it left Castro and Khrushchev free and unobserved in their Nuclear build-up. All reports of it from Cuban refugee and underground sources were discredited and/or discounted by the CIA, by the Pentagon *and by the controlled press* . . . until October 22, when the “*leak*” by a *loyal* American in the Pentagon *forced* Kennedy to reveal it.

There is far more importance to that phase of the matter than has been taken into consideration; to wit: a few more weeks of undisturbed build-up and we suddenly would have been told that there were enough Hydrogen bombs in Cuba, *all set and ready*, to completely destroy the United States. Regardless of our retaliatory powers, we would have been faced with an ultimatum of “**Be Red or Dead!** . . . **That would have been the ultimate victory for the Masterminds of the Great Conspiracy — it would have forced our total disarmament — and surrender to the One-World Government plot . . . unless the American people would have preferred to be “dead” — as, I am sure, they would!** More about this later.

No. 2) The Steel Crisis: To perfectly categorize that event is to state that it was strictly a manufactured imbroglio. Therefore, for a clear exposition, I will submit my analysis in the form of a critic’s review of a play — *which is exactly what it was.*

Now, that entire imbroglio was played out in the open, in full view of the (180 million Americans) audience. We were privileged with a (*not rare*) display of the big temper of the little man in the



White House . . . we were properly startled by the Kennedy-Blough "*angry feud (?)*" . . . we witnessed Kennedy's "*masterly solution*" of the entire problem. It was all on the surface — for all of us to see. But, now let's look *under* the surface and see the real motivation for that imbroglio — or play:

As we know, the CFR was set up *ostensibly* to advise (*control*) the State Department on our Foreign Policy. They even set up a Committee within State for that purpose. And that was done quite openly — *for the benefit of the public*. But, what was equally important for the CFR's overall objective was control of our domestic policies — *and our Economy!* The key to such a control is a price-fixing power. Through the years they made a number of tries at it. Roosevelt tried it with his NRA scheme — but our then still loyal Supreme Court declared it to be unconstitutional . . . that was when Roosevelt angrily screamed that he would "*tear that — — — old Constitution to shreds.*" Truman tried it with his attempt to seize the Steel industry — and was stopped in the same way. Eisenhower was very willing, but found no available opportunities — *and didn't dare to manufacture any*. Not so, Jack Kennedy — this young man is as daring (*until someone fights back*) as he is opportunistic. He achieved one tremendous break-through when he bamboozled Congress into giving him sole power to manipulate our Tariffs via the "*Trade Expansion Act.*" That, in itself, makes him virtual Dictator over the American Economy — it gives him power to destroy any business or industry which interferes with the development of international trade via the "*European Common Market.*" But, to acquire complete over-all dictatorship, he needs the power to fix prices within the country. That power had to be skillfully "*manufactured.*" He tried to manufacture it with the "*Steel Crisis*" imbroglio.

Now, in the construction of a play the dramatist has to provide a plot and a counter-plot. There has to be conflict — there has to be a villain and a good guy — with the good guy heroically fighting to save an innocent little gal from a horrible fate.

The chief protagonists in this "*play*" were: The hero (*natch!*) JFK . . . the villain: Roger M. Blough, head of Steel . . . the "*gal*" JFK was hell-bent (*and I do mean HELL-bent*) to save was the American people.

The construction of the play was very simple: In Act One we were to witness a frightening "*plot*" which threatened the honor and the very life of our "*little gal.*" The "*plot*" was a threat of a Steel strike that would be disastrous to our entire Economy — perhaps even more important, it would utterly disrupt our entire Defense program. Our "*distressed little gal*" was indeed in deadly peril. Only



one thing could save her — someone to avert the strike. But was there a man with a heart so noble as to dare such a derring-do? *Yes, there was!* None other than that brave Bahston Bucko, Hahvahd Jack himself! ! Mounting his gallant rocking-chair, and, in the very nick of time, midst the wild cheering of the anxious audience, he came furiously rocking into the fray. Boy, it was a tough fight! But he won — by (*naturally*) giving Labor all it demanded. Hip, hip, hooray! — the “*little gal*” was saved!

But, oh oh! ! All those paeans of victory came too soon! The wily villain had a dirty trick up his double-crossing sleeve — he still had our “*little gal*” in his filthy toils. So now we shall see Act Two— and the counter plot:

After the strike was fully averted. Blough announced a price increase to offset the wage increases. Our hero promptly flipped right out of his rocking chair. He screamed with rage — took it as a personal affront — and bluntly accused the villain of a deliberate double-cross. He warned that unless that price-increase was rescinded he would order Douglas Aircraft, Lockheed and all other Defense plants, on pain of having their contracts cancelled, to cease all purchases of steel from U. S. Steel, Bethlehem and all the other Big Steel “*recalcitrants*,” Kennedy’s word for them. When told that the smaller steel makers couldn’t possibly fill the needs of the Defense plants — that it would stop the Defense program dead in its tracks, our hero snarled a “so what!” and proceeded to add every possible Hitlerian method to force Big Steel to capitulate — he sicked the Income Tax boys on them — little stupid brother Booby transformed the FBI into a middle-of-the-night-visitations Gestapo, etc., etc., and to hell with the Constitution and the Law. And by golly and begorrah, he won the battle! With pitiful cries for mercy, the villain surrendered unconditionally.

Act Three has not yet been played out. But in that coming act we will supposedly see our “*little gal*” entrusted into the hero’s keeping “*for better or for WORSE.*” In other words, Blough’s “*surrender*” will be the precedent for an over-all Kennedy (CFR)-controlled price-fixing policy.

Nbw ponder the following — and see for yourself the accuracy of my critique:

Roger M. Blough (*and other Steel tycoons*) and John Kennedy are all fellow members of the CFR. But Blough is more than just a member, he is Chairman of the Business Advisory Council. Thus, he is Kennedy’s superior. Isn’t it logical that the two were in the deal together — that it was a prearranged scheme for Blough to create



the “*emergency*” and for Kennedy to solve it — and thus clamp a CFR price-fixing policy on the nation?

Congress was definitely remiss during that imbroglio! That whole “Steel Crisis” should promptly have been hauled in for a thorough Congressional examination! It still should be! Every phase of it, every individual involved in it should be closely investigated!

No. 3) The Oxford, Mississippi, “Invasion”: The complete story of the lawlessness and treason involved in that “*invasion*” requires a volume of *many* pages rather than a mere citation. Ignoring all due processes of law, with no call for Federal troops from the Governor and/or the Legislature of the state, *as rigidly required* by our Constitution, the Kennedy Kids rushed an army of 25,000 troops, plus 800 U. S. Marshals and Alcatraz guards (*thugs is the proper word*), into that tiny city of 5,000 inhabitants—to force the “*enrollment*” of one negro in that hitherto All-White University — a negro whose grades positively would not have admitted a white high school graduate to enrollment. This same negro is a known criminal. He is under indictment for perjury — but all courts in Mississippi, where he committed his crimes, are “*enjoined*” from putting him on trial by order from the White House and/or the Department of Justice.

Now, it has been definitely established that that outrageous mess was another plot concocted by the NAACP to further the agitation, rioting and Communist-required racial strife and hatreds they have been inciting during the past 45 years. They hired this criminal negro, Meredith, for a fee of \$20,000. to “*seek*” enrollment in the Mississippi University. They took him out of an all-negro college in Jackson (Miss.) for that very objective, knowing that it would enrage the educational authorities and Governor Barnett — and further intensify racial strife and hatreds. Also, *let's not forget*, racial strife is one of the surest ways to destroy the solidarity of the American people, which is one of the chief features of the CFR program. Kennedy knew all that, so feeding the flames of that strife in Mississippi was his “*duty*.” At the same time it would mean negro votes.

Now, Kennedy knew that Barnett and the University had resorted to proper legal measure to bar the enrollment, but he didn't wait for the due processes of the laws to resolve the matter — both Kennedys scornfully flouted and defied the Constitutional Laws and rushed in a huge army fully equipped to fight a war, *not merely to insure order*. . . . And they added insult to injury by including a large contingent of negroes in that army!



I don't think it is necessary for me to describe in detail what happened in that little Mississippi community — the riots, the murders, the assaults, the rapine. All of those atrocities were committed (*physically*) by thugs operating behind U. S. Marshal's badges and in American Army uniforms, *but it was the Kennedys who pulled the triggers* — exactly as it was Al Capone who pulled the triggers of the guns in the hands of the thugs who committed the St. Valentine's Day Massacre in Chicago.

That lawless INVASION was intended to serve as a warning to all of the American people against resistance to total DICTATORSHIP by the Kennedys — and there is no doubt that had Governor Barnett continued to resist, they were fully prepared to make a Congo-like bloody shambles of Oxford and the University campus.

This obsession for total dictatorship of the United States is nothing new with the Kennedys. In our "*News-Bulletin*" No. 90 I reported Joe Kennedy's frequent boasts that "*there will come a day when the White House will become the throne room of the Kennedy Dynasty.*" He voiced those boasts back in 1930 (*and before*) when I saw a great deal of him on the Pathe Lot in Hollywood. And now Jack, Booby and Ted are determined to make good on those boasts. Of course, Jack could not have achieved the nomination and/or the election without the consent of the CFR — and, to get that consent, he had pledged himself to be a faithful and obedient stooge of that gang of Conspirators. But, undoubtedly, he figured that he would be able to outsmart the CFR boys and, *at the right moment*, seize complete power and total Dictatorship. That's a technique that was perfected by old Joe in all his looting operations. But old Joe didn't have to match wits with the steel-trap brains in the CFR. His victims in the Vaudeville field, in Hollywood, in all other industries, may have been sharp in their own particular spheres, but they were miles behind old Joe in the unrefined "*art*" of cross and double-cross. In addition, Jack is nowhere near as "*smart*" as old Joe. I predict he'll come an awful cropper long before he achieves his objective. As I pointed out in that same "*News-Bulletin*," the CFR boys take no chances with their stooges— *they made sure that all the men in the Kennedy Cabinet and the heads of all important agencies in the Federal government are members and/or hirelings of the CFR. . . .* and you may be sure that those CFR members and hirelings will cut the Kennedys down the moment they step out of line — unless Congress finally will come alive and beat them to it via impeachment proceedings.

I frequently stated that the Kennedys will stop at nothing to achieve their final objective — that they have employed threats,



coercion, falsehood, deceit, treachery, blackmail and (*at least in Oxford*) murder. Amazingly, Attorney General Booby Kennedy brazenly confirmed all that, *and that they will continue to employ those tactics*, in an interview published on October 7 (1962) in "*The Sunday Times*" of London, England. . . . Said Booby:

*"I have been talking this week to the top executives of 40 important business firms whose central offices are not in the South, but who have branches and investments in Mississippi, and have asked them to use their influence, via persuasion or by threatening to curtail their investments in Mississippi. . . ."*

So here we have the evidence right from a Kennedy mouth — the Attorney General, whose office has the power to harass corporations by prosecutions of various kinds, valid and/or "manufactured," blackmailing American business men to threaten to close Mississippi factories and thus curtail Mississippi payrolls. . . . and then, expressing a doubt that that "operation" might not be as fully effective as desired, he added:

*"The Federal government is spending about 650 million dollars in Mississippi, even though the state pays only 350 million dollars in Federal taxes. There are possibilities of withholding some Federal money from Mississippi. . . ."* and then, evidently realizing that he had let too much cat out of the bag, he hastily added: ". . . but that's a lever that must be handled with great delicacy."

What he meant was that such brazenly open blackmail might possibly boomerang via Congressional investigation that easily could lead to impeachment procedures.

Further evidence that they (*the Kennedys*) intend to continue those same tactics in their pursuit of Dictatorship powers is to be found in the following statement (*by Booby*) in the same interview:

*"I have recently talked to publishers whose newspaper chains include newspapers in Alabama to try and infuse some sanity in their readers. . . ."*

Obviously, Alabama is to be the next target, to be followed by So. Carolina and Louisiana, and those newspaper chains are to sound "warnings" to them that any state that would have the "temerity" to resist the Kennedy-NAACP objectives it promptly would get the full Oxford treatment!

Now, I am sure that every lawyer who knows Constitutional laws will agree that that invasion of Oxford, Mississippi, was a lawless act of aggression against the sovereign state of Mississippi — that it was **SEDITION**, *at the very least*, against the duly constituted government of that state. *And that was another time that our Congress*



*was frightfully remiss! ! !* It is the sworn obligation of Congress to protect each and every state of these United States from sedition— or attempted tyranny by the Federal government or any other individual state. The moment the Kennedys ordered that lawless invasion of Mississippi, *lawless as defined by our Constitution*, Congress should have hauled both of them in for a review of that lawless act — and followed it with impeachment proceedings. . . . It still should be done! *Or is Congress going to wait until would-be Dictator Kennedy will hurl our nation into a renewal of the CIVIL WAR?*

I have frequently been told that there isn't one member in our Congress who would *dare* to initiate impeachment proceedings against any President or Supreme Court Justice, no matter the degree of guilt. *I don't believe that!* I am positive that among the 600 odd-members there are a considerable number of men with plenty of courage to act. . . . *if the American people will assure them of their support — in no uncertain language.*

And that brings me back to the most vital point in this entire issue — my urgent warning that our most dangerous enemy is our own SHORT MEMORY — that the most potent weapon for our destruction in the entire arsenal of the Masterminds of the Great Conspiracy is the SHORT MEMORY of the American People!

I will now cite two specific examples of that SHORT MEMORY to stress my point — examples of events which, *had we kept them high in our memories*, would have prevented the disasters and frightening dangers we are facing today:

No. 1) In 1933 Roosevelt tried to put over his *National Recovery Act* (NRA) scheme. It was a scheme that would have given him sole and supreme power over our entire national Economy, set (*control*) prices of all our commodities, including food, clothing, housing, etc., etc. The U. S. Supreme Court killed that scheme by ruling that it was unconstitutional. The press, at that time still more or less uncontrolled, properly interpreted that Court Decision as evidence that the NRA scheme was intended to be the first stepping-stone to a complete Dictatorship — and denounced it in no uncertain terms — *and, thus alerted, the entire nation angrily joined in the denunciation.* His (*Roosevelt's*) "Court Packing" scheme met with a similar reaction — and in the 1934 election, when he went on a personal politicking tour to purge the members of Congress who had opposed him, the people showed their distrust of him and his schemes by overwhelmingly re-electing the men he was out to purge. Consequently, there was a general feeling and belief that 1937 would see a new President in the White House.



But then, realizing his danger, the crafty Roosevelt turned "*humanitarian*." He set up the WPA and other "*hand out*" schemes — the people FORGOT all about his chicaneries. . . . and handed him a landslide victory in 1936. . . . and that was the pattern he pursued in 1940 and again in 1944.

That SHORT MEMORY, of the American people, and the *dere-liction of our press* enabled him to inflict "*Pearl Harbor*" on us — it enabled him to LEND-LEASE (*what an ironic travesty!*) multiple billions to Russia, *our mortal enemy* — it permitted all of his (*and Eisenhower's*) World War II treacheries and YALTA treasonous betrayals.



No. 2) In 1919 Woodrow Wilson frenziedly tried to entrap us in the "*League of Nations*." By the Grace of God, that year we had a great American patriot, Henry Cabot Lodge (*not the present phony,*) in our Senate. He saw through the plot — and blasted it on the Senate floor. There were many other staunchly loyal Americans in that Congress — they all supported Lodge. *Even more important, in those days our press was still loyal — and free!* They alerted the people that the "*League of Nations*" was an Internationalist "*One-World*" plot to destroy the sovereignty of the United States — and through all the months that Wilson raced around all over the country with his "*personal appeal to the people,*" the press continued to "*remind*" the people — and the people *angrily* repulsed Wilson's appeals.

But in 1945 we had no strong voice (*Lodge*) in our Senate— and, *tragically*, we had no loyal press to REMIND and warn us. Instead, the foul N.Y. Times, Washington Post and other of our renegade press hailed the advent of the "UNITED NATIONS" with great joy and enthusiasm as the blessed harbinger for the PEACE of the world. And the short-memored American people swallowed all those phony press paeans and "*danced in the streets*" with even greater joy and enthusiasm. And so, ensconced within our own land, we now have a sanctuary for spies, saboteurs and American traitors, all brewing treason, all brazenly plotting for the complete take-over of our country, all protected by a phony "*diplomatic immunity*". . . . Only once before in all history has there been a similar betrayal — that was the TROJAN HORSE of the ancient Greeks, which pillaged and destroyed the then great city of Troy. . . . and in 1945 our SHORT MEMORY caused us to open our gates to a TROJAN HORSE that will surely destroy our nation — unless we can *in time* REMIND and alert the whole American people to demand that Congress *get the U. S. out of the UN* and drive the UN



headlong out of the U. S. — *before we suffer the fate of ancient Troy!*

NOW OUR "SHORT MEMORY" IS  
KENNEDY'S "UMBRELLA."

---

I have already noted how Kennedy was *forced* to deliver his "*brave speech*" on October 22; from an official source in Washington comes this further proof that he *knew* all along about the missile build-up in "Cuber." He was told about it in all its details by the Chiefs of Staff. They pleaded for permission to destroy the sites. But even after he was shown the U-2 photos, *which fully confirmed that the sites were there*, he continued to refuse to permit action. That so infuriated one of the Chiefs that he threatened to resign — *and reveal the story to the public*. Kennedy laughed at him, didn't believe he'd *dare* carry out his threat, and blithely went off on his politicking tour — and that was when that Chief "*leaked*" the story and the photos.

We know the rest: the panic-stricken Kennedy delivered his "*brave*" speech — and the press and Radio and TV wildly eulogized the "*great*" young Irishman's courage — and all the people burst into joyous hosannas. All at once, he became the man of the hour — a new God-Man, acclaimed because he told Khrushchev "*where to get off*" — acclaimed for a deed performed, *although the people didn't know it*, only to save himself. . . . and the very Republicans who were fighting tooth and toe nail to defeat his Yes-Men in the coming elections, fell all over themselves with eager assurances of "*full support*," obviously not realizing that thus they were snatching victory for him right out the jaws of sure defeat.

*Forgotten* was the deliberate, murderous betrayal of the "*Bay of Pigs*" Freedom Fighters. . . . *forgotten* was the cynical Steel hippodrome that had endangered our entire Economy. . . . *forgotten* was his 4th of July "*inter-dependence*" speech which, to all intents and purposes, *outlawed our "Declaration of Independence"*. . . . *forgotten* was his lawless "*invasion*" of Mississippi. . . . *forgotten* was his brazen (*unilateral*) Disarmament plot — his gift of hundreds of our Jet planes to Tito and the secret training of Communist pilots by our Air Force.

In short, all of his chicaneries, betrayals, plottings, including his reprehensible concealment of the Nuclear build-up in Cuba, were forgiven and FORGOTTEN — because he "*stood up to Khrush-*



*chev.*” And during the next few days, as the nation showered him with plaudits, Kennedy, to use an old Bugs Baer simile, was “*as happy as an idiot sucking his thumb.*”

But after a few days of it that “*honeymoon*” began to wane. Disquieting rumors began to come out of Washington. First, there was that October 27 and 28 exchange of letters between the Irish K and the Russian K, which, according to the Irish K, contained a pledge by the Russian K that all “*offensive*” weapons would be removed from Cuba pronto. . . . *but the actual contents of those letters were never revealed* — obviously, the Irish K considers that the safety and security of our nation is exclusively his own personal business. Then, the Russian K proclaimed that, in exchange for on-site inspections in Cuba, the Irish K had given him a “*no invasion of Cuba*” pledge — *and Kennedy did not deny it!* Moreover, the mysterious “*agreement*” dealt only with the removal of the Missiles — there was no mention of the Russian Nuclear Jet planes, nor withdrawal of the more than 25,000 Russian (*Kennedy’s technicians*) troops. That would mean that Cuba would become an undisturbed and *protected* Russian Satellite. . . . and, by that token, our “*Monroe Doctrine*” would become a dead letter.

On the heels of that shock came another even more stunning one: instead of insisting that the on-site inspections of the removal of the Missiles should be supervised by OUR military experts, Kennedy entrusted that vital job to, *of all people*, U Thant, a notorious Marxist! The little Burmese promptly demanded that Kennedy remove the “*quarantine*” and suspend our aerial reconnaissance flights. *Amazingly*, Kennedy obeyed! Thant flew to Cuba. Two days later he flew back. The trip was a flop. Castro had demanded various concessions, one of them being our surrender of Guantanamo, otherwise he would permit no UN observation team in Cuba. . . . and, in so many words, Thant *approved* Castro’s stand — he stated that to have insisted on carrying out the inspection in the face of Castro’s objection would be an *insult* to the bearded bum and an encroachment on the sovereignty of Cuba.

The nation-wide angry uproar that followed that statement startled Thant and Kennedy. Thant hastily issued another statement in which he “*assured*” us that he had been “*reliably informed*” that the Nuclear Bases were being dismantled — and Kennedy “*assured*” us that “*an agreement with Mikoyan will solve the entire Cuban crisis*”. . . .

**Reminder:** This is the same Mikoyan who six years ago was in Hungary and promised faithfully the withdrawal of all Red troops. Not only were they never withdrawn, but additional divisions of Mongolian troops were rushed



in to complete the massacre of the Hungarian Freedom Fighters. . . . and this is the murderous liar Kennedy depended upon to solve the Cuban crisis!

Those "assurances" didn't go very far with the now again suspicious American people — until Kennedy and the UN issued a joint statement that the entire inspection job was to be handed over to the International Red Cross — that Red Cross personnel would inspect the dismantled sites — that Red Cross inspectors would be on board the Russian ships that were to haul the missiles back to Russia — with similar Red Cross teams on Russian ships headed for Cuba with oil and food cargoes, to guard against re-shipment of Missiles to Cuba. That announcement had a catch in it which, at first, nobody seemed to sense: U Thant, presumably on orders from Mikoyan, stated that the various Red Cross inspection teams would not contain any American military observers. Inexplicably, nobody asked how Red Cross personnel, utterly unfamiliar with Nuclear weaponry, could possibly do that kind of an inspection job without military observers.

However, the "Red Cross announcement" was accepted by the American people. And with that, Pete Salinger, a run-of-the-mill newspaper reporter serving as the White House "public relations man," began to issue grandiose statements about the "speedy" dismantling of all the Bomb sites. . . . he described the evacuation of the Missiles by (*three*) Russian ships. . . . he reported that not only had the Red Cross inspected the Missiles on those ships, but that the Russians had very obligingly enabled *our* planes and ships to view those same Missiles on the decks of their ships. Simultaneously, a number of White House favorite columnists began to go all-out with glowing assurances that the Cuban crisis had become a great triumph for the U. S. — *all due to Kennedy's "masterful handling" of it.* They referred to "the outcome" of the crisis as "*a tree of victory*". . . . "*Russia's capitulation*". . . . "*Kennedy's most stunning victory,*" etc., etc.

However, not all of the Washington press correspondents were convinced. Also, some members of both Houses of Congress were dubious. They began to ask some very pertinent questions. For example, it had become known that the Russians had employed *many* ships, *easily more than a hundred*, to haul all those Missiles, Bombers and other Nuclear weaponry to Cuba; it also was known that the Russian "*technicians*" had worked for many months, perhaps even a full year, to set up all the sites. . . . the questions that arose were: *how could all those Missiles have been dismantled and crated for shipment back to Russia in a matter of days?* . . . *how was it that*



*only a (comparatively) few ships were able to accommodate the original hundred-shiploads of the materiel?*

Kennedy angrily (*he does get angry quite frequently, you know*) brushed off all those questions — and flatly announced that all the (42) Missiles had been shipped back to Russia.

And then, out of the blue, someone "*leaked*" that the Red Cross had made no inspections at all, at all—that, in fact, the Red Cross had refused to go into the "*deal*" on the ground that its personnel was in no way equipped to make such inspections. . . . and then it was revealed that all those "*missiles*" seen on the decks of the Russian ships were just shapeless objects covered by many layers of canvas and tarpaulins — that none of the men in our planes and on our ships saw the objects under those tarpaulins. They *could* have been Missiles — but, *more likely*, they were just "*dummies*".

At once, the picture changed all over again. Even the controlled press voiced outrage at the deception that had been practised upon them — some of even the most "*Liberal*" columnists bluntly called Kennedy a liar. Senator Barry Goldwater publicly proclaimed his (*more than*) suspicion that Kennedy had made a "*deal*" with Khrushchev, stressing that he "*is not convinced Russia removed those Missiles from Cuba,*" and that "*caves in Cuba are being used to hide the Missiles and other Nuclear weaponry*". . . . and other Solons began to voice similar "*suspicious*."

Those "*suspicious*" are more than verified by a detailed report from a positively reliable source, none other than the Cuban (*underground*) Information Service, which has Cuban secret agents operating throughout the island. This organization has previously supplied information — *which always proved highly accurate*. In this report they name towns, ports and Keys, all of which are directly related to subterranean caves, tunnels, hangars, submarine bases and other secret installations in Cuba housing Missiles, planes and other Nuclear weaponry that were NOT spotted — *couldn't be spotted* — by U-2 flights over the island. Following are the names of the towns in which the various caves are located:

1) **Towns of SAN CRISTOBAL and CANDELARIA:** Vast tunnels were dug here in 1961, and were waterproofed to house Missiles . . . . 2) **SOROA** has caves, long under Russian control, housing Missiles . . . . 3) **Caves of SANTO TOMAS and CERRO DE CABRAS:** Important underground storage for Missiles. In the same region, the Russians have installed an electronic station to monitor Cape Canaveral launchings . . . . 4) **SAN JULIAN AIRBASE** with vast underground facilities reactivated by the Russians . . . . 5) **LA PALMA AIRBASE:** Camouflaged air strips. MIG-21s and IL-28s are stored



out of range of aerial reconnaissance . . . . 6, 7, 8, 9) Underground storage vaults in HERSHEY, COTILLA CAVES, CANDELA HILLS and in the mountain at SANTA CRUZ DEL NORTE. The latter is also an electronic observation center. SB. SAN ANTONIO DE LOS BANOS AIRBASE has vast subterranean facilities constructed to house MIGS and IL-28s . . . . 10) YUMURI VALLEY is criss-crossed with tunnels 30 feet high and 60 feet wide, dug to accommodate Russian war materiel. The BELLAMAR CAVES run for miles . . . . 11) LA VICTORIA: Many tunnels, reinforced. Missiles installed in units of five, pointing skyward, are inside tunnel openings and cannot be seen from the air. Also Russian underground activities at LIMONAR and MATANZAS CITY AIRPORT . . . . 12) COLON AIRPORT is known to house MIGS and military transport planes . . . . 13) GUARACABULLA has guarded Soviet Missile facilities which are hidden from aerial reconnaissance . . . . 14) YAGUAJAY CITY: The 6-mile-long PUNTA DE CAGUANES cave has a convenient exit to the sea, and is being converted into a secret submarine base . . . . 15) MAYAJIGUA has Missile launching equipment installed in tunnels . . . . 16) SAGUA LA GRANDE: Missile sites were spotted from the air but it also has vast underground facilities . . . . 17) PURIAL HILLS: Tunnels honeycomb the hills. Huge quantities of materiel was moved in and more than 1000 men are permanently stationed here . . . . 18) LA RONDO: The Russians took over 97 acres of land adjacent to a system of caves and tunnels, all camouflaged from above . . . . 19) CASILDA: Missiles were set up here pointing straight at the Panama Canal . . . . 20) SAN JOSE DE LOS JIBAROS and SIERRA DE CUBITAS HILLS have tunnels containing Missiles and launchers . . . . 21) PILON and PENON HILLS: Two long tunnels housing heavy equipment . . . 22) INDIO, LOS PERROS, LOS MUNECOS and BONITA CAVES, all containing armaments . . . . 23) FOUR HUNDRED ROSES CAVE: Offensive arms stored. Large submarine base under construction at BANES . . . . 24) MANATI has Missile sites . . . . 25) VICTORIA DE LAS TUNAS has more Missile sites . . . . 26) CHAPARRA SUGAR MILL: Again, more Missile sites . . . . 27) CAYO LEBISA has been converted into an underground military base . . . . 28) MARIEL: Mines planted against seaborne invasions along the entire coast from Mariel to Marianao . . . . 29) TURIGUANO has canals dug for submarine base . . . . 30) IGUANA KEY: Huge magazine built. Powerful radar installation at PUERTO ESCONDIDO to keep watch on our nearby GUANTANAMO NAVAL BASE . . . . 31) TWELVE LEAGUE KEYS has many small bases and observation posts . . . . 32) CIENFUEGOS: Another submarine base built in the bay . . . . 33) CAYO LARGO has Missile installations with a submarine platform.

Communist propaganda has tried to conceal the nature of the large military bases at Camp Liberty, Havana, at Minas del Frio and in the Sierra Maestra Mountains by alleging that they house school centers.
