### "DON'T TELL THE PEOPLE!"

As I have frequently pointed out, the power of a nation lies in its people, not in those who are in the seats of so-called power.

That's why, from time immemorial, the one great cry of the Despot or Dictator has always been "*Don't tell the people!*" The wrath of an aroused people is the one thing the Dictator has always feared the most. That's why the first step of the ILLUMINATI-CFR Conspirators had been to get complete control of all our Mass Communications Media. But even with that control there are times when some startling bit of information slips out and gets published. You may have noticed that some stories are published in the first edition of a Metropolitan daily, then mysteriously disappear from the "*home*" and succeeding editions of that day . . . you hear a bit of news on a Radio or TV broadcast, and then tune in on the succeeding hourly broadcasts only to find that that news item has been "*killed*". *The Conspirators "Censors" caught the escaping news within the hour and locked it up in the "top secret" file!*

However, there are other occasions when startling statements or developments are *deliberately* published to serve as "*trial balloons*" to test public reaction to a proposed plan or policy. The "*Iron Mountain Report*", published early in 1968, was one such case. We cannot be certain whether that report appeared accidentally, or whether it was published deliberately as a "*test case*" to measure public reaction. In either case, the following is factual—it *did* happen—it was published in the "*Iowa City (Iowa) Press-Citizen*" of March 2, 1968—and it did unmask the "*EXECUTIVE ORDERS*" phase of the over-all plot of the Conspiracy to such a degree that it aroused a dangerous public reaction, and the Conspirators hastily abandoned it—*for the time being* . . . I say "*for the time being*", because, as I have so often stressed, this ENEMY never quits—they wait until the people have "*forgotten*" and then try the same scheme all over again. Anyway, for your information, the complete article, published by the "*Iowa City Press-Citizen*" of March 2, 1968, follows:

### **"RATION BOARD BEING SET UP HERE"**

**By Robert G. Hibbs, Citizen-Press Staff Writer.**

"Arrangements are being made in Johnson County to set up a Federal rationing board. Civil Defense and Office of Emergency Planning officials were in Iowa City last week to organize it, but for lack of sufficient turnout at a courthouse meeting, they were able to lay only the preliminary groundwork.

"With the trends in the economy because of the war and spiraling inflation, some stabilization or rationing may become necessary, according to Johnson County Civil Defense Director Wayne Walters. "I want to emphasize

we're not crying wolf and saying it's going to be necessary to use them (control boards)." He then explained that plans call for the nation to be prepared for economic instability just as it is prepared for nuclear attack.

"The rationing board, local persons were told at the meeting, is to be ready to go into operation immediately on notice from the President—with arrangements for printing (Ration) cards made in advance and a director designated. Walters emphasized, however, that nothing is being done other than organizing and selecting persons to serve.

"If the Board were activated, controls could be placed on virtually everything from consumer products, such as food and gasoline, to wages and banking institutions, those attending the two-hour Courthouse session were told by Peter Braylic, State economic stabilization director for the U.S. Office of Emergency Planning.

"Such a Board, similar to ones many will remember from World War II, has been formed in Guthrie County, ready to go into operation on national order, Braylic said. A director to operate a program there, should that become necessary, has been designated.

"The meeting here, held in the Board of Supervisors office, was called by Supervisor Clayton D. Mahoney. He's chairman of the Johnson County Civil Defense Agency. No advance notice was given to permit members of the public (other than serving on the CD Council) to take part in the meeting.

"Those attending the session in addition to Braylic and Walters were Iowa City Assistant City Manager Kenneth Millsap, Coralville Police Chief Wayne J. Winter, University Heights Mayor Chase F. Coulter, University of Iowa representative Richard E. Lewison, Civil Defense representative Cliff Gustenberger of Des Moines, and an observer from Iowa State University, Thelma Hayes.

"U-Heights Mayor Coulter said the meeting 'shook me to my bones'. He said he finds it 'fantastic' that a nationwide organization is being set up that will permit the President to take over the entire country at his own will . . . 'The local authority does nothing but what it is told', Coulter commented.

"Millsap said he is concerned by the move, couched in terms of 'economic stabilization', noting that 'they made it SOUND like a logical extension of the Civil Defense program'.

"Others who attended the session said privately they are concerned by 'the amount of power being placed in so few hands', as one put it.

"Walters, who was asked to do the follow up work on the session last week, said he as yet has been unable to devote time to it. He said as yet no one has been chosen to serve as director, and no one has been named to a board. 'We are going to have to have more mayors and others involved

in development of the program' he said, adding that it is desirable to have cross-section of areas to be controlled represented.

"Walters said Congress authorized creation of the Boards under Office of Emergency Planning legislation . . . 'I want to emphasize', he added, 'we're not going to do anything but select people and get the organization work done' ".

There, then, was the announcement — *in black and white* — of the establishment of Board and Control Agencies — *at the local level* — to bring about an Executive Dictatorship via the Office of Emergency Planning and the Civil Defense Agency, *at any time the President of the United States may so direct!!!* Obviously, he would employ the "EXECUTIVE ORDERS" in the "FEDERAL REGISTER" to turn that trick.

That incident in Iowa City, Iowa, provided us with the evidence of the fact that the machinery of Dictatorship was being set up at local levels throughout the nation — even to the printing of ration cards *in advance*, and the appointment of local control officers.

To emphasize the horrifying menace of these "EXECUTIVE ORDERS" and the "FEDERAL REGISTER" I will repeat a warning issued by "DEFENDERS OF THE AMERICAN CONSTITUTION, INC.," Gen. P. A. del Valle's organization:

"The Civil Defense and Disaster Board of a city has the power to enforce these EXECUTIVE ORDERS. On occasion of any crisis, real or MANUFACTURED, it notifies the Major, who notifies the Governor, who notifies the President. Upon the President's approval, the entire program automatically goes into effect . . . The State and Federal governments can take over your business, your job, your home, your bank account, your personal property and your person. You might be rounded up and transported to areas they will designate. You may be ordered to work at tasks which they will determine. Your home may be razed and rebuilt elsewhere on pretext of clearing a 'dangerous area'. All housing will be under government control".

After being exposed to only parts of this plan for Dictatorship, Mayor Couiter of University Heights, Iowa, found it "fantastic that a nationwide organization was being set up that will permit the President to take over the Country at his own will". And Iowa State Director for the U.S. of Emergency Planning admitted that controls could be placed on "virtually everything from consumer products to wages and banking institutions."

To further give you a very clear idea of the horrifying menace of these "EXECUTIVE ORDERS", I will quote from Garet Garret's "THE REVOLUTION WAS", as follows:

"Revolution in the modern case is no longer an uncouth business. The

ancient demagogic art, like every art, as we say, advanced. It has become in fact a science—the science of political dynamics. And your scientific Revolutionary in spectacles (INTELLECTUALS and INTELLIGENTSIA) regards force in a cold, impartial manner. It may or may not be necessary. If not, so much the better; to employ it wantonly, or for the love of it, when it is not necessary, is vulgar, unintelligent and wasteful. Destruction is not the aim. The more you destroy the less there is to take over. Always the single end in view is the transfer of power.”

Our Federal Government — especially in its *appointive offices* in the Executive and the Judicial branches — is loaded down with “*scientific Revolutionaries in spectacles*” (INTELLECTUALS). In bringing about this social revolution of which they boast and to the success of which they are wholly dedicated, they would prefer not to use force — simply because they say that the use of force is “*vulgar, unintelligent and wasteful*”. But, when force and violence are necessary to the success of their plans, or necessary to prevent their plans from being failures, they are cold-blooded and impartial about using force and violence. When rioting and insurgency are necessary to aid in maintaining the Economy as best fits their purpose, they do not hesitate to prolong for years a war (*Vietnam*) that could be won in weeks.

In short: they don't want to declare a nation-wide “*Emergency*” with its CONSEQUENCE of COERCIVE DICTATORSHIP via the EXECUTIVE ORDERS. But if they must finally do so; well, the machinery of dictatorship must be set up and prepared to function, even in such remote communities as Iowa City, Iowa . . . And the conditions required to “*push the button*” and start the machine: “*times of international tension or economic or financial crisis*”.

That phrase, “*financial crisis*,” calls for particular appraisal: Federal fiscal policies are not going to be changed simply because the President of the moment poses as an ADMINISTRATOR rather than a Politician (*remember Philip Dru-Administrator?*). There is no intention of balancing a budget. Any income tax surcharge is like a bucket of water thrown to quench a forest fire. At the time that LBJ was twisting the collective arm of Congress for that 10 percent surtax, Rep H. R. Gross made the following speech on the floor of the House:

“I hope that some day we can bring an end to this business of a bunch of Americans (Congressmen and Presidential agents) going over to New Delhi, or to Buenos Aires, or to some other cockeyed place around the world—Timbuktu, or Quagadonouou—and there sit down with a group of foreigners and agree that the U.S. share of this fund or that fund, for the purpose of our participation therein, is going to be 41% or 70%. I hope we can summon the courage here to some day say to the people of this

country that Congress and only Congress will make these deals. Let us put an end to this business of a few individuals taking trips abroad and coming back to say to Congress that 'we have been down there and a commitment was made, and now you have got to pick up the check'."

Of course, Congressman Gross knew that nobody in high places was listening to what he was saying. Like a political Isaiah, he was getting it on the record and hoping his words will help judge the "scientific Revolutionaries in spectacles" when that delayed judgment comes. To "create financial tension" seems a deliberate part of the revolutionary planning.

With the dollar at its weakest, the call is for billions for cities, a guaranteed annual income for every family. At the same time, the Federal Reserve increases its discount rate higher and higher. Remember that financial panic was brought on in 1929 so that these scientific Revolutionaries could install the NEW DEAL, that first great victory of the Social Revolution!

As the Fed's discount rate kept going up, in 1968, Chairman William McChesney Martin told the world that "The nation is in the midst of the worst financial crisis since 1931 . . . in 1931 the "problem" was deflation. Today it is inflation and equally intolerable". He "foresaw" the Federal budget deficit would be about 20 Billion for the next fiscal year (1968) "which is intolerable." He also said that the international payments deficit would be intolerable. "Both have to be corrected," he said, "or the U.S. is going to face either an uncontrollable recession or an uncontrollable inflation." Well, Mister Martin ought to know—he helped to bring about the intolerable situation he predicted.

The *Wall Street Journal* stated in response to that prediction: "Federal mismanagement is the crux of the matter . . . the Government has been living in a fool's paradise . . . But let no one confuse the issue: it is there in Washington, not in the private economic affairs of the ordinary citizen, that the cause and the cure of the terrible trouble lie."

Mismanagement, yes. But it is *deliberate* and *premeditated* mismanagement. These people in high places are not *stupid*; they are not innocent bunglers; they are NOT ignorant. They know what they're doing—they are crafty operators and they know which way the nation crumbles, because *they* are directing the crumbling. Their aim is not destruction for the sake of destruction — their aim is a *transfer of power*, from the elected representatives of the people to a *Bureaucratic Elite*, which will impose a dictatorship, *but not with force unless force will be absolutely necessary*. But if it will be necessary, the machinery will be ready to function—even in Iowa City.

Revolution requires opportunity, and readiness to take advantage of the opportunity. 1929 was an opportunity *made to order* . . . and there was a Revolutionary Elite ready to take advantage of the opportunity. That Elite failed in great part, and had to use FORCE (*World War II*) to maintain the hold it had secured over the U.S. and the American people. And it had to hold and WAIT — wait for the technological development (*computerized control of Media, Money, Manpower, Minds, etc.*) to provide the weapons necessary for taking fullest advantage of the next Great Opportunity.

Speaking of that first (1929-1933) Great Opportunity, Garrett stated: "This Revolutionary Elite was (on the face of it) eminently respectable and it knew the American scene . . . a doctorhood of Professors, Writers, Critics, Analysts, Advisors, Administrators, Directors of Research, etc., etc., — a prepared 'Revolutionary Intelligence in Spectacles.'" There was one idea in which all differences could be resolved, namely, the idea of A TRANSFER OF POWER! For that a UNITED FRONT: after that, anything!

In 1968 President Johnson renounced Politics to become an Administrator, for the purpose of ending divisiveness and creating a *United Front*. The machinery (*FEDERAL REGISTER and EXECUTIVE ORDERS*) is ready, the foreman and supervisors are at their posts; if necessary, the button will be pressed because of *manufactured "international tension or Economic or Financial crisis"* . . . and from all indications, particularly in his appointments to important posts, Nixon is all set to follow in Johnson's footsteps!

## THERE IS ONLY ONE "CURE" FOR IT

---

Now, as I have previously stressed, *the people* are the real power of a nation. There is absolutely no doubt that a fully alerted and aroused (*American*) people could very quickly torpedo the entire GREAT CONSPIRACY, but the matter of alerting, *and thus arousing*, our people to the menace of this Conspiracy is our most frustrating problem.

Many who have been reading all of our previous "*News-Bulletins*" will assume that that "*problem*" lies in the fact that the vast majority of our people are deceived and brainwashed by our treasonous CFR-controlled Mass Communications Media. In great part, that is true, but that is not the *root-cause* of the "*problem*". Many others will assume that the "*problem*" lies in the fact that our Federal Government, as a whole, particularly the Executive, Legislative and Supreme Court Departments, are controlled stooges, (*and traitors*)

of the Masterminds of the GREAT CONSPIRACY, and that, too, is very true, but that, too, is not the *root-cause* of the "problem".

Some of our most concerned patriots, and that included such men as (*the late*) John T. Flynn and Senator Joe McCarthy, charged that the *root-cause* of the "problem" is the apathy of the American people. That charge was (*and is*) correct, *but only to a degree*, because the word "apathy" is a misnomer — it is not understood. Webster defines apathy to mean "Want of feeling; lack of passion, emotion or excitement — indifference (don't care) to what appeals to feelings or interest".

Thus, while the word "apathy" may cover the *seeming* indifference of the people to the real problem of arousing the people to take action against the menace of the GREAT CONSPIRACY, it is not the real "*root-cause*" of it. The real "*root-cause*" is that from the time when our Constitution was handed to us by our Founding Fathers it (*the Constitution*) was taken for *granted* by the people as a "*cure-all*" against injustices — that it stood between us and those who would seek to acquire dictatorial control of our nation. The word "*unconstitutional*" has always been used to protest injustices or threats to the Life, Liberty and Freedom of the people — and those who used that word simply assumed that those in authority, particularly our Congress and our U.S. Supreme Court, would turn to the principles and provisions in our Constitution to set everything straight. In other words, the blind faith of our people in the Constitution is the real "*root-cause*" of all our troubles. What the people have always overlooked is the fact that our Constitution is merely a written document which *provides* the provisions to protect the Life, Liberty and Freedoms of the people, but that by itself it has no power unless its provisions are *enforced* by those to whom the enforcement powers have been delegated. To simplify what I mean, a warrant issued by a Judge is just a "*scrap of paper*" unless that warrant is carried out (*enforced*) by a properly appointed officer of the Law. *All* our Laws and Warrants are just "*scraps of paper*" unless they are backed up by *enforcement* officers, or powers. And that same condition applies to our Constitution. Our Laws and Warrants are enforced by police officers, U.S. Marshals and similar enforcement officers; our Founding Fathers provided similar enforcement powers in the Constitution — they created Congress to serve as its enforcement powers. But, tragically, the people always assumed that the Constitution could do its own enforcing, and ignored the actual enforcement powers that were delegated to them (*the people*) via our Congress . . . the following will prove my point:

Our Constitution is the most wonderful DOCUMENT ever written for the protection of our people. It contains all possible *pro-*

visions for the protection of Life, Liberty and Freedom for all our people. But with full understanding of human nature, and as a matter of precaution, the men who wrote our Constitution also provided for *three* separate Divisions of Government to carry out all the provisions in the Constitution—each Division to stand guard and check the other Divisions should either of them stray, wittingly or unwittingly, from any of the provisions written into the Constitution. The most powerful of the Three Divisions is our Congress. Our Founding Fathers *intended* it to be the most powerful, because it directly represents the will of the people who choose the men they send to Congress to represent them and to *guard* their interests. It is the Congress, *and* only the Congress, that has the power to check and restrain the Chief Executive (*President*) from acts and deeds in defiance of the Constitution . . . it is the Congress, *and only the Congress*, that has the power to prevent the U.S. Supreme Court from flouting our Constitution by such acts as basing DECISIONS on “*the principles of the UN Charter*” instead of on the provisions of our Constitution. Under our Constitution, Congress has the power to investigate the acts of both the Executive and the Supreme Court via Congressional investigation, or, if necessary, *via the Impeachment process!* Congress also has the power and the right to investigate ALL Federal officials and Agencies and to legalize or NULLIFY all Legislation proposed by their own Committees and Members—just as they (*Congress*) should, *and could to this very day*, have nullified the “*Federal Reserve Act*” whereby two renegade Senators and the unconscionable Woodrow Wilson delivered our Money System to the International Bankers’ Great Conspiracy—that treasonous foul act was carried out despite the fact that our Constitution specifically placed (*and still places*) our Money System in the control of Congress.

In short, our Constitution was, *and still is*, the same perfect instrument to protect us that our Founding Fathers had intended it to be, but, *even as they were writing it*, our Founding Fathers knew that it would be a TREASURE that would *always* require protection and guardianship—the *protection and guardianship by the PEOPLE!* And close study of the Constitution clearly reveals that for that reason the Founding Fathers included the provisions that provides the *people* with the power to enforce that guardianship and protection; to wit: they placed all powers of Legislation with a Congress, all members of said Congress to be chosen and elected by the people of the various Communities of our Land—and that all such Members shall be directly responsible to the people who send them to Washington to fulfill their oaths to guard and protect the Constitution. Furthermore, it (*the Constitution*) provides the power to the people to FORCE their Representatives in both Houses of Congress to fulfill their oaths by calling them to *account* by a

simple RECALL measure. Thus, when, in 1913, those two renegade Senators and Woodrow Wilson deliberately foisted upon us that "*Federal Reserve Act*", which *unconstitutionally* took our Money System out of the control of our Congress and placed it in the hands of a gang of (*Robber Barons*) International Bankers, it was up to us (*the people*) to have demanded a thorough Congressional investigation of that vicious betrayal of our Constitution — or to have RECALLED every member of Congress who would have refused or failed to join in such a Congressional investigation. That same kind of negligence by our Congress has "*happened*" again and again. It happened in 1945 when, despite our Constitution provision that we can enter into Treaties *only with other Sovereign Nations*, our Senate signed us into membership in the "UNITED NATIONS," which has absolutely no semblance of Sovereignty. It happened again when we transferred our Armed Forces into the control of the UN in its so-called Police Action in Korea. It happened again when, without a declaration of war by Congress, *as distinctly required by our Constitution*, we entered into that Viet Nam (UN's) war.

In short, our Congress has been deliberately betraying our Constitution in all of the above acts — it (*Congress*) has been betraying our Constitution when they permitted Earl Warren and the other Supreme Court Justices to issue DECISIONS "*based on the principles of the UN Charter*," thus completely ignoring and flouting our Constitution, and, thus collaborating with the Masterminds of the GREAT CONSPIRACY . . . and the American people have been completely ignoring all those betrayals by failing to call Congress to *account* for those betrayals. Thus, we, the people, have no one but ourselves to blame for permitting our Constitution to have become just "*a scrap of paper*".

But it CAN happen here — *despite our Constitution!* As a tragic matter of fact, it *has* been happening here — and it will continue to happen here, unless our people come awake and turn to our Constitution for the means and methods to prevent the final transformation of our USA into a Soviet-like Police State and Dictatorship.

communities they are banding themselves together in little Patriotic Groups to serve as PAUL REVERES in their communities. But, unfortunately, even these Patriots don't know the *full score* — they *still* are primarily concerned with their own local problems (*such as SIECUS*) — but they don't realize that each and every one of those problems is a part of the over-all Conspiracy . . . they (*generally speaking*) don't realize that our only hope for the salvation of our Country is that ALL Americans must work in unison — that all of us must set our sight on just one goal: *to destroy the ILLUMINATI-CFR plot to transform the U.S. into an enslaved unit of a UNITED NATIONS ONE-WORLD GOVERNMENT!* Once *that* will be accomplished all our "problems" will die with it — *and that includes the plot to destroy Christianity! ! !*

In short, the following is a BLUEPRINT for a sure-fire way to weld ALL loyal Americans into one solid mass of "CHRISTIAN SOLDIERS" to achieve that goal. YOU and all the Leaders of the various Patriotic Groups can go far to do the welding.

Nowthen: if you are a member of *any* Patriotic Organization you don't have to be told that all such "*Humanitarian*" outfits as the "*Anti-Defamation League*", the "*Urban League*", the "*Atlantic Union*", "*Fund For The Republic*", "*League of Women Voters*", "*Siecus*" and other "*Groups*" of that ilk, are just splinters of the over-all Plot. But in your community you may have only one of the "*splinters*" that is working in real high gear. In consequence, your Patriotic Group is so deeply concentrated in the fight against that one "*splinter*" that it becomes almost unconscious of all the other "*splinters*" — *and of the over-all Plot.*

Therefore, I shall now focus your entire attention on two "*splinters*" that are *seemingly* unrelated, yet, are the most vicious Siamese-twin of the over-all plot — and, in one form or another, that double-splinter is a very live, very vital, and a very grave menace in *every* community in the United States — because those two "*splinters*" are directly responsible for all the street riotings by negro mobs — all the Campus riotings, all the disorders and lawlessness in our cities. And *therein* all *loyal* Americans have one common Cause and Goal which should unite all of us into a GREAT ARMY for the salvation of our REPUBLIC.

The Satanic "*twins*" to which I am referring are the "*Anti-Segregation*" plot and the "*Minority Groups*" agitators. Now: the "*Segregation*" matter may *seemingly* be closer to the hearts of the people of the South, but it is just as vital to ALL true Americans. By the same token, the "*Minority Group*" problems in New York, Chicago, Detroit, Los Angeles, may *seemingly* be closer to the people in the North, the East and the West, but they are just as vital to the South-

erner, because the "Anti-Segregation" plot and the "Minority Groups" agitations are the Siamese-twins menace to our entire nation. Both are integral phases of the ILLUMINATI-CFR Conspiracy.

In short, ALL of our present problems and dissensions can be traced directly to one gang: *the International Bankers*. And with the calculated risk of being charged with anti-semitism, I must stress that the masterminding "hatchet-men" organization of the Internationalist Politburo is the outfit that calls itself "*The Anti-Defamation League of the B'nai B'rith*" . . . This ADL outfit directly controls every sinister "Minority Group" movement in this Country—and, to a great degree, in the entire world. *We have documented proof for it!* But let's confine ourselves to our own Country—and, first of all, to the South.

Let's go back to the inception of the NAACP in 1909. Its first President was a man named Spingard, a white man, a Jew, financed by Jacob H. Schiff and the other International Bankers in New York. Likewise, his successors in that office were Jews—and their legal counsel always were white men. Every move made by those NAACP officials was in conformity and collaboration with the ADL. With the help of their Hollywood affiliates, the ADL has through the years produced films to further the dissensions created by the NAACP and URBAN LEAGUE and various other Negro organizations—as also for their own (ADL) dissension breeding activities. One such film, made early in the years of the Conspiracy, depicted how the Southern people were deliberately murdering harmless and inoffensive negroes and persecuting Jews. It was such a vile and vicious film that an outraged Police Lieutenant in Los Angeles issued a strict warning that if that Film, titled "THE CHALLENGE," would be shown within the city limits of Los Angeles, he would raid the place, (*or places*) where it would be exhibited—and prosecute to the limit of the law all who were responsible for the showing. The ADL made many such Films for showings in Schools, Churches, Synagogues, etc. But they never permitted anybody to get possession, by purchase or otherwise, of any copies (prints)—obviously for fear that some outraged American would use it to unmask and expose them . . . *all such Films were used to inflame the Negroes into the riotings that we have been suffering in all the later years, and which are scheduled to be increased in 1970!*

I will now cite one concrete example of how the ADL cooperates with, *and virtually directs*, the activities of the NAACP and all the Negro MILITANT gangs, providing them with legal talent, propagandists and finances: immediately after the U.S. Supreme Court issued that malodorous "Anti-Segregation" Decision, the NAACP and the ADL started a pressure campaign on Los Angeles Fire Chief Al-

derson to immediately integrate negroes in all the Los Angeles Fire department companies. Alderson, then considered one of the greatest Fire Chiefs in the Country, refused, on the grounds that it might disorganize the entire Department. However, the pressure was so great that finally, against his better judgment, and over a general protest from the White fireman, he did integrate several companies. Immediately, there was pandemonium in those companies. The Whites promptly gave the Negroes the "silent" and "contempt" treatment. Within a matter of days the Negroes hurriedly applied for transfer back to their old (*colored*) companies.

Thereupon, a clique of three White firemen set themselves up as an unofficial "protest" committee. They began to sow their seeds of dissension within the entire department—with charges of discrimination and "persecution" of the colored men. Naturally, every one of those three was the "Fifth Amendment" type of "American". Finally the most vicious of the three went entirely berserk with his activities and was brought up on charges before the Board of Fire Commissioners. And who do you think turned up as his zealous attorney?—a Mister David Ziskind, one of the ADL's prize lawyers, whose chief activities had been "humanitarian" work on behalf of the NAACP and other "Minority Groups".

Almost simultaneously they tried another tactic to "punish" Chief Alderson: the NAACP made a demand on U.S. Attorney Laughlin Waters to get a Federal (*no less*) indictment of Alderson for "violation of civil rights" of Negroes in the fire department—and bear in mind that Chief Alderson had nothing to do with that "silent contempt" treatment by the White members of the department that caused the Negroes to ask for transfers . . . The delegation that called on U.S. Attorney Waters was headed by one Loren Miller, a Negro lawyer, with a long, *but very long*, record of Red activities and "Minority Group" agitations—like Ziskind, *Miller had ADL written all over him!!!*

In short, without the ADL (*and the CFR*), the NAACP and all the other MILITANT Negro organizations would be about as powerful and effective as so many field mice. Practically ALL the Whites and lawyers working for all the Negro organizations are members and/or affiliates of the ADL. The same is true of every agitating "Minority Group" in the United States. The same is true of every Red-controlled Labor Union. Walter Routhier and his gang got their original backing and support from the same source. The various National Broadcasting Networks and TV Channels are *directly* controlled by the ADL and CFR. That is openly obvious by the fact that the top Executives of the Networks and Channels are top officers in the ADL and among the Masterminds of the

CFR . . . And, as I have frequently revealed, they also have an iron grip on our Press, including Magazines, book publishers and book-sellers. In my book "RED TREASON ON BROADWAY", written in 1949, I NAMED the ADL officials who own or control most of our important Newspapers, chains of Newspapers, and Wire Services. I also described how they intimidate and blackmail ALL (*particularly the comparatively few independent*) publishers through their control of the advertising budgets of Department Stores and other advertisers.

Now, of course, all of the foregoing is, speaking in the vernacular, "old stuff". Throughout all the years since 1946, when we unmasked the "Red Conspiracy in Hollywood" via a FORCED Congressional Investigation, we (CEG) have warned the American people of each and every new scheme and sub-plot of the ILLUMINATI-CFR concocted by the Masterminds of that Great Conspiracy. Each of our warnings *did* awaken and startle the people into action to torpedo the various plots—they (*the people*) did join in the fight to unmask the REDS in Hollywood—they *did* torpedo the UWF "RESOLUTIONS" plot to seduce our various Legislatures to FORCE Congress to transform the U.S. into a unit of a UN One-World Government—they *did* torpedo Eisenhower's plot to repeal the "Connally Amendment", etc., etc., but after each event, they, *the people*, felt that "the job" had been accomplished, and went right back into slumberland, ignoring my *constant* warnings that this ENEMY never quits, that they wait until the people forget, then they (*the Conspirators*) try the same schemes all over again under new camouflage. Hence, I early realized that we must remind and remind *and remind*, repeat and repeat *and repeat* our warnings.

Here let me give you conclusive proof that if the people would stop *forgetting* they could have torpedoed the entire Conspiracy many years ago: Beginning in August 1950, we devoted a number of our monthly "News-Bulletins" to charges that Eisenhower was a witting—and groomed—tool of the ILLUMINATI-CFR gang. We charged that he was being groomed by the CFR to become *their* man in the White House—and that if he ever did become the President of the United States, he would devote all his efforts to transform the UN into a One-World Dictatorship—also that he would champion the various Negro and "Minority Groups" objectives to create terror in all our cities—with "Anti-Segregation" to be the *ultimate instrument for the final victory for the Conspirators*. The CFR had finally decided that the best way to launch that "Anti-Segregation" plot would be through U.S. Supreme Court Action. Now, as we know, when the appointment of Chief Justice was made available, Eisenhower sent his Attorney General Brownell to Cali-

for a conference with Earl Warren—and the big question in that conference was would Warren, if appointed to be Chief Justice, be willing to “club” the other 8 Justices into a de-segregation “DECISION”? Actually, it wasn’t necessary to “club” ALL of them—for example: Frankfurter, Douglas, Black, etc. And, actually, it wasn’t necessary to ask Warren if he would cooperate—*we in California KNOW Warren for what he is!* Anyway, Eisenhower appointed Warren—and Warren, *quoting the opinions of Aliens instead of our own Constitution as his authorities, issued the horrifying De-Segregation DECISION.*

During Eisenhower’s campaign in 1952, we (CEG) warned the American people very explicitly that a de-Segregation deal was in the making, but the people just wouldn’t believe it . . . If the American people of the year when Warren issued that DECISION had been the Americans of yore—if our Senators and Representatives had been loyal to their constituents and to our Country instead of to the One-World Conspirators, all nine of those Supreme Court Justices would promptly have been impeached—*Eisenhower too!* As a matter of fact, if we were the Americans of the past century, many of today’s BIG SHOT politicians would long since have been hanged as outright traitors. Can you imagine in those years a Rusk, A Dulles, A McNamara, A Warren, a Fortas, a Justice Douglass, or even an Eisenhower, a Kennedy, a Johnson, or a Nixon, daring to scheme to transform the U.S. into an enslaved unit of a UN One-World Government?

Now I will get down to the crux of this “*News-Bulletin*”—and my humble suggestions how to transform our people into the kind of Americans we used to be.

During the past score of years I have travelled the length and breadth of our Country. I have studied our people. The *vast* majority are loyal to Country and God. But they have been tragically misled and brainwashed by a treasonously-controlled Press, TV, Radio and Screen. They are naive and have been accepting guile and craft for truth and honesty. In our 1955 *News-Bulletin*, “*The Eisenhower Myth*,” I revealed the full facts of Eisenhower’s vicious inhumanities in his collaborations with Stalin and Zhukov, yet the American people were solidly “sold” that he was a great “humanitarian”—even his (and Warren’s) desegregation scheme had been “sold” to the people as an example of his great “humanitarianism.”

Now, however, although still more or less bewildered, there are millions of true Americans who are eagerly ready for the TRUTH. They are ready and willing to unite and wrest the destiny of our Country out of the grip of the traitors—all they need is fearless leaders to *unite* them into one great fighting body.

There are two things that have been shocking our people into a sudden awakening:—1) The horrifying SIECUS plot to destroy the morals and morale of our YOUTH, *from kindergarten to the University Campuses . . .* No. 2) The Plot to destroy Christianity as revealed in our “*News-Bulletin*” No. 142.

As a result, during the past year or two, in practically ALL parts of America, little “*Groups*” of such Americans have sprung up—large Groups, small Groups, tiny Groups. Some are purely Local, some are statewide, some are even *loosely* nation-wide. *United*, these Groups could easily control the men they elect to represent them in Washington—and in their State Capitols. *United*, they could *force* the impeachment of every traitor in high office from the White House, the State Capitols and U.S. Supreme Court, down to the lowlier ones—they could RECALL every Senator, Representative and State Legislator who will fail to fulfill his oath to be loyal to Country and our Constitution . . . *united*, they can cure every national ill, destroy every national Cancer . . . *united*, they can restore our Constitution to all its power and grandeur—and *save the nation* . . . *united*, they can bring our America back to the American Way of Life created for us by our Founding Fathers.

That is my plea in this “*News-Bulletin*”. Let’s get UNITED—individuals and “*Groups*”. But let me caution you: before we start on any movement to unite these hundreds, perhaps thousands of Groups, we must carefully evaluate the word “*unite*”, lest we disrupt instead of unite.

We Americans are, or always have been, a ruggedly individualistic people. We would not be fighting so hard for our Freedoms if we were not individualistic. The true American will not accept the kind of “*unite*” that will lose for us our *individual* freedom. In that respect, all those “*Groups*” are “*individuals*”. In all cases, *as individual Groups*, they are, *above all*, concerned with their own local problems. For example:

In Mississippi, Louisiana, Georgia, etc., the Segregation problem is the most vital—in Wisconsin the vital problem may be the Labor racket—in another State it may be Fluoridation—in another one it might be the “*Minority Group*” FEPC racket.

All those are “*local*” problems and, *seemingly*, the most vital to the “*local*” Groups. They may be 100% loyal to America, but they are two or three percent more loyal to their “*communities*,” and will not abandon, or neglect, their community problems even for national problems . . . nor will they surrender their autonomy by merging with a national organization devoted entirely to the national problem, *vital as it is!*

In short, American "Groups" cannot be "united" to operate a la the Soviet (*so-called*) Republics, all slavishly obedient and taking their orders from a Politburo leadership. But they can be UNIFIED. They must not be asked to surrender their autonomy; they must retain their own Leaders; we must not infringe on community loyalties. The "unification" must be an *Alliance of Autonomous Groups—united* to fight our major national problems without abandoning their "community" independence and loyalties.

Right there, you may say, this is where we crash into a stone wall—on the theory that our individual community problems are so vastly different and far apart. For example: the man in Georgia, with whom Segregation is the most vital, may feel that to the man in Wisconsin, or in New York, it has no importance. *That is positively not true!* The objective of the ILLUMINATI-CFR and the One-World Conspiracy is to create strife and dissension (*bloody, as we know*). The Anti-Segregation plot was concocted for that very purpose. *Not only in the South, but all over the United States!* Because that desegregation scheme hits every community where there are Negroes—and *what community in the U.S. is completely free of them?* Thus, Segregation is not just a "South" problem—it is a *national problem*. If you doubt it, just look back at my description of the *violent* dissension it created in the Los Angeles Fire Department.

---

Now let me show you another phase of the "Segregation" problem—*under another name*: The ADL, the NAACP, and all other Negro organizations have been screaming and violently agitating for FEPC in every State in the Union. What is the objective of FEPC? To force all Industrialists, merchants, bankers, etc., etc., to "*cease job discrimination*" against Negroes, Mexicans, Jews and Orientals. Under FEPC, if a Department Store owner refuses to hire a Negro salesman or saleswoman, *regardless of fitness for the job*, he will face severe punishment—even a prison term; the same penalties would be suffered by a Christian who wouldn't employ a Jew, regardless of reasons, or the unfitness of the would-be employees. Under FEPC it would be very "*wise*" for employers to replace White Americans with "*Minority Group*" employees. And the White American would have no recourse—because can you imagine a White American making a discrimination charge stick?

What is *that*, if it isn't "Segregation" under another name—under even more vicious conditions?

Thus it is obvious that the "Anti-Segregation" problem is identically the same for the man in the North, the East and the West, as it is for the man in the South.

To stress that point, let me remind you that some years ago Moscow proclaimed that the U.S.A. would be divided into two nations—a White nation in the North and a Black nation in the South . . . *It was Moscow that mouthed that "Proclamation", but it was the Masterminds of the ILLUMINATI Conspiracy who "coined" it and placed it in Moscow's mouth!!!*

But it is even more important to fully understand that ALL of our internal and World problems are integral parts of the ILLUMINATI's Great Conspiracy to destroy our Free Nation. We blame "Communism" for the Racial upheavals in our Country—we blame "Communism" for the disunity of our people, for breaking us up into quarreling, squabbling, fighting factions—in short, we blame "Communism" for all the ills in our Land—and we have been made to fully believe that the Cancer of "Communism" was created in Russia—and brought into our Country by Russia. *That is not the truth!* The exact truth is that "Communism" was created in New York by Jacob Schiff and his International Banker Conspirators to serve as a camouflage (*bogey man*) for all their machinations to acquire control of the United States . . . *and to finally force the American people to surrender into their UN One World Dictatorship.*

Unfortunately, the vast mass of the American people have not yet become *fully* awakened to that stark fact. Nor, *even more unfortunately*, have the thousand and one local Patriotic Groups. They "see" only their own local phases of the problems—without realizing that they are splinters of the over-all problem. Moreover, there are many people who still refuse to believe that there *is* such an over-all Conspiracy as the ILLUMINATI. When told, they challenge you for PROOF.

Very well, there *is* proof, such concrete proof that even a school-boy couldn't challenge it . . . In our "News-Bulletin" (No. 110), entitled "OUR INVISIBLE GOVERNMENT MADE VISIBLE", published in February, 1965, we provided, *with DOCUMENTED proof*, the entire history of the ILLUMINATI, from the year it was founded (*in 1770*) *by one Adam Weishaupt, financed by the Rothschild clique of International Bankers!* That document reveals in minute details all the activities of the ILLUMINATI beginning with the French Revolution and the Napoleonic Wars, and including the Wars in the 19th Century, the two World Wars in this century, the Korean War, and the present war in Vietnam, and all the other brush-fire wars, all of which they fomented in order to destroy all Monarchies and legitimate People's Governments, *all Religion*, and to transform the whole world into a One-World Dictatorship under the enslaved control of the (*Rothschild*) International Bankers. If

you won't believe all the DOCUMENTED revelations in this (No. 110) "News-Bulletin," then you simply cannot believe that there is a God.

Now, let's come back to the main subject of this "News-Bulletin".

That over-all problem, the ILLUMINATI-CFR Conspiracy for the destruction of our Nation, will never be solved except by the unification into an "Alliance" of all the Patriotic Groups in America. And, strange though it may sound, the South, more than any other section of our Country could be the magnet to draw all true American "Groups" into a mass Alliance.

Not even a Joe McCarthy of today, or even a Douglas MacArthur, can do it alone. Neither can any individual "Group" do it—not even the rapidly growing "Groups" that are organizing to smash the evil SIECUS plot. None of the individual "Groups" has enough magnetic appeal to attract *all* of them . . . none of them has a "Holy Grail" symbol around which to rally the people. *But the South has!* The fight against "anti-Segregation" and "mongrelization" is a million horse power MAGNET for all the people in the South—and in the whole Country! Every "local" Group in the South will forget all "local" prides and jealousies and go into one "Alliance", such as I propose. And, fortunately, there already are in existence several organizations in the South that, combined, can easily become the core of such a National Alliance. One is known as the "Association of Citizen Councils of Mississippi". Headquartered in Winona, Mississippi, it was launched by Robert B. Patterson, a noted lawyer and fearlessly fighting American. At last reports it had a membership reaching toward 100,000 within that State alone, and is growing in leaps and bounds . . . In addition, since then, a similar organization come into being in Louisiana. It was organized by John U. Barr, a highly regarded American in that State. It is headquartered in New Orleans and is known as the "Federation For Constitutional Government". But what makes it even more important is that it promptly linked up and affiliated with "Citizens Councils" of Mississippi.

And that is not all—there are similar “Groups” already organized, or in the process of organizing, throughout the nation—all of them dedicated to the same objective: *to restore our Constitution as the Law of our Land.*

My prime reason for so strongly urging an “Alliance” of all those organizations is that practically none of them are interested in PARTY politics—they are interested first, last, and all the time, in the preservation of the American Way of Life handed down to us by our Founding Fathers. Thus, such an “Alliance” will be just as attractive to the unhappy so-called Republicans as it will be to the disillusioned and dissatisfied true Democrat. And, by that, I mean organized “Groups” as well as individuals in ALL parts of the Country.

## HOW HISTORY REPEATS ITSELF!

---

In 1945 a group of startled and concerned Americans gathered in the Washington office of Senator Vandenberg. We were shown Microfilms and Recordings of those infamous meetings at Yalta, at which Franklin Roosevelt, Alger Hiss, Harry Hopkins and the other despicable traitors, betrayed the Balkans, Poland, China and our own Country to Joe Stalin — those Microfilms and Recordings were secretly made by Stalin, to be used as a club over Roosevelt's head should he ever tried to renege on those "betrayal" agreements . . . at the same time we were told how "HOLLYWOOD" (the Film Industry) had collaborated with "MISSION TO MOSCOW," "SONG OF RUSSIA," and many other such Films, to brainwash the American people and the whole world about the GREAT CONSPIRACY . . . we were told how Senator Vandenberg had endeavored to get the Press, Radio and Hollywood to reveal the entire story of the Yalta betrayals — and how all the Media had flatly rejected his appeals . . . it was then that history repeated itself: With all due deep and humble reverence for our Founding Fathers, who met in 1776, to found our nation and "mutually pledged to each other their lives, their fortunes and their sacred honor," so did that group in Washington in 1945 "mutually pledge to each other their lives, their fortunes and their sacred honor" to save our Country from our Enemies within and without.

The first job in our "Declaration of Independence" was to expose the treason of our Mass Communications Media — but the most vital step in that "job" was to unmask the RED CONSPIRATORS in Hollywood, whose Films were aiding and abetting the GREAT CONSPIRACY on every Theatre Screen in America and in the World. That was a very difficult step. Both the FBI and the "House Committee On Un-American Activities" stated that there was an "IRON CURTAIN" all around Hollywood, and that they simply could not find the way to get enough documentary evidence to haul the Hollywood REDS in for a Congressional Investigation. Only someone on the "inside" in Hollywood could get that kind of evidence, they said. Well, my son, Bruce, and I were on the "inside," so that became our "pledge." We fulfilled that "pledge": within one year I provided both the FBI and the Congressional Committee with the names of 300 RED Stars, Directors, and Writers, together with documentary proof of their RED activities. That sensational "Hearing" of the Hollywood Reds followed in 1947, as you no doubt can recall.

I did even more than that: I wrote two plays, "RED RAINBOW" and "THIEVE'S PARADISE", in which I completely exposed the treason of our Press and Radio . . . Bruce and I did still more than that: we organized the "CINEMA EDUCATIONAL GUILD" (CEG), in order to continue to fulfill our PLEDGE to carry on the fight for the salvation of our Country. It was CEG that, in 1949, torpedoed that "UNITED WORLD FEDERALISTS" plot — it was

CEG that torpedoed the Eisenhower-Nixon plot to Repeal the "Connally Amendment", as also other various ILLUMINATI-CFR plottings.

When I undertook to unmask the Hollywood Red Conspiracy, I knew that I would face "blacklisting" by both Hollywood and Broadway. I knew that I would have to sacrifice my career — I knew that it would cost me my fortune, but I accepted all that, and fulfilled by pledge — and both my son, Bruce, and I are still fulfilling our PLEDGE.
