## A VERY VITAL PREAMBLE

---

There are some who will read this "News-Bulletin" who will unconsciously get an idea that my support of the "PETITION FOR REDRESS OF GRIEVANCES" by the courageous 27 Generals and Admirals, and my urging that the "COMMITTEE" shall continue as a functioning organization to enforce the requirements of the Provisions in the "PETITION," is some kind of a "MILITARY DICTATORSHIP" to overthrow the Government of our Country as prescribed by our CONSTITUTION . . . there will be others who, for their own diabolical reasons, will endeavor to make it appear that such a MILITARY DICTATORSHIP is the intent and purpose of the "PETITION" and of this Document.

All of that MUST be eradicated — the CONSTITUTION must once again become our SOLE GOVERNMENT — and that all the new men now elected into all those high offices must be held to straight and strict adherence to their official Constitutional oaths and duties. I sincerely hope and trust that all these new officials, in view of all of the unmaskings of the GREAT CONSPIRACY, will henceforth be loyal to their oaths and their duties to the American people. Some, I believe will. But, man being a strange animal, there may be some who will hope to be able to SECRETLY continue to "play ball" with the Conspirators.

In this "News-Bulletin" I urge that the courageous 27 Military Men who signed the "PETITION" shall continue to function as a "take-care of Government" Committee. ## THREATS OF REPRISALS

---

Within a matter of days, I might even say hours, after our preceding "News-Bulletin" ("TREASON WITHIN IS DESTROYING OUR NATION") was issued, Washington rang with anguished cries of rage and indignation. Those cries came from those I had NAMED as Traitors, and from many whom I had not NAMED, but who knew they were included in that category. "Liar" . . . *Distorter of truth* . . . "Rabble-rouser" were the mildest of the charges hurled against me. And from very reliable sources I was informed that some of those indignant "gentlemen (?)" had been putting their heads together to find ways and means to silence me, and to prevent any further revelations such as I described in that "News-Bulletin." They even gave thought to possible legal action to charge me with Libel, and even with SEDITION, on the ground that "false" accusations of treasonous deeds by men high in Government, such as Johnson, McNamara, Rusk, et al, could be construed as an effort, or plot, to overthrow the Government.

That threat of legal action, *via a Libel suit*, make me laugh long and loud. In such a suit the individual who claims to have been libelled would automatically become subject to *cross-examination under oath*. Can you imagine a McNamara, or a Rusk, or a Johnson taking such a chance?—*After what happened to Alger Hiss!!!!* If we need more concrete proof of that fact: Why didn't Johnson sue J. Evetts Haley for his charges of theft, crookedness, and even murder, in his book "A TEXAN LOOKS AT LYNDON?"

## THEIR ALIBIS

---

They admit that Franklin Roosevelt "*exceeded his authority*" in 1933 when, without the consent of the Senate, *without even discussing it with Congress*, he granted Official Recognition to the RED gang in the Kremlin, thereby opening our Country to an influx of Russian Spies and Saboteurs, but they call it a "*mistake*," not a deliberate crime—they admit that Roosevelt had no legal right to grant the Moscow gangsters that Eleven Billion Dollars in so-called "LEND-LEASE" phony deal even before we were hurled into World War II, but, *again*, they call it "*a mistake*"—they admit that the delivery of the Balkans and all of Eastern Europe to Stalin at that horrifying SECRET meeting at Yalta was lawless treason, but, *again*, they say it was just "*a mistake*"—they admit that the secret plotting to create a "UNITED NATIONS," which, *it is NOW so very obvious*, was for the purpose of destroying the sovereignty of the United States, was, to use their word, "*unconscious*" treason, but, *again*, they say it was just "*a mistake*"—they admit that it is horribly tragic that hundreds of thousands of our innocent young sons were, and still are being murdered and maimed in Korean and Viet Nam "*wars*" at the behest of the UN, but *again* they continue to insist that all those "*happenings*" were, and are, just "*mistakes*."

By "*they*" I mean, of course, the ILLUMINATI-CFR Conspirators, their controlled Mass Communications Media, and their controlled "*traitors*" in Washington!

Oh, they concede that many of those "*mistakes*" committed by Roosevelt, Truman, Eisenhower, Kennedy and Johnson, by the McNamaras and the Rusks, by Warren and the other Supreme Court Justices, and even by many CFR-controlled Members of Congress, might well be construed as malfeasance in office, and thus subject to impeachment, and while the impeached ones might be removed from office, that, they contend, would be the worst penalty that could be applied, because, *they keep insisting*, all those acts were "*innocent mistakes*"—and they challenge anybody and everybody to *prove* that any one of those "*mistakes*" was an overt act of treason.

Very well, I will now cite two cases (*of many*) deliberate acts of overt treason which not even an Abe Fortas would be foolish enough to try to defend:

---

## DELIVERY OF THE "A BOMB" TO MOSCOW

---

Shortly after World War II was launched, Washington set up quarters, first at Newark Airport, then at the big Air Base at Great Falls, Montana, where the Russians could pick up the various war material the U.S. was to provide Moscow under that illegal Eleven Billion Dollar "LEND LEASE" deal. The Commander of both those Military Exchange Establishments was Major George Racey Jordan, who later related all the treason committed at both Establishments, but particularly at Great Falls, when he appeared as a guest speaker on the late Fulton Lewis, Jr's Radio Broadcasts, and later repeated in his book "FROM MAJOR JORDAN'S DIARIES" . . . and in all of his revelations he bluntly charged that all the treason committed was *by direct orders from the White House!* His first startling revelation was as follows:

At the outset, Major Jordan worked wholeheartedly on behalf of the Russians because, like everyone else, he considered it his duty to do so—*the Russians were our allies, you know!* During 1942, '43 and '44 Jordan *officially* signed over to the Russians more than 16,000 planes. *All were military planes.* Then, in 1943, for some unknown reasons, at least unknown to Major Jordan, the Russians began to send their own transport planes to Great Falls, where they were loaded with mysterious cargoes consisting of huge containers, various kinds of crates, boxes, and other packages, the contents of which were concealed in heavy wrappings—and *none but the men in the Russian Mission at Great Falls were permitted to handle any of those cargoes!* All of that mystified Major Jordan—it also created suspicions in his mind. Now, at that time, the "*A-Bomb*" had not yet come into existence—that is, no information about it had been released to the public. Jordan had heard that some such weapon was being created, but he knew nothing more—he didn't know *how* it was being constructed, nor what *materials* were required for it—all he had heard was that just one such "*Bomb*" could easily destroy a city. He also knew that the secret of that Bomb had to be kept from all other nations, particularly any nation that *could* become a potential enemy of the U.S., and even though at the moment Russia was our "*ally*," Jordan had come to realize that Russia was our (*potential*) Enemy No. 1. And he wondered if all those containers and mysterious boxes and packages were in any way connected with the matter of that "*Bomb*." Anyway, he decided to board one of those transport planes, *just as it was ready to take off*, and personally investigate its contents. Anticipating possible objections by the Russian crew of the plane, or by Col. Kotikov, the head of the Russian

Mission quartered at Great Falls, Jordan briefed a number of his troops to "stand by." As Jordan approached the Russian plane, Col. Kotikov rushed over and *ordered* him not to try to board it—and to indicate his "authority" for that "order," he pointed to a squad of Russian soldiers who had hurried over to apply any necessary force to carry out the "order." Jordan promptly pointed to his own "on the ready" troops and told Kotikov that if he or his men would try to prevent his boarding the plane the American soldiers had been ordered to "mow them down"—and he asked Kotikov if he cared to create such an incident *on American soil*. Kotikov realized he was "on the spot." Furious, he turned, and rushed back to his quarters—and Jordan boarded the plane. And here is what he discovered: The huge containers were marked "HEAVY WATER"—the boxes contained URANIUM—the carefully wrapped packages contained maps, drawings and photographs, *thousands of them*, which obviously were the "blueprints" for the A BOMB, just as the "HEAVY WATER" and URANIUM obviously were ingredients for the *make-up* of the BOMB. Naturally, Major Jordan promptly impounded every Russian transport plane in the Field until he would complete his further investigations and could report his findings to his superiors in Washington . . . (Now, bear in mind that at that very time our "Leaders" in Washington were "predicting" that after we would perfect the BOMB it would be at least 20 years before any other nation would be able to pierce the secret) . . . yet here was the PROOF that those same "Leaders" were actually *deliberately* providing the Russians with all the "know-how" and the ingredients for it!!! . . . If there was any remote doubt that our top "Leaders" in Washington were the deliberate betrayers, the following should remove all that doubt: The moment Jordan boarded that plane, Kotikov, the Russian officer, dashed to his quarters and put in a call to a man named "Brown" in Washington, D.C.—*in the White House, no less*—and told him what had happened—he also told him what Jordan would find on that plane. "Brown" immediately rushed to Roosevelt's office with his story. Roosevelt promptly instructed the infamous Harry Hopkins to phone Jordan and order him to release all the Russian transport planes and allow them to leave for Moscow *with all their cargoes intact*. Hopkins phoned Jordan—and Jordan obeyed—he had to! *Do we need any further concrete proof that that was a deliberate OVERT deed of treason?* . . . But, as Al Jolson used to say, "wait, you ain't heard nothin' yet!" On one of the other Russian planes Jordan found thousands of copies of patents (and blueprints) of such things as the "Norden bombsight" and under carriage inventions for fighter planes, the existence of which were still unknown to the American people . . . but "you still ain't heard nothin' yet": on still other Russian planes, Jordan found Master (Money) Plates of the U. S. Treasury (23 Positive Plates and 23

Negative Plates), together with the necessary paper and ink and paraphernalia necessary to print all denominations of our money—which the Russians used to print many BILLIONS of our Dollars for their Occupation Army in Germany, and for any other purposes they desired! Those Master Plates were turned over to the Russians by Harry Dexter White, then Assistant Secretary of our Treasury—and it was done with the knowledge and approval of the Man in the White House! General Clay, later in command of our Army in Berlin, confirmed all that in a report to a Senate Committee. *Do we need any more concrete proof that all those are deliberate deeds of OVERT Treason—and not just "Mistakes"?* . . . Pierre Laval and Quisling were *executed* for lesser acts of treason!!!

Now, if all that about the actual delivery of the "A BOMB" to Russia by our own U. S. President isn't TREASON enough, here is a feature that would be utterly beyond belief had it not been revealed and confirmed by various White House staff members: "BROWN", the man whom the Russian officer (KOTIKOV) had contacted at the White House, was an alias employed by none other than Moscow's Molotov, for whom Roosevelt had assigned living quarters in the White House during his secret visits in Washington.

---

## TREASON DID NOT BEGIN WITH ROOSEVELT

---

Percentage-wise, very few Americans really know, or understand, the system by which we have been ruled for the last 50 years. They don't know that the old American Republic, now misnamed "Democracy, A Government of the people, by the people, for the people," set up for us by our Founding Fathers, has been dead through all of the last 50 years, and that during all these years we have been ruled by what can best be described as an "Invisible Government," officially known as the "COUNCIL ON FOREIGN RELATIONS" (CFR). The Hierarchy of this "Invisible Government" is composed of traitors who rule our nation from behind the scenes.

(Note:—In order to clarify what follows, and particularly to clarify what may sound like a harsh method to be proposed in this "News-Bulletin" that will have to be employed to wrest the destiny of our nation out of the grip of this Cabal of Traitors, I will have to repeat statements I included in other of our publications, one such "repeat" will be the identification of this "IN-

**VISIBLE GOVERNMENT"** . . . the reason for the "repeats" is that the memory of the people is very short, but, more important, that "memory" has at all times been confused and distorted by the propaganda practised by our CFR-controlled Mass Communications Media. MCF.)

---

In the early 1770's, one Adam Weishaupt, a Catholic Priest and a Professor of Canon Law in the University of Ingelstadt, defected and organized the "ILLUMINATI." The objective of this "ILLUMINATI" was the enslavement of the whole world in a "One-World Dictatorship." His collaborators (*and financial Angels*) in that plot were the then emerging "House of Rothschild" and other Money-Lenders of those years, now better known as "International Bankers."

Now, that One-World Dictatorship plot may sound utterly fantastic, but the idea of World Conquest is nothing new. History tells us of many men who sought total mastery of the world. Alexander the Great was, perhaps, the most famous of them. The Roman Caesars nearly achieved it. Genghis Kahn just barely fell short of it. Napoleon, too, had that ambition. But all those would-be world conquerors were warriors. They made no secret of their objectives—and they sought their conquests by force of arms. But the Masterminds of the "ILLUMINATI" were a different type of would-be Masters of the World. They employed the techniques of Machiavelli. First of all, they theorized that they would have to destroy all Monarchies and all *legitimate* peoples' governments—also all Religions, particularly Christianity, so as to destroy all spiritual principles. Ruthless, crafty, utterly unscrupulous, they hid behind phony ideologies. The Masterminds of the "ILLUMINATI," *from the outset*, remained hidden in a background of secrecy and mystery, all their plots and schemes carried out by Front-men and stooges. They employed *from the outset, and never deviated*, bribery and blackmail to seduce every type of official in high places. Their chief strategy, *always*, was to create strife, to promote anarchy nihilism, revolution. They set the masses against the classes—peasant against Landowner—workman against employer—the have-not against the haves. They *promised* the lands of the landowners to the peasants—the industries to the workers—the riches of the haves to the have-nots. Their chief weapons were confusion, fear, suspicion, threats of annihilation, etc., etc. . . . *exactly as they are doing today in America!* . . . What better proof of all that do we need than the Lyndon Johnson statement: "We are going to take all of the money from the haves and give it to the 'have nots'" . . . and what did they proclaim their objective to be?—the happiness and freedom of the human race—but, in particular, of the masses, the workers.

The "ILLUMINATI" reached their highest point in their Conspiracy with the French Revolution and the murderous "Reign of Terror" that followed. Of course, Robespierre, Murat and the other "leaders" of that bloody event were tools and stooges of the "ILLUMINATI" . . . *just as many of our "ELECTED LEADERS" since the turn of the century have been, AND STILL ARE, tools and stooges of the present (ILLUMINATI) Internationalist Conspiracy!*

The "ILLUMINATI" had intended to make the French Revolution serve as a pattern for similar Revolutions throughout all of Europe. But Napoleon threw a monkey wrench into their machinery. Although he (*Napoleon*) had started out as a "tool" of the "ILLUMINATI," he seized upon that Revolution as his own opportunity for *personal* world conquest. The Masterminds of the "ILLUMINATI" had not anticipated that—it, *temporarily*, stopped them dead in their tracks. Napoleon was a real military genius, perhaps the equal of Alexander the Great and Genghis Kahn. No one nation, not even Britain or Russia, could have stopped him. The "Masterminds" realized that they would have to hold all their plans in abeyance until they could create a coalition of nations to dispose of Napoleon. They assigned that job to the "House of Rothschild," then headed by Nathan Rothschild, headquartered in London. And, as we know, they were successful. But that disruption created havoc for the "ILLUMINATI"—it unmasked them—it made "ILLUMINATI" a "dirty word" throughout all Europe. But it did NOT mean the end of the GREAT CONSPIRACY—it merely forced the "ILLUMINATI" to go underground—it also forced them to change their over-all technique, to wit: In order to make the peoples of the world "forget" that there ever was an "ILLUMINATI" which had drenched all Europe with the blood of the French Revolution and the Napoleonic Wars, or, *at least*, to make the people believe that it no longer existed, they (*the Masterminds*) set up individual organizations under various names in every nation in the world—but, *of course*, all such organizations took all their directives from, and continued to work under the tight control of the same, *now underground*, Hierarchy of the "ILLUMINATI" . . . *here it is important to again remind that in the United States the "ILLUMINATI" operates under the name of "THE COUNCIL ON FOREIGN RELATIONS (CFR), which was "officially" organized immediately after World War One—more about that later.*

### BIRTH OF THE CONNSPIRACY IN THE U.S.

---

Earlier I stated that the "ILLUMINATI" set itself up "in business" in the U.S. immediately after World War One under the euphonious and highly American-sounding name of "COUNCIL ON FOREIGN RELATIONS." But let there be no delusion—even in its inception in the early 1770s, the ILLUMINATI had never overlooked the new world. George Washington revealed its existence and its designs on America in a statement he issued in the Salem (Mass.) Gazette, on December 25, 1798, in which he somberly warned the people of our then fledgeling nation against the "ILLUMINATES" in America, dedicated to secret world government. "If their art," said Washington, "can be applied to set aside the ordinary maxims of society and introduce policies of disobedience to government, while keeping its true aims secret, it must be obvious that such science and such societies may be perverted to all the ill purposes which have been suspected."

That statement by the highly revered Washington completely muzzled all the "Illuminates" in America for many years. Actually, the peace that followed the Napoleonic Wars likewise put what seemed like a quietus on the "Great Conspiracy." A "Conspiracy" can thrive only when the people of a nation, or nations, are in turmoil and opportunists, such as the "ILLUMINATI," can transform that turmoil into unhappiness and dissatisfaction with "governments." After the French Revolution and the Napoleonic Wars, the peoples in all Europe were so weary of wars, and so hungry for quiet and peace, that they avoided all bickerings and turmoil. Thus, the Conspirators (ILLUMINATI) were completely stymied. But,

again, let there be no delusion—the "ILLUMINATI" did not "go out of business"—they were very patient and merely bided their time, but quietly continued to agitate. And, as we know, in 1913 they deliberately created an incident (*the assassination of an Austrian Arch Duke*) which plunged the whole world into World War One, which they (ILLUMINATI) planned and hoped would result in a "League of Nations" One-World Government under their dictatorship . . . However, this issue is to be devoted to what is happening to our Country (*the U.S.*), so I won't devote any space to the overall world situation—all that is to be found in the ILLUMINATI-CFR CONSPIRACY RECORDINGS).

---

During the first half of the 19th century the "ILLUMINATI" were unable to infiltrate themselves into the affairs of our Country. But in the late 1840s they found their instrument for the creation of turmoil in our nation: *the Negro was that instrument!* They infiltrated a few of their agents (*so-called immigrants*) into our Northern States. Those agents, calling themselves "humanitarians," later to become known as "the Abolitionists," started an outcry against the "inhumanities" suffered by the "poor Negro slaves" at the hands of the White Southern people (*the Plantation owners*). Those "ILLUMINATI" agents were crafty. Gradually, they managed to inveigle many otherwise decent people in the North to join them in their phony "humanitarian" outcries. Naturally, the Southern people resented those outcries, and soon there was great acrimony and animosity between the people of the South and the people of the North—the very turmoil the ILLUMINATI conspirators required! At the height of that turmoil the ILLUMINATI sent one of their craftiest agents, one Judah Benjamin, a kin of the Rothschilds, into the South. This Benjamin wormed himself into the confidence of Jefferson Davis, Robert E. Lee and other Southern Leaders. And then he provided the finances to set up the Confederacy. The Civil War followed. The ILLUMINATI left nothing to chance. They infiltrated other agents into Abraham Lincoln's Cabinet, who endeavored to "sell" Lincoln into financial dealings with the "House of Rothschild" and thus get a grip on the North as well as the South. But old Abe saw through the scheme and bluntly rejected it. The rest is history. The victory of the North smashed the plans of the "ILLUMINATI." *Not that the "ILLUMINATI" gave up!* We know how they tried to use the "Reconstruction Period" to keep the South and the North divided—how their agents and bribed Federal Generals and Civil authorities sent into the South by the Federal government, tried to transform the South into a veritable Negro "Republic"—we know how that scheme was scuttled by the Southern

White people via the Ku Klux Klan, which today is so little understood by the American people. I won't go into all that, because our concern is with *the present*. The important point is that the ending of the Civil War destroyed the ILLUMINATI's plot to get control of the United States . . . *But, as I stated, they, the "ILLUMINATI" did not give up—they NEVER give up!!!*

---

## THEIR NEW PLOTTINGS

---

Shortly after the Civil War, a young immigrant, who called himself Jacob H. Schiff, arrived in New York . . . Jacob was a young man with a mission—for the House of Rothschild and the "ILLUMINATI."

I won't go into Schiff's background and the details of his activities in this country in the limited space of these few pages—it is all told in our "News-Bulletin, No. 110"—and even more fully described in the "ILLUMINATI-CFR CONSPIRACY" Recordings. I will merely cite his main objectives in America.

His objective No. 1 was to get absolute control of the entire Money System of the United States. He accomplished that, after many years of plotting, in which he was aided by renegades J. P. Morgan, the Biddles, the Drexels and the other "Money Kings" in America, just before Christmas Eve of 1913, when his two tools in the Senate, Carter Glass and Nelson Aldrich, and his White House tool, Woodrow Wilson, *illegally* enacted into Law the infamous "Federal Reserve Act." . . . The story of that horrifying act of TREASON is fully revealed in our "News-Bulletin" No. 134, entitled: "WHY CONGRESS MUST REPEAL THE FEDERAL RESERVE ACT!!!" . . . also, of course, in the "ILLUMINATI-CFR CONSPIRACY" Recordings.

Another of Schiff's major objectives was to get absolute control of our National Political Parties (*both Republican and Democrat*). That would enable the ILLUMINATI to plant their bribed stooges (*American renegades—the better word is TRAITORS*) in our White House, who, in turn, would plant other American TRAITORS in our State Department, our Defense Department, our Treasury Department, ALL Federal Agencies—also in our U.S. Supreme Court. But that objective could be accomplished only in one way—and that was by brainwashing and deluding the American people, *the voters*, to vote for their (the ILLUMINATI-CFR) chosen stooges. The

only way to brainwash the people was by achieving complete control of all of our Mass Communications Media. It was to achieve that latter objective that immediately after World War One, Schiff and his crafty agents, Col. Edward M. House, Bernard Baruch, the Lehmans, Warburgs and Rockefellers set up what they called "THE COUNCIL ON FOREIGN RELATIONS" (CFR), now commonly known as our "INVISIBLE GOVERNMENT." The Hierarchy of this CFR was composed of its founders named above, plus all the International Bankers in America, and all the Industrialists and professional men (*Lawyers*), Directors of Corporations and Tax Free Foundations, who were controlled by the Bankers. Immediately, they began to buy up all the important Newspapers and Magazines in our nation, including control of all our Wire Services, such as "Associated Press," "UPI" and even the Hearst Syndicate. And when Radio, and then TV, came into existence, the Internationalist Bankers, Goldman-Sachs, the Warburgs, et al, bought the control of all the Radio National Networks and the TV National Channels—they also achieved complete control of all the Motion Picture Lots in Hollywood and the various chains of Movie Theatres, which they use to brainwash the people, *especially the youth*, into every type of dissension—they also achieved complete control of practically all book publishing houses, *including those who publish the text books for our schools*; also virtually all book-sellers.

## SCHIFF'S CHIEF "JOB" IN THE U.S.

In the foregoing I have cited several of the Schiff machinations which enabled the ILLUMINATI-CFR to become the secret INVISIBLE GOVERNMENT of the United States. I have clearly established that this INVISIBLE GOVERNMENT controls both of the major political Parties. I have shown that during the past 50 years Presidential and other elections have been "fixed" and rigged. I have shown that this INVISIBLE GOVERNMENT (CFR) does not merely rule the political roost—that it also rules our economic life, our Mass Communications Media, our literature, even our educational system. I have shown that all those objectives were plotted way in advance. But the crafty ILLUMINATI Conspirators knew that even with all those objectives accomplished, it still would not mean complete conquest of the United States—they knew, and greatly feared, that somehow, in some way, a unified American PEOPLE would become awakened to what was being done to them and that a *revolt* could come about that would smash the entire plot. In short, they knew that to succeed they would have to find some *sure* way to destroy the *unity* of the American people. To prove my point, I will go to an incident I described in the "ILLUMINATI-CFR RECORDINGS": the incident was a meeting of the ILLUMINATI HIERARCHY in London, at which the matter of achieving control of the Money System of the U.S. was discussed—also, *naturally*, the matter of enslaving the U.S. within their One-World Dictatorship trap. It became clearly obvious that they realized that the great obstacle to the achievement of their objective was the unity of the American people. Disraeli, a kin of the Rothschilds, and at that time Prime Minister of Great Britain, came up with a "*brilliant idea*": they would use the Negro as the catalyst to create dissension, bitterness and hatred between the White people of the South and the people of the North and thus tear the nation apart. It was that "*idea*" that was the actual cause of our Civil War. When the Civil War failed to achieve their objective, the ILLUMINATI agents in the North (the so-called "*humanitarian*" Abolitionists) used the same catalyst (*the Negro*) to complete the job of destroying the unity of the American people during the "*Reconstruction Period*"—the whole story is told in the "ILLUMINATI-CFR Recordings. As we know, that "*Reconstruction Period*" plot was torpedoed by the Ku Klux Klan, as was revealed in the Thomas Dixon film "*The Birth of a Nation*."

Now, you would think that after that plot was torpedoed, just as Napoleon called it "*quits*" after the Battle of Waterloo, the Roths-

child-ILLUMINATI gang would have given up on that Disraeli "*brilliant idea*"—but they didn't. As I have frequently stated, *those Conspirators never quit!* They simply began to formulate a new plan of operation—and the same catalyst (*the Negro*) was again to be the core of that new plan of operation. Thus, when the Rothschilds emigrated Jacob Schiff into the United States, one of his chief assignments was to find ways and means to agitate and incite the Negroes (*and other Minority Groups*) to disrupt and destroy the unity of the American people. Following, is how Schiff and his aides went about it:

In 1909 Schiff engineered the organizing of the NAACP—the "*National Association for the Advancement of the Colored People*." The name of the "*Organization*" was supposed to indicate its "*humanitarian*" objective, and that, theorized Schiff, would be the "*magnet*" that would attract all the Negroes in America. But, in order to absolutely control all of the activities of that organization, every President of the NAACP, ever since its inception and to this very day, was a Jew—every Chief Legal Counsel of the NAACP, openly or under cover, was a Jew, appointed, of course, by Schiff. It may seem strange that through all the years the Negroes seemingly have not realized the anomaly of Jews being the official heads and directing forces of a (*supposedly*) purely Negro organization—well, the crafty Schiff counted (*correctly*) on the naivete of the Negro to overlook that anomaly.

Then, in 1913, Schiff ordered the creation of the "*Anti-Defamation League of the B'Nai B'Rith* (ADL). At this point it is necessary to stress that this ADL, by far the most dangerous of the two (*destroy the unity of the American people*) organizations, likewise was founded on a phony platform of "*humanitarianism*," to wit: during the two decades before 1913 millions of Jewish refugees, fleeing from the deliberately fomented (*by the Illuminati-House of Rothschild*) pogroms in Russia, Poland, Romania, etc., had poured into America. Throughout the ages, wherever they went the Jewish people have proven to be unassimilable. Without going into the reasons for it, that is a matter of record in Spain, in Russia, in Poland, in Germany, in all countries into which the Jewish people had ever immigrated. In short, the Jews always kept to themselves; their chief objectives were to accumulate and absorb wealth. As a result, the peoples of the host countries never developed any "*affection*" for Jews—never actually accepted them within their societies. That held true in America, too. The American people tolerated and were kind to them, but, because of their (*the Jews'*) peculiarities, preferred not to accept them within their society. The Jewish people were accustomed to such a condition and never actually fought against

it, as long as they were permitted to retain their own customs, their religion, and their above-mentioned pursuits of wealth accumulation—which the American people fully tolerated as long as they (*the Jews*) did not interfere with the American Way of Life. But that “*exclusion*” was seized upon by Schiff and his ILLUMINATI gang as “*a great Cause*,” which enabled them to use the Jews as an “*instrument*” to create dissensions that would heighten the discord necessary to destroy the unity of the American people. Thus, around the turn of the Century, the Schiff gang began to spread the myth of “*anti-semitism*” in America and how the American people were discriminating against the Jewish people. Soon they announced the creation of the ADL with the (*stated*) objective of creating harmony and amity between Jews and Christians. Had that been the *real* objective it would have been a laudable one, but, as we have learned during the past years, the ADL is the most vicious, the most unscrupulous, and the most dangerous Cabal in our Country. It was created to serve (*primarily*) two objectives:

No. 1: it was to be used to acquire absolute control of our Press (*then our only Mass Communications Media*). In the “*ILLUMINATI-CFR Recordings*,” I describe exactly how that was accomplished . . . No. 2: The NAACP had been organized to operate on a nation-wide scale. During its first three years, the Negroes, to whom the organizing job was assigned, floundered very badly—they needed advice and guidance—the ADL was to provide that advice and guidance, not only to the NAACP, but to the other Negro radical and rabble rousing organizations, such as the “*Urban League*,” “*Scope*” the Martin Lucifer King outfit, etc., etc. *And the ADL served in that capacity most successfully!!* Today it (ADL) blankets our entire Country; it maintains more than 2,000 “*agencies*” and employs more “*agents*” than the FBI. In short, the ADL has through the years been the chief instrument of the ILLUMINATI-CFR Conspiracy that has brought our nation to the very edge of destruction.

### HOW LONG, OH, LORD, HOW LONG?

---

Will the American people continue to be so terribly gullible until the Masterminds of the Great Conspiracy will finally complete the destruction of our nation with their Racial Upheaval plot?

In 1945, when we (CEG), *virtually single handedly*, unmasked the RED TREASON CONSPIRACY in Hollywood, we warned the

American people of the ultimate objectives of Schiff and his ILLUMINATI-CFR gang. But for every American we convinced there were thousands who refused to believe, until we brought about the Congressional investigation which identified and documented the more than 300 Hollywood Celebrities who actively participated in the plot. In 1949-50, when we forced the Legislatures of 26 States to rescind their *secret* approval of the UNITED WORLD FEDERALISTS “*Resolutions*” to *force* Congress to transform the U.S. into a unit of a “*Federated UN One-World Government*,” we again warned the people of that CFR plot. Again, in 1959, when Eisenhower tried to force the Senate to repeal the “*Connally Amendment*,” we warned the people. At the time of the Martin Lucifer King “*March On Selma*” we issued clear warnings that that “*Selma March*” was only the forerunner of similar “*Marches*” on Washington- D.C., of the riotings, lootings and murders in Watts, Newark, Harlem, Chicago, etc. etc., that would follow: we warned of the Racial Upheaval and “*Revolution*” to be launched by the Black Militants under the guidance and direction of White Leaders—and again we *stressed* that it had all been planned more than a half century ago by the Masterminds of the ILLUMINATI-CFR.

In order to leave nothing to imagination, even though we had published the following in previous “*News-Bulletins*,” I shall cite two incidents that occurred in 1910-12 which prove beyond the shadow of a doubt that the present racial upheavals, riotings, lootings and murders were planned, and all directives clearly outlined at that time:

1) In 1910, Israel Zangwill, an English Jewish playwright, wrote a play he titled: “*THE MELTING POT*.” It was produced on Broadway (*New York*) in 1910. Professionally, it was an excellent job of writing, direction and production. It was one of the big “*Hits*” of that year. But the important point is that the *theme* of the play was *the supposed persecution of Jews and Negroes by the White American Christian people!* But that theme was so completely camouflaged by the emotionalism in the play that nobody, not even I, with all my knowledge of theatre, had the slightest suspicion that the play was “*Racial Propaganda*.” I considered the theme “*bad taste*,” but I had no suspicion of its real objective.

2) In 1912, another English Jewish writer, named Israel Cohen, wrote a book which he titled: “*A RACIAL PROGRAM FOR THE 20th CENTURY*.” That amazingly brazen book contained all the “*directives*,” *with no attempts at camouflage*, for all of the Racial upheavals, riotings and murders that have been going on in our Country during the past 20 years. Shortly after traitor Earl Warren

issued his infamous "Desegregation DECISION" in 1954, we (CEG) revealed all those "Directives" in one of our "News-Bulletins" and in a "Tract," which called for the impeachment of Warren. That "News-Bulletin" and "Tract" brought avalanches of angry letters to all members of Congress—but no action followed, because by that time all copies of the "Israel Cohen" book had been ferreted out and destroyed—and our "charges" were proclaimed by various Communications Media and CFR-controlled officials in Washington to be *unofficial* and false "ravings" of a "rabble-rouser." But on June 7, 1957, Congressman Thomas G. Abernathy (*D. Mississippi*) inserted the following speech in the Congressional Record. His statement, anent the "Civil Rights Bill" of that year, follows:

"This civil rights business is all according to a studied and well-defined plan. It may be news to some of you, but the course of the advocates of this legislation was carefully planned and outlined more than 45 years ago. Israel Cohen, a leading Communist in England, in his 'A RACIAL PROGRAM FOR THE 20th CENTURY,' wrote in 1912, the following:

"We must realize that our Party's most powerful weapon is racial tension. By propounding into the consciousness of the dark races that for centuries they have been oppressed by the Whites, we can mould them to the program of the Communist Party. In America we will aim for subtle victory. While inflaming the Negro minority against the Whites, we will endeavor to instill in the Whites a guilt complex for their exploitation of the Negroes. We will aid the Negroes to rise to prominence in every walk of life, in the professions and in the world of sports and entertainment. With this prestige, the Negro will be able to intermarry with the Whites and begin a process which will deliver America to our cause."

Following his "quote" of the Cohen "directives," Mr. Abernathy said:

"What more accurate prophecy could there have been 45 years ago of what we now see taking place in America than that made by Israel Cohen? The plan was outlined to perfection and is being carried out by politicians who have fallen into the trap. Many thousands in America today who are in no sense Communists are helping to carry out the Communist plan laid down by their faithful thinker, Israel Cohen. Truly vigilance is the price of liberty."

The one point in Mr. Abernathy's statement with which I disagree is "the plan is being carried out by politicians who have fallen into the trap." There is incontrovertible proof that, in the main, all the politicians in all three Branches of our Government who are

"helping to carry out that (Cohen) plan" have not "fallen" into the trap, but have been seduced by various forms of bribery to support all the "directives" in the Cohen book.

However, the most important point about that Abernathy quote of the Cohen "directives" is that it was quoted directly from a copy of the Cohen book which he (*Abernathy*) had in his hand when he delivered his speech. Therefore, that "warning," published in the Congressional Record, was definitely OFFICIAL, and could not be brushed off as being the "false ravings of a rabble-rouser," as our (CEG) warning was brushed off. Drastic action by both Houses of Congress should have followed immediately; all Supreme Court Justices and heads of Federal Agencies who had *deliberately* aided the Racial upheavals should promptly have been hauled in for proper punishment, but, as we know, nothing of the sort was done. Instead, all of the "directives" in the Cohen book were carried out and zealously supported by Earl Warren and all our Courts. Mob action on a scale unprecedented in the history of the entire world has ravaged community after community in the entire country during the past 15 years. Watts, Chicago, Cleveland, Omaha, Philadelphia, Newark, Rochester, New York, Washington, D.C. and a hundred other cities have felt the lash of mass fury and rioting. And any of the victims who fought the looters and rapists were arrested and convicted as "criminals," whereas the rioters were punished by light fines, *which they did not have to pay*, or given light sentences, *which they did not have to serve!*

At this point, I wish to pause to stress the most important feature of all this lawlessness that is tearing our entire nation to shreds: throughout all of it our Press, TV and Radio reported that each outbreak in all of the more than 100 different communities was an *individual and spontaneous* outbreak by masses of hungry and desperately persecuted Negroes—that the outbreaks in Watts and Harlem and Newark, etc., etc., had no relationships whatsoever with similar outbreaks in other cities. "Oh, sure," they admitted, "Watts may have sparked the Harlem outbreak, Harlem may have sparked the Newark outbreak," etc., etc. "But," they insisted, "there was nothing conspiratorial about it." . . . In short, throughout all these years all of our Mass Communications Media have been deliberately lying to the people. All of the racial upheaval lawlessness is, and has been, *conspiratorial—directly in line with the "directives" in the Israel Cohen book, which Congressman Abernathy read into the Congressional Record in 1957!* There is a distinct pattern of the Conspiracy in the "uprisings" in every city. Each "uprising" was *deliberately planned* by the same "leaders." During the past ten years masses of concrete evidence of that fact have been submitted to

both Houses of Congress. It has been established, *and the Press, TV and Radio were unable to hush it up*, that the leaders of the rioting gangs in Harlem, Newark, Washington and other cities have always been highly paid employees of the Sargent Shriver "Anti-Poverty Program" and the CIA; that the Rap Browns, Carmichaels, Martin Lucifer Kings, et al, have been, *and are being*, financed by the Ford Foundation, Carnegie Foundation and other *CFR-Controlled* tax-exempt Foundations. It is also a proven fact that when the Racial upheavals were first launched the highly paid leaders found it difficult to incite the Negro masses into their lawless projects. *Why?* Because the average Negro in those years deathly feared Police. Well, the Master-minds of the CFR quickly found a "cure" for that: they had Warren issue a few "Decisions"—*and the Courts obeyed those "Decisions!"* It was in that way that the Police were *disarmed* and ordered to stand idly by while the thus emboldened Negroes and their leaders carried on their riotings, lootings and burnings. Similar "*disarm*" orders made the National Guard impotent. I am sure that everybody can still remember that incident in Washington, D.C., when many thousands of National Guardsmen, Marines and Policemen, *all disarmed*, stood idly by, *under orders to do so*, for 20 hours, while Negro mobs roamed all over the city, looting, robbing, burning, raping and murdering without interference. Proof of the "*orders*" to the National Guard and the Police to disarm and to permit the devastation of the city, came from General Archibald Sproul when he resigned his commission in the National Guard with a statement to the effect that he could no longer continue to contribute to the disorder and lawlessness *ordered* by the Traitors that command him—*at the same time he stated that the same kind of lawless orders applied to all the troops in the U.S.!*

I would require thousands of pages for a chronological review of the anarchy that has prevailed, and is prevailing, in every nook and cranny of our nation—of how our Press, TV and Radio, *particularly TV*, are aiding and abetting all that anarchy and the carrying out of all of the Israel Cohen "*directives*," but it would be a waste of space and reading time, because I am sure that every American is *by now* fully aware of all of it. It is more important that I come to the crux of this document—to show what we, *the people*, must do to restore law and order in our country.

During the past dozen years many great American patriots, such as Gen. del Valle, Gen. Stratemeyer, Gen. Wedemeyer, Arch Roberts, etc., etc., who had many times placed their lives on the line on fields of battle, expressed their outrage, and realizing that protests to the Eisenhowers, Kennedys and Johnsons and to the U.S. Supreme Court Justices would be of no avail, made appeal after

appeal to Congress to take the matter in hand. Realizing that the ILLUMINATI-CFR and their "UNITED NATIONS" was the hydra-headed monster that was behind all the anarchy in our Land, they kept demanding that Congress *get the U.S. out of the UN and the UN out of the U.S.*—and thus smash the entire plot.

A number of loyal Americans in both Houses of Congress have been desperately trying to respond to that appeal. James B. Utt, for one, has submitted such a BILL every year. Others, such as John Rarick and Strom Thurmond, have been doing likewise. But our Congress is loaded with men who have sold their birth-rights for ILLUMINATI-CFR pottage, and every UTT BILL, every Rarick Bill, every other loyal Congressmen's BILL continued to be *buried "in Committee"* by such traitors as Emanuel Celler and Jake Javits. Finally, early in this year of 1968, a group of those patriots, composed of Generals, Admirals, Colonels and Captains, some retired, some still in active service, got together and prepared what they called a "PETITION FOR REDRESS OF GRIEVANCES." It was sponsored and signed by 27 of our most famous military men and turned over to Congressman John R. Rarick for presentation to the Congress—*which was done on May 1, 1968.*

Assuming that by now everybody who will read this "*News-Bulletin*" has read our September "SPECIAL BULLETIN" in which we covered the entire matter, I will merely stress the important demands in the "*PETITION*," in order to, in turn, stress our suggestion for possible further action to *completely* safeguard our nation from the treachery and treason that has brought the U.S. to its present brink of complete destruction.

Now, as we know, ever since the U.N. came into existence, we have had all kinds of "*Wars*" in Eastern Asia, ranging from the Korean "*War*" to the one we now know as the Viet Nam "*War*." The objective of this Petition is to clear away all uncertainties about it. It succinctly calls *upon Congress* to clear away all that uncertainty by an outright declaration that we are *at war* with North Viet Nam; it requires that the Chief Executive (*the man in the White House*) shall surrender all control of our Armed Forces to the *militarily trained* Chiefs of Staff, not to a civilian like McNamara—and that our military commander in Viet Nam shall be given all necessary responsibility and authority for rapid and victorious conclusion of the present "*no win*" war; it further requires that the U.S. Government inform all nations concerned that we are *AT WAR* with Viet Nam, and warn them that any assistance in whatever form given to North Viet Nam will be considered an act of war against the U.S.A. The "*PETITION*" further requires that "*P.L. 87-297*," known

as *"The Arms Control and Disarmament Act"* be instantly repealed—also that every person in public office (*Federal Agencies, Congress, U.S. Supreme Court*) or military command whose loyalty to the United States and its Constitution is by their acts shown to be diluted by other *"loyalties"* inimical thereto, such as *"World Government,"* or so-called *"Limited World Government,"* shall be promptly cashiered or impeached, *as provided in our Constitution*—it further requires that each and every part of the entire *"PETITION"* shall be enacted into LAW so as to close every supply line to the Enemy and remove every restriction or sanctuary that will unnecessarily endanger one single American life . . . it (*the PETITION*) also demands that the (*treasonous*) policy of the U.S. State Department relaying our strategic and tactical plans for conduct of the war to all possible *"Enemies"* shall be stopped instantly!

That last *"demand,"* that the State Department (*and the Defense Department*) shall *immediately* cease relaying our strategic and tactical plans for conduct of the *"war"* in Viet Nam means far, far more than the mere words imply; to wit: we are fighting in Viet Nam at the behest and under control of *"Seato,"* of which the U.S. is a member, *"Seato"* is nothing more nor less than an *"Agency"* of the UNITED NATIONS. By that token, the U.S. Government (*State and Defense Departments*) must *"report"* to both *"Seato"* and the UN all of our activities and planned operations for the *"war"* in Viet Nam. Russia is a member of the U.N. Therefore, Russia automatically gets full information of every move we make or plan to make, in that *"war."* Russia is a brazenly open ally of North Viet Nam; without the military and financial aid of Russia, North Viet Nam would be unable to *"carry on"* this war—naturally, Russia *"relays"* to the North Vietnamese (*Viet Congs*) all the U.S. strategic plans McNamara and the State Department have through the years been *"relaying"* to *"Seato"* and the UN. In other words, *our own Defense Department, as also the State Department,* have been providing the Enemy with full information how, when and where to *slaughter our boys!*

It was under those same conditions that General Douglas MacArthur had to fight the *"war"* in Korea: MacArthur had to send reports of all his plans and operations to the U.S. Defense Department for approval. Under our *"Treaty,"* with the UN, the U.S. Defense Department was required to submit all of the MacArthur Reports and Plans to the Military Secretariat of the UN, together with their instructions. The chief of the UN Military Secretariat at that time was a Russian General, Vasiliev, who had taken a leave of absence to enable him to become the (*undercover*) Commander-in-Chief of the Red North Koreans and the Red Chinese. Naturally,

Vasiliev's assistant, acting as chief of the UN Secretariat, promptly forwarded the MacArthur Reports and the U.S. Defense Department's instructions to Vasiliev. So even before MacArthur received his approval from the U.S. Defense Department Vasiliev knew just when and where MacArthur would make his attacks—and thereby the No. Koreans (*Vasiliev*) knew just when and where to set their traps to slaughter our boys. Well, finally MacArthur realized the situation and launched his famous Inchon invasion without first *"advising"* the U.S. Defense Department about that planned invasion. It caught Vasiliev and the Red Enemy by surprise—and resulted in a disastrous defeat for them. But it also forced Truman, *by order of the UN,* to FIRE MacArthur. *Do you get the picture? . . . And that is how we, the U.S. have been fighting the Viet Nam War—that's why it has been a "no-win" war—and caused the slaughter and maiming of 150,000 of our boys!* Every President, Eisenhower, Kennedy and Johnson, also McNamara, Rusk, the UN and even our Congress, have been deliberately guilty of the murder of every one of our boys in Viet Nam.

Now do you realize how extremely vital that *"PETITION FOR REDRESS OF GRIEVANCES"* is?

In addition to the *"GRIEVANCES"* mentioned in the *"PETITION,"* there are other *GRIEVANCES,* not specifically named, that will have to be redressed, to wit: All relationships with the UN will have to be utterly repealed; the *FEDERAL RESERVE ACT* will have to be repealed, and our money system restored to our Congress; the 16th and 17th Amendments will have to be repealed; the CFR, the ADL, the NAACP and all the other Racial Upheaval organizations responsible for all the crime and disorder in our Land, will have to be thoroughly investigated and destroyed; all the Supreme Court *"DECISIONS"* that shield and protect all criminals, and had thus fomented all the racial upheavals, will have to be repealed, and the perpetrators (*Justices*) of those *DECISIONS* impeached and deprived of their powers; and all protection of Law and Order will have to be returned to a fully rearmed Police and National Guard.

Unquestionably, if all the requirements of the *"PETITION,"* named, and not specifically named, will be fulfilled and properly

carried out, it will go FAR toward the complete restoration of our Constitution and the "American Way of Life" that was set up for us by our Founding Fathers.

And with a new man in the White House and a reconstructed House of Representatives and Senate, such a change in the direction of our Government is fully possible. Because, with the "PETITION" in force, all the men in our Federal Government Agencies, including the President, Congress and the U.S. Supreme Court, will fully realize that the seldom-used, *but fatally dangerous*, Impeachment laws will hang over their heads like a, *metaphorically speaking*, guillotine.

But with all the above facts stressed, we have a big question before us; that question is: how long will all these new men in our Federal Government obey and observe the requirements of the PETITION? The answer is simple: *only as long as the people remain on guard to enforce the "Laws" in the "PETITION"*—but with our Mass Communications Media controlled by the Conspirators, it won't be long before "the people" will "forget," and the Politicians in the White House and the Federal Government, no matter who they are, no matter how "faithfully" they will have "promised" to carry out all the obligations of the "PETITION," will continue to respond to their real masters, the Internationalist Banker Masterminds of the ILLUMINATI-CFR Conspiracy, *as soon as they will feel it is safe to do so*. That is, as soon as the CFR-controlled Mass Communications Media will manage to make the people "forget" all about it, they, the men in our highest offices, will begin to find the "loopholes" in the "PETITION."

To leave nothing to imagination about the "forgetfulness" of the people and the tenacity of the Masterminds of the Great Conspiracy, I will cite several examples of that "forgetfulness":

1) In 1947, after two years of concentrated research, a group of loyal Americans in the Motion Picture Industry completely unmasked the Red Conspiracy in Hollywood to brainwash the American people. We acquired *documentary* proof of the pro-Communist activities by various of the Hollywood (Moguls) Producers and 300 top Stars, Writers and Directors. We turned it over to the FBI and the "House Committee on Un-American Activities." It resulted in an immediate Congressional Hearing in Washington. That Hearing created a nationwide sensation—the Press and Radio did not DARE to HUSH-HUSH it! Ten of the Conspirators, commonly known as the infamous HOLLYWOOD TEN, were sent to prison, and practically all of the 300 Celebrities were driven off the Screen.

*But Congress did NOT, as they should have, declare their Communist activities to be criminal treason!* And the Press went into deep silence after the "Hearing." The Reds waited two years—and then began to flock back into Hollywood. And the people "forgot" and began to flock back into the theatres showing their new *Treason* Films. Again, we (CEG) launched a campaign against the renewed Conspiracy in Hollywood. It resulted in another Congressional Hearing in 1952—and, once again, it resulted in a nationwide Press sensation—and, once again, it drove all the Reds out of Hollywood. But, as before, the CFR-controlled Communications Media again went into deep slumber, and as soon as the people again FORGOT, the Reds again came flocking back onto the Hollywood Lots. *And they have been here ever since, on the big Screens in the theatres and on the little Screens of your Television Set right in your Living Room, both spewing Communist propaganda, both encouraging, urging and furthering all the racial upheavals and riotings throughout the Land, both feeding filth, race-mixing and pornography into the easily impressionable minds of YOUR children!* . . . Now, you might well ask: why, after we had twice driven that phase of the Great Conspiracy out of Hollywood, hasn't it been kept off the Screens? Actually, there are three answers for that question: A) Despite efforts of several loyal American members, Congress, as a whole controlled by the CFR, never legislated that such acts are TREASON, *to be punished as such*; B) The CFR-controlled Press has constantly defended and shielded the perpetrators of that TREASON; C) And, *most importantly*, lacking LEGAL MACHINERY to smash this propaganda TREASON, we, the people, have never created a nationwide "Vigilante Committee" to punish the traitors in the only *sure-fire* way that we outlined in our News-Bulletin No. 125, entitled: "HOW TO GET THE REDS OUT OF ALL MASS COMMUNICATIONS MEDIA." That method, if adopted by enough Americans, would do the JOB, *beyond any doubt!!!*

Citation No. 2): At the very time (in 1947) that we brought about the first Congressional investigation of the Reds in Hollywood, and thus at least crippled that "instrument" for their "brainwashing" job, the Masterminds of the "One-World" Conspiracy set up what they called the "UNITED WORLD FEDERALISTS" (UWF). The job set for the UWF was to bribe and seduce our State Legislatures into SECRETLY passing "RESOLUTIONS" that would *force* Congress into transforming the U.S. into a unit of a "FEDERATED UN ONE-WORLD GOVERNMENT." By June 1949 the UWF had successfully seduced 26 States into passing their

"RESOLUTION." *All they needed was ten more States!* And it was all accomplished so secretly that nobody knew anything about the plot, except the Conspirators and the bribed Legislators—*because not one newspaper, not one Radio commentator mentioned one word about it!* But it was then that we (CEG) learned about it from the then California State Senator, Jack B. Tenney. We (CEG) promptly launched a campaign, via "Tracts" and "News-Bulletins," and personal appearances before the American Legion, VFW, DAR and every possible Civic Group, to alert the people of California to create a demand that the UWF "RESOLUTION" be subjected to an *open-to-the-Public* review by that Legislature. Despite every type of pressure, smears and threats, we accomplished our objective. That UWF RESOLUTION, *masterminded by Alan Cranston*, was reviewed in January 1950 and proclaimed to be a document of *Treason*—and the UWF was unmasked as a Cabal of TREASON. The California Legislature rescinded that RESOLUTION. *The Press was FORCED to report that review and the rescission!* The Legislatures of the other States that had passed similar UWF "RESOLUTIONS," frightened by the rage of the people created by those nationwide Press reports, promptly followed the example set by California, and rescinded *their* RESOLUTIONS . . . Naturally, that spelled the end of all UWF plottings—*for the time being!* !! One might well ask: why only "*for the time being*"? Various Legislatures, by their rescissions of the UWF RESOLUTIONS and declarations had established that the UWF was a Cabal of Treason. Congress and every State Legislature should have enacted Laws to deal with such obvious TREASON. Such legislation would automatically have forced a "review"—*and an end*—of the UN. *But neither Congress nor the Legislators enacted such laws!* Why? Because the CFR was still our INVISIBLE GOVERNMENT, and too many of our Congressmen and State Legislatures were taking their orders from that INVISIBLE GOVERNMENT—*and we, the people, had not organized a nationwide public organization to deal with that UWF TREASON!!!* As a result, the UWF is a full-fledged ONE-WORLD organization to this very day. True, they were so completely discredited in 1950 that it is to all intents and purposes a "dead" organization, but it still breathes, and occasionally tries to revive its activities.

Citation No. 3): Shortly after that UWF plot was unmasked and torpedoed, the UN, desperate for a new way to launch a "takeover" of the U.S., brazenly launched their AGGRESSI project, which we described in a series of "News-Bulletins" and "Tracts" in 1951. Briefly, the following was the objective of that UN AGGRESSI project: With the treasonous collaboration by the White House, the State Department and the Pentagon, the UN "borrowed" American troops,

dressed them in UN uniforms and placed them under UN appointed Commanders and under the UN (rag) Flag, and began a series of "invasions" into various *small* cities in California, Texas, New York State, etc. Those UN "invasion" Commandoes entered those various cities, "arrested" the Mayors, Chiefs of Police, all Civil authorities, took possession of the various City Halls and Police Stations, hauled down the U.S. Flags and replaced them with their own UN (rags) Flags, and proclaimed those "captured" cities to be "UN territory." The idea behind the scheme was simple—if it had worked; to wit: If the UN "invasions" had met with no resistance in the smaller cities, they, the UN, would have advanced their "invasions" into the larger cities, until, gradually, all of the U.S. would have become "UN territory," *occupied by American troops "loaned" to the UN by our own Federal Government . . .* It was a crazy, wild-eyed scheme, but, seemingly, there is nothing too crazy or too wild-eyed for the Conspirators—*especially if the American people can be kept unaware of the overall plot—and we were kept unaware of the "Aggressi plot,"* because not one newspaper, not one Radio, not one TV Commentator mentioned one word about those "invasions." But the most amazing feature of it all was the mesmeric grip that just those two words, "UNITED NATIONS," had on the intelligence of the American people! At that time the UN was a Holy of Holies—it just *could do no wrong!* Even more amazing, even today, *with the UN completely unmasked as it has become,* there still are many otherwise sane and intelligent Americans who feel that the UN must be "preserved"—that it is our only hope for PEACE; even among the *millions* of mothers, fathers, wives, sisters, brothers of the hundreds of thousands of our sons who were slaughtered and maimed in the UN Korean and Viet Nam "wars," there are many who are still so mesmerized by the UN PEACE propaganda that they still "worship" the UN. Thus, while the people in those small cities that were "invaded" by the UN in 1951 knew that something was wrong when they saw their Mayors and Police Chiefs hurled into jail cells—knew that something was VERY wrong when they saw the American Flag hauled down and replaced by the UN Rag—it puzzled and bewildered all those people—but it was the "wonderful UN" that was doing it—*and the UN could do no wrong.* That "UN Invasion Plot" was torpedoed by a sheer accident—*perhaps "an act of God" might be the better interpretation.* In one of those small cities there was one man who rejected the UN mesmerism: he saw the "invading forces" capture the City Hall of his town—he saw his Mayor being dragged off to jail—he saw the American Flag hauled down. That was too much for him! He hurried home and called together all his friends and neighbors. They armed themselves with rifles, shotguns, revolvers, etc. Then they descended upon their City Hall and ordered the Commander of the UN "invasion force" to sur-

render and "clear out—or else!" The UN Commander didn't stop to argue with that group of outraged Americans—he knew that if he would try to resist, it would result in the same kind of battle that took place at Lexington in 1776—that it would be "the shot that would be heard around the world"—that it would suddenly alert and arouse all of the American people. That UN Commander promptly hauled down his UN Rag—and the "invasion" was over. And the UN promptly ordered all of its "invasion" forces to vacate their "captured" cities. And that was the end of that entire AGGRESSI plot. However, the story of those "invasions" did leak out—the Press did not DARE to ignore it. When our then President, the pusillanimous Harry Truman, was asked to explain how American soldiers in UN uniforms had dared to "invade" American cities he said he knew nothing about it. *Of course, he deliberately lied!* The Secretary of Defense (the Pentagon) said he knew nothing about it—*of course, he deliberately lied!* When the question was put up to the UN, that outfit blandly stated that the whole thing had merely been "a dress rehearsal." A "dress rehearsal" for what, they were asked. The UN simply said: "No comment." . . . I will pause to STRESS a very important point for all of the American people:

Those UN "invasions" of our cities were acts of war exactly the same as Napoleon's invasion of Russia, the same as Hitler's invasion of Poland, the same as the recent invasion of Czechoslovakia by Russia, yet our Congress did not haul in the UN, or "review" the UN Charter for the authority for those "invasions"—the Legislatures of the various "invaded" States did not take any actions against the UN. Furthermore, the Man in the White House, the Secretary of State, and the Secretary of Defense, all of whom had *deliberately "loaned"* our soldiers to the UN for those "invasions," were just as guilty of HIGH TREASON as Benedict Arnold, Quisling or Laval, yet Congress did not haul any of them in for impeachment and trial for their crimes, the penalty for which should have been death. WHY? Because, except for one day of Press flurry about those "invasions," all our Mass Communications Media were ordered to go into deep silence about the entire incident—the American people, while momentarily enraged, were quickly brainwashed into "forgetting" all about the matter—and the UN has been permitted ever since then to continue their plottings to suck the U.S. and the American people into their ILLUMINATI-CFR One-World Trap . . . NOW do you realize why the "PETITION FOR REDRESS OF GRIEVANCES" is so vital for the salvation of our Country? . . . WHY EVEN THE MORE DRASTIC ACTION I WILL LATER SUGGEST IS ABSOLUTELY NECESSARY, IF WE ARE TO SAVE OUR COUNTRY!!!

I could cite many more cases of *deliberately* attempted TREASON by the men in high offices to whom we have entrusted the safety and security of our CONSTITUTION and our Country: for one example, there are the Warren and other U. S. Supreme Court DECISIONS which they based "on the principles of the UN Charter," thus *virtually destroying our Constitution*—there was Eisenhower's CFR-UN plot to repeal the "Connally Amendment," which would have placed the U.S. and the American people under the UN's One-World Court and deprived us of the safeguards in our Constitution—there was that State Department's "P.L. 87-297 Arms Control and Disarmament Act," also that "DOCUMENT 7277," which would have transferred all of our Military forces and Armaments to the UN—there was President "Saint" Jack Kennedy's 1961 secret agreement with the UN, which would have transformed the U.S. into a unit of a UN One-World Government . . . and *throughout all those acts, our Congress sat idly by and virtually confirmed all those plottings*—and, by no means least, there are those "EXECUTIVE ORDERS," which I described in previous "News-Bulletins," and which, by a stroke of a pen, can give the CFR-CONTROLLED Man in the White House the power of life and death over every man, woman and child in our Country . . . Do I have to say anything more about the vital need for all the requirements in the "PETITION FOR REDRESS OF GRIEVANCES"? Yes, I do have more to say:

Earlier I stated that if all the requirements of the "PETITION" will be fully and properly carried out, it will go far toward the complete restoration of our Constitution and our American Way of Life. I also stated that with a new man in the White House and a reconstructed Congress such a change in the direction of our Government is fully possible—simply because *with the "PETITION" in force* all those men in the high offices will *know the penalties* for further acts of treason. And then I posed the great question: "how long will all these new men in our Federal Government obey and observe the requirements of the "PETITION"?" And I answered it with: "As long as the people will remain on guard to enforce it!" Then, bearing in mind that our CFR-controlled Mass Communications Media will use all their powers to make the people "forget" to remain "on guard," I discussed that phase with several of the brave Generals who so courageously signed that "PETITION." I pointed out to them that even with the "PETITION" in full force and effect, it would still be up to Congress to carry out and fulfill its requirement, and, knowing Congress as we do, we know how they will stall and stall and stall, *at the behest of their CFR-masters,* and thus *virtually nullify the entire "PETITION"*—and I stressed



that the very Military men who gave "birth" to the "PETITION" should be provided with greater powers to carry out all the requirements in the PETITION without waiting for action by Congress. The kind of "powers" I suggested will, *off-hand*, startle you and all the American people, as, indeed it startled the very Generals to whom I broached it; yet it is of the utmost great need—if we are to *save our Country!*

Before I set down my "suggestion," let me qualify it with a few words about the men for whom I suggest those very broad powers: Most of the men who signed that PETITION are Generals and Admirals who are now in their middle and late Seventies. All have been in "retired" status for many years. All of them have *many times* laid their lives "on the line" on battle fields in the service of our Country. To show you how "willing" they are: last April, when word leaked out that they were organizing their "Committee" for that PETITION, the startled and alarmed Masterminds of the ILLUMINATI-CFR had their stooges in the Pentagon and in the White House warn some of the leading retired Generals that, *regardless of age*, they *could* be recalled into "active service," have their retirement pensions revoked, and then actually be "court-martialed" on one pretext or another. The retort of those wonderful old men (*Generals and Admirals*) to that threat was, in so many words, exactly the same defiance the immortal Patrick Henry hurled at those who warned him that his famous "Give me Liberty, or give me death" speech might be construed as TREASON—and they went right ahead with the formation of their "Committee" and their "PETITION." *That's the kind of men they are! That's the kind of AMERICANS to whom I suggest that we entrust the security of our nation . . .* and I urgently plead that all loyal Americans join me in the following appeal to those 27 wonderful signers of the PETITION; to wit:

No matter how *seemingly wholeheartedly* the "PETITION" will have been enacted . . . no matter how *seemingly sincerely* Congress will promise to fulfill and carry out all the requirements of the "PETITION," please, *all of you American people*, join me in an appeal to those 27 men not to feel that their job has been completed. During the past nearly two centuries we have placed and kept our faith in our Congress—but during the past 50 years our Congress has been failing us. For that reason that "Committee" must be kept intact and always ready to function. Furthermore, the present members of the "Committee" should invite and urge all other retired Military Generals and Admirals to join the "Committee"—invite and urge other Military men still in active service to join the "Committee"—also invite and urge the National and State Com-

manders of the American Legion, the VFW and other Veterans' Organizations to join the "Committee." I am sure that hundreds will join—*some of the original 27 agree with me on all of the above points.*

But before I go further into that suggestion I wish to say a few words of clarification that will serve to allay all alarms, all fears, all doubts from the minds of those who will read the suggestion: our Founding Fathers fought the Revolutionary War in 1776 to free us of all of the Old World Dictatorships, whether those of Royalty or Military. Ever since the inception of our Constitution the American people had a "Freedom and Liberty" Way of Life. We have always abhorred the idea of "Dictatorships." Ours has been a Government of the People, by the people, for the people. So, don't let the following mislead, or bemuse, or alarm you. What we, men such as Gen. Stratemeyer, Gen. del Valle, Congressman John Rarich, etc., want is still a Government of the People, by the people, for the people, under whatever name or form it may be necessary to insure that kind of Government. Most of us are nearing the end of our time on Earth—we have no personal axes to grind. All we want to do is preserve the Freedom and Liberty-loving nation that God and our Founding Fathers gave us. So I hope and pray that every American who will read this document will fully accept the spirit and the intent of it.

Now then, change the name of this "Committee." It should become a "MILITARY TAKE-CARE OF GOVERNMENT COMMITTEE." And to clarify what I mean, permit me to make this statement: Many very astute persons, including many of the original signers of the original "PETITION," share the opinion that conditions in our Country have reached such a state that only a military coup d'etat can save this nation, perhaps the entire Christian world, from the chaos planned for us by the ILLUMINATI-CFR.

A) The "how" it is to be done is quite simple to state: The Chairman of the Joint Chiefs (JCS) after a *confidential* session with the other Chiefs, including the Commandant of the U.S. Marine Corps, but excluding all their aides and staffs, must make the decision. There is no other person in position to do so.

B) The decision to take charge having been made, the following steps must be taken to implement the decision: . . . Place the follow-

ing under "protective" custody by the Armed Forces; The President, Vice President, Secretary of Defense, Secretary of State, the Chief Justice of the Supreme Court and Justices Douglas, Fortras and other Justices with pro-Communist voting records. In addition, take into the same kind of "custody" certain powerful individuals, such as Sidney Weinberg, the Rostow brothers, Katzenbach, Yarmolinski, Shelton and Wilbur Cohen, McChesney Martin (*Chairman of the Federal Reserve Corporation Board*), all the heads of the CFR, the ADL, the NAACP, URBAN League, etc., etc. And J. Edgar Hoover and Otto Otepka shall be required to furnish other important names from their lists of Security Risks. That "Protective Custody" will serve in two ways: 1) It will prevent the assassinations of Presidents and other figures of Government—2) More important, it will prevent deeds of treason such as were perpetrated by Franklin Roosevelt, Truman, Eisenhower, Kennedy and Johnson—it will prevent the destruction of our Armaments and Defenses such as was perpetrated by McNamara—it will prevent treason such as were perpetrated by the Dulleses and the Rusks—it will forever do away with all of the "Executive Orders" of the President of the United States; *he will function as a SERVANT of the American people, not as our MASTER*—exactly as our Constitution clearly stipulates!

C) The Senate and House Leaders of both Parties will be "invited" to consult with the Joint Chiefs. They will be "requested" to exercise their constitutional duties, such as: Repeal the Federal Reserve Act; the UNITED NATIONS so-called Treaty; all Federal and Foreign Aid Legislation and Appropriations; Public Law 87-297 (*The U.S. Arms Control and Disarmament Act*); also all so-called Civil Rights Acts and all Supreme Court "Decisions based on the United Nations Charter and Resolutions."

D) The Mass Communications Media "Lords" will be summoned: i.e., head of TV and Radio Networks, A.P., U.P., and International Press Ass'n., and given ORDERS to publish immediately the Proclamation of the Restoration of Constitutional Government, Law and Order! This will tell the American People all about all the foregoing Acts and Orders of the J.C.S. Make them, the Mass Communications Media, keep repeating it, and nothing else, until the J.C.S. are assured that the people are fully informed of what has been done—and why, and asking their support and cooperation in the sole purpose of the J.C.S. to restore Constitutional Government without stalling and delay!

E) The Governors of all the States shall be "requested" to "consult" with the J.C.S. and cooperate in this restoration by every avail-

able means . . . here is the reason for that statement: Major Arch Roberts has been working for years, trying to get various State Legislatures to investigate the UN and get their States to declare the illegality of the "Treaty" and declare it unconstitutional and therefore null and void in their various jurisdictions. He is still trying, but thus far progress has been nil, despite his brilliant writings and other valiant efforts.

Thus, actually, the situation in our Country today is this: The State Governors and Legislatures are doing nothing. The Federal Agencies of our Government have only such lawful powers as the States confer upon them in the Constitution. Since these Agencies have adopted the UN Charter instead of the Constitution (*See Decision of the California Supreme Court that the "Charter" is the Law of the Land*), and since the "Charter" confers no powers to our Federal Agencies of Government, the U.S. is presently ruled by an unlawful *but de facto* government in usurpation of the Constitution! And that puts us right back where the 13 original States were when they tried to form a Union. They first tried and failed with the Articles of Confederation. Then they wrote the Constitution which was (and still is) the cement that bound them into the United States of America. But, the Federal Agencies of Government, having rejected the Constitution, *we now have no real Union!* The "Joint Chiefs" can use this *factual condition of our Country today* to explain their actions to the American people—they can FORCE the Mass Communications Media to completely clarify that factual condition to the people. That clarification to the people is vitally necessary for one prime reason: There is absolutely no doubt that the Joint Chiefs will be supported by the Armed Forces at their command—but they need and, above all, *want* the approval and support of all of the American people. This would give them the essentials for a successful "take-over" of our government—by which I mean: a "take-over" from the present "dictatorship" of the CFR-UNITED NATIONS. I repeat: it would give them the Armed Forces at their command—and it would give them the support of the completely alerted American people.

### WHY TURN TO THE MILITARY?

---

Now, I know that some people who will read this document, and who will agree that some changes must be made and great actions taken to regain the control of our nation, who will say: "*But why*

turn to the Military" for such changes and action? They will point to the fact that we still have loyal men in our Government, such as the John Raricks, the Strom Thurmonds, the Jim Utts and others whom we can trust. That is true, but all such men have tried and tried to effect such changes. They have failed—the Masters of the ILLUMINATI-CFR Conspiracy are too powerful for them. The time has come to use FORCE to effect the changes and actions we must have for the salvation of our Country. The Raricks, Thurmonds, Utts, etc., do not have the "know-how" to effect such actions. Today we are fighting a frightful war—a Revolution—for the salvation of our Country. The Joint Chiefs are militarily trained people. They have the "know-how" to fight such a "war." They have the "know-how" to create a General Plan of Action, prepared in all details to cover the means and methods to carry out a plan for a bloodless "take-over" of the destiny of our nation.

Now, I realize that that very "take-over" expression will frighten some of our non-thinking people—some will even scream: "This means a Military Dictatorship." Well, for those, I have just one question: *What kind of Government are we living under today?* In our "News-Bulletin, No. 133" entitled: "UN IS U.S. CANCER" I have fully described how the UN has become the REAL Government of the U.S., ruling us through the traitors we have been electing into the high offices in Washington. *In short, today we are under the DICTATORSHIP of the ILLUMINATI'S "UNITED NATIONS."* Do YOU prefer to surrender our Country to the ILLUMINATI UN Dictatorship, or to a "Dictatorship," *if that's what you want to call it, of true and loyal Americans* such as del Valle, Stratemeyer, Willoughby, Arch Roberts, etc., etc., who have been devoting their lives to preserving a Free CONSTITUTIONAL America?

And just to stress that question, let me make another point: Ever since the UN was foisted upon us, the CFR traitors have been making desperate efforts to enact "Gun Laws" that would deprive all of the American people of their one sure way of protecting our nation and themselves. *Why?* Do you realize what would have happened to our Country in 1951, when the UN was pulling its AGGRESSIVE "Invasions" plot, if those men in California had been deprived of their guns, which they used to torpedo that UN "Invasions" plot?

In conclusion, I have just one thing to add: The plan outlined in this "BULLETIN," which I have discussed with some of the

men I have named, is our only hope for the salvation of our Country and of our Constitution. Those 27 courageous Military men made a great start with their "PETITION." YOU, *all of us Americans*, must do everything in our power to help them carry out this plan to the LETTER. This Plan will bind down with the chains of the Constitution the President, the Congress, all Federal Agencies, the U.S. Supreme Court, all Governors, all Legislatures. It will bring to an end all the treason, all the Racial upheavals, all the riotings, all the disorder in our Land. It will RESTORE our Country to the American people. For the love of God and Country, *and for your children*, let's all get together! Get a copy of this BULLETIN into the hands of all your friends and neighbors.
