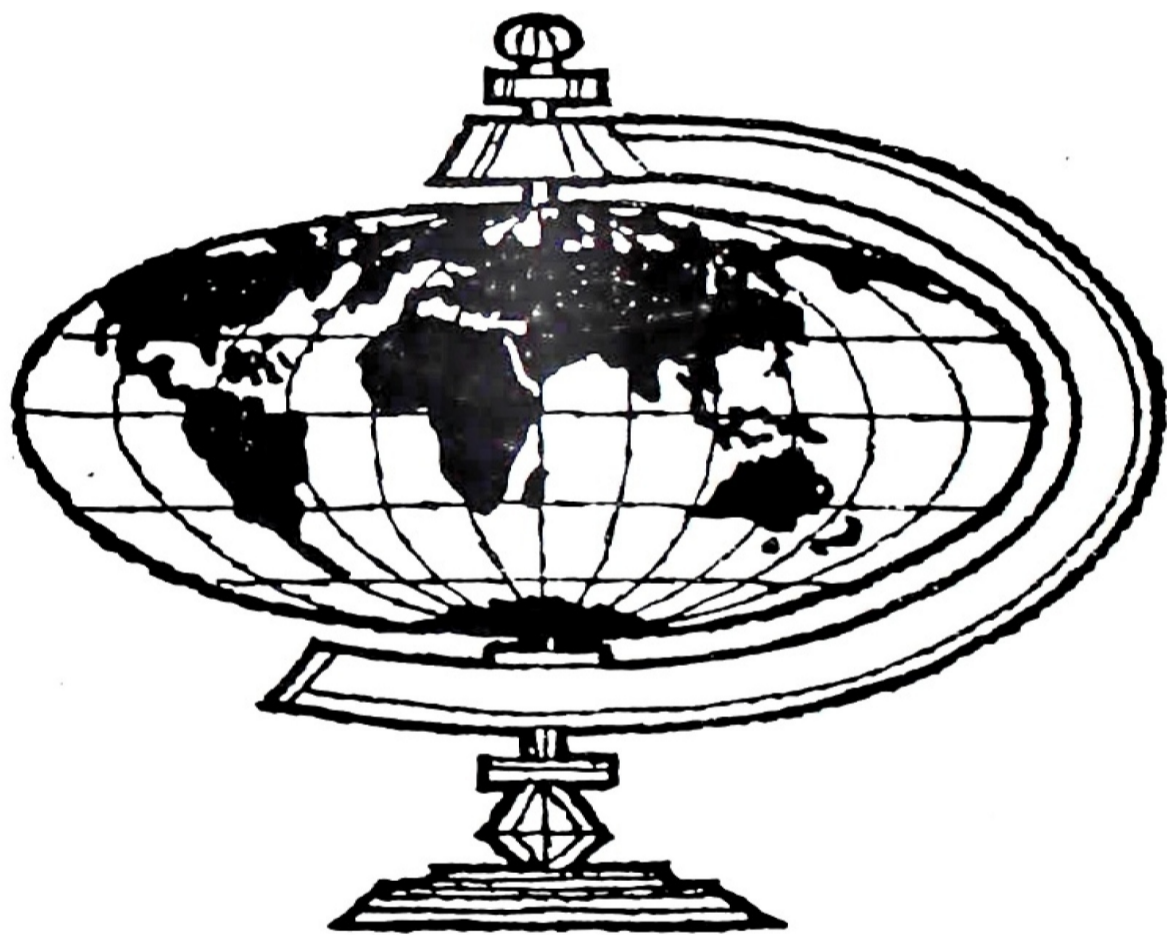

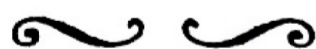

JOE STALIN IN SACRAMENTO!

On Monday, June 27, in Sacramento, I ran headlong into a scheme that out Machiavellis Machiavelli, and which is beyond any question or doubt inspired and oriented by Moscow! It is so subtle, so crafty, yet so diabolically ingenious, that if it succeeds it will "take over" America without a shot being fired, without a protest being heard, *without any choice being given to the AMERICAN PEOPLE!*

It will be absolute UNCONDITIONAL SURRENDER TO Moscow!!!

A NEW SET OF WHISKERS!

This nefarious scheme is camouflaged by the phoney, but very appealing promise of eternal world PEACE — *the Shostakovich Treason Train was camouflaged with that magic word!* This *new* scheme, hatched in the State of California, if you please, and dubbed the "California Plan," calls for a "ONE WORLD FEDERAL GOVERNMENT" in which our United States of America would become merely a unit with just about as much importance and potency in the world of nations as tiny Finland has today in Europe's family of nations.

If that scheme goes through . . . *dear God forbid . . .* we would have to give up our Navy and our Army, retaining just enough to *police* our territory — *in exactly the same proportions as a State Police Department.*

We would have to surrender our Atom Bomb . . . *which is the ONE thing they are after.*

Our Stars and Stripes would become a *State Flag . . .* and an International Flag would be hoisted above it — *and I guarantee you there would be a Sickle and a Hammer in that International Flag!!!*

Our National Anthem would be replaced by an *International Anthem . . . very likely composed by Comrade Shostakovich!!!* We would become merely 149 million votes . . . *a 7 percent minority* — in a world body of TWO BILLION voters . . . *if there would be a vote at all!!!*

This super-Machiavellan scheme was concocted . . . *and RAILROADED through the California Legislature . . .* by a gang of would-be America-Wreckers who call themselves the "United World Federalists."

Before I am through I shall *prove* that this "United World Federalists" was founded and created, and . . . *behind a facade of so-called respectable names . . .* is being directed by a gang of known Reds and Pinks! And, if our great American Watch-dog (I use that word with all sincerity, affection, and with great respect), J. Edgar Hoover, will dig deep enough and snatch the false whiskers off "United World Federalists" we will see revealed the saturnine face of Joe Stalin!!!

SHALL WE DIE IN OUR SLEEP?

I became aware of the existence . . . *and the vicious objective . . .* of "United World Federalists" in February 1947 when a motley crew of so-called Americans assembled in Asheville, North Carolina, for the brazenly avowed purpose of *canceling out* our CONSTITUTION and *outlawing* our DECLARATION OF INDEPENDENCE. However, I had at that time already dedicated myself to the chore of awakening America to the Red menace in Hollywood . . . *which I assure you is a full time job . . .* and I gave the UWF only a passing thought. I *assumed* that the very audacity of their attempted treason would quickly bring their destruction by other good and alert Americans. But — apparently — there are one hundred and forty-eight million and nine hundred thousand of our 149 million Americans still soundly asleep at the switch. This fact was brought home to me by an Editorial by E. F. Tompkins in the Los Angeles Examiner on Sunday, April 10, 1949 . . . which, while it practically repeats what I have already told, is worth repeating. It reads, in part, as follows:

"SHOULD WE ABANDON OUR FREEDOM?"

"Hardly observed by the vast silent majority of the American people, a spreading and seductive movement is progressing across the country TO REPEAL THE DECLARATION and

TO NULLIFY THE CONSTITUTION OF THE UNITED STATES.

"The *undeclared* objective is to be accomplished by establishing a form of world government based upon the existing organization of the United Nations . . . If the enterprise succeeds, this country would be required to abrogate . . . its national sovereignty.

"Eventually, we would . . . be compelled to MERGE OUR CITIZENSHIP WITH ALIEN AND DISTANT RACES, who do not share our language, our customs, our principles of law, our traditions of individual liberty or our ancestral experience in the arts and qualifications of democracy.



"Obscure in its origin, the movement was initiated some years ago by Robert Lee Humber, a lawyer of Greenville, North Carolina, who formulated a proposal, for submission to State Legislatures, to '*declare that all the people of the earth should be united in a world federation.*'

"Since the formation of the United Nations, the movement has been carried *further* by new organizations . . .

"One of the most active groups is the United World Federalists, Inc., headed by Cord Meyer Jr., which has a '*global*' prospectus . . .

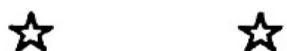


"Another group is Federal Union, Inc., which as a beginning would recombine the United States into the obsolete British Empire.

"Still another group would start with an '*Atlantic Union*' and progressively include all of Europe, the Americas, Asia, Africa and Australasia . . .

"*Then there is the 'American Association of the United Nations,' of which former Undersecretary of State Sumner Welles is honorary president.*

* NOTE:—We exposed the American Association for the United Nations in our April-May News-Bulletin and again in the June issue.



"Since the movement was instituted by Mr. Humber — way back yonder and way down in Dixie — the Legislatures of SEVENTEEN STATES have been deluded into adopting formal resolutions favoring '*limited world government*' — which is the basic idea. . .

"But developing this *basic idea* further, the United World Federalists, Inc., has devised a new '*model*' resolution for the Legislatures DIRECTLY SEEKING A CHANGE IN OUR FEDERAL CONSTITUTION and calling upon Congress to summon a *national constitutional convention for the purpose*.

"Furthermore, the United World Federalists has established local propaganda chapters in 600 communities and colleges; has won the support of the pretentious American Academy of Political and Social Science; and has under way a \$500,000 '*expansion campaign*' to '*transform the United Nations into a limited world government.*'

☆ ☆

"*The danger . . . is growing imminent.*

"*The Legislatures of 36 states can compel Congress to call a constitutional convention for that purpose; and nearly half of the requisite number of states have already sanctioned, in effect, this procedure which would ultimately result in their own political extinction.*

"The old and defunct League of Nations was an attempt at '*limited world government*' which started in the travails of one global war and expired in the bloodshed and anarchy of another.

"The existing United Nations, with its 200 or more commissions and councils, is developing into A SCHEME OF WORLD SOCIALISM, sustained chiefly by American taxpayers and providing notably a sheltered haven for foreign espionage and intrigue in this country.

☆ ☆

"Experience thus proves that a '*limited*' system of world government must either dissolve itself in disappointing futility or else become UNLIMITED government over *all* the diverse peoples of the earth.

"Under such a system —

"The American people would no longer be permitted to write their own tariffs or immigration laws; or to regulate their own banking and currency practices: for the free movement of goods and persons across national boundaries is an essential idea of world government: international monetary controls have already been set up in the United Nations; and *Congress has already scuttled our protective tariff system and repealed the statutes prohibiting Asiatic immigration.*

"Under such a system —

"Our natural resources, and the fruits of our productive free enterprise, could be exhaustively looted for the benefit of covetously less able and less industrious populations elsewhere.

☆ ☆

"Under such a system —

"American labor would have to compete at home and abroad with alien pouper labor, and the American standard of living would vanish.

"Under such a system —

"We would have to share our privileges of citizenship with the aborigines of Africa and the hordes of the Orient, and in the end be overwhelmed by their migrations.

☆ ☆

"We could maintain no national defense without the express consent of foreign powers.

☆ ☆

"Our Flag would cease to command respect, our institutions would become degraded, and an American would never again inherit the pride of our ancestors in being AN AMERICAN."

I SEE RED!

After reading the Tompkins very disquieting article, I promptly began to dig into the background of the "United World Federalists, Inc." — *especially as to its founders.* I never accept these organizations at *face* value, because when and if the Redness of a Founder or an Officer is exposed, that individual promptly disappears off their letterheads and liter-

ature and is replaced by a "respectable" name. I will cite a *very recent* example of that technique:

In our April-May News Bulletin we exposed that both Dr. J. Eugene Harley and Mary J. Workman, President and Secretary, respectively, of the Los Angeles chapter of the "American Association for the United Nations" are *notorious Red Fronters*. An "election" was promptly arranged and both Dr. J. Eugene Harley and Mary J. Workman were "replaced" by individuals who on their *face* are not suspect to the unwary citizen. Hence, the *face value* of an organization means nothing to me . . . I've heard skunks called wood-pussies, but I discovered they both smell the same.

BACKGROUND OF "UNITED WORLD FEDERALISTS"

The ill-omened birth of United World Federalists, Inc., occurred in Asheville, North Carolina, on February 21, 1947. On that day all the groups in America that were organized to *clamor* for world federalism assembled in that city. This conference was called the "First National Congress of World Government Organization," the purpose being to merge all of them into one over-all organization. There were sixteen such groups under various names. Five of these were merged into one major organization, now known as "United World Federalists" and their *announced* objective is "World Government with Limited Powers Adequate to Prevent War."

SO THEY SAY!!!

In addition to the merger of the five groups, the general session of the convention coordinated the platform and interlocked activities of all the world government organizations in America *so that all would drive at the same objective from different directions*.

The Executive Council of this newly organized over-all organization, "United World Federalists," thirty in number, was elected at that Asheville Conference. This Executive Council was empowered to elect officers, select an Advisory Board, appoint Honorary Directors, etc., etc.

REDS ORGANIZED U. W. F. INC.

To remove even an infinitesimal doubt that "United World Federalists" is Moscow inspired in its very inception I will *name* the *Reds* who gathered in Asheville on that day to organize this *new approach to such unwary Americans into surrendering to Stalin*. There were 300 "delegates" there, but I will name only the most notorious ones — we won't waste space on the *small fry*. All of these names have been — *and many of them still affiliated with U. F. W. as Organizers, Sponsors, and / or Directors*. Likewise, *most* of these have been Organizers, Sponsors, Directors and / or active workers in *at least 5 to 40 FLAMING RED FRONT ORGANIZATIONS!*

It would be very illuminating if the F. B. I. could be prevailed upon to show from their files how many of these "World Federalist" organizers are also *secret members of the Communist Party!*

THE TECHNIQUE OF THE REDS

At this point a comparison of the methods of operations decided upon by the United World Federalists with the Mos-

cow official techniques becomes *very significant!*

We cannot do better than cite the structure of the "*American Association for the United Nations*" as a pattern:

"Local *Chapters* are to be set up under the jurisdiction of City and State branches wherever possible, otherwise directly under the National Central Headquarters. Provision is to be made for Members-at-large in communities where there are no organized chapters. Each chapter is to develop and train speakers and make them available for Women's Clubs, College and University Fraternities and Sororities, Parent-Teacher groups, Men's Service Clubs, etc. All chapters are to organize "Study Groups" within, and whenever possible, under the sponsorship of those various clubs and organizations. The speakers are to arrange special study meetings in their homes, and / or in the homes of influential Social and Civic leaders."

In our April-May News-Bulletin on pages 12, 13 and 14, we described in detail the method they employ in setting up those "Study Groups."

Now let us examine the FEDERALISTS' Bag of tricks —as taken verbatim from their Charter and By-Laws:

TECHNIQUE OF THE "FEDERALISTS"

"Local *chapters* are to be set up under the jurisdiction of state branches wherever possible, otherwise directly under the corporation itself. Provision is made for members-at-large in communities where there are no organized chapters. The Governing body of the United World Federalists is to be the General Assembly, a representative assembly of all members is to meet at least once each year. In between meetings of the Assembly, the corporation is to be governed by the Executive Council.

"Each chapter is to create and train a corps of effective speakers and make them available to Women's Clubs, Church organizations, University, College and High School Clubs and Societies, Men's groups, Parent-Teacher groups, etc. Special efforts to be directed at all Church groups, stressing the word Peace as our motive. Wherever possible induce Ministers to lend

their names to chapter boards."

In other words, their theory is that if they delude and hypnotize your pastor, he, in turn will anesthetize you and all the other members of his church.

"All chapters are to create Study Groups within the various Churches and Social and Civic organizations, and wherever possible, under the sponsorships of the Churches and various organizations. In addition, the speakers are to hold home meetings in their own homes, or the homes of Community leaders."

Close examination of the structures of "The League of Women Shoppers," the "American League for Peace and Democracy," "The American Peace Crusade," "American Peace Mobilization," "American Youth Congress" — *all blazing Red Fronts* — discloses a startlingly striking similarity.

"GIVE ME THE YOUTH OF A NATION" . . . STALIN!!!

The Federalists further decided that *student* chapters are to be organized and are to have the status of local chapters: these chapters to be under the immediate direction of a National *Student* Council — but, the Executive Council would make all decisions in the student field and control all student chapter activities. In other words, the National Student Council is the taskmaster set up *by the Reds behind the Executive Council . . .* the Student Chapters are the stooges — and the student members just so many "knuckle headed" pigeons. This student Council consists of 35 members — 10 from colleges 6 from *high schools*, 4 from *preparatory schools*, and 15 *unspecified*. Bearing in mind Stalin's orders to "capture the youth of the nation" it will not be surprising to find some of those unspecified 15 assigned to the Kindergartens . . . and nurseries.

No Red Front organization, with the possible exception of Gene Kelly's Youth Section of The Communist Progressive Party of America, is making as determined an effort to capture "Young America" as United World Federalists, Inc. . . . *and they are meeting with great success!!!*

"BUTTON, BUTTON . . . WHO HAS THE BUTTON?"

A statement of policy was drafted at the the Asheville Convention. Boiled down, it declared for a world government with so-called limited powers adequate to prevent war, expressing the theory that peace is not merely the absence of war, but the presence of justice, law and order; that world peace can be created and maintained *only under world law* sufficiently strong to prevent armed conflict between nations; that, while endorsing the efforts of the United Nations to bring about a world community favorable to peace, the United World Federalists will work to strengthen the United Nations *into a World Government*.

Thus, the United World Federalists, Inc., brazenly declares itself an anti-Nationalist organization — *and, in particular, anti-United States anti-Nationalist!* It would surrender the sovereignty of the Nation, and it would favor making the United States but a common denominator of the whole. *This was actually acknowledged by AN OFFICIAL of the United World Federalists, Inc., at the hearing before the Senate Judiciary Committee in Sacramento on June 27.*

So there is no question — *or doubt* — that the aim of the United World Federalists is to establish *a world government*. In this connection, they stated: "This federal world government" (*in which we would be a 149 million voice against TWO BILLION*) "will make laws relating to natural resources, international trade, transportation, currency, and many similar matters. For it is quarrels between nations about these bread-and-butter questions which will go on causing wars forever, unless you and all other world citizens give a law-making body higher than any national government the power to settle them."

In other words, we, the richest and most powerful nation in the world today would meekly sit down and permit 60 beggar nations and two billion paupers to create and pass laws to loot and distribute our wealth and bring us down to the living standards of the Russian Peasant. And, this is proposed by men who call themselves Americans!

BENEDICT ARNOLD WAS A "SMALL TIMER"!!!

Now, get this, my friends, and tremble with fear and shiver with apprehension:

This man, Cord Meyer, Jr., who is the brain of the United World Federalists, wrote a book entitled "Peace or Anarchy." After he gets through telling how the Federalists would transform the United States into just a State within a Federated World Government, *under the control of that Government*, he explains on page 171 of that book that once having joined the World Federal Government no nation could secede — OR REVOLT . . . "*because with the Atom Bomb in its possession the Federal Government police could blow that nation off the face of the earth.*" —

This is a statement *in print* by the man who is using the word PEACE to induce us to give up our sovereignty, our freedom, our Army and Navy, *and our Atom Bomb . . .* and in the same breath he informs us that if we fall for his scheme *and then discover our mistake* we could never secede — and if we tried to revolt we would be blown off the face of the earth by *our own surrendered Atom Bomb.*

This sounds unbelievable, doesn't it? But don't forget, Adolph Hitler stated exactly what he planned in "Mein Kampf"; so did Lenin and Stalin — *and all three did exactly what they said they would do!!!*

On another page in this book this man Meyer states that "The Russians *rightly* suspect" . . . that the Western World is in conspiracy against them.

If that isn't Communist language right from Moscow I don't know how to read English!

THE FINE MONGOL HAND OF STALIN

The manner in which officials of this proposed "Utopian" Federated World Government are to be elected has not yet been made public by "United World Federalists.". But it is well to remember at this point that from 1945 until the U.W.F. came into existence, *Russia was driving for a World Communist*

Federation exactly along these same lines! Nor has it been explained how the world government advocates expect to create such a body without Russia dominating it, *as she is now dominating Asia and practically all of Europe.* Neither do they say how the majority of the people in the Western Hemisphere, France, England, and elsewhere would be induced to bow to Russia's domination over such a government, because it is a lead pipe cinch that Russia could never be persuaded to become absorbed in a world government not of Russia's making.

THEY INVADE SACRAMENTO

On March 24, 1949, a Resolution PREPARED by the WORLD FEDERALISTS, known as Resolution 26, was passed UNANIMOUSLY by the California Assembly — and, after *strenuous opposition*, was approved by the Senate 23 to 9. Only one word can describe the method employed to get that Resolution passed; that word is: RAILROADED! The Federalists themselves acknowledged that fact with gleeful chortles and statements that Resolution 26 was rushed through the California Assembly before anybody knew "*what it was all about!*"

But that was a slight exaggeration . . . what they should have said was: "*before anybody outside of the California Legislature knew what it was all about.*"

Now to describe the method they employed to *railroad* Resolution 26 through the California Legislature:

Under the supervision of Alan Cranston, the Federalists' "Big Wheel" in Northern California, the U.W.F. canvassed the members of the Legislature. The answer to Resolution 26 was unanimously an emphatic "NO!" The greatly alarmed Cranston scurried to Paul Smith, Editor of the San Francisco Chronicle, and laid his problem before him. Mr. Smith hied himself to Sacramento for "a few words" with one, Artie Samish:

CZAR OF CALIFORNIA

Artie Samish is a behemoth of a man. Outwardly exuding

great good nature, his huge fat body shakes like a vat of jello when he laughs. Artie is a professional Lobbyist, but the mere word Lobbyist in the case of Artie is as great an understatement as saying that Toscanini is an orchestra director. Artie is the Master of Master-Lobbyists. Artie openly boasts that he can *pass* a Bill or Resolution . . . or KILL it . . . before you can say abracadabra—and THAT is no understatement. He has publicly boasted that he "carries the California Legislature around in his *small change* pocket." And THAT is no understatement!!! Artie lobbies for Bus Companies, Oil Companies, the Movie Studios, Race Tracks — anybody who can pay \$25,000 . . . but no less than \$25,000 . . . to a million. But his pet "client" is the Liquor Industry . . . and his "slush fund" is *positively* without limit! His power in Sacramento is far greater than the power of any Governor in the past decade and has been so acknowledged by Governor Warren . . . but it is best exemplified by a statement made by Artie himself: "To hell with the Governor of California, I'm the Governor of the Legislature!" This is the man Paul Smith turned to when Cranston informed him that the "Federalist" scheme had been pronounced a "dead duck" by every California Legislator he had buttonholed.

"Artie," said the Chronicle's Mr. Smith, "I need a favor. I've got a little Resolution I want put through, but the boys are acting hard to get — can you help me out?"

"What's the little Resolution, baby?" . . . "*Baby*" is Artie's pet name for those he likes.

"It's to support a World Federated Government," replied Mr. Smith.

"What's a World Federated Government?" asked the puzzled Czar of California.

"Here;" Mr. Smith laid a copy of the Resolution before Artie; "read it and you'll know."

"Never mind," hastily assured Artie, eyeing the document warily — Smith uses *big* words and Artie's education has been a limited one, not much beyond kindergarten. "If you want it passed, baby, it'll be passed."

And on March 24th it was passed UNANIMOUSLY by the Assembly — *many of whose members had previously shied away from it with holy horror!!!*

How much do re mi . . . MONEY, in Artie Samish's language . . . it took to accomplish it no one but Mr. Samish knows. But one very reputable gentleman in Los Angeles has stated that he KNOWS how much . . . *and whence it came!*

By March 31st a few members of the Senate became aware of the heinous intent of this Resolution 26 and put up a strenuous opposition, but with Artie Samish cracking the whip, it was approved by the Senate 23 to 9.

Gravely alarmed, the 9 who voted *against* the Resolution took steps toward reconsidering it. That was brought up on April 6th and was defeated 22 to 13. Thereupon a new Resolution, known as Resolution 36, was introduced by Senator Hugh Donnelly to rescind Resolution 26 — and was defeated.

In a *confidential* Special Bulletin to their members the Federalists gloatingly describe the methods they employed to defeat Resolution 36. Lack of space in this Bulletin prevents a detailed analysis of their methods . . . *it will be given special attention in our September issue . . .* but in their boasting they reveal how closely they hew to the Moscow-directed Commie technique.

Their description of one particular method they employed to "pressure" wavering Senators and Assemblymen into supporting their *treason-packed* Resolution . . . *and which they are now applying to members of Congress in Washington . . .* is definitely *criminal under our laws* and may prove to be the very boomerang that will alert the entire nation! *Action is now being taken to bring that out into the open before our September News-Bulletin goes to Press!!!*

THE VALIANT!

When the fight against Communism in America is finally won, and the valiant ones who made the victory possible will be counted, the name of Jack B. Tenney will ride high up on the list.

Armed with his vast knowledge of Red objectives and Red methods, Senator Jack B. Tenney used up a lot of midnight oil during 1948 preparing several anti-Communist Bills which, *had they been enacted into Laws, would have cleaned Communism out of California — AND HOLLYWOOD — with the effectiveness of an Atomic Bomb . . .* and made the State of California the symbol for all America. By the same token, there would have been no "United World Federalist" Resolution 26. When first submitted, early in 1949, the Senate passed all those Bills unanimously and practically all the Assemblymen assured Tenney that they would vote *for* those Bills. Well, then Tenney went to Honolulu, so he wasn't in Sacramento when the Federalists *railroaded* their Resolution 26 through both Houses. But when Senator Donnelly and his Co-Americans launched their fight against that "*give away America*" Resolution Tenney promptly jumped in with them. When he did that he signed a personal political death warrant with every one of those "give away America" State Senators and Assemblymen — *and, of course, Artie Samish!* When his anti-Communist Bills came before the Assembly *sixty-seven* out of the *total eighty* who had promised an "aye" vote voted against them! At the same time the cry went up "Get Tenney!!!" "Drive Tenney out of politics!!!"

LEADERS OF THE PACK

The leaders in the attack on Tenney in the upper House were: Senators Gerald J. O'Gara, George Miller, Jr., H. E. Dillinger, and Harry E. Drobish. In the Assembly, Sam Collins, Speaker, took the lead, with John B. Cooke, Ernest R. Geddes, George Collins Jr., Lester A. McMillan, and Thomas A. Maloney, *sponsor of the Federalists' Resolution 26*, promptly swinging into line behind him. But the real knifer-in-the-back was Sam Yorty. The chief reason they gave for their gang-up on Tenney was that he had used the funds allotted to the Committee to "*build himself*" up with the public. This was proved false very quickly. The second *given* reason was that Tenney had committed rank heresy by exposing a Red taint in several

of his colleagues. Well, now, let's analyze the latter reason—
and go beyond it.

IN THE SPIRIT OF JUDAS!

Brutus achieved his particular ill-fame when he stabbed the mortally wounded Caesar in the back of his neck. Caesar had been his great friend and patron. Well, right in our own Sacramento we have a Brutus or two — plus a Judas! Assemblyman Sam Yorty had been a very close friend and political associate of Jack B. Tenney. When the Tenney Bills came through the Senate with flying colors, Yorty told Tenney that it would give him great happiness to sponsor those Bills in the Assembly. Came the day before those Bills were to be submitted. In the interim the Sacramento wolves had howled their howl of "get Tenney" and Yorty solicitously advised Tenney to choose somebody else to sponsor his Bills — *on the theory that it would be political strategy to have some one not identified as a close buddy do the sponsoring!* That, earnestly assured Yorty, would give *him* greater freedom in doing *the more important job* of all-out support on the floor. Harold K. Levering took over the sponsorship — *and he did a great job of it!* Then came Yorty's "once-in-a-lifetime" opportunity. I will describe it in the words of the Reporters present at that historic session: "Sam Yorty, Tenney's friend, whipped out his trusty blade . . . *and sank it deep into Tenney's back!*"

Now, knowing what is at stake, why did this Sammy Yorty stab Tenney in the back? — *actually, however, he sank his dagger into the collective back of his constituents!!!*

What was his objective? . . . *What was his gain?*

Mussolini stabbed dying France in the back to achieve an empire . . . Brutus stabbed dying Caesar in the neck in the hope that he would inherit Caesar's power . . . Judas betrayed Christ for thirty pieces of silver. Yorty stabbed Tenney — AND AMERICA in the back . . . FOR WHAT? . . . and FOR WHOM? *That* is something for his AMERICAN constituents to find out.

As ye sow, so shall ye reap! We know the grim rewards

reaped by those three *historic* stabbers-in-the-back . . . will Sam Yorty reap *his* reward? I prophesy he will — *when his constituents learn the full extent of his betrayal — not of Jack B. Tenney — but of his oath to his people and to his Country. The Mills of the Gods grind slowly, but they grind exceedingly fine!*

BY THEIR DEEDS SHALL THEY BE KNOWN!

Another gentleman who plunged his blade deep into the collective back of his AMERICAN constituents — *and of his State and of his Country* — is Assemblyman Sam Collins. Mr. Collins is Speaker of the House. He fancies himself a very important BIG FISH in his little pond. He would resent being told that he is disloyal to the land he lives in — but, then, so did Frederic March and Eddie Robinson scream when *they* were *exposed*. I *won't* say that Collins is a Communist or a Fellow Traveler . . . I don't know. I can only judge him by his deeds . . . and by his deeds he has convicted himself of at least giving plenty of comfort to the Reds. All his charges, attacks and smears against Tenney were motivated by one overwhelming desire: abolish the California Un-American Investigating Committee! *The Reds of Hollywood organized "The Committee for the First Amendment" for that very identical objective!* To my distinct knowledge Sam Collins has fought tooth and toenail for several years to abolish the California un-American Investigating Committee . . . he and his particular pals in Sacramento. He . . . *and his pals . . . couldn't very well dare* protest against the objectives and the purposes for which the Committee was set up, so they invoked phoney charges and a smear campaign against the man who *headed* the Committee — obviously in the hope that by destroying the head they would destroy the body. *And they were grandly supported in their attack by the Reds' "DAILY PEOPLE'S WORLD!!!"* By that very token Sam Collins . . . *and his pals . . .* have been for years violently opposing the investigation of Communism in the State of California — AND AIDING JOE STALIN!!! This is amply corroborated in that previously mentioned Communist

sheet, "Daily People's World," which burst forth on Monday, March 31, 1947 with the following blazing *front page* headline:

GOP LEADER REFUSES FUNDS FOR TENNEY

Daily People's World Political Editor

"Sacramento, March 30 — Opposition to Senator Jack B. Tenney's State Un-American Committee hit a new high in the legislature today, when Sam Collins, *conservative* Republican assembly speaker declared emphatically he "will not vote one red cent" for continuing the Committee."

The story goes on in typical Commie style, accusing Senator Tenney of having used the funds of the Committee to "build himself up politically by smearing . . . or *threatening* . . . all those who stood in the way of his ambitions."

Two weeks later, on April 12, 1947 this same Red sheet came out with another blazing headline:

"GOP LEADER: 'NO FUNDS FOR TENNEY'

Daily People's World Sacramento Bureau

"SACRAMENTO, April 11, — Another influential Republican legislator today joined the ranks of those who will oppose any appropriation for the Tenney State Un-American Committee.

"Assemblyman Ernest R. Geddes (R. Pamaona), said he was in agreement with Republican Speaker of the Assembly Sam Collins that the Committee should not be given 'one red cent.'"

As in the previous article, "People's Daily World" quotes Geddes along *exactly* the same line as they had quoted Collins. In both cases the same motive stood out like a beacon . . . "abolish the California State Un-American Committee."

It *may* be just a co-incidence, but those two stories in the Red "Daily People's World" remind me of the high praise Al Capone used to accord certain political figures in Illinois —

who were on his secret payroll.

On that same front page of the "Daily People's World" — right alongside the eulogy accorded Sam Collins for his vituperation of the Tenney Committee — we find a huge four-column headline glowingly praising Communist Eugene Dennis for denouncing our *Congressional* un-American Investigating Committee. Is that just another co-incidence? . . . *or is there something significant in the fact that these two articles are twin in their support of Red Communism?*

That was early in 1947. Mr. Collins . . . *and his pals* . . . were unable to destroy Tenney and / or the Committee *at that time*. But they did not give up. They bided their time — for an opportunity which would enable them to line up *overwhelming odds*. That came with Resolution 26." In March 1949 few people knew very much about the United World Federalists. Nobody had gone to the trouble of investigating and exposing the fact that United World Federalists had been *founded . . . created . . . and organized . . . by a gang of the most notorious and crafty Reds in America*. Employing their wily Red technique they railroaded their viciously traitorous Resolution 26 through the California Legislature and — *to our everlasting shame* — brazenly announced it to the world as the "California Plan." Then, as previously stated, Senator Donnelly and a pitifully few other wide-awake Americans set up Resolution 36 to rescind the "give-away American" Resolution 26. Jack B. Tenney roared in to their support. Ah'h!!! *That* was the opportunity Collins, Geddes and Yorty had been waiting for! And this time they had a Federalist-Samishized "captive" Assembly and Senate ready to say "Uncle" — and roll over on command!

As previously said, the American people didn't know that Resolution 26 is treason-packed. *Most of them still don't know*. ..But Sam Collins knew . . . Sam Yorty knew . . . *all those other Assemblymen and Senators, who fought against the rescinding of Resolution 26, knew* — and before I am through I will *prove* that they knew. I will prove that every individual in the California Legislature who voted *against* rescinding Reso-

lution 26 was guilty of an act that would have meant death without a trial behind the Iron Curtain.

Anyway, *that* was the opportunity Collins and his particular henchmen had been waiting for . . . Resolution 26 would enable them to kill two birds with one stone: Tenney, the fighter against the "Give-Away America" conspiracy — and Tenney, the exposé of Reds and their activities in California. They used that act of treason as their springboard for an all-out attack on Tenney. Once again they demanded that *the Tenney Committee be abolished!* And—*again*—they charged that Tenney had misused Committee funds for personal objectives. *This time* they made the *specific charge* that Tenney had subsidized—with Committee funds—a News-letter publication called "Alert" and its Editor, Ed Gibbon, to smear those Assemblymen and Senators who opposed his (Tenney's) political ambitions.

That charge was an utter and complete lie. Those who made the charge knew it was a deliberate lie. Its only purpose was to confuse the public. That lie was the Iron Curtain behind which they could scheme and plot and conspire how to kill . . . not Tenney — but the California Un-American Investigating Committee — or, at least, make it innocuous.

At this point I will go on record with a statement — *and with a prediction* — that those who attacked, smeared and villified Tenney were not concerned with Tenney *per se*, but with Tenney *the Chairman of the Un-American Investigating Committee.* They smeared him because he refused to be influenced, coerced, intimidated, terrorized into soft-pedaling his investigations, or into withholding what those investigations revealed. And here is my prediction: no matter who follows Tenney in the Chairmanship of that Committee, *unless he plays ball their way*, or is terrorized into crawling under the bed, he will be attacked, smeared and villified exactly as they smeared and villified Tenney . . . *except and unless we clean house in Sacramento before they get an opportunity to do so.* Now, let's get back to the attack on Tenney.

On Tenney's insistence a Committee was appointed to investigate that charge. *It was quickly proved false — AND SO*

ANNOUNCED IN THE PRESS!!! But the two Sammys . . . and their co-workers . . . shrewdly continued to use that treason-loaded Resolution 26 as their bludgeon to KILL THE ANTI-COMMUNIST BILLS — and prevent the rescinding of Resolution 26. And they succeeded!!!

And now I will show you who wanted those anti-Red Bills killed! I will show it to you in the official mouthpiece of the Communist Party —the "Daily People's World":

" 'WORLD' LAUDED FOR ROLE IN DEFEATING TENNEY BILLS.

"Los Angeles, July 6, 1949 — The Daily People's World was praised today for its 'excellent coverage' of the campaign which aided in dumping the Tenney bills in the state legislature.

"The praise came in the final report of the Emergency Coordinating Committee to Defeat the Tenney Bills, and was drafted by Philip M. Connelly . . . Connelly directed the campaign for the Committee.

"The report was approved by the Committee's steering committee, consisting of Robert W. Kenney, Daniel G. Marshall, Hugh Macbeth Sr., Ignacio Lopez, Averill Berman, William B. Elconin and Paul Major.

"After outlining activities of the Committee, which included placing ads in various papers, the report said:

" 'Aside from excellent coverage given by the Daily People's World, both to the Los Angeles campaign and to information out of Sacramento . . . the Press was of little assistance in promoting the campaign.

" 'The Tenney Bills went down the legislative drain pipe mainly because enough assemblymen were inundated with telephone calls, telegrams and letters to the point where they were convinced that a vote for the Tenney program would be an emphatically unhealthy act — *politically, that is.*'

"The report noted that the Committee didn't worry too much about delegations to Sacramento, or appearance at legislative hearings on the Bills, but instead urged the people to utilize

their time, energies and money in mobilizing the 'voice from home.' ”

The Federalists employed identically the same Commie method of the “voice from home” to make the members of the Legislature “sit up and say ‘Uncle.’” That method will be exposed in detail in our September issue — and it will show *a criminal exploitation of the United States Mail!!!*

Does that show whom the Collinses, the Yortys, the O’Garas, and all those others were working for?

Friends, if we, the people of the State of California, allow those men to go back into our Legislature in 1950 we will have no one but ourselves to blame if we finally find ourselves and our children in Joe Stalin’s Prison-Labor Camps — *or worse!* Those men must never be re-elected! *We* must see to that! The Reds admit they succeeded only because we were asleep. The Federalists gleefully chortled that *they* succeeded because we were asleep. But finally we are awake! Anything they can do we can do . . . anything they can achieve we can achieve! We are going to get those anti-Red Bills passed and enacted into laws — and *we are going to get Resolution 26 rescinded and repealed!*

On Friday, June 17, one of the Editors of “Alert” called me on the phone: “Mr. Fagan,” said he, “Jack Tenney needs help. The Reds have ganged up in Sacramento to kill all the anti-Communist Bills and to prevent the rescinding of Resolution 26.”

Within eight hours the Cinema Educational Guild sent out *two thousand* telegrams and letters by air-mail and special-delivery to our members here and in the San Francisco-Oakland area, in which we gave them a clear and concise picture of the entire situation, and urged them to *wire* their Assemblymen and State Senators and demand their support of the anti-Red Bills and Resolution 36 to rescind Resolution 26. And all our members fully carried out our request — thousands of telegrams and special delivery letters poured into Sacramento during the next three days. So. if your Senator or Assemblyman will tell you that he did not know the importance of the Tenney

Bills, or the significance of the Federalists Resolution 26, you can tell him he lies. As further proof that each and every one of them *knew* all the facts *in advance* I will cite in part, two statements made in the Assembly Room by Assemblyman Don Levering and in the Senate Chamber by State Senator Donnelly.

Mr. Levering was speaking on behalf of the Tenney Bills; after Sammy Yorty had *decreed their death* by sending them to the Rule's Committee — Yorty's Press-quoted words were: "I am sending them to the Rules Committee *to be killed . . .* without a further hearing." Had Sam Yorty any real power of speech he could have paraphrased Marc Anthony's famous oration with: "Friends, *Fellow-Americans*, Countrymen, I am here today not to praise *anti-Communism* but to bury it." At least, it would have *sounded* less hypocritical!

Yorty smashed to smithereens all Assembly rules of procedure with that act. In an eloquent plea, Levering made that all very clear on that day — especially in his concluding statement:

In conclusion, he said. "Let me point out that the name of every member of this House is under a shadow because of our failure to stand up and be counted on this subject. We are being called traitors and cowards because of the honest mistake we have made. You can, and should, correct this mistake by withdrawing these bills from the Rules Committee and placing them before this House for further consideration."

Despite that plea the Tenney Bills remained killed!!!

Now, as to Resolution 26: On March 24 the Assembly . . . *whipped into line by Artie Samish . . .* passed it unanimously 68 to 0. On March 31 it came up before the Senate. As proof that every individual in the Senate Chamber was made fully aware of the treason in that Resolution *on that day* I quote — in part — from Senator Donnelly's plea for its defeat:

"This resolution would apply to the California delegation in Washington to ratify United States entry into a world government *that would take away United States' sovereignty* and permit a world army to exist stronger than the army of the United States. This resolution would take away from the United States *its sovereign right to maintain an army, navy or*

air force.

"HOW DO WE KNOW THE POWER WE ENTRUST TO THIS WORLD COURT (FEDERAL WORLD GOVERNMENT) WILL NOT BE USED AGAINST US?"

"There are worse things than war. Slavery is worse.

"We are speaking for the people of California. I urge you to turn this resolution down."

Despite this eloquent plea — *and knowing what this treason-loaded Resolution meant* — the vote was 23 FOR THE RESOLUTION to give our Country away, 9 AGAINST it. Following are the 9 gallant and true Americans: Senators Abshire, Crittenden, Desmond, Donnelly, Hatfield, Hulse, Mayo, Rich and Sutton.

Following are the 23 Weasel Americans who favor giving up our Sovereignty, our Flag and our Country: Senators Breed, Brown, Hugh M. Burns, Busch, Coombs, Cunningham, Dillinger, Dorbish, Gibson, Johnson, Judah, Keating, Miller, O'Gara, Parkman, Powers, Regan, Salsman, Swing, Ward, Watson, Weybret and Williams.

On April 6 there was another debate in the Senate to reconsider Resolution 26, at which time Senator Donnelly again appealed to the patriotism of his Colleagues:

"I'm not foolish enough to believe the legislature in Sacramento can give up our sovereignty.

"But Article 5 of the Constitution of the United States gives us the power to call a constitutional convention. Do you know that the purpose here is to call a convention to give up our sovereignty?"

He then *emphasized* the fact that this movement to *surrender* all our rights and powers *is Moscow inspired and directed!*

"I can remember the time when nobody would have *dared* to offer a resolution of this kind.

"The reason our foes would have us give up our sovereign powers is — *we've got the atom bomb.* I'm glad we have it. It would be better a thousand times that the bomb destroy the world than that we be bound in chains by giving up our liberty and our sovereignty.

"If we give up our sovereignty, we give up our right to defend ourselves. Already the Communists control not only all the land and peoples behind the iron curtain, but almost control France, Italy and many other nations. Would you favor turning over *our sovereignty to them?*"

"You'll say this resolution merely calls for a convention. I'm fearful if you start here, you'll end by giving up our sovereignty to other nations!"

On this occasion Senators Brown, Hugh M. Burns, Dilworth, Jespersen and Williams joined the original gallant 9. But 22 of our other *great* American State Senators again voted to give our Country away.

THE AMERICANS FIGHT ON!

On June 20th Senator Tenney informed me via long distance phone that Resolution 36 to rescind and repeal Resolution 26 would be up for a hearing before the Judiciary Committee on Monday, June 27th. Could I again get Cinema Educational Guild to support him and Senator Donnelly? I assured him that we would not only repeat our previous action of wires and letters but that I would personally appear at that hearing in my official capacity. I immediately contacted Mrs. J. Henry Orme, President of "The Americanism Defense League," who promptly provided me with a Resolution by *her* organization. In addition she secured and gave me a Resolution by the Ebell Club.

On my arrival in Sacramento on June 27th I had a ten minute talk with Senator Jack B. Tenney. The first thing he told me was that during the past week *tons of money* had been poured into Sacramento to kill off all opposition to Resolution 26. Also that for *every wire and letter* our Guild members had sent in the Federalists had poured in *scores*. I'll tell you how they did that: if you recall, in his "Daily People's World" interview, Connolly stated that they didn't bother to send delegates to Sacramento — that they achieved their objectives with wires and letters from the "home folks." Well, normally that would be fair enough — as it is no different from our own procedures — but what Connolly did not mention

is a very unique Red technique: whenever the Reds have to apply pressure for or against a Bill in Washington, or a State Capitol, they secretly instruct every Red and fellow-traveller to pick out the names of 50 to 100 citizens in their communities and send wires in *their names* — not letters, but *wires* — because even the Telegraph office cannot trace *typewritten signatures* on telegraph blanks — should anyone of the innocent 50 to 100 citizens become aware that his or her name was used without consent. *The Federalists employed that very same technique . . .* (in our September News-Bulletin we will publish *documented proof from Washington* to verify that statement) . . . and *deluged* Sacramento with wires and *tons of money*. As a result, I strongly doubted that we would have any luck with the Judiciary Committee — but I never give up without a fight!

The Hearing was scheduled for four o'clock. That gave me time to interview several members of the Assembly and the Senate. Here is the stock answer I got from practically all of them:

"I voted for Resolution 26 without knowing what it was all about."

A fine admission by men who are entrusted with the safety of our nation — *if those statements can be accepted* as the truth. But let me give you an even more naive — *and reprehensible* — reply by Assemblyman Charles Conrad.

"I knew that Resolution was rotten," he said: "it was hot, so I was one of the 12 who refused to vote for or against it."

When I asked him why he hadn't voted for Resolution 36 *to rescind* the treason-packed 26 he mumbled an evasive reply. In short, he theorized . . . *and I say that on excellent authority . . .* that he could not afford to become unpopular with "the boys" in Sacramento — *let alone Artie Samish!* The opinion of the people who elected him to guard their interests apparently doesn't matter to Mr. Conrad as long as he can remain popular with those "boys" in Sacramento *who had decided to betray America!* Well — maybe his constituents will think otherwise on next election day!!!

At a quarter of four I entered the Committee Room in which the hearing was to be heard. It was already pack-jammed to the doors. Present for our side were three women from Los Angeles and two men — members of our Guild in San Francisco and Oakland. Also, a Minister, Dr. Wesley Swift, representing his congregation. In addition there was a Committee of three from the Veterans of the Foreign Wars, and the Adjutant of the American Legion in the Sacramento area — a total of eleven fighting for America. The hundred-odd others, mostly women, were so-called Federalists . . . but if I had entered that room blind-folded I would have known it was full of Reds and fellow-travellers — I don't have to *see Reds* — *I smell 'em!* I can smell 'em as quickly as my dog smells a rat.

The Judiciary Committee was composed of Senators Busch, Coombs, Desmond, Dorsey, Keating, O'Gara, Regan, Salsman, Tenney and Ward. Ward was Chairman and Keating Vice Chairman.

The Chairman announced that the hearing was to be given two hours — one hour to *those who love America*, one hour to the Federalists.

Senator Donnelly called upon the Committee of the Veterans of Foreign Wars to present their Resolution. The Spokesman of that Committee delivered a very forthright and direct statement to the effect that his organization had fought through two frightful wars to preserve America and they would not now stand idly by while that same America was being handed over to the Communists.

Senator O'Gara promptly attacked that statement, virtually accusing the Veterans of Foreign Wars of being War mongers if they opposed a Federal World Government. He put that Spokesman on a red-hot grill for more than a half-hour with biting questions and challenges. Regan and a couple of the other Senators co-operated with O'Gara in somewhat milder form. O'Gara went thru the same performance with the other members of the V. F. W. Committee. When the American Legion Adjutant came forward to make his statement O'Gara promptly challenged his right to speak because he had no

official Resolution by the Legion authorizing him to represent the organization. The Adjutant thereupon explained that when and if the American Legion had had no time or sufficient opportunity to meet and issue a formal Resolution . . . *as had been the case in this instance* . . . the Adjutant had the authority to represent the organization. O'Gara rejected that statement. Regan supported him. In short, throughout, O'Gara challenged, cross-examined and heckled those four men with what was obviously an intent to completely confuse the real issue of the Hearing. O'Gara's very pronounced stand was that to avert a Third World War America *would have to surrender its sovereignty . . . its Army . . . its Navy . . . AND OUR ATOM BOMB!* And Mr. O'Gara could not claim to be unaware as to the identity of the founders and organizers of this "give-away America." If that wasn't a Red . . . or, at least, a Fellow-traveler . . . talking, then Senator O'Gara is the most assinine and stupid Legislator I have ever listened to — *and I've listened to many stupid politicians.*

That *hearing* was *cooked* before it was served . . . *it was a "hearing" to forever KILL all opposition to Resolution 26, not to weigh it.* Artie Samish and the Federalists had put over a perfect job of Lobbying. I wasn't greatly amazed by the fact that Chairman Ward and Vice Chairman Keating sat supinely through all of O'Gara's challenging and heckling . . . *I expected that.*

O'Gara's filibustering . . . *and it was nothing less than that* . . . with the three V. F. W. representatives and the American Legion Adjutant consumed one hour and fifty minutes. At ten minutes to six Chairman Ward pointed out that the two hours allotted had been consumed and the Hearing was over. Donnelly, however, pointed out that most of the two hours had been "filibustered" and insisted that I be permitted to present *my* statement and resolution. Ward *magnanimously* agreed to give me the unexpired ten minutes . . . he obviously felt that it would not be necessary for the Federalists to bolster their case with any statements.

The moment I stepped forward Senator O'Gara proceeded to

"take me in hand" as he did the others but I promptly put a quietus to that. I pointed out that I came to Sacramento representing three respected groups of *American* citizens . . . that I had a statement to make — *and that I would not be filibustered* out of making it.

Thereupon I presented my *three* Resolutions condemning World Federalism as a Moscow inspired scheme to take our Country away from us exactly as all of Eastern Europe was gobbled up by Moscow. I concluded with a statement that Cinema Educational Guild publishes a News-Bulletin monthly . . . that our next issue would be devoted to a full and complete report of the Sacramento "putsch" . . . together with the Resolution submitted to the Judiciary Committee on the occasion of its hearing: which read as follows:

Resolution issued by Myron C. Fagan, National Director of CINEMA EDUCATIONAL GUILD on behalf of all the Guild members throughout the State of California.

"Resolution 26, which we are asking to be rescinded, memorializes our Congress and our Nation in general to be swallowed up in a world government which, if followed through to the ultimate, would accomplish the following:

- "1. The establishment of a Constitution which would rescind the Constitution of the United States.
- "2. The adoption of a world Flag that would fly above the Stars and Stripes.
- "3. The surrender of our national sovereignty to the point where the U. S. A. would cease to be a nation and become merely a state.
- "4. The subordination of our laws to international laws,
- "5. It would grant authority to the World Government to arrest private citizens; to try them in international courts away from their homes, or even their nation.
- "6. It would establish international prisons where *our* private citizens could be imprisoned outside the borders of the U. S. A.
- "7. It would subordinate our nation to a world government whose parliament would be made up overwhelmingly

of representatives from nations that are *Communist, or Communist controlled.*

"8. It would give Russia and her satellites parliamentary and legal authority over American citizens.

"The plan, when reduced to its real essence is *treason*, because it proposes to destroy our national identity and our existence as a nation by handing over to an international cabal the inalienable rights granted to us under our Constitution. It is as vicious as Communism. It appeases Communism and it is more subtle in that it exploits the naive, the visionary intellectual and certain so-called prominent people.

"I prophesy that every member of this Legislature who will vote to uphold this treasonable trick to subordinate our flag, our Constitution and our nation will commit political suicide. It is to be assumed that some who voted for the resolution in the beginning did so without real consideration — *but from now on they have no excuse!*

"I may be old-fashioned, but anyone who votes to put any flag, or any anthem or any law above our flag, our Star Spangled Banner or our Constitution betrays our country!"

The room burst into a pandemonium.

"Are you threatening that we won't be re-elected?!?" demanded Senator Ward.

"I never make threats," I replied; "I merely make prophecies — *which I endeavor to make come true.*"

There was no further talk about bringing the hearing to a close at six o'clock. Instead, it was adjourned until seven o'clock.

Promptly at seven the hearing was resumed. Dr. Wesley Swift, in a 15 minute address delivered a clear and concise . . . *but grim* . . . picture of what will happen to our Country, to our Flag, and to the American people if the Federalists have their way. Nobody heckled him, nobody questioned him — not even O'Gara. I can only presume that, Minister though he is, Swift looked even tougher to them than I did. That concluded the presentation for our side.

Alan Cranston, Northern California Chairman of United

World Federalists, took the floor . . . in the words of Shakespeare, "a lean and hungry looking Cassius." He immediately launched into a long-winded dissertation on the *humane* objectives of the Federalists. "It was the only thing that would insure world *peace*" . . . throughout his talk he sprinkled the word "peace" . . . he oozed "peace" . . . he *leaked* "peace." He glowingly lauded the founders and the organizers of this *great movement* for *peace*. "Yes," he admitted, "we would have to give up our sovereignty; we would have to give up our Army and our Navy . . . we would have to surrender our Atom Bomb." But, he argued, isn't it worth while to give up a *little* of our sovereignty, a *little* of our Freedom and our outmoded Constitution, in order to get the protection of a Federated World Government which would insure *peace*? "Think of all our boys who would be alive today," he finally cried out in a tear-choked voice, "if there had been a Federated World Government in 1939."

At any moment I expected to hear him say that in order to preserve *peace* the Federalists would place a bottle of milk on the table of every Hottentot — *if Hottentots have tables*.

At this point, don't forget what Cord Meyer said in his book as to what they — *and Joe Stalin* — would do with the Atom Bomb once they got possession of it.

Now throughout this entire harangue nobody heckled or interrupted Mister Alan crying-for-peace Cranston. Once or twice, O'Gara and Regan interjected questions *to bolster* Cranston's arguments.

Finally, when Cranston reached the end of his elegy, Senator Tenney took him in hand. But first I must emphasize that throughout all the heckling of the Veterans of Foreign Wars, the American Legionaire and myself by O'Gara, Regan and the others, Tenney never once interfered. But the moment he began to question Cranston they — and O'Gara in particular — stiffened into alert watchfulness.

Tenney's questions primarily, sought to bring out the hypocrisy, the phoneyess and the intended treason in Resolution 26. Cranston parried, or thought he parried, all those questions with a superior smile on his face — and all the Red little

Audreys in the audience gleefully laughed and laughed and laughed . . . and applauded and applauded and applauded without reproach from the Chair — although *our* three women were threatened with ejection when they opened their mouths.

But finally Tenney's questions began to get somewhat hot . . . Cranston began to squirm — whereupon O'Gara broke in heatedly that they weren't there to listen to a lecture by Senator Tenney. That didn't stop Tenney. He opened a sheaf of papers and proceeded to question Cranston about the backgrounds of the founders and organizers of United World Federalists. He named Norman Corwin, Van Wyck Brooks, Mary Ware Dennett, Rex Stout, Elmer Rice, the two Van Dorens, Walter Wanger and others. "Were they among your founders?" asked Tenney. Cranston hesitated . . . he would very much have preferred to say "No," but he finally admitted they were.

"Well," said Tenney, "do you know that Norman Corwin helped to found and organize *fifteen* Red hot Red Front organizations?"

"Well" . . . Crannie stuttered and stammered — "No . . . that is, yes . . . that is . . . I didn't know it was that many."

Tenney continued his questions: did Mr. Cranston know that Upton Sinclair was in *thirty-five* Red Fronts . . . Elmer Rice in 27 . . . Rex Stout in a dozen . . . Thomas Mann in 31 . . . etc., etc.

Cranston's replies became more and more stuttery and stammering. He began to throw appealing looks to O'Gara, Regan and others. *And they came to his rescue!* Their objections to Tenney's questions and Tenney's retorts gave Cranston time to pull himself together and he came up with this brilliant all-embracing answer: It is true that all those Reds Tenney named had been among the founders and organizers of U. F. W. but he *believes* that some of them are no longer in the organization.

But to refute that statement I have a copy of their May 1949 News-Bulletin which lists all their officers and Board Members . . . among them are — just to mention a *few* — James B. Carey, Norman Cousins, Clifton Fadiman, Walter Wanger,

Carl Van Doren, Sholem Asch, William Rose Benet, Charles G. Bolte, Albert Einstein, Raymond Swing, Robert St. John, Harlow Shapley, Senator Glenn H. Taylor, Mark Van Doren — all notoriously flaming Reds and Fellow-Travellers!

That Hearing was finally concluded at ten o'clock that night. As you know — they again voted 7 to 2 in favor of Resolution 26. But I'm here to tell you that those seven men did not sleep easily that night — or any night since. Those seven did not vote for Resolution 26 because they wanted to, but because they had committed themselves too far to retreat . . . Artie Samish had assured Editor Paul Smith . . . *and the Federalists . . . that their Resolution 26 would be passed — and he was there in Sacramento to see that it stayed passed!!!*

This brings our saga of the Reds in Sacramento to a conclusion. But it does not tell what we of the Cinema Educational Guild . . . and all other true Americans who join us . . . are doing to wipe the "California Plan" blot off our State's escutcheon . . . it does not tell how our fight in Sacramento is awakening all America to the treason-plan of "United World Federalists" . . . it does not tell how the Federalists, in panic, and in fear that they may not now be able to hoodwink enough State Legislatures to accomplish their purpose, are feverishly trying to do it in one full swoop by seducing our Congress in Washington . . . *where they have already lined up EIGHTY-FOUR tainted, or sound-asleep Members of the Lower House.*
