"RELIGION" TO CREATE ATHEISM

"Religion" is perhaps the most subtle of all the techniques of the Masterminds of the Great Conspiracy—I will come back to this point in the following pages.

In our "News-Bulletin" No. 110 I provided a crystal clear outline of the frightening Conspiracy, once known as the "ILLUMINATI," now generally known as "THE ESTABLISHMENT," to enslave all of the peoples of the world in a "One-World Government," a Conspiracy that is headquartered in the "House of Rothschild" and is masterminded in the United States by the evil "Council on Foreign Relations" (CFR). This CFR was initiated and launched in 1919 by Jacob Schiff and his stooge, Col. Mandell House—and its present Hierarchy is composed of the Lehmans, Schiffs, Bernard Baruch, Sidney Weinberg and all the so-called International Bankers. And their "elected" and "appointed" stooges in Washington range, and have ranged, from Woodrow Wilson, Franklin Roosevelt, Truman, Eisenhower, Kennedy, Johnson, Dean Acheson, the Dulles boys, Alger Hiss, McNamara, the poisonous Earl Warren and the other eight "Old Men" on the U. S. Supreme Court, etc., etc.

THEIR VARIOUS TECHNIQUES

As I explained in No. 110, several of the chief techniques of the Masterminds are . . . 1) Absolute control of our Money system and property rights, which they accomplished with the 16th Amendment . . . 2) Dupe the Negroes to create anarchy and terrorism throughout the nation—this was *clearly* revealed in great detail in our "News-Bulletin" No. 108 and earlier "Specials" and "Tracts" . . . 3) Destroy all respect for Law and our Police, national and local, via the slogan "Police Brutality," every time the Police try to prevent so-called "non-violent demonstrations" by Negro Mobs of Looters, rioters, rapists and murderers . . . 4) Complete "DISARMAMENT" of the nation — and simultaneously deprive all White Americans of all self-defense firearms — *regardless of our Constitutional rights to possess arms for our own defense*. I also revealed the plot to turn our Armed Forces and Nuclear Armaments over to the UN. I also revealed the story of the UN "invasions" (to test the spirit and resistance of the American people to a complete take-over by the Conspirators) of various small cities in California, Texas and other states by so-called "United Nations" Armies—composed of American soldiers provided by the Pentagon—on orders from the White House!

So-called "LABOR" is another of their techniques. The idea is to keep the working men in turmoil with constant demands for

increased wages, fringe benefits, sick benefits, strike funds, etc. Knowing that the average working man is naive and quickly responds to "Leaders," the "Masterminds" have developed such "Leaders" as Sidney Hillman, Walter Reuther, the most vicious of the lot, James B. Carey, Harry Bridges, and other so-called "Labor" leaders, to create turmoil on top of turmoil—and the stooges in Washington have set up what they call the NRLB ("National Relations Labor Board") to back up the "Leaders." One of their chief objectives is to outlaw the "Right to Work" Laws in ALL our States—and to finally enslave ALL of our working people within a nationwide "Union," which, on a given signal, will paralyze the entire nation with a so-called strike.

Now, in all fairness to the men and women who compose the rank and file of "LABOR," I state, without any mental reservations, that the vast majority of them are totally unaware that by carrying out the pleas and ORDERS of their "LEADERS" they are unconsciously doing their utmost to destroy the freedoms of our nation—that they are (*again, unconsciously*) robbing their own children of the heritage provided for them in our Constitution. They swallow the speeches and exhortations of their "Union Officials" with the same naivete that the vast majority of the American people swallow what they read in our (*CFR controlled*) Press and what they hear in the similarly *CFR controlled* Radio, TV and Motion Pictures. The "Union Leaders" tell their members that they are fighting all "Right to Work" laws on the grounds that all working people who support Legislators who insist on *freedom* to choose the right to work as they see fit are selfish and greedy "parasites" who simply don't want to pay their share (*dues*) to Unions to secure "better working conditions" and better wages. *All of this is a monstrous lie!*

Here is a suggestion for all loyal American working people: Stop to think and find out who your "Union Leaders" are—and their real objectives. Among the current TOP "Union Leaders" we have the brothers Reuther (*Walter and Victor*), who spent years in Russia to absorb all the Communist techniques, and who are on *official record* as having stated that they came back here to "sovietize" America — Harry Bridges, an Australian, whose background reeks of affiliation with Reds and Red activities — A. Phillips Randolph, an outright Negro Red, and others of that ilk . . . find out how many MILLIONS of YOUR "dues moneys," ostensibly accumulated for "Strike benefits," "Sick benefits," etc., etc., those "Leaders" have "contributed" to Red Fronts, to the LUCIFER Kings and other would-be saboteurs of our nation—find out how many MILLIONS of your "dues moneys" they have siphoned off to enrich themselves—and to finance various illegal operations, and then decide if you should continue to support a *direct* plot to destroy the freedoms of our nation.

By all means, organize yourselves into *personally protective Unions*, but make sure that the men you appoint as your "Leaders" are honest men and loyal Americans who will work to preserve your freedoms and the safety of our nation—not men who are dedicated to transform LABOR into an instrument for Conspirators who are determined to carry out the objective of enslaving the whole world within a "One-World (UN) Government"—find out why the Roosevelts, the Kennedys, the Johnsons and Humphreys are always supporting and catering to so-called LABOR and to "The Americans For Democratic Action."

In these very days Johnson is frenziedly pressuring Congress for a "Work Law Shakeup"—pushing for CLOSED Union Shops in the very (19) States which have rigid "Right to Work" Laws. If he succeeds in forcing Congress to repeal the "Taft-Hartley" Section 14B it will mean the loss of all such freedoms as the right to hold a job in one's chosen profession, except by the consent and the sufferance of a Labor Union. Why is this man Johnson so frenziedly seeking to rob you professionals and working men and women of that freedom? WHY! ! ! Ask yourselves that question—and then tell your Representatives and Senators, *the men YOU voted into their jobs*, in no uncertain language, that you demand that they STOP Mister Johnson!

In several of our BULLETINS I have fully revealed how the CFR has acquired complete control of all of our Mass Communications Media, so I won't repeat that "technique" in these pages. I have provided the names of the "Heads" of our TV Networks, of Radio, of Hollywood and of the (*brainwashing*) Press—and how all the "news" is "managed."

Just to show how the "news" is "managed" and slanted—I will cite one significant case of how TV deliberately "covers up" the facts: recently the press carried a detailed story of the student riotings at the Berkeley (*California*) University—and stressed the leadership by one Mario Savio. The press story revealed how one TV Network financed a tour of several cities for this Savio—*ostensibly* to tell his story on the TV stations owned by that Network—but, according to the story in the press, they also arranged to have the same young saboteur address student gatherings on the Campuses of Universities in those same cities. On its 7:00 P.M. News-hour that same Network repeated the press story of Savio's vicious activities at Berkeley, but they left out the details of Savio's activities in the cities in which he appeared on their TV stations—which, to express it mildly, is *very significant*. WHY did they hush-up that feature?

Another vital technique of the American branch of the One-World

Conspiracy (*the CFR*) has been to acquire control of our Judiciary—particularly the U.S. Supreme Court. We devoted several of our “*News-Bulletins*” and “*Tracts*” to that technique. All the men on the U.S. Supreme Court are appointed by the President, with the supposedly *free* approval of the Senate. Since the days of Franklin Roosevelt, all the men on the U.S. Supreme Court (*and all the Federal Judges*) have been appointed by the President. Without any mental reservations, I can say that, *with only two or three exceptions*, the men on the U.S. Supreme Court Bench are not fit to “*judge*” and/or render “*Decisions*.” Most have had no judicial experience whatsoever—and most have less *legal* learning about our Constitution than some of our lesser members of the Legal profession. All of them were “*appointed*” to serve the objectives of the One-World Conspiracy. Let’s take Felix Frankfurter as one of the earliest examples: his principal “*job*” was to infiltrate outright traitors into positions in our State Department and other Federal Agencies where they could best advance the objectives of the Great Conspiracy—all of his proteges in those posts were commonly known as Frankfurter’s “*Hot Dogs*” . . . *one of them was none other than ALGER HISS!*

Without wasting time or space on any of the other “*Nine Old Men*,” let’s come to one who has been out-Frankfurtering Felix—I refer to Earl Warren, now our Chief Supreme Court Justice: In Warren we have a man who has had no judicial experience whatsoever. Virtually, his entire legal experience was that of a Prosecutor in one of California’s northern counties. A political opportunist, he courted the favor of former Senator Knowland’s father, who owned a powerful newspaper and was a power in politics, and thus landed in the Governor’s Mansion in Sacramento. Always, a rabid Leftist, in 1948 he was fully aware of the “*United World Federalists*” (UWF) plot to seduce the California Legislature (*also other State Legislatures*) into *secretly* passing a “*Resolution*” to memorialize Congress into transforming the United States into a unit of a One-World Federated Government to be governed by the U.N. He knew of the “*tons of money*” being poured into Sacramento to bribe State Senators and Assemblymen to pass (*secretly*) that “*Resolution*”—he knew that the infamous Lobbyist, Art Samish, was the UWF’s paymaster. He (Warren) not only did nothing to expose that plot, but, *by something more than mere innuendo*, proclaimed that Samish was the real “*boss*” of the California Legislature. When the “*Resolution*” was finally (*secretly*) submitted for passage, he, Warren, could easily have exposed the plot *and vetoed* it—but he remained completely silent. And when we (CEG) launched the fight to expose the plot and force the rescission of the “*Resolution*” he and his stooges threw every possible obstacle in our efforts. He then joined with Tom Dewey, Henry Cabot Lodge and others of that ilk to

rob Taft (and Gen. MacArthur) of the Presidential nomination. In return, he was promised—and was given—the post of Chief Justice of the U.S. Supreme Court—and right from the outset he began to issue “Decisions” favoring the Communist Conspiracy. He reversed State Court Decisions and findings—he freed convicted murderers, rapists and Communist saboteurs—he “legalized” travel to Communist nations, etc., etc. But the most reprehensible of all his deeds was an “investigation” of the assassination of Kennedy. His appointment to head the “Investigation Committee,” composed, in the main, of Leftists, came at the behest of the Communist Party—and the Communist “Worker” press!

In fact, this book is so vitally informative and expository that I URGE you to get a copy—indeed, I urge you to get a dozen copies and get them into the hands of all your friends and neighbors — it will SHOCK them; MCF.

As I have stated, in various of our issues I have described many of the vicious and actual criminal “techniques” employed by the hierarchies of the “Great Conspiracy,” but perhaps the most vicious of all is their “technique” to seduce the men of Religion—*Ministers, Priests, Churches* — to promote the Atheism that is such a demoralizing influence on the minds of the men and women AND GROWING CHILDREN who normally are loyal Americans and true Christians—their organized “National Council of Churches” (NCC) is their prime and most reprehensible instrument to achieve that objective . . . and this NCC sacrilegiously calls itself “The National Council of Churches of Christ!” Imagine that!

However, before going into that detail, I wish to clarify two or three matters that seem to confuse some of our readers: 1) In one of our recent issues I stated that I was glad that I was not born in the State that produced a Lyndon Johnson—and a few Texans have assumed that it was a slur on the fair name of their State. Here let me state without the slightest reservation that it was not so intended. I have always had a very high admiration and regard for Texas. I consider it, *always have*, to be one of our greatest and most loyal States. So when I said “I am glad I was not born in the State that produced a Lyndon Johnson” I was really expressing sorrow that that fair State has to bear a stigma that certainly is not its fault—and I happen to know that many, *many* loyal Texans feel the same way

about it, and fully understand the true sense of my statement.

2) In our most recent "Tract," entitled "MARTIN LUTHER KING and his 'CIVIL RIGHTS' URINATORS," I reported how, *on a given signal*, some 75 of the "marchers" in Alabama urinated on the sidewalks — also, that in a number of restaurants, groups of Negroes, *to show their defiance*, urinated into the sugar bowls on the tables of those eating establishments. Since issuing that "Tract," we have received a few, *not many*, demands for documentary proof and films of those horribly disgusting and criminal deeds. For those demands I have only one answer: for a very vital reason, we rigidly refuse to reveal the sources and names of our informants and research workers. We do this in order to protect our informants from vicious retaliations by the "Enemy." To prove that point, an Alabama newspaper happened to name *one* restaurant in which that outrageous "sugar bowl" incident took place—within two days that restaurant was virtually demolished by Negroes—and the authorities (*Federal Marshals*) did not lift a finger to protect that property, or to punish the perpetrators. Anyway, a careful reading of our "Tract" provides sufficient "documentation" that leaves very little to imagination—or doubt.

"RELIGION" MOST POTENT CFR INSTRUMENT! ! !

The first and most frantic objective of the GREAT CONSPIRACY was to use "Religion" and the Man of the Cloth to delude and deceive the true Christians into non-belief in God—and create Atheism . . . *and it is truly amazing how successful they have been.* Their most effective instrument to accomplish that objective in the United States is the previously mentioned "National Council of Churches" (The NCC). The World Council of Churches is doing this job throughout the world, but at this point I will concentrate on the NCC.

From the day that I was born, so to speak, I accepted the Man of the Cloth as my spiritual guide in my faith in God. I had no quarrel with "Denominations." I didn't care whether the Man of the Cloth was a Catholic, or a Baptist, or a Methodist, or an Episcopalian, etc. I felt and believed that all their roads to God were more or less identical. I easily understood why the Jew refused to accept Christ, but I didn't "hate" him for it—I truly pitied him, because I knew that throughout the centuries *his* MEN of the Cloth inculcated an unreasoning hatred of Christ in all of their succeeding generations. I accepted the Mohammedan's refusal to accept Christ as a Divinity—but, at least, they *did* respect Him as a true "teacher." I have always felt the same way about all the other "Religions." But what did begin to sicken—and enrage—me was the

sight of the men who took the Cloth of Christianity—only to use it to bemuse the people of their Church into doubts about the MAN who created Christianity for the salvation of the soul—and to bring politics and Racial discords into their pulpits. And that brings us to the most vicious and most sacrilegious group of all of the “*Cloth*,” the . . .

NATIONAL COUNCIL OF CHURCHES

●

First, to avoid all misunderstandings, I completely agree that the various churches of each Denomination should be organized, both state-wide and national—on condition that the Hierarchies of the various organizations be composed of the proper kind of men and should zealously adhere to the one supreme function of Christian guidance. They must keep the pulpit free of politics and of propaganda. The Minister is a servant of God—and his job is to guide his congregation in the observance of their obligations as the children of God. When I see a Denomination, whether Methodist, or Presbyterian, or Baptist, or even Catholic, set up Political, Racial, or so-called “*Liberal*” groups, I lose all my confidence in that Denomination—and in the individual Pastors who neglect their religious duties to join with such groups. I have a feeling that they are not to be trusted with leaderships of their flocks.

Now, insofar as the “*National Council of Churches*” is concerned, it is my contention that they are definitely not concerned with religion, but are instruments of the Masterminds of the Great Conspiracy to promote the atheism that is to destroy Christianity—and *transform the whole world into a Godless One-World community!*

To prove that point, I will quote some passages from statements by Rosalind Frame, Executive Director of “DOORSTEP SAVANNAH, Inc.,” an organization created to educate the public through an American program on Radio and TV. The text of one of the DOCUMENTED programs she *tried* to present concerned the “*National Council of Churches*.” Mrs. Frame’s program was to have consisted of poems and statements issued directly by the NCC—*so there was no doubt of the accuracy of her program!*—But the Moderator of the Radio Station considered her intended “*quotes*” as “*improper*” and “*against the policies of the national Radio networks.*”

Furthermore, various programs, such as “*You’re on the Air*” usually accepts telephone questions—but virtually every question that inherently protested “*racial demonstrations*” or “*Civil Rights*” was either ignored, or distorted, or completely deleted. And this is true not of any one particular Radio or TV Station, it is true of the *vast*

majority of Stations, particularly those that are owned and/or controlled by *all* the National Networks.

Strangely, *yet perhaps not so strangely*, because so many, many loyal Americans are still brainwashed by what they read in the press or hear on Radio and TV—and from some of their Pastors, many people ask: “*Have Communists really infiltrated the “National Council of Churches?”*”

It is utterly impossible to describe in any *one* of our issues the extent to which such infiltration has taken place, but as one bit of *documented* proof, I will quote from a “*training manual*” issued by the United States Air Force:

“Does any sizable group of Americans ever fall for the Communist line, you may ask? Unfortunately, the answer is ‘Yes.’ On 3 June 1959 an editorial appeared in a large daily newspaper which first of all provided the following background . . .

“‘Terror, torture, the murder of 30,000,000 people. Those are the sickening facts of the methods used by the Communist rulers of China to make their people a faceless, mindless, souless, mass harnessed to the state’s use.

“‘The details of the Chinese Reds’ suppression of humanity have been revealed by the House Un-American Activities Committee, which has heard testimony by religious leaders of Asia. The Red campaign has been using every weapon at hand to wipe out Christianity among the Chinese, the missionary witnesses reported.

“The editorial then went on to recount the fact that the governing bodies of prominent Protestant church groups had just called for ‘mutual understanding’ with Red China . . . and had urged that the Peiping regime be recognized by the United States and admitted to the United Nations.” The editorial concluded:

“It makes us wonder what kind of dream-world wishful thinking dominates the General Assemblies of such Church groups.

“There is something topsy-turvy about the guiding bodies of Christian churches asking that the U.S. and the world clasp the bloody hand of a regime which seeks to exterminate Christianity.

“The implications of this editorial are clear—Communists and Communist fellow-travelers and sympathizers have successfully infiltrated into our churches. The foregoing is not an isolated example by any means; it is known that even the pastors of certain of our churches are card-carrying Communists! The extent of Communistic activities in religious groups is further detailed below.

“Communism in Religion: From a variety of authoritative sources, there appears to be overwhelming evidence of Communist anti-religious activity in the United States through the infiltration of fellow-travelers into churches and educational institutions.

"The National Council of Churches of Christ in the U.S.A. officially sponsored the Revised Standard Version of the Bible. Of the 95 persons who served in this 'revision' project, 30 have been directly affiliated with pro-Communist Fronts, Projects and Publications.

"In its own brochure, the NCC listed the names of the Revision Committee and the Advisory Board. Among these were Walter Russel Bowie of Grace Church, New York; Henry J. Cadbury of Harvard University; George Dahl of Yale University; Frederick C. Grant of Seabury-Western Theological Seminary; Leroy Waterman of the University of Michigan. ALL of these men were affiliated, for one example, with the 'National Federation for Constitutional Liberties' (NFCL).

"The House Committee on Un-American Activities officially reported: 'The NFCL is one of the viciously subversive organizations of the Communist Party.' "

To leave nothing to imagination, all of the above-named men, Bowie, Cadbury, Dahl, Grant, Waterman and another man, Fleming James, also a member of the Bible Revision Committee, have together been cited for affiliation with Communist Fronts a total of 198 times . . . *and these are the atheists who were chosen by the "National Council of Churches" to revise our Bible!!!*

Now, once again, I will quote from the Air Force Training Manual:

"Dr. Harry F. Ward, long a recognized leader in the National Council of Churches, was a Professor of Christian Ethics at Union Theological Seminary in New York City for some 25 years, during which time he influenced thousands of theological students. Dr. Ward was identified by Louis Francis Budenz (an ex-Communist) before the Senate Internal Security Sub-committee as a member of the Communist Party. Ex-Communist Leonard Patterson testified that Dr. Ward, himself, Earl Browder and others were assigned to a top policy-making body of the Communist Party. Ex-Communist Manning Johnson referred to Dr. Ward as the 'Red Dean of the Communist Party in the religious field.' To show the thinking of Dr. Ward, in a radio broadcast on May 21, 1954, he stated: 'The Soviet Union is progressing and growing up economically and politically since the time of the Czars, while capitalist society is starving and going down.' Neither Dr. Ward nor his works have been repudiated by the Union Theological Seminary, an interdenominational seminary highly rated in National Council circles."

To show how frenziedly the Communists keep trying to infiltrate our Churches, Karl Prussion, the famous counterspy for the FBI, recently reported that the Communist Party in Michigan tried to recruit him to the Protestant Ministry while he was a student at Wayne University. He said he was assured that Dr. Ward, head of the Union Theological Seminary would make all arrangements for him to enroll as a student at the Seminary—*Naturally, for the*

purpose of serving the Great Conspiracy! Bearing in mind the frenzied efforts of the NCC to force the U.S. to recognize Red China and admit it into the UN, I feel it necessary to include a further "quote" from the U.S. Air Force Manual, to wit:

"In a sworn statement before HUAC, in March 1959, Rev. Shik-Ping Wang, East Asia Director of the Baptist Evangelization Society International, described at some length the Commune system instituted in Red China, to wit:

"The family unit is broken up. Husbands and wives are separated into different barracks. The children are taken away from the parents and placed in government-run nurseries. Husbands and wives may meet only once a week for two hours—they have no other contact. Because these places of meeting are few, couples must stand in line at the special rooms waiting their turn. After they have finished, they must report to the commune group leader to tell the date and time and how long they stayed together. They must also report what they said and did together. The parents may see their children once a week and when they see them they cannot show affection toward the children. The idea is to have the children and the family sever their affection and direct it toward the state. Names are taken away from the children and they are given numbers. There is no individual identity. The basic unit of social life in the commune is the commune itself.

"Reverend Wang was questioned further by the interrogator for the House Un-American Activities Committee: 'Do families try to meet at other times between the approved once-a-week meetings?' In reply, Reverend Wang stated: 'They cannot meet because they are not consigned to the same place and do not have freedom to travel. They come to work in a group, eat in a group, work in a group and return in a group. There is no opportunity for individuals to get away and see their families. Husbands and wives are placed on different communes. Travel between communes is only possible if the traveler has a pass. There is no contact between the once-a-week meetings.'

"The commune system," the Reverend Wang continued, "is destroying morality in Red China: There is no morality because the love of the family is taken away. There is no honesty and respect among men or between men. There is no human dignity: they are all like animals. There is no guilt associated with murder of individuals for the improvement of the state. In Communist Party circles, a woman must submit herself to any Party member who desires her favors. If the woman refuses a Party member, she may be thrown into jail or stripped and nailed to a wall until she dies. Another punishment is to cut the breasts off the woman who refuses.'"

This Air Force Manual report consists of 20 pages of facts—many are terrifying; all are documented truth. It ends with this paragraph of advice to the man in the Air Force:

"From all of the foregoing, you can judge for yourself how much you must be alert, and how carefully you must evaluate any conversation, speech,

article, sermon, or book, advocated by the NCC, which you may have occasion to hear or read if the subject touches adversely upon any aspect of the American way of life—our religions, our morals, our social lives, or our political and economic institutions. We believe in the dignity of man—of the right of every individual to choose his manner of living, of worship, of his occupation, in short, everything that he does, so long as the rights of other individuals are respected. In contrast, the Communists believe the state to be supreme—in individual lives, in family life, in morals, in religion, in government and in the economics of making a living.”

And here is a very significant point: On February 11, 1960, James Wine, Associate General Secretary of the “*National Council of Churches*,” addressed a letter to the then *Secretary of Defense*, Thomas Gates, enclosing a copy of this Air Force Training Manual, complaining that the manual was in “*patent contravention*” of the first amendment of the Constitution of the United States. Dudley Sharp, Secretary of the Air Force, testified he had “*immediately started an investigation but found that the manual had been withdrawn on the morning of the same day that James Wine wrote his letter.*” What influence and unseen power could have sufficient force to command immediate withdrawal of this manual?

Does Congress know about it? If not, why not? ASK YOUR CONGRESSMAN! *Or are you willing to accept the Red Chinese Commune way of life?*

It is interesting to note here that this same former Secretary of Defense, Thomas Gates, is a member of the *Council on Foreign Relations*, part of the Invisible Government in America, an organization dedicated to a one-world socialist system and to make America a part of it.

It is the reference to the Revised Standard Version of the Bible that particularly stirred the wrath of the leaders of the “*National Council of Churches*;” yet, strange as it may seem, *they never challenged the factual material offered in the manual concerning the Communist-front identities of 30 of the 95 translators.*

The “*National Council of Churches of Christ*” in the USA was created in 1950, with headquarters in New York, with a budget of 13 million dollars. They took churches into its membership without consulting various parishes or priests. They cover 35 denominations.

The Revised Standard Version of the Bible, copyrighted by the NCC, was presented to the public with much fanfare on September 30, 1952. Three thousand, four hundred rallies were held under the auspices of the NCC. *These celebrations occurred before the public had an opportunity to examine the Bible.* This Revised Standard Version, or modernized Bible, has fundamental changes that

many leading theologians claim "reinterpret" the role of religion, demoralizing the church by injecting something that does not belong there, and bringing about confusion and contradiction. This modernization eliminates from the actual text:

1. THE VIRGIN BIRTH, INFERRING THAT OUR BLESSED MOTHER WAS JUST ANOTHER WOMAN — THAT HER DIVINE SON WAS NOT CONCEIVED BY THE HOLY GHOST, IN EFFECT THAT JESUS CHRIST WAS NOT THE SECOND PERSON OF THE HOLY TRINITY; THAT HE WAS MERELY A PROPHET.

2. CONSISTENT REFERENCES THROUGHOUT THE KEY PASSAGES IN THE OLD AND NEW TESTAMENT REVEAL THAT THE NCC TRANSLATORS REMOVED OR TONED DOWN REFERENCES TO CHRIST'S DEITY. THE EFFECT OF THESE 1800 REVISIONS INCLUDES THE DENIAL OF THE FUNDAMENTAL TEACHINGS OF CHRISTIANITY.

The Air Force Manual uproar also brought to life a very interesting pamphlet published by the "*Department of Racial and Cultural Relations*" of the "*National Council of Churches of Christ*" in 1957. On April 20 (1957) the then Congressman, Donald Jackson, of California, took the floor in the House of Representatives and read into the Congressional Record a long expose of the pamphlet. Jackson's devastating expose of the type of books recommended in the National Council's reading list of some 260 titles stressed that these titles were selected after elimination of many more because they "*are safe to recommend for children.*" The following well-known Communists, veteran Communist-fronters, or fellow-travelers, were authors recommended by the NCC:

"Victor Perlo, W. E. B. DuBois, Gene Weltfish, Benjamin Botkin, E. Franklin Frazier, Ruth Benedict, Eleanor Lattimore, Bucklin Moon, Herbert Aptheker, Shirley Graham, Langston Hughes, Alan Lomax, Gunnar Myrdal, Margaret Halsey and Benjamin Mays.

"Perlo has been identified in sworn testimony, not only as a Communist, but a member of a Soviet spy ring . . . Aptheker is one of the chief theoreticians of the Communist Party and editor of one of their leading magazines, 'Political Affairs' . . . Dubois has one of the longest front records ever achieved by an American . . . His wife (Shirley Graham) has also been identified as a Communist Party member."

Congressman Jackson concluded that several of the NCC's recommended books contained passages so lewd and shocking that he could not conceive "*that any man who wears the Cloth of any church in this country can read these lines without repugnance.*" Incidentally, the particular books we have just mentioned are so obscene that some of them are forbidden to be sent through the mails. *Strange business for so-called churchmen to engage in!*

Another author the NCC highly recommends for reading is the identified Communist, *Langston Hughes*. They recommend six of

his books for reading. I shall quote from his so-called poem, "Goodby Christ" in order to give you an idea what kind of sacrilegious tripe this author writes:

"Listen Christ, you did all right in your day, I reckon, but that day's gone now. They ghosted you up a swell story, too; called it the Bible, but it's dead now. The Popes and the preachers've made too much money from it. They've sold you to too many kings, generals, robbers and killers; even to the Czar and the Cossacks; even to Rockefeller's church, even to the Saturday Evening Post. You ain't no good no more. They've pawned you till you're done wore out. Goodby. Christ Jesus Lord God Jehovah, beat it on away from here now. Make way for a new guy with no religion at all—a real guy named Marx Communist Lenin Peasant Stalin worker, me — I said, me; go ahead on, now. You're getting in the way of things, Lord, and please take St. Gandhi with you when you go, and St. Pope Pius, and St. Aimee McPherson and big black St. Becton of the consecrated dime. And step on the gas, Christ, Move. Don't be so slow about moving. The world is mine from now on and nobody's gonna sell me to a king, or a general, or a millionarie. Goodby Christ, good morning, revolution."

And this is the kind of writing and "religion" the NCC eulogizes and endorses!

Space limit forbids my going into detail on many subjects, such as the NCC's sponsoring the breakdown of neighborhoods on behalf of Negroes (*a fact every real estate man should find interesting*); the NCC's request to the Clergy that they not show the J. Edgar Hoover sponsored film, "Operation Abolition," presented as *documentation* by our House Committee on Un-American Activities; the establishing of bail bond for demonstrators, some of whom don't believe in God. There are literally dozens of shocking practices to which the NCC are instigators (*or are party to*), which benefit our enemy, the Communists. Gus Hall, ex-convict head of the Communist Party, USA, outlined the building block voting in America, saying:

"The Communist Party can depend on the NCC and their affiliated churches to carry out Objective No. 4. Dr. Eugene Carson Blake and Martin Luther King have this well in hand."

Do the people in the pews endorse this activity in their church?
Do you want your innocent children to accept such principles?

Eight months ago, a study of the "National Council of Churches" was made by the *Staff of a Southern State Legislative Commission*. This report begins with the following paragraphs:

"The National Council of Churches of Christ in the USA has set itself up as promoter, director and screening committee for racial demonstrations in the South during this summer.

"The NCC, on June 7, 1963, set up a Commission on Religion and Race 'to engage the churches more directly in the present racial revolution.'"

"The Commission, with the assistance of the Lawyers Committee for Civil Rights under Law, were able to secure the services of a national lending company for the first time, to put up money for (bail) Civil Rights cases in Mississippi . . ."

"Currently, in cooperation with local and state councils and churches, teams of Civil Rights and Religious Leaders are touring six mid-western states . . ."

Nearly five pages of this seven page report quotes the actual words of the "National Council of Churches." That State Legislative Commission has this to say:

"The NCC and its racial committee will be promoting, directing and helping to finance racial demonstrations this summer . . . approves, fosters and urges the breaking of laws which it considers to be unjust; that students are being hired off college campuses to lead the invasion of Dixie."

Should anyone doubt the last statement, the Alabama Legislature Commission has a copy of an uncanceled check made out for \$336.85 by the National Council of Churches for the purpose of "grant" for students participating in student-interracial ministry program.

This Alabama report also quotes Richard Arens, one time Staff Director of our Government Investigating Committee, the House Committee on Un-American Activities; to wit:

"Thus far, of the leadership of the National Council of Churches of Christ in America, we have found over 100 persons in leadership capacity with either Communist front records or records of service to Communist causes. The aggregate affiliations of the leadership, instead of being in the hundreds, as the chairman first indicated, is now, according to our latest count, into the thousands, and we have yet to complete our check, which would certainly suggest, on the basis of the authoritative sources of this committee, that the statement that there is infiltration of fellow-travelers in churches and educational institutions, is a complete understatement.

"On October 15, 1953, the NCC held a testimonial meeting at Carnegie Hall to honor Dr. Harry F. Ward on his 90th birthday. Dr. Ward, founder of the Methodist Federation for Social Action (officially identified as a Communist front) was long active with the NCC and its predecessor, the Federal Council of Churches. He has been officially identified as a member of the Communist Party; was a close friend and confidant of Eugene Debs, Founder of the U. S. Socialist Party, and William Z. Foster, head of the Communist Party of America. He was head of Union Theological Seminary for many years and is credited with influencing many ministers toward his 'Social Gospel' and the Communist Party." . . . The report further states:

"In 1961 the United Youth Movement of the NCC published a pamphlet by William Cole Graham, called 'The Meaning of Sex in Christian Life.' In

slang expressions, this pamphlet virtually advocates the flouting of sex standards by unmarried teen-agers, and endorses their revolt against such standards." To quote from one paragraph of the pamphlet:

"Our culture declares that all sexual activity within marriage is legal, proper and good, while any such activity outside marriage is illegal, sinful and wrong. This is to ignore the personal dimensions of life, to seek to force everyone under massive legal umbrella. You know and I know perfectly well that there are many marriages that are simply matters of convenience, that such sex as goes on within them is selfish, exploitative, and evil. We know further, that there is sexual contact between unmarried couples that is motivated by love and which is pure and on occasions beautiful."

Such filth and corruption! However, this is not found in a smutty, pornographic book — it is found in a publication of the "*National Council of Churches*," a so-called religious organization, which is advocating the breaking of the Ten Commandments. The Alabama Legislative Commission summarizes the NCC report with the following:

"Contrary to popular belief, The 'National Council of Churches' does not operate as a 'Super Church' and is more of a political pressure group than a religious federation. It maintains a strong lobby in Washington. It is deep in political meddling and social irresponsibility, as shown by its clear history, and enjoys the status of a tax-exempt institution. It was active in support of abolishing public prayer in schools . . . Further proof of its deep and direct involvement in the often violent and always lawless social demonstrations has just been furnished this Commission by Police Chief Virgil Stuart, of St. Augustine, Florida. Police there obtained documented evidence that the financial backing for the demonstrations was sent to St. Augustine in large money-orders by the NCC from its National Headquarters. Cashier checks, in the amount of nearly six thousand dollars were sent back unused to the NCC from St. Augustine . . . The conclusions are clear. The citizens who support their churches from a feeling of reverence and responsibility, are also being unwittingly used by the NCC in its attack on racial integrity and individual freedoms in the South."

Another man, Manning Johnson, once a top Communist official, had something to offer along these same lines in his testimony during the investigation of Communist Activities in the New York area. He had this to say:

"Once the tactic of infiltrating religious organizations was set by the Kremlin, the actual mechanics of implementing the 'new line' was a question of following the general experiences of the living church movement in Russia where the Communists discovered that the destruction of religion could proceed much faster through infiltration of the church by Communist agents operating within the church itself . . . In the earliest stages it was determined that with only small forces available it would be necessary to concentrate Communist agents in the seminaries and divinity schools. The

practical conclusion, drawn by the Red leaders, was that these institutions would make it possible for a small Communist minority to influence the ideology of future clergymen in the paths most conducive to Communist purposes . . . The Communists had some small forces in the seminaries and under the leadership of Harry F. Ward . . . The plan was to make the seminaries the neck of a funnel through which thousands of potential clergymen would issue forth, carrying with them (in varying degrees) an ideology and slant which would aid in neutralizing the anti-Communist character of the church and also to use the clergy to spearhead important Communist projects. This policy was successful beyond even Communist expectations. The combination of Communist clergymen, clergymen with a pro-Communist ideology, plus thousands of clergymen who were sold the principle of considering Communist causes as progressive, within 20 years, furnished the Soviet apparatus with a machine which was used as a religious cover for the overall Communist operation ranging from immediate demands to actually furnishing aid in espionage and outright treason . . . It is my conviction, as a former leader of the Communist Party, that those who lead our Nation must expose this plot and the Communist pattern of operation within our churches." . . . Do we need any more proof that the Communists have had more success in the past 20 years, through infiltration of the churches, than they ever dreamed could come to pass. *Can you name any single religious group which has furthered the Communist conspiracy more than the National Council of Churches?*

I will conclude my review of the NCC with the following information: Archbishop J. Toolen, of Mobile, Alabama, recently delivered an address in which he excoriated all men of the Cloth who participated in that horrifying Alabama "March," but he particularly "laced" into the 200 Catholic Priests and Sisters (Nuns) who joined in that "March" . . . "Why did those Priests and Nuns come from other states and Canada to take part in those demonstrations?", he asked: "Certainly the Nuns are out of place in such demonstrations. Their place is at home, doing God's work. The same is equally true of the Priest and the 600 or more Protestant Ministers. Priests and Nuns are required to ask permission to take part in such demonstrations. They came without requesting such permissions . . . does that mean that they simply complied with a demand by the NCC? . . . does that mean that the more than 600 Protestant Ministers came because of their membership in the NCC" . . .

But, really, is either question necessary? And bear in mind, all those "Men of the Cloth" helped to recruit many of those "out of state" Alabama Marchers and Urinators!

WHO PAID THE BILLS

Here is even more significant proof that the NCC (a Church Or-

ganization?) is a conscious nest of traitors not only to the Cloth, but to the American people who provide them with the money for their treason activities.

In one of our recent issues I revealed that the 30,000 "Demonstrators" in the Alabama atrocities were, *in the vast majority*, outsiders lured there by offers of \$10.00 a day, plus room and board—and free sex orgies. Aside from the "Clergy" the vast majority of those outsiders were beatniks, brainwashed students and actual prostitutes. All this was confirmed by a United States Congressman and other highly reliable observers. Now, just the \$10.00 per day for those 30,000 demonstrators for that period of 10 days amounted to *three million dollars*, and that does not include the costs of room and board and travelling expenses. It is quite safe to assume that the total cost ran considerably beyond *five million dollars*.

Now, by *anybody's* calculation, that's "a heap of money." Where did it come from? "Lucifer" King would have us believe that all of it came as "free will offerings." Wherever he "preaches" or speechifies, he insists on three collections of "freewill offerings" before he starts his "sermons" and/or "orations." But no matter how great or small those "collections" from his, *mostly impecunious*, negro contributors, the total was an infinitesimal drop in that five-million dollar bucket. He also urged all the negroes to withdraw their meager savings (*those who had any savings*) from their banks and turn all their "valuables" into cash, so as to enable him to "carry on the fight for their rights." It is true that he also received contributions from such as Walter Reuther, Harry Bridges, Jim Hoffa, and other so-called Labor Leaders, who rob their tax-exempt Union funds to help spread chaos and communism throughout the Land. Also contributions from tax-exempt "so-called" Foundations. But all of that comprised at most a few drops in that "five-million dollar bucket." The truth of the whole matter is that much, *very much*, of that Alabama "demonstration" was financed by the "National Council of Churches" and their member pastors, who exhorted their congregations to "donate" for that "March." Now, where does the NCC get that kind of money? *From its member churches*, who siphon off YOUR contributions to help the NCC to use "religion" to spread atheism throughout the nation? Thus, most of that money came from you and you and you, who, "out of the goodness of your hearts" are *unconsciously* aiding and abetting the "Civil Rights" hoax.

Now, if you think that the above statement is an exaggeration, go back into the earlier pages of this "Bulletin" and study the names of the "Men of the Cloth" I have named — study the deeds of "Rev." Ward through all the years of his administration of his organization — study the deeds of Bromley Oxnam during his years of his "Kingship" of the Methodist Church, of Bishop Pike, of Bishop Kennedy, of other Bishops and Ministers of that ilk.

To provide concrete evidence of the apostasy of such "Religious Leaders," I urge you to read what I reported in our "News-Bulletin" No. 108, on page 19, about Bromley Oxnam; in that paragraph, I quoted, *verbatim*, a statement Oxnam made to his late mother-in-law, Mrs. Elizabeth Fisher, that "*Christianity is a myth, and Christ was a faker and a phony.*" . . . and in the same breath he eulogized Communism!

An appraisal of the other Bishops, such as Kennedy, who endorse and support the "NCC," places them in the Bromley Oxnam category, all of them using their high places in the "Cloth," all spouting Christianity, all serving as pied-pipers to lead their flocks into atheism. Now, let's take the lowlier "Men of God," the Martin Lucifer Kings, the Abernathys, the Shuttleworths, the Adam Clayton Powells, the Dawkinses and all the other Negro "Reverends," all apostates, who are the "Leaders" in the phony fight for "Civil Rights," each and every one of them using the "Cloth" as his "authority" to incite all of their *deluded* flocks to defy law and order, to loot, to rape, to murder — all "*in the name of God and Brotherhood*" . . . the same is true of every "Reverend," especially those who participated in the rioting and sex orgies in Alabama, who is in any way affiliated with the "National Council of Churches," the same is true of every Jewish Rabbi who adds his voice to the clamor for "civil rights" for the Negroes. They don't want "civil rights" — they want destruction of Christianity and enslavement for those who are true Christians.

That goes for Presbyterian Ministers, Methodists, Baptists, Episcopalians — and, yes, for Catholic Priests of that ilk.

To make that point crystal clear, I again urgently refer you to our "News-Bulletin" No. 108, also beginning on page 19, in which I revealed how a Presbyterian Minister delivered a "sermon," in which he virtually *ordered* the members of his congregation to vote NO on "Proposition No. 14" which would have forced the California Legislature to pass a so-called "Housing Bill" which would have forced all (White) owners of housing properties (Apartment Buildings, etc.,) to open all those properties to an influx of Negroes . . . that Minister also, to all intents and purposes, ordered all voters in his congregation to vote for Johnson. His "sermon" boomeranged when one irate member, a highly regarded business man in Westwood, "*walked out*" of that church—and was followed by scores of others—that action put that church and its minister "*out of business.*"

(Note:—These two points are so startlingly vital, I would have reprinted them in these pages, but lack of space won't permit it. MCF)

However, I will DOCUMENT that statement with a reprint of the following statement from the October 26, 1964, issue of "NEWS-WEEK":

"Los Angeles:—Churches in Los Angeles opposing a proposal on the November ballot to kill fair-housing laws (the Rumford Law) are feeling the backlash. The Los Angeles Episcopal diocese, for example, is reported as having lost almost \$5 million in contributions and planned bequests from wills for this reason. And churches of all denominations whose clergy have attacked the proposal report Sunday collections down."

This amazing story revealed by a publication as violently "Left-wing" as "NEWSWEEK" tells the real story—the story that people are beginning to awaken — they are beginning to see through their "Men of the Cloth" — they are beginning to resent and reject the pro-Communist "pied pipers" in their pulpits . . . and they are showing their objections by hitting those "pied pipers" in their pocket books — the only language those "Men of the Cloth" understand! The proof of that is that today all those particular "Men of the Cloth" no longer spout "Liberal" propaganda to their considerably decimated congregations.

In conclusion, I wish to stress one additional point. I do not for one moment intend to convey that all Clergymen are guilty of betraying their Cloth. There is plenty of incontrovertible (documented) proof that there are THOUSANDS of certified Clergymen who are outright Apostates, as outright as the late Bishop Bromley Oxnam and the Red Dean of Canterbury — (Holy?) men ensconced in pulpits who betray God as Judas betrayed Jesus Christ, men who pied-piper their trusting congregations into Marxism, atheism and treason to God and Country. On the other hand, I know of many Men of the Cloth who are true disciples of our Lord, who render honest and sincere service for the salvation of the souls of the men and women in their congregations, who are zealously loyal to God and country. The former will cry out that I am a "hater" and a liar — the latter will understand and agree with my statements, and respect me for it . . . It is up to the people, the members of the various congregations to thoughtfully appraise their Pastors — and to act accordingly — as did the men and women in that West Los Angeles Presbyterian church. The members of a Congregation can fire an (Apostate) Pastor — they can veto membership in the National Council of Churches — they can accomplish that by hitting the "pocket book" of the church — that's the one language they all understand!

On November 3 all "Ifs" were wiped out. Now, today, with Johnson, a charlatan who makes an Al Capone look like a tyro and amateur gangster, in the White House, and an even more despicable (if that is possible) charlatan (HUMPHREY) as his possible successor, with both merely FRONTS for the CFR, we know the deliberately intended havoc we are facing.

As I stated at the outset, the One-World Conspirators seized upon "RELIGION" as one of their most potent instruments to destroy the morals and decencies of the people—to destroy their sacred belief in God and Christianity. And that began not in the 20th century, but long before the French Revolution. And it is happening today because we, "*the flocks*", have always fully believed our "*Men of the Cloth*."

But we now know the truth about our "*Religious Leaders*"—those of the *Oxnam type*. Thus, we now know how to torpedo that "*technique*" of the Conspirators. What happened in West Los Angeles, and Los Angeles in general, is our perfect lesson. Only the loyal Christian Americans can cure the cancer that is destroying our Religion and Faith in God. Every Congregation, *every individual in that Congregation*, should fully appraise the man in the pulpit—you should search and search and search to find out if your contributions are going to a pastor who is a member of NCC — you should find out if your church is a member of NCC. If so, WITHDRAW from that church — reject that pastor as you would reject Satan. Or do you want your family to listen every Sunday to the sacrilegious double-talk of a Satan in that pulpit? . . . Do you want your youngsters, who revere their Sunday School teachers, to be *subtly* transformed into atheism — to be "*educated*" about the joys of pre-marital sex relationships between Whites and Negroes? — about the joys of Negro and White intermarriages? — only YOU and YOU and YOU can drive the apostates out of our Churches — *they cannot exist without your contributions!* That's the only language they understand. *The leader of that revolt in the West Los Angeles Presbyterian Church proved that . . .* here let me repeat a statement made by that man — and others of that Congregation.

"For a long time I was bewildered. I sensed a double meaning in his '*sermons*,' but couldn't figure it out. I knew that my contributions and similarly generous contributions should have provided a heavy church treasury — yet he continued to exhort for heavier contributions — and then I discovered that our Church had been providing the NCC with heavy financing. At first, I didn't realize that the NCC was truly an '*ENEMY*' of Christianity, that they were frenziedly brainwashing our young people to scoff at Christianity, but that last '*sermon*' in which he ordered us to vote NO on Proposition 14 gave me the complete answer. Today I will attend a Church which I am SURE is not a member of NCC or its tributaries — today I must be SURE that my Pastor is a truly devoted Servant of God."

And THAT is what every loyal American Christian MUST do— THAT is the only procedure which will save our Youth and our Country. Jesus Christ "*lashed the money-changers out of the Temple*" — we, who believe in God and true Christianity, must lash the Oxnam, the Kennedys, the "*Lucifer*" Kings, etc., etc., out of the

pulpits of their Churches — or build *new* Churches and pick honest and sincere Ministers to conduct them.

Now, if there still is even a remote doubt in your mind about my charges, let me again quote just one passage out of that seven page "*Report*," issued by that Alabama Legislature Committee:

"The NCC and its racial committee will be promoting, directing and helping to finance racial demonstrations this summer . . . approve, foster, and urge the breaking of laws which it considers to be unjust; that students are being hired off college campuses to lead the invasion of Dixie."

They will be doing that with money provided by their member churches—*money provided to those churches by YOUR contributions!* Do YOU want to enable them to do it? If not, challenge your Church Board to reveal its membership or NON-membership in the NCC — challenge your Pastor to reveal *his* membership or NON-membership in the NCC . . . and then act as your conscience and Faith in God directs you to act!

LET'S HAVE CONGRESS DECIDE THE TRUTH

Unquestionably, the NCC and its apostate affiliates will scream denials of all the above charges — or use "*do-good*" and "*humanitarian*" alibis. They will insist that all those charges are made by Bigots, Far-Rightists, Extremists and Fright Peddlers. Well, let's strike a happy medium that can bring the truth to the surface:

For many years, the ADL, the CFR, the ADA, the Communist Fronts, etc., etc., have violently ranted against all Congressional investigations. Their cries were that only the "*do-good*," the "*Liberal*" and the Communists have come under such investigations. Of course, they never mention that the Buchanan Committee, *instigated, and virtually created by the "Anti-Defamation League,"* was set up to "*investigate*" only Patriotic organizations and force them to reveal the names of those who financed their work. They never mention it, because it boomeranged when influential Senators demanded that the ADL should be among the first to be hauled in for investigation. Several years ago, in San Francisco, there were demonstrations and riots to prevent a House Committee investigation of Communism in the Universities — and only a week or two ago, there were similar demonstrations in Chicago for the very same purpose. Therefore, I have a suggestion to submit:

Congress has the *Constitutional* right and power to investigate ALL activities—from those of the President and the U. S. Supreme Court down to even what may seem to be trivial activities. Very well, let's have Congress live up to that Constitutional requirement. *Let's*

demand it! Let's insist on Congress hauling in the CFR, the ADL, the ADA, the NCC, the "UNITED NATIONS," the Union "Leaders," etc., etc. Let's haul in all their records. Ditto the Mass Communications Media. Our Constitution guarantees the right of "free speech" for all of us—but not the right to use that "free speech" to destroy our nation. Therefore, it is up to Congress to investigate how our Mass Communications Media are using that "free speech" right—and thus unmask their treasonous activities.

Now, to nullify and offset the screamings of the NCC, the ADL, etc., and their vicious efforts to muzzle and handcuff the Congressional investigations, let's issue a direct challenge by offering to submit the Patriotic groups to similar investigations. On behalf of CEG, I freely and eagerly offer to submit to a thorough open-to-the-public Congressional investigation of C.E.G. — and I here and now assert that I will *never* resort to the Fifth Amendment, or any other Amendment. My only reservation (*and that is perfectly legal*) is that I will not reveal the names of the individuals and sources that do our research work for us. I am sure that Dean Manion, the White Councils in the South and all other Patriotic organizations who have nothing to hide will join in that offer.

Another, and even more important unmasking that should be done by Congress is that of *the President, the State Department and all heads of Federal Agencies!*

Our only hope of saving our Country — *and our children* — is by a *united* effort to *force* such Congressional investigations. And the men in Congress, such as Emmanuel Celler, Javits, Fulbright, etc., should also be thoroughly unmasked—even if we have to start *recall* movements by those who elected them into their offices. In short, we must restore Congress to the *loyal* service assigned to them by our Constitution — and *force* them to fulfill *their oaths of office* — *and their promises to their constituents!*

My statement that "*we must FORCE*" Congress to fulfill all of the above demands may sound harsh and arrogant, but there is an extremely vital reason for that harshness — and I will show you why it is so vital:

This year, (*and for a number of previous years*) Congress is reaping the bitter fruit of its self-destruction. They seem to have forgotten that they are the *servants* of the American people, not our Masters. But, first let me hasten to say that I do not include ALL the members of both Houses in that category — we have (*and have had*) men like Jim Utt, Strom Thurmond, John Tower, Bruce Alger, William Jenner, Bricker, etc., etc., who are, and have been, zealously loyal to their oaths, to their campaign promises and to natural loyalty to America, but there are hundreds of others, who not only have "*forgotten*" their promises and their oaths; some have traded their oaths and promises for so-called Federal patronage; others are

deliberately collaborating with the traitors in Washington for other reasons. In short, Congress, as a whole, has surrendered its former (*Constitutional*) rights and powers and now merely serves as a "rubber stamp" to the Executive (*White House*) Branch and its various agencies, commissions and committees, seemingly without either wish or will to resume its former virile status. The (*practically*) dictatorial powers granted to the Executive; the power and might granted to one individual to destroy at will or whim the nation's agricultural yields; the puissance bestowed on one man (*McNamara*) to set aside unanimous recommendations of the highly trained Joint Chiefs of Staff on vital Defense matters and to ignore and/or refuse to spend monies voted and appropriated by Congress for national defense; the muzzling and gagging of the Military when their highly competent and dedicated advice to the public is desperately needed; turning over its powers of policy making to the arrogant, disloyal and now virtually supreme State Department, which has had the audacity to offer to the UN a plan for the complete disarmament of the United States — *and enslavement of the American people*; allowing the continued existence in our midst of that modern Tower of Babel with its alien (*and traitorous*) philosophies and policies diametrically opposed to our hard-earned institutions and Constitutional rights. All this means that the American people must quickly awaken — *and let the men in the Congress KNOW that we are awakening!*

My saying: "Let's Force Congress" to take those actions are not idle words — *please believe me!* It *can* be done. *It has been done* — in such a way that even a Fulbright panicked and ran for cover. But it can be done only by YOU and YOU and YOU who elect those men into office. And we must not — *dare not* — wait for the "*next election.*" I will *show* you how it has been done — and can be done again. Limit of space won't permit me to do it in this issue — but I will devote one of our next issues to it . . . *if you will write and tell me you want me to do it and will cooperate.*

But before I conclude, I will set down one piece of advice: when any man appeals to you to vote for him to be your representative in Congress or in your State Legislature, appraise him very carefully. Don't just accept his honeyed political promises. Examine his background, his integrity, his honesty — and, despite his *apparent* trustworthiness, watch his every deed in office, and the first time he deliberately breaks his promises, organize your friends and neighbors and RECALL him! It has been done before — *it can be done again!* One RECALL will warn all the others!

Now, while I am on the subject of the men who come to you for your votes, I want to mention one more thing: As you and I know, there are thousands of types of men who seek the various political offices. Some are blessed with good looks and pleasant

appearance and personality (*on the surface*), some are blessed with eloquent tongues. Recently, since Ronald Reagan delivered an eloquent speech on behalf of Goldwater's candidacy, I have been getting many letters for my reactions to that speech—and my further appraisals of the man (Reagan). This is in part due to what I have previously stated about his activities prior to his recently announced conversion to Republicanism. I had intended to conclude this issue with a detailed appraisal of the man and his proclaimed change to Conservatism. But just as it was going to press, I received a request for a conference. In this conference, Mr. Reagan expressed objections to some of my previous charges of Leftist activities. I won't use the word umbrage, but he did contend that some of my charges were erroneous. *That was his OPINION!* He did not deny commission of all the charges, but he indicated that some of his acts were due to "*unawareness.*" He also defended his fraternization with known Reds on the ground that he had been informed *and convinced* that they had been "*cleared.*"

Nowthen, there is no doubt that his speech on behalf of Goldwater—and his speeches since then, have gained him many new admirers—and have instilled in him political ambitions. Whether or not his limited political experience warrants those ambitions is still a matter that requires proof—but, most important, is the question of the depth of his conversion from his self-admitted (former) "*Liberalism*" to true Conservatism.

I have always tried to maintain a fair and free mind about all men and about all issues. I sincerely hope that I have always evidenced that kind of a free mind. Therefore, in view of his objections to my charges about his activities and his explanation about those activities, I have decided to make further research of our files and other authentic files and reserve my complete appraisal for a following issue.

I would like to have it clearly understood that this is by no means a retraction of my previous charges, but a thorough and careful reappraisal for the benefit of our (CEG) members and other interested individuals.

I have just one vital reason for this reappraisal: There are many men in our Congress, in our Legislatures and in other of our highest offices who are fully as "*charming*" and fully as "*eloquent*" as Ronald Reagan. They, too, gained your votes with honeyed words and assurances of great Americanism. Some are honest in their statements—some are deliberately false. *Appraise them!* Study their statements, as I am now studying Ronald Reagan's new statements—and, above all, *study their integrity*—as I shall now study Reagan's integrity. By careful observation of such precautions, the country you will save is YOUR country—the children for whom you will provide that safety are YOUR children.
