NOW THE UNITED NATIONS!

Well—the Rats are on the run! On November 4th, the American people most gloriously told Moscow that we are coming awake! But, wait! Let's not lay down our arms! In our very victory we can go asleep right into defeat! That has always been our trouble—and *Stalin knows it!*

In our October Special Bulletin we favored Eisenhower NOT because he is GOOD, but because Stevenson would have been so TERRIBLY bad! And I KNOW that with the vast majority it was not so much a case of voting FOR Eisenhower, as it was against the Phillistines—beg pardon, the Roosevelt-Trumanites.

But we know what we are facing with Eisenhower. I do not retract any one of the charges I made against him in our July 1951 Bulletin; nor those I made in our 1952 Bulletins. Being forewarned, we should go FOREARMED into the next four years.

During his "scared" campaign, in sheer desperation, Ike made many promises—it is up to us to STAY ALERT and force him to keep those promises! . . . conversely, he made some "promises" that have me shuddering, fulfillment of which we MUST, with the help of God, prevent. The most frightening "promise" he made was that he would continue to be all-out for the UNITED NATIONS and would seek to strengthen it.

Seemingly, only a comparative few of the American people realize what a DIRE MENACE the U.N. is to the U.S. Few seem to know that Alger Hiss (with the help of other American traitors) created the U.N. AT THE BEHEST OF JOE STALIN! That means that as long as the U.N. is entrenched WITHIN the U.S. just that long will our country be in DIRE DANGER! It is now OUR job—our most important job—to get the U.S. out of the U.N. and drive the U.N. out of the U.S.!!! Eisenhower won't do it on his own—WE must FORCE him to do it . . . because the UNITED NATIONS is our Country's CANCER—and I shall prove it in these pages.

In my "proving" there may be moments when you will think that I have drawn in irrelevancies—but they are NOT irrelevancies . . . you will find that they are links in a chain of treason plots within the MASTER plot. In order to give you a crystal clear step-by-step picture of this UNITED NATIONS treason plot, I shall now take you back with me to that day in 1946 when I was given my first glimpse of it.

RED TREASON IN WASHINGTON

January 14, 1946 is one day in my life that nothing but death will erase from my memory.

It was on the morning of that day that I arrived in Washington, D.C.,

for conferences with Congressman George Dondero and Senator Arthur Vandenberg on the matter of Red Treason in high places in our Government. Present at the conference in Senator Vandenberg's office were several Members of both Houses of Congress, Army and Navy Intelligence officers, and Secret Service operatives. All of them were men whose veracity could not be even remotely questioned. And on that day in January 1946 I hear a story of rampant treason in our State Department, in various branches of our government, and even in the White House, such as has never been equalled in the annals of any nation on the face of the earth.

In my boyhood days I had been fascinated by Alexander Dumas' tales of Court intrigue, espionage and treason, countered by heroic patriotism. I vividly remember the thrills in "The Scarlet Pimpernel," one of the great plays of its day, which breath-takingly portrayed the treason and espionage, the heroism and counter-espionage, in the exciting days of the French Revolution. And at the turn of this century, two Britons, H. G. Wells and E. Phillips Oppenheim, gained great fame with *their* fantastic tales of international plot and counter-plot, of espionage and counter-espionage. They were entrancing tales of high and hair-raising adventure, of heroic patriots, and of black-hearted scoundrels. But even the spies and the traitors in those stories exuded a degree of glamor—in a villainous sort of way. There was a sparkle in their villainy—and even a perverted sense of righteousness. But the story of the treason in Washington that I heard on that never-to-be-forgotten day in January, 1946, was dull and drab and tawdry, just cut-and-out vicious villainy, as sacrilegious as the kiss of Judas. There was not even a semblance of an alibi of mistaken high idealism, for those who committed it (and are still committing it) are men and women of high education, of brilliant minds, who are fully aware of the deadly poison in Communism, and who knew that their betrayal of their own people and their own country was distinctly of the Judas order. No wonder that some like Lawrence Duggan, took the Judas way out when faced with discovery of their vile treachery.

Norway had its Quisling, France had its Pierre Laval, Bulgaria its Dimitrov, but for every one of those traitors America had—and still has—a score of Alger Hisses, William Remingtons, Harry Dexter Whites, Owen Lattimores, Lee Pressmans, John Abts, etc., etc. Yes, and even as Czecho-Slovakia had its Eduard Benes and Jan Masaryk, America had its Franklin Delano Roosevelt and Harry Hopkins, its Dean Acheson and George C. Marshall.

OPEN "SECRETS" IN WASHINGTON!

But among the most stunning revelations I heard on that January day, was that it had long been an open "secret" in Washington that Alger Hiss had been a Communist Spy *throughout all the years that*

he was in the State Department . . . ditto Harry Dexter White, Remington, Duggan, Pressman, etc., etc.; that the entire State Department was LOADED with Commies; and that all our top Security secrets and Codes had for many years been systematically delivered to Moscow. It was an equally open "secret" that for many years Dean Acheson had been the paid legal representative in the United States for Moscow and various of her Satellites—and that TO THIS VERY DAY Acheson's Law firm is still the registered Attorney and Agent for Moscow in the United States. Of course, we know that TODAY Dapper Dean is "throwing rocks" at the Communists with one hand—and is taking their fees (through his Law firm) with his other hand. And I won't even concede that this is a case of one hand not letting the other one know what it is doing. It reminds me of an ancient, but very amusing vaudeville act, which ran about as follows: a motorcycle cop caught up with a speeding motorist and motioned him over to the curb. The motorist's wife promptly broke out with a shrill tirade, *not at the officer*, but at her husband, reminding him how she constantly kept at him not to speed—to drive carefully—not to pass through red lights and "Stop" signs, etc., etc. Throughout her tirade she kept turning to the waiting policeman and urging him to give her husband a ticket, or even better, to put him in jail as a lesson. The husband desperately kept trying to retort—the policeman kept trying to break in—but the woman outscreeamed her husband and outshouted the policeman, until both looked at each other—and gave up.

"Okay, mister," said the sympathetic cop, "any poor devil who has to live with a battle-axe like her has enough troubles without me adding to 'em—drive on."

As the cop mounted his motorcycle and roared away, the wife leaned back with a happy sigh; the husband grinned his relief; they looked at each other and chuckled: "Boy, it worked!"

Every time Dapper Dean and Vishinsky engage in their violent "debates" I am vividly reminded of that vaudeville act.

HOPKINS' ATOM BOMB TREASON

Another open "secret" in Washington, disclosed to me on that day in January 1946, was that the blueprints of our highly secret Atom Bomb, TOGETHER WITH THE MATERIAL TO MAKE THAT BOMB, had been handed over to Moscow from the very inception of that Project—*directly by order of Harry (the Hop) Hopkins*, no doubt with the knowledge and approval of UNCLE JOE's long time patron saint in America, Franklin Delano Roosevelt. Even as I was being told that "secret" in 1946 THAT TREASON WAS BLITHELY GOING ON. And, to date, none of those TOP AMERICAN OFFICIALS guilty of that treason has been hanged or shot!!!

HISS "PLANTS" THE U. N.

Still another open "secret" confided to me on that date was that the "UNITED NATIONS" had been a pet dream in the brain of Joe Stalin since the early 1940's—*perhaps even before that*. Anyway, it is known that early in the 1940's Alger Hiss, and all those men who "refused to turn their backs" on dear Alger after he was exposed, got an order *direct from Moscow* to create and organize the "UNITED NATIONS."

Now, you, my puzzled friend, might well ask—*as I did*: why should Joe Stalin have been so eager for the creation of the "UNITED NATIONS?" The answer turned out to be ridiculously simple:

It is commonly known that all Embassies and Consulates have what is known as Diplomatic Immunity. Their official premises are above the law of the land, and even the luggage of the Diplomats (which includes all attaches) is sacrosanct and passed through Customs without inspection. From time immemorial, it has been assumed that Diplomats are men (and women) of honor, and that they would not knowingly transgress laws, or take advantage of their immunity privileges. Of course, that theory does not apply to the "diplomats" from Moscow and her satellites— a Communist looks upon the words honor, truth and decency with the same scorn that a fox views a "keep out" sign on a hen-house. Hence, it is now common knowledge that from the very day our "great" FDR opened our gates to Moscow, every Communist Embassy and Consulate in the United States has been a nest of spies—and a sanctuary for all the saboteurs who sneaked into America via Diplomatic visas, counterfeit passports, and DP privilege. But Stalin knew that that could not go on forever. He knew that as long as a Roosevelt and a Truman and an Acheson remained in control, his "diplomatic" espionage system would be safe; but he also knew that some day the American people *might* wake up—and, in their rage, break off all "diplomatic" relationships.

The United States is the only nation strong enough to smash Moscow's plan for world conquest—*and will do so*, unless the American people can be kept in a state of non-realization, or so muzzled and hand-cuffed as to be impotent. Therefore it behooved wily Joe to prepare—**IN ADVANCE**— another kind of "diplomatic" espionage and sabotage system. What could be better than a "UNITED NATIONS," created, formulated, and organized by the fair-haired lads of the U.S. State Department, with the warm blessings of the "saintly" FDR—**intrenched WITHIN the United States!!!**

"Think." I can hear Satan, alias Stalin, chortling to his Molotovs, Vishinskys and Gromykos, "what a PERFECT set-up that will be for us: a 'United Nations' *controlled by Moscow*, with far more power and far greater respect than any single nation on the face of the

earth—with “diplomatic immunity” far beyond that of any mere Embassy or Consulate—*with all its doors open to us!* We can FLOOD all of America with our spies and saboteurs, even if they finally throw out all *our* diplomats.”

“Do you think the American people will swallow that?” asked Molotov, dubiously.

“Of course,” scornfully snorted FDR’s Uncle Joe. “You know what good old Harry Hopkins said: ‘all the American people are morons.’ Franklin D. Roosevelt is their God—he has them eating out of his hand. They will swallow anything that good old Uncle Frankie and Auntie Eleanor will shove into their foolish mouths. GET BUSY!”

And so, a peremptory order to create the U.N. was dispatched to that *fine and exalted American*, Alger Hiss, *protege of FDR and Acheson*—and the U.N. was created!!! But there is FAR more to the story of the “United Nations” than just that—I will return to it as soon as I have concluded with my conference in Senator Vandenberg’s office.

COMMUNIST ESPIONAGE TECHNIQUE

Now, when I received the request to attend those conferences I was puzzled. Until that day, my interest in—and *knowledge of*—Communism was perfunctory. I was a playwright, lazily concerned with nothing but my own affairs of the theater. Oh, of course, I knew that Communism was poison, but I looked upon it as one of those cock-eyed foreign ideologies that could in no way affect *our* country—WE were too smart for that! And even after I heard all those shocking open “secrets” I still could not understand why I had been called into those conferences—and I so stated.

“Because,” they explained, “you can do a job against Communism that none of us is capable of.” And then I was given a brief but complete lesson in Communist techniques:

Communist spies, such as Alger Hiss, are of inestimable value to Moscow—but *only as long as they can operate in absolute secrecy*. The moment a Hiss becomes known as a spy he not only loses all value to the Kremlin, but becomes a menace—and must be *purged*; because through him the FBI, or Army, or Navy Intelligence, can trace his various links—and thus imperil the entire espionage system. Thus, all top spies are surrounded by all possible protective measures. Each one must do his job as a “lone wolf.” Or, if it is vitally necessary for him to have co-workers, he is provided with a “cell” composed of a few, *very few, sworn to the death individuals*. Such spies are never in direct contact with Moscow, or with the American Communist “party.” They receive their orders, *invariably orally*, through a tried and true SPECIAL COURIER, such as a Whittaker Chambers, or an

Elizabeth Bentley; in turn, the spy delivers his photostatic copies (and even originals) of State Department top secrets and all other information vital to Moscow to that same Courier. That Courier makes his (or her) delivery to another Courier, who delivers it to the Master Courier, who finally delivers it *by hand* to Moscow—or it is included in the Russian Ambassador's (*diplomatically immune*) pouch to the Kremlin.

Now, a Dean Acheson—if he is a *fully constituted spy*—would not have to go through all that rigamorole. Bear in mind that his Law firm (*he is presently merely on a leave of absence from that firm*) is—and has been for many years—Moscow's legal representative in Washington. As such, Acheson's firm is legally entitled to deal directly with Moscow—and act as Stalin's direct agent. And under our present laws—and *Bar Association ethics*—it is a lawyer's sacred obligation to hold inviolate all of a client's secrets. Thus, Dapper Dean—if he is a *fully constituted spy*—can get all of his "orders" directly at the offices of his Law firm. In addition, he can follow out the "expert advice" of an Owen Lattimore, a Doctor Jessup, a Vincent. He can even lend a very ready ear to the I. P. R. (Institute of Pacific Relations) and the A. D. A. (Americans for Democratic Action). What's that?—you say those organizations are Red outfits! Oh, my goodness, NO! They were organized to FIGHT Communism, not aid it. You don't believe me? Don't be silly—they've said so, themselves. What's that?—you don't believe *them*, either? Well, that is being ridiculous—why, every one of their organizers and top functionaries is willing to swear to it on a stack of bibles as high as the Empire State Building! . . . you *still* wouldn't believe them, because Communists don't believe in bibles?—well, there, my friend, I'm afraid you've got me.

Well, anyway, after I had recovered from the impact of all those revelations, I expressed my puzzlement as to why I, a mere lay citizen, had been called into that kind of a conference. Senator Vandenberg quickly told me:

"We want to smash the entire Red treason conspiracy within our government. We can do it if we get all these facts before the American people. YOU can do it by incorporating all the facts we have given you into a play—and by Naming all the Red spies we have named."

For a moment the very audacity of the idea held me in stunned silence. The Senator continued:

"Such a play will be a sensation, because instead of fiction it will be factual—and it will deal with still living and famous names. It will be sensational "front page" for months to come, because men like Alger Hiss won't dare to let it go unchallenged—they will be forced to sue you for criminal libel . . ."

I nodded grimly. I fully realized how sensational such a play would be—and how dangerous to ME. The Senator sensed my thoughts.

"You need have no worry about such suits," he assured me. "We will provide you with all necessary documentary evidence, plus the personal testimony of the Courier who was Alger Hiss's contact with Moscow"—and he named Whittaker Chambers. The entire explanation they gave me ran about as follows:

Actually, the Alger Hiss treason became KNOWN in Washington in 1939, and was suspected even before that—although Senator Vandenberg frankly admitted that he, like many others, disregarded all signs of the Red Treason in Washington and the full meaning of the UNITED NATIONS, until after the "Charter" was "signed, sealed and delivered" at the San Francisco Conference—they were blinded to it BECAUSE RUSSIA WAS OUR ALLY—and because our great American Chief executive, FDR, was Stalin's palsy walzie.

It was in 1939 that A. A. Berle, Jr., then an Assistant Secretary in the State Department, personally submitted *prima facie* evidence of Alger Hiss's treason to FDR—but that great American laughed at the evidence and told Berle to "go jump in the lake" with it—I am using a printable expression in lieu of the one the White House gentleman actually used.

Everybody knows what happened when Martin Dies, the then head of the House -Un-American Activities Committee, decided to bear down on the Reds in Washington—Alger Hiss among them: he was called into the White House by an angry FDR and told to concentrate his attention on the Nazis and the Fascists and to keep "hands off" the Communists—"many of whom are my (FDR's) good friends." Likewise, the White House Shrew, Eleanor, shrilly yammered at Dies for so much as questioning Red Joel Lash, one of her special proteges. It is a known fact that Martin Dies' political career was wrecked by his frustrated efforts to throw a public spotlight on the Red Treason in Washington—just as Parnell Thomas was wrecked and jailed for his investigation of the Reds in Hollywood. Later, in 1944, certain Members in both Houses talked of launching an investigation. There were Democrats as well as Republicans in the group, but the moment Roosevelt heard about it he denounced it as a political maneuver and issued a Presidential ukase that Hiss and all the other Reds were to ignore all summonses and to refuse to answer all questions—on the grounds of "war-time security." Even Dewey, who had been given many of the above mentioned facts, on the "advice" of that other great American Patriot, General Marshall, "buttoned" up his lips" during that Presidential campaign.

During the final months of 1945 there was again considerable talk about a Congressional investigation. This time our new Chief Executive, "Red Herring" Harry, threw a monkey wrench into the machinery by issuing his dictatorial ukase to J. Edgar Hoover, and the chiefs of all Government Intelligence Bureaus, to SEAL their files and refuse

information to *all* Congressional and Senate Committees investigating Reds. At the same time the FCC (Federal Communications Commission), all FDR or "Red Herring" Harry appointees, quietly made it known that any Broadcasting Station that would permit "comment" about Reds in Government would be in danger of having its license revoked—*on some charge, or other.*

(NOTE:—As a matter of fact, in 1950 the FCC did start an action to shut down the three Richards Stations, in Los Angeles, Detroit and Cleveland, for that very reason—only with the help of the malodorous "Anti-Defamation League" they camouflaged *that* action by making it a charge of "anti-semitism," that most effective "smear" to discredit patriotic anti-Communists. Only a nation-wide uproar, created by the CINEMA EDUCATIONAL Guild, forced FCC into a hasty retreat).

The Press, likewise, decided that discretion would be healthier than valor. Even when the highly respected Walter Trohan wrote his famous "Our Secret Government" Documentary, which merely *hinted* at the Red Internationalists who control the White House and our State Department, the newspaper publishers turned thumbs down on it.

With both the Press and Radio muzzled, the idea of a Congressional investigation was dropped. At best such an investigation is merely a gesture. All that such a Committee can do is ask questions—which can be scornfully flouted by resorting to "Constitutional rights." The Committee can *suggest* legal action and punishment, but it cannot enforce it. The only real value in such an investigation is in alerting the PEOPLE into demanding action. That can happen only if both press and radio give it full and favorable coverage. In 1915 *that* was definitely OUT.

Thereupon, one of the group came up with the brilliant idea of having some patriotic Hollywood producer incorporate the story of the Red Treason in Washington in a Motion Picture. A clever script writer *could* make it a very good evening's entertainment of the "Cloak and Dagger" type—in fact, it could easily have been the most startling evening's entertainment ever seen, with many of the characters portrayed as actually LIVING individuals, such as Hiss, Acheson, Lattimore, etc., etc. It was a PERFECT idea—because such a film would have forced the Press to spread the story far and wide! *But to get it made was a horse of another color!* In those days, there wasn't even a remote suspicion of how completely Moscow had "taken over" our entire Film industry. Only a few of the loyal Americans in the very heart of the industry were aware of it. Thus, when certain Hollywood producers were broached, it quickly reached the ears of the half-dozen Moguls who control the industry—and *only those who are in "Hollywood" know what a complete strangle-hold those half-dozen men*

have on the entire industry! They promptly issued a "blacklist" threat against anybody who would write, work in, or produce such a film.

There is one very important point that I feel should be stressed: I stated that Hollywood (the Film industry) had been completely "taken over" by Moscow. That is true, of course, as I clearly established in my book, "Red Treason in Hollywood," but it must be emphasized that Moscow did not achieve it by her own efforts. Franklin D. Roosevelt, *knowingly, and deliberately*, did that job for Moscow. In my later book, "Documentation of the Red Stars in Hollywood," I submitted *documentary evidence* of how he DROVE all the Broadway actors, as well as those in Hollywood, into the Red fold. He virtually said "Go Red or starve." *And that charge in "DOCUMENTATION OF THE RED STARS IN HOLLYWOOD" has never been challenged!!*

After vainly trying to break through the stone walls of Hollywood our Washington AMERICANS decided to turn to Broadway. But, smattered up by their experiences, their approach was far more cautious. On Broadway they found a more encouraging picture. Here they found no "Moguls" with the power of economic life and death control over everybody in the industry—the giants on the Broadway scene were the old-timers who, while they may not have been particularly willing to risk their skins for America, were not at all sympathetic to the Moscow conspiracy. But actors, playwrights, directors, were a different story. Practically every theatrical Union, with the exception of the Stagehands Union, was Red controlled or dominated. Loyal American actors were afraid to death to so much as express their views--those who did just simply could get no jobs. As to playwrights, the vast majority of the established ones, such as Lillian Hellman, Ben Hecht, Moss Hart, Elmer Rice, Oscar Hammerstein, George S. Kaufman, Chodorov, William Gropper, Clifford Odets, Irwin Shaw, George Sklar, John Wexley, etc., were either out-and-out Reds, or pro-Reds. The same was true of Directors, such as Herman Shumlin, Harold Clurman, John Cromwell, Jose Ferrer, Garson Kanin, Orson Welles, Herbert Biberman, etc., etc.

Thus, their first objective was to find an AMERICAN playwright whom, as Senator Vandenberg expressed it, "God had endowed with sufficient intestinal fortitude" to write such a play. A certain highly-trusted individual whose name, for the moment, I will not mention, had spoken about me to Congressmen Dondero and Woodruff—in fact *he* had arranged my meeting with Dondero. Hence the call for my presence at that conference on January 14, 1946.

This brings to a conclusion that particular conference. But it was only the beginning for me. It was followed by a round of discussions with other top officials, who further enlightned me; plus research at the Library of Congress and in various "top secret" archives, which, surprisingly, were opened to me. Out of it came the writing of the

play "Red Rainbow," in which I told the story of the treason in Washington *without pulling a single punch*. But getting it on Broadway was something else again. However, I told that entire story in "Red Treason in Hollywood," so there is no need to repeat it here. I did *finally* produce it in Los Angeles in May 1952—and, amazingly enough, it received RAVE reviews from even the "Liberal" critics . . . the Critic of the "Hollywood Citizen-News" stated that "had this play been produced in 1946 it might well have changed the entire history of the past six years—and that it can still vitally influence the course of coming events. *Most important*, it can bring about legislation to *outlaw the Communist party!*"

ILL-OMENED BIRTH OF U. N.

The "United Nations," conceived in the secrecy of Dumbarton Oaks, is the most crafty conspiracy ever created to destroy the sovereignty of the United States and the freedom of our people.

Between the time that Hiss received his orders from Moscow and the submission of the monstrosity at Dumbarton Oaks, it is known that Hiss and FDR burned much midnight oil in its preparation. It had to be camouflaged with the allure of "Peace" and the charity of "humanitarianism," the bait with which Roosevelt had led the American people into trap after trap. Of course, at Dumbarton Oaks only the skeleton of the idea was presented. Nothing of the contemplated abolishment of our Constitution, or the surrender of our sovereignty, was even hinted at. The most important objective at Dumbarton Oaks was to get a general approval—the "dirty work" was to be done *after* the BIG BRAINS at that assembly gave it the green light.

Intimates of the perfidious Roosevelt have since revealed that that crafty charlatan had been outsmarted by Hiss when that traitor induced him to sponsor the creation of the "United Nations." Knowing that Roosevelt's most driving ambition was to become the first KING OF THE WORLD, he deluded the already mentally dying Roosevelt into the belief that he (Roosevelt) was laying the foundation for a King Roosevelt "one world" government. Of course, Roosevelt knew that "Uncle Joe" likewise had World Dictatorship ambitions, but he always more or less scorned Stalin's mentality, and felt quite confident that he could "handle Uncle Joe." And he never for one moment suspected that Hiss was deliberately "using" him (Roosevelt) on behalf of Stalin. It was only in the very last days of his life that the truth pierced through to his parietic brain that he had been a dupe—he then actually wailed to his intimates that he had begun "to believe that Stalin was not as trustworthy as he had thought." He died very shortly after he made that statement, and there are those "in the know" who contend that he committed suicide when he discovered how Hiss had

walked him into that trap—others, on the other hand, say that he was “knocked off” to prevent his blurting out the entire truth about that black conspiracy. Anyway, it is a fact that complete mystery surrounds his death—AND NOBODY SAW HIS FACE OR BODY AFTER HIS DEATH! There is no doubt, however, that Eleanor knows all the facts!!! . . . However, let’s go back to the UNITED NATIONS:

STALIN TAKES COMMAND

Between Dumbarton Oaks and that secret meeting at Yalta, Hiss and Roosevelt did much collaborative work on the proposed CHARTER. They studied our Constitution for such loopholes in it that would enable the “United Nations” to LEGALLY vitiate and nullify the vital provisions that safeguard the sovereignty of the nation and the freedoms of our people. They made several “rough” drafts—no doubt excellent for their objective, but calamitous for the American people. Even so, the final rough draft had to be submitted to “Uncle Joe” for approval.

Such an important document, however, could not be entrusted to even the most discreet of Couriers. So a “Big Three” conference at Yalta was decided upon—and Alger Hiss, the real architect of the “United Nations,” went along as “chief adviser” to our already senile President. That secret meeting was Communism’s greatest victory and America’s greatest humiliation—and *might yet well be its end as a sovereign nation!* It was at Yalta that Russia achieved her centuries-old ambition for the conquest of China . . . it was at Yalta that all of Asia and the Pacific Ocean were handed over on a silver platter to the 20th century Genghis Khan. However, while all those tid-bits were highly desirable to Joe, the main objective of “Yalta” was the “United Nations”—it served as an excellent alibi for personal meetings between Hiss and Stalin. At Yalta Hiss was able to work directly—and *openly*—with Molotov, Vishinsky, Gromyko and the entire unholy crew—and it was at that Yalta meeting that the “United Nations” Charter was finally polished and camouflaged for its “pushover” at San Francisco . . . *with the acclamation of a betrayed and thoroughly bemused American people!* Thus, by all diplomatic standards, the “United Nations” was an *American* project—in short, right then and there *America created its own Frankenstein!*

All that hooey about the Charter having been written in San Francisco was just a lot of hooey! That was another “open” secret in Washington. It was a completely finished job before Hiss left Yalta. No doubt, Roosevelt and Hiss, aided by their Washington co-traitors, had made a pretty good job of it before Yalta, but it was there that Stalin, Molotov and Vishinsky injected the craftier provisions that were to enmesh the United States.

When it comes to craft and guile those Russkies are as far beyond the Western mind as electricity is beyond the tallow candle. So when they got through with the comparatively simple Hiss-Roosevelt document it was loaded with treachery, deceit, falsehood and hypocrisy, but so camouflaged and sugar-coated as to be hailed as the sure-fire cure-all for all the ills of the entire world. I will cite just two or three of their diabolical gimmick provisions:

STALIN DECIDES U. N. TO BE TROJAN HORSE

Hiss and Roosevelt, in their rough draft for a "United Nations," had stipulated that it would be headquartered in Geneva, Switzerland, where all the buildings of the old "League of Nations" were standing idle and empty, awaiting the reorganization of that defunct and flopperoo organization. It was a natural assumption. But Stalin promptly vetoed it—a "United Nations" headquartered in Geneva would be of as little value to him as if it were on Robinson Crusoe's Isle. As previously stated, the United States was the only nation strong enough to stand between him and world conquest—that was before the feeble minded Truman emasculated our then invincible military machine. Stalin had to have free access into our country—for *unlimited espionage and sabotage purposes*. He knew that the "Russia is our ally" myth would be exploded very quickly after the war was over, when Moscow would start her "hate America" propaganda. A properly controlled "United Nations" headquarters *within* the United States would be a perfect Moscow base of operations. So the U.N. *within* the U. S. was to be the first gimmick! But thinking far ahead, with the impending rift in mind, Stalin theorized that if Russia so much as *suggested* that the "United Nations" be domiciled within the United States, the American people would remember it and take quick alarm. So it was decided that the *demand* should be made by America's "beloved President," and his "loyal adviser," Alger Hiss. The Russians would strenuously oppose it—but finally, *with great reluctance*, acquiesce. THE SAME STRATEGY WAS TO BE EMPLOYED THROUGHOUT! Any time that Stalin would want to "put over" one of his diabolical schemes, it was to be suggested by the United States and strenuously opposed by Moscow . . . finally Moscow would *reluctantly* consent—and let naive old Uncle Sam crow over "a great victory." This order is being carefully followed out to this very day, as for example, when our great Guardian of State, Dean Acheson (Moscow's lawyer) and Vishinsky clash in violent "debates" before the U.N.; Vishinsky screams at Dapper Dean with guttersnipe billingsgate—Acheson retorts with biting, but "gentlemanly" Harvard sarcasm . . . Vishinsky finally surrenders, and the smug Dapper Dean is "patted on the back" by our press for his *masterful diplomacy*.

It was by *that* method that Stalin planted inside our gates a Trojan Horse, compared to which the one the ancient Greeks put over on Troy was a child's toy!

STALIN "NAMES" HEAD OF U. N.

Stalin's next objective was to have the United Nations "headed" by an individual who would be loyal to Moscow—who would zealously install tried and true Communists in all important posts in the U.N. Trygve Lie, in Stalin's opinion, was the perfect choice. Trygve insists that Lie should be pronounced LEE, but it spells Lie, and, as far as I am concerned, LEE it is.

As per schedule, our Mister Hiss proposed Lie for the job of Secretary General of the United Nations, but the conspirators ran into a totally unexpected obstacle when a Canadian member received 8 out of the 11 votes necessary for election—and *Hiss could do nothing about it*. In sheer desperation, Gromyko threatened to use the veto if the voting continued. He demanded the election of Lie by acclamation—despite the fact that such elections could only be conducted by secret ballot. As a result of zealous missionary work by Hiss and other American traitors, always using that "Russia is our ally" as a persuasive argument, Lie was elected by *acclamation!* And now, just to present a clearer picture for those who don't know, let's lift the curtain on Lie's background.

WHO IS TRYGVIE LIE?

Trygve calls himself a Socialist. By now, only the most naive are unaware that Socialism is just a very brief corridor to Communism.

Trygve was a top member of the Norwegian Labor Party, which was one of the first to affiliate with Lenin's Third Internationale. As late as April 9th, 1915, Trygve tried to essay the role of Alger Hiss to his own country, by proposing the joint defense of Spitzbergen by Russia and Norway. That would have given Moscow an ice-free bastion within easy striking distance of Britain and America; it would have controlled our pathway to Europe and Russia, and would have subjected Sweden to a cross-fire between Spitzbergen and Russia. But Norway rejected the idea.

Trygve was a frequent long-time "guest" in Moscow during the years before World War II, and throughout the entire war. During all that time he was palsy-walzie with Stalin, Molotov and Vishinsky.

As Secretary General of the U. N., Lie has the sole authority to appoint all his assistant Secretaries-General, of whom there are eight—*I will give you one guess to figure out how many of them are outright Communists and pro-Communists . . .* but, as Al Jolson used to say, you ain't heard nothin' yet!

Can you also imagine how they can assemble blueprints and diagrams of our Defenses, our Secret weapons, all of our other Top Secrets, and ship them to Moscow in that same *untouchable* luggage?

Furthermore, all spies and saboteurs who are ostensibly U.N. employees, operate openly, brazenly and untouchably, literally thumbing their noses at our authorities. For just one example, there was one Gubitchev (the Judith Coplon case). He was caught red-handed, tried, and found guilty. Instead of being jailed, he was wined and dined, loaded with gifts, and provided with royal-suite passage back to Moscow—at our expense. And all that time our own Robert Vogelers was being held in the Communist torture chambers in Hungary. There wasn't even a thought of an exchange of prisoners--*Dapper Dean said that such a suggestion might offend Moscow!!!*

Is it any wonder that the Communists look upon the United States with contempt? . . . is it any wonder that the Red Chinese spit upon us? . . . is it any wonder that the United States, the most powerful nation in the history of the world, has lost all face all over the world? It is no wonder that Stalin believes that Harry Hopkins was right when he said: "*all the American people are fools.*"

STALIN STOOGES U. N. BOSS OF KOREA "POLICE ACTION"

Arkady A. Sobolev, next in line to Lie in the U.N., is the minister of War, Communications, and Information. All military and diplomatic affairs go to him first. All movements of troops, of guns, of materiel, are reported to him IN ADVANCE. Sobolev is a Moscow Communist, one of Stalin's favorite henchmen. Do you have to be told what that means? I can't think of a more perfect set-up for Joe, our *real* enemy in Korea. Can you?

Do you see under what impossible conditions *our* sons in Korea are fighting? How CAN they win under such circumstances? This provides a clear picture of the *tragic* comic opera farce at Koje and Panmunjon. That should give you an idea of what General Van Fleet must think of having to wage a war under such circumstances—*when he must report all movements to Moscow's Sobolev*—and accept the dictation of non-military men in the "United Nations" as to how the war shall be conducted—how the armistice shall be planned—how the "truce talks" shall be conducted—how the prison camps are to be operated. All this despite the fact that thousands of *our* captured boys have been murdered and tortured, that no report has ever been made of other thousands who have disappeared. Sirloin steaks and strawberry short-cake for Koje, but bullets, knives and fire for our own boys. Maybe *you* can take that kind of a deal for our kids—and our country. I can't—at least, not without TRYING to do something about it.

I know many members in both Houses of Congress who have sons on the firing line in Korea—they have the power to stop all this—yet

they support the United Nations *and talk about "strengthening it."* This may sound cruel, but I don't have the slightest sympathy for their heartbreak as they watch the casualty lists and wonder if *their* boy will be on the next one. But I do wonder what is the matter with their heads, for *they* know what a tragic farce the whole thing is.

Perhaps you have seen a cat playing with a mouse before it administers the final coup de grace. That's what Stalin is doing with us. Here we are, a once great and proud nation, once the strongest militarily in the entire world, *supposedly* with the finest minds in the whole world, and presumably at the very peak of governmental excellence, and we permit ourselves to be sold down the river to a bunch of nomad rats, thieves and traitors, living in lush luxury *at our expense* who laugh at us, as they see to what degrading depths we have sunk into the trap of mongrelized and alien infamy! How much lower can we get before we cry with a mighty roar: "You have done enough! Now get out—out—OUT!!!"

HOW NITWIT TRUMAN PLAYED STALIN'S GAME

At this point it may be a good idea to go back and retrace the step-by-step moves which have mired us in that horrible Korean mess.

Of course, the principal blame can be deposited on Harry Truman's shoulders—simply because he, as our President—*no longer, thank God*—gave all the orders.

I will not say that Truman is a Communist, or even that he is particularly pro-Communist. In my opinion, Harry Truman is a rough, uncouth, hill-billy nitwit. As such, he stands in awe of the Harvard "spit and polish" Achesons and Hisses. Having no brain of his own, he, throughout his tenure of office, was actually Acheson's "Yes" man and cat's paw.

The facts about the beginnings of the Korean situation are very clear. *At the behest of Stalin, vide the U.N.,* the United States agreed to split Korea into two sections and *invented* a 38th parallel. Never in Korean history, not even during the 27 years of Japanese occupation, had there been a "38th parallel," or a North Korea and a South Korea. All of Korea had always been one united people. Came the surrender of Japan—Korea was free! But a free Korea would be a roadblock in Ghenghis Kahn's—beg pardon, Joe Stalin's planned conquest of Asia. In 1945 he didn't dare to try to just step in and "take over"—at that time Uncle Sam had the mightiest military machine on the face of the earth. Hence, his diabolically clever scheme to get half of it—and, at the proper time, have that half gobble up the other half. But there was a fly in that ointment: China—a China controlled by Chiang Kai Shek, who knew Communism and Joe Stalin as well as Joe knew himself. Chiang would never permit Moscow to

take over in Korea. Joey didn't relish the idea of fighting 450 million Chinese--*at any time!* Joey prefers to win with guile, deceit, treachery and terrorism. So, here is what happened:

In 1946, at the behest of Dean Acheson, or Trygvie Lie--or of both, *by order of Joe Stalin*--Harry Truman ordered General George C. Marshall to fly to China and talk "turkey" to Chiang Kai Shek: Chiang was to "invite" the Communists to become full partners with him in the government of China--OR ELSE! As we know, Chiang refused--and the OR ELSE happened. Thus, we, the United States, delivered all of China into the hands of the Communists--WHICH MEANS STALIN!

Now, as in the case of Truman, I will not say that Marshall is a Communist, or even particularly pro-Communist. But I will say that if he ever had anything that resembles a brain, it had become atrophied *long before* 1946. He, himself, proved that when he stated that he could not remember where he was the night the Japs attacked Pearl Harbor--but, perhaps Roosevelt ordered him to *forget* where he was . . . Roosevelt preferred that *everybody* forget all about Pearl Harbor! Anyway, China was no longer a problem for Stalin. But at this point it is vital to highlight a very important feature about Marshall's trip to China.

General Wedemeyer, just prior to Marshall's flight, had issued a full AND TRUTHFUL report of the conditions in all of Asia. Had it been made public--AND HEEDED--there never would have been a Korean "police action." But, by order of Acheson and Truman, *that* report was suppressed. Upon Marshall's return *he* rendered *his* report--a pack of lies from the first word to the last. But the important feature about that report was that it had not been written by Marshall, but by Acheson, Lattimore, Service and Jessup--and in certain quarters in Washington it was loudly whispered that, in anticipation of the reception Marshall would get from Chiang, it was written BEFORE MARSHALL LEFT WASHINGTON!

THE KOREA CONSPIRACY!

In 1947 the Joint Chiefs of Staff were asked to make a study of the world situation in connection with the disposition of our shrunken armed forces. They agreed that if things came to a global show-down the last place on earth where we would want to have our troops would be Korea. There was no disagreement on that point among the military--*and they all still feel the same way!* That military opinion was then accepted by the Administration (Truman), the Secretary of State and the National Security organization which keeps all policy plans. It was made a part of the official--and HIGHLY SECRET--policy of the United States. It must be borne in mind that the military have abso-

lutely no authority in such matters—they merely give a purely professional military opinion which *the policy makers* accept or reject. They accepted this one. Again I stress that all such policy decisions are made by the President of the United States, *on the advice of the Secretary of State*. If they had informed the military, at that time, or at any other time prior to the outbreak of hostilities, that we planned to hold Korea at all costs in case of an attack, the military would have made suitable plans to do so. On the contrary, Truman AND ACHESON (Stalin's lawyer) adopted the "no defense" policy—*but it was a TOP SECRET policy*. And from 1947 to 1950 we gradually withdrew our forces from Korea, leaving the South Koreans with nothing but small arms, *while Moscow was training the North Koreans and arming them to the teeth with ALL types of arms, tanks, planes, etc.* Acheson's excuse for refusing to provide the South Koreans with proper war materiel was that "he AND THE UNITED NATIONS were afraid the South Koreans would attack the North Koreans."!!! . . . *the mouse would attack the cat!!!*

NOW—in January 1950 Mister Acheson loudly proclaimed to the world that Korea was "not within our line of defense." Bear in mind that that was one of our TOP SECRETS!!! Why did Acheson reveal it? It was a *deliberate* and an open invitation to Stalin to go ahead and "take over"!

Furthermore, during the first few days of the North Koreans' attack there was no intention on the part of the United States—OR THE UNITED NATIONS—to interfere with the North Koreans. In fact, Acheson's first order to General MacArthur was to evacuate all Americans from Korea. Then a storm of disapproval erupted all over the world . . . the Acheson-Truman statement (and invitation to Moscow) became a heated issue . . . *the U.N. was harshly criticised for its silence and failure to take action!*

A panicky Truman, after two days of sweating indecision, ordered MacArthur into Korea, but although military appropriations had aggregated 100 Billion dollars since V-J day, only one and a half divisions were available for combat duty. Nevertheless, Chiang Kai Shek's offer of three and a half divisions, *American trained*, was rejected, and Formosa was even commanded to life her very effective blockade of Shanghai and Tientsin, thus opening the way for British shipments of oil, steel and cotton to the Chinese Reds.. But that was not all! At the U.N. demand, Acheson ordered his White House catspaw to order our Navy to PROTECT Red China against any diversionary invasions from Formosa—because that would have forced Mao Tse Tung (or is it DUNG?) to withdraw his forces from Korea to defend China--and again our "great" President obeyed.

No need to dwell on how the North Koreans, magnificently equipped with Russian Armor, Russian Tanks, Russian planes, Russian weapons, swept everything before them right to the very gates of Pusan.

Throughout all this, the "United Nations" did some *talking*, but, as the saying goes, sat on its hands. Our navy was ordered to stand by for the final evacuation—and *the surrender of all Korea to the Communists!* Stalin, in far off Moscow, smiled . . . Acheson smiled . . . Trygve smiled—but *they smiled too soon!*—they failed to reckon with the military genius of Douglas MacArthur. Out-manned, out-gunned, out-tanked, out-everythinged, he held the enemy at bay at Pusan and then pulled his Inchon invasion—to *panic and completely demoralize the North Koreans!* The "police action" should have been concluded right then and there—but Stalin took off his mask and rushed in 250,000 of his Russian trained and Russian equipped Chinese from Manchuria. Even so, MacArthur had the solution of the entire situation well in hand—he decided to bomb the Red installations on the Yalu. That was the one kind of action Stalin feared! Immediately screams of protest arose from the Russian and all other Communist delegates in the U.N.! Trygve Lie protested! Dean Acheson protested! Dapper Dean told Truman that MacArthur was a Bull in a China shop (meaning that MacArthur was destroying Stalin's China shop) and demanded his dismissal . . . "you ain't never had it better" Harry obeyed.

Even so, our pitifully small army continued to tear the enemy to shreds, despite all of its Chinese manpower and Russian arms. The Reds were completely licked and shattered—one more powerful attack and they would have been swept out of Korea. That was when Moscow's Gromyko suggested "truce talks" to Trygve—Trygve suggested it to Acheson—Acheson suggested it to Truman . . . *again Truman obeyed!* Those disgraceful and humiliating "truce talks" served but one purpose: it gave Stalin time to recover, re-organize, re-equip—all the time slaughtering our sons.

You know the rest. You know how General Van Fleet pleaded and pleaded and pleaded that he be allowed to replace our American boys with South Korea Divisions. Trygve said "No." . . . Acheson said "No" . . . Truman said "No!" So the slaughter of OUR boys will go on ad infinitum—until the American mothers and fathers come to their senses and force an end to this treachery, deceit, and treason! The American people did speak their minds at the polls on November 4th! *Now we will see what Ike will do about it!* WILL HE DEFY THE U.N. AND THE INTERNATIONALISTS WHO NOMINATED HIM?!?!?

OUR OWN CONSTITUTION USED AGAINST US!

Before I conclude this Bulletin, I wish to stress one more fiendishly clever "gimmick" injected into the U.N. Charter by Stalin—or it might have been by Alger Hiss, or Roosevelt, or Acheson. That "gimmick"

alone can destroy the United States as a sovereign nation—and it can transform every free American into a Siberian Labor Camp slave.

Our Constitution was prepared and written by our Founding Fathers to stand forever as an invulnerable guardian of our nation. Stalin knew it—Roosevelt knew it—Dean Acheson and Alger Hiss knew it. But as we all know, clever lawyers can always find loopholes in every written document—just one misplaced comma, or semi-colon, *could* be transformed into a loophole.

As I previously stated, Hiss and Roosevelt burned much midnight oil studying our Constitution. No doubt Acheson did, too—and Vishinsky and Molotov and Stalin. *And between them they found that loophole!* They found it in Section 2 of Article Six—which reads as follows: “This Constitution, and the Laws of the United States which shall be made in pursuance thereof: *and all Treaties* made, under the Authority of the United States, shall be *the* Supreme Law of the Land.” Thus a “treaty,” approved and signed by our Senate, automatically becomes the Law of the Land, superseding all Federal, State—and *even Community*—laws.

So'o'o—a provision was written into the U.N. Charter giving the UNITED NATIONS the power to enter into TREATIES with its member nations, and/or non-member nations. Primarily, however, that power was granted to the U.N. to enable it to handcuff and leg-chain the United States of America and make it a helpless victim for Moscow!

Moscow, in a way, is very patient. Stalin had the U.N. proceed slowly and carefully with that “treaty” power. They first tried it out on California, when they SUCCESSFULLY outlawed that State's long-standing “Alien Land Law.” That “test” created considerable murmuring—but *only in California*, as it did not particularly affect the other States. But it was a definite protest against U.N. interference in our Domestic affairs—and it startled Joe and Trygvie and Dean. They realized that if the U.N. tried to ride their “treaties” rough-shod over the American people we *might* “wake up” and tear that “Charter” and the UNITED NATIONS to shreds. They decided that a camouflage and blinding “dust clouds” were needed to shield the U.N.—*and here is how they went about it.*

As I revealed in my book “Red Treason in Hollywood,” right up until 1947 the Reds in Hollywood had flooded our Screens with “glorify Moscow” films—such as “Mission to Moscow,” “Song of Russia,” “North Star,” etc., etc. At the same time they were putting out “Smear America” films. But in 1947 I stopped that singlehandedly: I began to NAME the Reds in Hollywood who had written, produced, directed and acted in those films. I was promptly branded a “Red-baiter,” a “Witch-hunter,” and threatened with their chief weapon:

the "blacklist." *But all the Studios scrapped all their unfinished "glorify Moscow" and "Smear America" films and scripts.*

Balked in that propaganda job, Stalin decided to use his still "eager Beaver" Hollywood Reds to provide an umbrella for the UNITED NATIONS "treaties" scheme. From Moscow came an order to flood our Screens with "Peace, eternal Peace," via "One Worldism" films.

My friends in the industry (I have always retained many valuable, albeit necessarily SECRET, friends in all the Studios) promptly informed me of the "switch." On April 12, 1948, I delivered a public address at the El Patio Theater, and NAMED one hundred of the top Red Stars, Writers, Directors and Producers. That *really* created a sensation . . . it rocked the nation . . . and led to the Congressional investigations of Hollywood that followed. And from every Red throat in Hollywood came anguished screams of "Liar!" "Character Assassin!" "Red-Baiter," etc. The "blacklist" was really clamped down upon me. I ignored the smears and the threats, and followed up with "Red Treason in Hollywood," in which I NAMED *over two hundred and fifty* Hollywood Reds, unmasked all the "Red Fronts," and NAMED the guilty Studios and Producers.

The screaming increased to a crescendo! And this time they called upon the power of that most of all poison-for-America outfits, the "Anti-Defamation League", to smear me into oblivion. The ADL used its most dreaded weapon: the "anti-Semitic" brand. They stopped at nothing. In turn, I exposed, *with documentary evidence*, that the ADL was a Red-dominated outfit. And as evidence that not one of my charges was even *remotely* faulty, not the ADL and not one of those 250 millionaire Reds, who can afford the best lawyers in the land, ever dared to sue me for libel!

But they could—AND DID—threaten death and bodily harm. My friends, alarmed, urged me to surround myself with bodyguards. I laughed and retorted that I had one perfect bodyguard—my 60 pound Airedale, Magee . . . he is as fast as a bullet, fierce as a tiger, and can *smell* a Red a mile off—and he hates that scent as much as I do.

At this point, I might add that nobody *outside* the industry, not even the FBI, could have defanged the Hollywood Reds the way I did, because only someone *within* the industry, who knows every wrinkle in the brains of it, and who has "pipeline" friends within it, could have accomplished that job. I am not seeking any kudos for it--it just happened that I am one of the old-timers in that industry—and, maybe, that was my "mission" on earth.

However, Stalin has more than one string to his bow. When he realized that the U.N. would have to manipulate its "treaties" behind a smoke screen, he ordered his zealous American stooges to create and organize, "Peace, Glorious Peace" propaganda through "One

World" movements. In late 1947, 1948 and 1949, a perfect rash of such organizations broke out all over the country. Having previously named and exposed all of them, I will merely refer to the activities of the most powerful one, the "United World Federalists." It suddenly burst onto the American scene in 1947, window-dressed with some of the finest and most respected names in America, and with unlimited finances. In March 1949, with the aid of the notorious Liquor Lobbyist, Artie Samish, they railroaded the California State Legislature into passing a "Resolution" for a "One World Government."

Only one man in that entire Legislative body, Senator Hugh Donnelly, sensed that there was "something rotten" in that "Resolution." But it was so craftily camouflaged that he couldn't find the "darkey" in that "woodpile." He called Senator Jack B. Tenney's attention to it, on the theory that Tenney's vast experience as head of the California State Investigating Committee would enable *him* to see the "gimmick" in it - but Tenney, while as suspicious as Donnelly, couldn't put his finger on the hidden menace. But, on general principles, they demanded a hearing before the Judiciary Committee - and a recall of the "Resolution." They were disastrously defeated. It was then that they called on the CINEMA EDUCATIONAL GUILD for help.

We promptly put in motion our own investigating machinery in Washington and New York. Within a couple of weeks we had the entire story--the UWF was just another Moscow "gimmick." In July 1949, we issued a 42-page booklet, entitled "Reds Behind World Federalism," in which we NAMED the more than 10 notorious Reds who organized that treason outfit in Asheville, North Carolina, in February 1947--and outlined their scheme to transform the United States into a unit of a Communist controlled "one world" government.

Once again I became the target for every type of smear. The "American Association for the United States," whom I had previously exposed as out-and-out Red dominated, rushed to the defense of the UWF . . . one Canham, the Rhodes Scholar (truff sed) editor of the "Christian Science Monitor," published a viciously scurrilous editorial, denouncing me as an anti-Semite and falsely linking my name with one G. L. K. Smith . . . a pinko Radio blabbermouth, named Chet Huntley, added his screeching voice. But *they could not deny my charges!* A month later I published "Federalists demand: ABOLISH THE UNITED STATES." Within a few months the UWF went puff! --and with them went all the "One-World" treason plots.

And once again I learned that arguments and debates against the fiendishly clever Communists are of no avail--NAMING the REDS behind those treason plots is the only effective RAT poison!

THE U. N.'s "GENOCIDE" TREATY

Seizing upon the confusion and turmoil of the battle with the UWF as a good smoke screen, the UNITED NATIONS decided to try to sneak through one of its own "treaties"—a treaty which would achieve all that the UWF very nearly put over, *and more*. That U.N. "Treaty" was known as the "GENOCIDE PACT." *And, oh, but it read beautifully!*—it was so "humanitarian."

Ostensibly, it was for the purpose of preventing atrocities such as the Hitler mass murders of the Jews, etc., etc. *Of course, it made no mention of Communist mass murders!* Those were necessary "purges." Nor did it even hint that when Trygve submitted the idea, the "gentlemen" of the Kremlin so reworded it that it would leave *them* free to commit their mass "purges," and operate their Siberian Slave Camps, but it would tie up the United States into a million—or, rather 155 million—knots. Here is the "joker":

The crime at which the "Genocide Pact" is supposedly aimed is that of mass murder of "minority groups," or even the wanton killing of any one member of such groups, but, *carefully camouflaged*, it makes physical or MENTAL injury to such an individual an equally greivous "crime"—and the "criminal" can be taken out of his own country to be tried before any court designated by the UNITED NATIONS, whether it be located in Paris, or Prague, or Moscow; and no law of his own country can be invoked for his protection. Thus, under the "Genocide Pact," *aimed at the United States*, if you (any American) should hurt the feelings of a Jew by casting even a *joking* aspersion on his race, or that of a negro by thoughtlessly calling him "nigger," a common word in this country, you have "mentally injured" him, and you can be hauled off to a court in Tel Aviv, or in Afghanistan, *as decided by the UNITED NATIONS*, and, if found guilty, shipped off to hard labor in a Siberian Slave Labor Camp (all Americans are welcome there), or even hanged—and *the United States could do nothing about it*—IF OUR SENATE APPROVED AND SIGNED THAT "TREATY."

Inasmuch as we covered the entire story of that sinister plot in our November 1950 Bulletin, entitled "Genocide, A Menace to the United States," there is no need for further details here. But I will stress one *amazing and frightening*, fact in connection with it: that "Treaty" had had the blessing of Harry Truman, and even of some important men *with brains*. It was up before our Senate Foreign Relations Committee, and due *to be signed* in March 1951. When I arrived in Washington in February 1951, to oppose it, I discovered, to my horror, that even men like Fulton Lewis, Jr., and Senator Pat McCarran knew practically nothing of its SINISTER import, and approved its acceptance by our Senate. Of course, it didn't take me long to "alert" them—and the "Treaty" was NOT signed. But that emphasizes the constant danger

we are in with all those UNITED NATIONS "Treaties" constantly bobbing up.

The "GENOCIDE TREATY" is *by no means* the only such American sucker-trap the UNITED NATIONS has on its agenda. There is that one they call the "Covenant on Human Rights of the U.N.," which they are trying to slip through under the sponsorship of that "great" American Matriarch, Eleanor Roosevelt, who, for years has been preaching that we should turn over all our wealth and property to Moscow for distribution among the under-privileged peoples of the world—*not in those exact words*—but what are mere words to that fuzzy-brained female? Then there is that UNFSCO deal, by which the UNITED NATIONS would take over the molding of our children's minds, so as to make them think in GLOBAL terms instead of the American way of life. Also, there are the demands of the U.N. that we abandon our immigration laws, our tariffs, our Foreign Policies, etc., etc. There are scads of them. Each one means another fight all over again. Sooner or later, one of them *might* escape our vigilance and become the Law to destroy us.

Shortly after the "Genocide Pact" was halted, Senator Bricker, joined by more than 50 other Senators, introduced a proposed Constitutional amendment to limit the effect of such "Treaties," or agreements. The spontaneous rallying to the Bricker proposal by so many Senators *of both parties* shows the deep misgivings that this "Treaty" provision in the U.N. Charter has evoked. All those Senators feel, as Bricker phrased it, that "at present the UNITED NATIONS appears inspired by an ambition to define and enforce BY TREATY the economic and political rights and duties of every human being in the world—but especially of those in the United States. The most comprehensive of these proposed treaties at the moment is the UNITED NATIONS draft "Covenant of Human Rights."

That is putting it MILDLY! Why keep writing AMENDMENTS to our Constitution to protect ourselves against the machinations of a known enemy? We have all the evidence we need to know that the UNITED NATIONS is our Stalin-created nemesis! It has cost us the precious blood of 125,000 of our sons, *to date*, to discover it! Must we have them murder another million before we take action?

We have only one solution, AND ONLY ONE, for that problem—which also means the salvation of our country: GET THE U.S. OUT OF THE U.N. and DRIVE THE U.N. OUT OF THE U.S.!!! Tear their very roots out of our soil! Destroy that Spy Nest within our land! Destroy forever that sanctuary for all of Moscow's saboteurs!!!

In conclusion: *don't* go "to sleep" feeling safe merely because the rats who have betrayed us for 20 years are now driven out of Washington. We don't know but what other rats will take their places. Eisenhower

is NOT the complete solution of our problems—especially if he surrounds himself with Deweys and Fines and Stassens! Don't forget that Ike has proclaimed that George C. Marshall is a GREAT American—even though he KNOWS how Marshall sold us out in China and Korea . . . don't forget that Ike has vowed to STRENGTHEN the UNITED NATIONS!!! Maybe he will listen to the Tafts and the Brickers and the McCarthys—but *it may well be that his ear will be all for Dewey and Duff and Lodge!* Forewarned, let us be forearmed. Taking him at his own word, we CANNOT leave the UNITED NATIONS job to Eisenhower! *That is up to YOU and ME!!!*
