Now all the above measures may apear to be provocative and harsh, but they are the only ways to abruptly bring to an end a "war" in which, to begin with, we never had any business to become involved—and in which we never would have become involved if Eisenhower, Kennedy and Johnson had not deliberately object the UN to get us so involved—a war to be continued for another five, ten or more years, as it will suit the UN Conspirators! . . .

The average American, no matter how well informed he may think he is, cannot possibly know what goes on behind the scenes

of Government. He cannot possibly know the treasonous political "reasonings" as to why we are fighting a deliberately "no-win" war, sacrificing our Youth and our wealth, that is unprecedented throughout the history of military science—knowing, as we all do, that we have the military strength to crush North Vietnam with practically a single blow!

But those 27 Military men who signed the original "PETITION" do know all about the treason behind both the Korean and Viet Nam "no-win wars." They know the only way to smash all that treason. They want all of the American people to know. That was why they appealed to our Mass Communications Media to tell the whole story to the people. But, as already described, only one publication, "SCIENCE & MECHANICS," responded to that appeal. But to make sure the American people know that those 27 men really know all the facts, they (SCIENCE & MECHANICS) assigned Lloyd Mallan to do a thorough job of researching—to get all the answers from unimpeachable sources Mr Mallan spent three months in steadily "digging" and interviewing for all the behind-the-scenes information.

At first he ran up against a stone wall, so to speak. His first bit of information was stunningly surprising. He applied to the Pentagon, as the surest source, only to discover that no military officer of either the highest or the lowest rank was permitted to talk about why we are doing the bewildering things we are doing in Vietnam. All those officers were permitted to give him a so-called "briefing" on the way things are going in the "war," but they were not permitted to give him their personal opinions or criticisms—even "off-the-record." As one Public Affairs Officer in the Department of Defense explained it to him: "Even if you would not attribute your quotes to a specific officer, his name would be known after you published your article—because there would be a record here of the officers we cleared you with for interviews. That record is mandatory—and anuone who would make a revelation that is "classified" would be subject to at the very least, a court martial."

Thus, it is obvious that our supposed "Frcc" Press is not only controlled by the CFR, but, even if it were not so controlled, would not be permitted to inform the public about Government policies that could be—and are—wrong Mr. Mallan was effectively blocked by the Department of Defense at the very beginning of his investigation—or so they thought. But, Mallan had a few old friends in the Pentagon who were willing to see him on the q t—as it were—that is, outside of the Pentagon. He went to one of these who had spent considerable time in Vietnam and, by that token, was not a novitiate in his job. Mallan could not, and will not, identify either

It would force Ho Chi Mien's hand-he would have to recall his troops from the South to fight for survival in his own homeland. And I might mention that our firepower is far superior to that of the North Vietnamese Army. Another factor, an extremely vital one in this kind of invasion, is the psychological one: the people of North Vietnam would see that we meant businessit would shake them up-and Ho would be faced with internal dissent as well as with external military force . . Add to this an invasion over the 17th Parallel and concentrated bombardment of EVERY important target by air and sea-AND THE WAR IN THE VORTH WOULD BE FINISHED WITHIN SIX WEEKS

"But," asked Mr. Mallan. "how about the Victoring in the South—

wouldn't they continue to fight their guerrilla war against Saigon?"

"They would—for a while," replied the officer, "but anyone who wants to fight effectively needs food as well as arms. Their MAJOR supply of both would be cut off with the defeat of Hanoi. the following story:

"Just after the Air Force was removed from Army control and set up as a separate military department, the emphasis was placed on air power. At that time the President (Eisenhower) saw the vital importance of building a powerful Air Force, (so he said) second to none in the world. So the higgest part of the Defense budget went into realizing that aim. General Maxwell Taylor, then Army Chief of Staff, resented that idea. He tried very hard to persuade Eisenhower to build up the Army rather than the Air Force. His argument was that, if ever again a shooting war got started, there would be a huge vacuum if the Army were not properly supported Eisenhower, although an ARMY man, rejected Taylor's argument, the reason he gave was that there are some enemy armies, the Red Chinese in particular, with their multitudes of potential conscripts, that we could not effectively fight with a land army But, he stressed, we could destroy that enemy's capability to support an army with superior firepower from the air and the sea—knock out his means of communications, industrial production and food production. He also proposed a new approach to warfare: bearing in mind how MacArthurhad been circumvented in Korea, and sensing another Korea-type of war in Vietnam, he wanted to get some Army troops into Vietnam—AS A WARNING TO NO VIETNAM AND HO CHI MIEN."

(Note:—During Eisenhower's Administration, a comparative handful of U.S. military advisors had been sent to Vietnam at the (supposed) request for aid by the Saigon Government. But Eisenhower had insisted that those Advisors wear crivilian clothes. Taylor's plan, as he (Taylor) expressed it to Kennedy, was to send UNIFORMED men to Vietnam, which was to be the first step toward building our Army's prestige and power in that area. And, strangely, however, he proposed a system of minor escalations, to with hit the enemy—but not too hard—and stop and wait to see what he (the enemy) will do next. That was his theory of "flexible response" To a trained (and loyal) military mind, as some have expressed it, it is a slow-moving way to fight a war, because it keeps you pressed it, it is a slow-moving way to fight a war, because it keeps you basically on the detensive—but General Taylor evidently viewed it differently. Just exactly what motivated that "view" is anybody's guess. That it was a lack of military intelligence is hard to believe vet it is equally hard to believe that he was voicing the "views" of other men who wanted the U.S. to adopt that kind of war "game." Anyway, the idea appealed to Jack Kennedy and his "intellectual" advisers in the White House... bear in mind that among those "intellectual" advisers were Rusk, McNamara and others of that (CFR-controlled) ilk! They (Rusk, McNamara and the others) thought (?) that that would be a "humane" way to show the that that would be a "humane" way to show the enemy (Ho Chi Mich and the No. Victnamese) that we were supporting the South Vietnamese Government—without any danger of an actual confunction with Pol Chi funtation with Red China or Moscow

After they (Kennedy and his advisers) bought the idea, Taylor saw his Army gradually come to life again. The few American military advisers wearing civilian clothes in Vietnam under Eisenhower soon expanded to 16,000 troops in uniform under Kennedy. Then, because Taylor's "flexible response" technique actually bought time for the enemy to infull that more and more troops from the North into for the enemy to infiltrate more and more troops from the North into

the South, the U.S. was forced to meet the challenge by sending more and more troops, until by November 1967, there were approximately a half-million of our men in Vietnam—and little more than 10 percent of them were Air Force and Navy Personnel! Thus, as we know, under Johnson, the war continuously escalated in terms of men and firepower. But both were—and still are—restricted to the "flexible response" technique—which is not so "flexible" after all, because it has been keeping us in an (militarily) unscientific straitfacket of limiting our objectives. Actually, in the minds of those (CFR-controlled) civilian Government "intellectual" advisers to the President (both IFK and LBI), the phrase "LIMITED WAR" has been equated with "LIMITED" wantare—which means a "no-tein" policy.

At this point, let's go back to that period when Taylor was badgering Eisenhower to build up our Army and Eisenhower's contention that to combat a possible conflict with the Red Chinese it was far more important to build up our Arr and Naval power so as to enable us to destroy the enemy's (Ho Chi Mich and the Viet Cong) capability to support an army with superior firepower from the Air and Sea. What became of that "strategy" During Eisenhower's Administration, we DID have such Air and Sea firepower superiority. Why was it never used during the past 8 years of JFK and LBJ Administrations? I will answer that question by quoting a report from "U.S. News & World Report" of June 10, 1968 At this point, let's go back to that period when Taylor was badger-

"From Gen. Curtis E. LeMay comes a warning of 'grave danger' for the U.S.—and one of the hardest-hitting attacks yet on Robert S. McNamara's seven years in the Pentagon

"This country," says the retired Air Force Chief, "is in deep military trouble a result of civilian control of the Pentagon' In a book, 'AMERICA IS IN DANGER, 'Gen. LeMay says:

"'We have permitted our general war capability to rust ... we have scrapped 1,000 B-47's without providing replacements. Our B-52's are also on the way out... Our Minuteman force has been reduced to a thousand missiles while our higher-yield Titans are phasing out. Our Polaris submarine fleet is static at 41 vessels ... No 'anti-ballistic missile system' has been put into service. We stand nakedly exposed to a first-strike! Even our air-defense system has been allowed to deteriorate. We have no space weaponry of any sort. Our survival depends almost exclusively on the effectiveness of Minuteman and Polaris—and how effective are they? No one truly knows!

"'After tracing the massive Soviet build-up of recent years,' the General - 14 -

concludes: 'If we have not already lost our military superiority, we are well on the way to it."

"The main reason for today's troubles," writes General LeMay, "is a strategy of deterrence, that has placed the U.S. in a purely defensive role in the war.' The blame for this is placed on Mr. McNamara, who served as Secretary of Defense from 1961 until his retirement earlier this year. In aiming for nothing more than nuclear parity with the Soviets. Gen. LeMay charges, Mr. McNamara in fact cut back our nation's power to a secondary position. He is accused of wresting 'every residual threat of authority' from the Joint Chiefs of Staff and of dictating decisions despite unanimous military opposition. Gen. LeMay says these were almost always wrong and wasteful and accompanied by 'flagrant bits of deception' presented to Congress and the public.

The Defense Secretary's decision to cancel the Skybolt Air-borne missile creating a diplomatic furor in Britain, was made without any consultation at all with main advisers, Gen. LeMay says. He faults McNamara for his delay of an anti-missile system; for scrapping the B-70 Bomber; and for pressing ahead with the F-111 Bomber version. Gen. LeMay calls the F-111 an inferior stopgap weapon system. Of McNamara's creation of a unified Defense Intelligence Agency to supersede those of the individual services, and creation of other vast military bureaucracies, General LeMay states in his book: 'I question whether an organization as unwieldly and amateurish as has been created by the Secretary of Defense could ever propagate a successful war—the dismal results in Vietnam attest to this doubt."
