THE ENEMY IS "RUNNING SCARED"

In our preceding "News-Bulletin" (No. 97) we rendered a lengthy report on the growing awakening of the people despite all the frantic efforts of our "Leaders" and the controlled press to keep us confused, bewildered and bemused. Perhaps the best proof of that was provided by the hysteria and outright falsehoods in a speech delivered on the floor of the Senate on May 2 by Senator Kuchel, a rabid Left-winger, posing as a Republican conservative. Actually, his "speech" can best be described as a diarrhea of words and constipation of thought—even the "Liberal" Senators were too nauseated to stay to hear it out, but, *as intended*, it promptly was front-paged all over the country.

In order to get a clear picture of this "Gentleman from California," I will briefly go into his background:

In his early years, Tom Kuchel was a minor political opportunist in Southern California. As one of the means to advance his political aspirations, he became a fawning Earl Warren bootlicker. Thus, when one of the California Senate seats became vacant, Warren, then Governor of California, appointed his protege (Kuchel) to fill the vacancy. In 1960 Kuchel ran for election. His opponent was one Richard Richards, an even more brazen Lefty. Kuchel won, despite the fact that his voting record revealed that he consistently favored (*at least 70%*) ADA and other Left-wing objectives—in other words, the voters elected him as the lesser of two evils . . . *that "lesser of two evils" has for more than 30 years been the cancer that is gradually destroying our nation!*

In his (May 2) speech he fulminated hysterically against all patriotic organizations and publications. And with that he coined a new term of opprobrium for us. "Red-baiter" has become an outworn cliché—even "anti-semite" and "anti-negro" are no longer sufficiently horrendous, so Mister Kuchel came up with a brand-new "horriification"—he lumped all of us as "fright peddlers." And all the "Liberal" editorial writers of the controlled press joyously pounced on that new "brand" of opprobrium! They acclaimed the entire "speech" as once we were wont to acclaim our "Declaration of Independence." They furiously berated us (*fright peddlers*) for our "outrageous" efforts to alert and warn the American people about the Internationalist-Communist plot to destroy the sovereignty of our nation . . . to transform the U. S. into an enslaved unit in a UN One-World Government . . . and about the (*unilateral*) "DISARMAMENT" plot fostered by Kennedy and the State Department to transfer all of our Armed Forces and Armaments to the

UN, etc., etc., etc.,—all of which Mister Kuchel and various of the “gentlemen of the press” hysterically insist are false. And they revile all patriotic groups and loyal American individuals as war-mongering alarmists who have been conjuring up a lot of “ghosts” to “frighten” and “victimize” the “gullible” among the American people.

The “ghost” that particularly infuriates Mister Kuchel and the editorial writers is our denunciation of the above mentioned “DISARMAMENT” plot. This plot was launched under the following official title:

*“Department of State Publication 7277 . . . Disarmament Series 5—
Released September 1961 . . . Office of Public Services . . .
BUREAU OF PUBLIC SERVICES.”*

It was first unveiled at the Sixteenth General Assembly of the UN. Then it was submitted to our U. S. Congress—whence it emerged as “PUBLIC LAW 87-297.” It was “railroaded”—exactly as the “UNITED WORLD FEDERALISTS” traitorous “RESOLUTION” was “railroaded” into approval and passage by the California State Legislature in 1949. This “PUBLIC LAW 87-297” gives Kennedy the frightful power to transfer ALL of our Armed Forces and Armaments to the UN—and to transform the U. S. into a unit of a (UN) One World Government . . . **a power which, if he so much as dares to attempt to use it, should promptly mean a hangman’s noose for him—and for every traitor who will aid and abet such treason!**

Now, in his speech, Mister Kuchel frenziedly denied that the “DISARMAMENT” proposal contains even a remote possibility of harm to the U. S. and the American people. Very well, ask him, or your own Representative, to send you a copy of that “U. S. State Department PUBLICATION 7277.” After you receive it, I urge you to read it SLOWLY—in order to pierce through the thin and obvious camouflaging of the plot. You will find it to be EXACTLY the same plot, virtually word for word, that was embodied in the brazen 1949 UWF “RESOLUTION,” which was fully exposed and rescinded by the California State Legislature in 1950, and proclaimed to be “an outright treason plot”—and the UWF was denounced as “a cabal of traitors.”

Note: The entire “PUBLICATION 7277” was published, VERBATIM, in our “News-Bulletin” No. 91. M.C.F.

At the time (1949) we were demanding a review of the UWF “RESOLUTION,” there were a number of Kuchel-type politicians in the California Legislature. They, too, frenziedly screamed against our demand. They, too, called us “fright peddlers,” only

their term was "*the lunatic fringe*" — you see, all the One-Worlders constantly must keep finding new and more horrendous "*brands*" for the loyal Americans fighting to thwart their plots. Well, that review not only unmasked the treason in that UWF "RESOLUTION," it also unmasked all the Kuchel-type politicians in the California Legislature—and *torpedoed many of them out of public life*. I predict the same thing will happen when Congress will finally take the necessary steps to unmask the "DISARMAMENT" plot . . . it was the finally alerted people in California who forced the unmasking and rescission of the UWF "RESOLUTION"—it is up to loyal American people in all our States to do the same for the "DISARMAMENT" treason plot . . . *our "Tract No. 8," can do the job!*

In his "*speech*," Kuchel stated that he receives 60,000 letters each month from his constituents. He said that only 10% are from those who are "*deluded*" by the "*fright peddlers*" . . . from a very reliable source, right on his own staff, we are informed that the reverse is the fact—that most of his letters come in the form of SIGNED "*Tracts*." Undoubtedly, that, in a great measure, prompted his "*speech*."

"WE DONE UN WRONG," SAID TOMMY

Another of our dreadful "*ghosts*" that horrifies our "*Liberal*" Mister Kuchel is our revelation of the Hiss-Molotov secret agreement whereby a Moscow Red is ALWAYS to be the Chief of the UN Military Secretariat.

Note: The official title of this Secretariat, as incorporated in the UN Charter, is: "THE DEPARTMENT OF SECURITY COUNCIL AFFAIRS, to serve also the General Assembly in all political questions and the Atomic Energy, the Disarmament, and other Commissions." M.C.F.

Resorting to the verbiage of the ridiculous denials by the State Department, Kuchel vehemently denied the existence of the Hiss-Molotov agreement—*then he put his hoof in his big mouth by reciting the FACT that since the very inception of the UN, that post has been held consecutively to this very day by a Moscow Red—he even NAMED all of them!*

I won't go into all the details of that cock-eyed denial, because, by a truly strange coincidence, the complete answer for it is to be found in our "*News-Bulletin*," No. 97. Indeed, that "*News-Bulletin*"

clearly throws back into Kuchel's teeth all the half-truths, distortions and outright falsehoods in his idiotic diatribe.

However, there is one statement in that "speech" for which I am truly grateful—that statement was:

"But consider the key and most frightening plank in these leaflets (Tracts)—the charge that a Russian colonel is commanding or will command all of our military. Can its origin be found? . . . Yes, it can. It can be found word for word in, of all things, a stage play written in the early 1950's by one Myron C. Fagan, the national director of something in Hollywood called the Cinema Educational Guild. The play, titled "Thieves' Paradise," purported to show, in Fagan's own words:"

And then he listed all the revealments in the play, among which were the Hiss-Molotov secret agreement; the details of how the UN was set up to be a "housing" for the Internationalist-Communist One World Government; how the UN was to promote, militarily and otherwise, the Communist take-over throughout the world, a la the Korean "police action," etc., etc., etc.

Of course, he rantingly "refuted" all the revelations in "Thieves' Paradise," but by his mere mention of the play, he established beyond all further debate that I was the very first person to publicly reveal the entire Great Conspiracy. Whether by design, or otherwise, he included some ridiculous mis-information. He stated that the play was written "in the early 1950s." That is not true—I wrote the play in 1946, some three years before Hiss was exposed as a Communist spy in our State Department—it was staged at the Las Palmas theatre in Hollywood in 1947 . . . Again I refer the reader to our "News-Bulletin," No. 97—I provided all the facts about this matter in that issue . . . it was as if by some form of telepathy Kuchel had conveyed to me what he was going to say in his so-called "speech."

In his speech, Kuchel referred to our (CEG) "UN Tract No. 1." To refute the charges in this "Tract," Kuchel employed virtually the same verbiage found in the "STATEMENTS" issued by the State Department. I devoted several pages in "News-Bulletin," No. 97 to those "STATEMENTS," particularly the one in which they tried to tear to shreds our "UN Tract No. 2," entitled "THE TRUTH ABOUT THE UN . . . As Revealed By TRYGVIE LIE." This "Tract" contains excerpts from Trygvie Lie's book, "IN THE CAUSE OF PEACE," which conclusively establish the existence of the Hiss-Molotov secret agreement . . . the book establishes in no uncertain way that Lie was fully aware that his position would be in jeopardy if he refused to assign the "Military Secretariat" to the RED designated by Moscow. The State Department, through the

years, issued various "STATEMENTS," in one of which they charged that our "quotes" were "entirely fraudulent," on the ridiculous grounds that Lie had never "authored" the statements we quoted . . . in another "STATEMENT" they charged that "the quotes had been taken out of context" . . . in another one they stupidly stated: "Lie didn't mean what the words in the quote implied."

Obviously, space limitations of the "Tract" prevented full-page "quotes." We quoted only the phrases and statements pertinent to the full establishment of our charges. Hence the misleading retorts in the "STATEMENTS" and in Kuchel's speech. Therefore, I have decided to employ the only sure-fire method to settle the entire controversy, to wit: In our following "News-Bulletin," the final five pages will be devoted to *photostatic reproductions* of the pages in Trygvie Lie's book from which we chose our excerpts for "UN Tract No. 2." Thus you will be able to draw your own conclusions as to "THE TRUTH ABOUT THE UN—as Revealed By TRYGVIE LIE" (title of our "Tract").

Before I close my book on this particular "ghost," I wish to throw back into Kuchel's teeth one particularly brazen lie in his speech: he charges me with the "fabrication" that all of our Military Forces are to be (*after we will transfer our Forces to the UN*), under the sole command of a mysterious Russian Colonel. Now, he saw "Thieves' Paradise," the play upon which he bases his charges—nowhere in that play is there even a remote reference to a "Russian Colonel"—nor did any of our subsequent publications, nor the "Tracts" from which he quoted, contain anything about any "Russian Colonel." In the play, I NAMED every individual involved—ditto in all of our publications . . . how about that, Mister Kuchel?

OPERATION "WATER MOCCASIN"

This is another "ghost" that has our Kuchel man chewing his nails down to the quick. And for this "horrid canard" he flayed one Theodore Jackman—whom he promptly linked up with the "awful, fright-peddling" John Birch Society. The whole story is utterly false, Mister Kuchel palpitated. It was just a simple little Army maneuver, in which only a few hundred American troops and just 124 Foreign Observers participated, he insisted. He completely ignored the stark evidence that the original plan, until exposed by Mr. Jackman, called for large contingents of Ghanian, Indonesian, Czech, and other foreign troops, to be included in the "maneuvers"—and that it was to have been another UN "Dress rehearsal invasion"—

identically the same as the UN "Agressi invasions" of the California cities in 1951, only on a far more massive scale.

(Note: Immediately after we were first alerted to "Operation Water Moccasin" we launched a massive research for a complete appraisal of that project, and of the similar ones to follow in the Carolinas, California, Washington and other Pacific Coast states. Our findings will be published in a SPECIAL BULLETIN very shortly . . . we will show how these projects directly fit in with the overall "One-World" plot. M.C.F.)

THE "DEBUNKERS"

At this point, it is well to show how far Kuchel and his so-called "debunkers" reach "*below the belt*" to smear and discredit those who would alert the American people to the treason being perpetrated by our Khrushchev-described "*Leaders*"—*such as Kuchel!*

In his speech, after quoting excerpts from our "UN Tract No. 1" which clearly reveals the Hiss-Molotov secret agreement, Kuchel ponderously propounded:

"Now, first, who is Myron C. Fagan, who discovered this vile plot so many years ago? . . . I quote briefly from portions of the State Senate Fact-Finding Subcommittee on Un-American Activities to the 1961 regular California Legislature:

"We do not wish to impugn the sincerity of Mr. Fagan, but we do wish to make public the facts about his Cinema Educational Guild, and our opinion concerning the erroneous nature of many of the statements in its publications . . . There are heavy evidences of anti-semitism throughout many of the booklets and in many of the Fagan speeches . . . Mr. Fagan may well be one of the nation's outstanding experts on matters theatrical, but that does not qualify him as an expert in the field of countersubversive intelligence."

And there it is! Three disjointed "*quotes,*" all—to use the State Department's (and Kuchel's) pet expression when seeking to discredit our "*Tracts*"—*taken out of context,* in order to emphasize their pet "*anti-semitic*" smear.

But now, paraphrasing Seargent Friday of "*Dragnet*" fame, let's have ALL the facts about that California State Committee's "*REPORT*"—facts which completely reveal the charlatantry of all such "*honorable gentlemen*" posing as our "*Leaders.*"

In 1949 we (CEG) issued the first of our "*Red Stars Tract*," in which we named some 250-300 of the Reds and Fellow-Travellers in Hollywood. The entire Motion Picture Industry promptly erupted into shrieking protests—but, the most strident shrieks came from a more amazing source, none other than the "*Anti-Defamation League*" (ADL). All of the protests and challenges from the Film industry were based on the fact that the "*Tract*" contained no *proof* of the pro-Communist activities of the individuals named. But the ADL's denunciations were based on the fact (*their statement*) that 87% of the individuals listed in the "*Tract*" were Jews.

Thereupon, we issued our "*Documentations*" book, in which we provided documented and incontrovertible evidence of the guilt of each and every individual named in the "*Tract*." The evidence was composed of *official citations* issued by the "*House Committee on Un-American Activities*," by the "*California State Senate Fact Finding Committee*," by the FBI, and various other such Agencies . . . and that was the end of all alibis, denials and protests.

The demand for the book was very heavy during the next several years. We had to issue a number of re-prints between 1950 and 1959. But in 1960 we announced that we could fill no more orders—for two specific reasons: . . . 1) our entire stock of the book was exhausted . . . 2) The *prime reason*: the plates of the book had DISAPPEARED.

Within two months, as if that announcement was the signal they'd been waiting for, several official Agencies, with high ratings of (*presumed*) integrity, launched individual vicious attacks on our "*Red Stars Tract*"—on CEG—on Myron C. Fagan . . . each one, either directly or indirectly, emphasizing charges of "*anti-semitism*."

The first attack came in a "*form letter*" issued by Frank S. Tavenner, Jr., Counsel of the House Committee on Un-American Activities. In that letter he stated that he knew virtually nothing about the Cinema Educational Guild, Inc., and/or about Myron C. Fagan . . . and, as to the individuals listed in the "*Red Stars Tract*," only a scant few, less than a dozen, had ever been cited as Reds by the Committee—so he stated in his "*form letter*."

Mr. Tavenner's big mistake was "*a short memory*"—as it turned out, he had forgotten that shortly after he received a copy of my first book (in 1951), he wrote me a glowing letter of commendation, and praised the meticulous accuracy of the book—he added that without the aid provided by CEG and myself the Committee could never have achieved the complete exposition of the Communist Conspiracy in Hollywood.

Now, in that book I stressed the fact that all of the 250-300 individuals listed in the "*Red Stars Tract*" had been hauled up before the Committee—and their pro-Communist activities thoroughly revealed. After I was made aware of his (1960) "*form letter*," I wrote Mr. Tavenner, enclosed a photostatic copy of his 1951 letter, and asked him to explain the flagrant misinformation in his "*form letter*." His response was fairly prompt. He admitted that he should have checked the records more carefully before he issued that letter—and he assured me that he would properly rectify the matter. He kept his word—he issued another "*form letter*" in which he stated that, far from "*a scant few*," there were more nearly a hundred Committee-proven card-carrying Communists (*named*) in the "*Tract*"—he also indicated that it was highly probable that many of the others named (*in the "Tract"*) were "*Red-Fronters*" and/or "*Fellow-Travellers*."

(Note: Our files contain positive documentary proof of direct pro-Communist activities of EVERY individual named in the "*Tract*." M.C.F.)

Another attack, launched simultaneously with the above mentioned one, came in the form of a "REPORT," issued by the "*Los Angeles Better Business Bureau*" (L. A. BBB). This attack was far more virulent than the Tavenner (HCUA) "*form letter*." It contained a thinly veiled charge that the entire CEG project was a "*Fagan Family racket*"—that the "RED STARS TRACT" was "*trash*"—and it stressed the so-called "*anti-semitism*" in all my writings and speeches. In short, it faithfully followed the ADL line—*as did the Kuchel speech*. I first became aware of this attack when I received a number of newspaper clippings containing the "REPORT"—they came from various cities. I promptly contacted the L. A. BBB and demanded to speak with the individual who had compiled that "REPORT." It turned out that the compiler was none other than the President himself, one Robert J. Bauer. In a discussion at his office, Mr. Bauer sheepishly "*admitted*" that many of the statements in his "REPORT" were "*erroneous*"—that he had been "*misinformed*"—and he assured me that he would retract all those statements in a new "REPORT." He kept his word—a few days later he submitted the new "REPORT" for my approval . . . it contained no smears—and made no references to "*anti-semitism*."

But here is one very significant point: during my conversation with Bauer I drew from him an admission of a "*cordial*" relationship with the "*Anti-Defamation League*." It instantly became evident that the "*compilation*" of his "REPORT" had been *guided*

by the ADL—indeed, it might well have been entirely written by the ADL . . . *which makes one wonder how much of the Kuchel speech was written by the ADL!*

The third attack, which I will now discuss, is the California Committee 1960 “REPORT,” from which Kuchel picked those three disjointed excerpts with which to establish (?) that I am “*anti-semitic.*”

That “REPORT” was issued more or less simultaneously with the above-mentioned attacks by HCUA and the L. A. BBB. I first became aware of it when it was front-paged by all the newspapers in Los Angeles—and *by all the “Liberal” newspapers throughout the nation . . .* and, strangely (?), the only part of that “REPORT” that was given such prominence by the Press was the section that was devoted to the vilification of CEG and Myron C. Fagan.

Now, why was that “REPORT” published all over the country? None of the previous “REPORTS” of the California Committee had ever received such preferred treatment. The answer is simple: *it was accomplished by the ADL—and was part of the scheme to completely discredit the “Red Stars Tract” and destroy its effectiveness—also to whitewash the Reds and Fellow-Travellers it exposes.*

On the day following the “*front-paging*” of the “REPORT,” I served every Los Angeles newspaper and the Associated Press with copies of my rebuttal. In that rebuttal, I charged that the “REPORT” was in its entirety composed of half-truths, distortions of facts, and outright (*deliberate*) falsehoods. But I did not stop with just the charges—I *PROVED* them with *DOCUMENTATIONS* right from the previous *YEAR BOOKS* issued by that very same Committee!

For one example: the “REPORT” stated that in our “*Red Stars Tract*” I *falsely* accused such individuals as Melvin Douglas, Kirk Douglas, Gregory Peck, etc., etc., with being REDS, when, in fact (*so the “REPORT” stated*), all of them are “*ardent patriots and anti-Communists.*” In my rebuttal I provided excerpts from the Committee’s previous “REPORTS” which cited the specific (*numerous*) acts of Communist activities of all of their (*suddenly*) “*ardent patriots and anti-Communists.*” Even more important, I provided *documentary* proof of their continuing pro-Communist activities through the years and to this very day . . . *and that was only one of the witting and deliberate falsehoods in that “REPORT” that I nailed down.*

In all fairness, I must admit that all the L. A. newspapers gave my rebuttal almost as generous coverage as they had given the “REPORT.” But, all but one deleted my direct charge that that

section of the "REPORT" had been written at the behest of the ADL, even though I pointed to the similarity of verbiage in the "REPORT" and in previous ADL publications.

In response to questions about the charges in my rebuttal, Sen. Burns, Chairman of that California Committee, had only one answer—a curt "no comment." But the Committee Counsel, Combs, did wryly admit, although he tried to make it sound facetious, that "*it would seem that (Fagan) is the only expert in the field of counter-subversive intelligence.*"

(Note: Immediately after those attacks, to forestall similar attacks, we issued a new and up-dated "DOCUMENTATIONS" book (\$2.00 per copy). There have been no further attempts to discredit the RED STARS TRACT. MCF)

DO WE NEED ANY MORE PROOF?

In all of the foregoing I endeavored to accomplish two objectives . . . 1) Provide incontrovertible proof of the plot to deliver our Country into UN One-World enslavement . . . 2) Provide incontrovertible proof that many of the men we have elected to the highest offices in Washington are the kind of "Leaders" who, *so graphically described by Khrushchev*, will keep feeding us "*small doses of Socialism, until we will suddenly awake to find we have Communism.*"

Actually, Kuchel himself provided all the evidence we need on both counts, when he recited the names of the six Russians who, *consecutively*, headed the UN Military Secretariat since the inception of the UN—and then resorted to the State Department's explanation that it was just "*sheer coincidence*" that none but a Russian has ever occupied that post. In discussions about that "*sheer coincidence*" with other members of Congress, Kuchel and State Department spokesmen loftily assured that "*that would never happen again*" . . . well, I have news for them:

Several weeks ago, the (*sixth*) Russian in that post, Eugeny D. Kiselev, dropped dead—heart attack. Just two days after Kuchel's speech hit the front pages, U Thant, the little Burmese Marxist Secretary-General of the UN, announced his appointment of Kiselev's successor . . . and, *what do you know*, the successor is none other than Vladimir Pavlovich Suslov, assistant to Russia's

Foreign Minister Andrei Gromyko . . . *the seventh Russian to SUCCESSIVELY hold that post!*

How about that, Mister Kuchel and "gentlemen" of the State Department? . . . Is this another SHEER COINCIDENCE? . . . Do you still insist that there is no Hiss-Molotov agreement that rigidly reserves that post for Russians? If you do, kindly explain why ALL three Secretary-Generals of the UN appointed none but Russians to that post . . . let's see you double-talk your way out of this *seventh* Russian UN Secretary for Political and Security (Military) Council Affairs.

That appointment of a seventh Russian to that post is so clearly a confirmation of the Hiss-Molotov secret agreement that it removes all question or doubt about the entire UN Conspiracy—even a junior grade high-school student should be able to see that.

To some of my more sensitive readers my appraisal of Kuchel may seem to be too strongly tinged with contempt. Well, I have no apologies for it, and to justify that stand, I will point to the fact that in all of his tirades Kuchel flayed and vilified all those he calls "Rightist Extremists," whereas he has never uttered one unkind word about "Left-Wing Extremists," Leftist Organizations, or even outright Reds. Where does that place him? Even a mother, if she is loyal to her country, can't love that kind of a son.

DIVIDE AND CONQUER

—————●—————

As I have reported in previous "News-Bulletins," the Great Conspiracy to enslave the American people in a One-World Government was launched way back in our Civil War years, when the House of Rothschild shipped Jacob H. Schiff into the United States to mastermind that objective.

Schiff devoted all of the remaining years of the 19th century to the preparations for the actual launching. As we know, it was 1911 when he finally assembled the Warburgs, Seligmans, Lehmans, Rockefeller, Morgan, the Biddles, and other renegade American

bankers, financiers and industrialists in that secret conclave at Jekyll Island which resulted in the surrender of our money system to the Conspirators via the "Federal Reserve Act" and the 16th Amendment.

That was the first giant step of the Great Conspiracy—the first crack in the wall of our Sovereignty. But there were two additional great obstacles they had to overcome:

1) The Freedom of our Press—they had to acquire complete control of all of our Mass Communications Media, so as to keep the people unaware of their plottings. In one of our early "News-Bulletins," entitled "FREEDOM OF THE PRESS—TO PROMOTE TREASON," I revealed in great detail how they accomplished that objective.

2) From the very inception of the United States as a nation we have been a very closely knit people—and that has been so despite the heterogeneity of our people. The United States is a composite of virtually all the nations on the face of the earth. We are Irish, Italian, German, Polish, French, etc., etc., etc. Naturally, all of those different peoples are proud of their ancestries—proud of the homelands of their ancestors. But America always came first, last and all the time, with all of them. Even the immigrant, once he had his citizenship certificate, transferred his allegiance and love to America. None of them thought of themselves as members of "Minority Groups"—*they were AMERICANS!* That's the way it *was* from that year in the 18th century when true Liberty and Freedom were born—that was the unity that made them so proud to live and fight and die for AMERICA. The Civil War created a temporary break in that unity, but even that wound became healed within a few years, and we went on to even greater national unity. The One-World plotters knew that that unity would be their greatest obstacle—they knew that as long as that unity would remain intact their plot would make no headway. *That unity would have to be destroyed*—All Loyalties would have to be eroded—National pride and patriotism would have to be made terms of derision—Americanism would have to be made a loathsome word akin to "antisemitism" and "anti-negroism" . . . each of those objectives to be a forward step in their "Divide and Conquer" technique.

Thus, the chief strategy in the "Divide and Conquer" technique was, and continues to be: "Destruction of the unity of the American people." For that objective they set up two separate and distinct "operations." Both are independent of each other—but as closely linked for the overall objective as Siamese Twins.

Operation No. 1) Capture the collective mind of our Youth—on the fairly infallible theory that just one generation of *completely* brainwashed and *indoctrinated* “Youth” will automatically surrender our nation into “*One-World Government*” enslavement. The principal facets of the indoctrination are: . . . A) **Intensify a Fear of War Psychosis, thus instilling desire for One-World Citizenship to insure PEACE** . . . B) **Destroy all parental, home and Religion influences** . . . C) **Destroy Patriotism and loyalty to Country** . . . D) **Convince them that the UN is the only SURE instrument for PEACE.**

Operation No. 2) Create racial and religious strife, dissensions and hatreds among all the so-called “*Minority Groups*”—ditto Christians and Jews—ditto Protestants and Catholics—ditto Negroes and Whites. But of all the dissensions, the racial-hatred between the Whites and Blacks was to be the A Bomb in their “*Divide and Conquer*” arsenal of weapons. It was to be constantly intensified until it would not only shatter the unity of our people, but would blacken our image abroad.



Like the many-headed Hydra monster of Mythology, the strategy for the accomplishment of those two “*operations*” called for many “*heads*,” in the form of “*organizations*,” to each of whom a special “*job*” was assigned. Indeed, the strategy of the entire Great Conspiracy consists of “*organizations*” to do the actual work—but, just as “*all roads lead to Rome*,” all the “*jobs*” of all the “*organizations*” lead directly to the achievement of the overall objective of destroying the sovereignty of the United States.

On behalf of the particular “*operations*” mentioned above, the plotters began to set up various “*organizations*” in the early years after the turn of the century. The three best known of these “*organizations*,” and *the most virulent*, are “*The Anti-Defamation League*” (ADL), the NAACP and UNESCO. However, at this point I wish to stress that all such “*organizations*” operate under the control and direction of the malodorous “*Council on Foreign Relations*” (CFR), as fully described in our “*News-Bulletins*” Nos. 87 and 88, entitled “OUR INVISIBLE GOVERNMENT MADE VISIBLE,” Parts One and Two.

The NAACP was the first to be launched. It was organized in 1907. It was proclaimed to be a Negro organization—but *the organizers were WHITES!* It is now, and *always was*, officered and directed by WHITES! One Joel Spingarn was its first President, continuously, until 1936. He was succeeded by a member of the same family, its present President—Arthur Spingarn. This Spingarn

is an affiliate of the ADL, as Joel was during *his* incumbency. Other Top Brass (*Vice Chairmen and Directors*) of NAACP are Herbert Lehman, James Warburg, Bernard Baruch, Sulzberger (*of the N. Y. Times*), and others of that ilk—and all those above-named are also TOP BRASS of the ADL and CFR! . . . *Remember that-when we will later discuss the activities of the NAACP!*

The NAACP was inactive during its first few years—they went into high gear immediately after the ADL was set up . . . *as will be seen later, the NAACP was set up to be the Plotters big “ace in the hole.”*

The ill-omened birth of the ADL came in 1913. Immediately it proclaimed itself to be the *official* voice of authority of the Jewish people—and that it was organized to: . . . 1) **Promote amicable and amiable relationships between Jew and Christian . . .** 2) **Safeguard the individual members of the Race from persecution and discrimination . . .** 3) **Prevent “anti-semitism” and “defamation” of the Race as a whole.**

That “proclamation” was as false as Kennedy’s assurances (until October 22) that “there are no offensive (Nuclear) weapons and no Russian troops in Cuba.” There is ample evidence that the ADL has, from its inception, been fomenting “anti-semitism,” not preventing it. In addition, the ADL has, through the years, been directing and masterminding the NAACP’s racial-hatred activities. Ditto all the strife and dissensions spewed by all of the so-called “Minority Groups.” It is the ADL that masterminds the “brainwashing” by all of our Mass Communications Media, etc., etc., etc. In short, the ADL is the chief instrument in the “Divide and Conquer” plot.

“UNESCO” was organized simultaneously with the birth of the “League of Nations,” and incorporated as a “Special Agency” of that now defunct League. Its chief function was to acquire control of the Educational Systems of various nations — *but particularly in the United States*. World War Two exploded the “League,” but not UNESCO. True, it was more or less in hibernation between the demise of the League and the birth of the UN, but it remained intact — and went into high gear as a Special Agency of the UN immediately after the UN Charter was approved and signed by the U. S. Senate.

Within months UNESCO began to infiltrate *their* approved text books into all of our schools, from Kindergarten straight through to Universities — text books in which American history was distorted so as to demean and degrade America and Americanism, and extol Russia, Socialism and Communism . . . *exactly as described in "Operation One."* And they had the able and zealous — *and treasonous* — cooperation of our "National Education Association," of the National and local PTA groups, of our State Department, and of Hollywood and TV.

DOCUMENTARY EVIDENCE

Earlier in this issue, I stated that the plotters set up the NAACP to become their supreme weapon in their "*Divide and Conquer*" project. Guided and masterminded by the ADL, the NAACP was to launch a "*crusade*" on behalf of the negroes — a "*crusade*" to incite all negroes, *particularly in the South*, to demand *NOT equality with the white people, but preference and superiority* — a "*crusade*" which would create such violent racial hatreds all over the country as to forever destroy the unity of the American people.

However, in order not to throw the entire onus on the one (NAACP) "*organization*," the plotters set up additional Negro "*organizations*," such as "Urban League," "CORE," "CARE," etc., etc., etc., all directed and masterminded by the ADL . . . they launched supporting "*crusades*" for FEPC ("*Fair Employment Practices*"), against "*Housing Discrimination*," "*Segregation*," etc., etc.

Early in 1950, when we had to fight off an attempt to foist an FEPC law on the people of Los Angeles, California, we devoted one of our "*News-Bulletins*" to unmask the hypocrisy in such a "law" — and in that same issue I reviewed the entire NAACP plot and warned of the (*present*) things to come. I DOCUMENTED my warnings with excerpts from a book entitled "THE NEGROES IN A SOVIET AMERICA," published in 1935 by the Communist Party's "*Workers Library Publishers*." That book urged Negroes of

the South to rise up, form a Soviet state, and apply for admission to the Soviet Union it contained implicit assurance that the revolt would be supported by all American Reds and Liberals, and protected by important elements in Washington on page 33 it promised that a Soviet government would confer greater benefits on Negroes than upon Whites, and that — **“Any act of discrimination or prejudice against a negro will become a crime under the revolutionary law”**

If that isn't enough to show that our present Racial tension and strife did not *“just happen,”* let's now go back to another bit of *documentary* evidence which will prove that, as Franklin Roosevelt once expressed it, *“We planned it that way.”*

In 1913, one Israel Cohen, a Communist Party functionary in England, wrote a book which he called: **“A RACIAL PROGRAM FOR THE 20th CENTURY.”** The following is a highly significant (*verbatim*) excerpt from that book:

“We must realize that our Party's most powerful weapon is racial tension. By propounding into the consciousness of the dark races that for centuries they have been oppressed by the whites, we can mould them to the program of the Communist Party. In America, we will aim for subtle victory. While inflaming the Negro Minority against the Whites, we will instill in the Whites a guilt complex for their exploitation of the Negroes. We will aid the Negroes to rise to prominence in every walk of life, in the professions and in the world of sports and entertainment. With this prestige the Negro will be able to intermarry with the Whites and begin a process which will deliver America to our Cause.”

To remove all doubts about the authenticity of the above excerpts, the latter was published in the Congressional Record on June 7, 1957. And now, let's see how all those *“directives”* were carried out.

Since the Israel Cohen book was written, negroes have been aided to rise to prominence in every walk of life — in the professions, in sports, in entertainment, etc. NOT so much on their merits, *but because they are negroes.* We have the Jackie Robinsons and Floyd Patterson, a *“cheese champion,”* who fought only White amateurs (*stumble bums*) to achieve and retain his championship — we have the Paul Robesons, Lena Hornes, Dick Gregorys', Langston Hughes, James Baldwins, Sammy Davis, Jr., Harry Bellafontes, etc., etc., in entertainment and in the literary field — all of them *“leaders”* in the *“crusade”* to *“inflame negroes against Whites.”* And for proof of *“with this prestige the Negro will be able to intermarry with the Whites,”* we have a prime example in Sammy

Davis, Jr. But he is by no means the only example — many of the negro “leaders” brazenly and arrogantly flaunt their White mates.

However, with all their “leaders,” with all their “Reverends,” such as the Rabble-Rousing Martin Luther King, Adam Clayton Powell, Fred Shuttlesworth, etc., to spearhead their “sit-ins,” their “Freedom” marches, their riots, the negro “crusade” could never have gotten off the ground without the support of “all the American Reds, and men of highest authority in Washington,” as promised in the pages of “THE NEGROES IN A SOVIET AMERICA” . . . and don’t forget the promise in the Israel Cohen book: “While inflaming the Negro Minority against the Whites, we will instill in the Whites a guilt complex for their exploitation of the negroes.”

And, through the years, that “promise” has been continuously fulfilled! By our Mass Communications Media, by the “Liberals,” by the “Do-Gooders,” by the “Bleeding Hearts,” by corrupt political opportunists. With their constant yammering that for a hundred years the “poor negroes” have been persecuted, denied their rights, subjected to all types of discrimination, they have “inflamed the Negro Minority against the Whites” — and are doing their best to instill a guilt complex in that vast majority of the American people whom they have been brainwashing with their pious yammering.

Now let’s see who are the men “in highest authority” in Washington who have been providing the support for the Negro “crusade”:

The Roosevelts, Franklin and Eleanor, were the first to give it the “big push.” We all can remember how Eleanor roamed all over the country, making “heart-breaking” speeches in Synagogues, Jewish Centers and Negro churches, in which she denounced and deplored the “persecutions” suffered by those two “Minority Groups” Now, as is commonly known, the Roosevelts owned and developed virtually all of Warm Springs, Georgia, Franklin’s favorite health resort. Well, all the deeds of the properties they sold contained provisions (*in fine print*) prohibiting the sale or rental of those properties to Negroes or Jews.

Eisenhower, the phony “Military Genius,” was the next “high authority” to give a “big push” to the Negro “crusade” to destroy our unity. He forced integration in our Armed Forces — he forced desegregation in the Washington schools — and Washington in general. Today, Washington, the Capital of our nation, the once most beautiful city in our country, the most important city in the world, is a black jungle. At least sixty per cent of the population are Negroes. No woman — or man, for that matter — is safe on

Washington streets after darkness sets in. Indeed, muggings, stick-ups, robberies, rapings, murders, go on during the day as well as the night. Secretaries of members of Congress have to be provided with armed bodyguards. That's the picture of our Capital all the Embassies in Washington send back to their countries. Nice, eh, what! We have Eisenhower, the phony "*humanitarian*," to thank for all that.

Now, let's see what a stinking hypocrite he is! He had piously deplored the racial inequality of the schools in Washington. He insisted that the poor little negro kiddies should sit side by side with the white youngsters in all the schools — otherwise the poor little negro kiddies would go through life with an inferiority complex. And he finally forced complete integration in all the Washington schools. But, what about his own grandchildren? Did they sit "*side-by-side*" with the poor little negro kiddies? Uh, uh — no, no, no! Desegregation is fine for your children and mine, but not for the Eisenhower kids. During the eight years Eisenhower was in the White House, and his son was stationed at Fort Belvoir where the Army schools are integrated, the "*Military Genius*" sent his grandchildren, *in a White House or Army limousine*, to segregated St. Stephens School in Alexandria, Virginia.

During the entire eight years of his Vice Presidency, Richard Nixon was another of the "*highest authorities*" who aided and abetted the Negro "*crusade*" that is destroying the unity of the American people. Throughout those years he was a slavish Eisenhower echo and catspaw. Ike (*ordered by CFR*) wanted the Connally Amendment repealed — Nixon delivered the first public address in favor of the repeal . . . Ike tsk, tsk, tsk'd, about "*anti-semitism*" and discrimination against Jews—Nixon tsk, tsk, tsk'd along with him . . . Ike wailed for complete desegregation of all Washington schools — Nixon wailed right along with him. Under those circumstances, you'd think that Nixon would conduct his home life to fit his pious words. Not so! Immediately after he was elected he bought a home in a segregated area in a swank sub-division *where property cannot be lawfully sold or rented to Negroes or Jews — the deed to his property contained a rigid clause to that effect*. Moreover, he clearly revealed his true feelings about desegregation by sending his children to a segregated Friends School many miles from his home, so that they wouldn't have to rub shoulders with children of African descent. *In the 1960 campaign he completely unmasked himself by publicly repudiating his earlier exhortation for the repeal of the Connally Amendment.*

The nick-names applied to individuals in public life correctly reveal their characteristics — "*Tricky Dicky*" is an apt soubriquet

for Nixon. In his ruthless pursuit for dollars and political aggrandizement he was perfectly willing to aid and abet the plot to destroy the unity of the American people.

Needless to say, there are many others of the Roosevelt-Eisenhower-Nixon ilk in virtually all of the high offices in Washington—all perfectly willing to destroy our unity to advance themselves, but, at the present time, all such top “honors” go to the Kennedys.

Before moving into the White House, Jack Kennedy had a lush home in segregated Georgetown where it is hard to find a Negro even on the streets. Bobby Kennedy lives in rigidly segregated McLean, Virginia, where the only integration is in the schools — *and on a token basis only*. Nevertheless, Mister Integration, won't take a chance on his children going to the same school with a Negro or two. He sends them, during rush hours and heavy traffic, across Northern Virginia, through the Wisconsin Avenue section of the District of Columbia, out into Maryland to Sone Ridge Convent of the Sacred Heart Parochial School in Bethesda, Maryland.

In short, the Eisenhowers and the Nixons and the Kennedys are staunchly and determinedly all-out for Integration — *for you and for me, but not for them!* They are strong for Housing Integration — for you and me, not for them!

This present “zeal” of the Kennedys for desegregation, for integration, for “civil rights” for all the “Minority Groups,” brings to mind an incident of 1930, which starkly reveals the contemptible *and vicious* hypocrisy of the Kennedys. It happened at the time when I was in charge of the Story Department on the Pathe Lot, then owned by Joe Kennedy. The incident had to do with one Stepin Fetchit, a Negro comedian, then employed in one of our Films. As we were watching the “Rushes” in our projection room we had frequent occasions to mention Fetchit. All of us referred to him as Stepin or Fetchit. Not Joe Kennedy. He always referred to him as “*the nigger*” or “*the boogie*.” Likewise, when he had occasion to mention the Warners and the Cohns and other of the Hollywood (*Jewish*) Moguls, he always referred to them as “*Sheenies*” or “*Kykes*” — oh, not in their presence, of course, only in the privacy of our own offices. This occurred particularly when he would angrily assail — *and properly so* — the prevailing practice of nepotism in Hollywood. With the exception of our (Pathe) Lot, all executive jobs on the various Lots were held by brothers, sons, nephews, sons-in-law, and other kin of the top Moguls. Old Joe didn't like that at that time his kids were too young for executive jobs — *but look at them now!*

Our “News-Bulletin,” No. 91, entitled “WHY KENNEDY MUST

BE IMPEACHED," contained a biographical review of the Kennedy "family traits" and their "heritage" of dishonesty, deceit, treachery and hoodlumism. I stressed — *and proved* — that all of the present Kennedy Kids are "spittin" duplicates of old Joe and their other forebears. Even in their resorting to the picaresque verbiage of the father. You will recall Jack's quote of old Joe's statement that "All business men are sons-of-bitches." Well, you can rest assured that when, *amongst themselves*, they rage and rant against the need of pandering for the votes of the Negroes and the "Minority Groups," their words for them are their father's "niggers" and "boogies," and "kykes" and "sheenies." The young leopards have the identical never-changing spots of the old leopards.

Do we need any greater obvious proof of the vile hypocrisy — *and outright treason* — of the Roosevelts, the Eisenhowers and the Kennedys? . . . But, — as Al Jolson used to say — "*wait, you ain't heard nothin' yet!*"

MORE PRIMA FACIE EVIDENCE

●

All of the Negro and "Minority Group" agitations were launched in the early years of the second decade of this century. Their progress was very slow until Roosevelt entered the White House. That was when it went into high gear — *with that charlatan's high approval*. Even so, the Negro "crusade" did not attain a high momentum — for a very distinct reason: there was nothing in the Constitution that could be used to FORCE the South to desegregate their housings and their businesses — or to integrate their schools. Moreover, the Negroes were fully aware of the temper of the Southern people — they knew that any attempts at violence in any parts of the South would be met with prompt and severe punishments. Hence, the Masterminds of the Great Conspiracy knew that the mere approval and encouragement of the men in the White House would not be enough — they'd have to provide "law" that would "validate" violence. They (*the Masterminds*) knew that Congress would never pass such a "law" — but there was one way they could get it: "DECISIONS" by a corrupt U. S. Supreme Court — phony "Decisions" based on (*deliberately*) false interpretations of the 14th Amendment of the Constitution — "Decisions" that would outlaw Segregation of all types. Those phony "Decisions" would be declared "Laws of the Land" — and that would be all that would be needed to "inflamm the Negroes against the Whites" — and thus carry out ALL the "directives" in the Israel Cohen book and in

the Communist Party's "THE NEGROES IN A SOVIET AMERICA."

To accomplish such an objective it would be necessary to "pack" the U. S. Supreme Court with unscrupulous and unconscionable stooges. That, of course, could be done only by the Men in the White House — and, beginning with Roosevelt, all of them appointed men who could be depended upon to fulfill that objective. For concrete evidence we have the "deal" entered into by Eisenhower and Earl Warren at the 1952 Republican Convention. In our (*News-Bulletin*) report of that Convention, I revealed all the details of that "deal." It called for Warren to "knife" Taft and deliver the California delegation to Eisenhower. In return, Eisenhower pledged himself to appoint Warren to the U. S. Supreme Court — *as Chief Justice, no less!* I also revealed that Warren had pledged himself to issue the kind of "Decisions" required by the "Masterminds" — particularly a "DESEGREGATION DECISION!"

In later issues of our "*News-Bulletin*" I reported all of the reprehensible shenanigans Eisenhower was employing to carry out his pledge to Warren. And, when Warren finally got his appointment, I forewarned about the kind of "Decisions" we could expect from him. Unfortunately, at that time, the false "image" of Eisenhower as a great American and great "humanitarian" had been so completely "sold" to the American people that the moment he stepped into the White House the vast majority heaved a great sigh of relief, and, metaphorically speaking, joyously proclaimed: "*Happy Days are here again — leave everything to the great Ike — he will solve all our problems.*" Even some of our (CEG) charter members, all truly dedicated Americans who should have known better, actually believed that Eisenhower was to be the savior of our country — they resented my forewarning, and demanded retractions — and angrily resigned when I refused to retract.

Well, today, they all know what kind of a "savior" he turned out to be — we all know what an unscrupulous and unconscionable opportunist he was throughout his adult life And now, let's pause for a moment, and see what just one of his many treasonous deeds, the appointment of Warren to the U. S. Supreme Court Bench, did to us — let's see what Warren's "*Desegregation Decision*" has done to our nation — let's see how devotedly it conforms to the "*Destroy the Unity of the American people*" directive.

Eisenhower gave that "directive" its first great impetus when, *unlawfully*, he ordered thousands of Federal troops into Little Rock, Arkansas. That Little Rock incident is too well remembered to need reviewing in these pages. We remember how the troops roughed-up and man-handled the WHITE citizens if they so much as look-

ed cross-eyed at them — how they invaded the homes of WHITE citizens and manhandled them on the slightest pretext — we remember the sight of WHITE teen-age high school girls being bayonet-prodded into the integrated class-rooms — how teen-age girls were held incommunicado by Federal (FBI) Agents and all of that was done on orders from the White House — *orders to "protect" the negroes, no matter at what cost to the Whites!*

That was the signal for the NAACP, guided and masterminded by the ADL, to go into high gear! They started off with "sit-ins" in White restaurants — they organized "Freedom-Rider" caravans, etc., etc. In short, *that was Eisenhower's "D-DAY for the Negro "crusade!"*

And then came the second great impetus at Oxford, Mississippi, when Jack Kennedy, of "Cuber" infamy, our "President" by fraud, poured 25,000 Federal troops and hundreds of thugs, transformed into so-called Federal Marshals, into that small community, on the excuse of forcing the integration of one totally-unfit negro into "Ole Miss." Those thugs and troops murdered Whites — they seriously injured Whites — they shot tear-gas bombs into groups of teen-age (White) students and that was the signal for all the Negroes throughout the nation to go into ACTION! The "Birmingham Demonstrations" followed — with similar "Demonstrations" threatened all over the country. And now the Negroes are not demanding "equality" — they are demanding SUPERIORITY — they are demanding a SOVIET AMERICA, *as openly voiced by the chief of the Muslims* — they are now serving ULTIMATUMS on the White people of America, ULTIMATUMS of "give us what we want — OR ELSE! and that "OR ELSE" has dire and frightening forebodings.

And if you think that the Negroes are alone with their ULTIMATUMS, I call your attention to a recent speech Jack (President) Kennedy voiced in Honolulu. He addressed it to all the Governors and Mayors in the U. S. In that speech he warned all of them that complete victory for the Negroes was at hand. In so many words, he urged all Mayors to prepare their cities for SURRENDER. Moreover, he clearly indicated that he will, if necessary, use the U. S. Army to FORCE the SURRENDER. Get a copy of the speech — read it — then study the between-the-lines portent.

IS OUR CONSTITUTION DEAD?

●

New let me show how *treasonously* lawless are these late deeds by Eisenhower, the Kennedys, the traitors on the U. S. Supreme Court Bench, the men in our State Department.

Recently, Dean Rusk stated that we have much to worry about the "image" of America being created abroad nowadays. *And he is so right!* Rusk attributed it to the so-called controversy over what he called "racial discrimination." But he didn't tell the whole story—that part which is overlooked by almost everybody because, on orders from those who "manage the news," our Mass Communications Media never mention it. That part is the fact that not a single law has ever been passed by Congress requiring desegregation or integration of public schools, universities, restaurants, theaters or hotels — and not a single law has been adopted prohibiting discrimination in employment!

This same "racial controversy" points up another fact, of which the vast majority of the American people are (*deliberately kept*) unaware, to wit: The U. S. Supreme Court, consisting of nine men, is not a Legislature. It has no Legislative powers whatsoever. It cannot lawfully substitute its will for that of Congress. *But it has done so!* Warren issued the "Desegregation Decision" and proclaimed it as a "Law of the Land" — under our Constitution, *that is a criminal LIE!*

Also, as a consequence of that "Desegregation Decision," Eisenhower and Kennedy have sent federal troops into sovereign states to enforce court orders for school integration, *but no laws covering the subject have been passed by Congress!* Moreover, our Constitution rigidly prohibits sending federal troops into any state — *unless expressly requested to do so by the Governor and/or the Legislature of the state.*

The 14th Amendment, on which Warren based his phony "Decision," and on which both Eisenhower and Kennedy based their authority to send federal troops into the various states to enforce that "Decision," makes no mention of schools or private or public employment, but declares all citizens have a right to the "equal protection" of the laws. This same amendment says explicitly that Congress, *and only Congress,* is given the power to pass laws to enforce the provisions of the amendment.

By that token, all the Justices who joined in the issuance of that "Desegregation Decision" and the two Presidents who rushed federal troops into Arkansas and Mississippi and Alabama to enforce that unlawful "Decision," are guilty of malfeasance in office — all of them should promptly have been impeached, tried, and properly punished . . . Moreover, by that same token, *both of the Kennedy kids are directly responsible for the murders committed in Oxford — and should be tried and properly punished for those crimes!*

The United States has always been proudly portrayed to the whole world as a free republic. We have always emphasized that

we have a government of laws — not of men. But now foreign observers, the Embassies in Washington and the Consulates throughout our country, are noting that an oligarchy of nine old men, *who hold office for life*, is now writing our laws — and, in the process, tearing our Constitution to shreds . . . *nine men who are under oath to protect and preserve our Constitution!*

WHO ARE THE INCENDIARIES?

One of the chief “*directives*” in the Israel Cohen book was “**inflame the Negro Minority against the Whites.**” Needless to say, that “*directive*” has been so fiendishly carried out that today it is a nation-wide conflagration that has not only destroyed the unity of the American people, but threatens to destroy our entire nation. During the past several years various local communities in various parts of the country have endeavored to try to settle the racial question by calm suasion. In many of those communities those efforts were making healthy progress when “*demonstrations*,” as in Birmingham, proclaimed as “*non-violent*,” erupted into vicious racial violence. Such episodes have not been confined to the South. They have spread to all parts of the country. Riots and other disturbances occur frequently — another prime example was that murderous Thanksgiving Day riot in Washington, D. C. . . . All of which makes it obvious that the plotters don’t want the question peacefully settled — they want the “*inflaming*” to go on and on until it will erupt into *nation-wide* murder and bloody revolution. And that will be the signal to place the entire nation under martial law — *under supervision of the UNITED NATIONS!*

Another of the chief “*directives*” in the Israel Cohen book was “**instill in the Whites a guilt complex for their exploitation of the Negroes.**” And that “*directive*” is being carried out by all of our Mass Communications Media, by various “*Men of the Cloth*,” by crooked politicians, etc. . . . but principally by the Mass Communications Media. In all press coverage of the various incidents, they “*deplore*” the

violence — then they *sanctimoniously* stress the fact that all of the present racial strife has been engendered by the centuries-old exploitation of the Negroes, of the various discriminations against them, etc., etc., etc. Every day we see “columns” by the Walter Lippmans, Roscoe Drummonds, Drew Pearsons, the Alsops, sometimes referred to as the Allslops, and others of that ilk, all urging peaceful settlement of the racial question — but always *sanctimoniously* reminding the Whites that for centuries, *and to this very day*, we have been exploiting the “poor” negroes, depriving them of their civil rights, barring them from decent jobs, decent housing, decent schooling, etc., etc., etc.

And if you think that kind of “*brain-washing*” hasn’t been effective, think again. There are millions of White Americans who have swallowed that “*guilt complex*” hook, line and sinker — it has been creating discord and bitter dissension between such brain-washed Whites and those who are alerted to the truth — and, tragically, it has been, and still is, more effective with the Youth than with the more mature. Furthermore, all that “*sympathy*” goes far to further inflame the Negroes— it “*reminds*” them of all the injustices they have been suffering at the hands of the Whites (?).

There is only one sure “*cure*” for this entire racial question — and only one branch of our government can provide it . . . and that is the Congress of the United States. If this nation is to survive, Congress must reassert the authority and powers provided them by our Constitution — it must haul in all those who usurped those powers (*the Kennedys, Eisenhower, Warren, etc.*) and place them on trial for their criminally unlawful acts. Never again must Congress permit a President of the United States to send federal troops into a sovereign state, unless requested to do so by the proper authorities of such a state . . . never again must the U. S. Supreme Court be permitted to issue “*Decisions*” contrary to our Constitution — and foist those “*Decisions*” on us as “*Laws of the Land*” equally as important, if not even more so, Congress must haul in the NAACP, the ADL and the CFR for thorough investigations of their activities. Such investigations will quickly unmask and smash the entire conspiracy — and settle the entire racial issue — NOT to the satisfaction of just the Negroes, but to the satisfaction of ALL of the American people with Liberty and Justice for ALL!

The salvation of our nation lies in the hands of our Congress. If the men and women in our Congress fail to take the action imperative for the survival of our beloved country they will go down in history as the assassins of our Republic . . . but, by the same token, those of the American people who fail to demand such action by

their representatives in Congress will be full accessories to that assassination!

OUR IMAGE ABROAD

Earlier, I stated that foreign observers in America are sending very grim reports to their home governments. The confirmation of that statement reached me just as this issue was going to press. Following is that confirmation in the form of a confidential report from a highly reliable and unimpeachable source in Paris, France:

"The Governments of Western Europe are receiving alarming reports which touch on America's internal stability. Their informants put it bluntly: A development has taken place within the past few weeks which can shake America — and a crisis in America can endanger the West. The NAACP has consistently expressed embarrassment at the violence and anti-White declarations of another group, the Black Muslims, who preach a distorted mohammedanism under the leadership of a former factory hand, Elijah Poole, now known as Elijah Mohammed. The NAACP's moderate leaders have acquired both sympathy and support by repudiating Black Muslim advocacy of terrorism and black supremacy. However, according to reliable reports reaching governments around the world (though not the American public), the NAACP and Elijah Mohammed's followers have formed a common front, which means that the more violent leaders have assumed direction. The focal points for a sudden, brutal outbreak are now New York, Detroit and Chicago, Black Muslim strongholds where for five years Elijah Mohammed's lieutenants have been organizing an elite militia and stocking arms.

" 'Apprentice Sorcerer' is a European term for one who out-smarts himself and creates serious trouble in the hopes of making a gain. Our apprehensive allies, studying the possible effects of an internal American explosion on the world balance, are applying that term to our President and his brother. The feeling is that Dr. Martin Luther King, Jr. and other NAACP leaders did not want to make the gulf between Blacks and Whites too wide, but that the Black Muslims out-paced them and, as in the case of all power struggles, the more inflammatory leader wins the masses. Thus the moderate enters the race to violence or he loses power. Opinion is that for reasons cynically political the Kennedy brothers did not want integration to proceed too smoothly. A count of noses disclosed that more votes would be gained by creating a collision between the white and black communities and emerging as the champion of one than by proceeding softly, without headlines, to-

ward a hate-free solution. To goad the Whites it was necessary to agitate the negro, to export disorder from Washington. Enter the "Freedom Rides."

"In Europe acceptance of negroes into polite society was attained by the negro conforming to a certain standard of deportment and selfrestraint and no scramble for votes was involved, so that only a few top-level officials among our allies were aware that in America the Justice Department's policy of refusing to punish negroes molesting women and turning Washington streets into a jungle at night was part of a national policy — but instinctively Europe feels that she is safe only as long as America is stable, and recent experience in Algeria taught that nothing is gained by pitting communities against each other, that the result is a downward escalation toward savagery, as one informant put it to your correspondent.

"Americans were foremost in demanding that the Algerian conflict with France be internationalized in the interests of world peace. The men who opposed such a measure are convinced that before the end of '63 America may well be on the receiving end of just such a demand. All reports tend to convince them that a sudden, brutal outbreak, nationwide in scope and with Black Muslims forming the officer cadre, is approaching and that it will follow the now familiar pattern: Uprising, government reaction to restore order, and internationalization of the dispute, the latter in the form of a clamor to settle it through the UN. African delegates assure Black Muslim lieutenants of solid support in the world assembly. So matters stand."

The above horrifying and frightening "report" comes from perhaps the most expert research-reporter in European journalism. READ IT AGAIN!
