## GET THE TRAITORS OUT OF WASHINGTON!

---

Throughout the past years, *and especially in 1966*, I have revealed and DOCUMENTED the treason committed by our Administration (*the President and his Cabinet officials*), by our U.S. Supreme Court, by the UN — and I have stressed how our Congress has deliberately surrendered all of its powers to the President, the State Department, and the Defense Department. I particularly stressed it in our most recent (January 1967) "Year-End Report" — *read it again to refresh your memory* — and help us to solve that problem and *to save our Country FOR YOUR CHILDREN!*

## FACTS EVERY AMERICAN SHOULD KNOW

---

Our Constitution provided us with three distinct Branches of Government: . . . 1) The Executive Department, meaning the President and his Cabinet . . . 2) the Judiciary, or U. S. Supreme Court . . . 3) Congress.

However, this same Constitution provided all necessary checks and balances to keep each Department within its own field — *and it is up to us, THE PEOPLE, to keep them in their own fields.* The Executive Department is limited to "Administration" of Domestic and Foreign affairs. But under our Constitution, every man he appoints (his Cabinet) *must be approved by the Senate!* Thus, *the Senate is really responsible for the treason committed by the State Department and the Defense Department and the Treasury Department* — because the Senate always retains the power to, if

necessary, impeach every member of the Cabinet, and even the President, for any act of malfeasance in office.

The Judiciary (*U. S. Supreme Court*) is limited by our Constitution to properly interpret legislation and the acts of the "*Administration*," so as to keep all of it within the laws of our Constitution—it has absolutely no power or right to "*legislate*" and/or create laws by illegal "*DECISIONS*." Unfortunately, the selection (*or appointment*) of every member of the U.S. Supreme Court is delegated to the President — but, here again, every man chosen for the Court must be approved, or rejected, by the Senate; furthermore, Congress has the sole power to impeach any one, or all, of the Supreme Court Justices for malfeasance or misfeasance in office.

Now we come to the Constitutional third branch of our government: *the Congresss*. The entire Congress is elected by the people — thus it is the closest to the people, and is our main, *actually the only*, recourse we have to right the wrongs inflicted upon the nation by the other two Branches — because, as I have stated above, the fitness of all appointees by the President must be submitted to the Senate — and the Constitution gives Congress the power to impeach all officials of the other two Branches, and, by the same token, to keep its own members "*in line*." Unfortunately, the men we have been electing to Congress during the past three or four decades have, *in the main*, not been true to their *oaths* and their promises.

### LET'S NOT BE FOOLED AGAIN!

---

In our "*Year-End Report*" I cautioned the American people not to accept the election of 47 Republicans to the House of Representatives as a "*Waterloo*" victory for the salvation of our Country. In looking over the results of that election, certain conclusions can be drawn as to the dire future of our country — *unless the people resort to a RECALL movement to prevent it!*

As I see it, *unless we create a nation-wide RECALL movement*, there is no question but what the overall size and scope of government (*mismanagement by Johnson and his Cabinet*) will increase in the next two years. That will mean not only Federal government but also those closer to home. I predict, *unless we use our RECALL powers*, that the new lineup of office holders will vote even larger taxes and appropriations than their predecessors did.

It is true that in some isolated cases, men *pledged* to platforms

of reduced taxes and spending were elected. But we must accept that most of these men will, as I stated in the *"Year-End Report"*, *"go along"* with the bulk of the orthodox functions of government — no matter how repugnant to themselves — *in order to consolidate their own positions in office!*

*"Party labels"* will mean even less during the next two years than they have in the past. The Republican victories, for example, do not necessarily mean less *"Federal government"* in those cases. For the Republicans are just as vulnerable to the demands of staying in office as are the Democrats. And no one yet has ever proven to a politician that cutting accepted government programs is a way of perpetuating himself in office — *only the threat of "RECALL" will prove it to them!*

A studied analysis of most of the particular individuals who were elected will show that each of them has his own pet projects, *or the projects of his chief financial supporters*; projects that are designed to increase government control over your life. For example, several have said they want to hold the line on spending — *not cut it, but merely hold the line* — while at the same time, to *"satisfy" their constituents*, promoting some program to increase governmental control of anti-pornography regulation, or tighten control on Unions, or by inhibiting trade with Communist nations. *And not one that I know of has pledged himself to initiate, or support, Congressional investigations of the treason being committed in Washington!*

Thus, the sum and substance of very careful analysis of the election returns must be this: no matter what your political persuasion, there is very little reason for new optimism, because things are going to continue onward *"as usual"* with little change in the drift of the nation — *unless ALL loyal Americans join in a nationwide outcry and back it up with RECALL action!*

As you *now* review the election returns, do my comments make sense to you? Do you get the same impressions as I do, now that you can closely study the attitudes and platforms of the victorious candidates? I am sure you do.

And *remember this*: I stressed my predictions in our *"News-Bulletins"* and *"SPECIALS"* weeks before the election day. But already I can see that my predictions will be borne out before the two-year period affected by the election is over — *unless we, nationwide, use our RECALL weapon at the first sign of betrayal!*

Actually, I am merely calling attention to the obvious — that it doesn't really matter who was elected, the result will be the same — *unless we, the people, will use our powers over the elected! As*

proof, did Eisenhower reverse the trend to the "*welfare state*" that we associate with Roosevelt and Truman? Did even the famous 80th "*do-nothing*" Congress bring about greater freedom for us? Did the election of Max Rafferty in California reduce or alter the course of the gigantic, tyrannical state education system in California? And now that Ronald Reagan has been elected governor of California, I predict, *despite all his phony promises*, that the size of the state budget will be at least 25% larger within the next two years. And even if, *as a result of the election*, the new alignment of Republicans and Southern Democrats does achieve control of the House of Representatives, I predict an increase in "*Defense*" and "*Great Society*" costs . . . unless, as I have time after time stressed, *the people* will use their power to FORCE the men they've elected to fulfill their oaths to save us from the continued march into Socialism and Communism. In short, you and you and you, who have the power to do so, must stop depending on politicians' promises and use the only way (FORCE) to protect your own life and property — *and the life of our nation* — before it is too late!

## UN IS MOST VITAL CONGRESSIONAL INVESTIGATION!

---

In our "*Year-End Report*" and previous "*News-Bulletins*" I have listed a number of vital investigations we must FORCE Congress to initiate, but for reasons that will reveal themselves in the following pages, the investigation of the UN, which will automatically result in the withdrawal of the U.S. from the UN, *is the first and most imperative one!* Such an investigation will not only reveal that the UN is the chief instrument of the CFR's (*Council on Foreign Relations*) One-World plot, but it will also reveal all the traitors in Washington who are collaborating with the plot — and, *most important*, it will reveal that the UN IS NOW GIVING ORDERS TO THE U.S. The following FACTS prove it:

- 1) On November 20, 1963, the General Assembly of the UN adopted unanimously "*The Declaration On The Elimination Of All Forms of Racial Discrimination*; . . . 2) All 11 Articles of that "*Declaration*" are being accepted by our Federal Government as "*The Law Of The Land*;" . . . 3) *Each one of the 11 Articles violates the Constitutional liberties guaranteed to the American people under the "Bill of Rights;"* . . . 4) All of the unconstitutional acts and "*DECISIONS*" of the Supreme Court, of Johnson, and of Congress, are directly traceable to this "*UN DECLARATION.*"

The horrifying significance, in all effects, of these acts by our

Federal Government constitutes the elimination of the "*Bill of Rights*," as the first ten Amendments to the Constitution are called. Thus the Federal Government — *and our Congress* — has amended, *on orders of the UN*, our Constitution *unlawfully!* Our basic law requires the approval of three-fourths of the States to amend the Constitution — *this has not been done in this case!*

*The immediate dangers* as a result of our acceptance of that UN DECLARATION are . . . 1) *Employment of U.S. military forces and armament by the UN* against South Africa, Portugal and Rhodesia *in obedience* to this "DECLARATION" and of Articles 2, 25, 39 and 45 of the UN Charter, and . . . 2) Elimination in our school books of mention of the Constitution and of the heroic acts of our Founding Fathers by substituting therefor the UN Charter and so-called "*Civil Rights Laws*," to make them more acceptable to a rabble rousing minority of American Negroes and to the Black so-called Nations of the world . . . Unless the American People act NOW, and FORCE Congress to get the U.S. out of the UN *immediately*, these acts of our Federal Government could result in . . . 1) A Civil War quickly developing into a so-called Communist "*War of Liberation*" with all of the accompanying Red and Black atrocities and terror and assassinations of public figures *and innocent people*; or . . . 2) Federal acquiescence to "*invasion*" by alien Black and Yellow "*Peace Keeping Forces*" of the UN to counter our own forces and obtain "*Peace*" by surrender to a One-World Government and World Court, *in accordance with the "Great Conspiracy" plans*; or . . . 3) A second and bloody American Revolution to reject and outlaw the UN and launch *a new Continental Congress* to take the place of the absconding traitorous Federal Government, thus again starting, as did our Founding Fathers, with an un-encumbered Constitution — and new LAWFUL money.

Nowthen, in the preceding directives I have shown that *the people* have the power to FORCE Congress to do our bidding. But there is no time to be lost in making it clear to the members of Congress that we, the people, are their masters — *that they are our servants* — that they must haul the UN up for investigation IMMEDIATELY, because, under the provisions of that State Department's starkly treasonous "*Document 7277*," September of *this year* is the deadline for beginning the transfer of all of our military forces to the UN. However, should Congress fail us, *God forbid*, we have recourse to another method of getting the U.S. out of the UN — and I earnestly suggest that we should prepare to get that method under way NOW, even if we will never have to use it.

## THE STATES OUR RECOURSE

---

Inasmuch as our Federal Government is a creature, and an employee of the 50 States, as specified in the Constitution, its elimination, ipso facto, eliminates the Federal Government. What remains, then, are 50 sovereign, independent States without the instrumentality devised for their Union. The governments of each of these States being supreme within their own jurisdictions must make a decision . . . 1) Surrender to the usurpers, or . . . 2) Pass laws nullifying their participation in the UN. Any State Government that fails to follow the latter (No. 2) course would be derelict in its duty to its citizens and guilty of collaboration with our enemies: the UN One-World Conspirators. *If free men do not hang together in this crisis, we will hang separately after it!*

## PROOF OF STATE DEPT. DELIBERATE TREASON

---

Ever since 1946, we (CEG) have revealed with indisputable proof that the UN is nothing more nor less than the "cat's paw" of the Masterminds of the One-World Conspiracy — that it is the planned "housing" for their One-World Government. The "PEACE" bait of the UN has long been unmasked, except for those who still are brainwashed and gullible — and, too, more and more of those naive ones are beginning to have their doubts.

However, there is one great fact that still seems to escape many normally intelligent people, and that fact is that the UN, of itself, would be no great menace — that, in fact, it would long ago have disintegrated, had it not been aided, supported and shielded by our own traitors in Washington — traitors who take their orders from the CFR, the Masterminds of the Great Conspiracy. To remove even a remote doubt of that fact from the minds of the naive ones, the following pages will be devoted to provide *concrete* proof that from the very inception of the UN all of our Federal Administrations have been collaborating in the plot. However, because of limited space, I will concentrate on the State Department.

---

**Note:** In order to make the following crystal clear, let me point out that when the Conspirators were formulating their plans to use the UN, with its PEACE bait, to accomplish their One-World objective, they took



every measure possible, to make the UN sacrosanct. In other words, to keep it a "holy" instrument for the preservation of PEACE. Hence, the UN was to be kept beyond suspicion. For that reason, in their phony "Preamble" they "faithfully" stated that never, but never, would the UN try to interfere with the domestic affairs of their member nations. They made one serious mistake when they tried to make a "World Court" an integral feature of the "Charter." That was why, when Pat McCarran insisted on his "amendment," the "Masterminds" quickly ordered their stooges not to resist it — for fear that it might lead to debates that would unmask the entire plot and lead to complete rejection of the UN. However, even with their control of our traitorous Mass Communications Media, there would have to be a lot of "dirty work" done to accomplish their overall evil objective. So it was decided to set up various "Agencies," or "Fronts" to do that "dirty work." Among these "Agencies," there were "Unicef," the "United World Federalists" (UWF) "Atlantic Union," "UNESCO," etc., etc., and all those "Agencies" were to be given official status by our Federal Government Agencies, particularly by the State Department. In view of space limitation in this issue I will deal with only one of the UN Agencies, to wit: "UNESCO."

---

One of the chief objectives of the Conspirators was to "capture" our Youth — *to indoctrinate in them a One-World conception that would supposedly save them from wars* — to "educate" them out of Nationalism and patriotism, and thus transform them into One-World citizenry. That could only be accomplished by complete control of our educational systems — *from kindergarten to Universities!* Thus, even before they met in San Francisco to set up the "United Nations," the Conspirators began to lay the groundwork for an "Educational, Scientific and Cultural Organization," which quickly became UNESCO immediately after the UN Charter was accepted by our Senate.

Almost from the outset, the Masterminds of the Conspiracy tried to seduce our Senate to grant UNESCO a "Treaty" status — just as they also tried to get "Treaty" status for UNICEF and GENOCIDE — but CEG and various other alerted Patriotic Groups swamped all the Senators with strongly worded protests, and, as a result, UNESCO never did get an actual "Treaty" status. But in the following pages, I will show how our traitorous State Department provided UNESCO with an *official* status fully as powerful as a "Treaty" status — *they set up within the State Department something which they called "The United States National Commission for UNESCO and its Secretariat."* And, on behalf of UNESCO, that "Commission" was empowered by the State Department to issue "Resolutions" and "Edicts," which, *backed as they were by the State Department,* were accepted, to all intents and purposes, as

*"Laws of the Land."* In addition, the State Department itself published pamphlets and books to serve all UNESCO objectives — they also induced, or FORCED, the publication of text books embracing UNESCO teachings in all schools, Colleges and Universities — thus committing treason against American Youth *and the American people* equal to the treason committed by Pierre Laval, for which the French people executed that traitor.

Nowthen, lest some of the brainwashed and still bemused people will consider what I have said as merely *"personal opinion,"* I will now set down a DOCUMENTED event which took place in 1956, in which neither I, nor CEG as a whole, were in any way involved — it was entirely an *American Legion* project — and follows thusly:

In 1956 the Kansas City Times published an interview with J. Addington Wagner, of Battle Creek, Michigan, who was then the National Commander of the American Legion. In that interview Commander Wagner declared that UNESCO should be abolished *"because it advocates One-World Government, and One-World Government is a threat to the freedom of the U.S."*

But even more important, Mr. Wagner testified to the same effect on March 7, 1956, before *"Sub-Committee No. 3, International Organizations and Movements, of the House Foreign Affairs Committee,"* in connection with hearings on UNESCO . . . following is the complete statement of National Commander Wagner before that House Sub-Committee:

**"My name is J. Addington Wagner. I am the National Commander of The American Legion, and I appreciate, through my appearance here today, the opportunity to carry out the mandate of the October 1955 National Convention of The American Legion relative to UNESCO."**

The pertinent clauses of that 1955 Resolution are as follows:

**"RESOLVED, That The American Legion urges Congress to repeal the laws creating the United States National Commission for UNESCO and its Secretariat; and that Congress deliver mandates to all Administrative Departments of the United States Government to desist from further dissemination of UNESCO and United States National Commission for UNESCO materials, reports and programs within the territorial jurisdiction of the United States . . . That Congress be urged to make a complete current investigation of the operations of UNESCO to determine whether or not that Agency has complied and is complying with the terms and conditions of Resolution 215 of the House of Representatives and Resolution 122 of the United States Senate, 79th Congress; said Resolutions being the basis of the United States participation in UNESCO; provided further, that investigation be**

especially made to ascertain explicitly whether there has been violation of the provision of the final portion which specifically stated: 'that such agency shall not interfere with educational systems or programs within the several nations, or their administration.' And if, upon investigation, it be determined that UNESCO HAS violated any of the conditions as set forth in the Resolutions, that Congress be urged to take appropriate action to enforce compliance therewith."

---

The American Legion's (1955) Convention mandate on UNESCO climaxed the most extensive study, debate and discussion ever given to any subject by the Legion. Aside from the two days of discussion and debate given the subject by the members of the Joint Foreign Relations — Americanism Convention Committee, and by witnesses who appeared before it, UNESCO was considered by delegates to many of the Legion's Department Conventions in 1954 and 1955. As a matter of fact, ten Department Conventions adopted "*Resolutions*" on the subject — and all ten supported American Legion policy of adamant opposition to UNESCO. The same subject had also been thoroughly studied and discussed by the National Executive Committee of the Legion.

---

## WHAT AMERICAN LEGION RESEARCH REVEALED

---

The opposition of The American Legion started with those who originated UNESCO. The *official* publication of the *Department of State*, entitled "*Post War Foreign Policy Preparation (1939-1945)*," on page 216 states that Alger Hiss was appointed Special Assistant to the Director of the office of Special affairs in April 1944 — *this is the same Alger Hiss who was the chief architect of the UN, and who later served a term in prison for perjury in connection with his Communist Party affiliations!*

Subordinate to and reporting to the Office of Special Political Affairs was the Division of International Security and Organization. Employed in the "*Division*" were: Mrs. Esther C. Brunauer, later (*reluctantly*) fired from her job in the State Department as a "*security risk*;" Dr. Quincy Wright, later *documented* by the Senate Internal Security Subcommittee as having "*actively participated in the work of the American Institute of Pacific Relations. (IPR)*." This IPR was identified by the Senate Internal Subcommittee in 1952 as an "*instrument of Communist policy, propaganda and mili-*

*tary intelligence". . . . it was the IPR that was directly responsible for delivering China to Communism — and let's not forget that Dean Rusk, present head of our State Department, was the "brains" of the IPR at the time that China was delivered to the Communists!*

On March 25, 1944, *the State Department* announced that the U.S. Government would send a delegation to the Conference of Allied Ministers of Education in London. The American delegation included Archibald MacLeish, *documented* by the House Committee on Un-American Activities to have been affiliated with ten, *or more*, organizations cited as (RED) subversive. At meetings April 5 - 29, 1944, that Conference drew up a tentative draft agreement for a "*United Nations organization for Educational, Scientific and Cultural*" reconstruction — *a full year before there was such a thing as UNITED NATIONS!!!*

In the U.S. Department of State, through the collaborative efforts of the "*Division of International Organization Affairs*" and the Office of "*Special Political Affairs*," a new proposal was formulated which looked to the establishment of a permanent organization for "*educational, scientific and cultural*" cooperation to begin functioning simultaneously with the already planned general international (UNITED NATIONS) organization — and they shifted the emphasis from "*reconstruction*" to longer range objectives. This new proposal was approved in principle by the staff committee on February 2, 1945, at which time *the not yet unmasked* Alger Hiss was Acting Director of the Office of Special Political Affairs. On April 17, 1945, when the final draft of the proposal was made available by the State Department to the Conference of Allied Ministers in London, traitor Alger Hiss was Director of the Office of Special Political Affairs . . . In its January 2, 1955 Report, the Senate Internal Security Sub-committee concluded:

**"1) Alger Hiss, Harry Dexter White (Weiss), and their confederates in the Communist underground in the U.S. Government, had power to exercise profound influence on American foreign policy and the policies of international organizations during World War Two and the years immediately thereafter . . . 2) They had power to exercise profound influence on the creation and operation of the United Nations and its specialized Agencies. . . . 3) This power was not limited to their officially designated authority. It was inherent in their access to and influence over higher officials, and the opportunities they had to present or withhold information on which the policies of their superiors might be based . . . 4) Hiss, White and a considerable number of their colleagues who helped make American foreign**

policy and the policies of international organizations during crucial years have been exposed as secret Communist agents."

---

In its "Second Report on Activities of United States Citizens employed by the United Nations," the Senate Internal Security Subcommittee further concluded that . . . "Harry Dexter White was the Treasury's representative at the United Nations San Francisco Conference, where he gave particular attention to the establishment of UNESCO."

---

## RIGHT FROM THE HORSE'S MOUTH

---

The U.S. Department of State publication #2457, entitled "*The Defense of Peace Documents relating to UNESCO*," lists among the delegation to the "Preparatory Educational, Scientific and Cultural Commission" in 1946 the following: Esther C. Brunauer, Archibald MacLeish, Alexander Meikeljohn, Harlow Shapley and Mark Starr — *all of them DOCUMENTED REDS!* . . . In addition, subsequent to its formation, a number of the U.S. delegates, *appointed directly or indirectly by the State Department*, to the General Conference of UNESCO were individuals with DOCUMENTED records of affiliation with subversive (RED) records; among them were: Lawrence Duggan, Charles S. Johnson and Reinhold Neibuhr, in addition to many others who subsequently were fired from their jobs with the State Department and/or UNESCO, as a result of loyalty investigations.

The same American Legion research revealed that Alva Myrdal, wife of Gunnar Myrdal, *author of the book upon which Earl Warren based his DESEGREGATION DECISION*, was the Director of the Social Science Department of UNESCO — this same Alva Myrdal was known to be such an extreme Leftist (RED) (*as was her husband*), that the State Department at one time denied her a visa. In its official report in 1954, the Special Committee to Study Tax-Exempt Foundations, stated that: "*A person of Mme. Myrdal's persuasion should be Director of the Social Department of UNESCO is rather forbidding*" . . . the real word should have been *treasonously reprehensible!*

During his appearance before the Congressional Committee, National Commander of the American Legion (*J. Addington Wagner*) stated that the American Legion is unalterably opposed to the

creation of *any* form of One-World Government, and then he stressed that UNESCO in its own publications, *many of them approved and sponsored by the U.S. State Department*, advocates World Government. He pointed out that the most clear-cut examples of that advocacy were found in the series of pamphlets entitled "*Toward World Understanding*," published by UNESCO and sold and distributed through UNESCO and the U.S. State Department outlets. *To leave nothing to imagination*, that series of pamphlets was advertised in the "*Report*" of the Fifth National Conference of the State Department's "*U.S. National Commission for UNESCO*." . . . Page 60 of Volume 5 of that series stated:

**"Education for World-mindedness at present encounters obstacles outside the school. THE PRINCIPAL ONE CERTAINLY IS NATIONALISM. If the feeling of belonging to the human community develops normally by an extension of the feeling of belonging to the national community, it cannot possibly develop from the caricature of patriotism which is extreme nationalism. If the integration of the child in the national group takes place in the atmosphere of pride and contempt characteristic of this attitude, the efforts of the teachers, no matter how judiciously concerted they may be, will in most cases remain barren. Education for world-mindedness is not a problem that the school can solve within its own walls or with its own means. It is a political problem even more than an educational one, and the present position of teachers does not, in general, permit them to intervene in the field of politics with the requisite authority."**

The above *verbatim* quoted statement clearly establishes the American Legion's charge that UNESCO advocates "*One-Worldism*" — and that it was set up to accomplish it by getting control of our entire Educational system. But, again, to leave nothing to imagination, let's go a step further; in Volume IV of that same series of pamphlets, entitled "*The United Nations and World Citizenship*," and sponsored by the State Dep't., we find the following brazenly published statement:

**"World-wide organization for the conduct of human affairs is therefore essential. No teacher with a sense of realism and even an elementary knowledge of world affairs will ignore this basic need or be indifferent to its consequences for education. WORLD machinery is required; and human beings with the right outlook are required to utilize it or to insist that it be utilized. The educator (teacher) thus has a double task; to teach about the machinery of WORLD co-operation and to foster the growth of the spirit that will make it (ONE-WORLDISM) function. Education has, in short, the urgent duty to develop informed and competent WORLD citizens."**

Even more significant is a UNESCO Report to the UN in 1952, on page 61, under the caption "*Education for International Under-*

*standing,” which stated: “In this field, UNESCO, often reaching far beyond the boundaries of the schoolroom, is endeavoring to encourage the new attitude of mind which alone can foster the development of a sense of (One) World citizenship.”*

---

At this point, I wish to remind the reader that Lenin, Trotsky, Stalin, Khrushchev and other Communist officials have repeatedly stated that all they needed was one fully indoctrinated generation of American Youth to transform our nation into a Communist One-World unit. Thus we know that our Youth was their principal target — *and that was the job that was assigned to UNESCO.* Any attempt to categorize how “*far beyond the boundaries of the schoolroom*” UNESCO went to achieve that objective would require a book of many, many pages. But I will set down a few of their steps — and in those steps, they, of course, had all of the powerful help of the Masterminds of the GREAT CONSPIRACY, the CFR.

One of their first steps was to create what they called “*Progressive Education*,” which was gradually introduced into all our schools. John Dewey, an “*Educator*” of considerable reputation, and *as RED as they come*, was the “*Father*” of this “*Progressive Education*” scheme. Of course, he had plenty of help by members of Harvard, Columbia and other University Faculties.

UNESCO’s next step was to get complete control of NEA (*the National Educational Ass’n.*) — and of the National “*Parent and Teachers Association (PTA)*.” Through the National PTA, they were able to influence the local PTAs in many communities throughout the nation — many of the local PTAs were “*sitting ducks*” for UNESCO’s scheme, simply because those local PTAs were naive (*perhaps STUPID is the better word*), and thoughtlessly carried out all of the National PTA’s directives and suggestions.

Simultaneously, UNESCO *successfully* reached out to the publishers of our Text Books, with the result that the present day textbooks used in our schools deliberately denigrate Americanism, patriotism, loyalty to Country — *and to parents.*

But, as Al Jolson used to say, you ain’t heard nothin’ yet. The transformation and distortion of our text books was intended to create One-World mindedness in our Youth, but to complete the job UNESCO went a step further — they felt it was necessary to destroy the moral fiber of our Youth. So they reached out (*in their own words*) “*far beyond the boundaries of the schoolroom.*” During

the past couple of decades you have heard and read much about obscenity in books, pamphlets, Films, TV shows, etc., about pornography — well, we can thank UNESCO and our State Department's "United States National Commission for UNESCO" for all of it. They "reached" into the book publishing fields, the Film Industry and all such means to demoralize our Youth. They promoted the writing and publishing of books and Films that glorified (Sex) immorality and lawlessness of every type — and made them available through every means of circulation. *And all such books and Film scripts were written by men and women who have time after time been officially DOCUMENTED as REDS!* It is impossible to name all such books and films and their authors in our limited space, but it is hardly necessary for me to state that such books, pamphlets and Films, all eulogized by Press, "critics," far outnumber all other types of decent literature and Films — and all have a ready market — *especially in sources accessible to the Youth in all of our educational institutions and Libraries!*

Now, do you still wonder about the strange ideas your children bring home from their schools? Do you still wonder why so much of our Youth has turned to a beatnik-way of life? Do you still wonder why so much of our Youth have become sex perverts? Do you still wonder why there are so many Juvenile Delinquents? Do you still wonder why your children scorn home and parental influences? Do you still wonder why our entire society is becoming demoralized and law-defying?

Now bear in mind that UNESCO, which is directly responsible for all of the above, *is only one of many such UN Special Agencies* — and that all such Special Agencies were set up to destroy the moral fiber of our entire nation. Do you still have any doubts that one of our most important objectives is to FORCE Congress to haul up the UN for a thorough investigation — and take the U.S. out of that UN trap — and hurl the UN out of the U.S.?

It is not just UNESCO that is a menace to the survival of our nation — *it is the UN as a whole!* Smash the UN, and UNESCO and all of its other poisonous "Special Agencies" will die with it. The immediate investigation of the UN by Congress is a MUST. For the love of our Country *and your children*, join with your friends and neighbors in a DEMAND on your Representatives in Congress in both Houses to start that investigation NOW — *later will be too late!*



## ALSO THE STATE DEPARTMENT

---

Simultaneously, Congress MUST investigate the State Department's collaboration with the UN. I — *and the American Legion* — have already established that there is such a collaboration. The State Department's "*U.S. National Commission for the UN*" alone makes it very apparent that our State Department is a full partner with the UN to transform our beloved Country into a unit of a UN One-World Government. But it is only one segment of such a partnership.

To (*again*) leave nothing to imagination, I will provide DOCUMENTARY evidence of the State Department's partnership with UNESCO, I will show their guilt by quoting from the State Department's own statements:

1) As I have previously stated, the U.S. Department of State publication #2457, entitled "*The Defense of Peace, Documents relating to UNESCO*" lists among the delegation (*set up by the State Department*) to the Preparatory Educational, Scientific and Cultural Commission in 1946 the following: Esther C. Brunauer, Archibald MacLeish, Alexander Meiklejohn, Harlow Shapley, Mark Starr, Lawrence Duggan, Charles S. Johnson and Reinhold Neibuhr (among others) — *all of them DOCUMENTED as subversive Reds* by the House Committee on Un-American Activities and/or the Senate Internal Security Committee and/or the U. S. Attorney General — *in most cases by all three . . .* 2) In November 1949, a pamphlet entitled "*UNESCO TODAY*" was published as *State Department Publication #3694* for the "*U.S. National Commission for UNESCO*," which reported that: "*Largely as a result of Commission activities, at least a dozen Universities and Colleges now have UNESCO courses on international understanding — and MANY grade school teachers throughout the nation interested in the UNESCO movement have brought it to the attention of their classes; international themes have been stressed in pageants, plays and music; and national scholastic newspapers and magazines, as well as those published by schools, have stressed UNESCO along with the UN and other specialized Agencies*" . . . 3) In May 1950, a booklet entitled "*THE UNESCO STORY*" was published as *State Department Publication #3931* — Activities which have been carried on in the schools of the United States in behalf of UNESCO are listed on approximately FIFTY pages of this *U.S. State Department publication* . . . 4) In November 1951, a Bulletin entitled "*A Junior High School Looks At UNESCO*" was published as *State Department Publication #4380* — this entire publication was de-

voted to showing (*brazenly*) how the entire UNESCO program was carried out in the Alice Deal Junior High School in Washington, D.C.

I could cite MANY more State Department official Publications which prove beyond even a remote doubt that *our* State Department has been — *and is* — deliberately sponsoring and aiding UNESCO to take over our entire educational system, in order to create the kind of a “*generation*” required by the *Masterminds of the Great Conspiracy* for a One-World take-over of our Country. *If that is not outright TREASON then Quisling and Pierre Laval were wrongfully executed by their Countries!*

However, if that is not sufficient cause for “*trial*” by Congress of Dean Rusk and the other traitors in our State Department I will again point to an even more horrifying act of TREASON!

### THE “DISARMAMENT” PLOT

---

The following is a verbatim reprint of a State Department SECRET Publication, “*Department of State Publication 7277 . . . Disarmament Series 5. Released September 1961 . . . Office of Public Services . . . BUREAU OF PUBLIC SERVICES.*”

“*INTRODUCTION:— The revolutionary development of modern weapons within a world divided by serious ideological differences has produced a crisis in human history. In order to overcome the danger of nuclear war now confronting mankind, the United States has introduced at the Sixteenth General Assembly of the United Nations a Program for General and Complete Disarmament in a Peaceful World.*

---

(*Note:— What “Peaceful World?” What about Viet Nam? MCF.*)

---

“*This new program provides for the progressive reduction of the war-making capabilities of nations and the simultaneous strengthening of international institutions to settle disputes and maintain the peace. It sets forth a series of comprehensive measures which can and should be taken in order to bring about a world in which there will be freedom from war and security for all states. It is based on three principles deemed essential to the achievement or practical progress in the disarmament field:*

**FIRST, THERE MUST BE IMMEDIATE DISARMAMENT ACTION:—**

*“A strenuous and uninterrupted effort must be made toward the goal of general and complete disarmament; at the same time, it is important that specific measures be put into effect as soon as possible.*

**SECOND, ALL DISARMAMENT OBLIGATIONS MUST BE SUBJECT TO EFFECTIVE INTERNATIONAL CONTROLS (BY THE UN!):—**

*“The control organization (the UN) must have the manpower, facilities, and effectiveness to assure that limitations or reductions take place as agreed. It must also be able to certify to all states that retained forces and armaments do not exceed those permitted at any stage of the disarmament process.*

**“THIRD, ADEQUATE PEACE-KEEPING MACHINERY MUST BE ESTABLISHED:—**

*“There is an inseparable relationship between the scaling down of national armaments on the one hand and the building up of international (THE UN) peace-keeping machinery and institutions on the other. Nations are unlikely to shed their means of self-protection in the absence of alternative ways to safeguard their legitimate interests. This can only be achieved through the progressive strengthening of international institutions under the United Nations and by creating a United Nations Peace Force to enforce the peace as the disarmament process proceeds.”*

(NOTE:— AS THE UN DID IN THE CONGO? MCF.)

*“There follows a summary of the principal provisions of the United States Program for General and Complete Disarmament in a Peaceful World. The full text of the program is contained in an appendix to this pamphlet.”*

---

**FREEDOM FROM WAR**

---

*“The United States Program for General and Complete Disarmament in a Peaceful World.”*

*“Summary:— Disarmament Goal and Objectives:*

*“The overall goal of the United States is a free, secure and peaceful world of independent states adhering to common standards of*

justice and international conduct and subjecting the use of force to the rule of law; a world which has achieved general and complete disarmament under effective international control; and a world in which adjustment to change takes place in accordance with the principles of the United Nations . . . In order to make possible the achievement of that goal, the program sets forth the following specific objectives toward which nations should direct their efforts: The disbanding of all national armed forces and the prohibition of their reestablishment in any form whatsoever than those required to preserve internal order and for contributions to a United Nations Peace Force; The elimination from national arsenals of all armaments, including all weapons of mass destruction and the means for their delivery, other than those required for a United Nations Peace Force and for maintaining internal order;

*“The institutions of effective means for the enforcement of international agreements, for the settlement of disputes, and for the maintenance of peace in accordance with the principles of the United Nations; The establishment and effective operation of an International Disarmament Organization within the framework of the United Nations to insure compliance at all times with all disarmament obligations.*

#### **“TASK OF NEGOTIATING STATES:—**

*“The negotiating states are called upon to develop the program into a detailed plan for general and complete disarmament and to continue their efforts without interruption until the whole program has been achieved. To this end, they are to seek the widest possible area of agreement at the earliest possible date. At the same time, and without prejudice to progress on the disarmament program, they are to seek agreement on those immediate measures that would contribute to the common security of nations and that could facilitate and form part of the total program.*

#### **“GOVERNING PRINCIPLES:—**

*“The program sets forth a series of general principles to guide the negotiating states in their work. These make clear that: As states relinquish their arms, the United Nations must be progressively strengthened in order to improve its capacity to assure international security and the peaceful settlement of disputes; Disarmament must proceed as rapidly as possible, until it is completed, in stages containing balanced, phased and safeguarded measures . . . Each measure and stage should be carried out in an agreed period of time, with transition from one stage to the next to take place as soon as all measures in the preceding stage have been carried out and veri-*

fied and as soon as necessary arrangements for verification of the next stage have been made; . . . Inspection and verification must establish both that nations carry out scheduled limitations or reductions and that they do not retain armed forces and armaments in excess of those permitted at any stage of the disarmament process; and . . . Disarmament must take place in a manner that will not affect adversely the security of any state.

**“DISARMAMENT STAGES:—**

*“The program provides for progressive disarmament steps to take place in three stages and for the simultaneous strengthening of international institutions.*

**“FIRST STAGE:—**

*“The first stage contains measures which would significantly reduce the capabilities of nations to wage aggressive war. Implementation of this stage would mean that:—*

**“THE NUCLEAR THREAT WOULD BE REDUCED:**

*“All states would have adhered to a treaty effectively prohibiting the testing of nuclear weapons . . . The production of fissionable materials for use in weapons would be stopped and quantities of such materials from past production would be converted to non-weapons use . . . States owning nuclear weapons would not relinquish control of such weapons to any nation now owning them and would not transmit to any such nation information or material necessary for their manufacture . . . States not owning nuclear weapons would not manufacture them or attempt to obtain control of such weapons belonging to other states . . . A Commission of Experts appointed by the UN would be established to report on the feasibility and means for the verified reduction and eventual elimination of nuclear weapons stockpiles.*

**“STRATEGIC DELIVERY VEHICLES WOULD BE REDUCED:—**

*“Strategic nuclear weapons delivery vehicles of specified categories and weapons designed to counter such vehicles would be reduced to agreed levels by equitable and balanced steps; their production would be discontinued or limited; their testing would be limited or halted.*

**“ARMS AND ARMED FORCES WOULD BE REDUCED:—**

*“The armed forces of the United States and the Soviet Union would be limited to 2.1 million men each (with appropriate levels*

not exceeding that amount for other militarily significant states); level of armaments would correspondingly reduce and their production would be limited . . . An Experts Commission (appointed by the UN) would be established to examine and report on the feasibility and means of accomplishing verifiable reduction and eventual elimination of all chemical, biological and radiological weapons.

**“PEACEFUL USE OF OUTER SPACE WOULD BE PROMOTED:—**

*“The placing in orbit or stationing in outer space of weapons capable of producing mass destruction would be prohibited . . . States would give advance notification of space vehicle and missile launching.*

**“UN PEACE-KEEPING POWERS WOULD BE STRENGTHENED:—**

*“Measures would be taken to develop and strengthen United Nations arrangements for arbitration, for the development of international law and for the establishment in Stage 11 of a permanent UN Peace Force.*

**“AN INTERNATIONAL DISARMAMENT ORGANIZATION WOULD BE ESTABLISHED FOR EFFECTIVE VERIFICATION OF THE DISARMAMENT PROGRAM:—**

*“Its functions would be expanded progressively as disarmament proceeds . . . It would certify to all states that agreed reductions have taken place and that retained forces and armaments do not exceed permitted levels . . . It would determine the transition from one stage to the next.*

*“States would be committed to other measures to reduce international tensions and to protect against the chance of war by accident, miscalculation, or surprise attack.*

*“States would be committed to refrain from the threat or use of any type of armed force contrary to the principles of the UN Charter and to refrain from indirect aggression and subversion against any country . . . A UN Peace Observation group would be available to investigate any situation which might constitute a threat to or breach of the peace . . . States would be committed to give advance notice of major military movements which might cause alarm; observation posts would be established to report on concentrations and movements of military forces.*

## **"SECOND STAGE:—**

---

*"The second stage contains a series of measures which would bring within sight a world in which there would be freedom from war. Implementation of all measures in the second stage would mean: . . . Further substantial reductions in the armed forces, armaments and military establishment of states, including strategic nuclear weapons delivery vehicles and countering weapons; . . . Further development of methods for the peaceful settlement of disputes under the United Nations; . . . Establishment of a permanent international peace force within the United Nations; . . . Depending on the findings of a UN Experts Commission, a halt in the production of chemical, bacteriological, and radiological weapons and a reduction of existing stocks or their conversion to peaceful uses; . . . on the basis of the findings of a UN Experts Commission, a reduction of stocks of nuclear weapons; . . . the dismantling or the conversion to peaceful uses of certain military bases and facilities wherever located; and . . . The strengthening and enlargement of the UN International Disarmament Organizations to enable it to verify the steps taken in Stage II and to determine the transition to Stage III.*

---

## **"THIRD STAGE:—**

---

*"During the third stage of the program, the states of the world, building on the experience and confidence gained in successfully implementing the measures of the first two stages, would take final steps toward the goal of a world in which: . . . States would retain only those forces, non-nuclear armaments and establishments required for the purpose of maintaining internal order; they would also support and provide agreed manpower for a UN Peace Force. . . . The UN Peace Force, equipped with agreed types and quantities of armaments, would be fully functioning . . . The manufacture of armaments would be prohibited except for those agreed types and quantities to be used by the UN Peace Force and those required to maintain internal order. All other armaments would be destroyed or converted to peaceful purposes . . . The peace-keeping capabilities of the United Nations would be sufficiently strong and the obligations of all states under such arrangements sufficiently far-reaching as to assure peace and the just settlement of differences in a disarmed world."*

---

Following the above "THIRD STAGE" the State Department "Document" contains what they called an "APPENDIX." It is the windiest, gabbiest and most repetitious piece of writing I have ever read. It is a repetition of the "THREE STAGES," but goes into greater, *albeit more confusing*, details of just exactly how the United States is to finally deliver to the UN all of our Nuclear and military armaments — *and transfer our armies to UN control*. It will confuse many readers — as the authors of that "DOCUMENT" hoped it would *if it was ever revealed to the public!* Limit of space does not permit a verbatim reprint of that "APPENDIX," but it is hardly necessary to do so, as the THREE STAGES, in themselves, if properly analyzed, provides the self-incriminating evidence of the men who wrote the entire "DOCUMENT" (*Rusk and his Cabal in the Department*). It proves that at the conclusion of the "THIRD STAGE" *the U.S.A. would no longer be a free and sovereign state, but a unit in the Communist One-World Government . . .* It proves that we will have absolutely no choice but to surrender . . . it proves that the "no-win" (undeclared) war in Viet Nam is merely a training process for a million of our sons to be used when (*not if*) the UN will decide to use armed force to subjugate Rhodesia, South Africa, Portugal — *and any other nation that will try to resist that UN subjugation . . .* it proves that Rusk and his co-conspirators, and that includes Johnson and McNamara, are as guilty of deliberate TREASON as Quisling and Laval — that the treason committed by Benedict Arnold compared to that continuously being committed by Rusk and his co-conspirators was, in legal terminology, a minor misdemeanor.
