THE LAST WARNING! ! !

In our March 1968 "News-Bulletin", entitled "ONLY A LOYAL CONGRESS CAN SAVE OUR COUNTRY," I stated that 1968, *which was an ELECTION YEAR*, would have to be *our Year of Greatest Decision*.

I made that statement, *which actually was a warning*, because everything pointed to the fact that that was the year in which we, the people, were faced with the question of whether our Country was "*to be or not to be*" the Free Land our Founding Fathers had handed down to us. And I *stressed* that it was we, the people, who would have to decide that question by the kind of a Congress we would elect . . . but, *more important, it also was a warning NOT to put a Richard M. Nixon into the White House!*

Now, why did I warn against the election of Nixon to the Presidency? Because, *and I so stated at the time*, if he ever achieved such an election, he and the CFR would immediately begin to scheme for ways and means to transform the Presidency into a DICTATORSHIP.

Now I will let you decide the accuracy of that warning by reprinting a *dead giveaway* statement made by Nixon's own White House Counselor, Daniel P. Moynihan, which was published on June 7 (1970), by the Los Angeles Times:

"DISTRUST OF GOVERNMENT GROWS," MOYNIHAN SAYS—NEW YORK UPI

White House Counselor Daniel P. Moynihan said Saturday the rumor that President Nixon would cancel the 1972 Presidential election indicated that fear and distrust of the Government had epidemic proportions on College Campuses. The fact that educated persons all across the Land believe that the elections would be cancelled on the pretext of avoiding violence by radical students was evidence of the very great difficulty we must expect in the effort to restore confidence and trust. Moynihan further said a newspaper reported during the Spring that the White House had ordered a study of the effect of a possible election cancelation in 1972."

Here let me make one point clear: your right to vote for the men you want to represent you in the White House, in Congress, in *any* elective office, is perhaps the most sacred provision in our CONSTITUTION. Anyone, from the President down, who tries to deprive you of that right automatically becomes subject to IMPEACHMENT.

Now: in view of Nixon's plan to deprive you of that right to vote in 1972, as clearly indicated by Moynihan, I now repeat, *with greater emphasis*, what I told you in 1968: that "ONLY A LOYAL CONGRESS CAN SAVE OUR COUNTRY"—that how YOU, and ALL the American people, will vote in November of *this* year will decide the question of whether our Country will continue to be the Free Land our Founding Fathers handed down to us—or an enslaved unit in the CFR's ONE-WORLD (UN) DICTATORSHIP . . . *because THAT is what Nixon's plan to void the 1972 elections really means!!!* . . . In short, my dear Fellow-American, you may take this WARNING of Nixon's plan, *as revealed by Moynihan*, any way you like, but, please believe me, the way you and ALL of the American people will vote in November, the kind of men you will vote into Congress this year will have a terrific bearing on the entire issue—it will be the men we elect to be our next Congress who will decide whether or not Nixon will be permitted to cancel the 1972 elections.

I, personally, believe that Nixon is fully capable of trying to carry out such a plan—and there are many knowledgeable *and* alarmed men in Washington who feel the same way about it—furthermore, they, as well as I, know that the CFR is behind this Nixon "plan"—*they (the CFR) want Nixon to be their obedient "Commander-in-Chief" in the White House when the day for the final "take-over" of our Country will arrive . . . and that day is now very close!!!*

However, I fully realize that there are many naive, *but otherwise loyal*, Americans who even today accept Nixon as a loyal and sincere American—men and women who, although disappointed and bewildered by his failure to fulfill all the glittering "*promises*" he made when he was seeking their votes, simply cannot believe that he would deliberately collaborate with the Masterminds of the GREAT CONSPIRACY to destroy the SOVEREIGNTY of our Nation. So, in all fairness to those naive Americans, and in the hope that it will serve to unbrainwash them, I will devote the rest of this "*News-Bulletin*" to a review of Nixon's background and thus, let them decide the answer to: *Is Richard M. Nixon loyal to Country and to the American people who elected him to be our President—or, like several of his predecessors, is he in the White House to help the CFR carry out their heinous plot to transform the USA into an enslaved unit in their UN One-World Dictatorship? ? ? . . . his past deeds will PROVE that question.*

First, I assume that you know what the CFR (COUNCIL ON

FOREIGN RELATIONS) is, and the extent of its fiendish influences (*actually control*) over both our National Political Parties—over our Mass Communications Media (Press—TV—RADIO)—over our Educational Institutions—over our Foreign and Domestic politics—and over our national Economy, via the “Federal Reserve System”.

I base that assumption on the fact that, in addition to our regular Monthly publications (*News-Bulletins*) on the subject, in 1967 we issued and made available to you an Album of RECORDINGS (3 *two-sided Records*), entitled “THE ILLUMINATI-CFR CONSPIRACY,” in which we revealed the entire history of the “GREAT CONSPIRACY” from the inception of the “ILLUMINATI” in the early 1770’s to the present day, *when it is operating in America as the “COUNCIL ON FOREIGN RELATIONS” (CFR)*.

Now let me tell you why we issued that “*Set of Recordings*”: It was to alert (WARN) our people that 1968 would be our year of greatest decision—*perhaps our last year for it!* It would be an ELECTION year in which the American people would have to choose the next man for the Presidency, and the men for our next Congress. We STRESSED that that choice might well mean *Life or Death for our nation!* Therefore it was extremely vital that the people should be made aware of how and why our Country has been going down the drain during the past fifty-odd years—it was extremely vital that they be made fully aware of the GREAT CONSPIRACY to destroy the Freedom of our Nation—and *who the would be Destroyers are . . .* but it was far more important to make the people aware that many of the men they had been electing into the highest offices in the Land (*the White House and Congress*), to whom they had been entrusting the safety and security of our Country, had been deliberately aiding and abetting the Conspirators (CFR) to further their One-World Dictatorship plot.

In short, we issued that “*Set of Recordings*” in the hope that by revealing the treacheries and betrayals by the men to whom we had been entrusting the guardianship of our Nation and of our CONSTITUTION it would serve as a guide for a PROPER choice of the men we would elect in 1968 to be the new Guardians of our Nation—that *they would be loyal and TRUE Guardians*.

Now, you may not have heard those “*Recordings*”, or if you have, you may have forgotten all about it by now, so, in order to leave nothing to imagination, or to a faulty memory, *and to show exactly* how the men in the White House and Congress have been betraying us, I will now repeat that section of the “*Recordings*” which defined in brief and concise language the DOCUMENT we know as the

CONSTITUTION of the United States—and inasmuch as that same definition will guide us in our review of Richard Nixon's background, please read the following very carefully!

THE CONSTITUTION OF THE UNITED STATES

The sovereignty of the Thirteen Colonies, each an individual NATION, that in 1783 entered into the Constitutional Compact, was established by the Treaty of Peace at the end of the Revolutionary War. Years passed before those SOVEREIGNTIES contracted with one another in the Agreement known as the CONSTITUTION of the United States. At that meeting those 13 Sovereignities set up Three Branches of a Federal Government to serve the newly organized United States:

1) The Executive Branch, which means the Presidency: The powers delegated to this Executive Branch (the President) were clearly defined: He was to conduct our relations with all foreign governments; he was to enter into all necessary Treaties with other Sovereign nations—BUT ONLY WITH SOVEREIGN NATIONS; he was to set up all Federal Agencies, such as State Department, Defense Department, Treasury and other Agencies, and enter into any agreements as they became necessary—but all such actions would first have to be submitted for approval and consent to the Congress of the United States.

2) The Second Branch was the Congress of the United States, to be composed of a Senate (2 members from each State) and a House of Representatives, to be elected by the people, and to be directly responsible to the people! The powers and duties delegated to the Congress were to enact all Legislation (LAWS) as and when deemed necessary; to have complete control of our monetary system; to maintain control of all domestic affairs; in short, to stand guard over all acts of the Executive Branch, and guard all the interests of the people they represent!

3) The Judiciary Branch, commonly known as the U.S. Supreme Court: The duties and the powers of this third Branch of our Government are circumscribed and very simple: they are to interpret, when necessary, the Laws of our Constitution and all Legislation proposed by Congress and enacted into LAWS by the signature of the President. Thus, under the Constitution, the U.S. Supreme Court has absolutely no authority to create, or enact Laws, or to base their DECISIONS on any principles except those of our Constitution! . . . Certainly not on "the principles of the UNITED NATIONS CHARTER!!!"

ALL THREE BRANCHES HAVE BETRAYED US!!!

Limitation of space in this "News-Bulletin" does not permit a recapitulation of ALL their betrayals, but to confirm that charge I will cite just three distinct betrayals, which are by now commonly known:

1) In 1913 Woodrow Wilson and several renegade Members of Congress enacted into Law the treasonous "FEDERAL RESERVE ACT", which transferred our entire Money System into the complete control of the International Bankers (ILLUMINATI) in defiance of our CONSTITUTION's edict that our Money System was always to be controlled by our Congress . . .

2) In 1945 our then President and Senate signed the UNITED NATIONS CHARTER, thus entering into a TREATY with that gang of Conspirators; in defiance of our CONSTITUTION's express EDICT that we could enter into TREATIES only with other SOVEREIGN Nations . . .

3) In 1954 Earl Warren, our then Chief Justice of the Supreme Court (Our 3rd Branch of Government), issued his illegal and traitorous "DESEGREGATION DECISION"—and proclaimed that it was "based on the principles of the United Nations Charter", thus flouting our Constitution, and declaring the UN Charter to be the LAW OF OUR LAND!

And now we will proceed with the main objective of this "News-Bulletin": a full review of the background of the present man in our White House, who would destroy your Constitutional right to VOTE by cancelling the 1972 Elections—a BETRAYAL that would go far to complete the destruction of our CONSTITUTION . . . and finally deliver our beloved Country into the CFR's UN ONE-WORLD DICTATORSHIP!!! . . . and bear in mind that his own Counselor, Moynihan, in so many words, confirmed that "planned" BETRAYAL!!!

THE REAL "TRICKY DICK" NIXON

To establish how Nixon acquired his "*Tricky Dick*" sobriquet we had to go back into his early youth. The Quaker-born Nixon classified himself a "*liberal*" in College, where he soon had a reputation for sliding around arguments on his debating team, and was adept at producing tears in school plays. After a stint in the Armed Services, he entered politics in 1946 at age 33. He came to that decision in response to a newspaper story in his home town. That was the year when the Reds in Hollywood were exposed, and anybody who was in any way identified with Communism automatically became a pariah with all loyal Americans. Nixon's District was represented in Congress by Jerry Voorhis, a man who was more than slightly tainted by Communism. Nixon promptly pounced upon the idea of wresting that Congressional seat from the "*pariah*". He loudly proclaimed himself to be a zealous anti-Communist—and easily won the election . . . And with that came his great opportunity to achieve nation-wide fame for himself; to wit:

In 1947 Whittaker Chambers revealed the fact that Alger Hiss, co-author of the UNITED NATIONS CHARTER, and generally acknowledged to have been the BIG BRAIN of the UN, had for a number of years been a member of the notorious Harold Ware Communist Cell within our State Department. The case came within the jurisdiction of the "*House Committee on Un-American Activities*." Nixon was a member of that "*Committee*", and, sensing the "*opportunities*" in the case, he promptly took it upon himself to become the "*chief prosecutor*." Hiss, with a great show of "*injured innocence*", testified (*before the Committee, on August 5, 1948*) that he was not and never had been a member of the Communist Party or any Communist Front Organization, directly or indirectly, and that "*to the best of my knowledge none of my friends is a Communist*."

Of course, all those statements were utterly false. Both Chambers and Elizabeth Bentley had provided documentary proof that Hiss had for years worked with the Communists, and supplied secret U.S. documents to Chambers to photograph and transmit to Moscow. In short, Hiss was just as guilty of rank treason as were the Rosenbergs who paid for *their* treason with their lives, yet, Nixon did not press TREASON charges against Hiss, and, as we know, Hiss was convicted merely of perjury. By accepting perjury, Nixon walked right into the trap that exposed him not as anti-Communist but as a traitor to his own Country.

Now, the great question is, *as it was at that time*, why did the

"hungry for fame" Nixon acquiesce to the mild charge of perjury where a conviction of treason, which, with all the overwhelming evidence, was a foregone conclusion, would have been so sensational as to automatically lift the then little-known Nixon into Presidential timber right then and there? The late Senator Joe McCarthy gave the answer; to wit:

Alger Hiss had been the moving figure in the plot to create the "United Nations" and to have it planted on American soil . . . Alger Hiss, in collaboration with other known Communists, had written the UN CHARTER . . . had Hiss been charged with treason it automatically would have forced a thorough Congressional investigation of the UN and its Charter. Such an investigation would quickly have revealed that the UN had been set up to be the housing for the ILLUMINATI-CFR ONE-WORLD DICTATORSHIP — it would have forced Congress to nullify our membership in the UN trap, exactly as the action by Senator Henry Cabot Lodge (*not the present phony using that name*) had foiled Woodrow Wilson's treasonous scheme to force the U.S. into the "League of Nations," *that first One-World trap*. Nixon had that very opportunity had he pressed the TREASON charge against Hiss. Why didn't he press that charge? Was it because he was ORDERED by the CFR to stop short of that step? Was it because he was told, or knew, that unless he did stop short of that step his political career would have been the price of his defiance of the CFR? . . . *his later collaborations with the CFR leaves no doubt that he placed his personal ambitions far above loyalty to his country!*

However, his successful "prosecution" of Alger Hiss as a Communist and perjurer falsely established Nixon as a staunch Anti-Communist. It set the stage for his next frenzied (*White House*) ambition. That next stop was the Senate. Shrilling "anti-Communism" more loudly than ever, he launched a campaign against Helen Gahagan Douglas. The Douglas woman, deeply tainted herself, and the wife of Melvyn Douglas, one of Hollywood's most notorious REDS, had no defense against Nixon's charges, and he (Nixon) won the election hands down.

Then came 1952. With his eye on the Vice Presidency as his next step to the White House, Nixon joined the infamous Earl Warren in a plot to deliver the California delegation to Eisenhower—and then participated in the over-all plot to deliver the nomination to the phony "God Man". The smearing of Taft, the briberies of delegates, and all the chicaneries that were employed in that plot are too well-known to require a recapitulation in these pages. Our objective here is to establish how and why that soubriquet of "Tricky

Dick" was fastened on Nixon, so we will cite just three distinct acts of treason that went far to do it.

No. 1) During his Vice Presidency it was revealed that Richard Nixon was, *and had been for years*, an official member of the CFR. That automatically established why he (NIXON) had failed to press charges of TREASON against Hiss and the UN as a whole—*that alone should have warranted the "Tricky Dick" soubriquet*—and put finis to his political career.

No. 2) In 1959 he (Nixon) delivered a speech in which he advocated and urged the (*CFR's required*) repeal of the "CONNALLY AMENDMENT", which would have placed the American people under the control—*and at the mercy*—of the UN's World Court. Now, it certainly is no secret that the UN is, and was from the outset, Communist controlled (*always bearing in mind that Communism is simply a camouflaged instrument of the ONE-WORLD CONSPIRACY*), so what values can we place on Nixon's cries of anti-Communism as proof of his loyalty to the United States?

No. 3) In 1960 the Republican Convention in California was generally viewed as a mere formality to announce the nomination of Nixon for the Presidency of the U.S., but on the very eve of that Convention, he (Nixon) made a sudden flight to New York for a secret conference with Nelson Rockefeller. It quickly became known that that flight was a SURRENDER to Rockefeller's demands for specific changes in the Nixon-dictated Platform of the Party—*changes demanded by the CFR!* . . . Needless to say, Nixon SURRENDERED, and he "*won*" the nomination. But that is not the complete story of that event.

As I have stated, Nixon's mysterious flight did not go unnoticed. Nor did the changes he inserted in the Party Platform go unnoticed. Certain important people in the Party, *outside of CFR control* but who could not be brushed off, began to ask questions—*embarrassing questions*: One question was: Did he (Nixon) promise Rockefeller (*and the CFR*) that his first "*job*" after he would enter the White House would be to get the Senate to ratify the UN's "GENOCIDE CONVENTION" into a TREATY? . . . Another question was: did he promise Rockefeller that he would prevent a Congressional investigation of the UN and its CHARTER? . . . Still another question: did he promise Rockefeller that he would prevent a Congressional investigation of the "FEDERAL RESERVE ACT" and/or the "*Federal Reserve Banking System*"?

Nixon tried to answer all those questions with his usual "*Tricky Dick*" double talk . . . and his answers once again aroused the distrust of Rockefeller and the CFR, and the order went out that no

matter how the people would vote, Jack Kennedy, whose loyalty to the CFR at that time was beyond all questions and doubts, was to be planted in the White House.

Well, we know what happened. Actually, insofar as the matter of votes was concerned, Nixon won that election, but votes didn't count, or to be more exact, the votes were counted the wrong way—the *CFR way!* We know how all the votes were manipulated—how they were MIScounted in Texas, in Illinois, in many other States. We know that in Cook County (*Illinois*) alone a number of men went to prison for manipulating the voting machines to rob Nixon of votes. In short, it was commonly known that actually Nixon had won the election—and *was robbed of it*. Some furiously outraged Republicans (*not of CFR persuasion, of course*) pleaded with Nixon to challenge the vote count. There was absolutely no doubt that such a challenge would have proved the robberies—and *reversed the election!* But Nixon, although greatly embittered by what the CFR had done to him, refused to challenge. Why did he refuse to challenge? The answer is quite simple: FEAR—fear of the consequences of the investigations that would automatically have followed such a challenge; following are the “consequences”.

In 1960 the vast majority of the American people did not know of the existence of the CFR. It is doubtful that more than one person in every 10,000 had ever heard about the CFR. And those who had heard about it, *except for a very few*, accepted it as some sort of harmless social or fraternal organization. Certainly, it was not known that the CFR was in absolute control of both our National Political Parties—that it had absolute control of all our Mass Communications Media—that the UN had been set up by the CFR to be the housing for their One-World Dictatorship . . . in short, it was not known that the CFR is the GREAT CONSPIRACY to transform the U.S. into an enslaved unit of their One-World Government plot . . . a Nixon challenge of the 1960 election might well have brought out all those facts—it might well have been the one thing that would have awakened, aroused, and enraged the American people into FORCING Congress to make the kind of investigations that would have smashed the entire Great Conspiracy. It would have meant the salvation of our nation! But such investigations was the one thing that Nixon did not dare to engender. It would have unmasked the CFR for what it is—it would have unmasked every member of the CFR,—it would have unmasked every Federal Government official, past and present, from the Presidency down to the very lowest who had served the CFR objectives, *such as, for one example, Nixon's efforts to repeal the “Connally Amendment”*—it would have meant impeachments and trials for treason.

Thus, furious as Nixon was, he did not dare to challenge that 1960 election fraud. The risk was too great, because even if his "challenge" had reversed the election and placed him in the White House, I repeat, it also would have revealed his relationship with the CFR and his treasonous acts in their behalf, *and automatically made him subject to IMPEACHMENT!*

There was another reason why he preferred to swallow his humiliation: The CFR, as long as it would remain unchallenged and unmasked, would continue to be the power in U.S. politics—they would continue to control the machinery in both Political Parties—therefore it would serve him best if he could retain the goodwill of the CFR rather than to incur their enmity—he still had an idea that he could restore himself into their good graces. And two years later he set forth on the come-back road by running for the Governorship of California. But by that time the "Tricky Dick" soubriquet had become so fastened on him that the people of California preferred a known phony like Brown to a known political trickster.

And that was the most devastating blow of all. He knew that—*anyway as of that moment*—politically, Richard M. Nixon was the proverbial "dead duck"—that he couldn't successfully run for the office of dog catcher. But, *again*, he did not publicly blame the CFR for that second humiliation. Instead, he blamed the Press, TV and Radio for what happened, and, in a fit of vicious temper, he railed against all of them and proclaimed that never again would they get an opportunity to "kick Dick Nixon around," thereby implying that he was all through with politics—and California, too!

In actuality, he had realized that his "Tricky Dick" image had become his political bete noire—that to retrieve his political fortunes he would have to create a new "image"—an image of truth and reliability. In short, that he would have to create a "new" Nixon devoid of all trickiness.

THE "NEW NIXON"

In keeping with the proclamation that he was leaving his political career behind him, and a new (*seeming*) humility, he announced that he would move to New York and take up the practice of Law. But for those who could read between the lines, he made two mistakes right from the outset: No. 1) He "accepted" a "partnership" in a Law Firm that was distinctly a Nelson Rockefeller (*Kingpin of the CFR*) controlled outfit: No. 2) He moved his family into

an Apartment building owned by Rockefeller, which, *according to very reliable informants*, he got rent free. During the following years he stayed out of the political limelight—he was distinctly a “lawyer”. Yet all the “work” he did for his Law Firm consisted of travels in the U.S., in South America, in Europe . . . but, amazingly, he never participated in any Court cases. In short, he was a lawyer “in name only.”

And throughout all that time he assiduously cultivated Rockefeller's friendship . . . which, of course, means the friendship and good-will of the CFR!

Then, in 1967, he launched his “NEW NIXON image” with a series of highly patriotic articles in the “READERS DIGEST” and other publications. At the same time he set up a seemingly modest “Nixon For President” organization headquartered in New York, headed by Maurice Stans. Simultaneously, he began to build up a campaign staff. He “sold” himself to Sen. Strom Thurmond to “build” him up in the Southern States, and to Sen. Karl Mundt to “build” him up in the mid-western States. He then entered all State Primaries. It is hardly necessary to repeat what followed, including the outcome of the Republican National Convention in Miami, Florida—except one very important point: Nixon's nomination clearly indicated that all differences between Nixon and the CFR had been resolved—that Nixon was once again in the good graces of the CFR . . . *And that is BAD NEWS for the American people, as you shall see.*

At the conclusion of that Convention, the jubilant Nixon delivered an “Acceptance” speech, in which he “promised” that, if elected, he would do everything that all loyal Americans have been crying for ever since our Country fell into the clutches of the CFR gang. He castigated the Johnson appointed Attorney General, and “promised” to appoint a man in that post who would quickly put an end to all of the rioting, looting and anarchy that has been rampant in all the cities in our Land . . . he castigated the McNamaras and the Rusks and “promised” to appoint men to the Defense and State Departments who would be loyal to God and Country. In short, (*while, of course, he never mentioned the CFR*) he “assured” us that he would set up a Cabinet and Secondary Official Assistants who would be free of all taints and suspicions. In other words, to all intents and purposes, he “told” us that there would be no CFR stooges and TRAITORS in his Federal Administration . . . And he repeated the same glowing “promises” in his inaugural address.

In response to both of his speeches, I issued “Special Bulletins” in which I bluntly warned that he would never fulfill his glittering

promises—that he *couldn't* fulfill them, and I stressed two distinct reasons why he could not fulfill them:

1) After the UN had been *forced* to include the "CONNALLY AMENDMENT" in their "CHARTER", they issued their so-called "GENOCIDE CONVENTION", in the hope that if they could have it transformed into a "TREATY" it would nullify the "CONNALLY AMENDMENT". And they (the CFR) forced every candidate for the Presidency, both Republican and Democrat, to pledge himself to make all possible efforts to get the Senate to ratify the "GENOCIDE CONVENTION" into a "TREATY." Truman was the first to try it, but the Senate turned it down. Then Eisenhower and Nixon tried to accomplish the same objective by a "*repeal*" of the "CONNALLY AMENDMENT"—you know how *that* was torpedoed. Then LBJ tried it—our "*News-Bulletin*" No. 147 told how he was forced to abandon that act of treason. Now, it is a foregone conclusion that when the CFR decided to let Nixon make another try for the Presidency, one of the rigid provisions was that he (*Nixon*) would make the Senate ratification of the "GENOCIDE TREATY" one of his chief objectives. And although, as you know, we (CEG) stymied that effort so far, that is still one of his (*Nixon's*) main objectives, *which he will again try to put over after the next November elections!*

2) I rejected Nixon's "*promises*" to keep his Administration clean of all CFR stooges for the following reason: the most important objective of the CFR is to place *obedient* CFR members in every important Federal post, from the Presidency down, in order to carry out the entire ILLUMINATI plot to transform the U.S. into a unit of their ONE-WORLD Dictatorship. So, when Nixon voiced all his glittering promises to put none but loyal Americans in all vital posts in his Administration, he deliberately lied, as the following will show:

Even before he *officially* took office, Nixon appointed Henry Kissinger to be his chief advisor on Foreign Policy. It is commonly known that Kissinger, in addition to being a CFR BIG BRAIN, is the personification of everything that all loyal Americans distrust and fear. He is perhaps the ILLUMINATI-CFR's chief ONE-WORLD Mastermind . . . Almost simultaneously, Nixon announced the appointment of Charles W. Yost as U.S. Ambassador to the UN and Jacob D. Beam as our Ambassador to Moscow. Both Yost and Beam are members and high functionaries in the CFR. In addition, both have records of affiliations with the Kremlin that smell to HELL.

But those three appointments were only the beginning of Nixon's

broken promises to the American people.
